The ornamental design for a vibrator for massage, as shown and described.

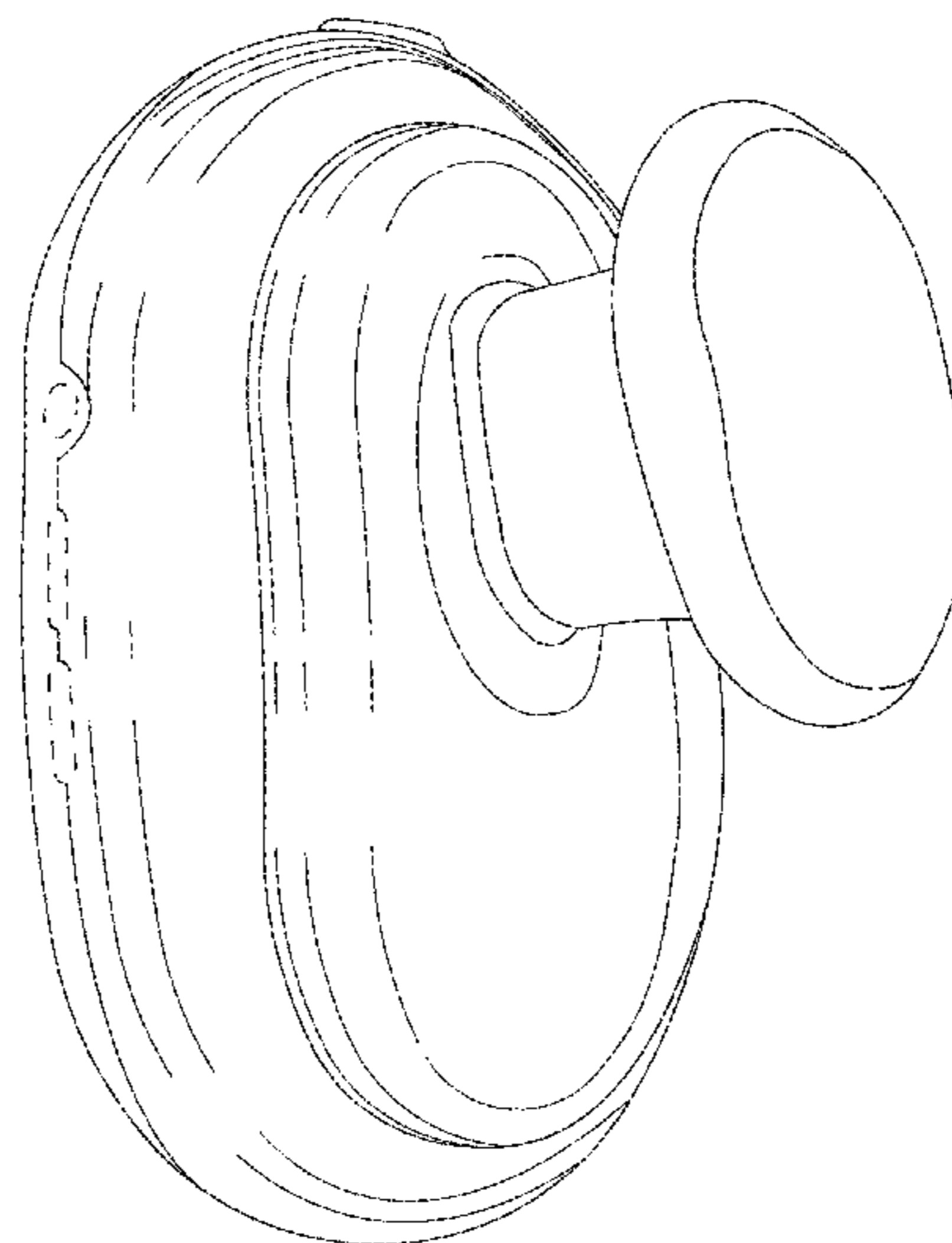
DESCRIPTION

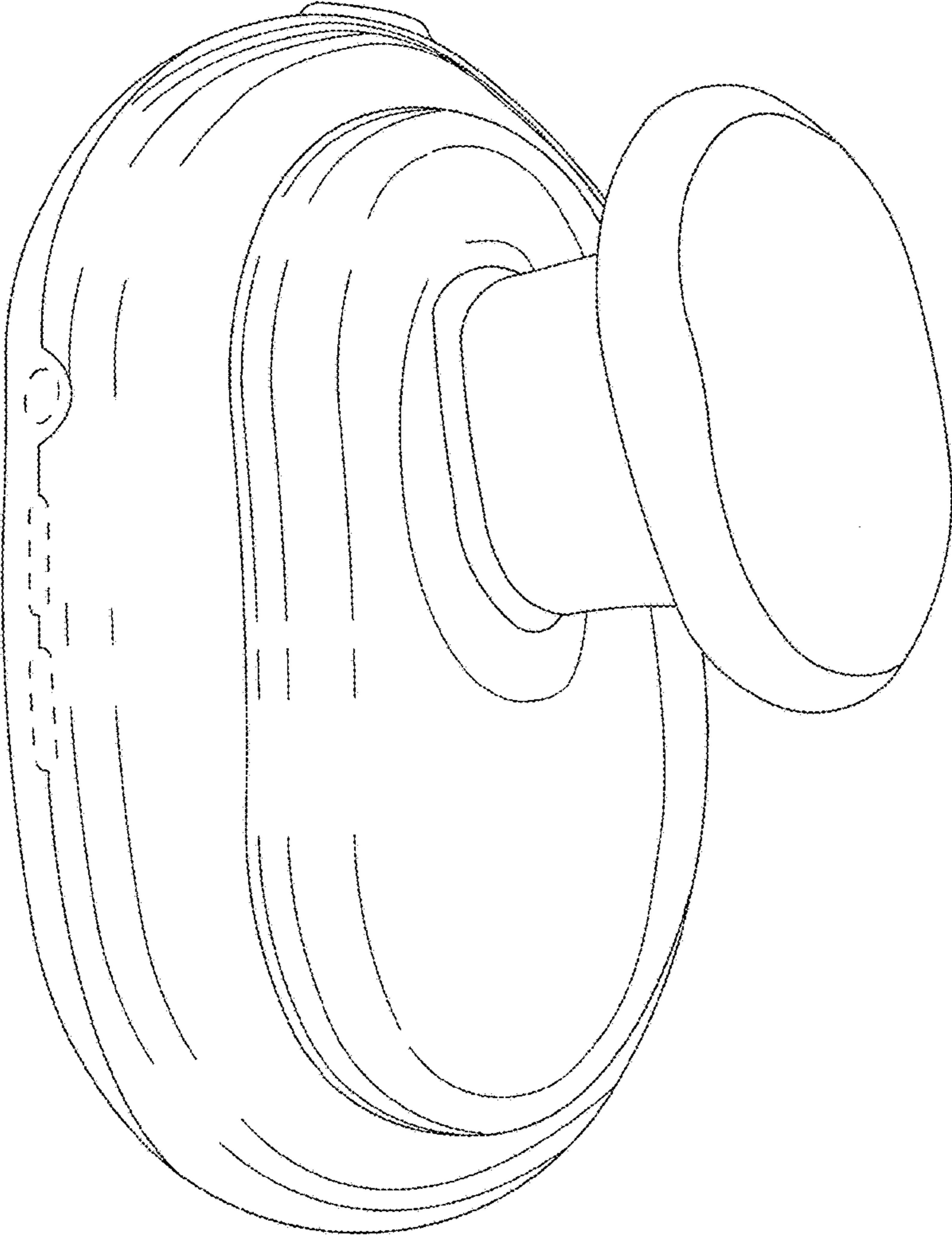

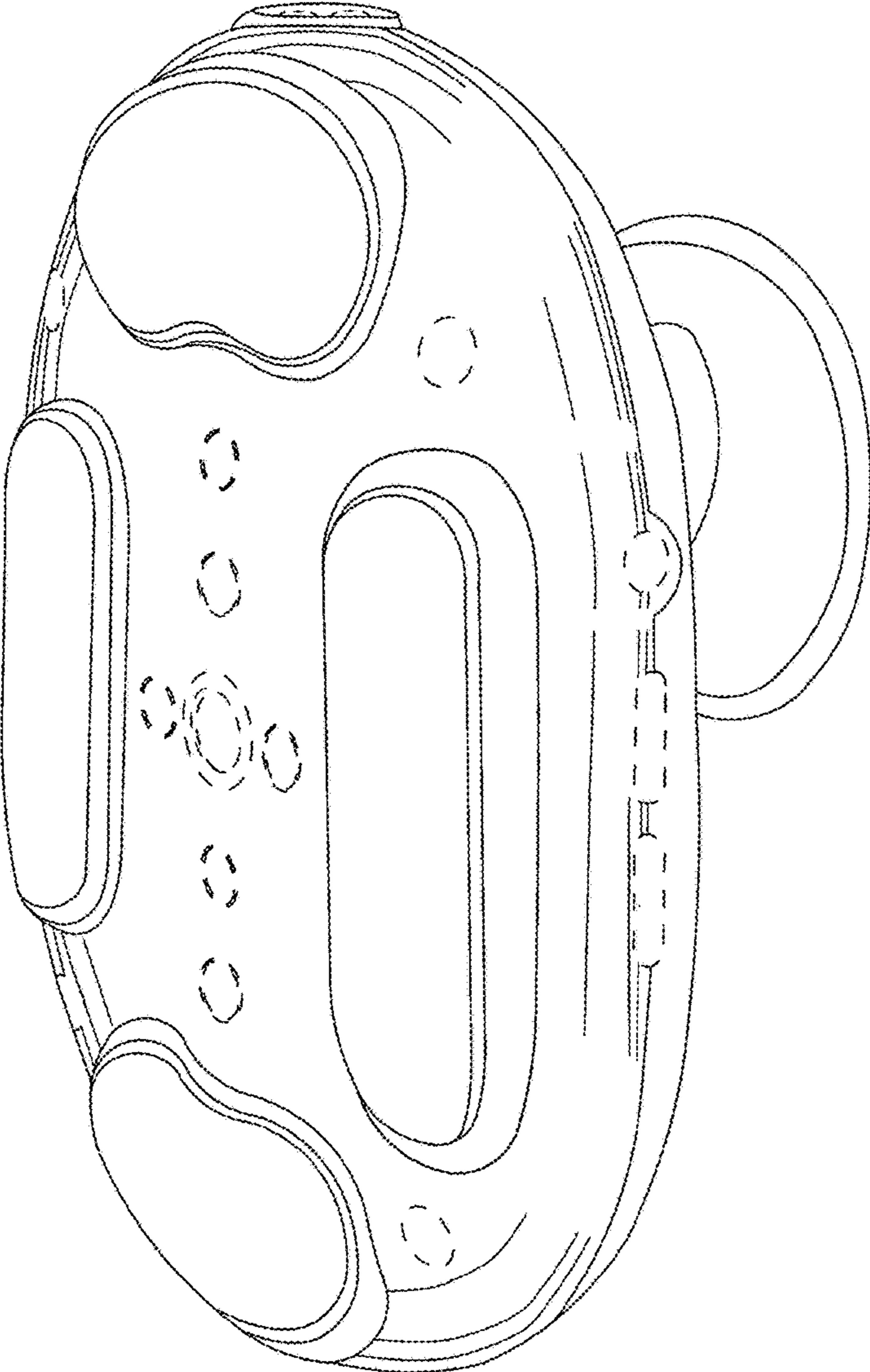

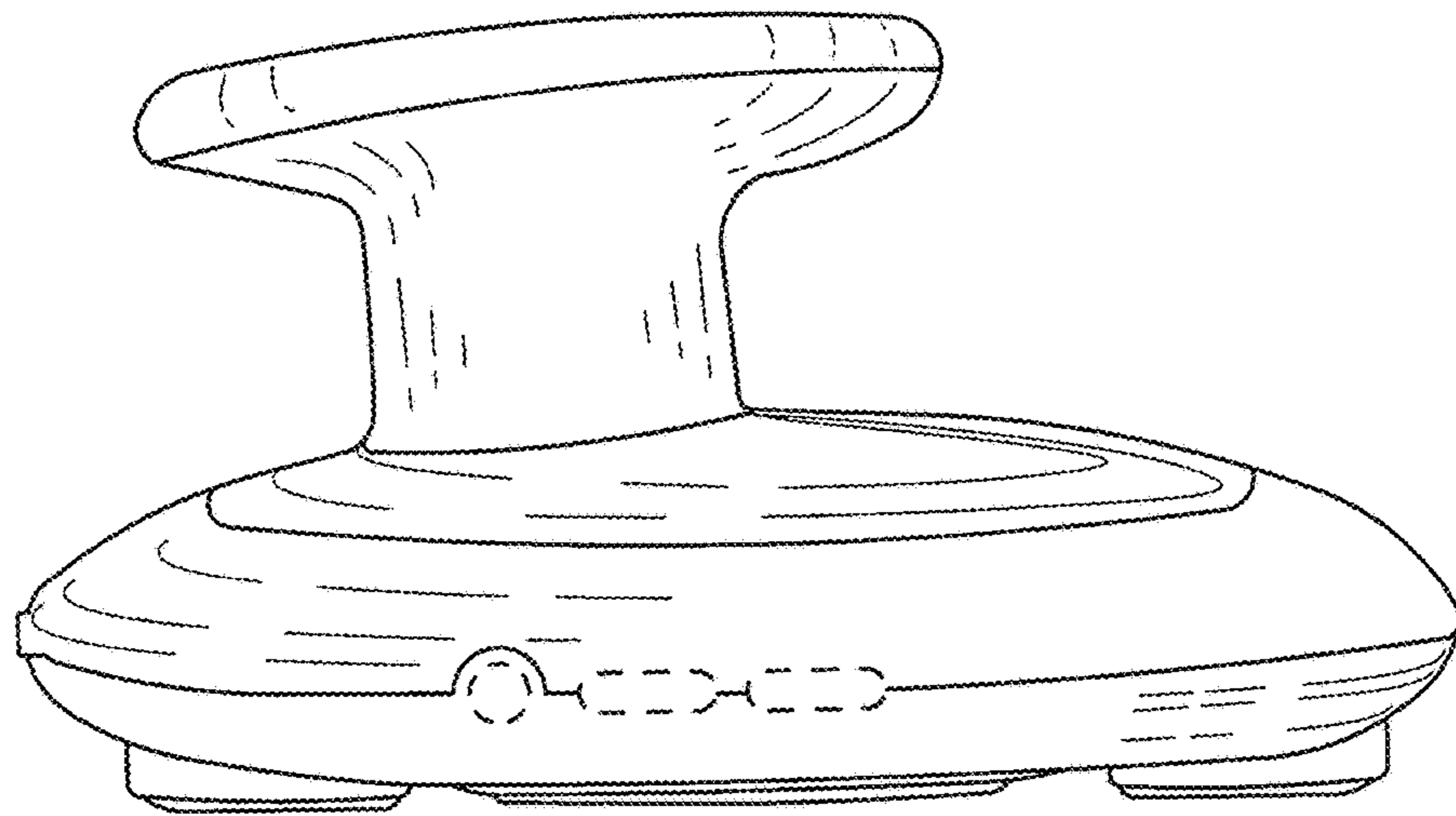

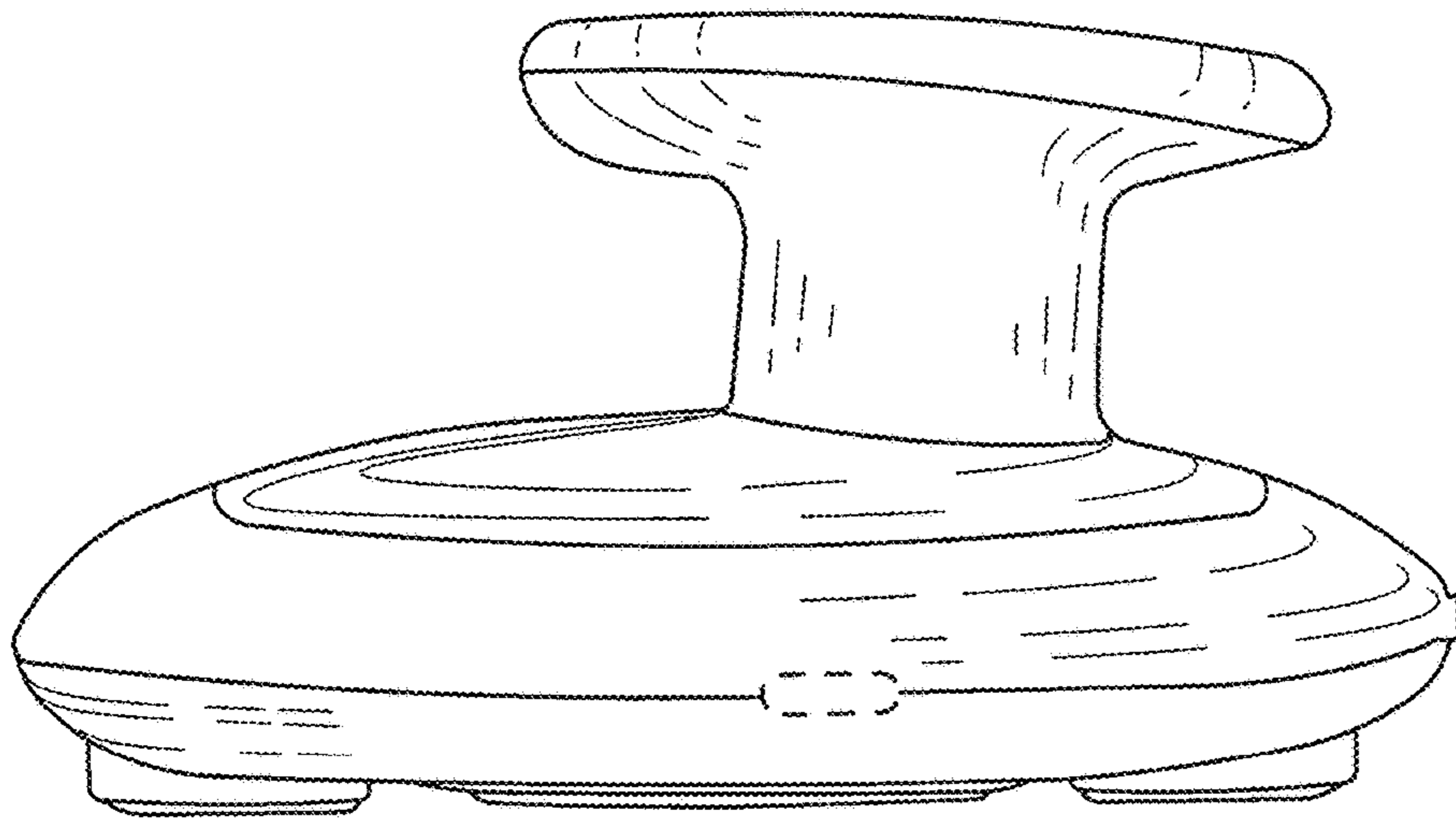

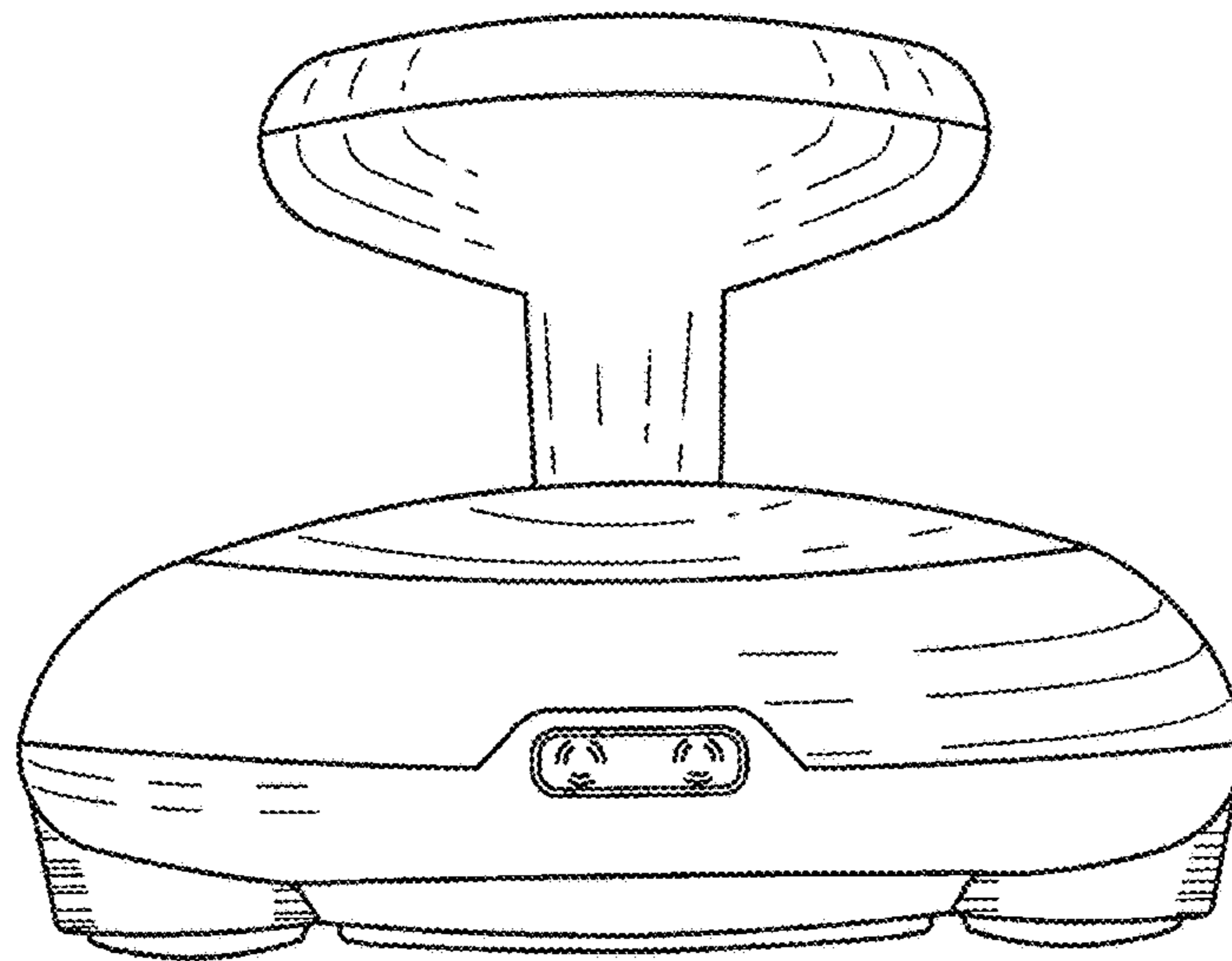

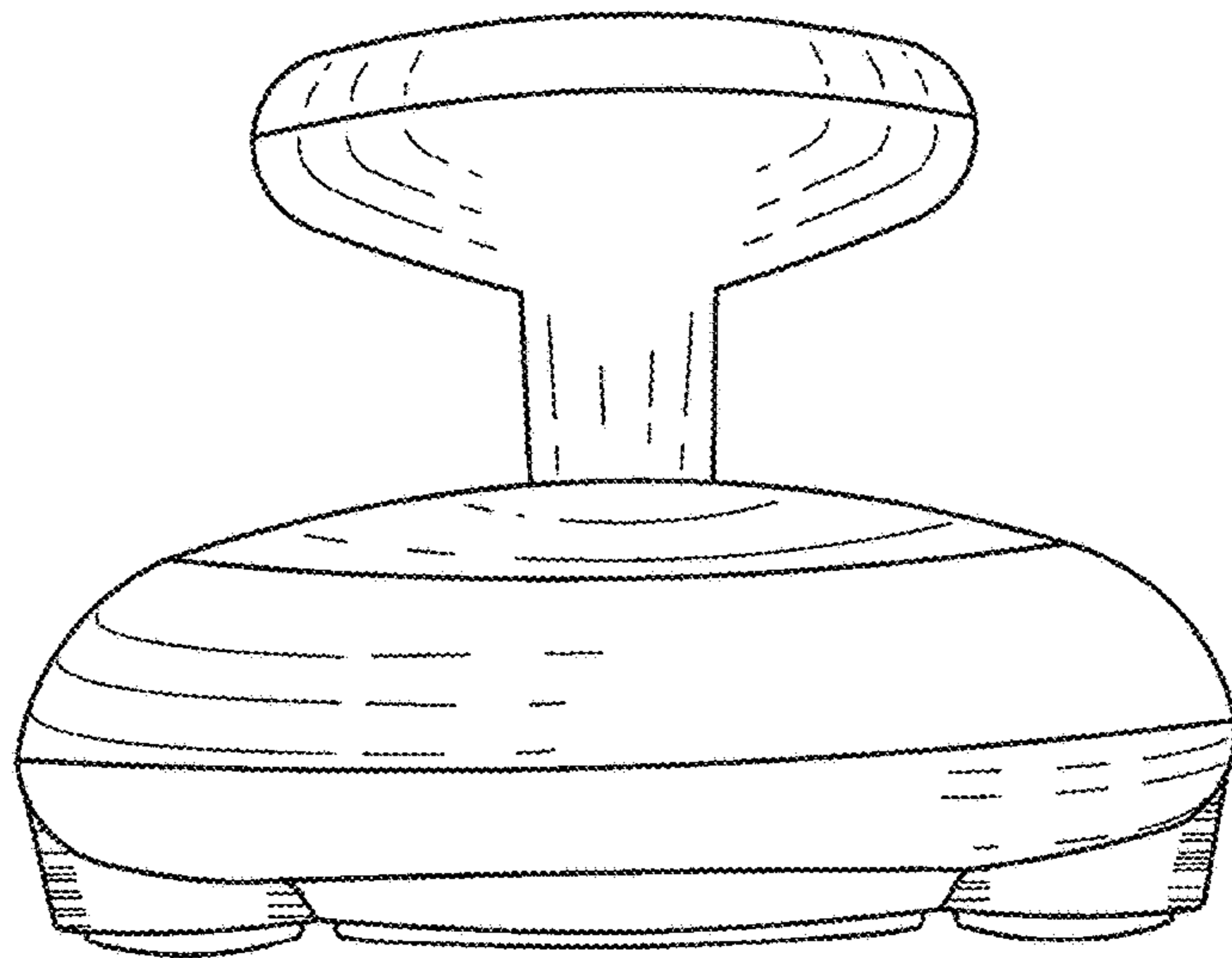

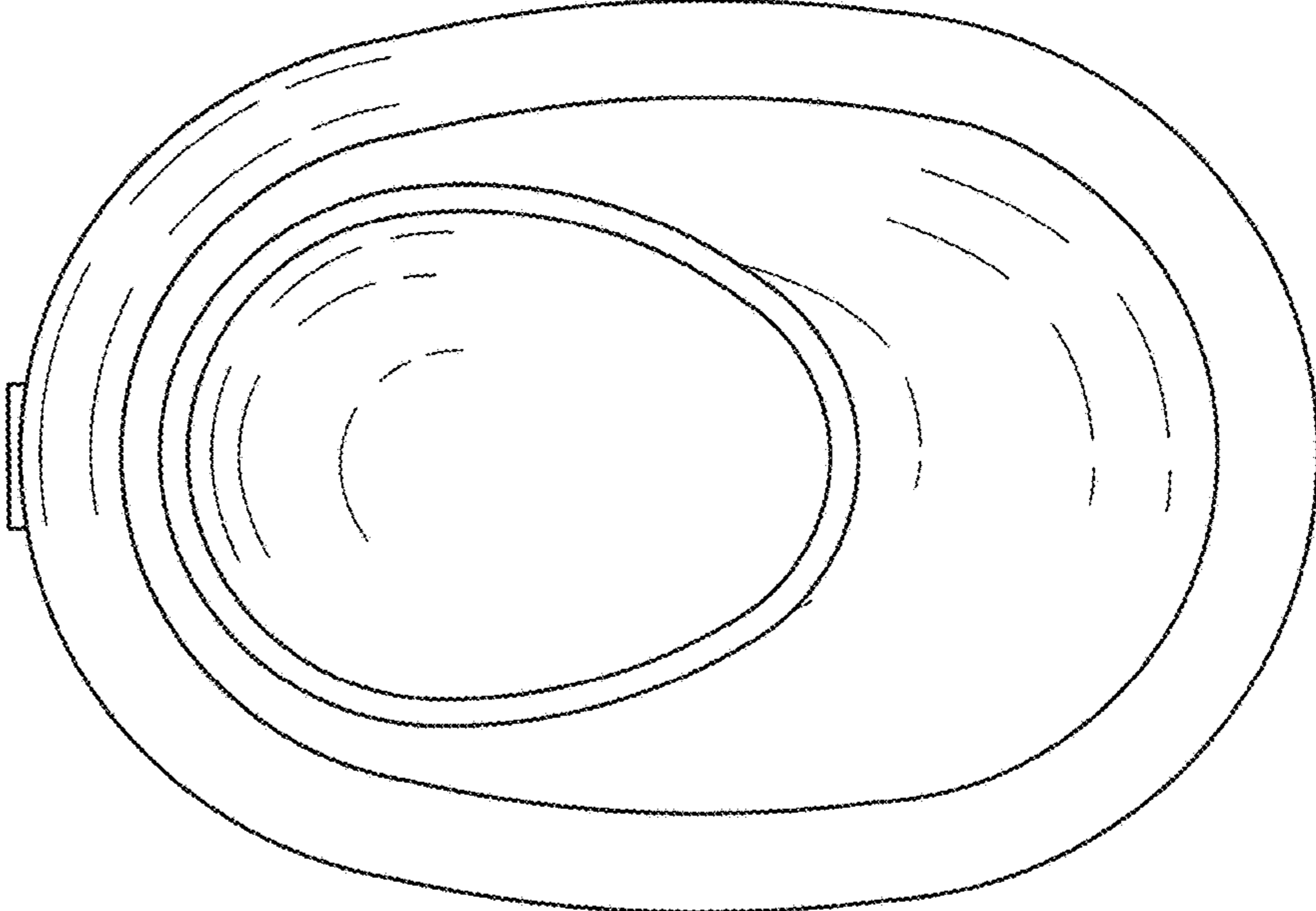

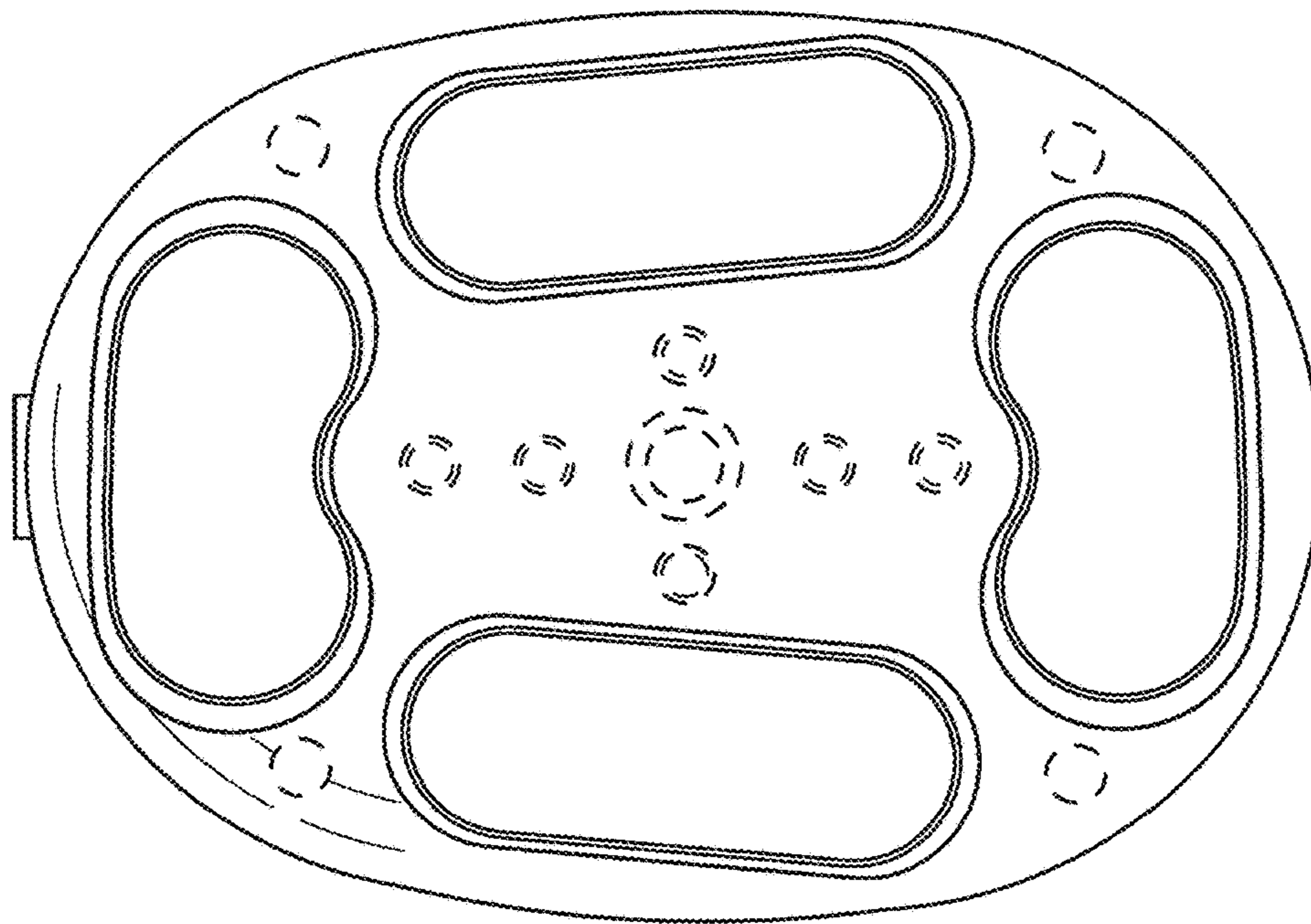
