**DESCRIPTION**

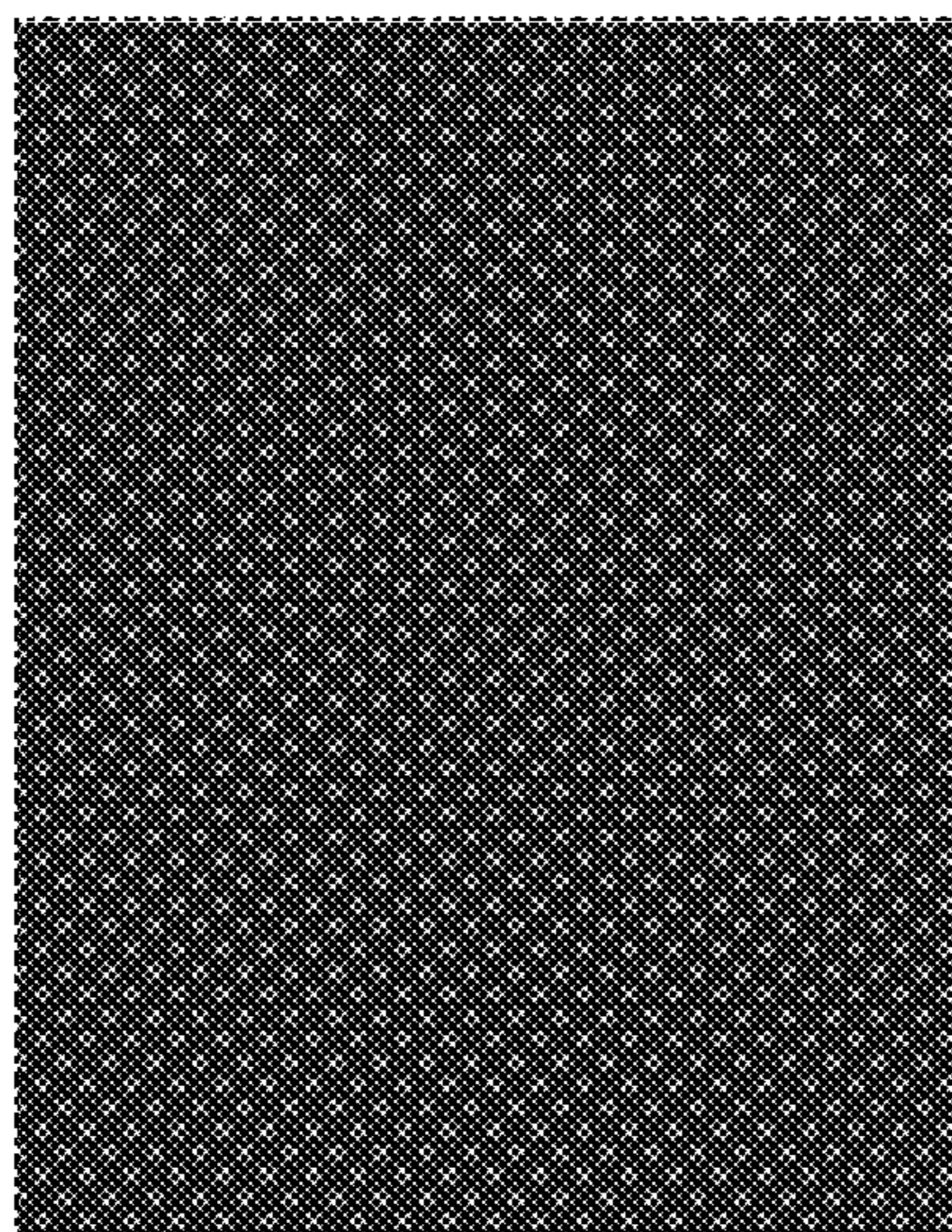

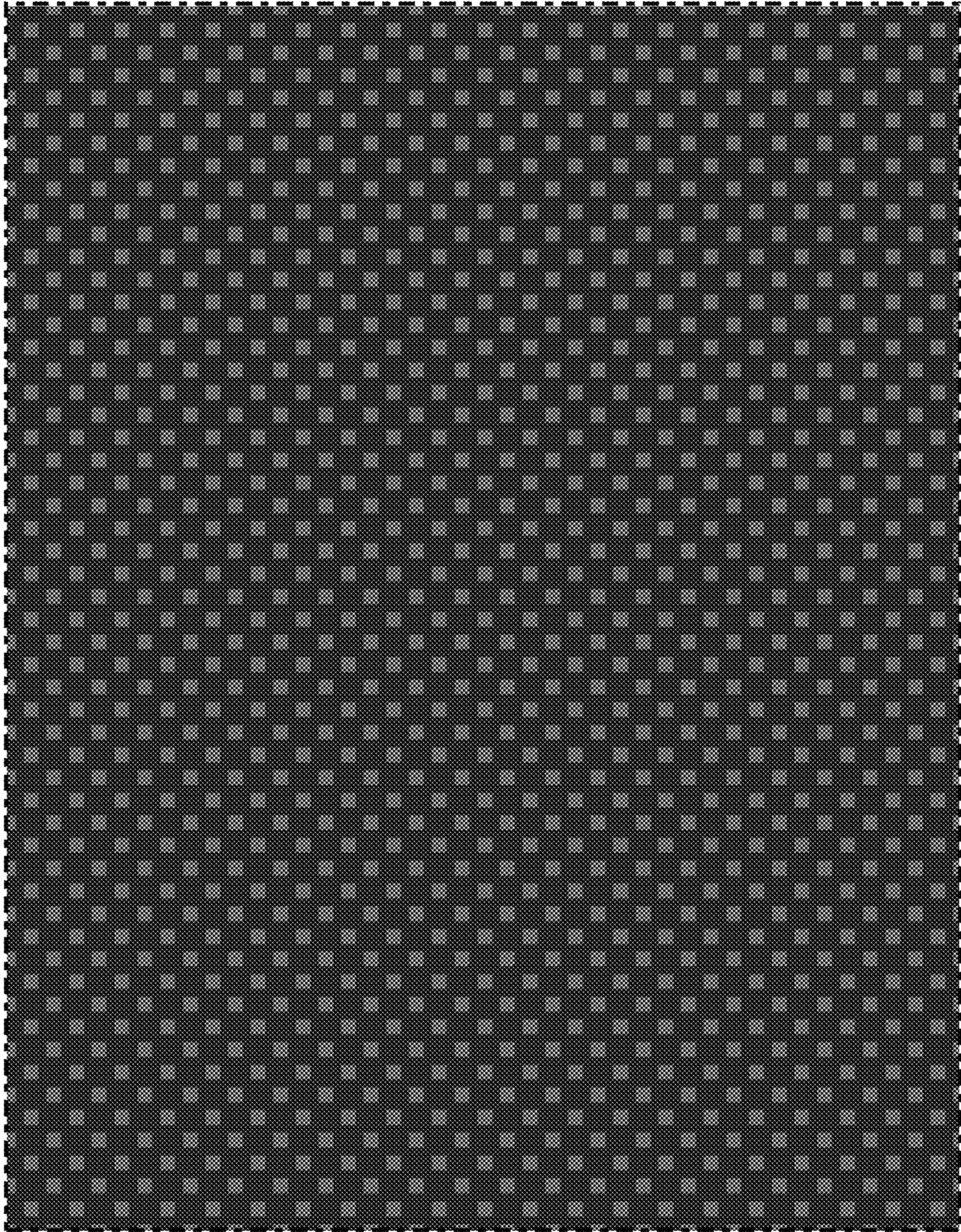

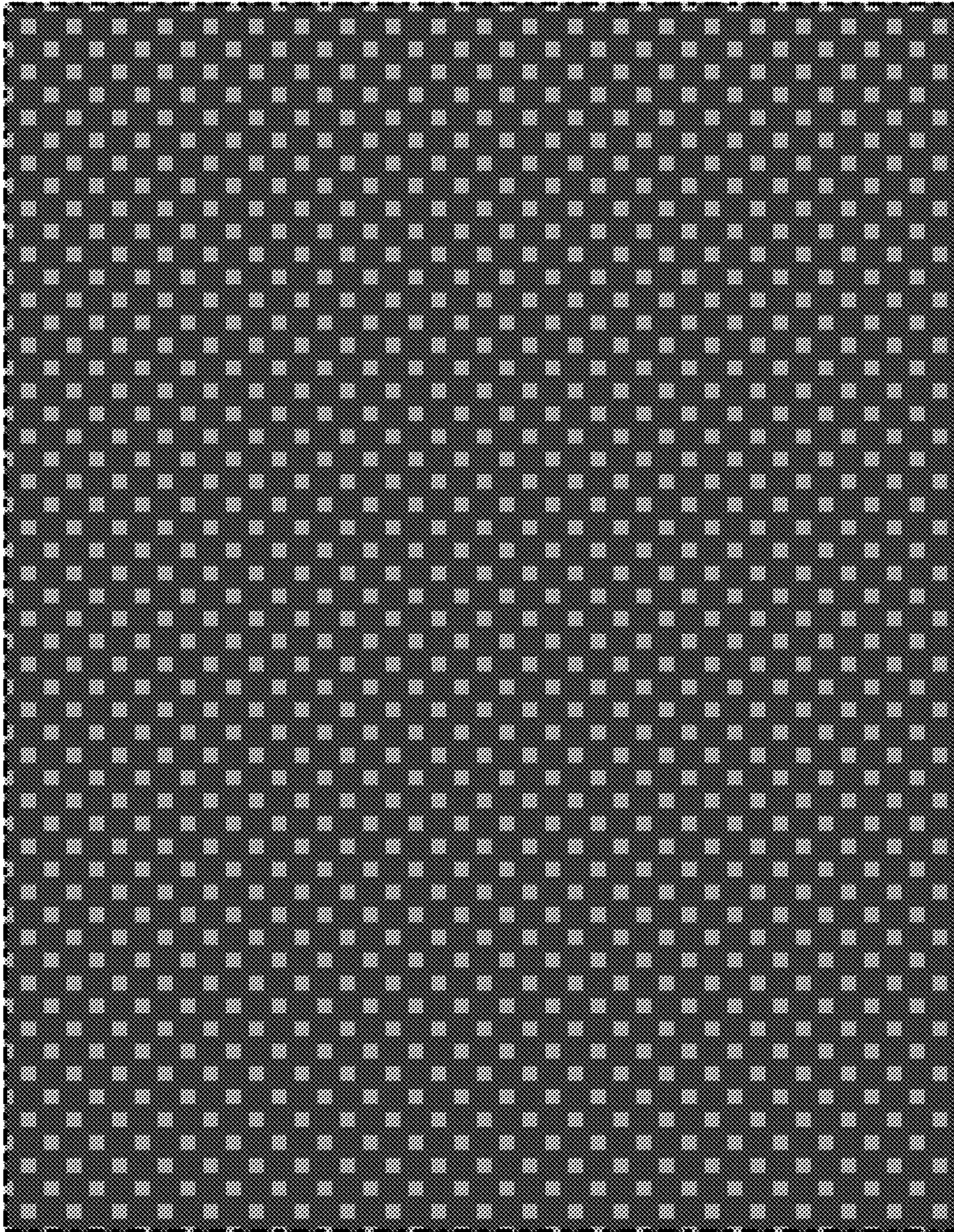
