The ornamental design for a light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right side perspective view of a light fixture according to the new design;
 FIG. 2 is a front side elevation view thereof;
 FIG. 3 is a rear side elevation view thereof;
 FIG. 4 is a left side elevation view thereof;
 FIG. 5 is a right side elevation view thereof;
 FIG. 6 is a top plan view thereof;

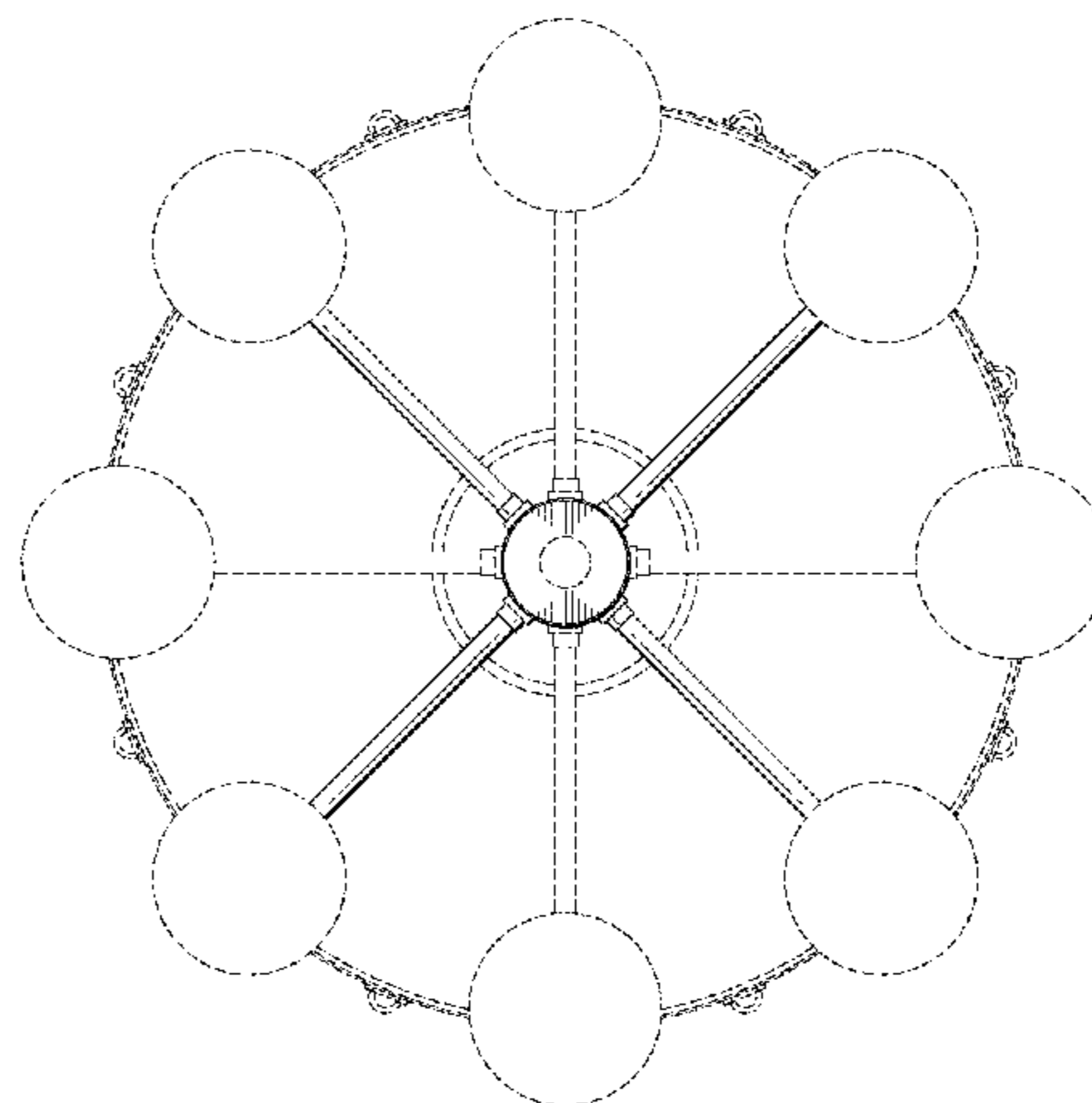
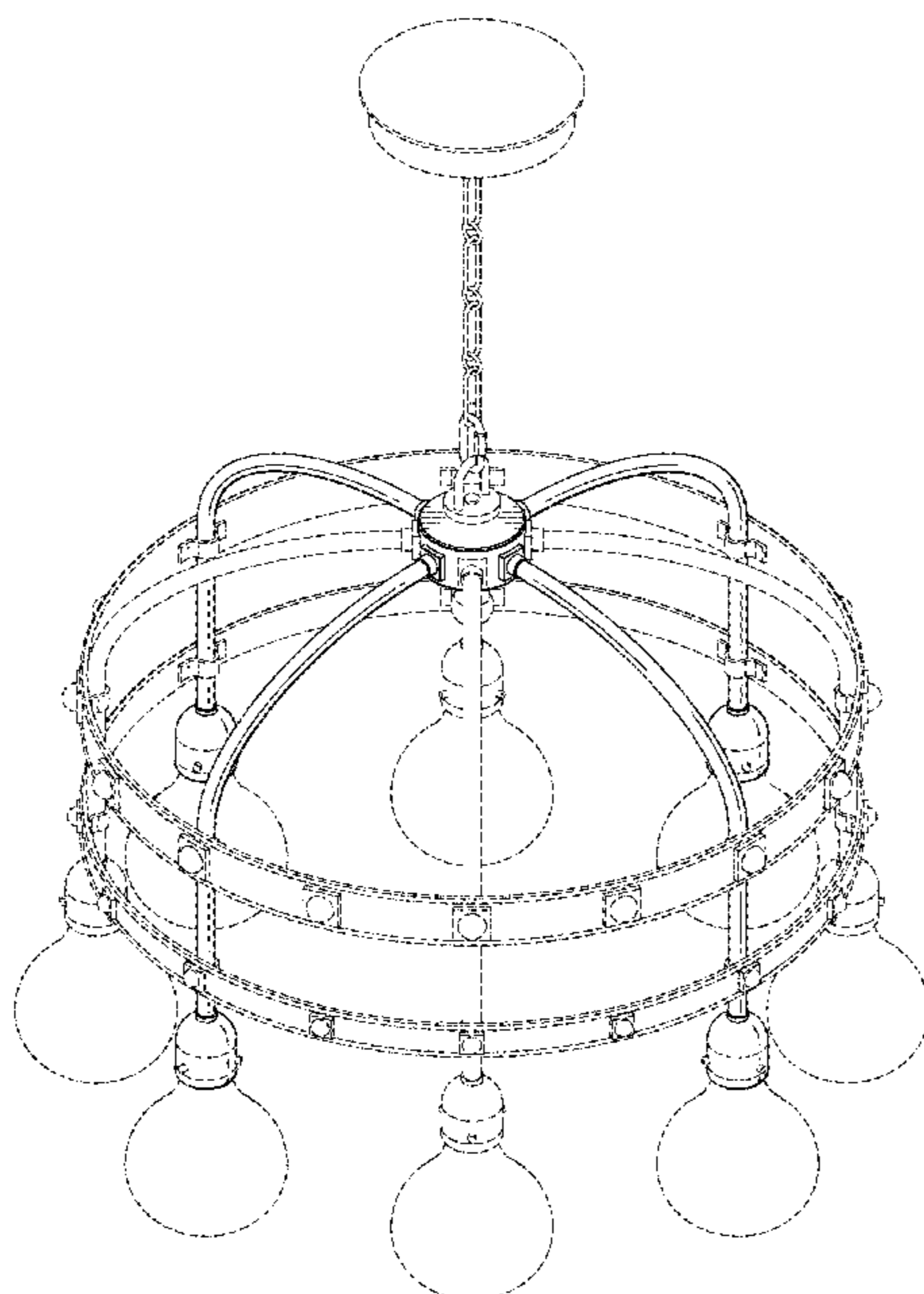
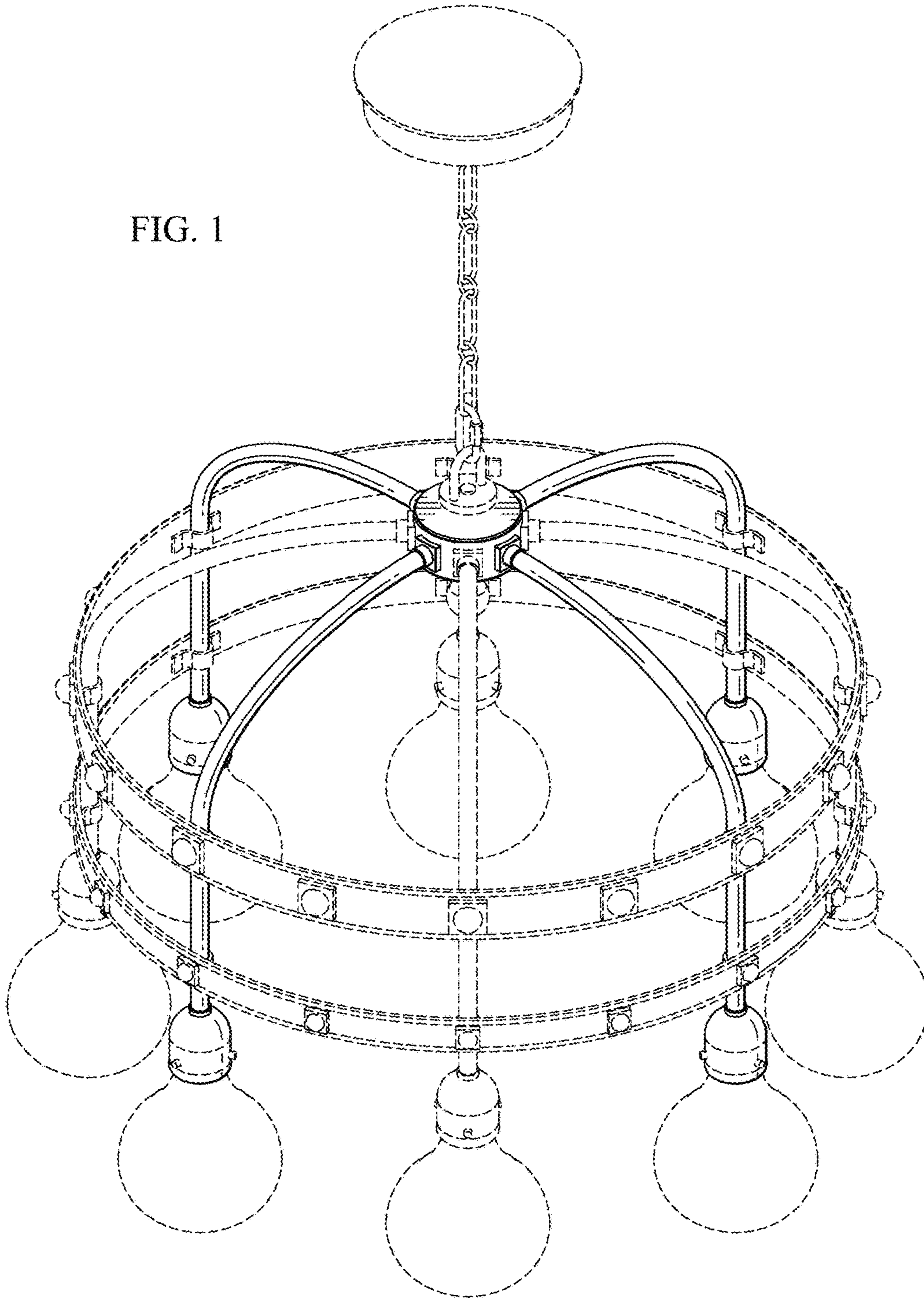

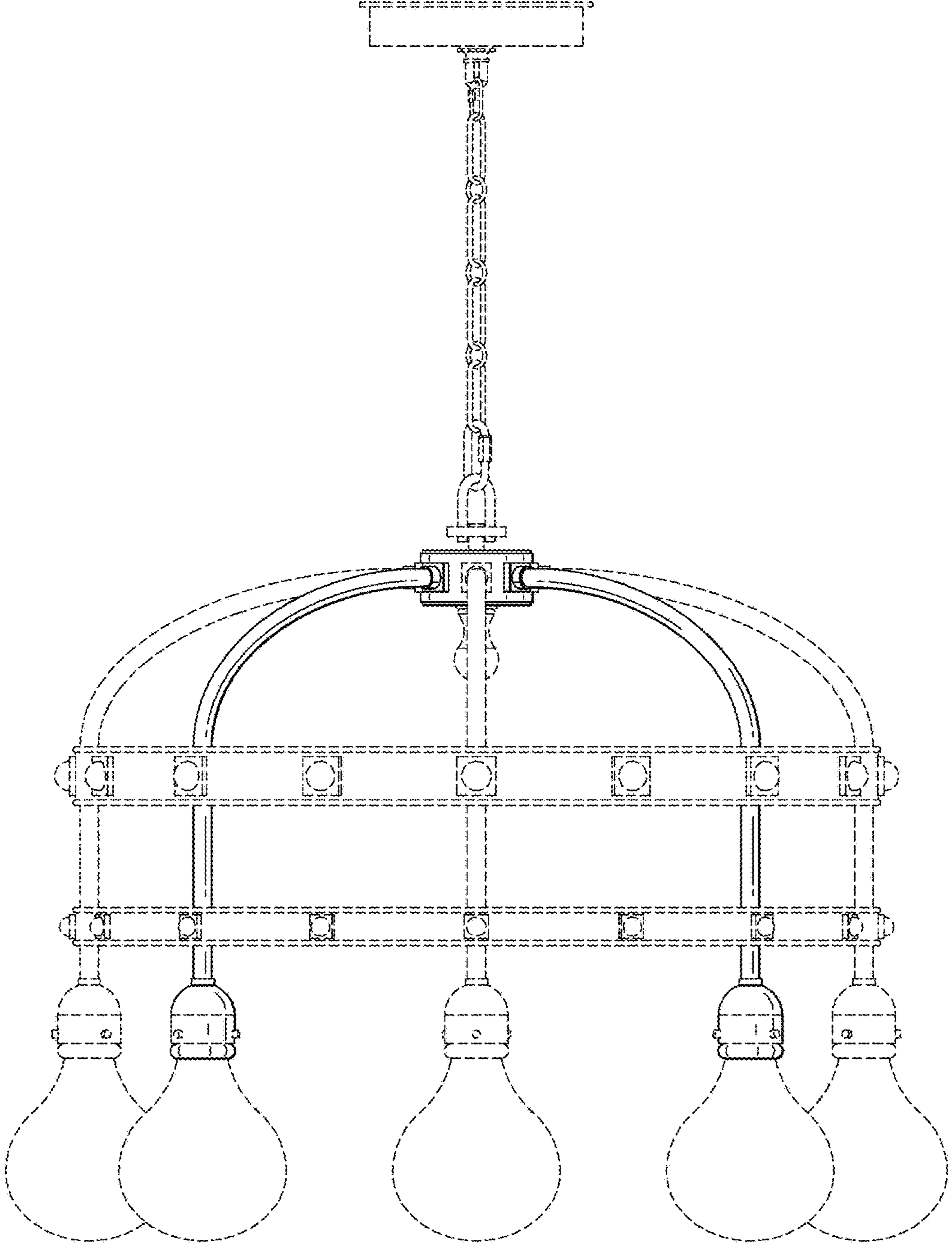

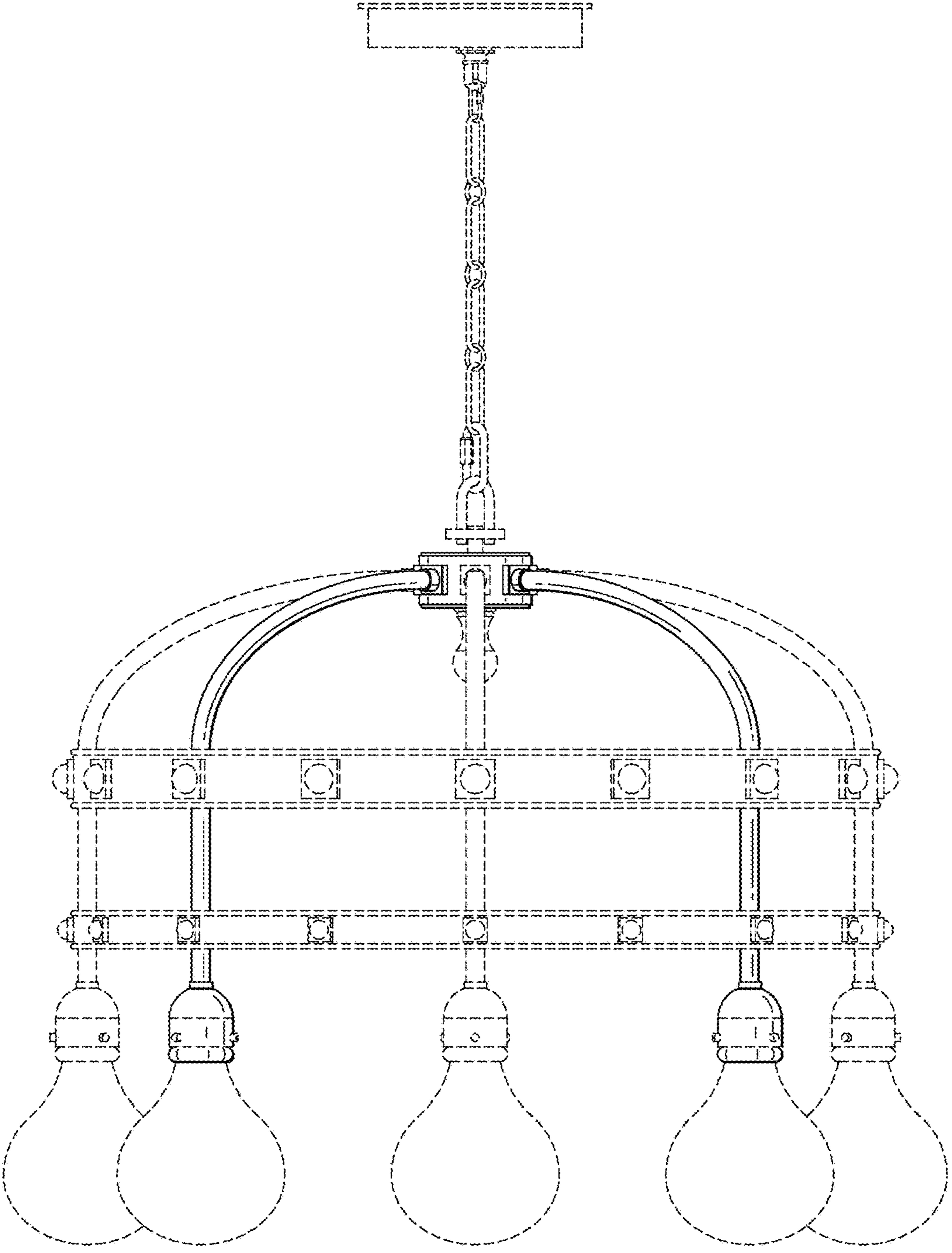

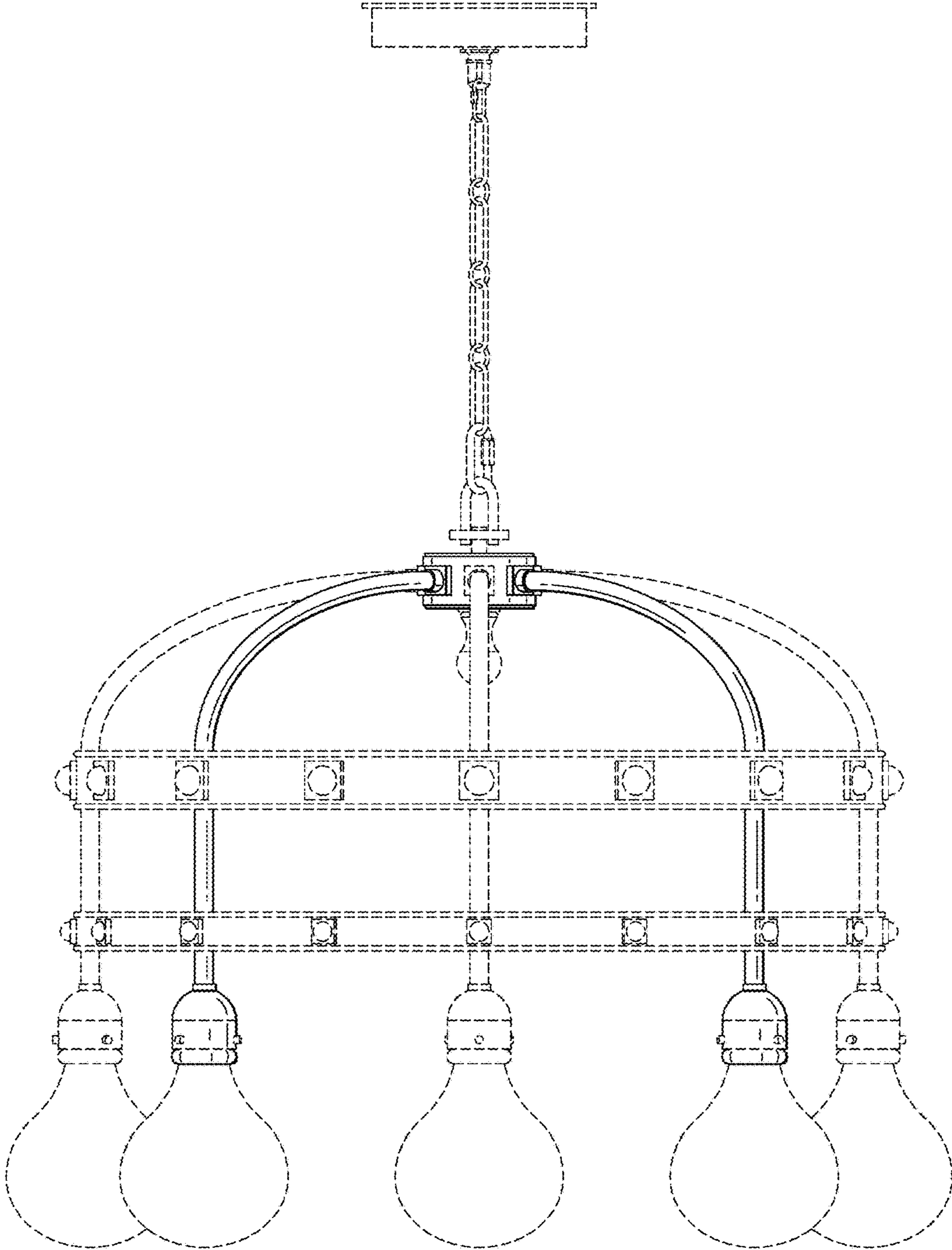

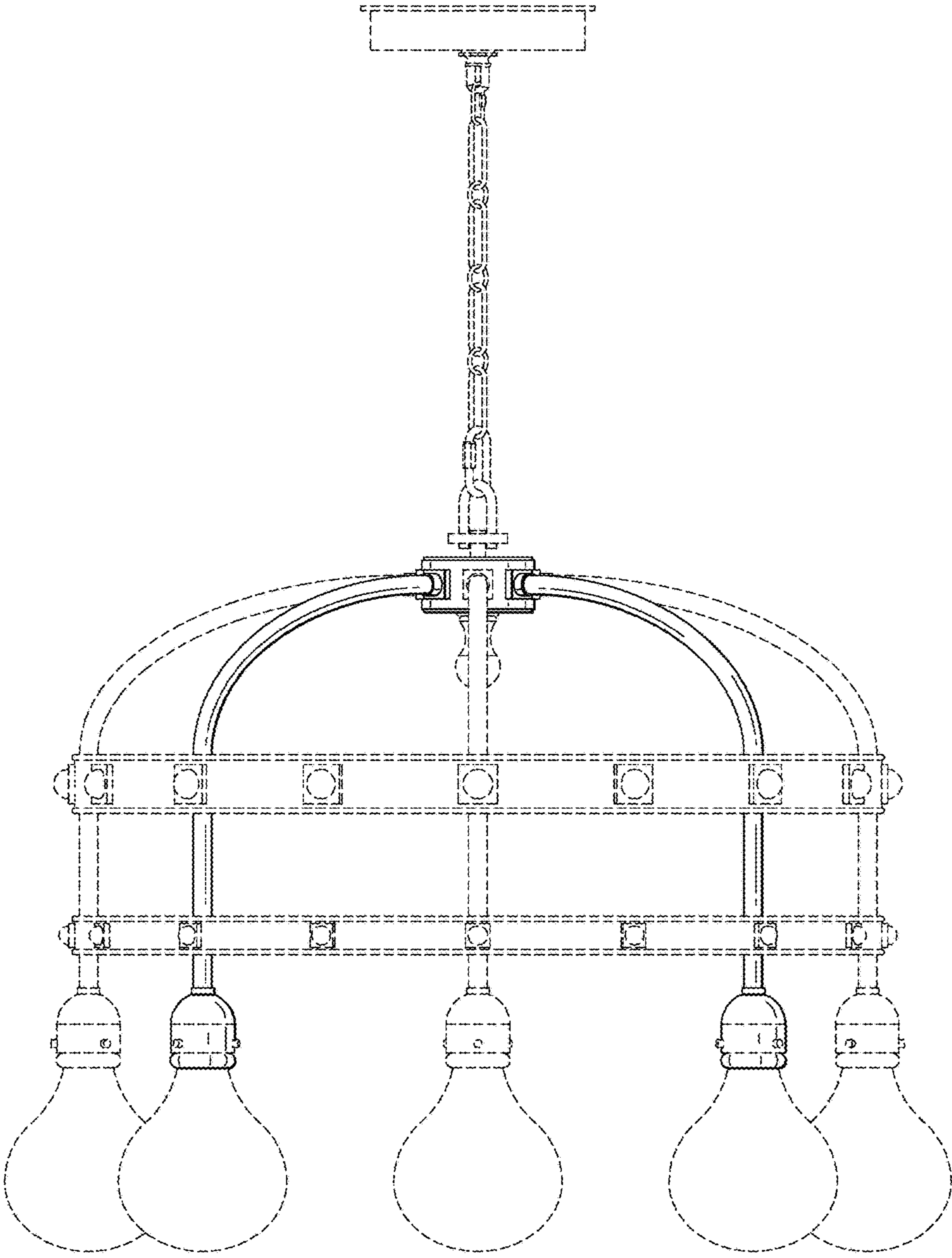

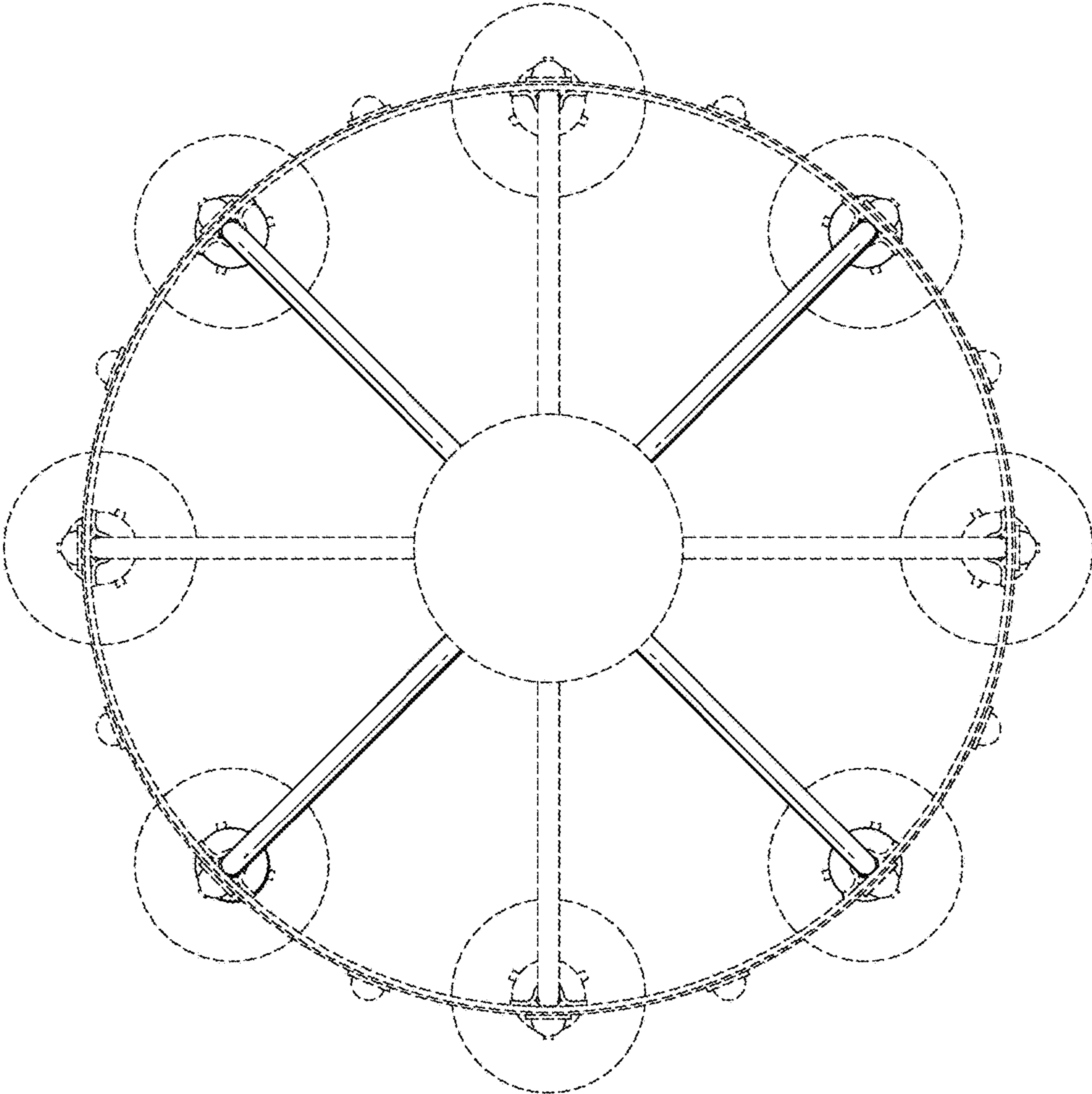

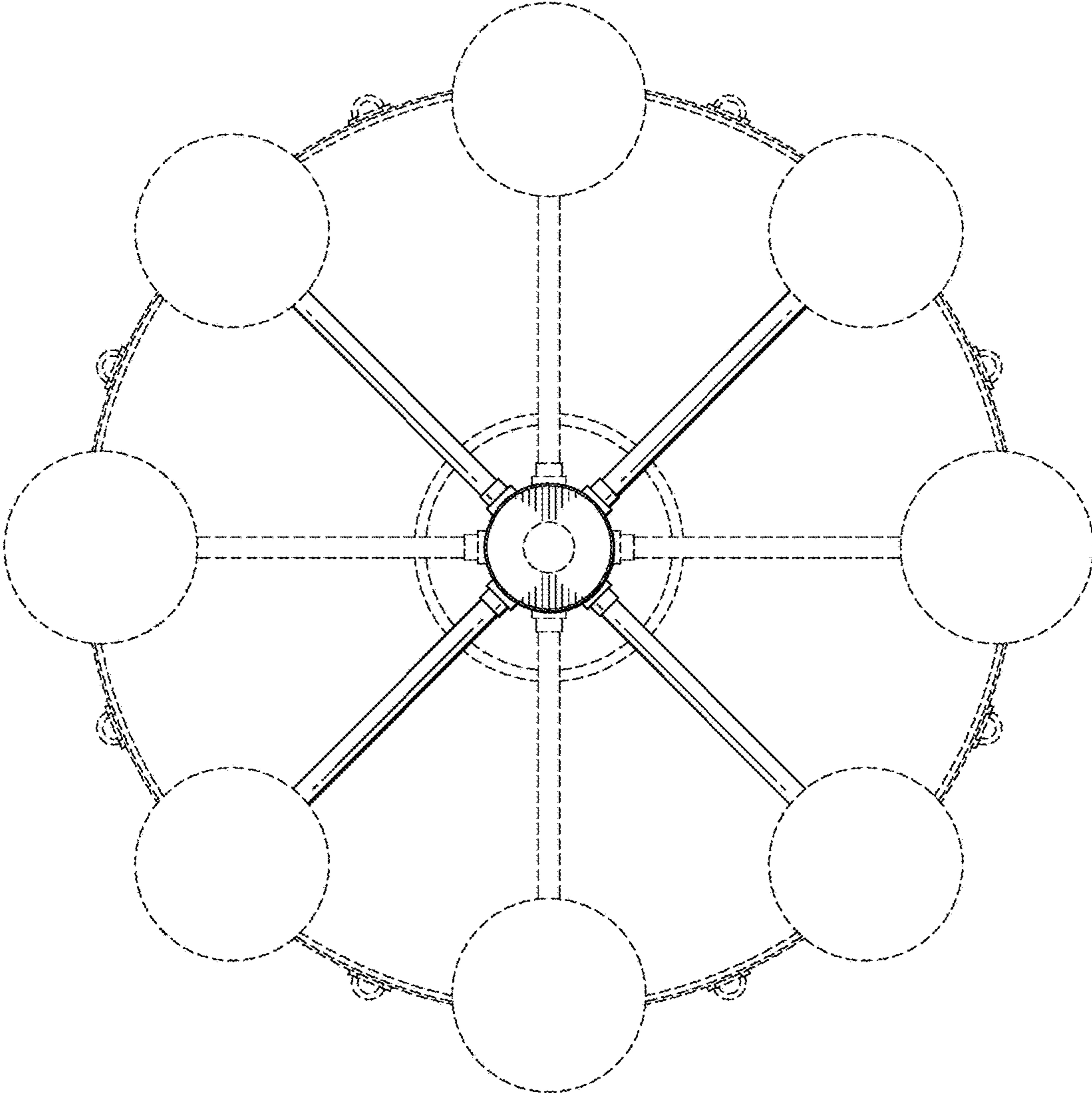
