FIG. 5 is a front view thereof, the back side view being the same.

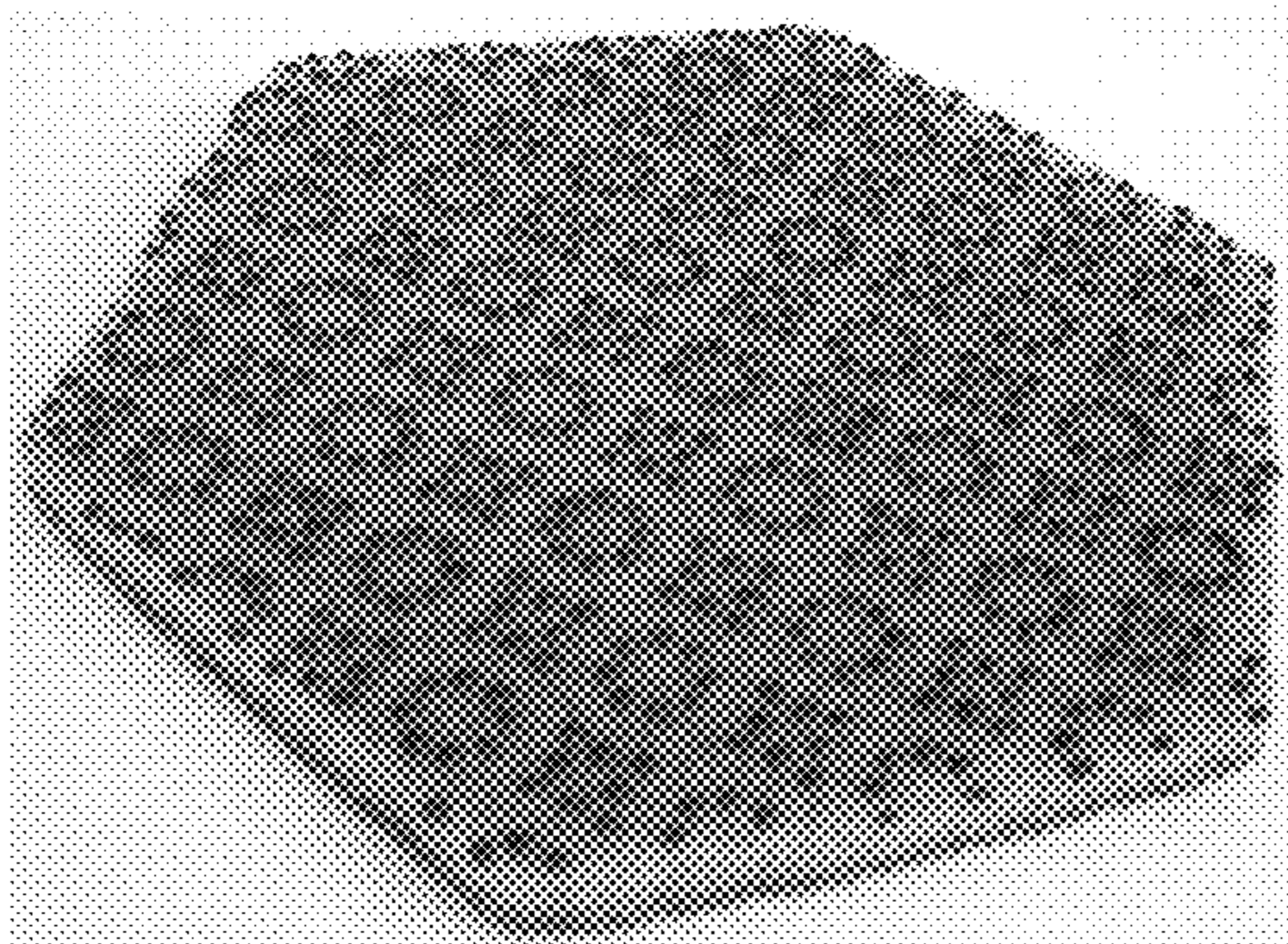

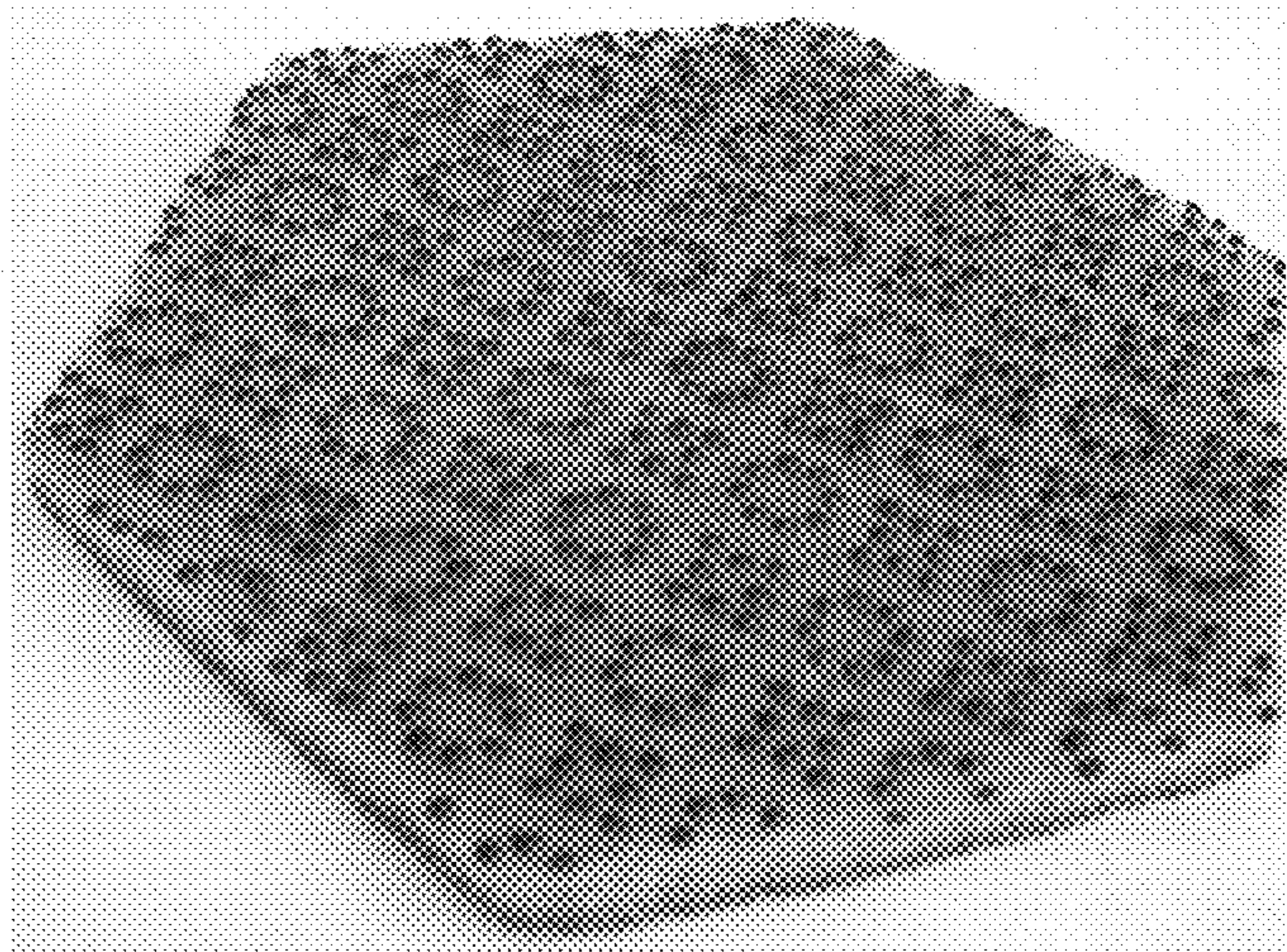

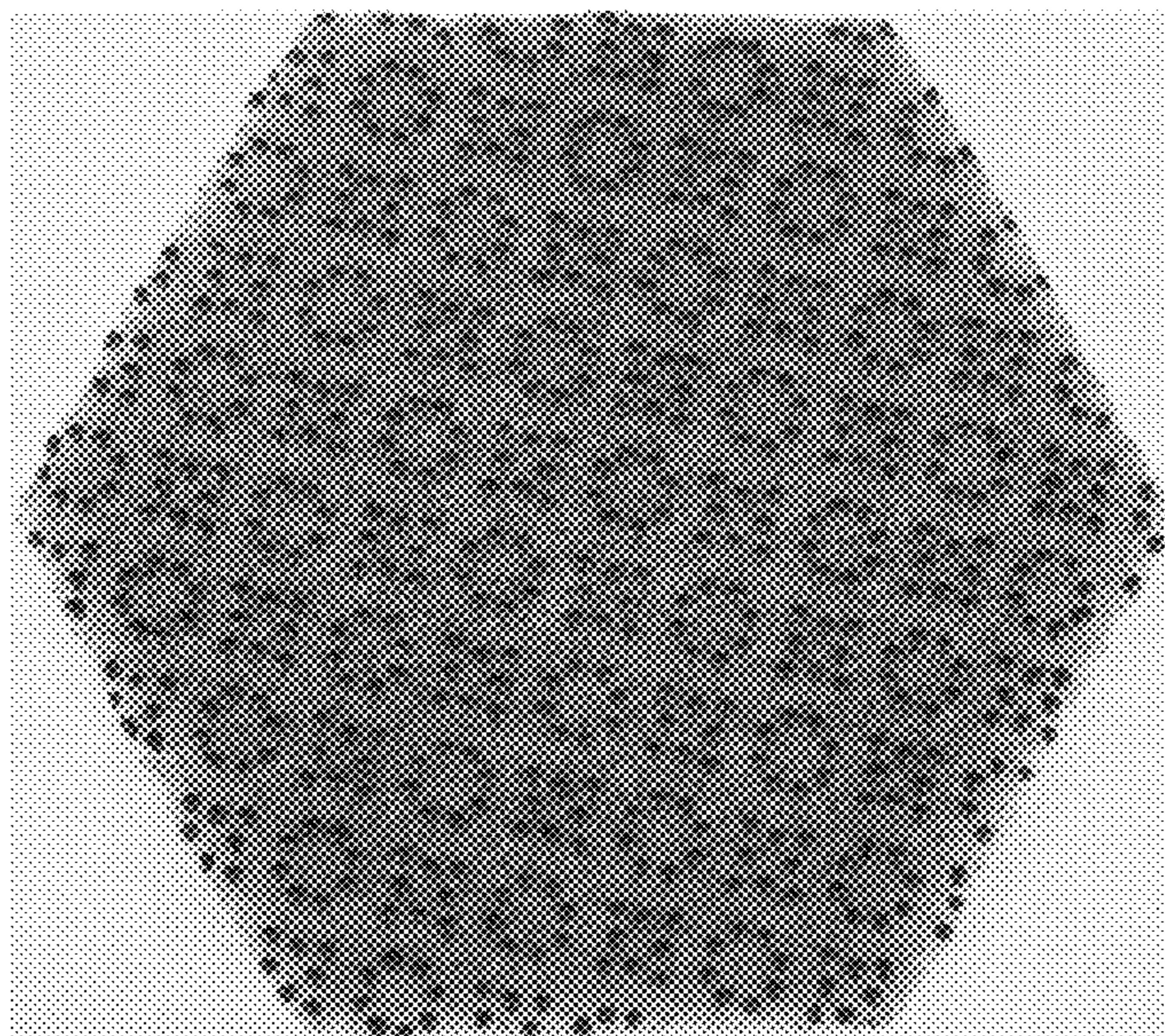

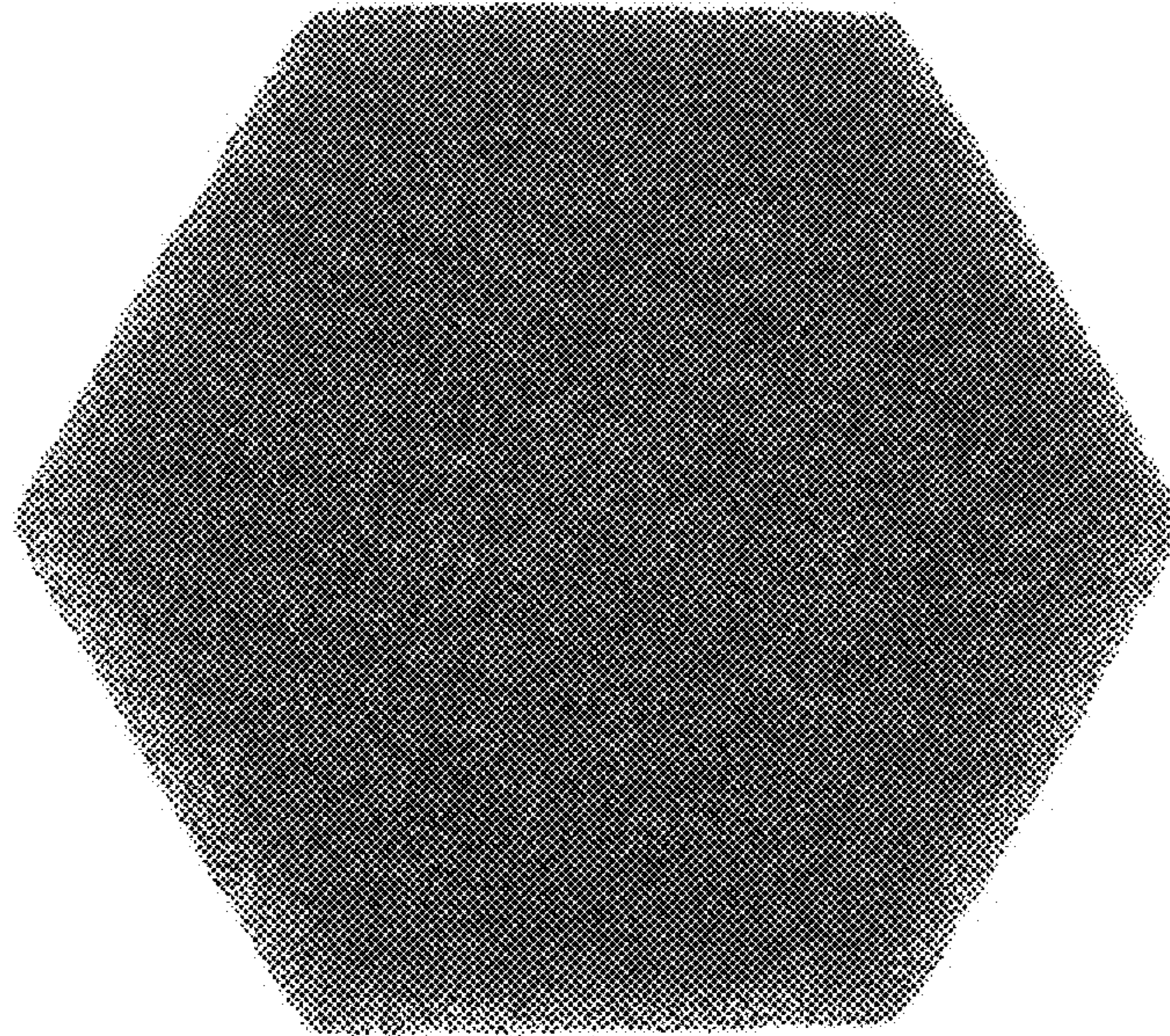

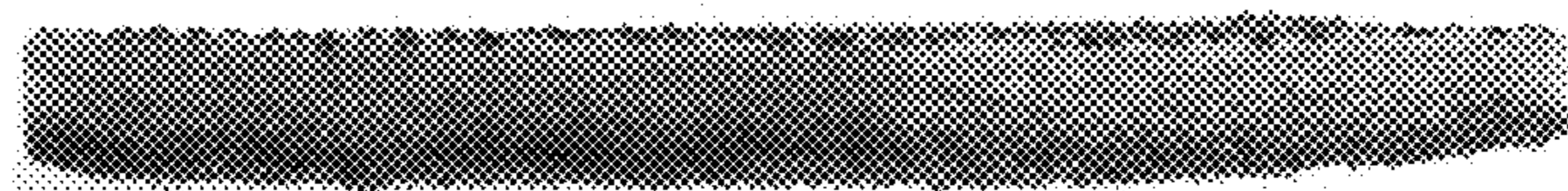
