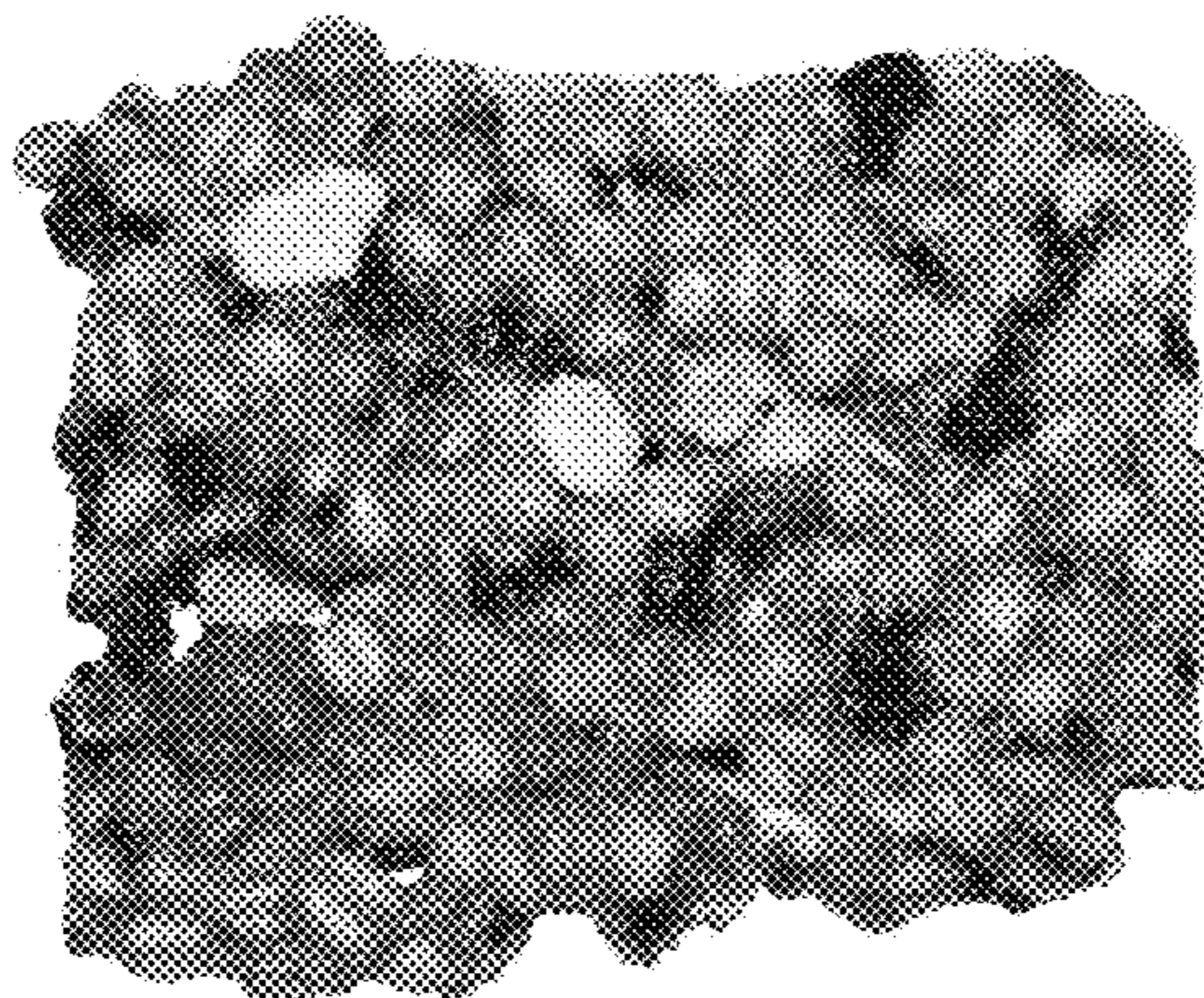
(57) **CLAIM**

The ornamental design for a thin food cluster, as shown and described.

DESCRIPTION

FIG. 11 is a front view of the thin food cluster of FIG. 10; and,
FIG. 12 is a side view of the thin food cluster of FIG. 10.

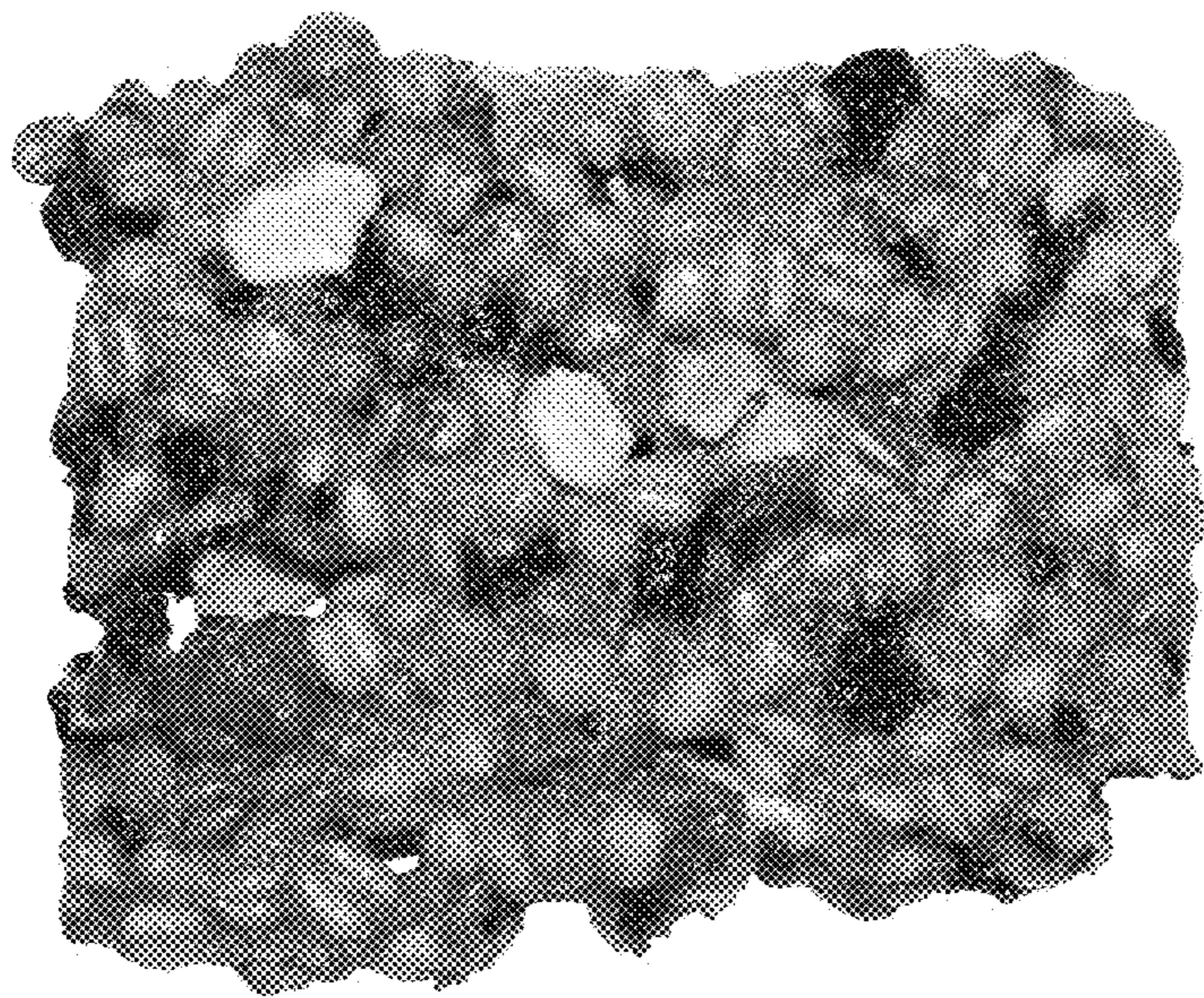

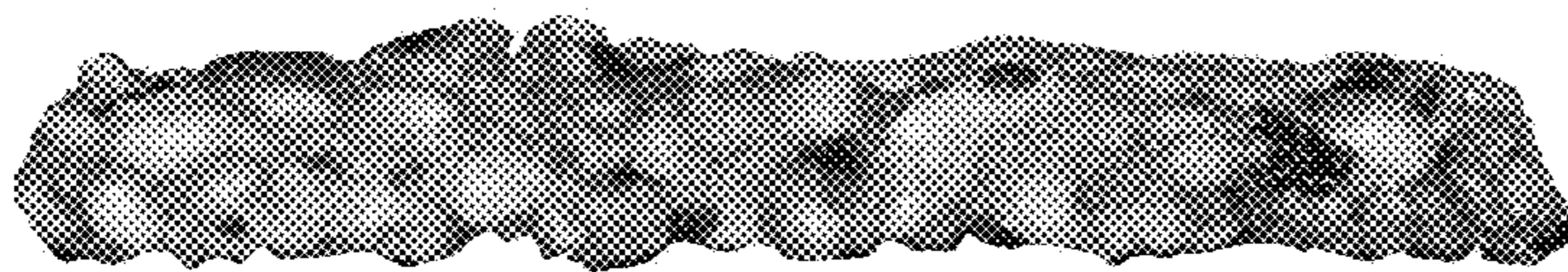

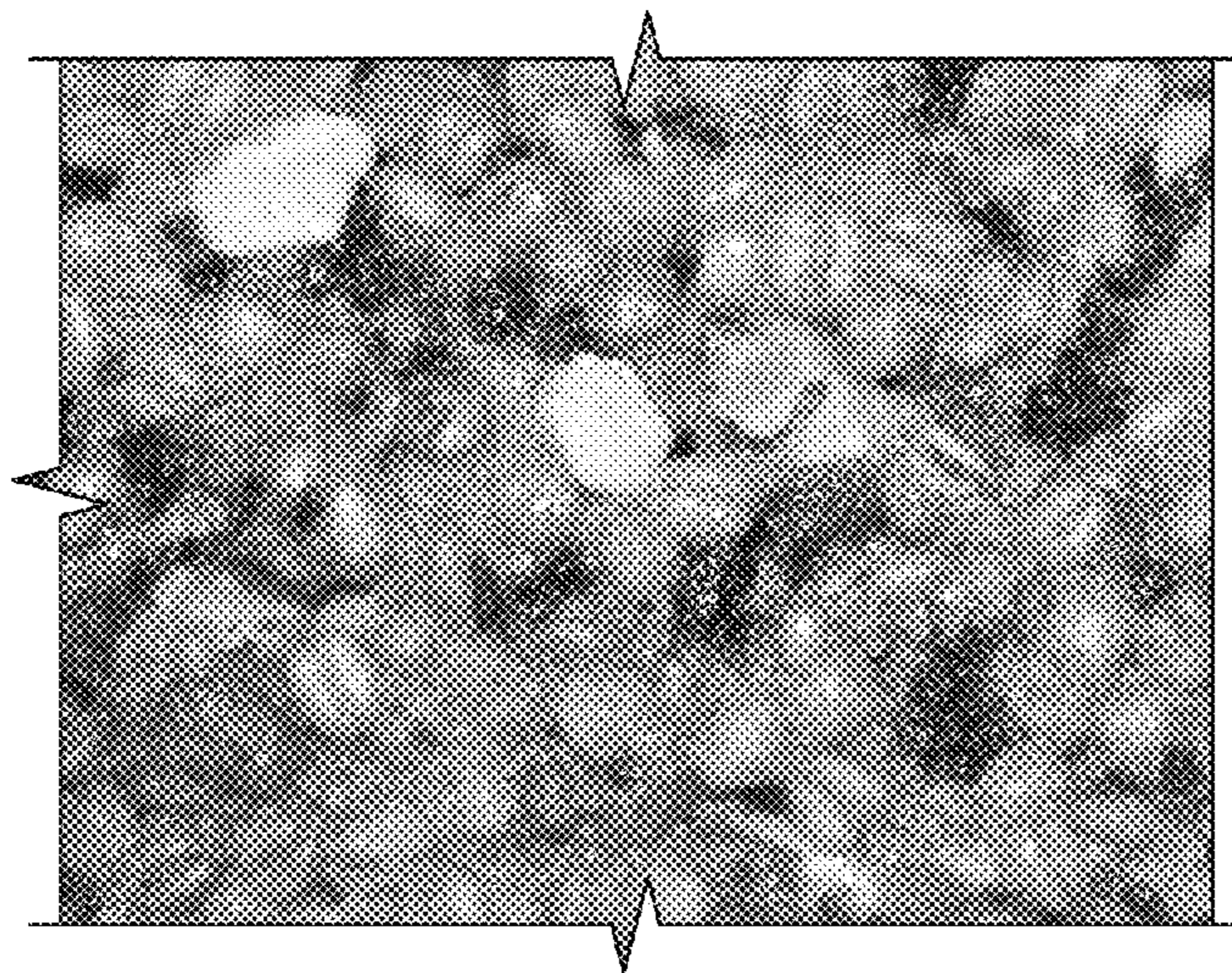

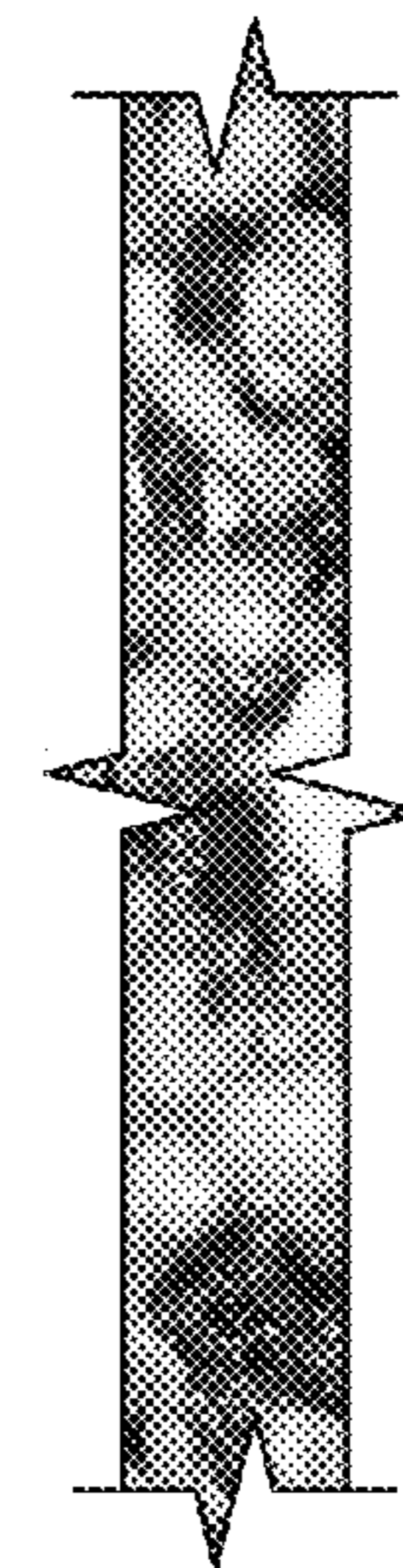

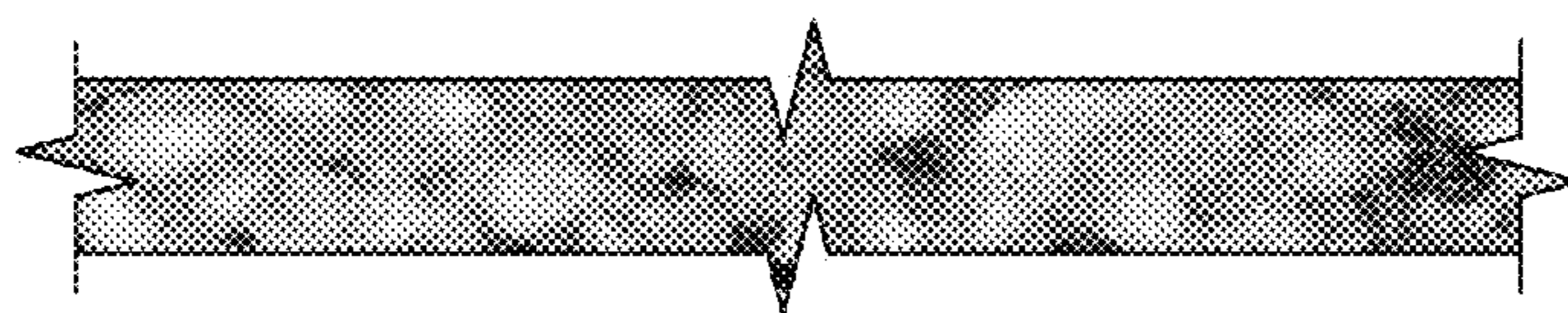

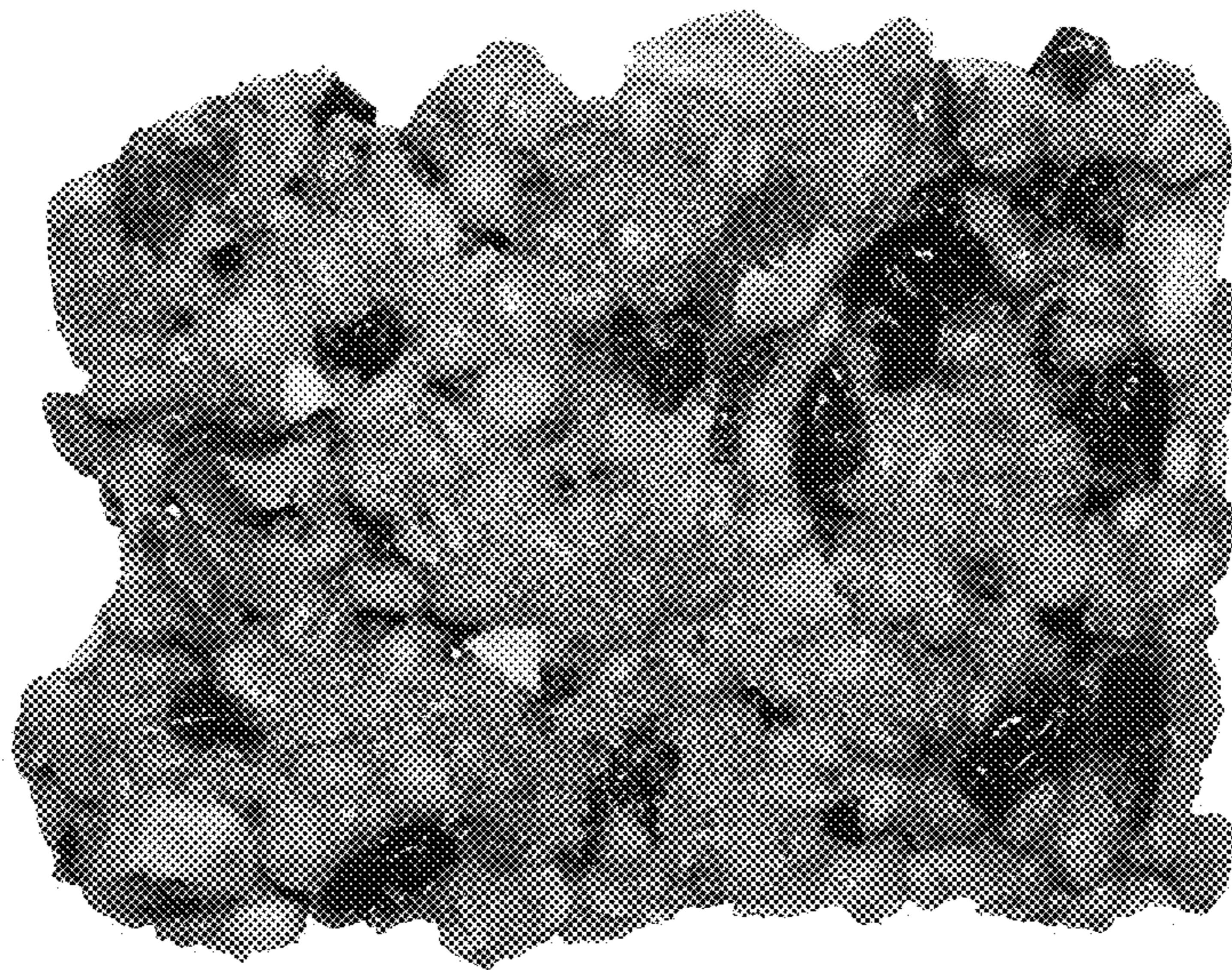

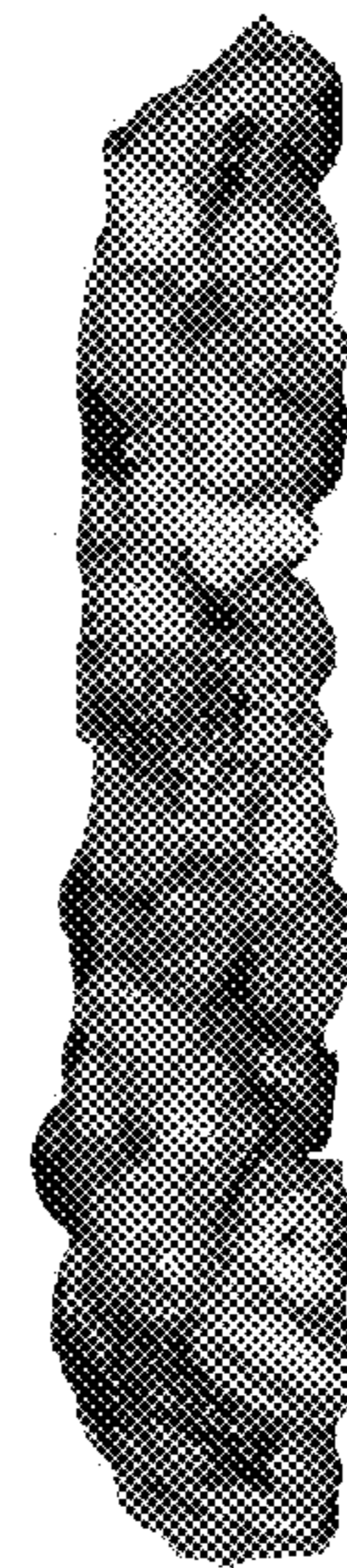

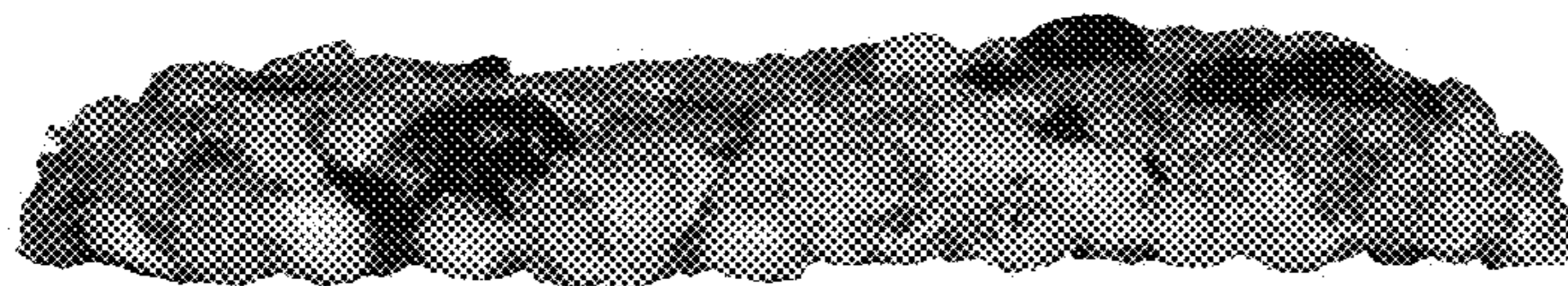

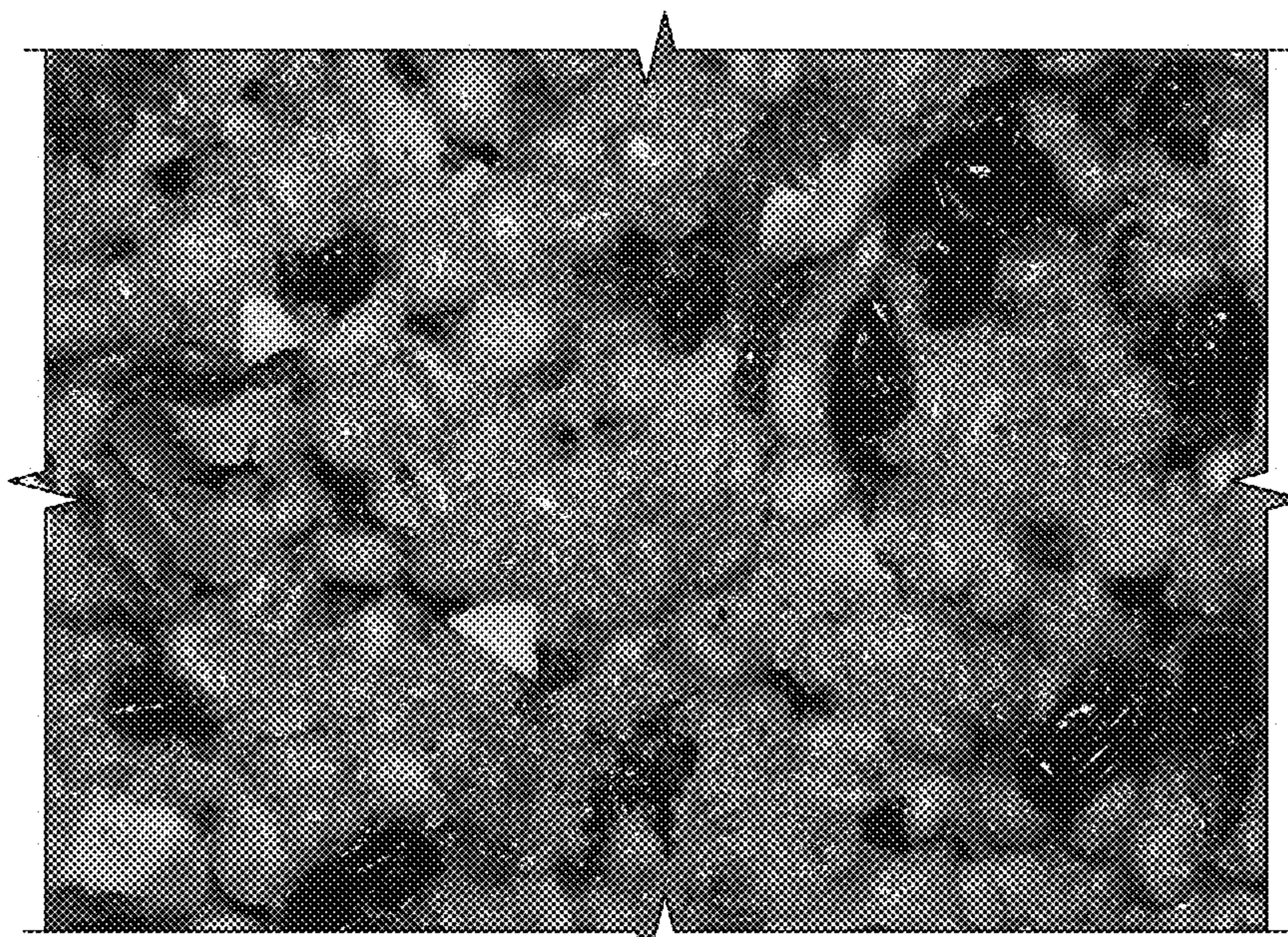

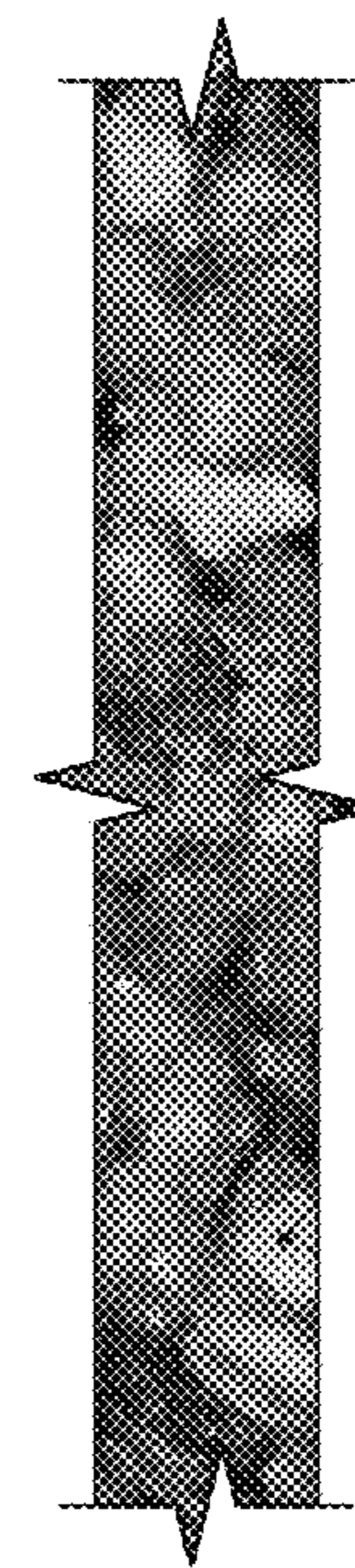

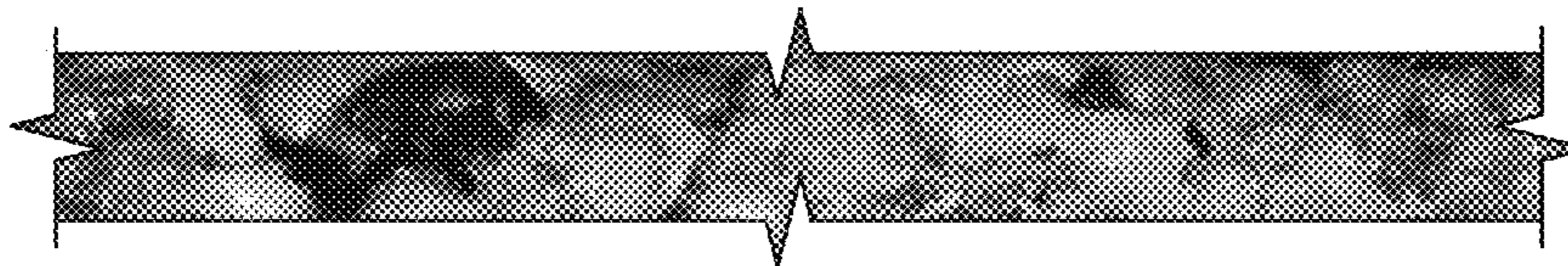
