We claim the ornamental design for a glove, as shown and described.

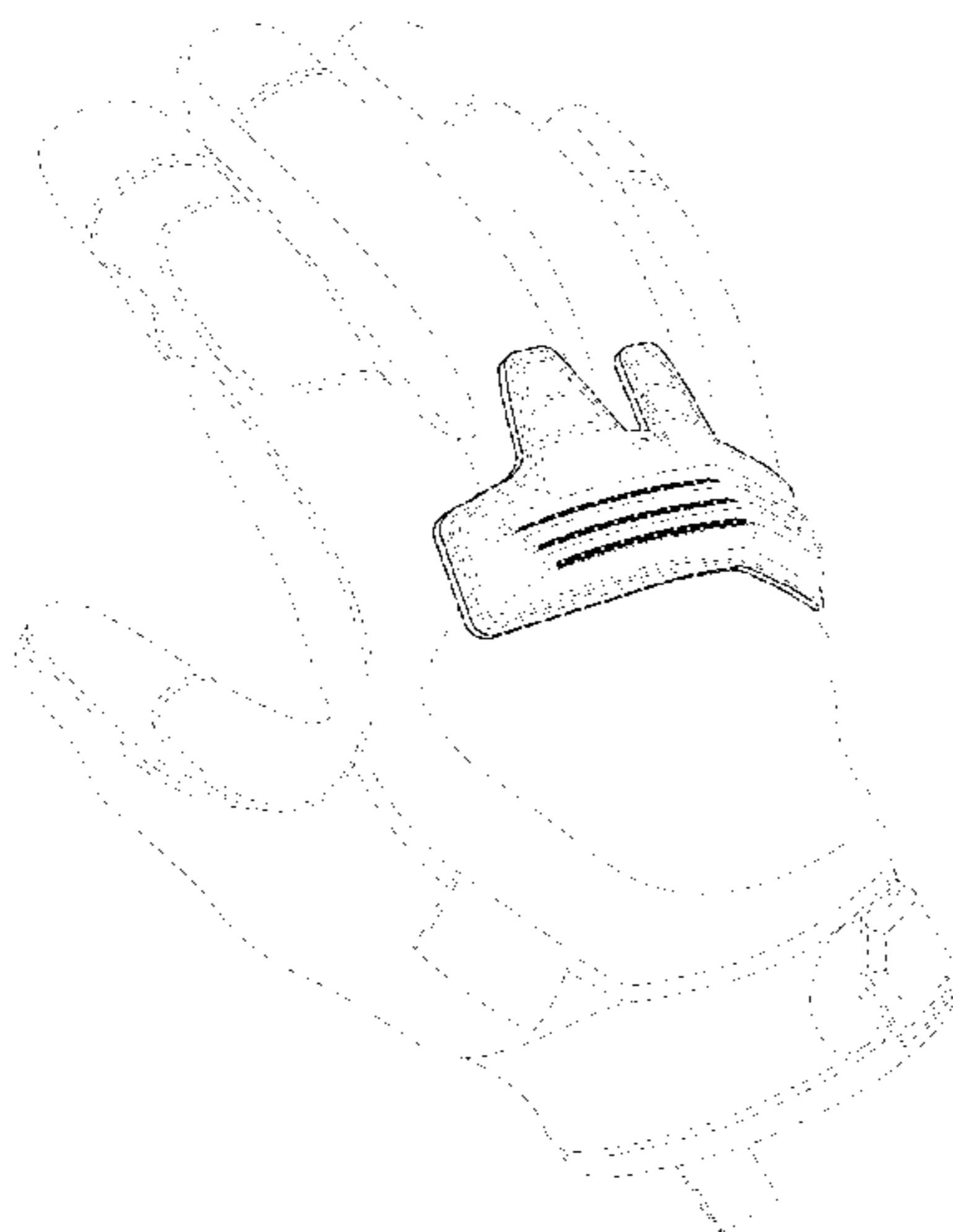
DESCRIPTION

FIG. 1 is a top perspective view of a right hand glove according to a first embodiment, showing our new design; FIG. 2 is a top view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top perspective view of a left hand glove according to a second embodiment, showing our new design; FIG. 6 is a top view thereof; FIG. 7 is a right side view thereof; FIG. 8 is a left side view thereof; FIG. 9 is a top perspective view of a right hand glove according to a third embodiment, showing our new design; FIG. 10 is a top view thereof; FIG. 11 is a top perspective view of a left hand glove according to a fourth embodiment, showing our new design; and, FIG. 12 is a top view thereof.

Any line in a black-lined drawing or colored drawing may provide a boundary line of a claimed design element. A boundary line of a claimed design element may be defined in an area between lines in a black-lined drawing or a colored drawing. An element or a subset of any combination of elements in a drawing may form a claimed design. Any portion of the glove shown in broken lines is included for the purpose of illustrating environment and forms no part of the claimed design.

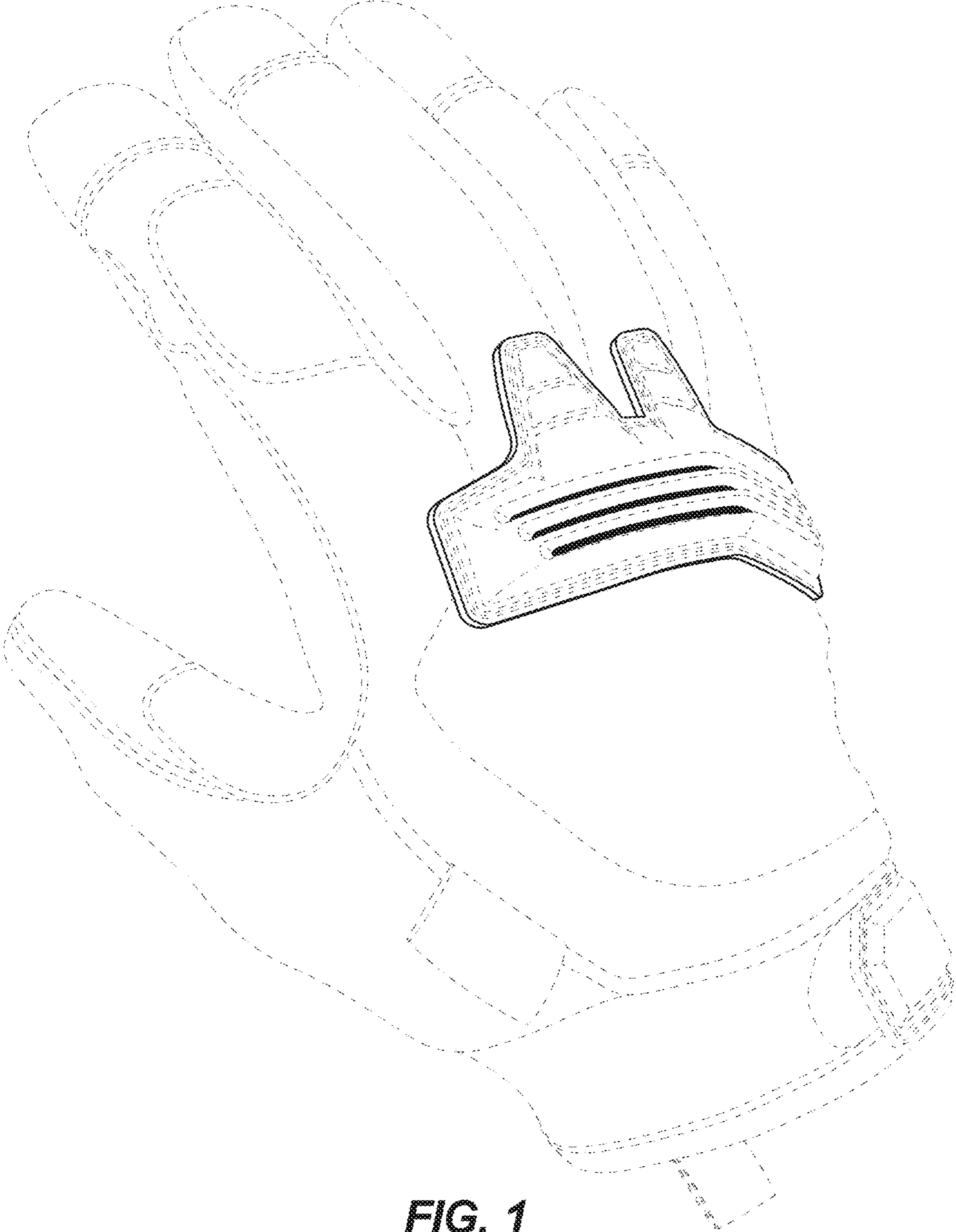

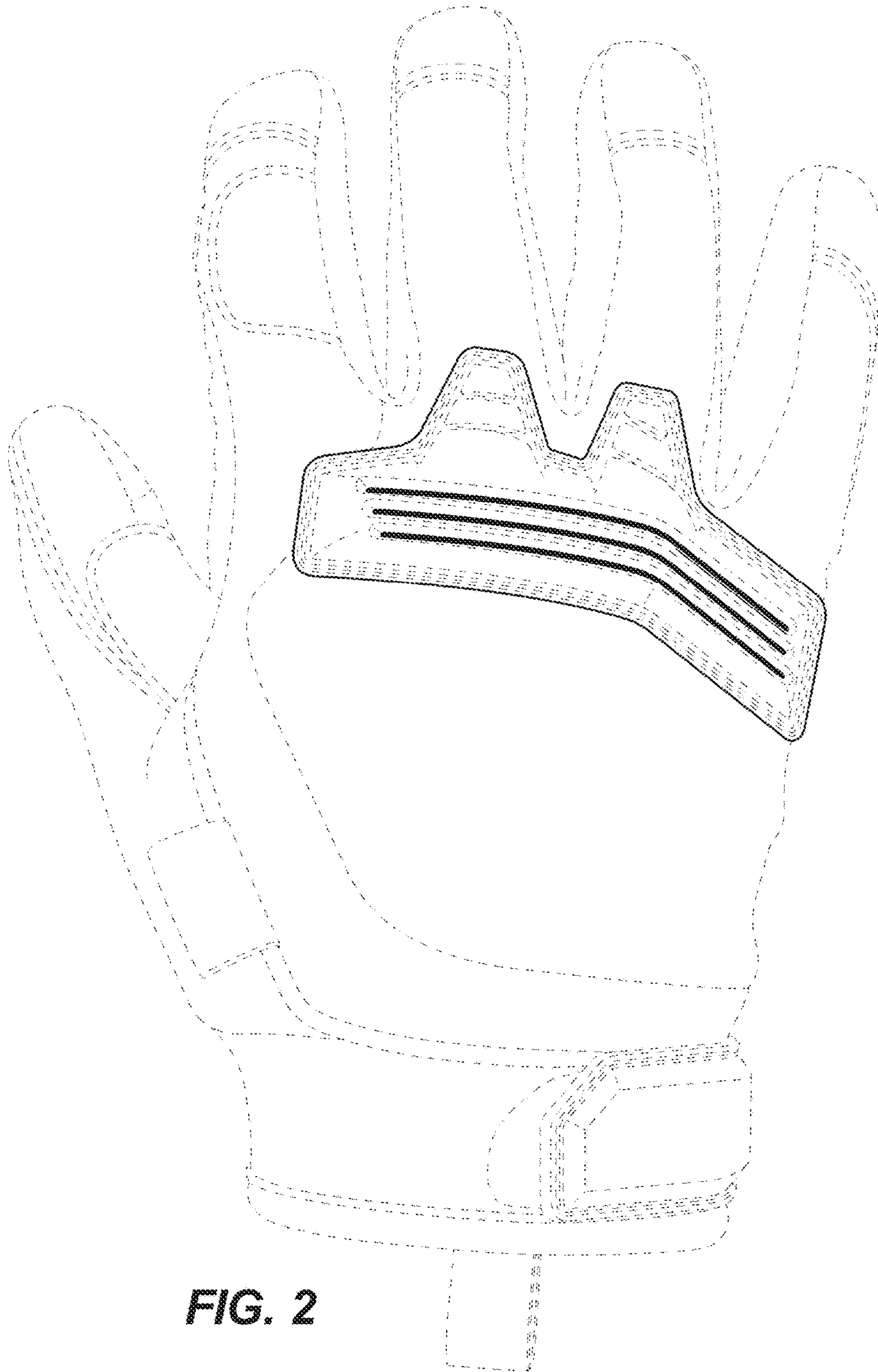
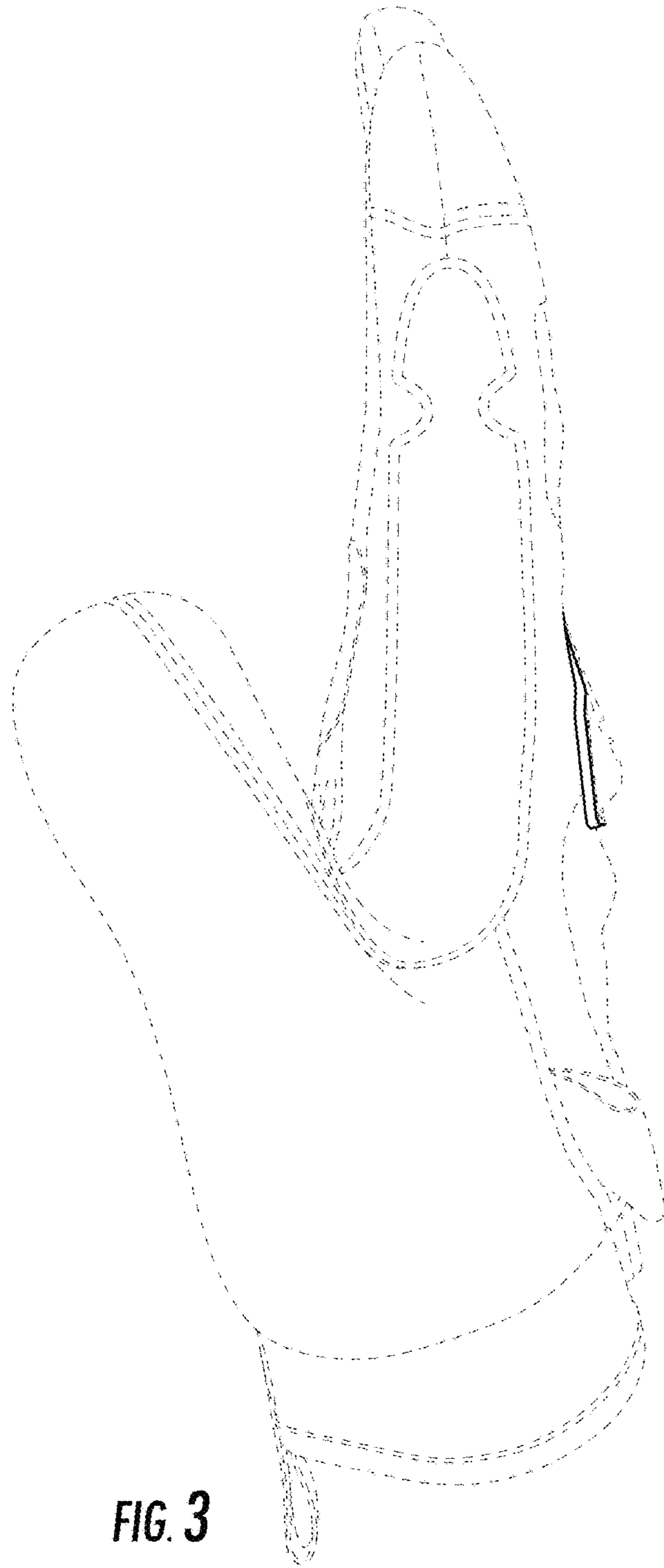

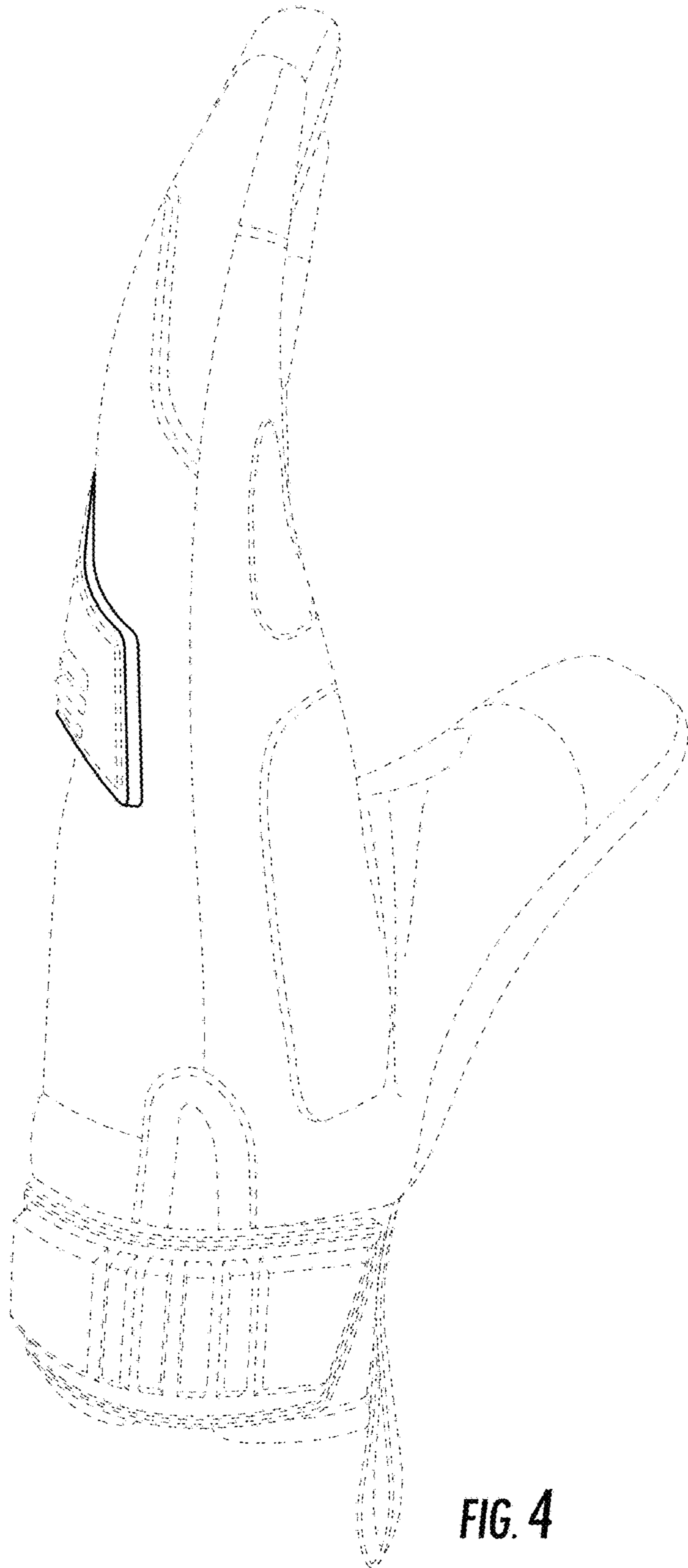

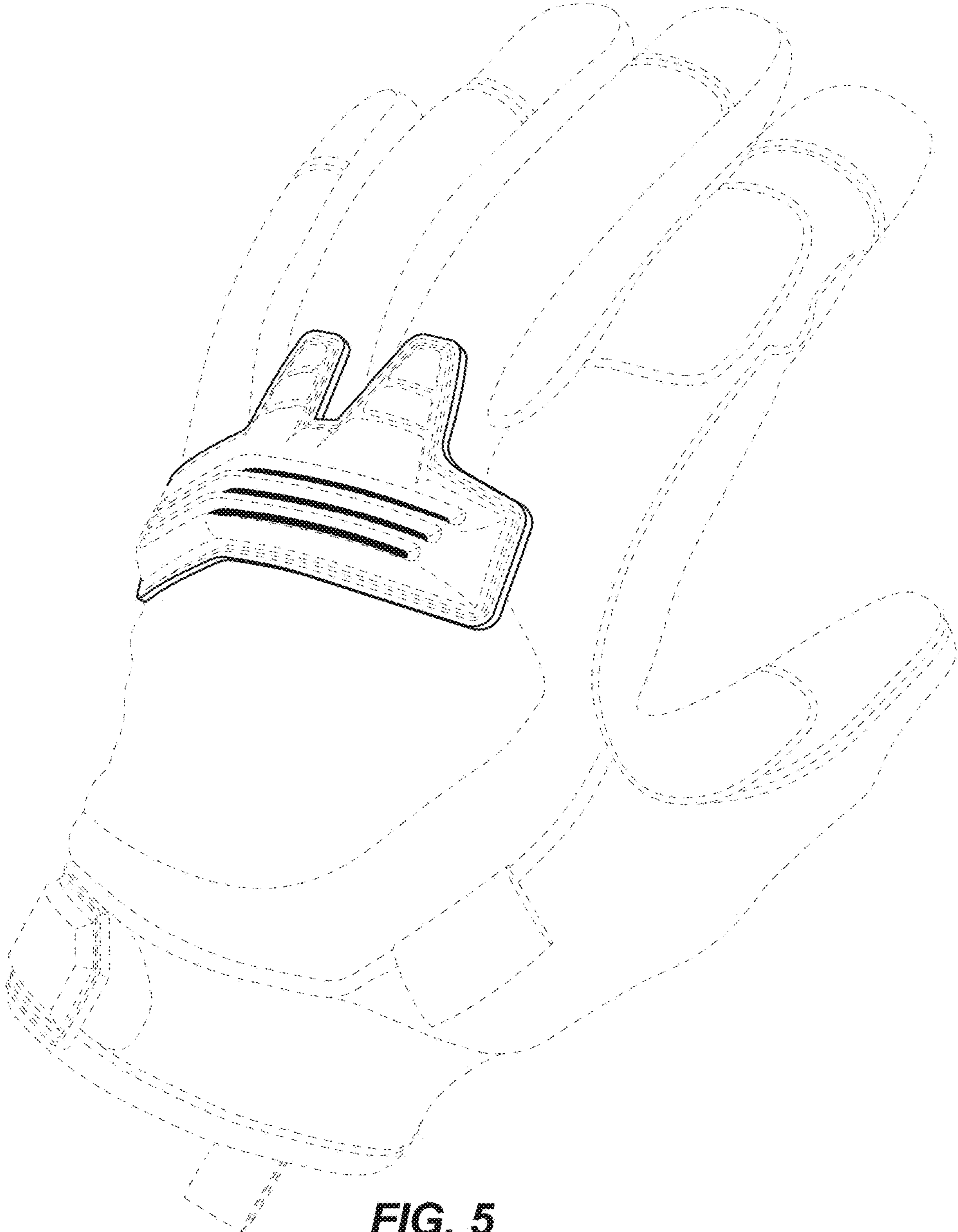

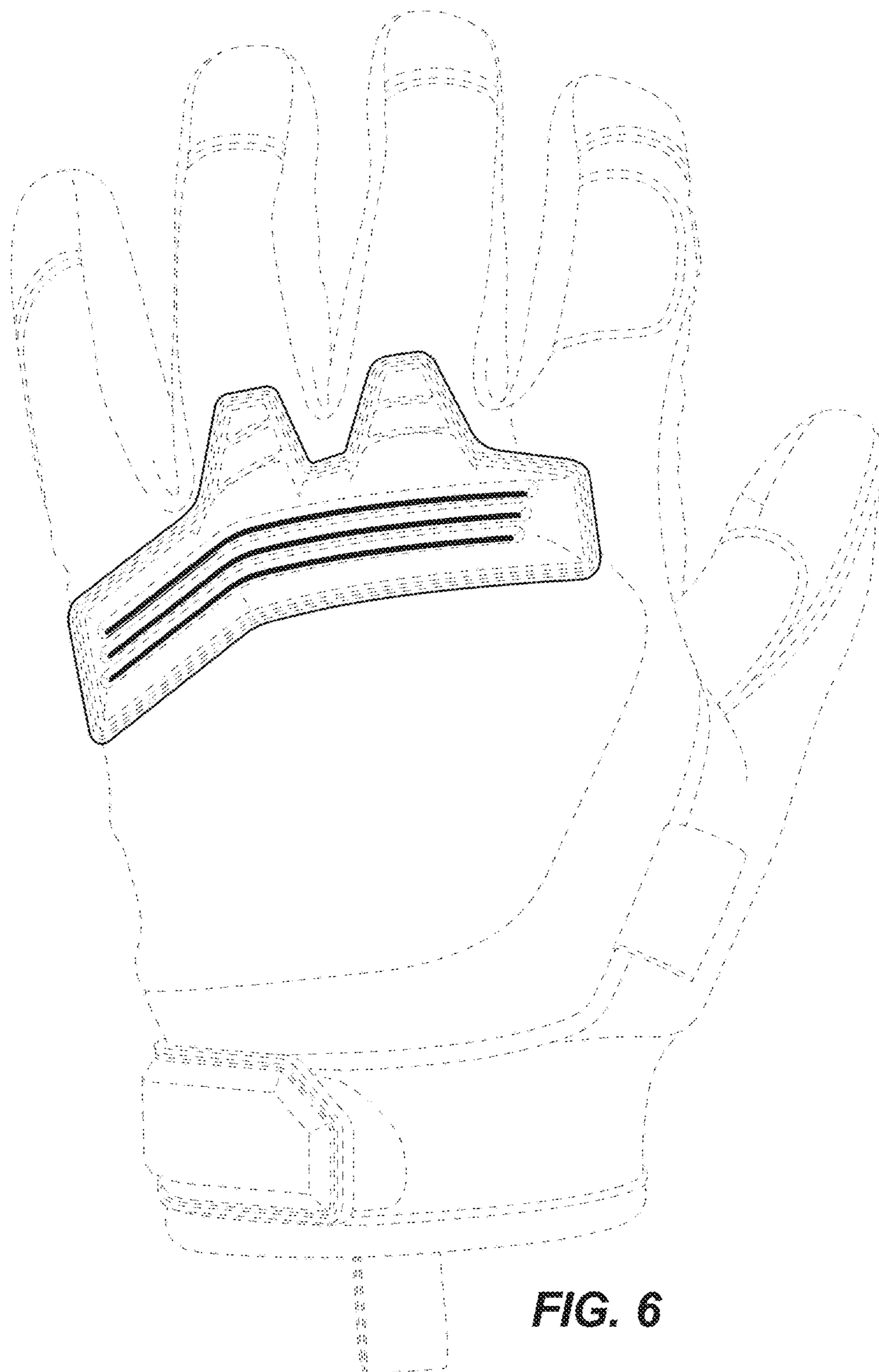

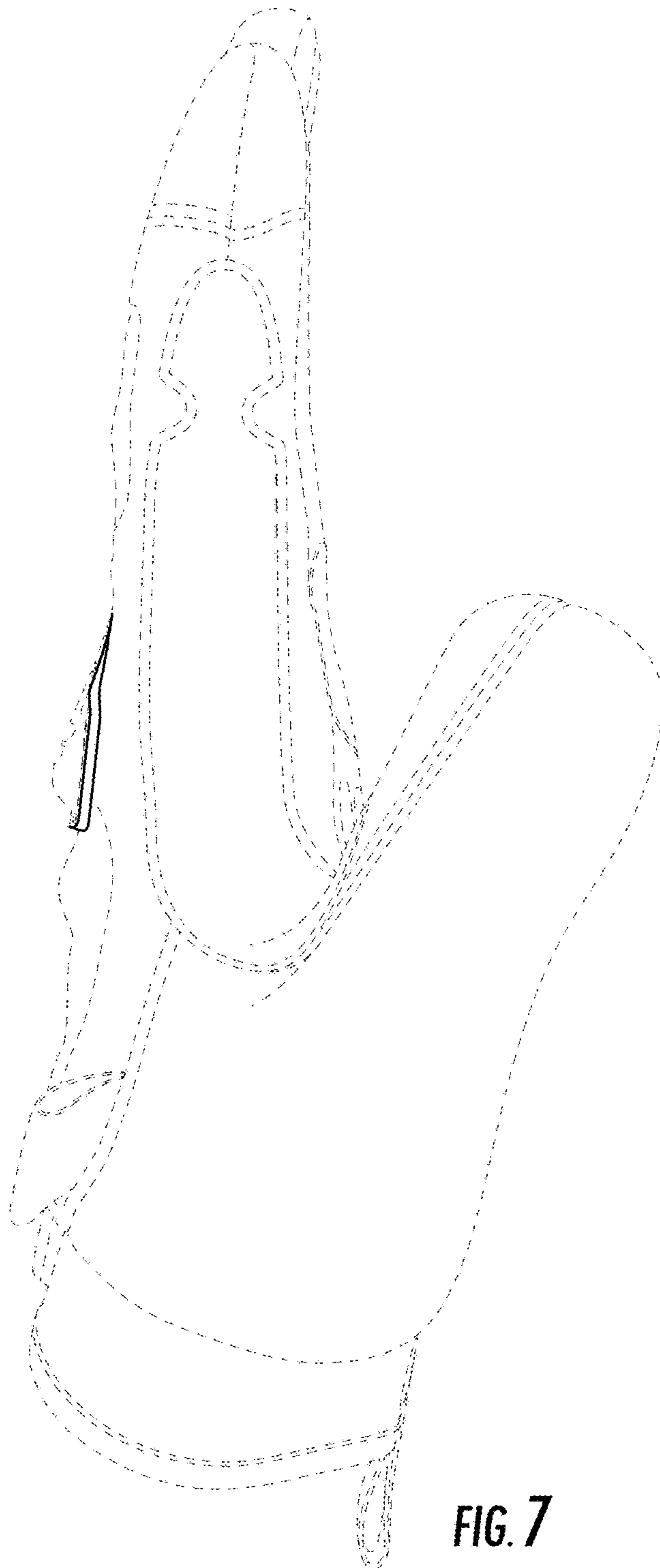

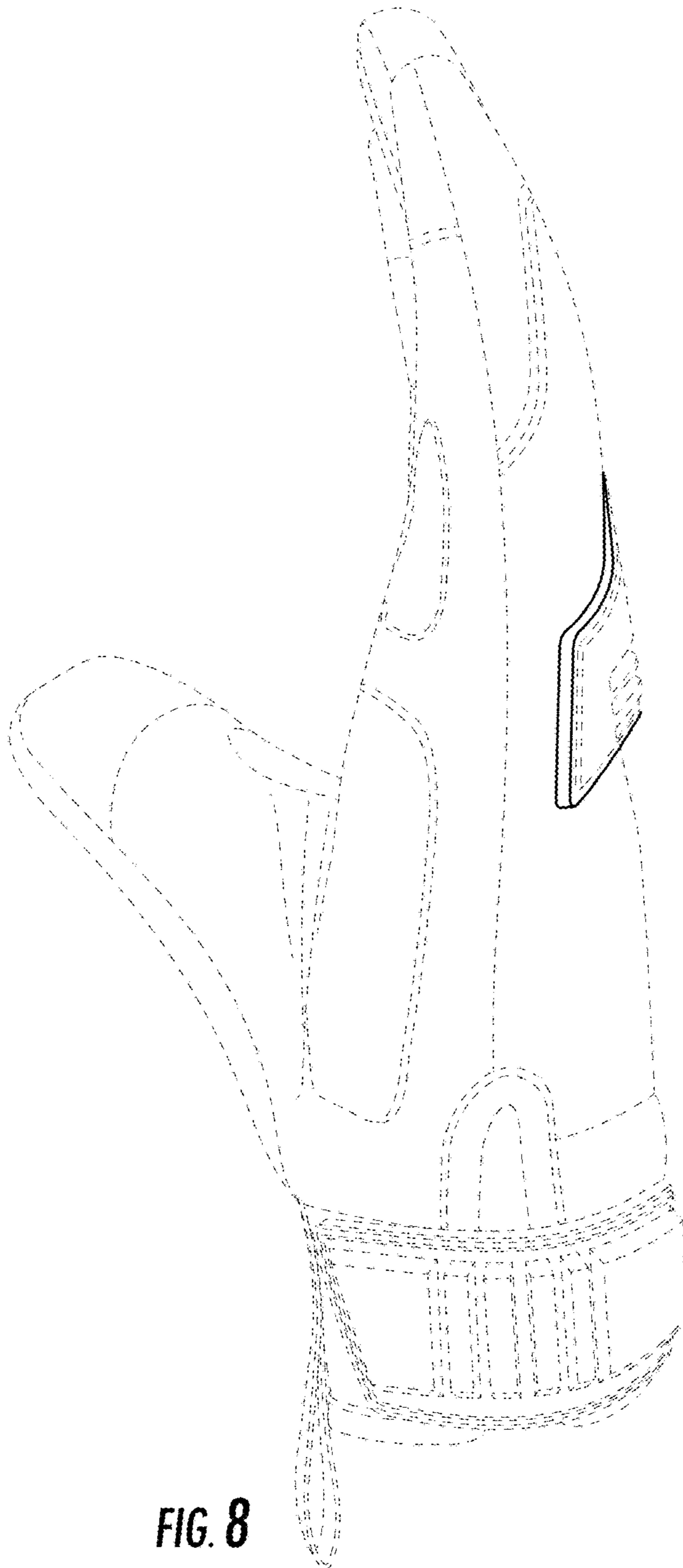

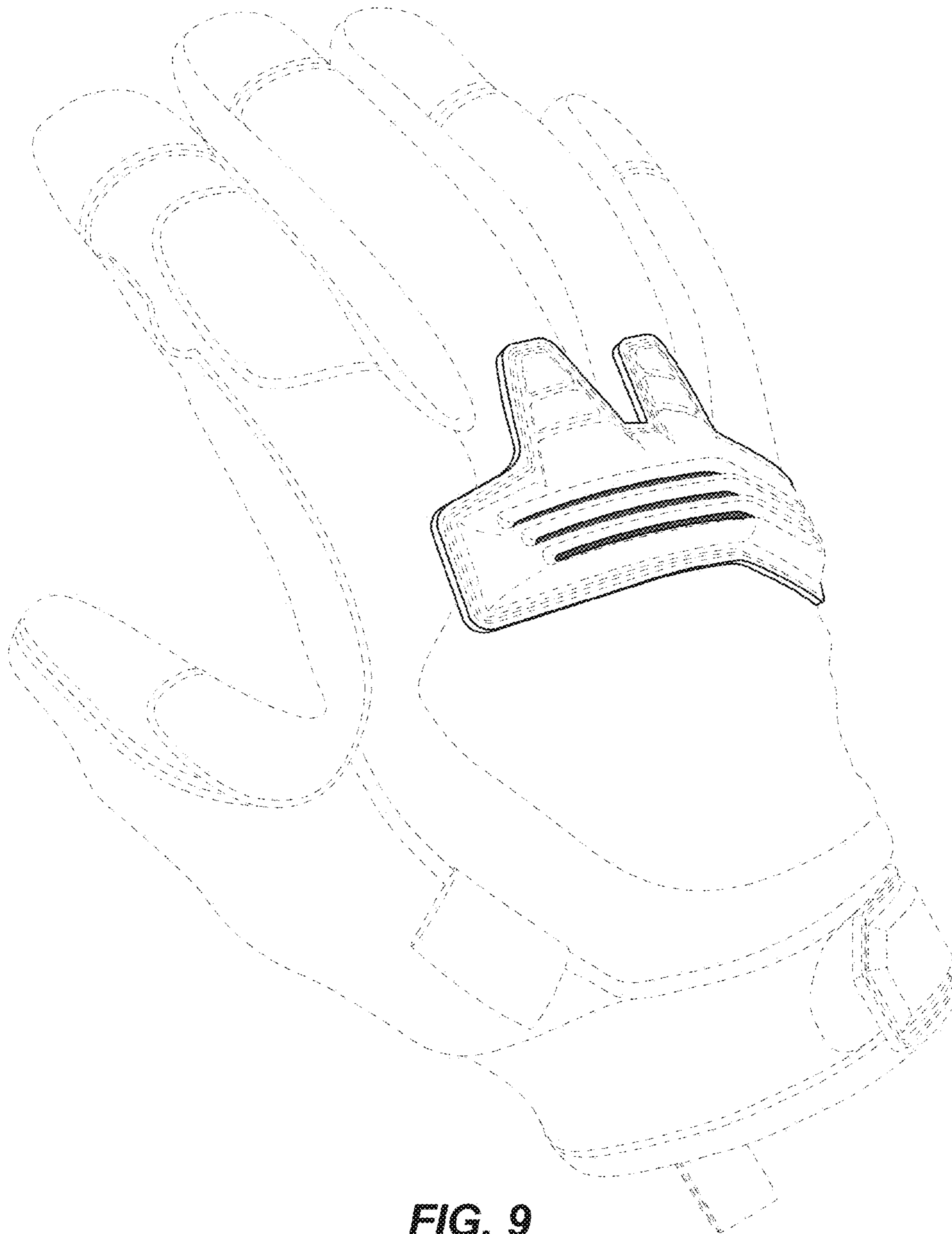

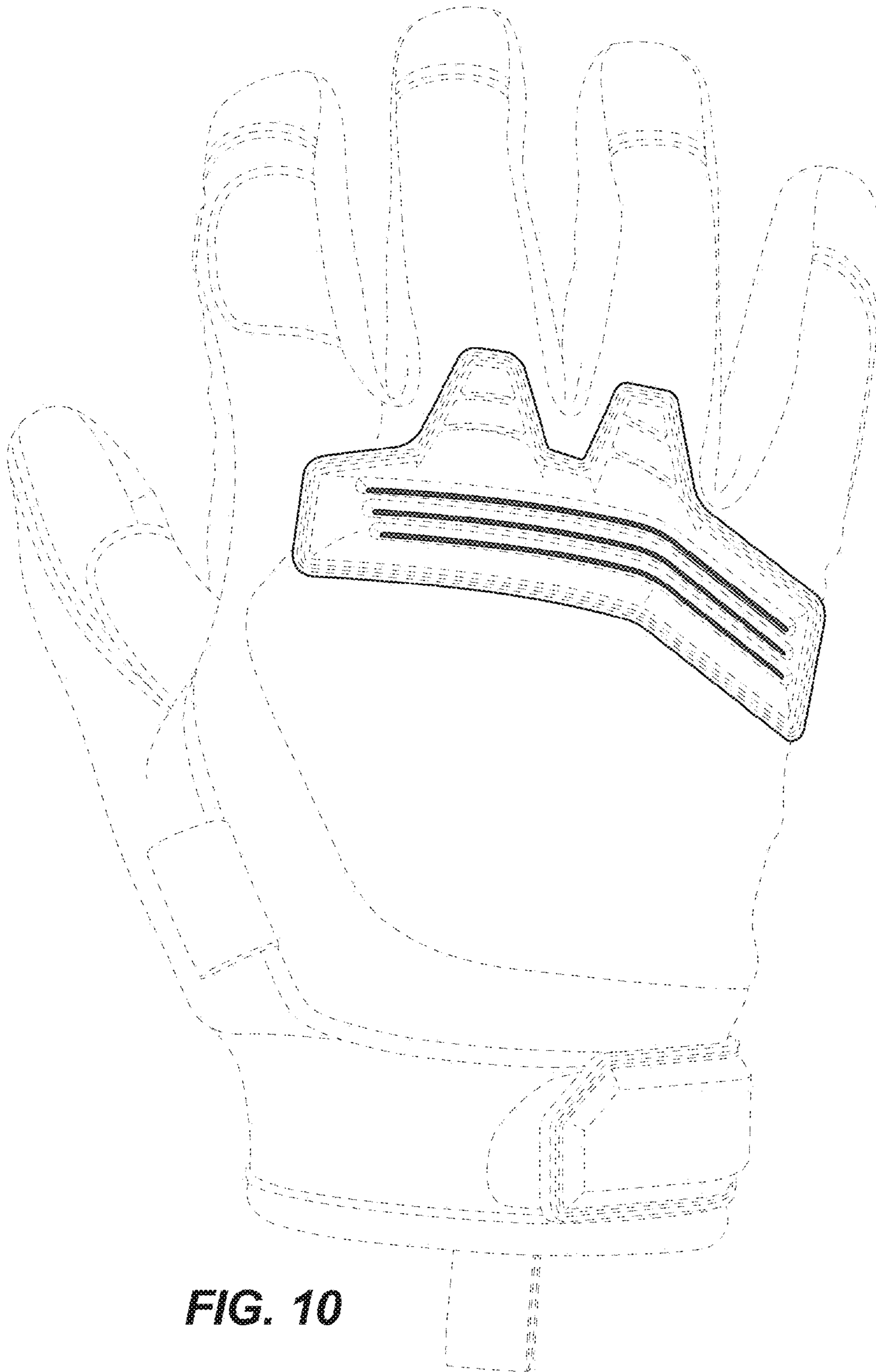

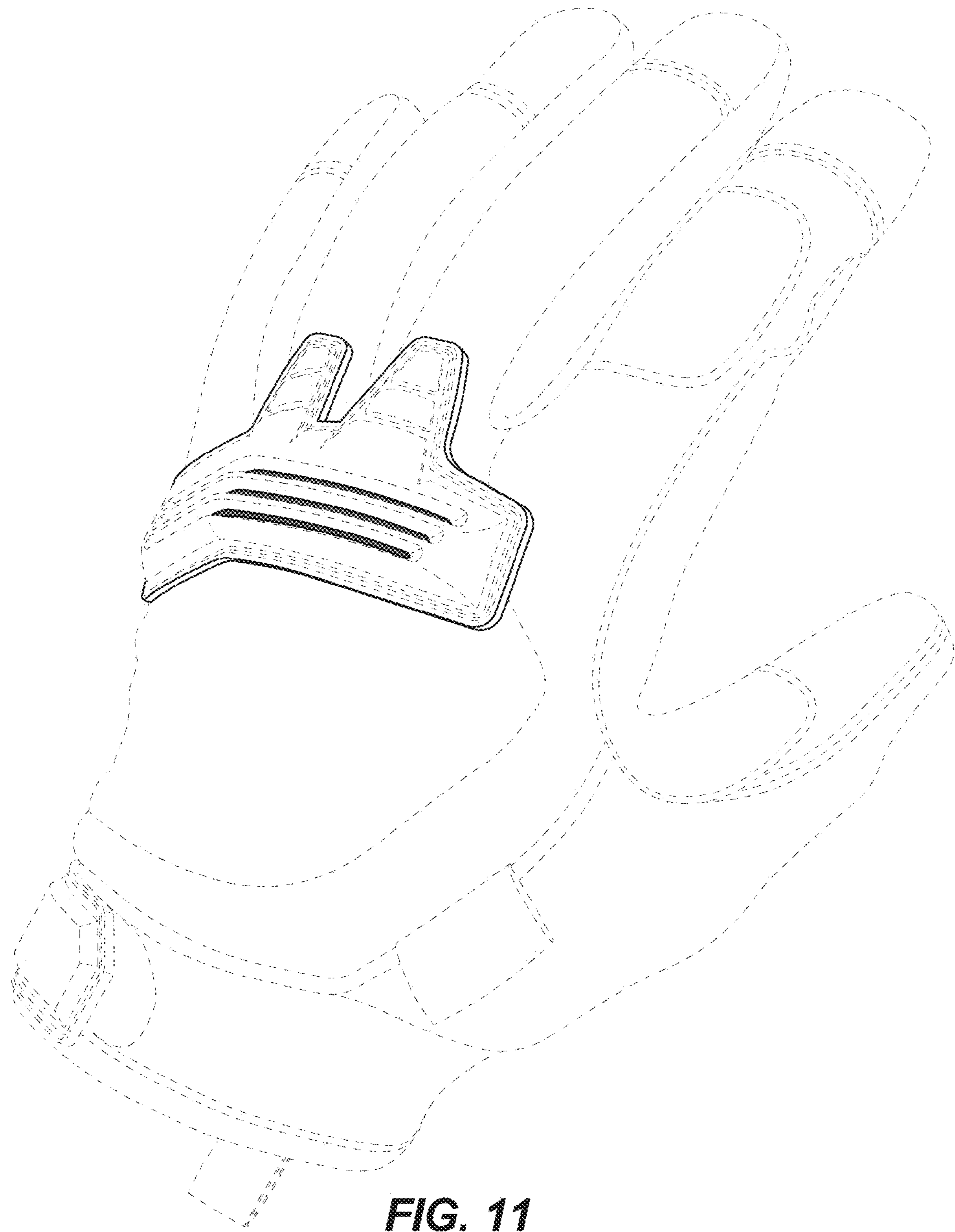

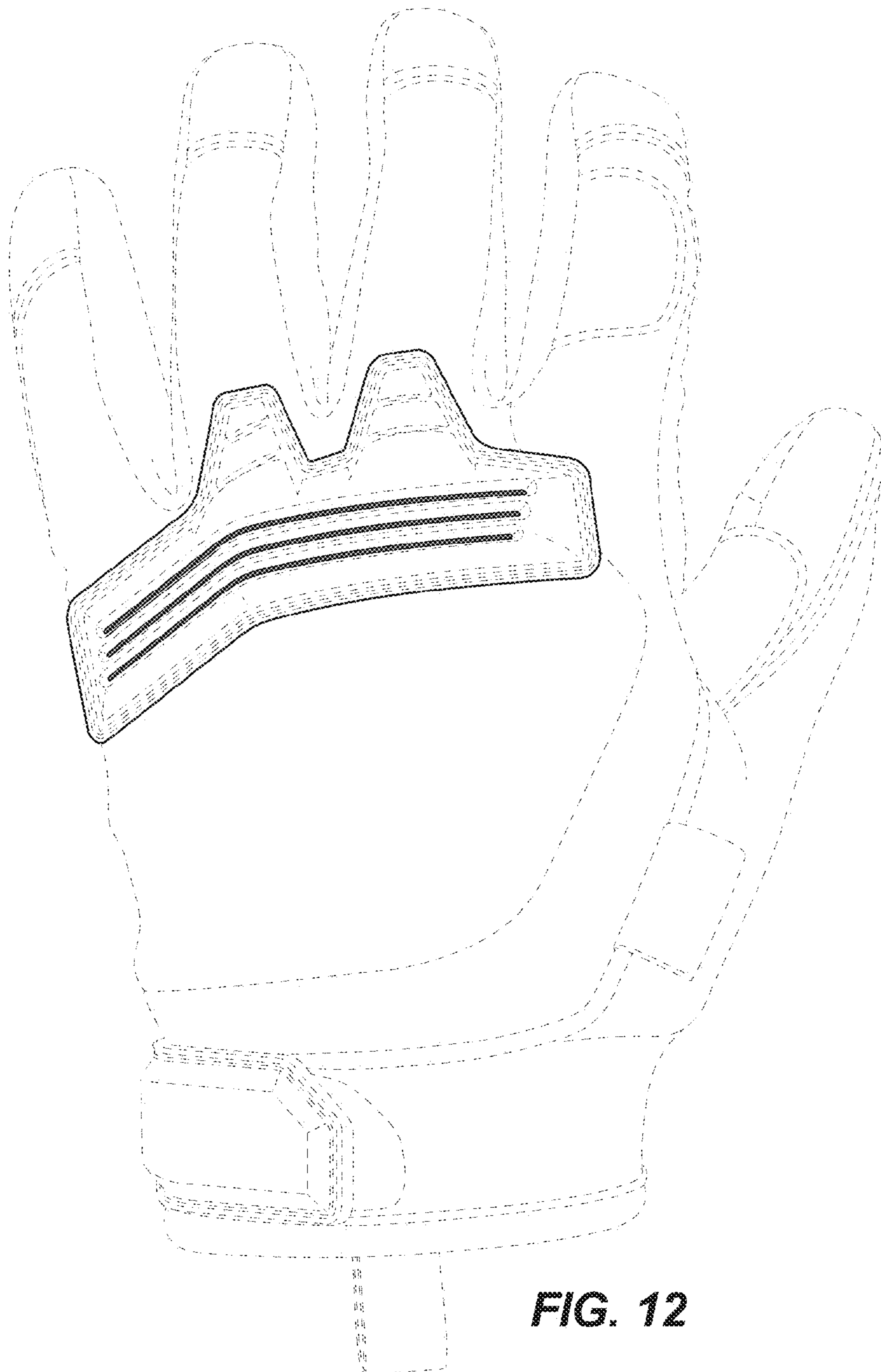
