(57) **CLAIM**

An ornamental design for a men's underwear, as shown and described.

DESCRIPTION

FIG. 1 is a back elevational view of the men's underwear in a non-intended use position and showing the outer surface of the rear portion of the underwear. Wavy lines show the construction surrounded by the wrinkled fabric;

FIG. 2 is a front elevational view of the men's underwear of FIG. 1;

FIG. 3 is a left plan view thereof;

FIG. 4 is a right plan view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a back elevational view of the men's underwear not being worn and showing the inside surface of the rear portion of the men's underwear, dashed dotted lines showing stitches holding the elastic bands in place;

FIG. 8 is the left plan view of FIG. 7;

FIG. 9 is a back perspective view of the men's underwear of FIG. 1, being worn in an intended use position and showing the outer surface of the rear portion of the lifting underwear;

FIG. 10 is a front perspective view of the men's underwear of FIG. 9;

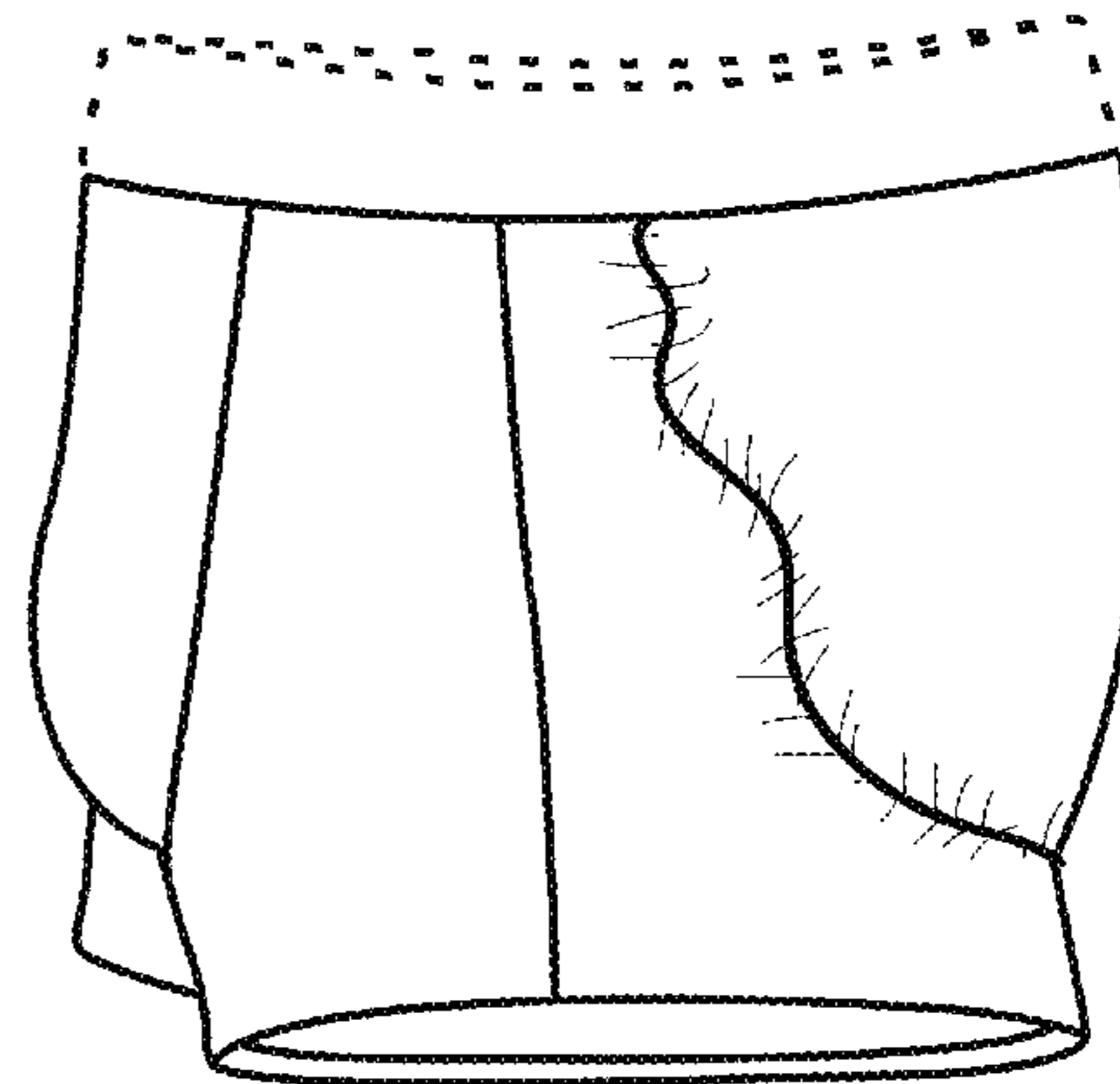
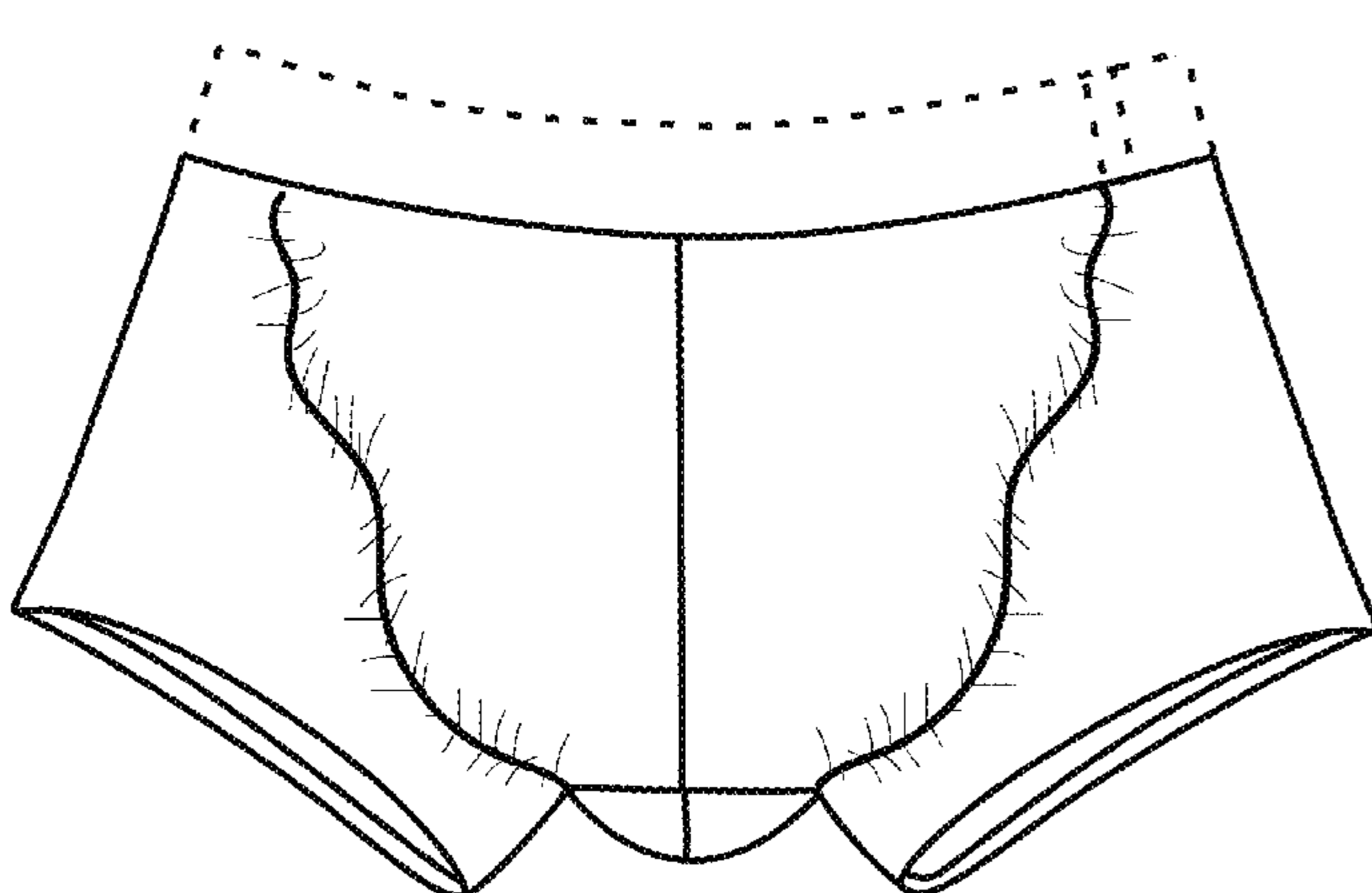
FIG. 11 is a left side perspective view of FIG. 9; and,

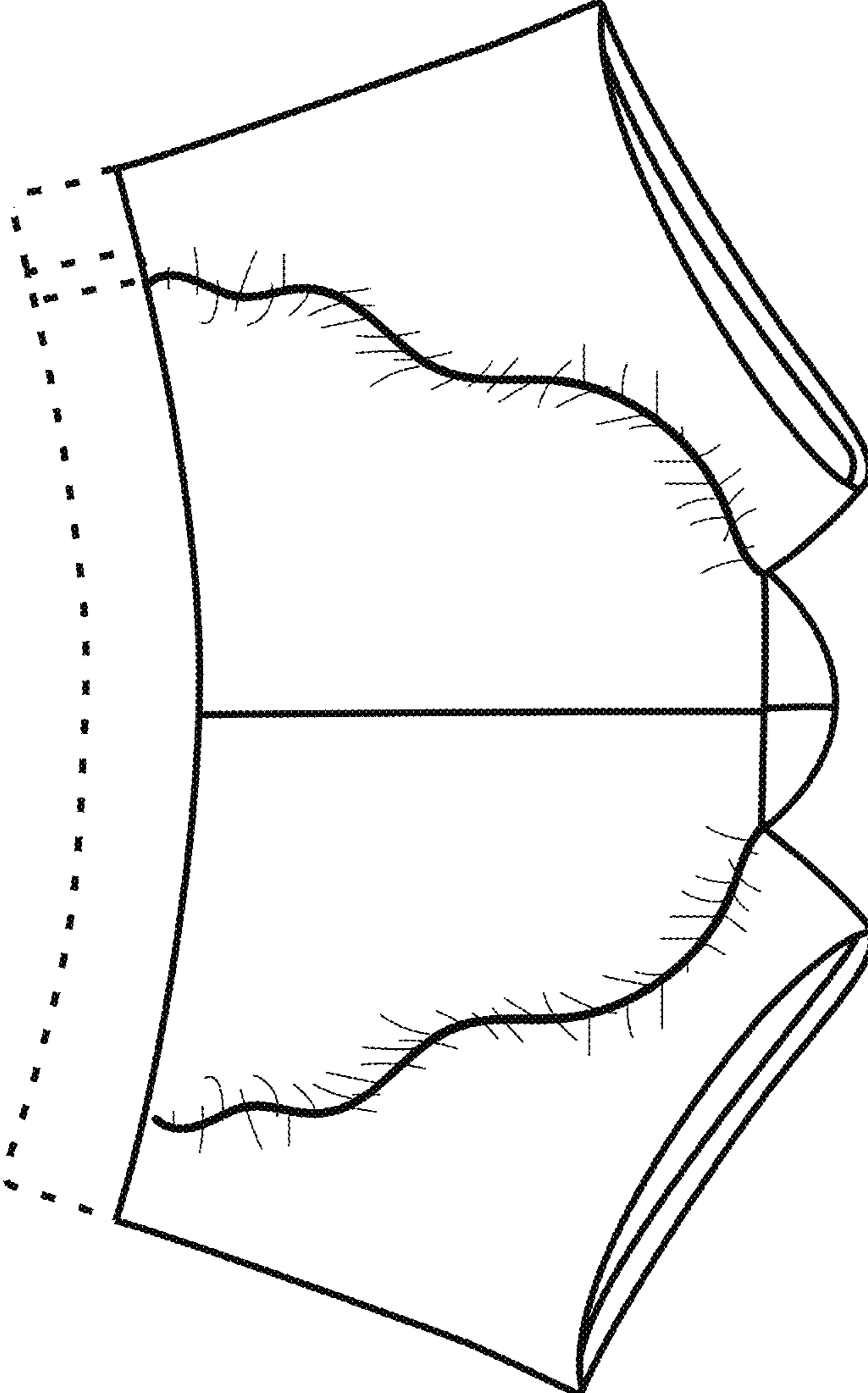

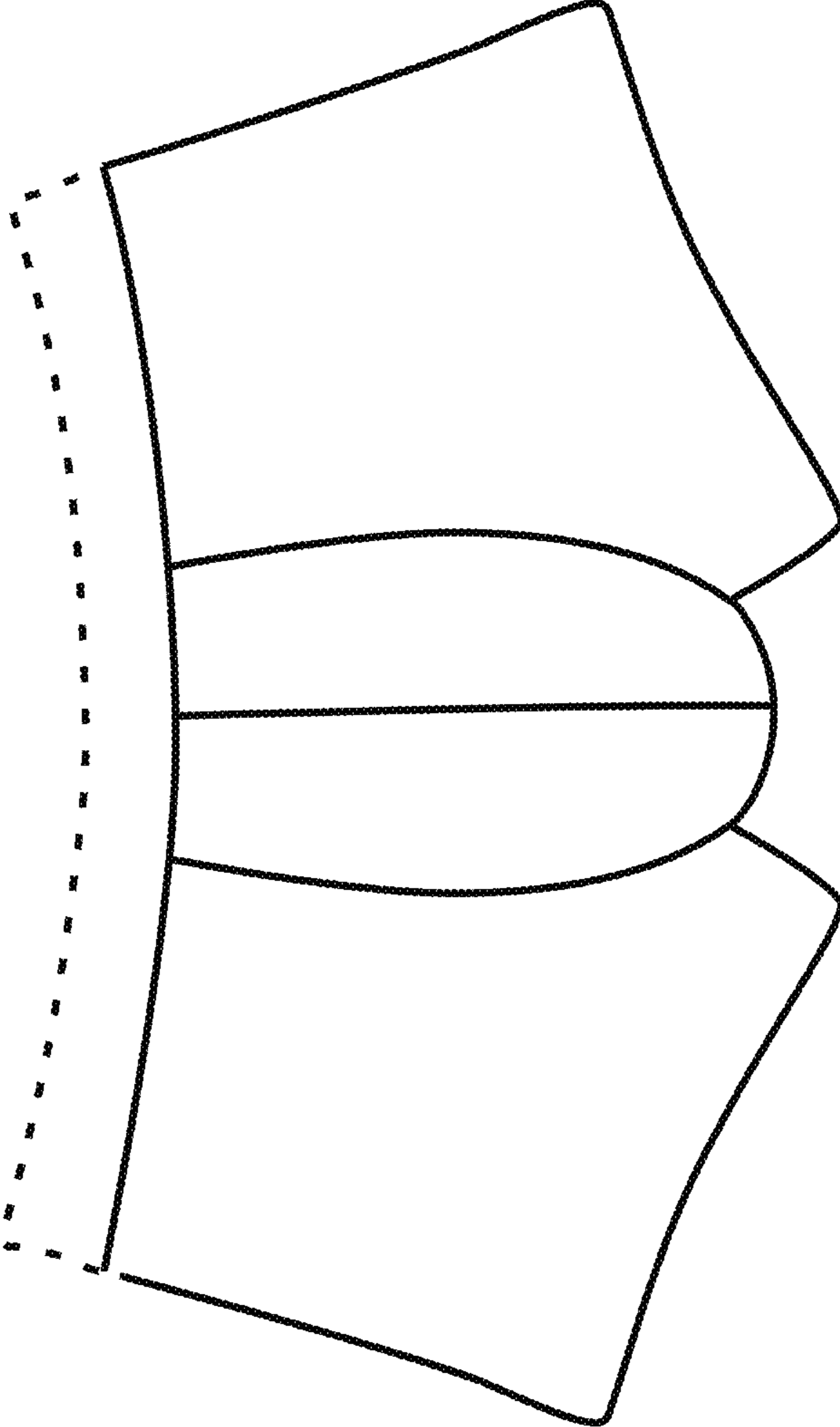

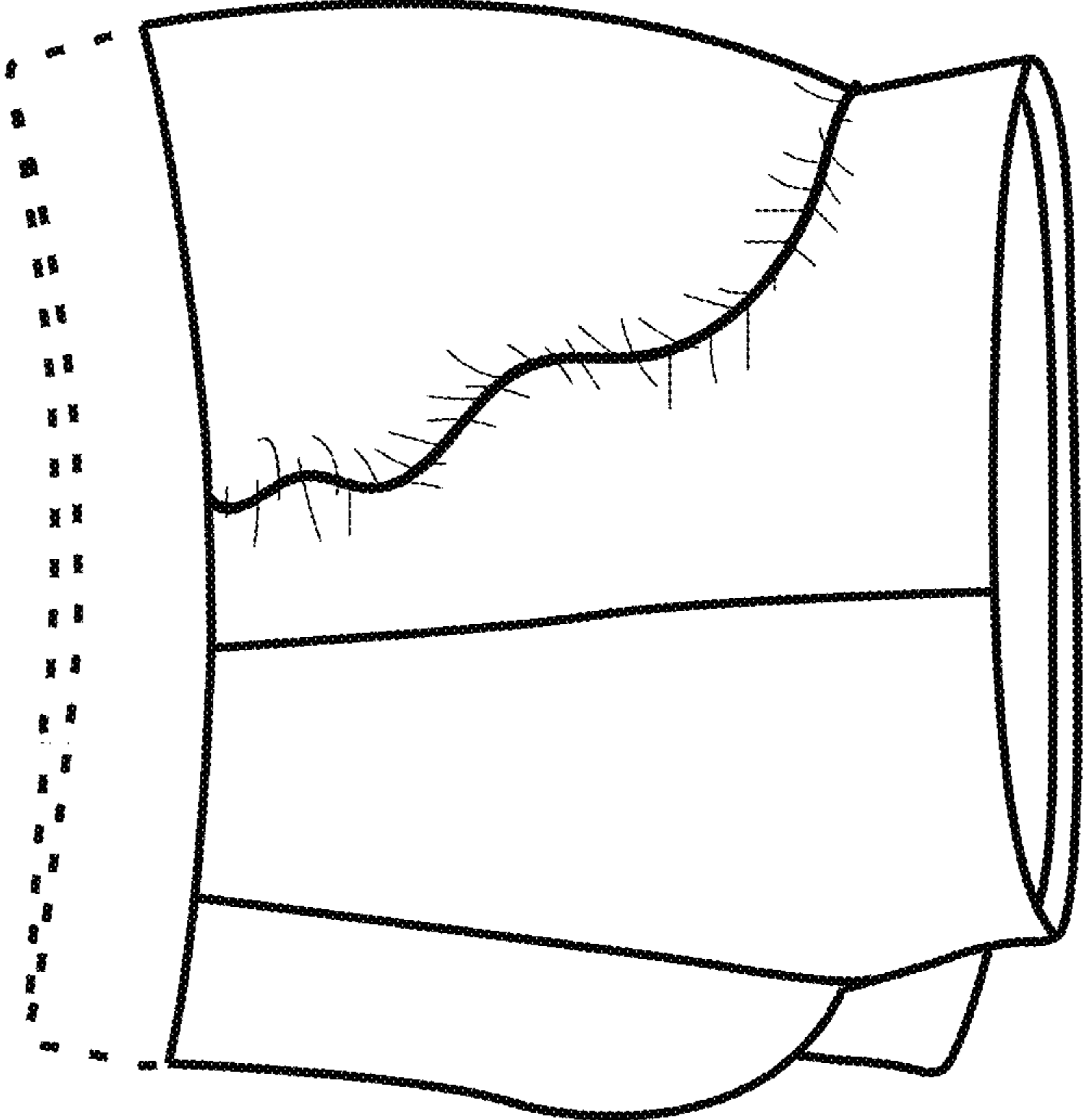

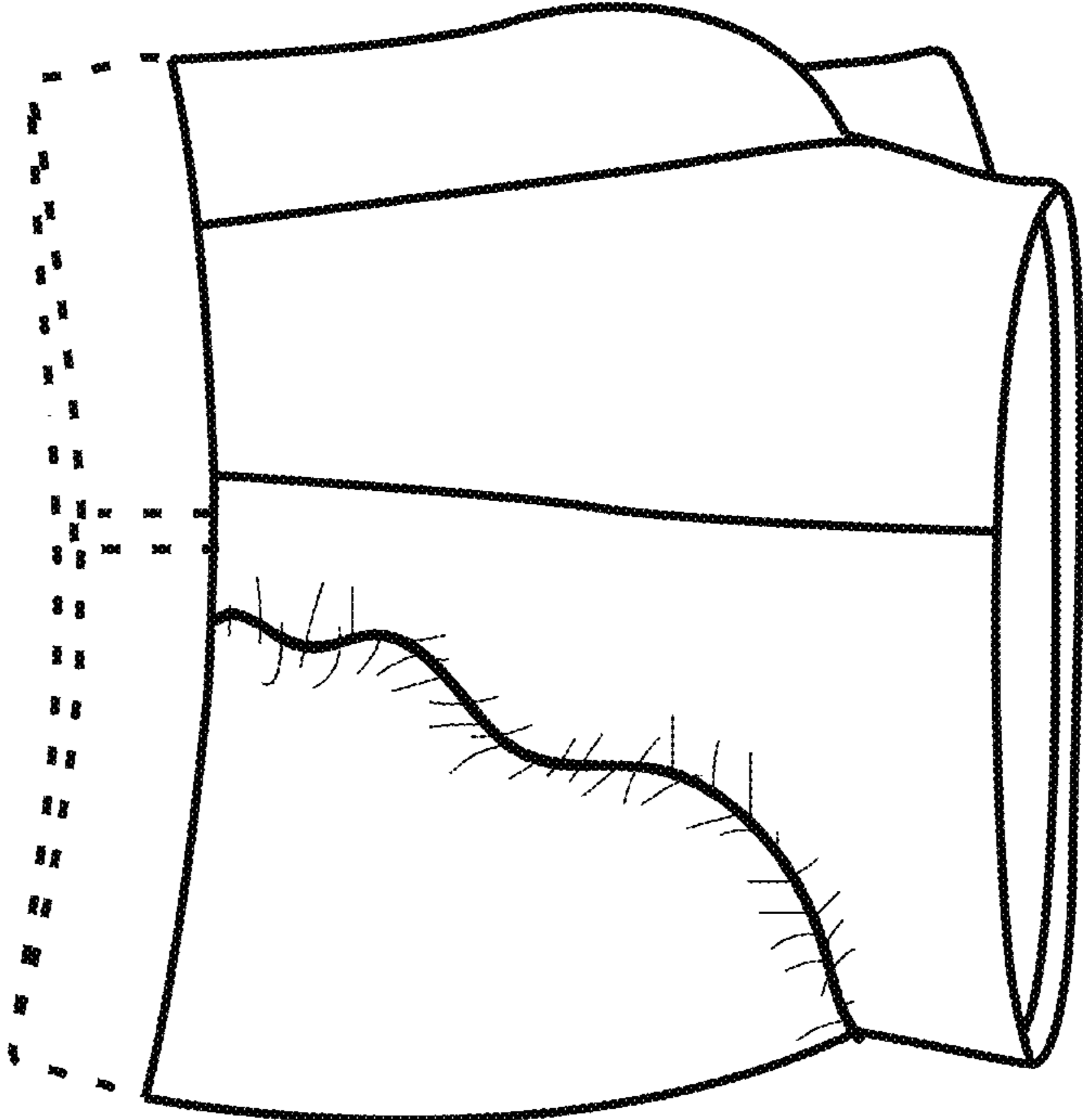

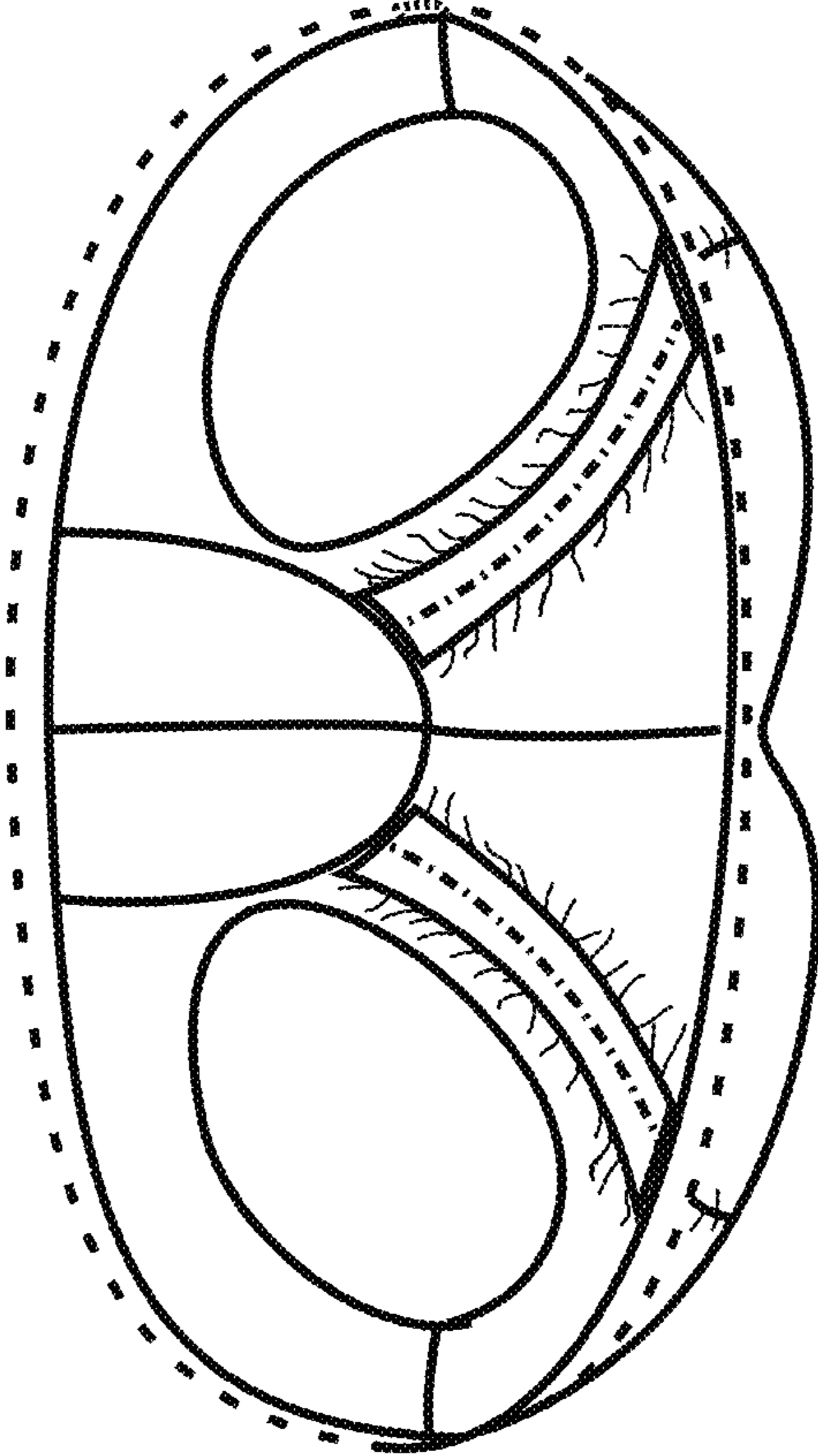

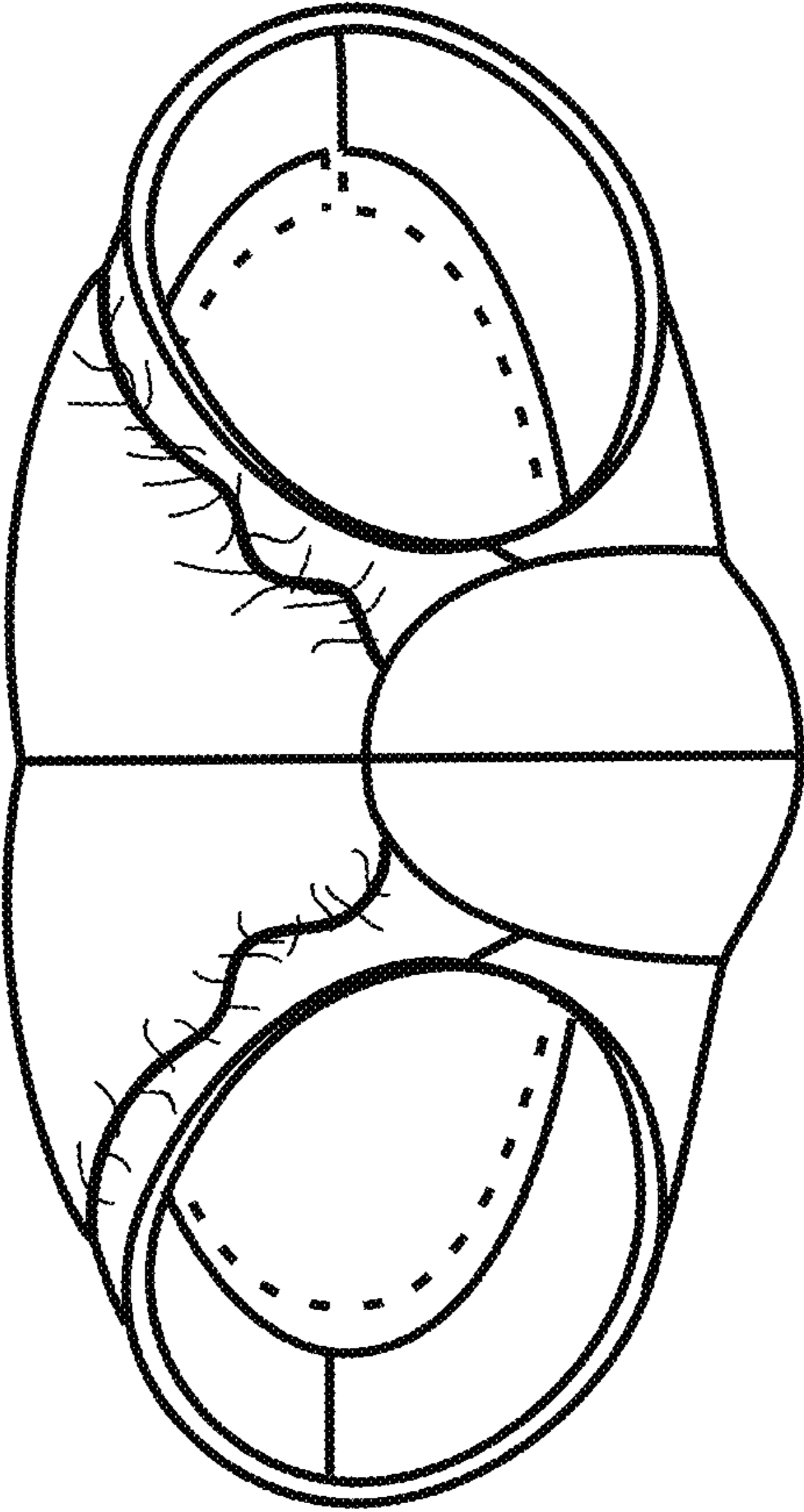
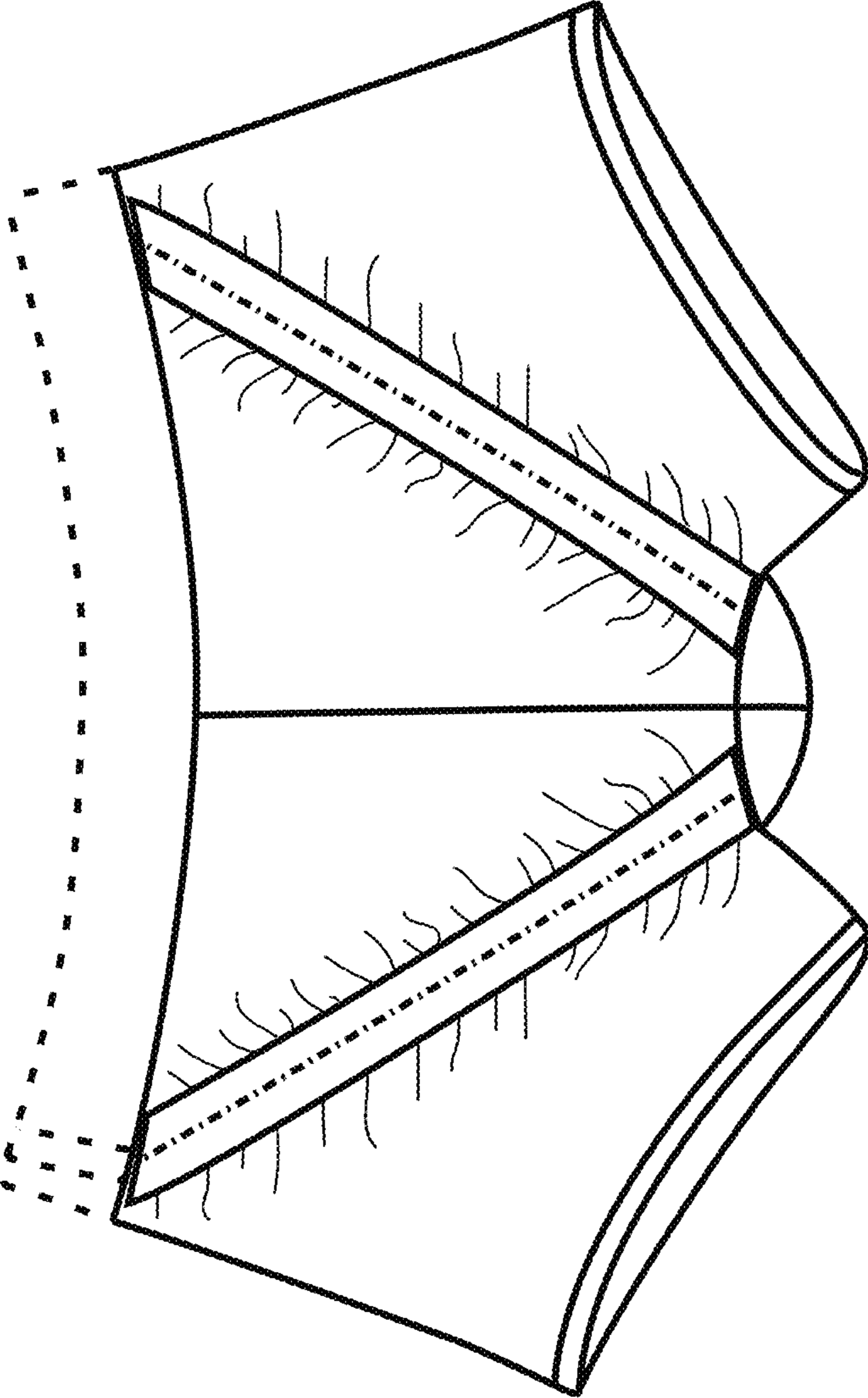

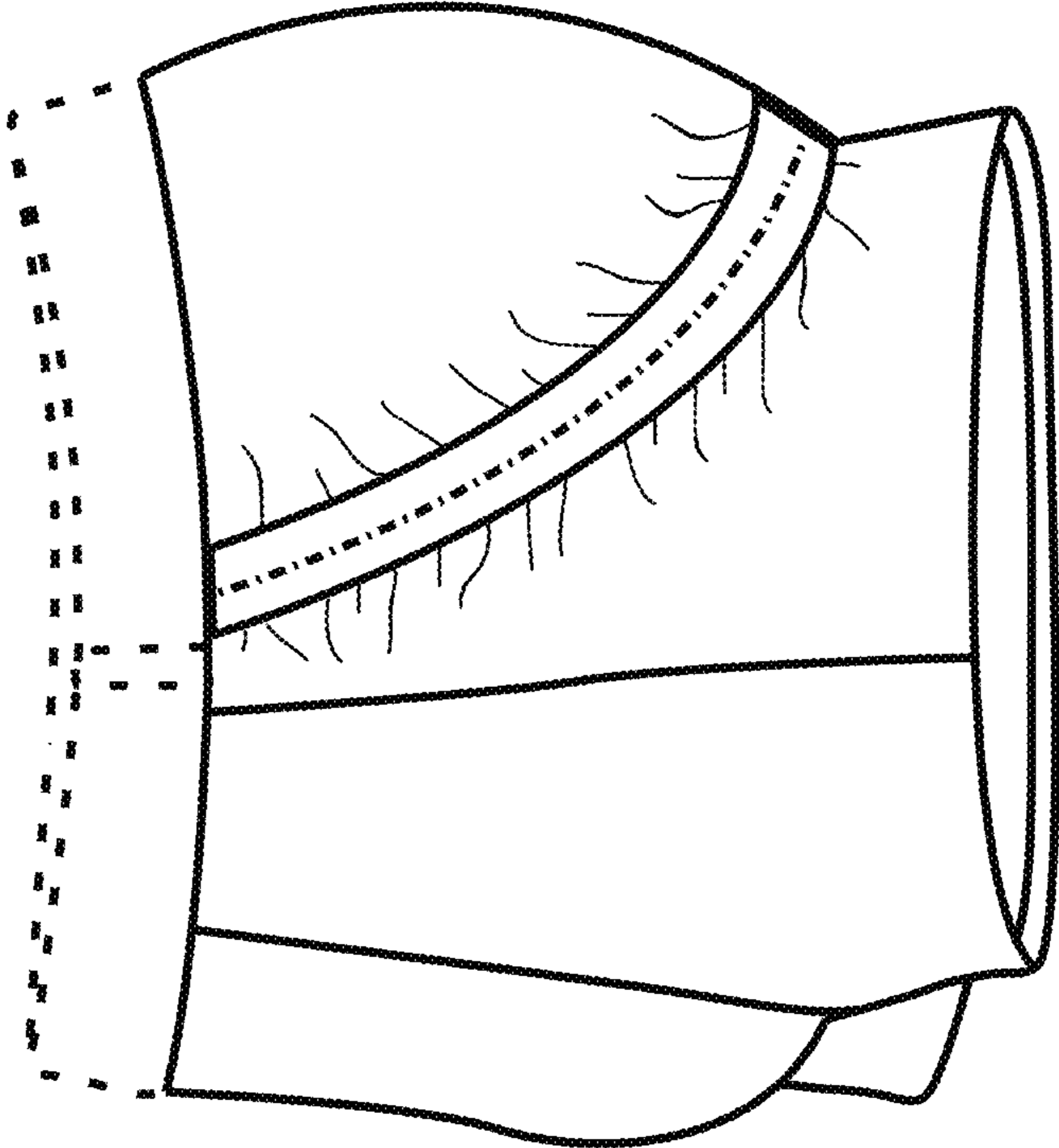

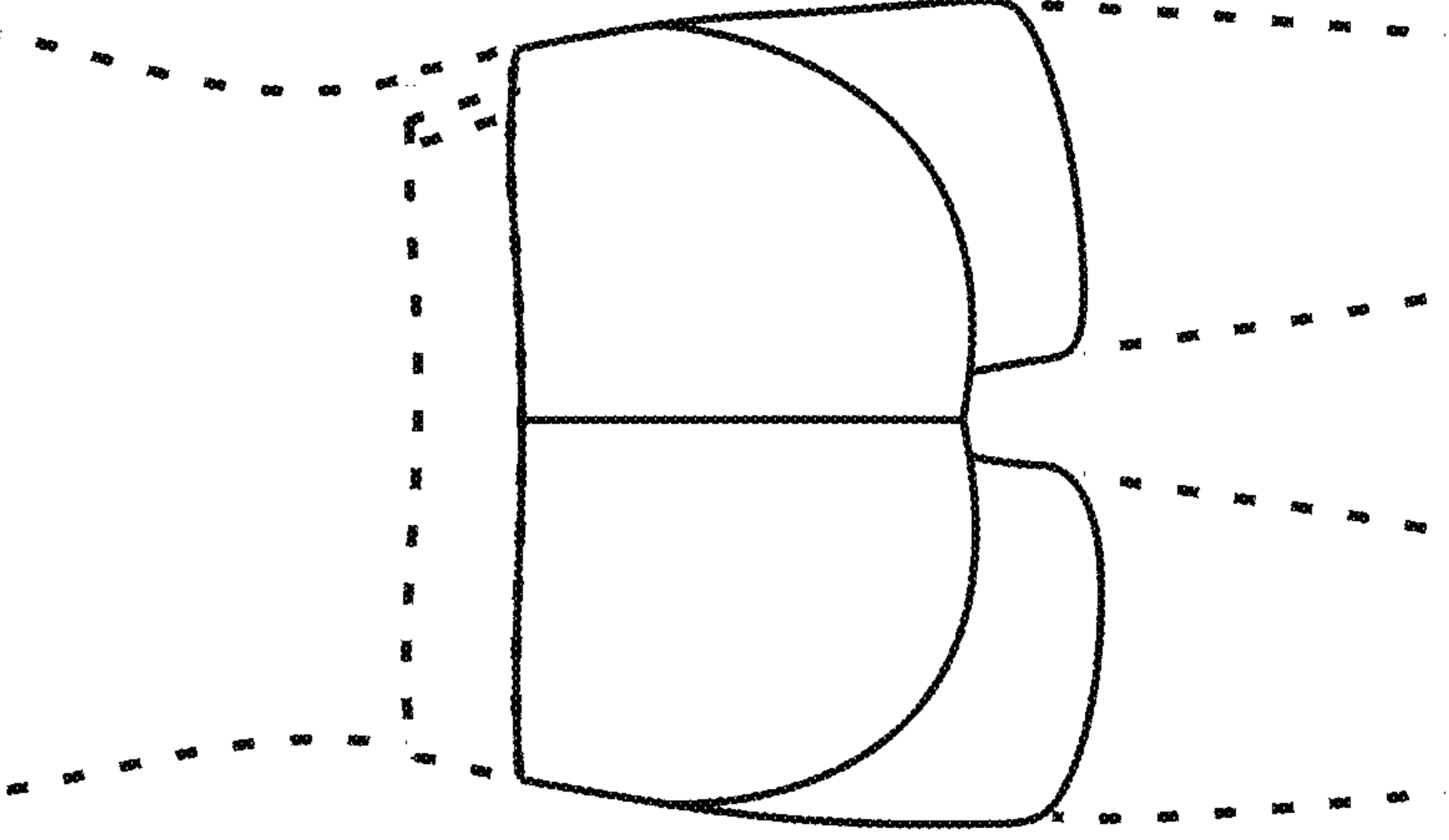

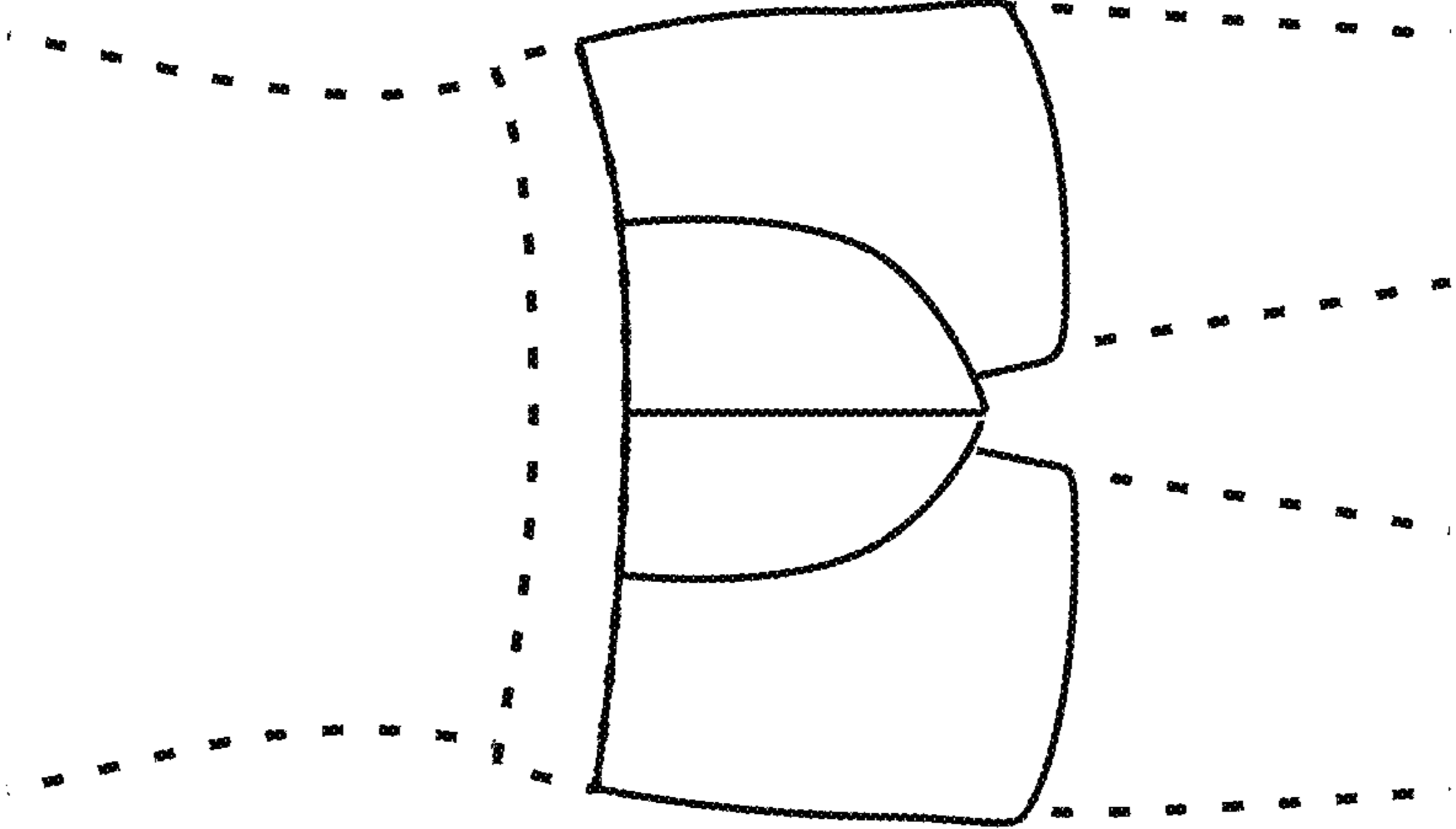

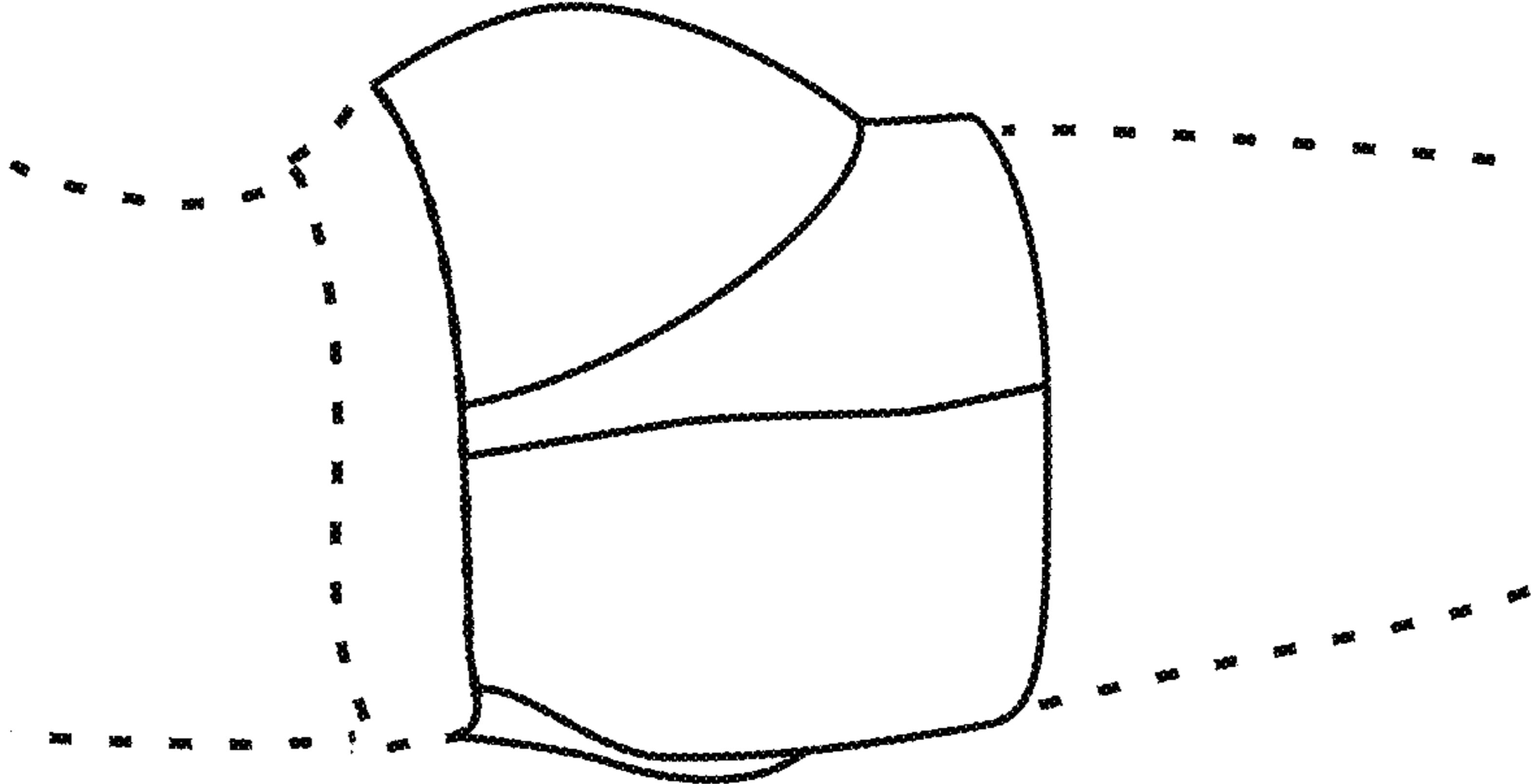

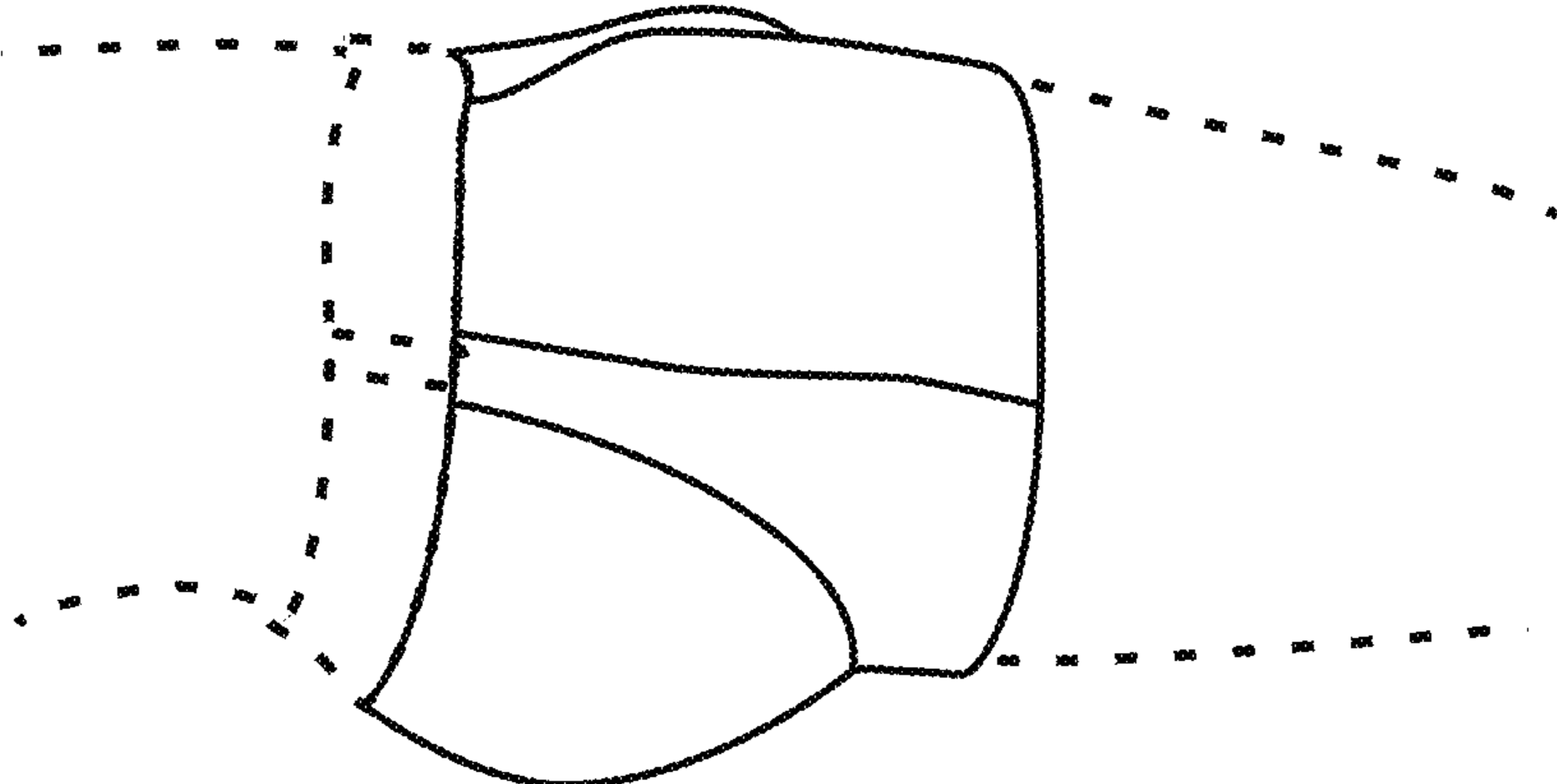
