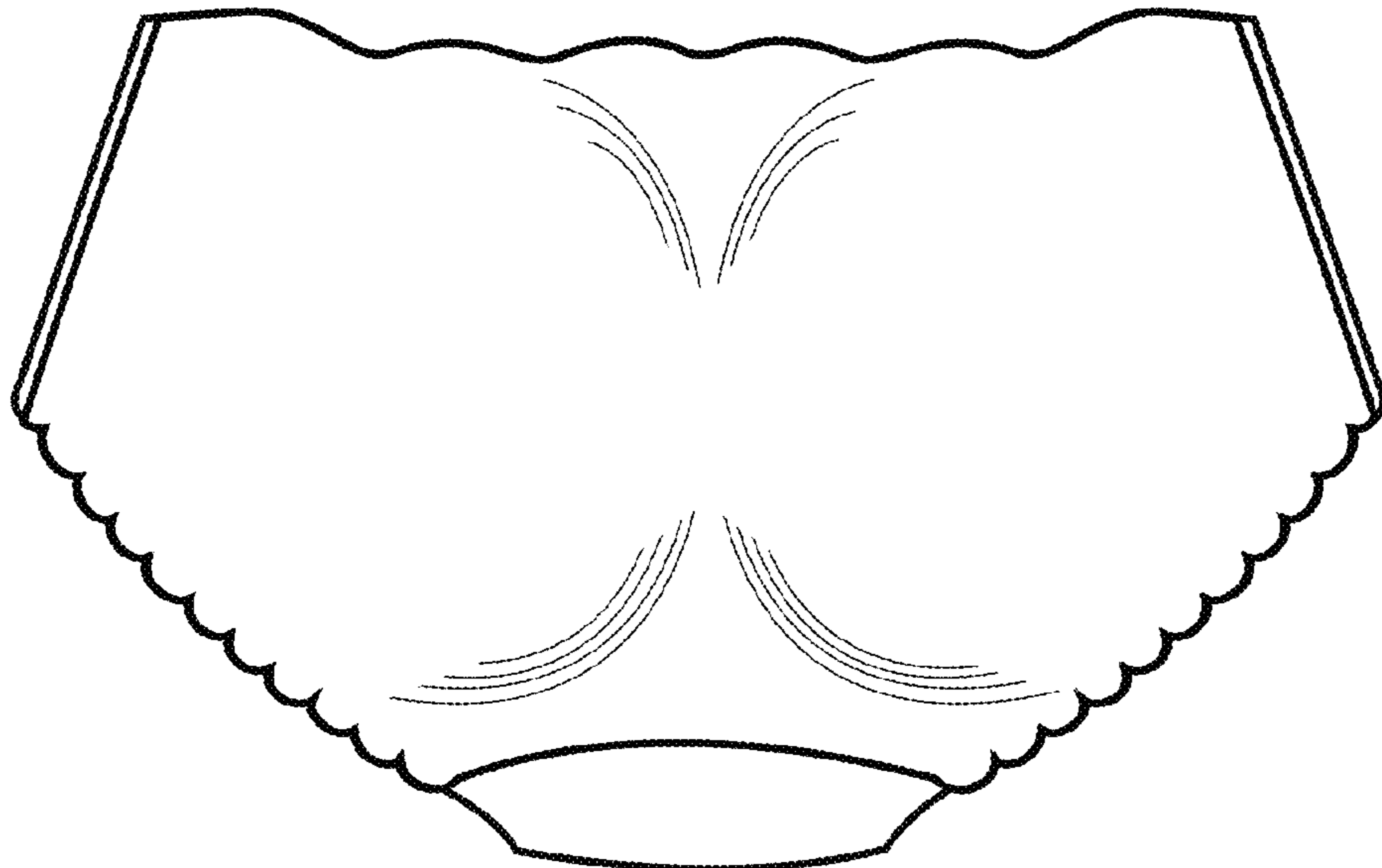
FIG. 1 is a back elevational view of the padded underwear not being worn and showing the outer surface of the rear portion of the padded underwear;

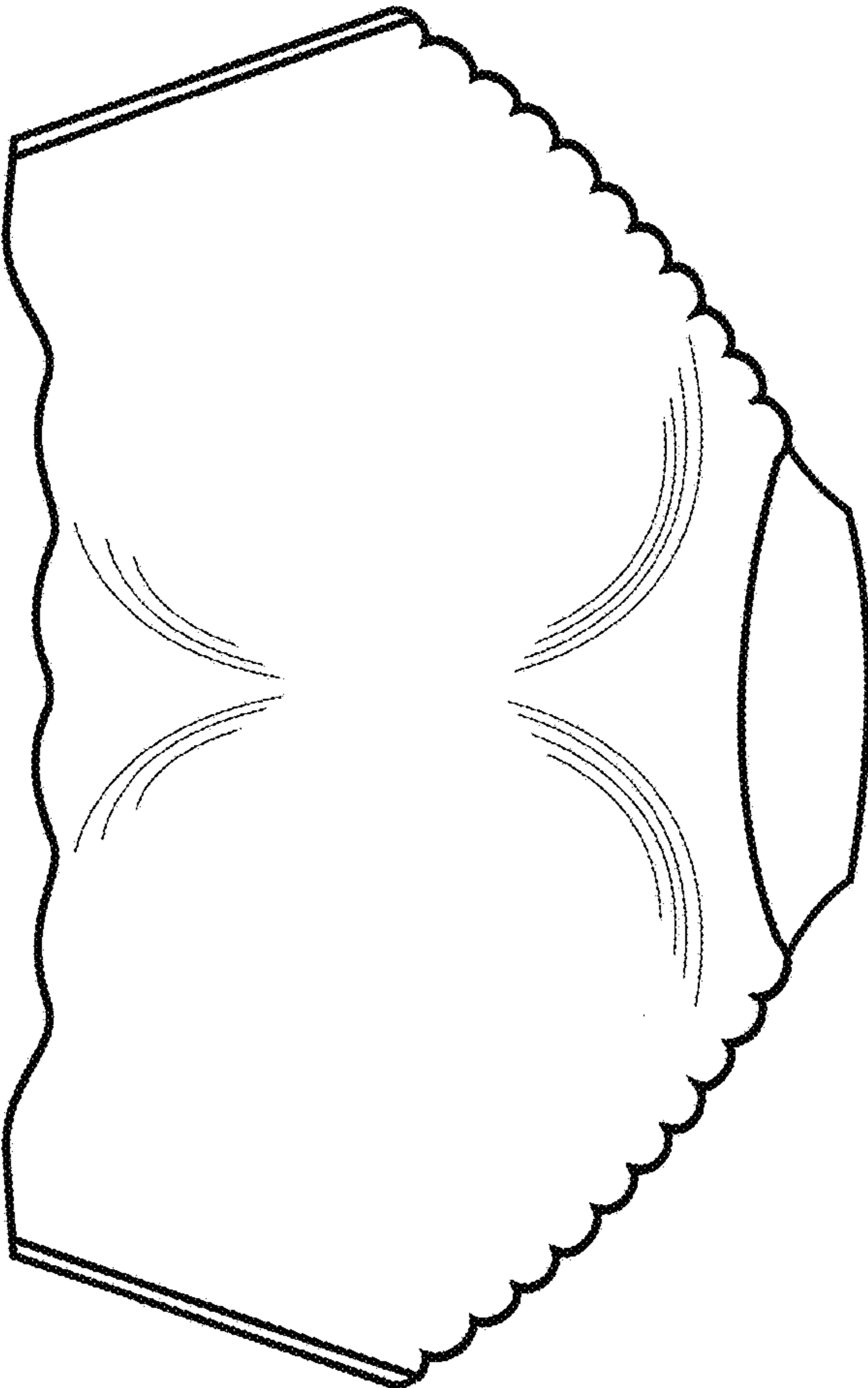

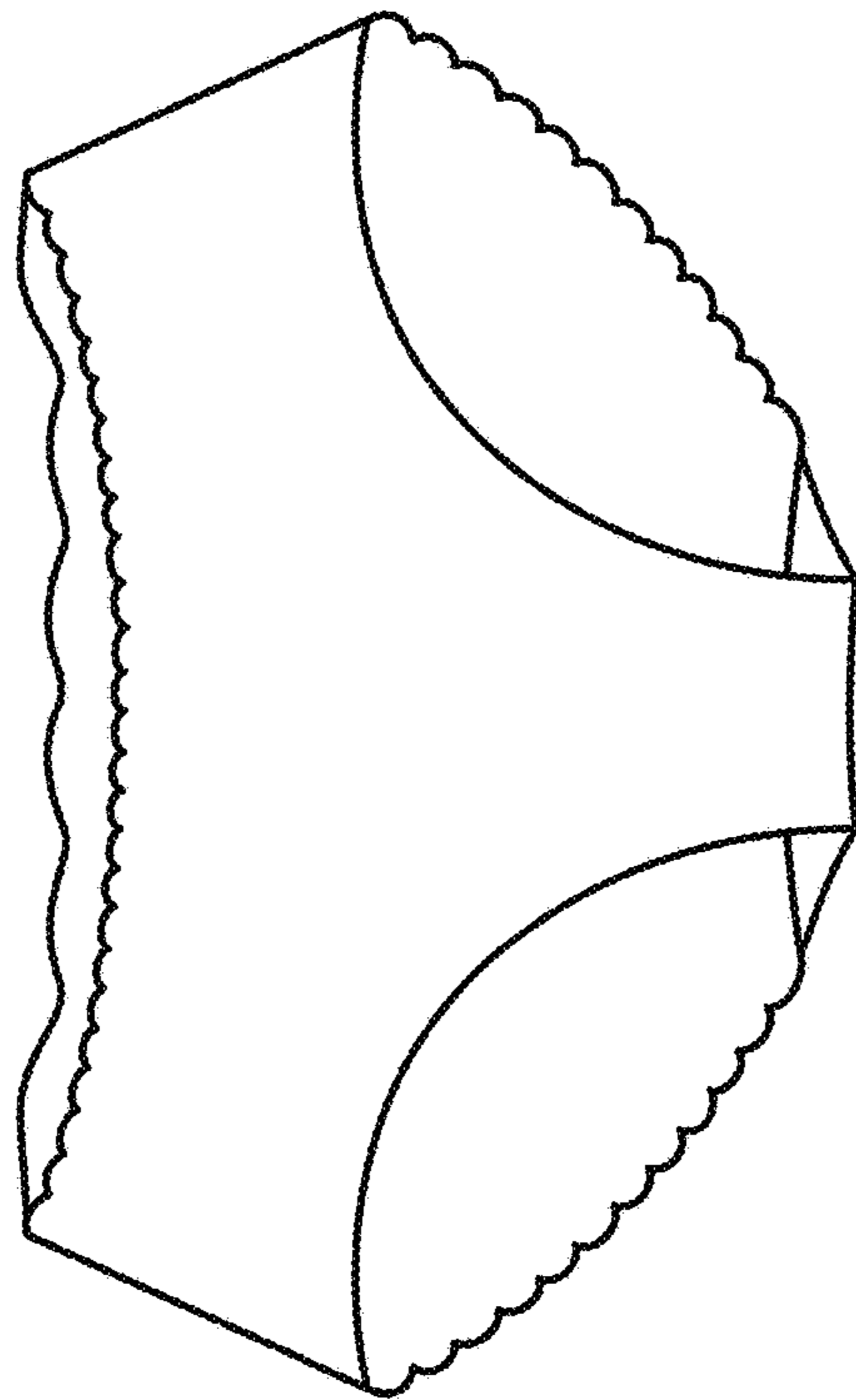

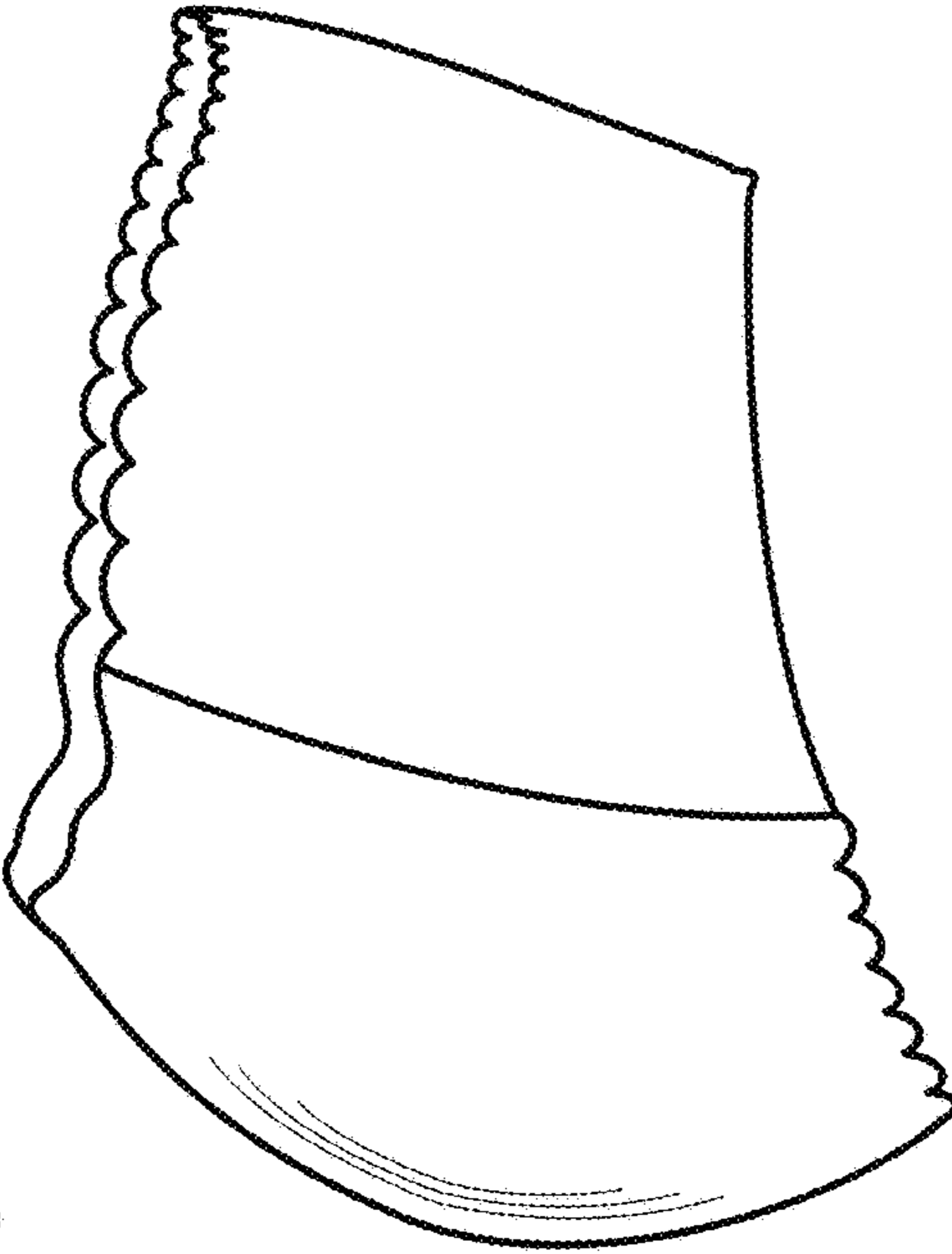
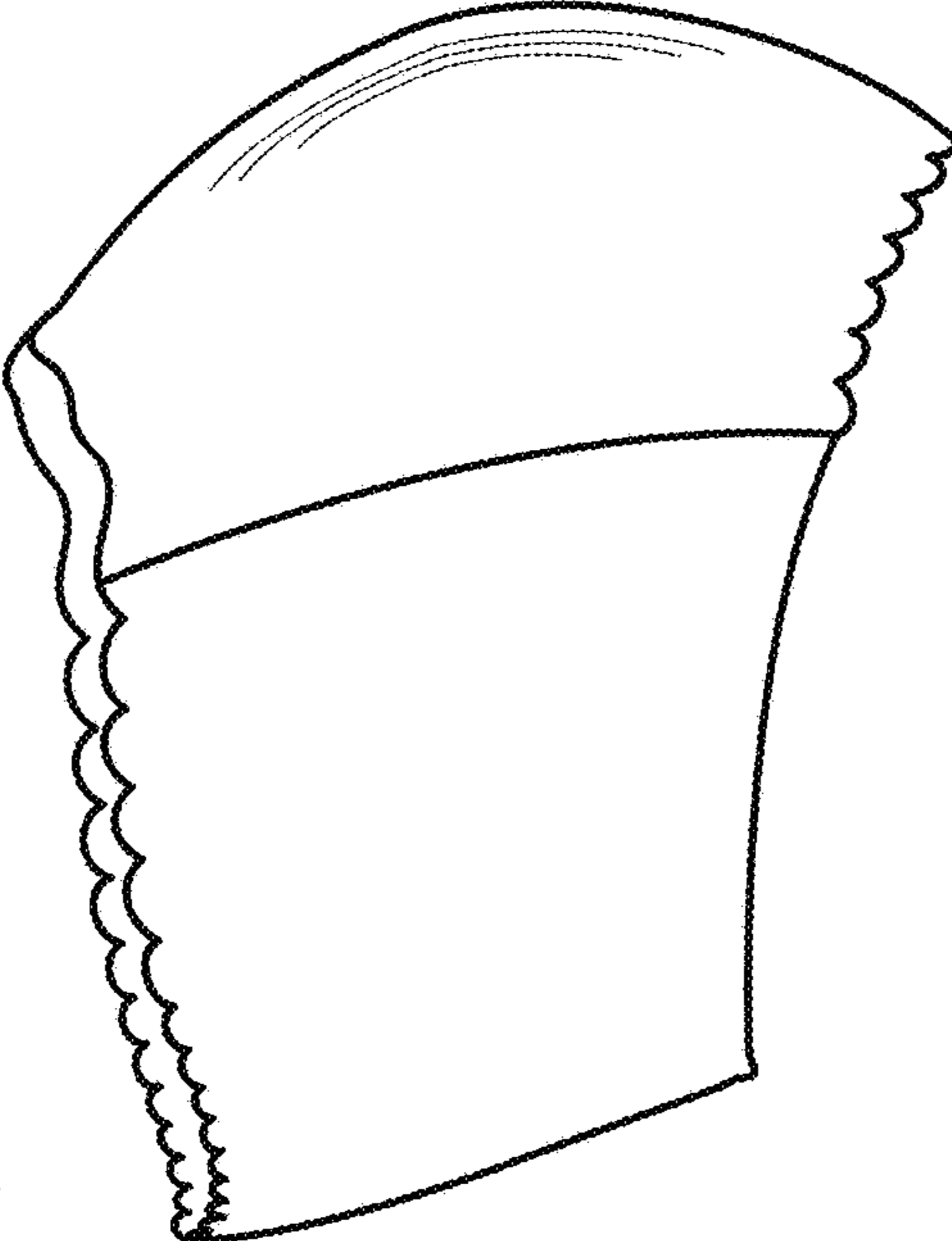

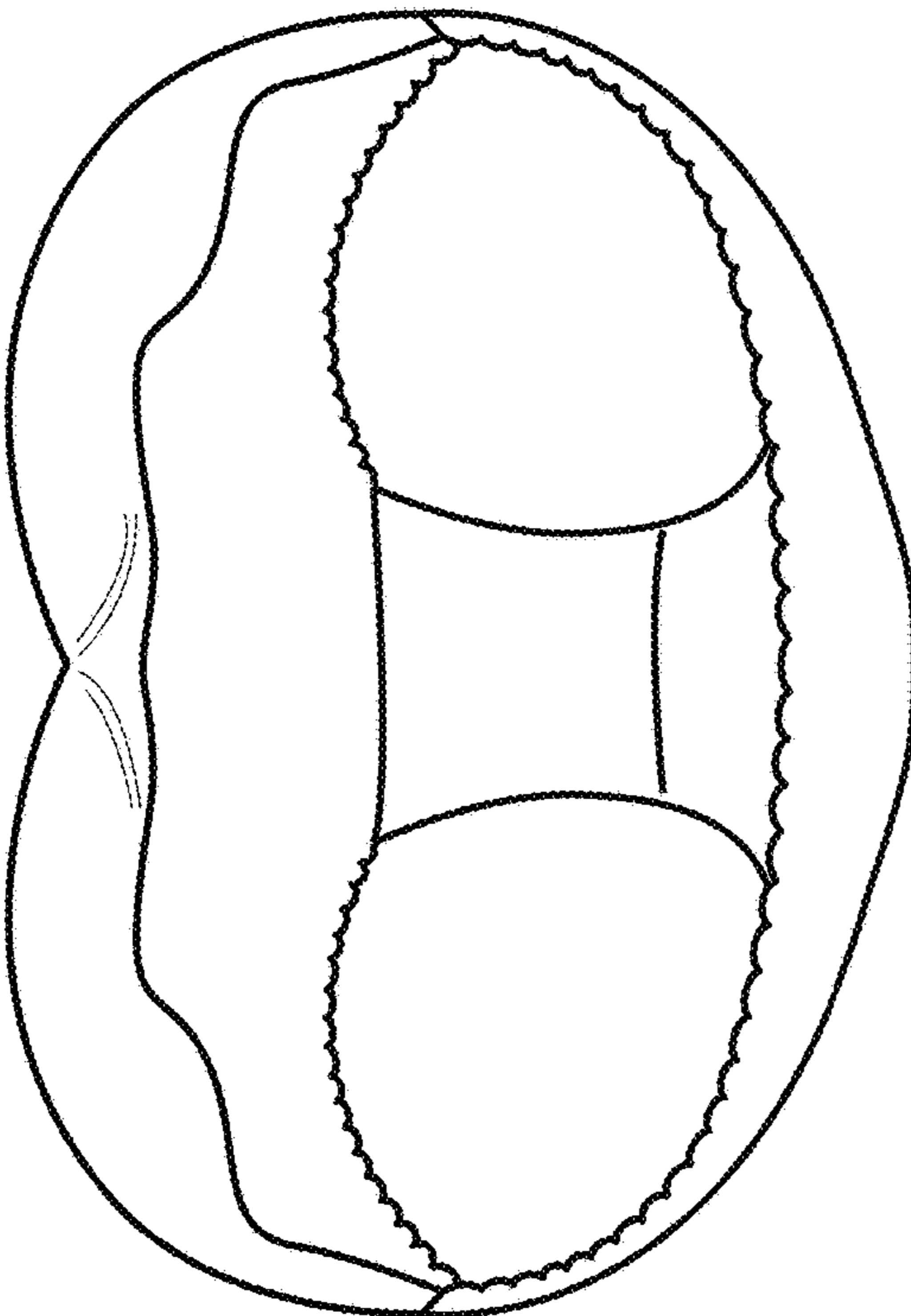

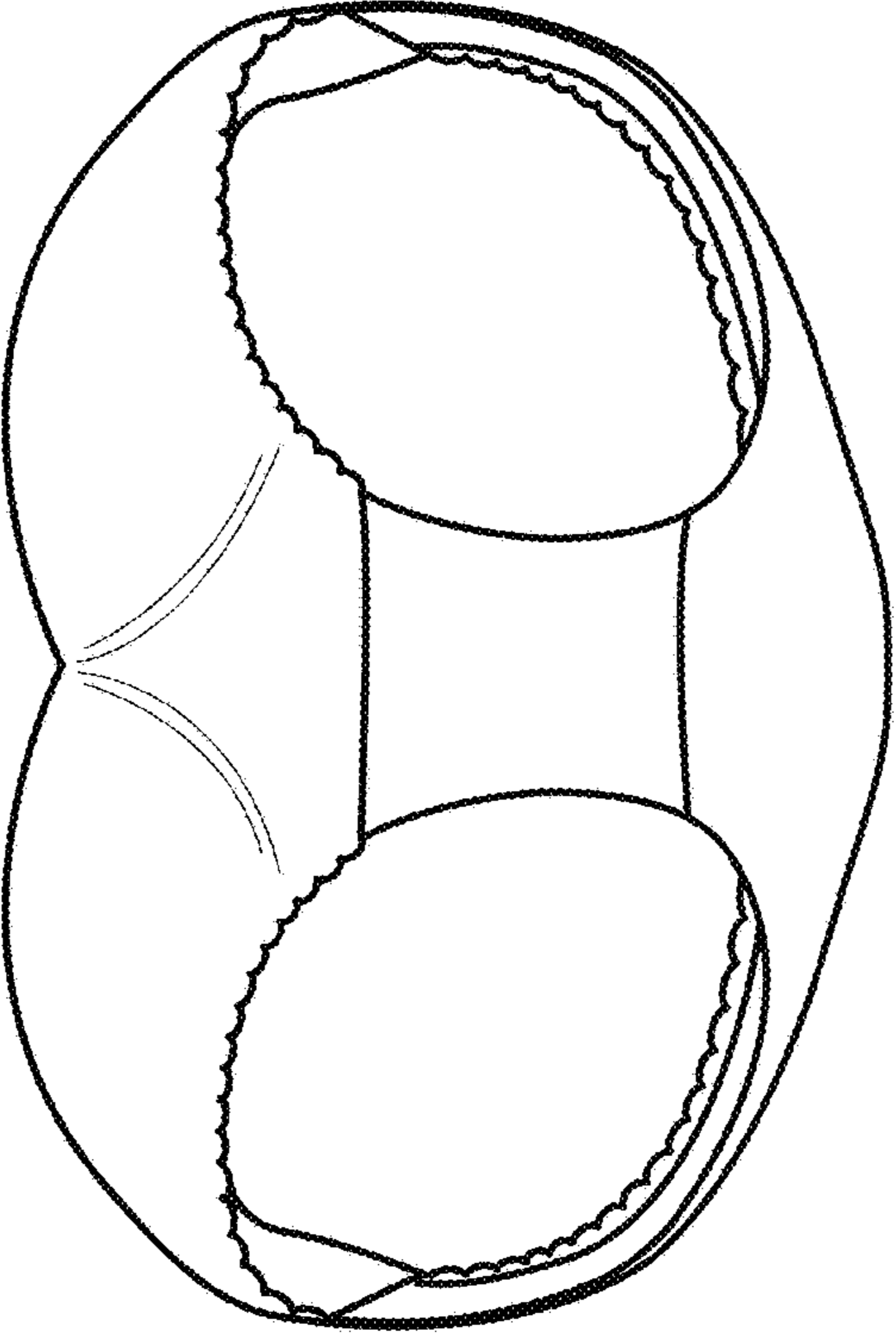
