The ornamental design for pants with contrasting waistband, as shown and described.

DESCRIPTION

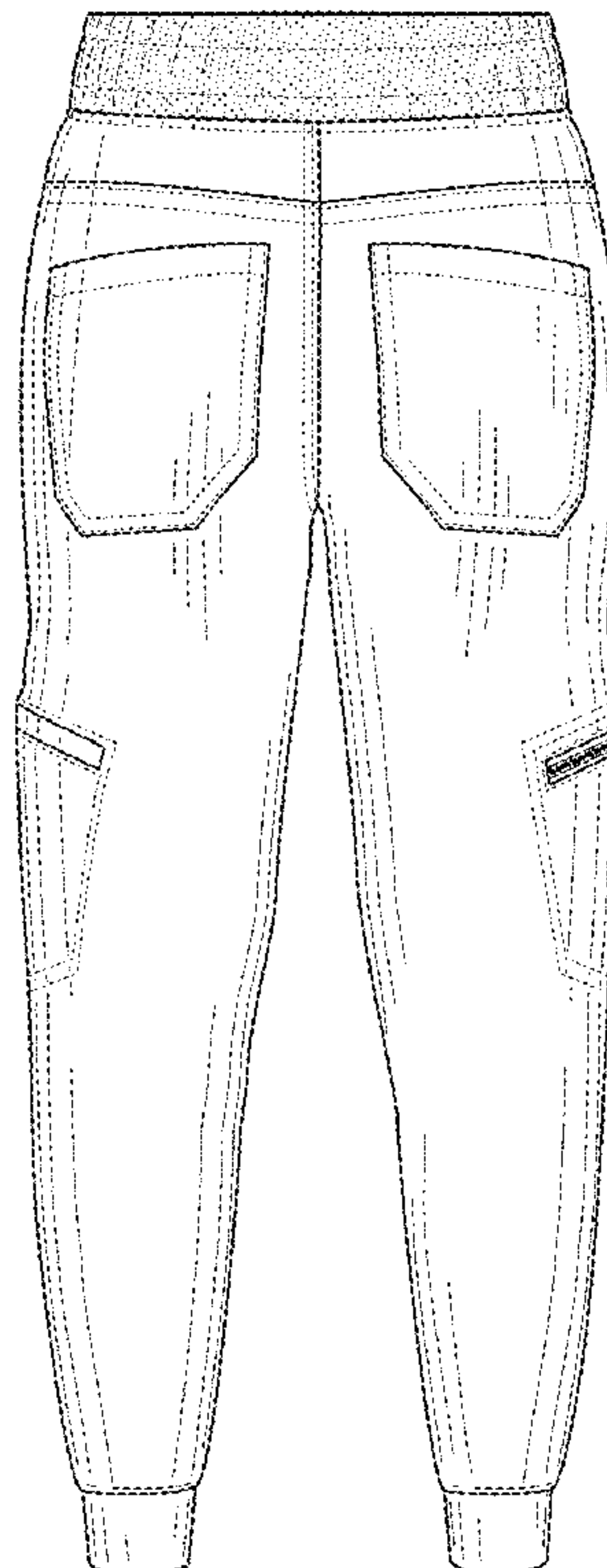
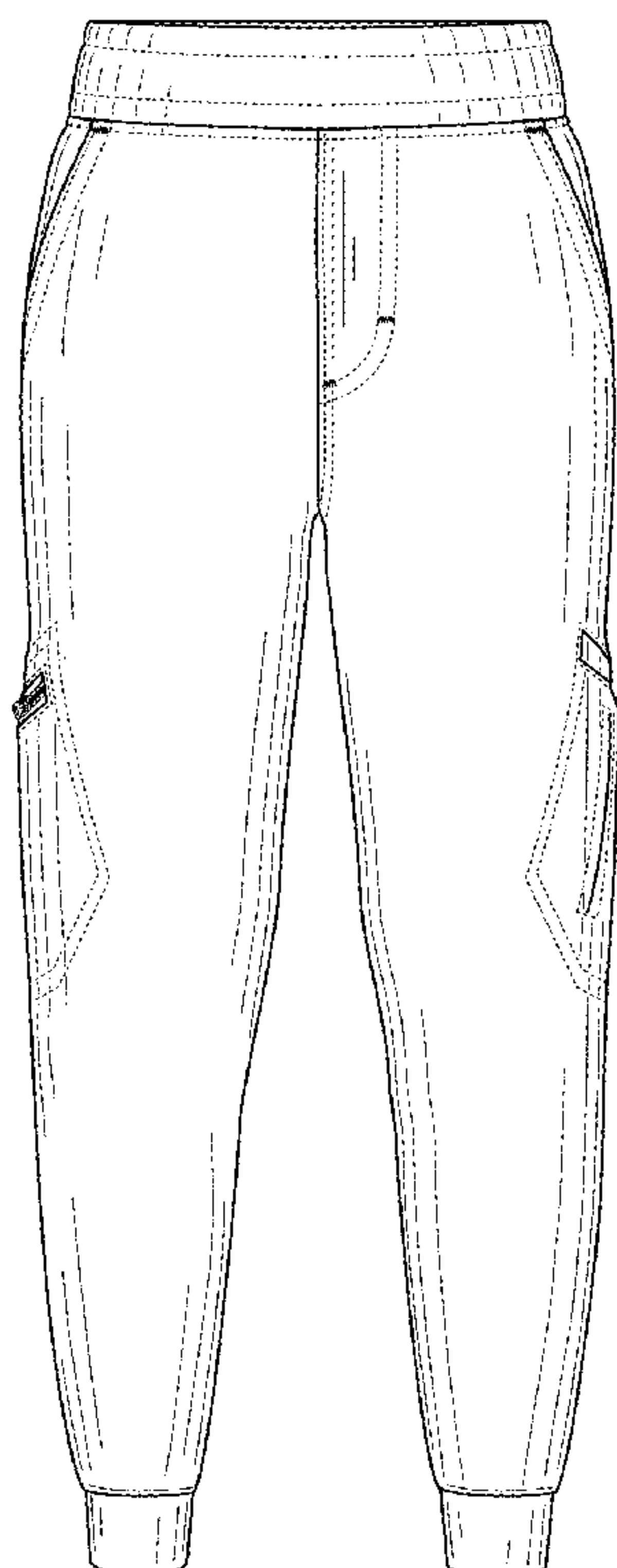
FIG. 1 is a front perspective view of pants with contrasting waistband showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; and, FIG. 4 is a rear perspective view thereof.

The shorter evenly-spaced dashed broken lines in the figures illustrate stitching and form part of the claimed design.

The longer evenly-spaced dashed broken lines shown in the inside of the waistband in FIGS. 1 and 4 illustrate portions of the pants that form no part of the claimed design.

The stipple shading in the drawings illustrates a contrast of appearance and does not represent any particular color, texture, or material.

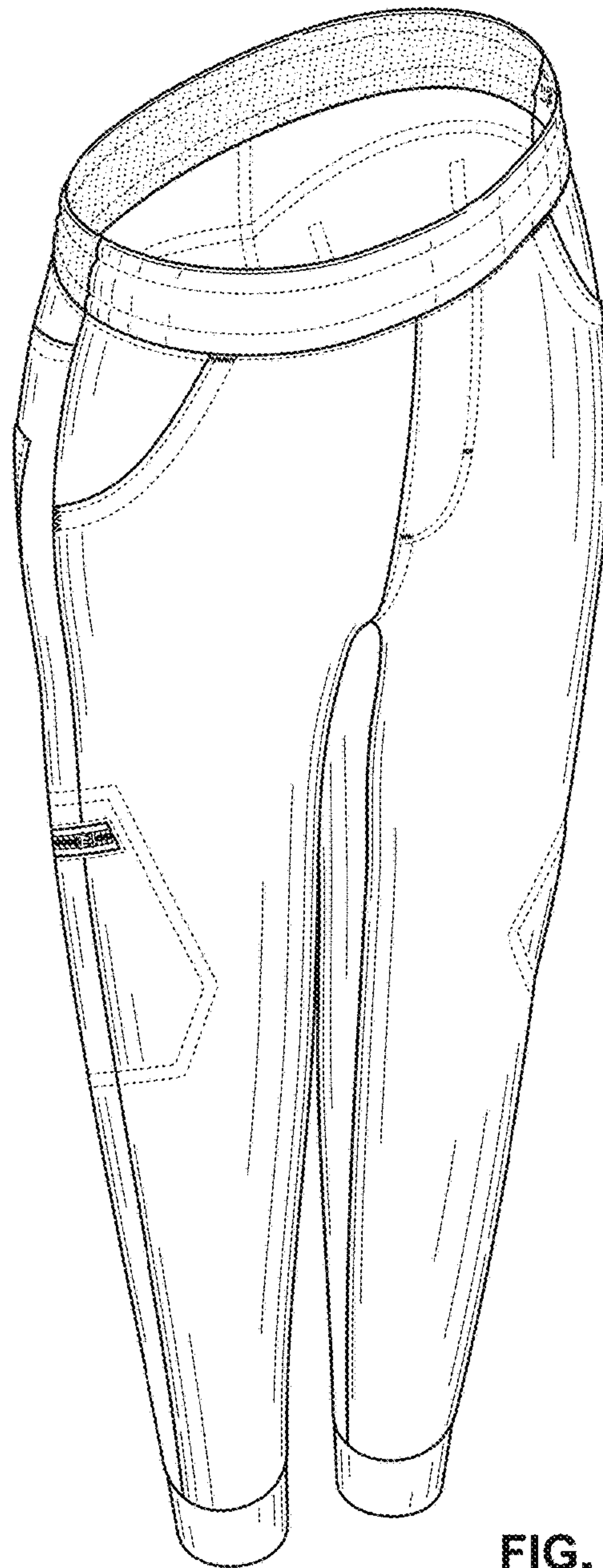

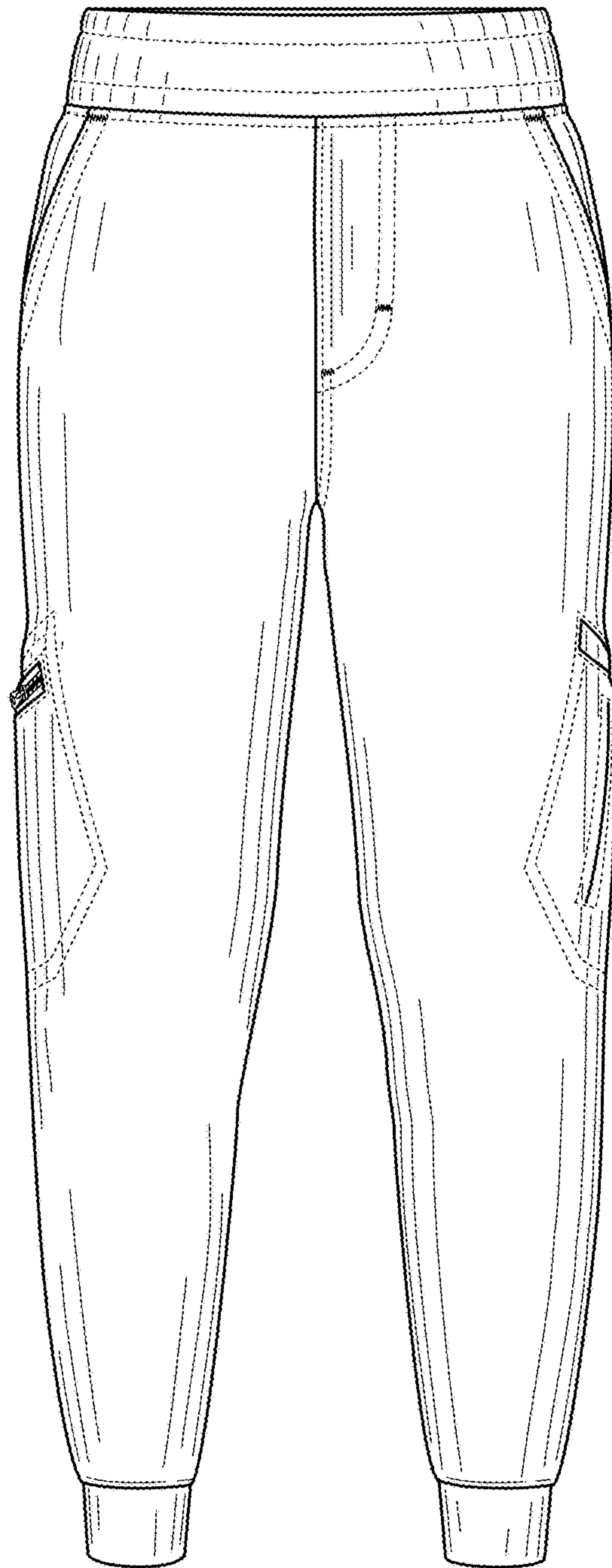

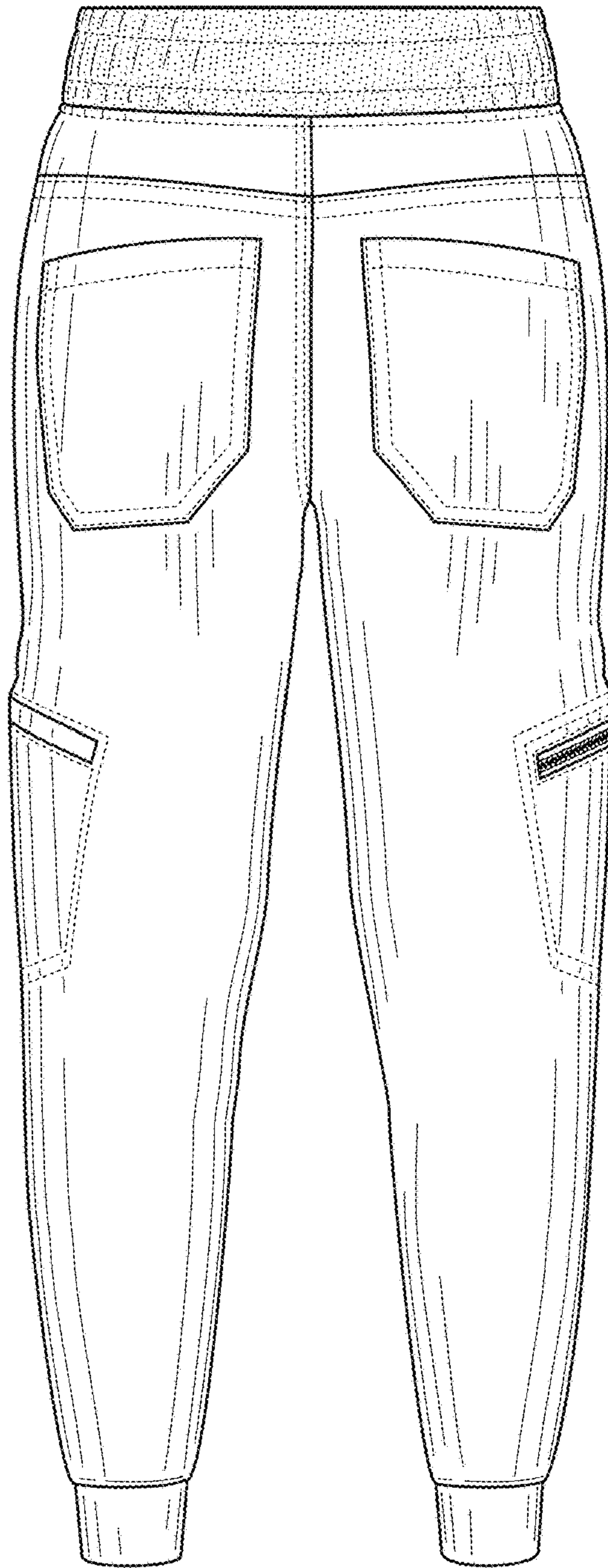

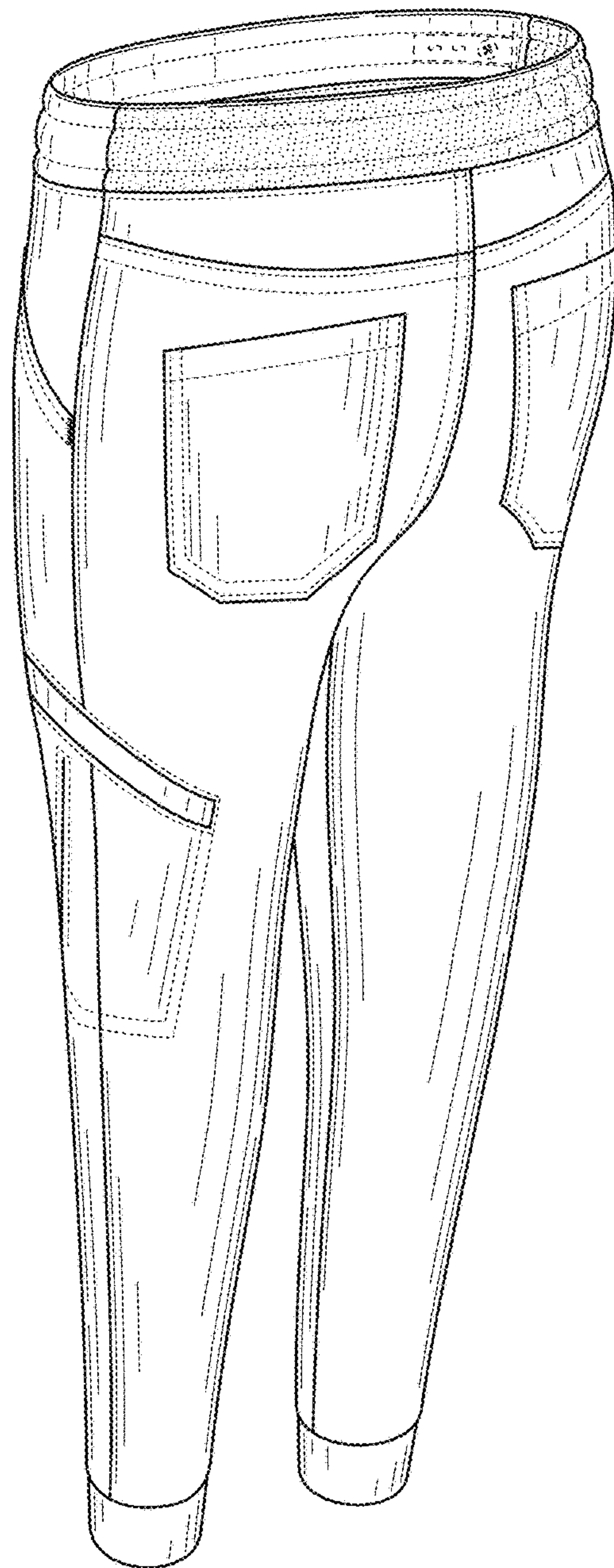
