(57) **CLAIM**

The ornamental design for a reversible double legging with interior pocket, as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of a reversible double legging with interior pocket, showing the first side of my new design;

FIG. 2 is a left perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a left view thereof;

FIG. 6 is a right view thereof;

FIG. 7 is a top view thereof, with the second side visible;

FIG. 8 is a bottom view thereof, with the second side visible;

FIG. 9 is an enlarged view taken from FIG. 7;

FIG. 10 is a front view thereof, everted at the waist partially exposing the second side;

FIG. 11 is a cross-sectional view taken along line 11-11 in FIG. 3;

FIG. 12 is a cross-sectional view taken along line 12-12 in FIG. 3;

FIG. 13 is a cross-sectional view taken along line 13-13 in FIG. 3;

FIG. 14 is a left perspective view of a reversible double legging with interior pocket of FIG. 1, showing the second side; and,

FIG. 15 is a right perspective view thereof.

The broken lines throughout FIGS. 1-15 illustrate environmental structure and form no part of the claimed design.

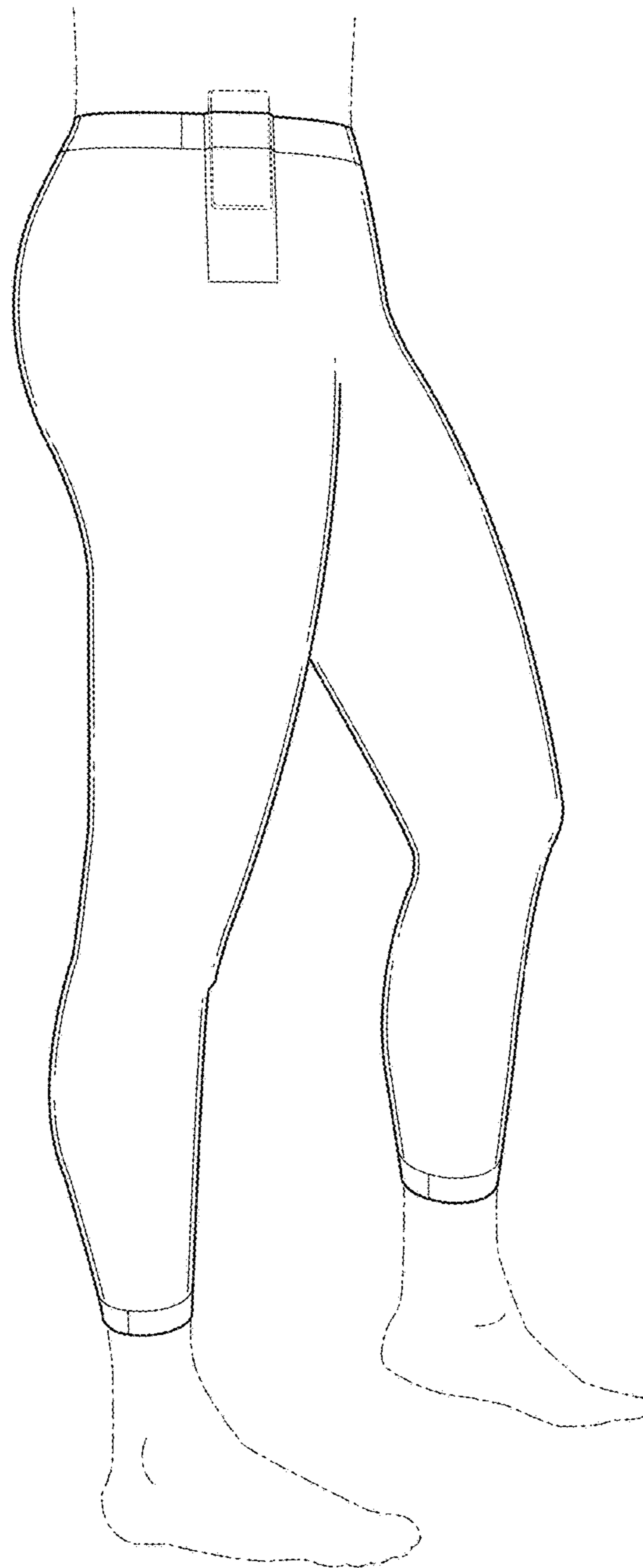

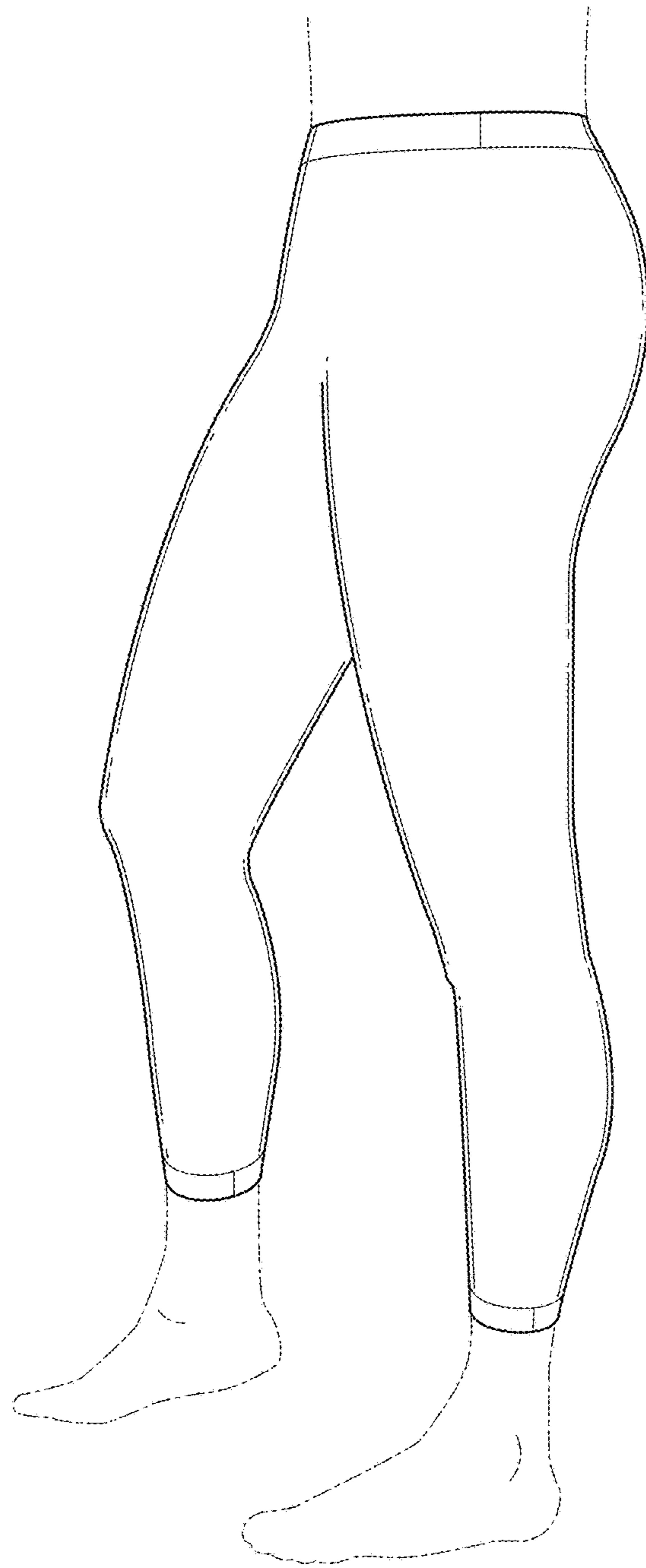

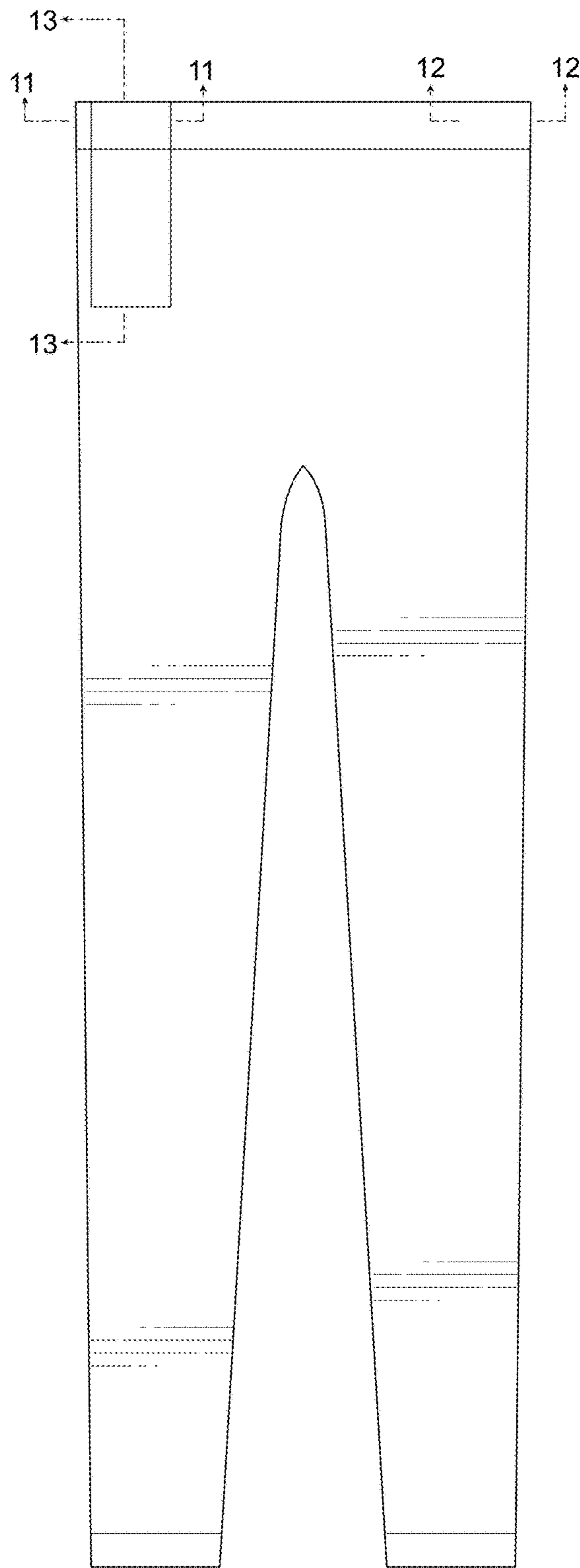

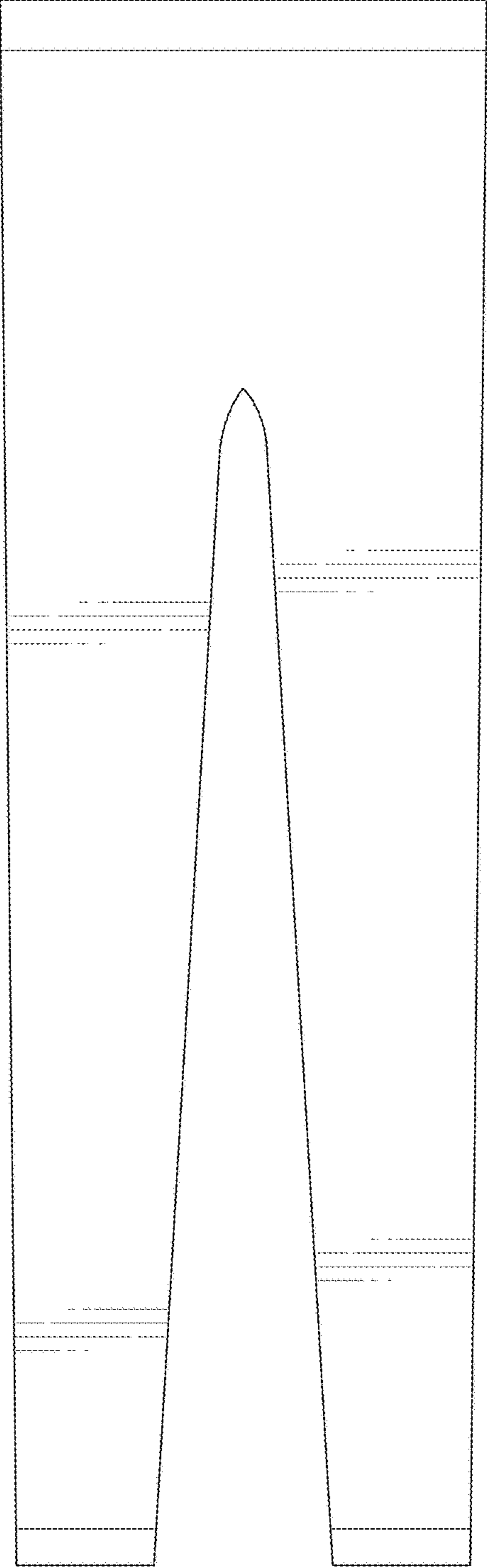

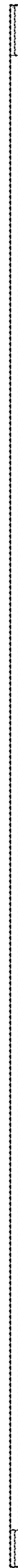

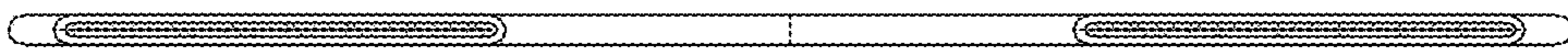
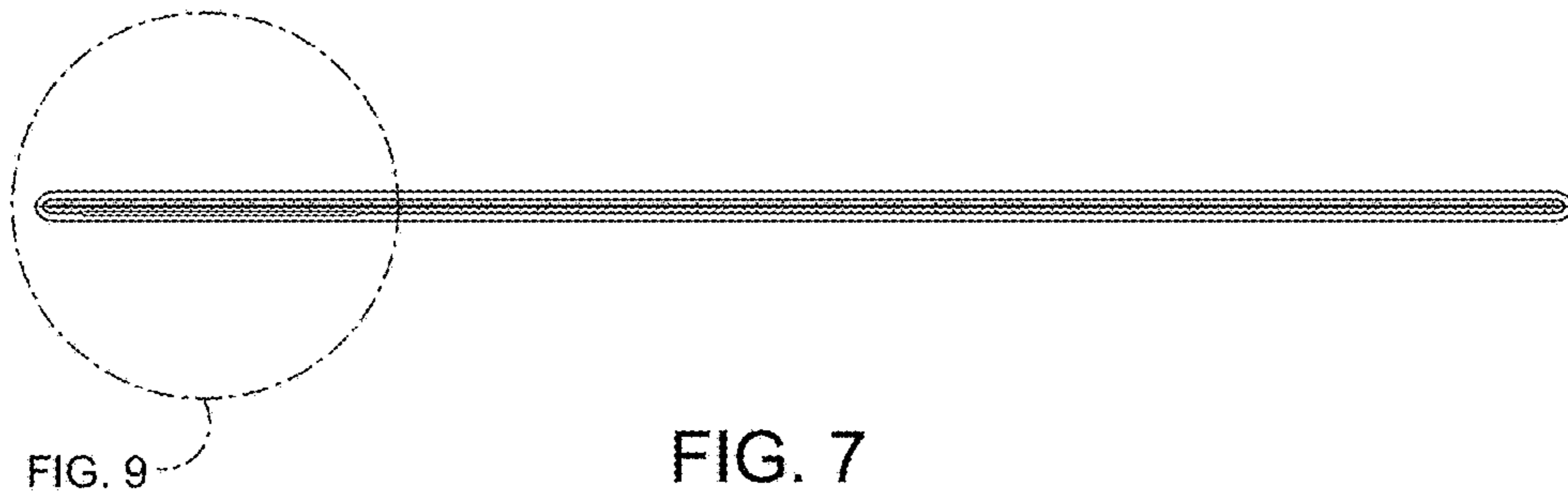

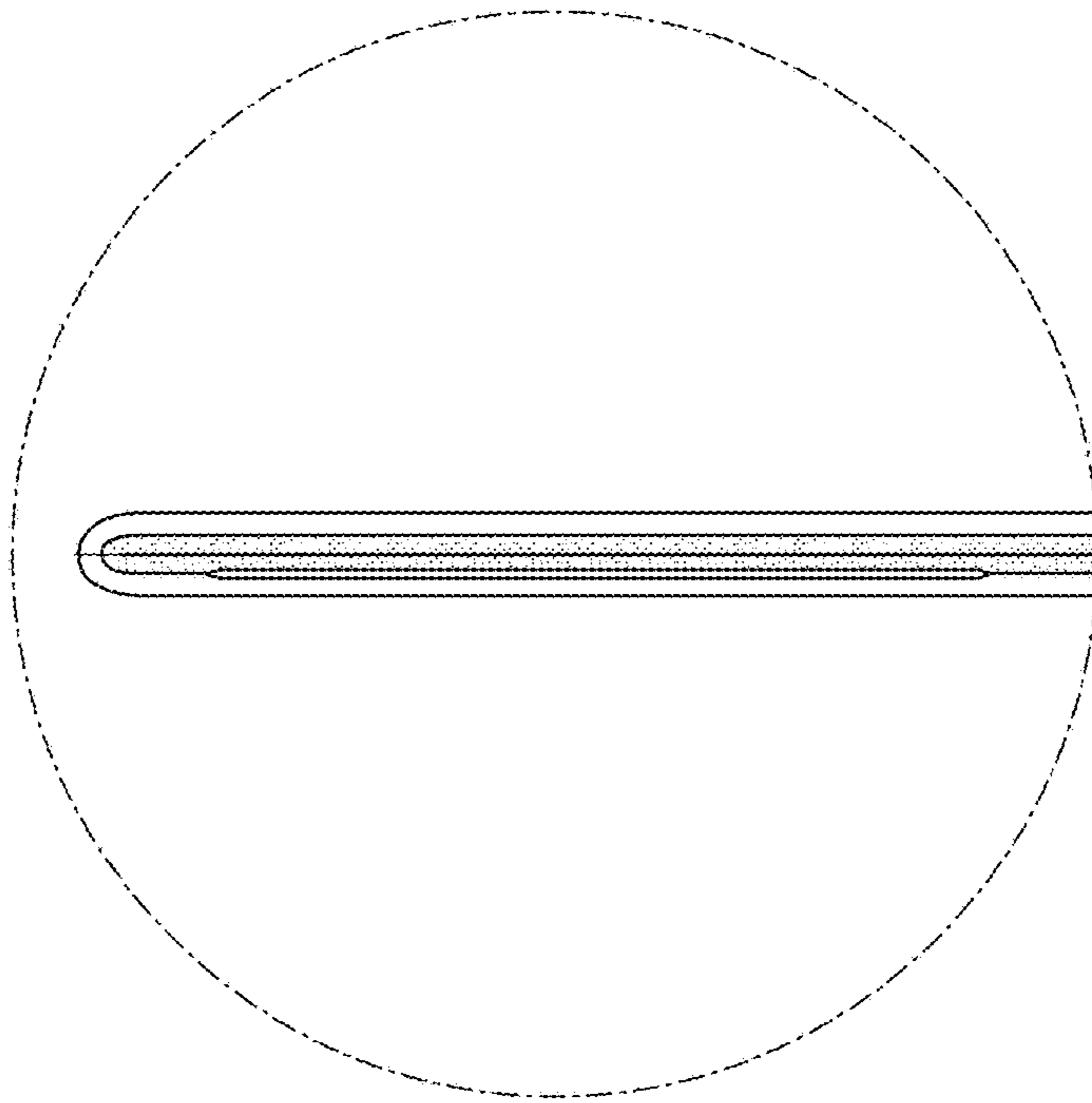

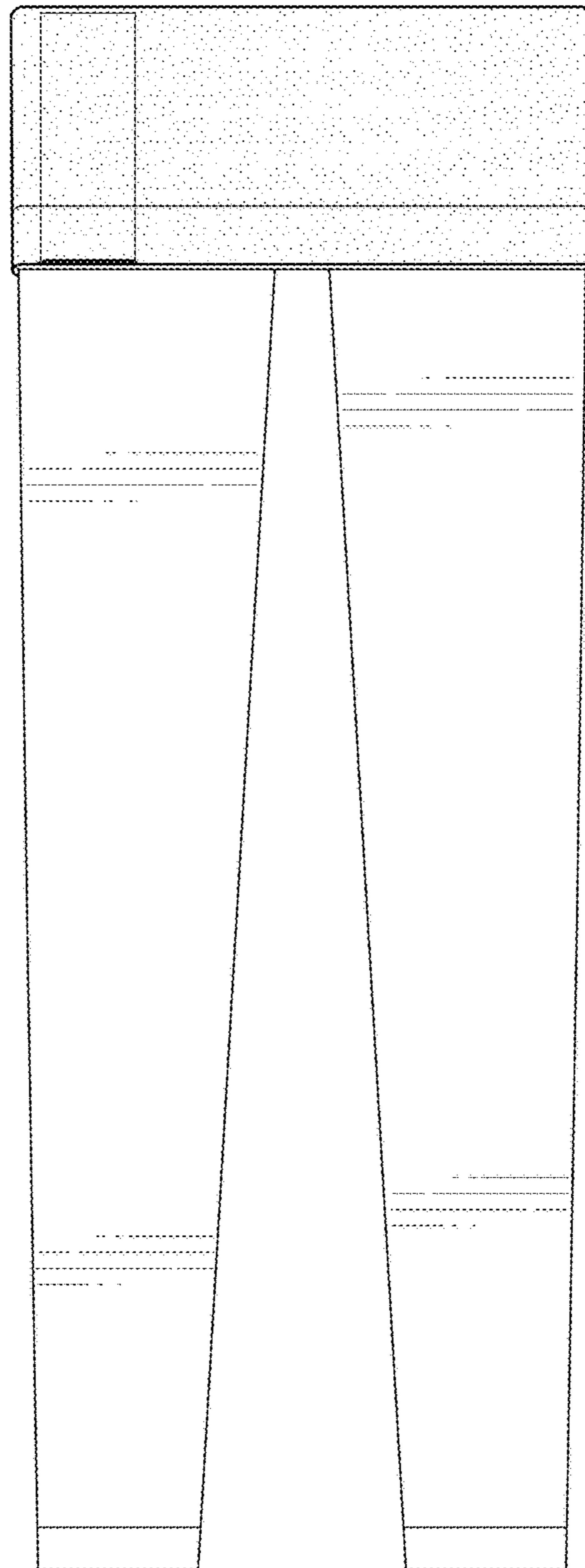

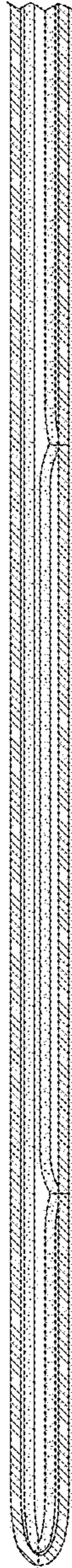

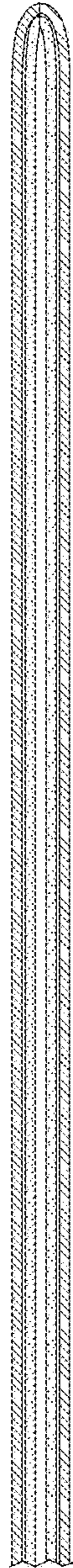

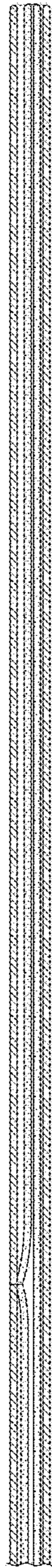

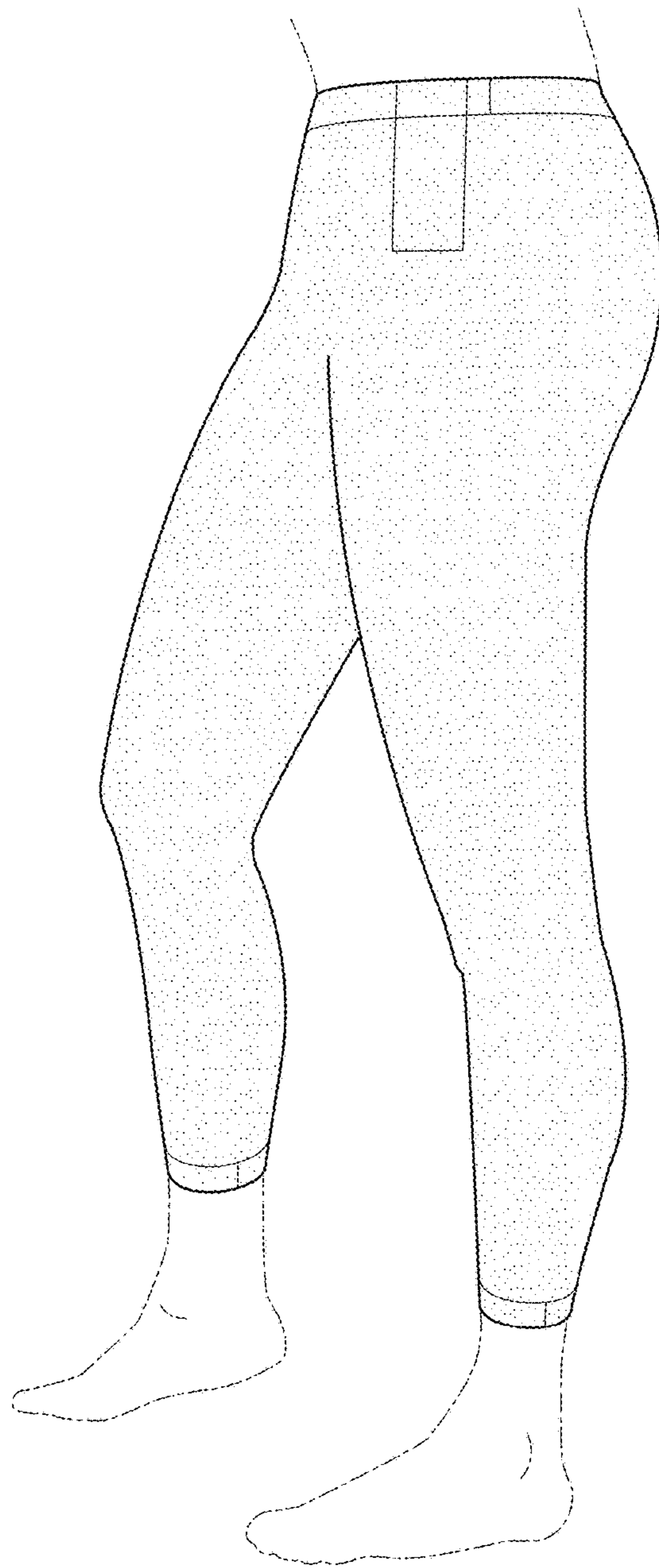

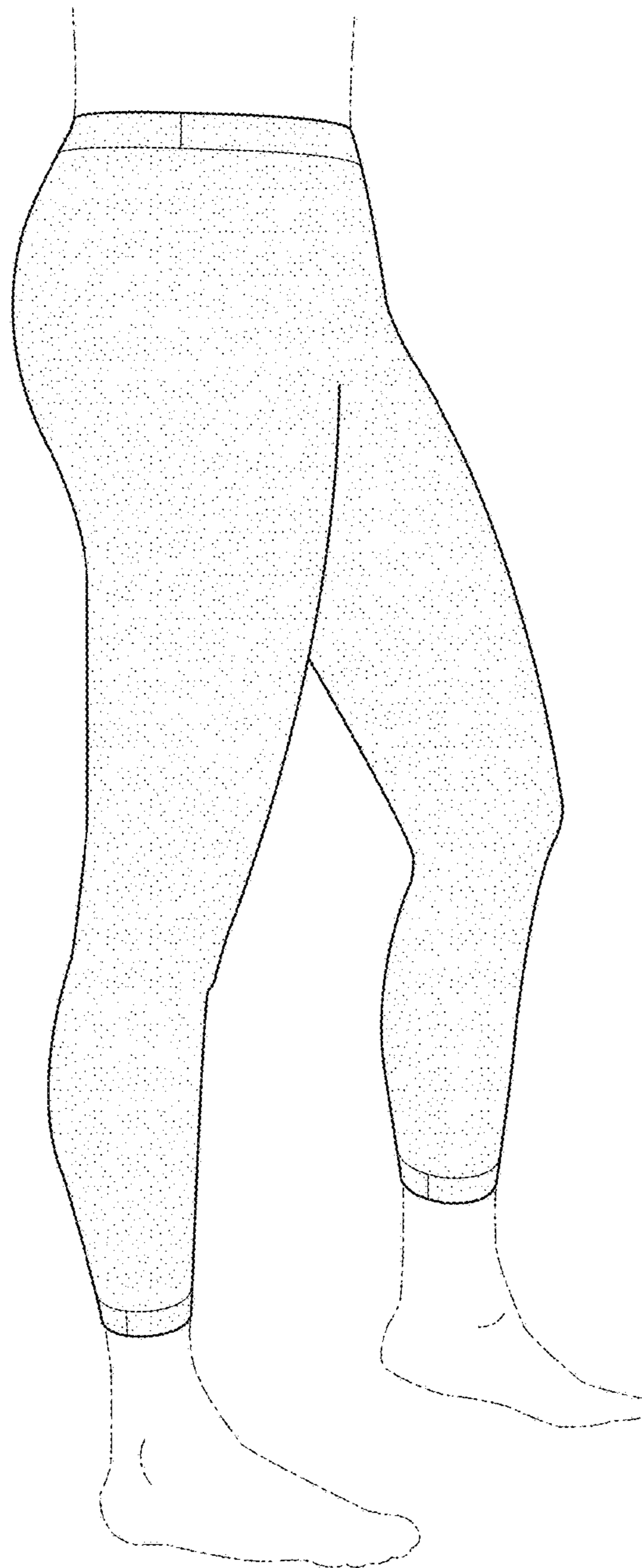
