(57) **CLAIM**

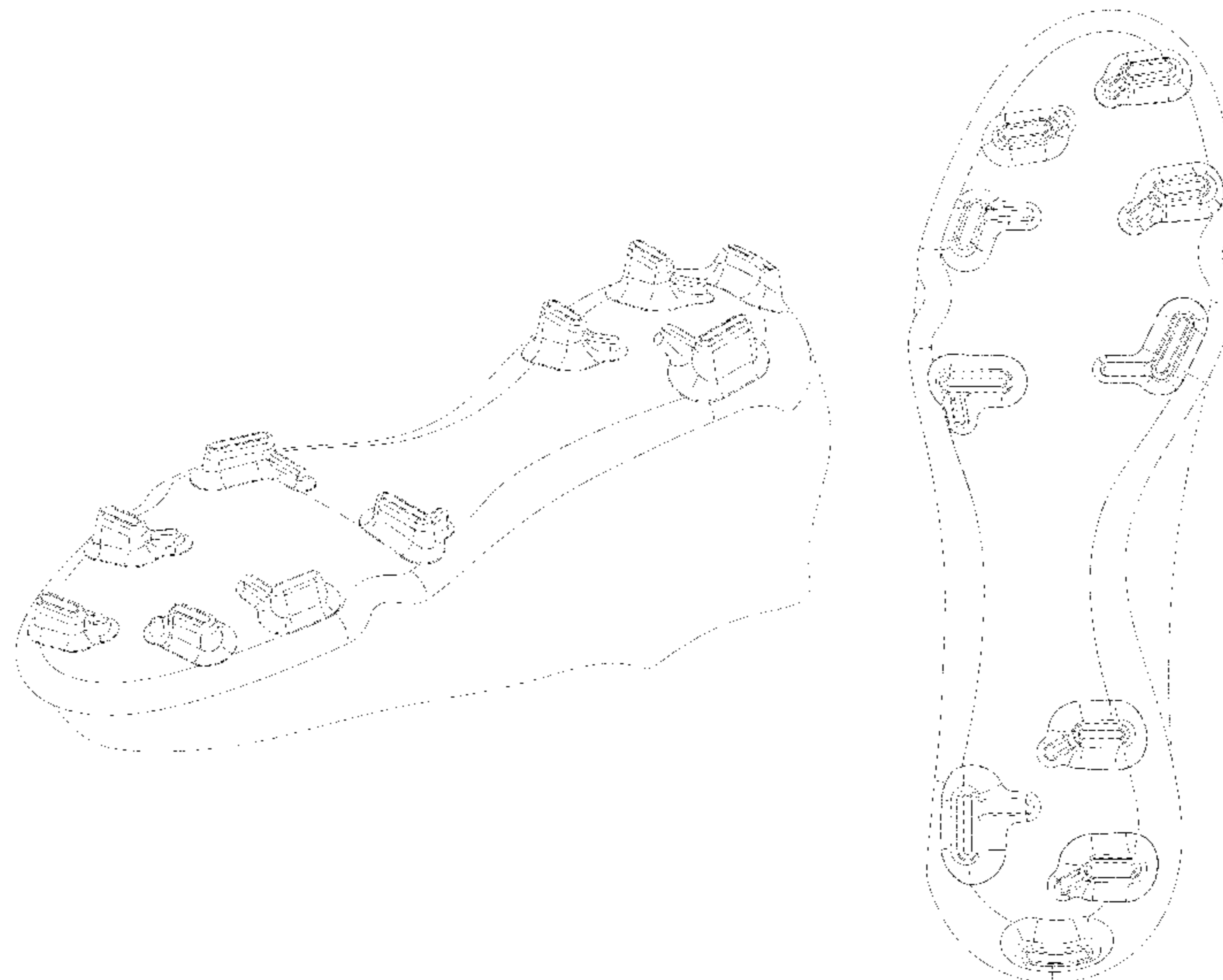
The ornamental design for a sole structure, as shown and described.

DESCRIPTION

FIG. 1 is a lateral, bottom perspective view of a sole structure showing our new design; FIG. 2 is a lateral side view thereof; FIG. 3 is a medial side view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a rear view thereof.

The sole structure in FIGS. 1-7 are for a right footed form, a left footed form being a mirror image of the right footed form. The broken lines shown in the drawings represent portions of the sole structure that form no part of the claimed design.

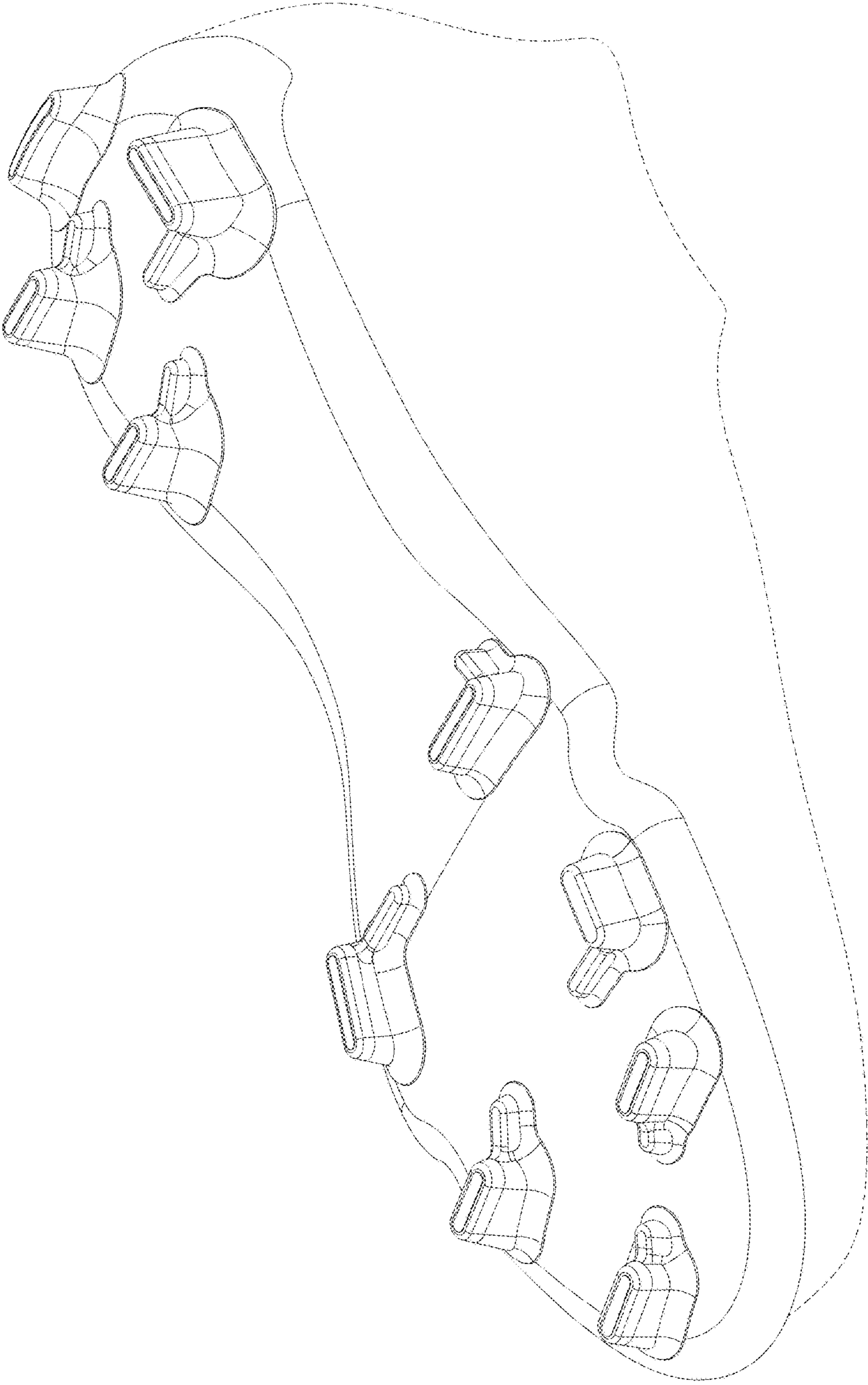

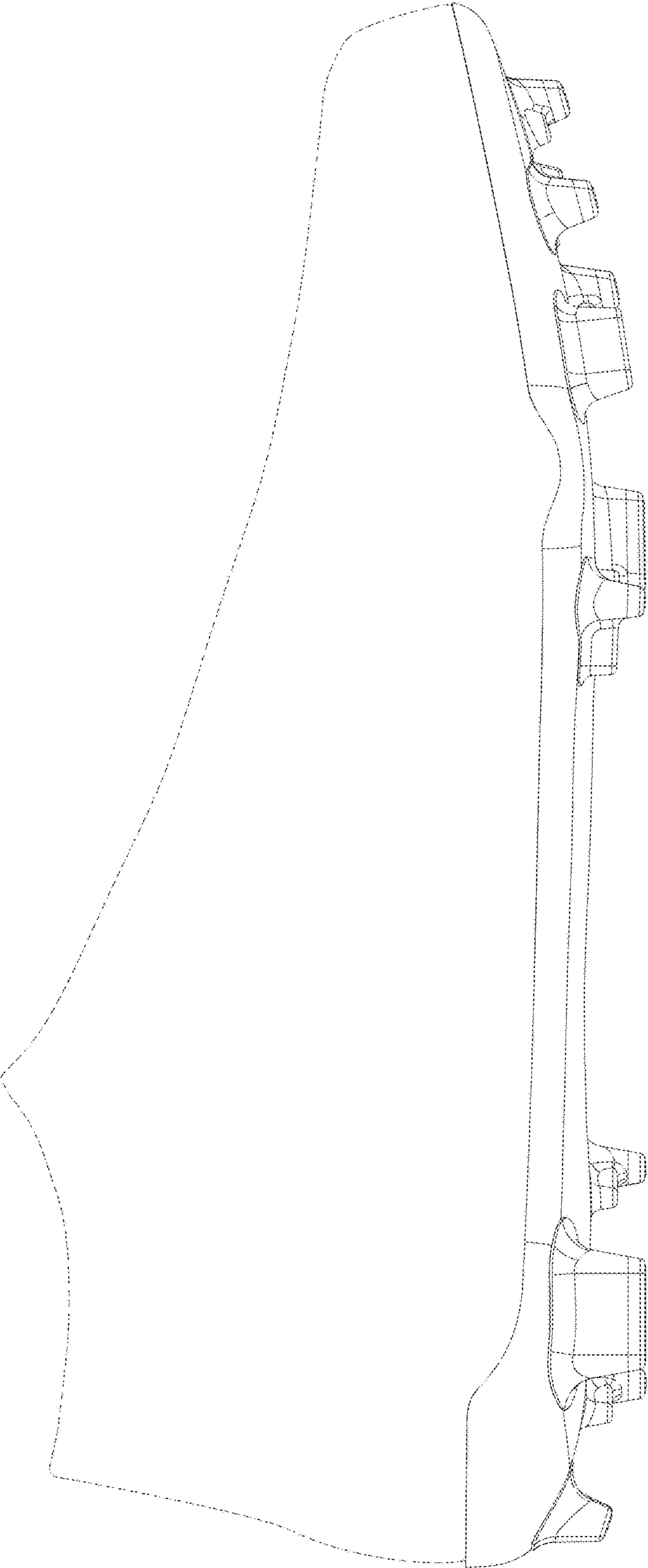

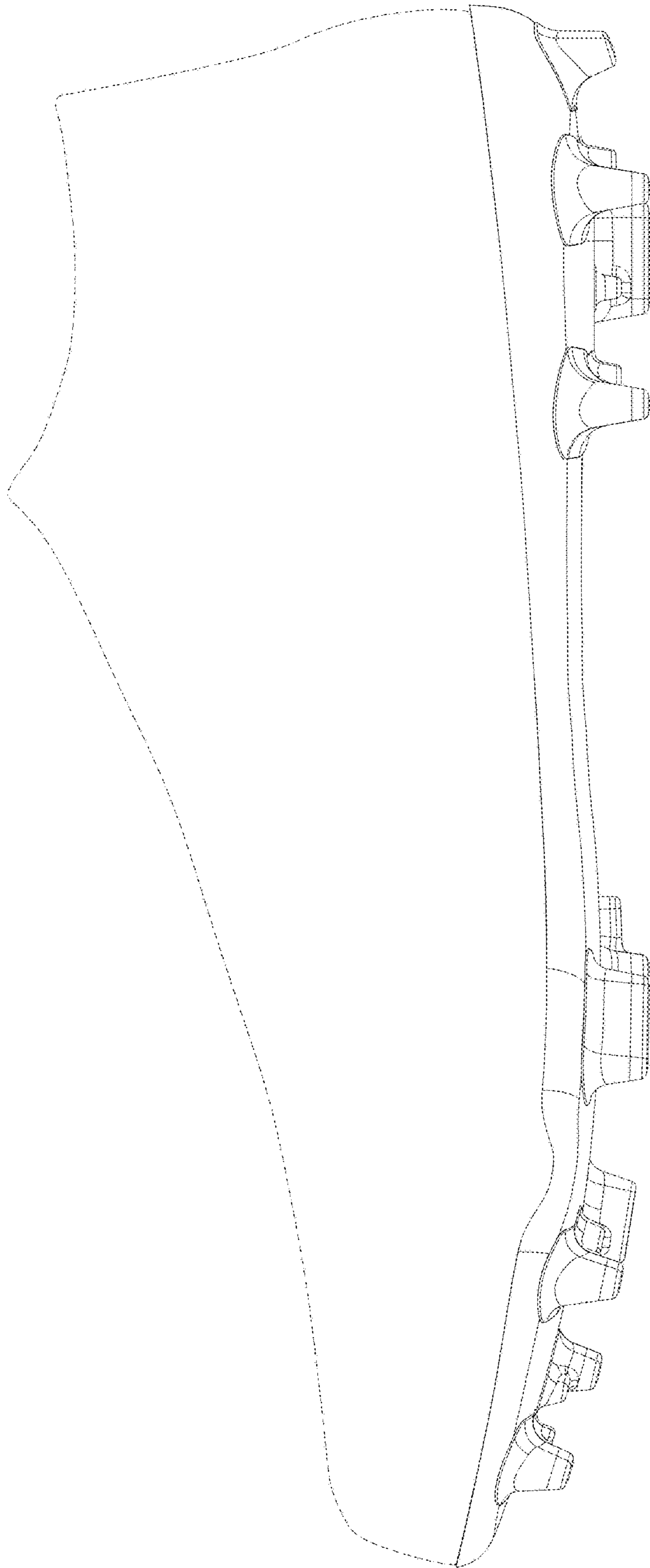

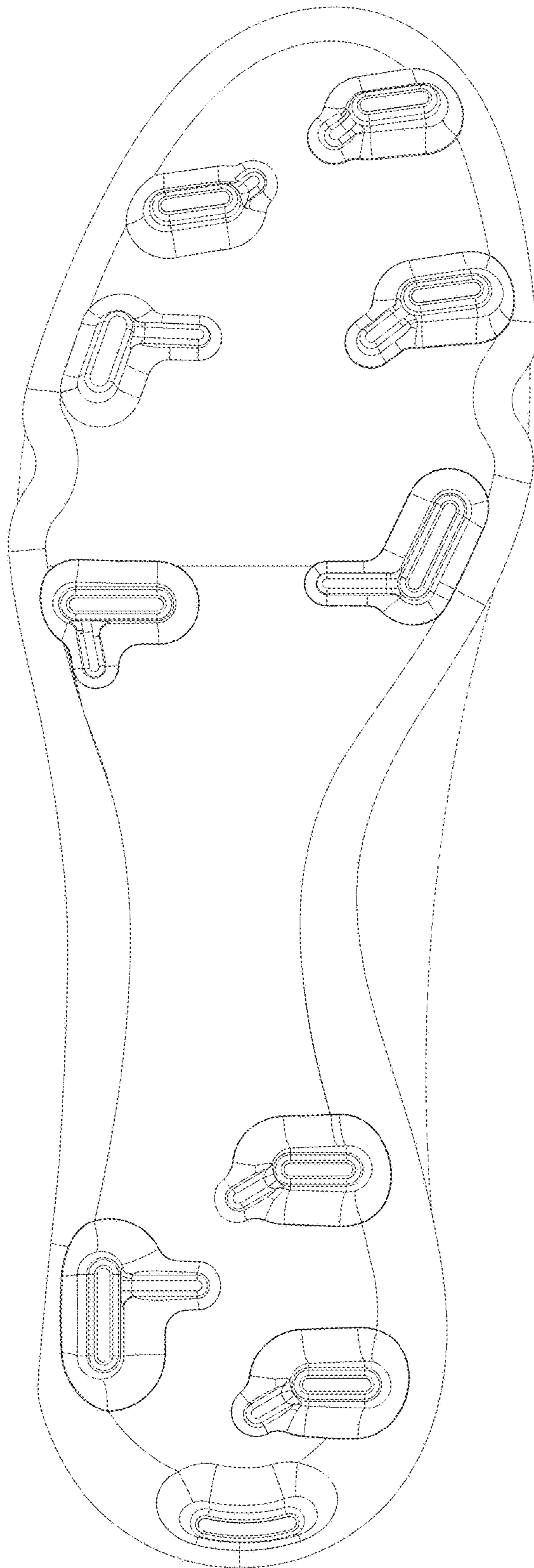

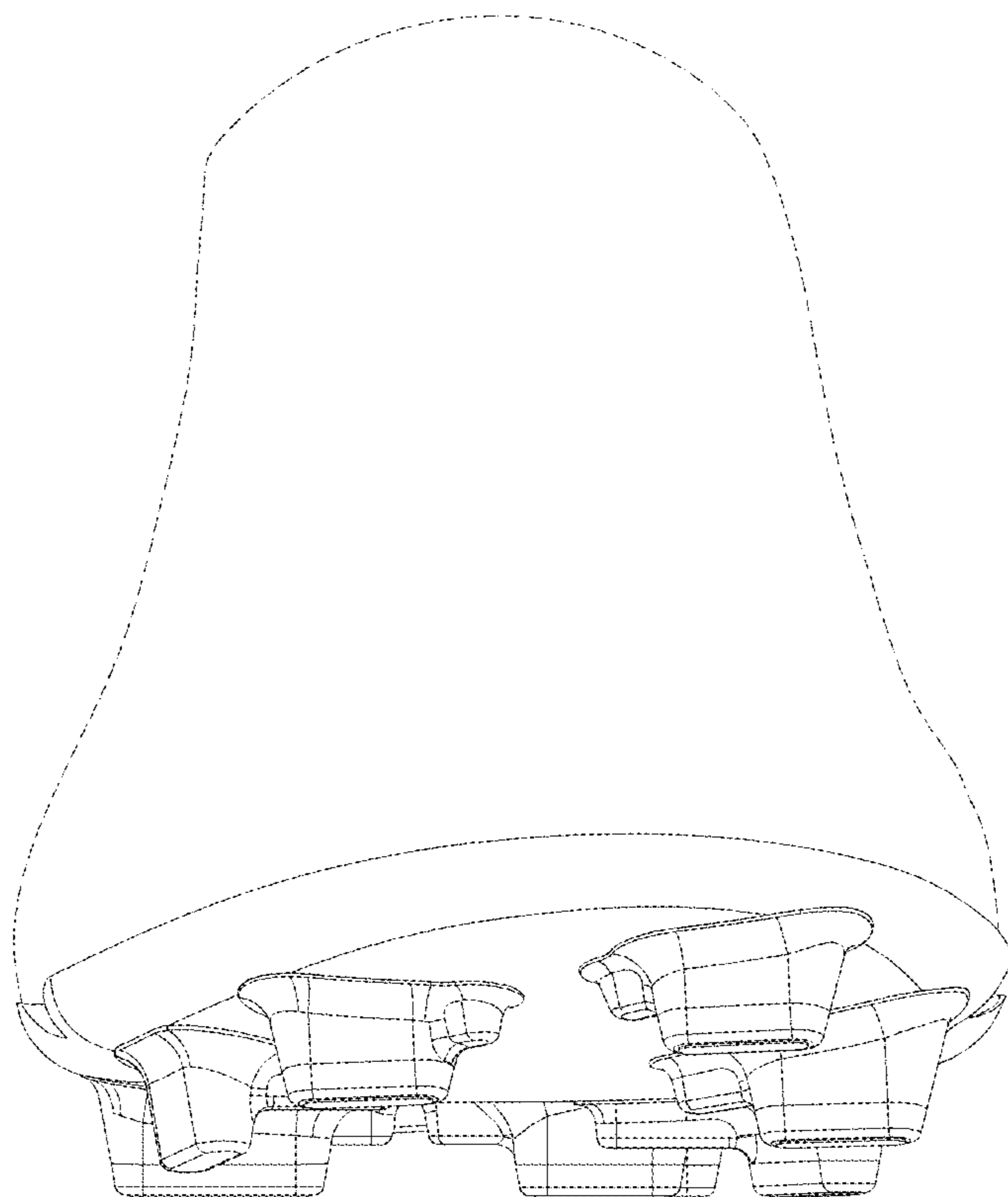

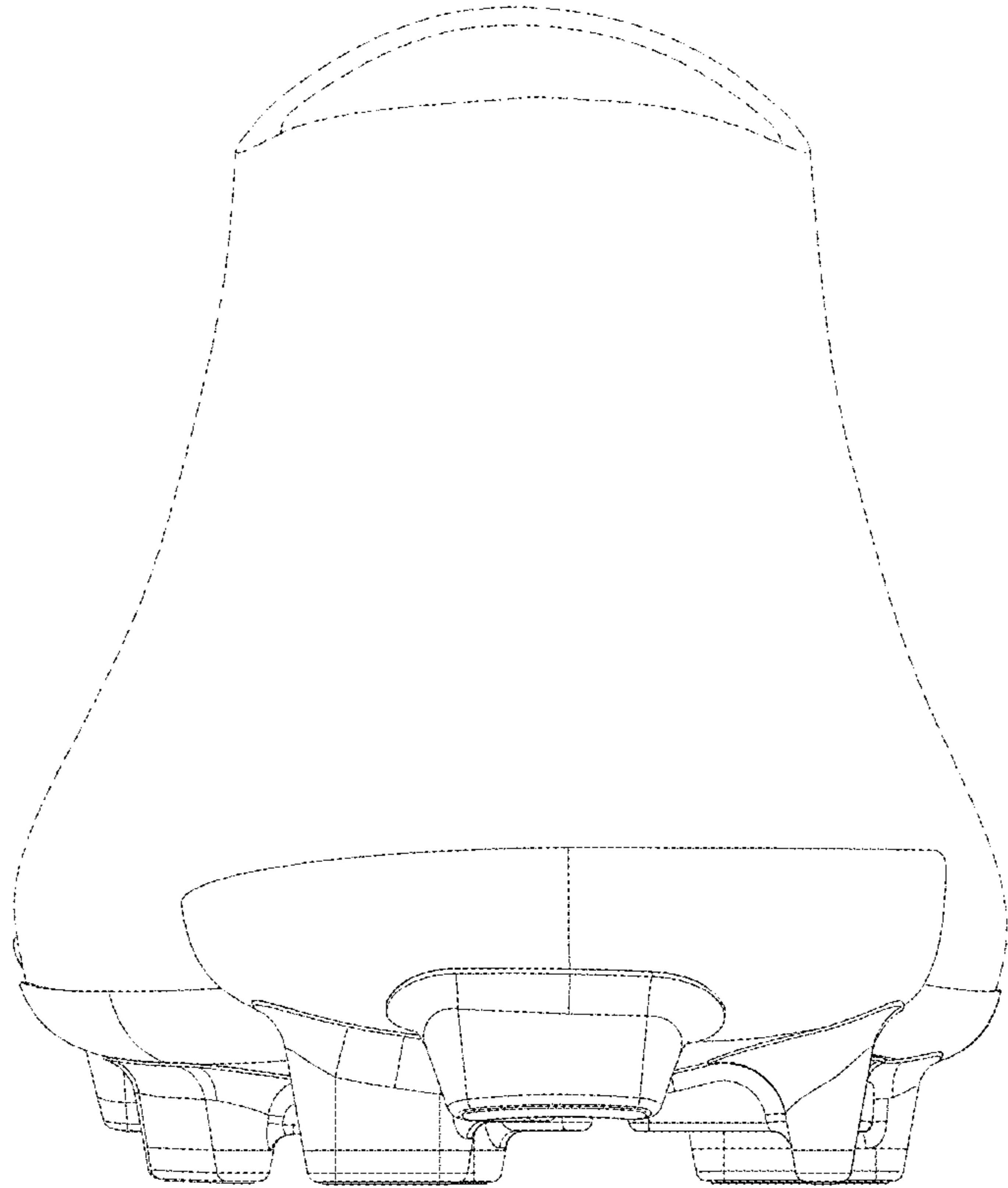
