The ornamental design for a shoe with surface ornamentation, as shown and described.

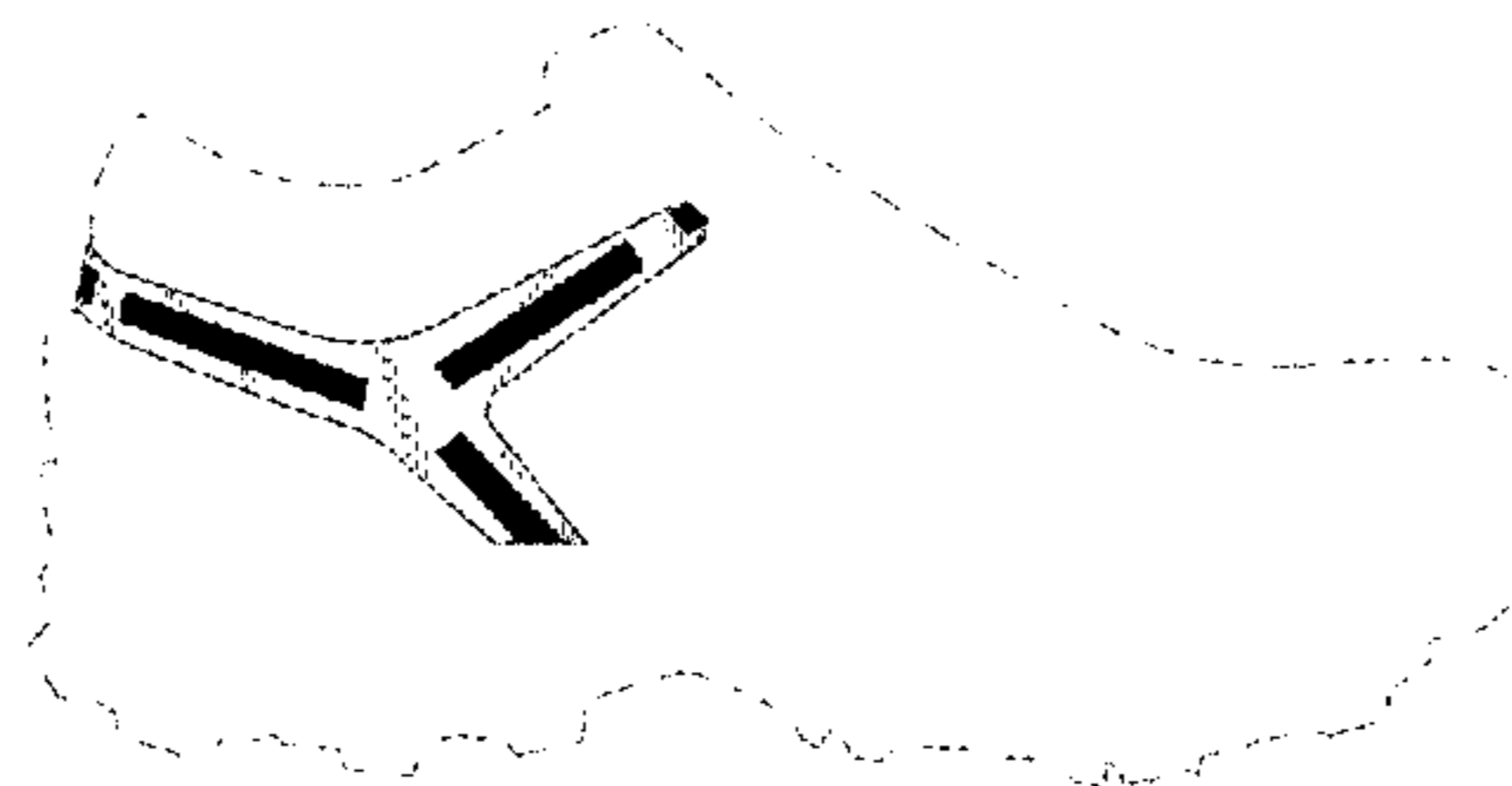
DESCRIPTION
