The ornamental design for an electric toothbrush, as shown and described.

**DESCRIPTION**

- 1.1 : is an upper front perspective view of electric toothbrush, showing my new design;
- 1.2 : is an upper rear perspective view thereof;
- 1.3 : is a front elevation view thereof;
- 1.4 : is a rear elevation view thereof;
- 1.5 : is a left side view thereof;
- 1.6 : is a right side view thereof;
- 1.7 : is a top view thereof; and
- 1.8 : is a bottom view thereof.

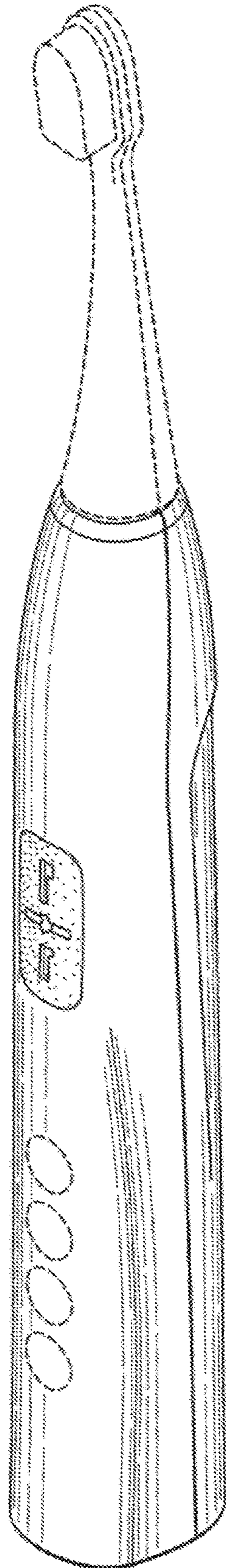

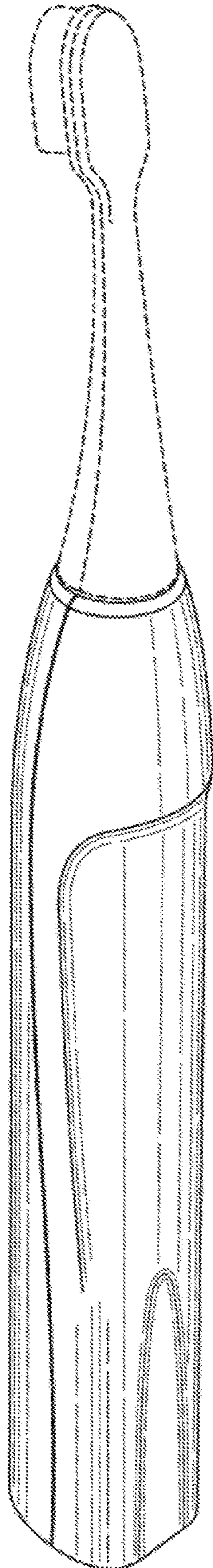

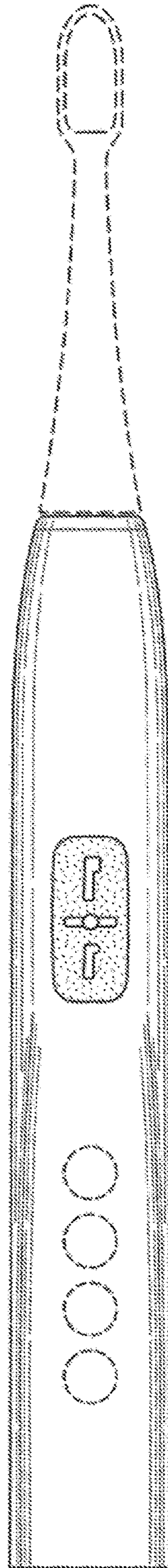

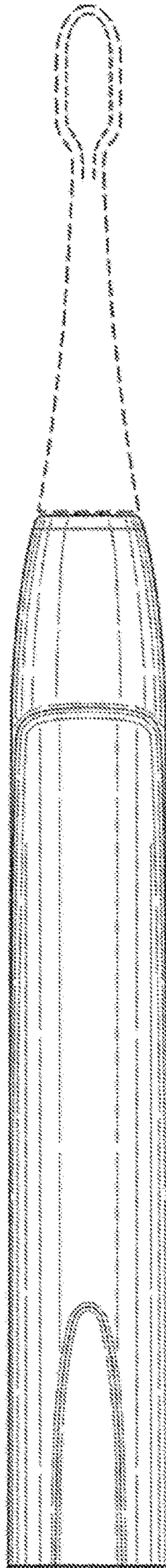

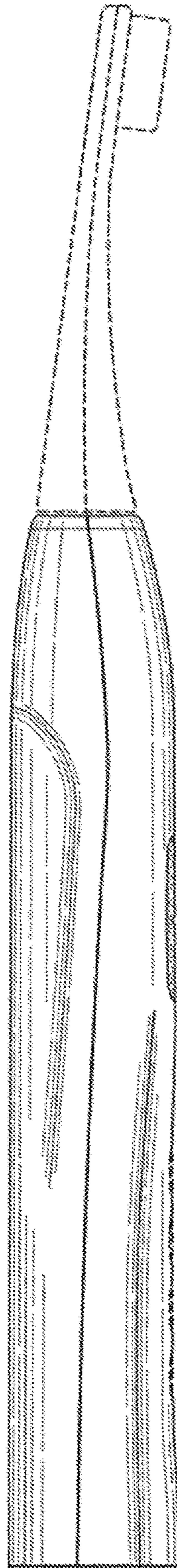

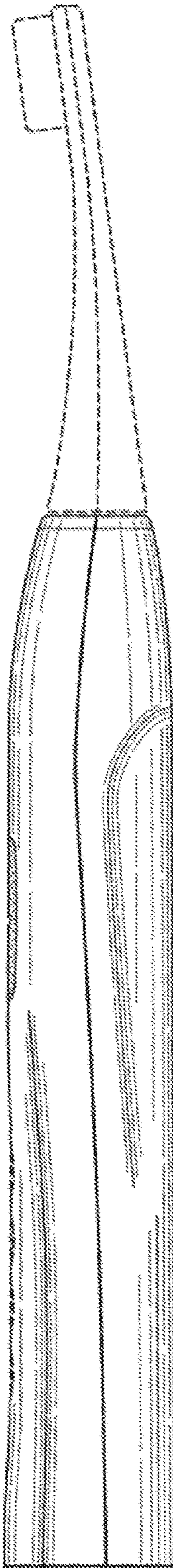

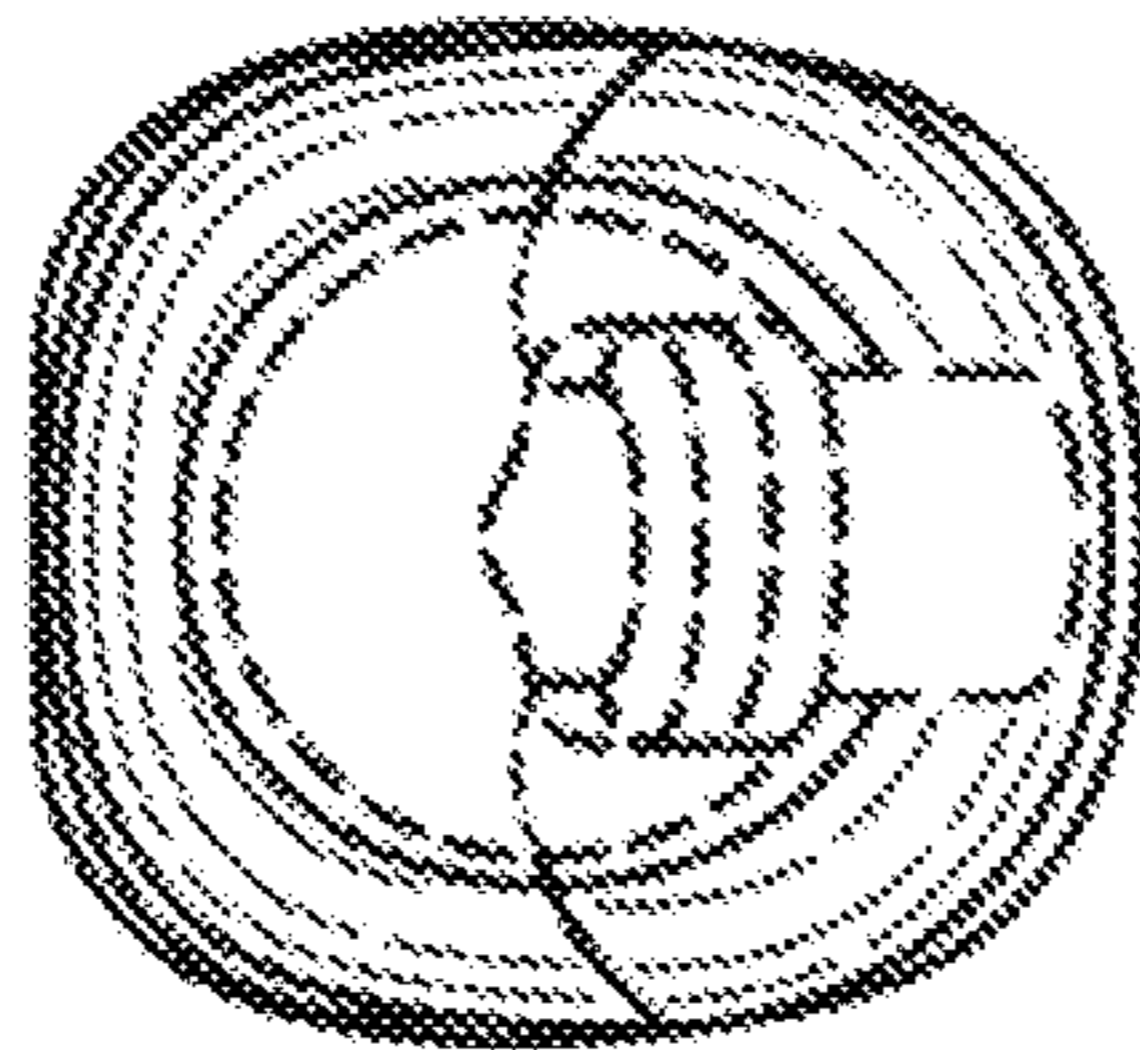
