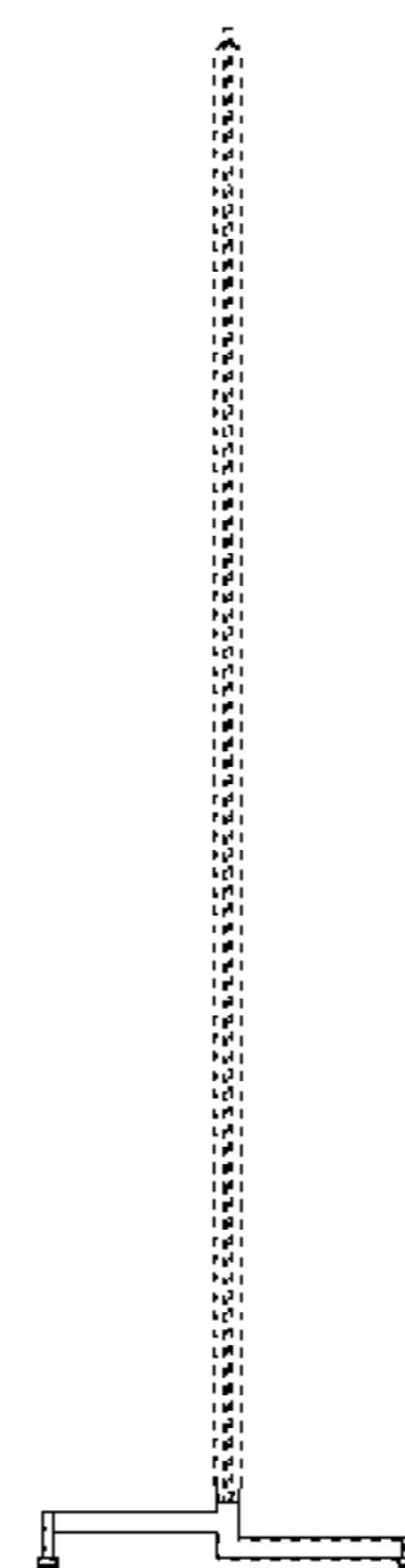
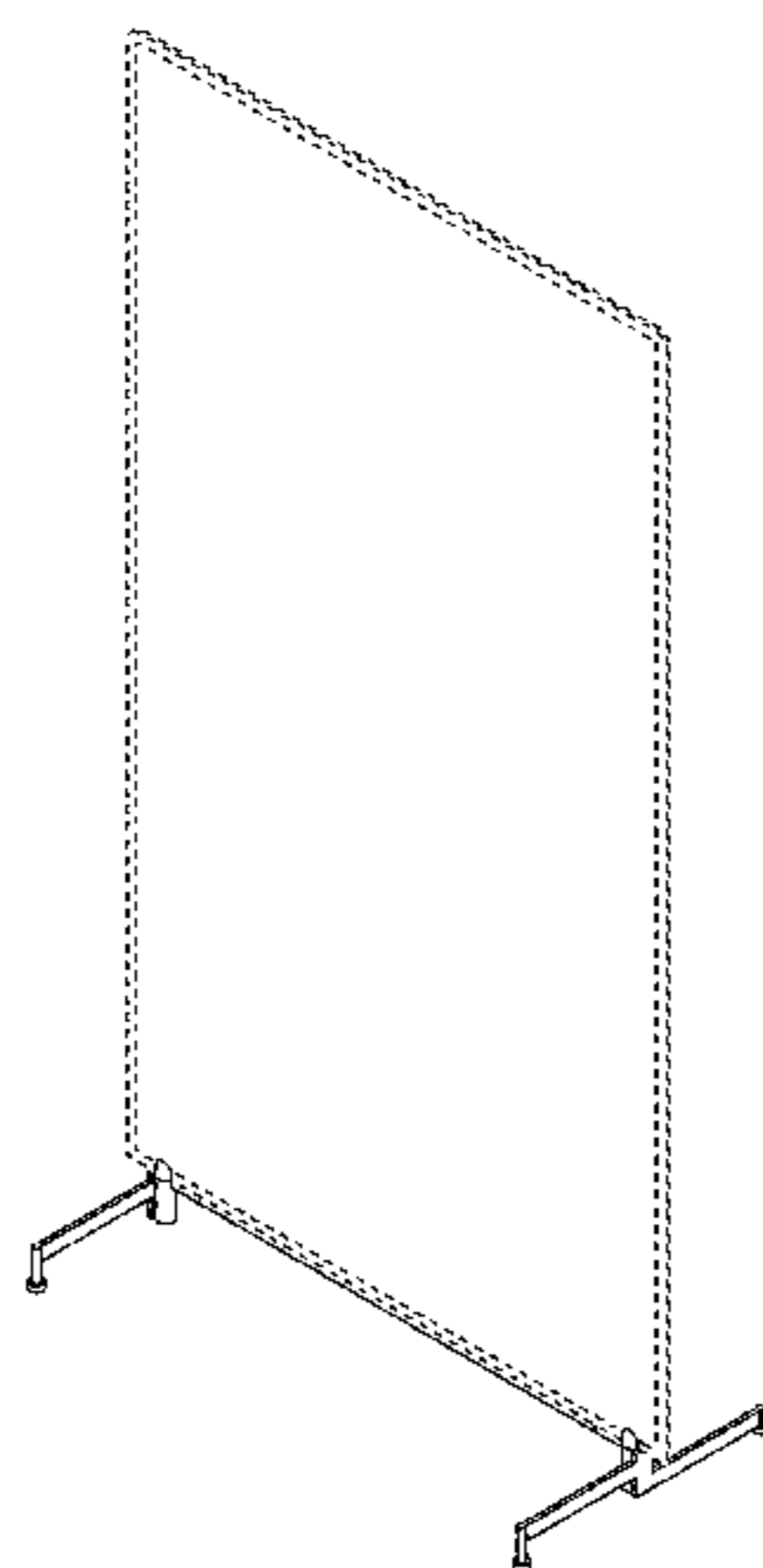
(57) **CLAIM**

The ornamental design for a partition panel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a partition panel showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof, the left side view being a mirror image thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a cross-sectional view taken along line 7-7 in FIG. 2;
FIG. 8 is an enlarged cross-sectional view taken along line 8-8 in FIG. 2; and,
FIG. 9 is an enlarged cross-sectional view taken along line 9-9 in FIG. 2.
The broken lines shown in the drawings illustrate portions of the partition panel that form no part of the claimed design.

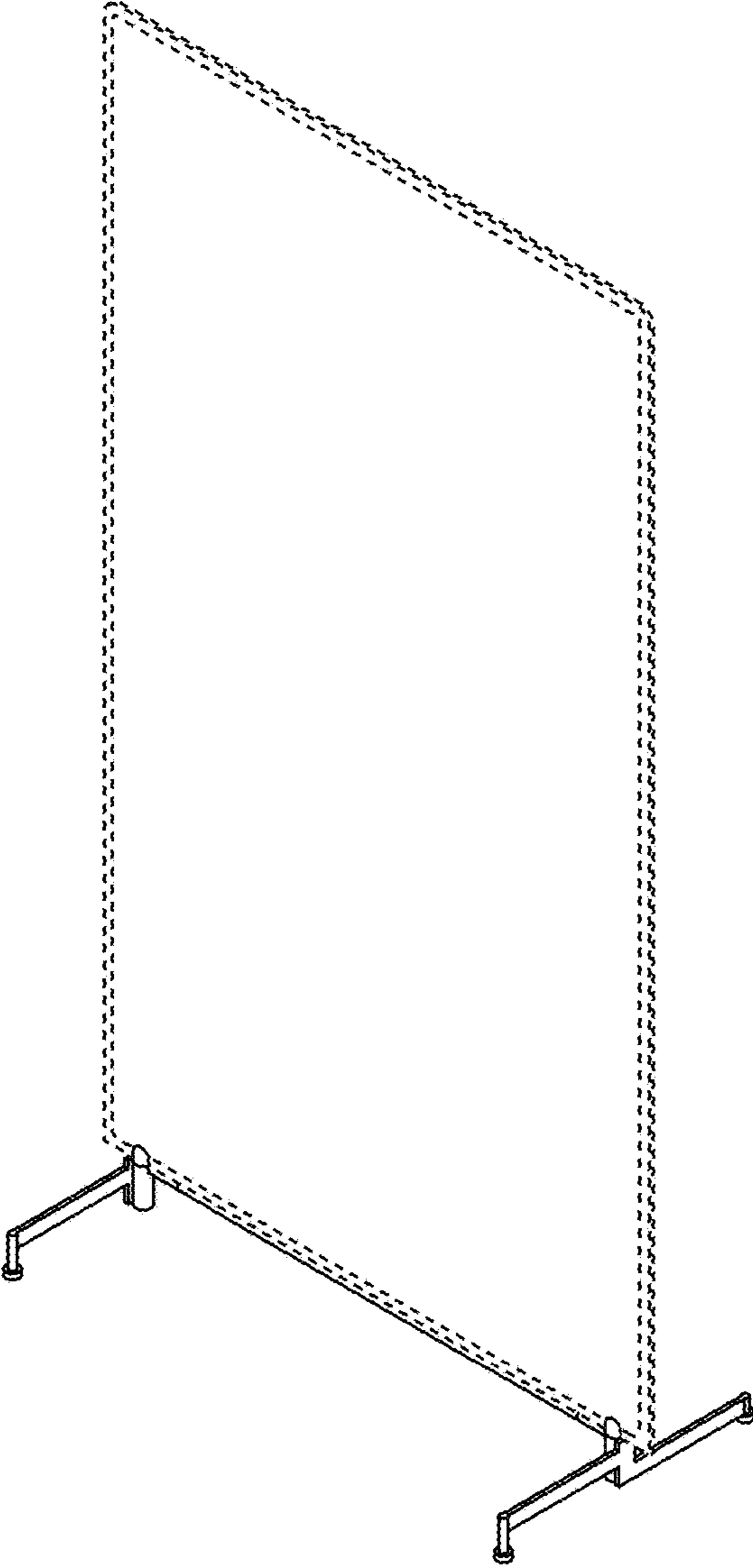

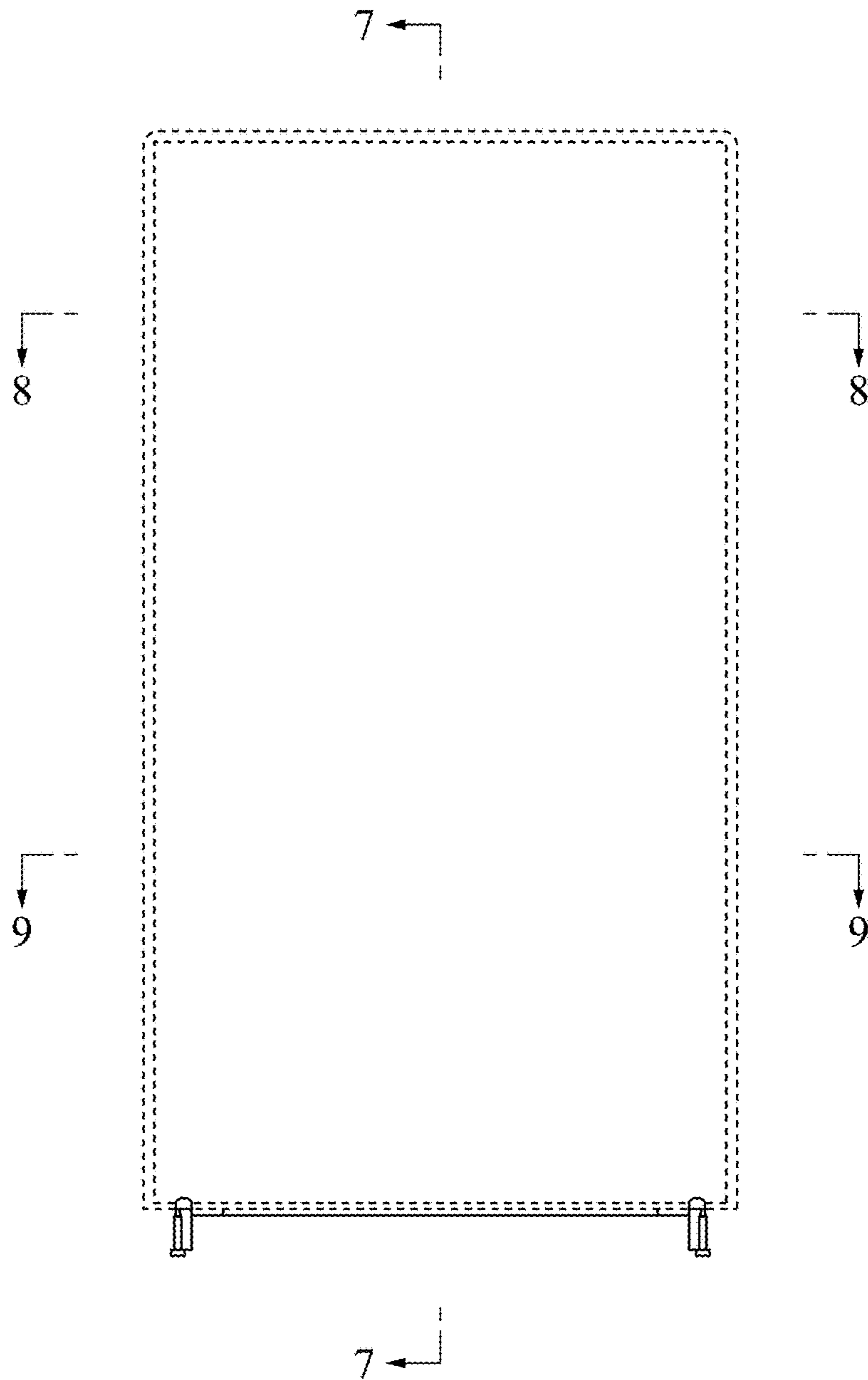

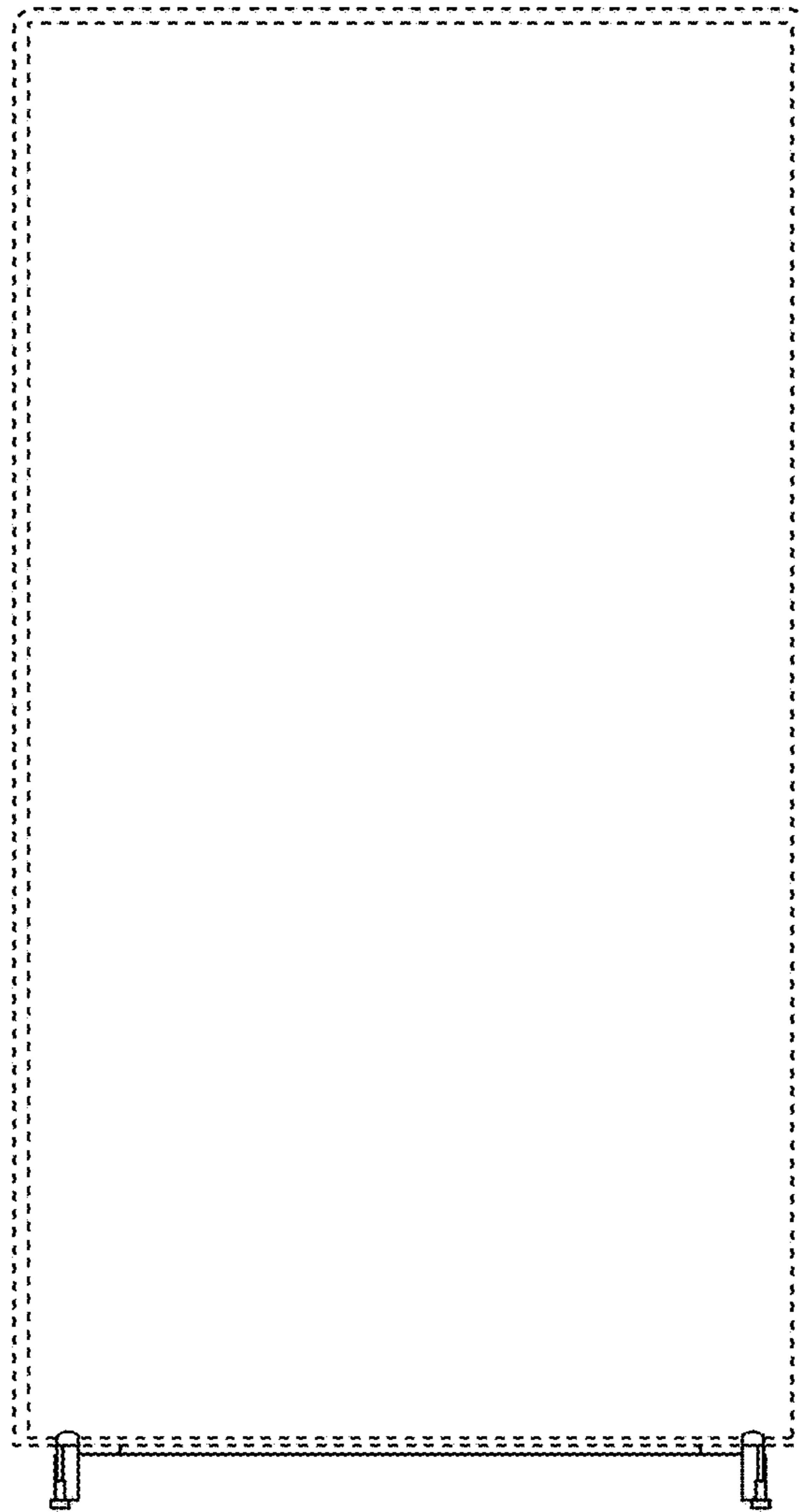

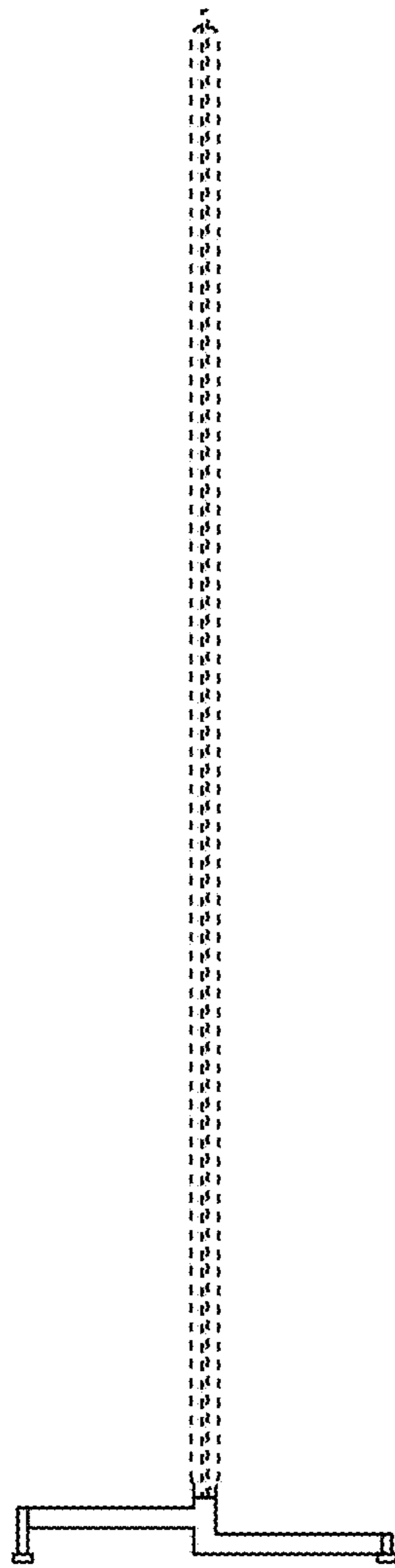

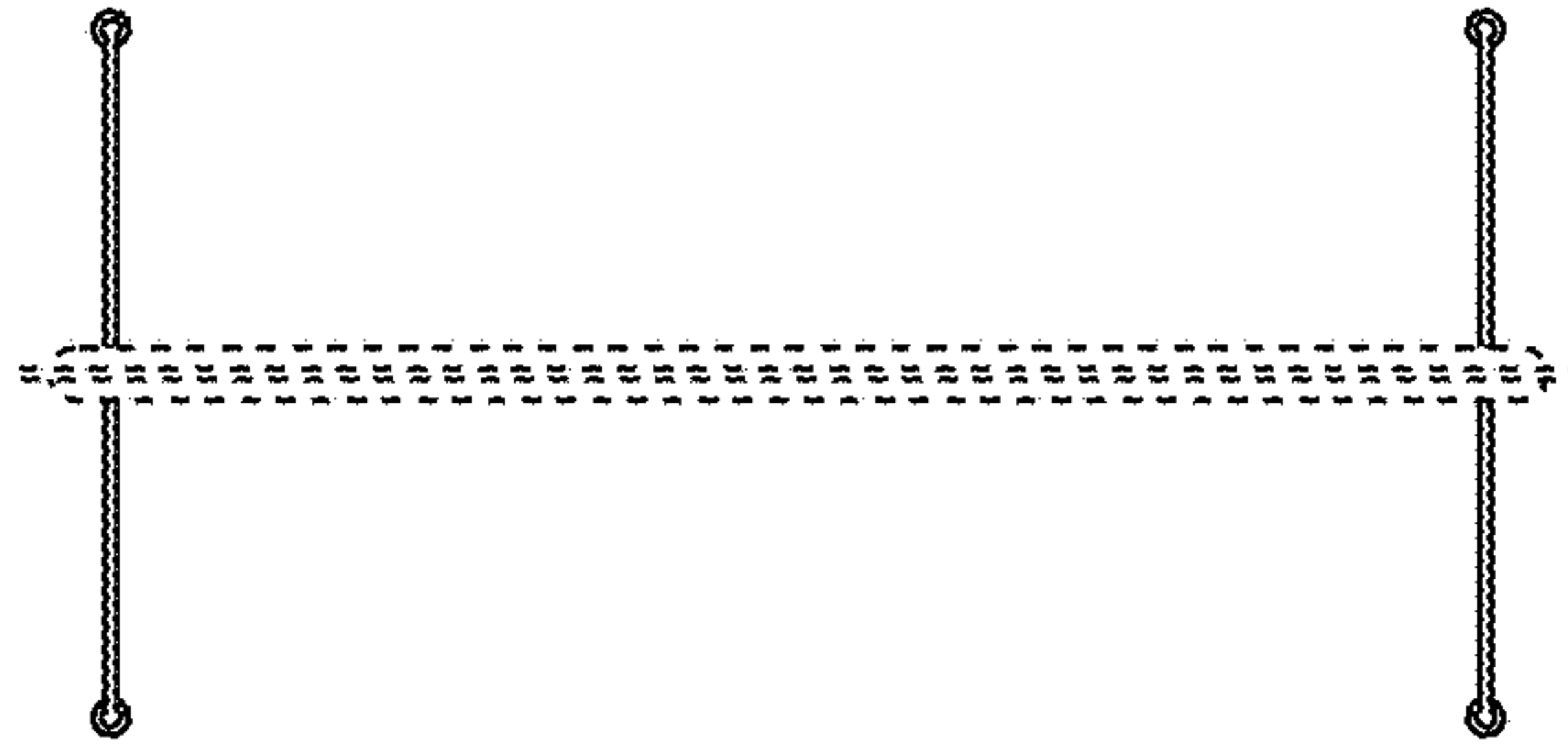

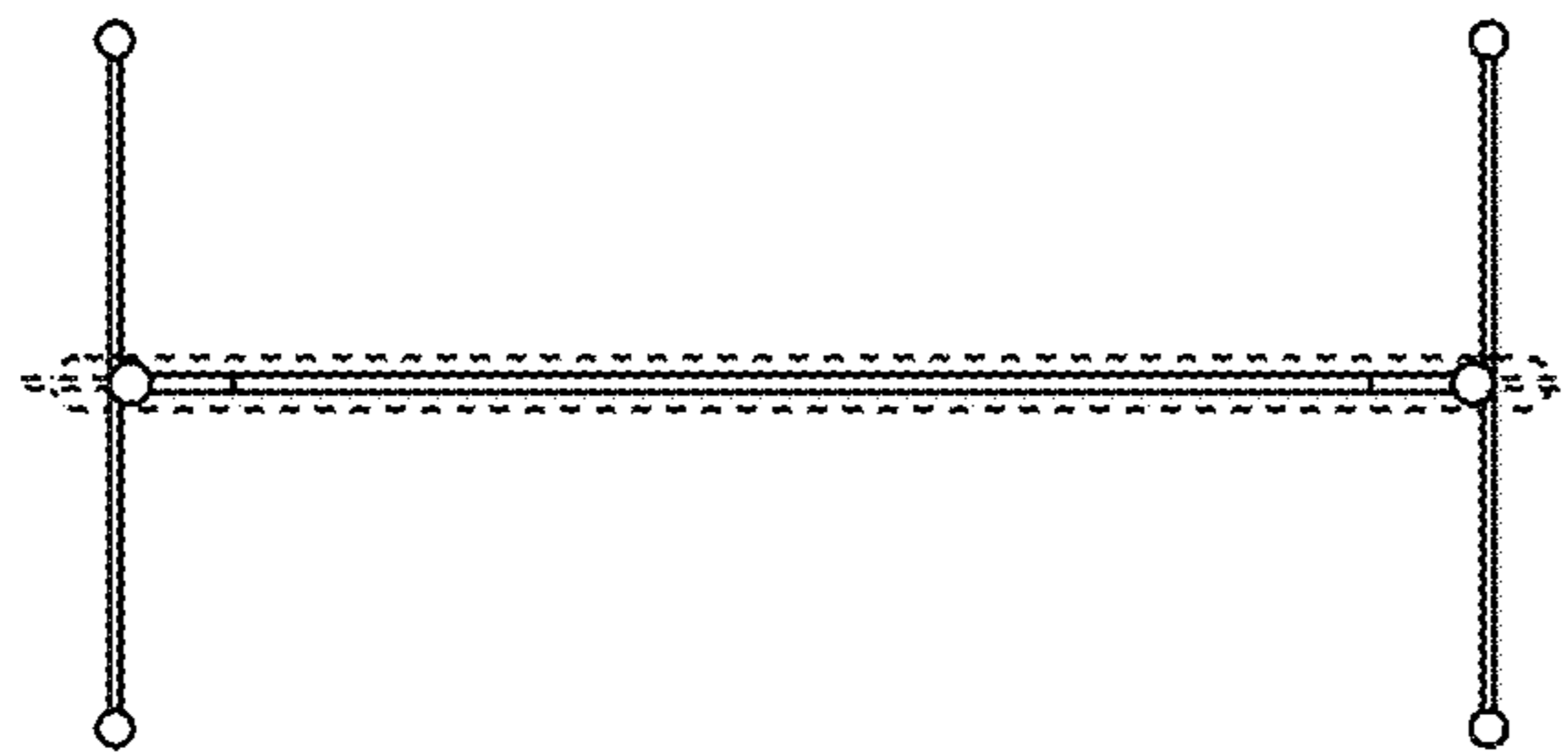

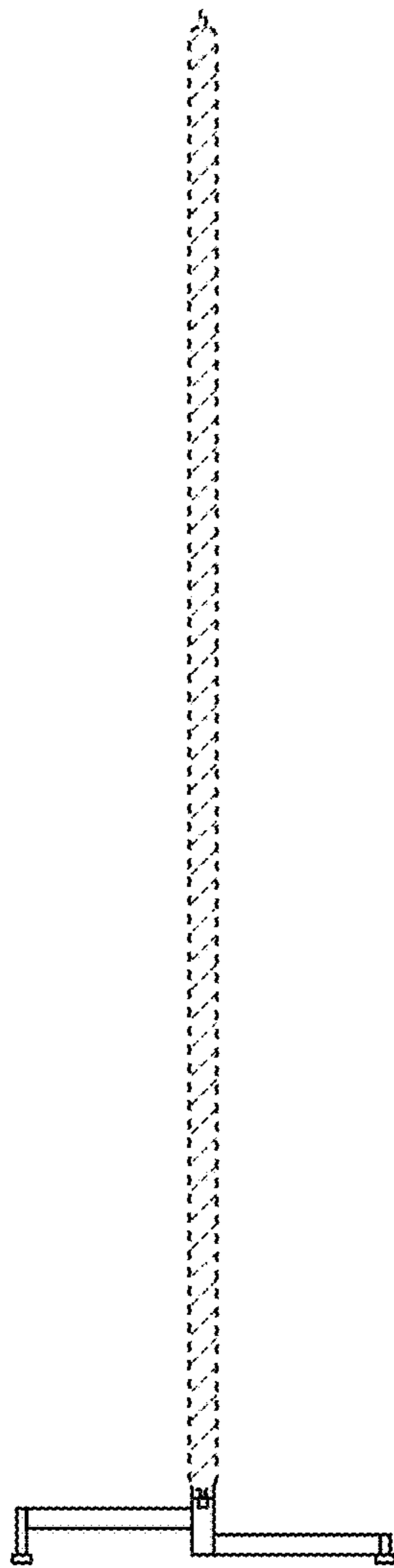

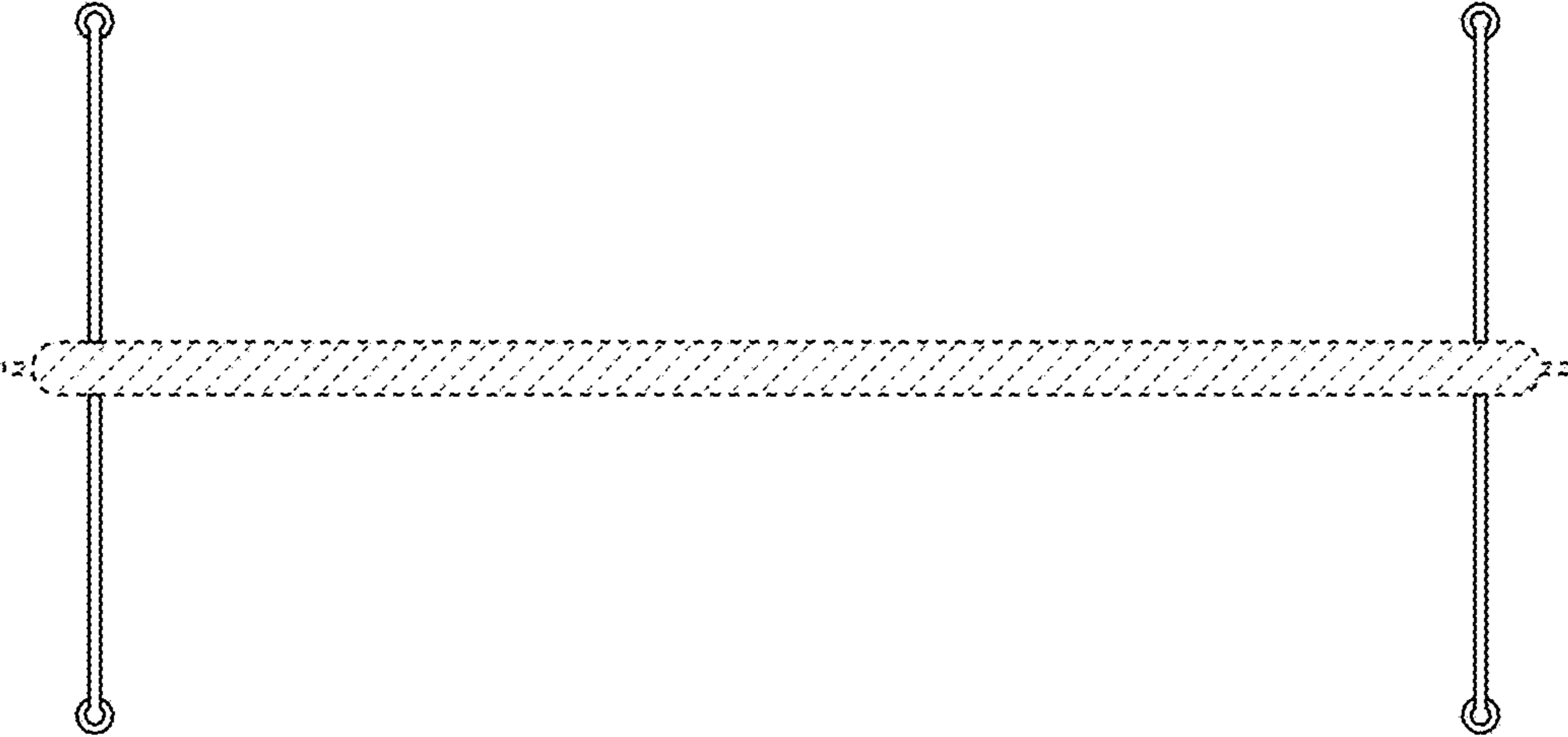
