2.5 is a rear view thereof;

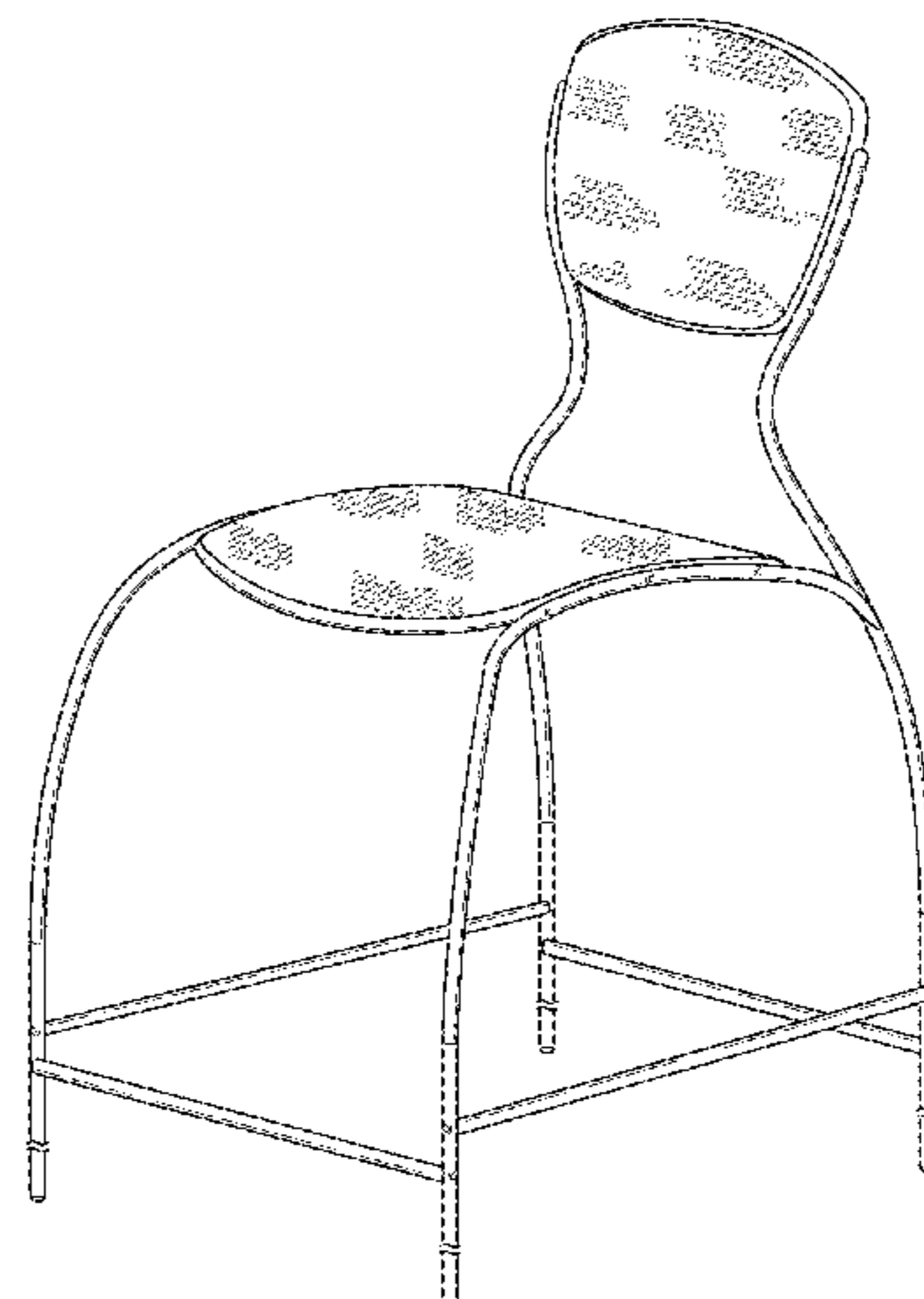
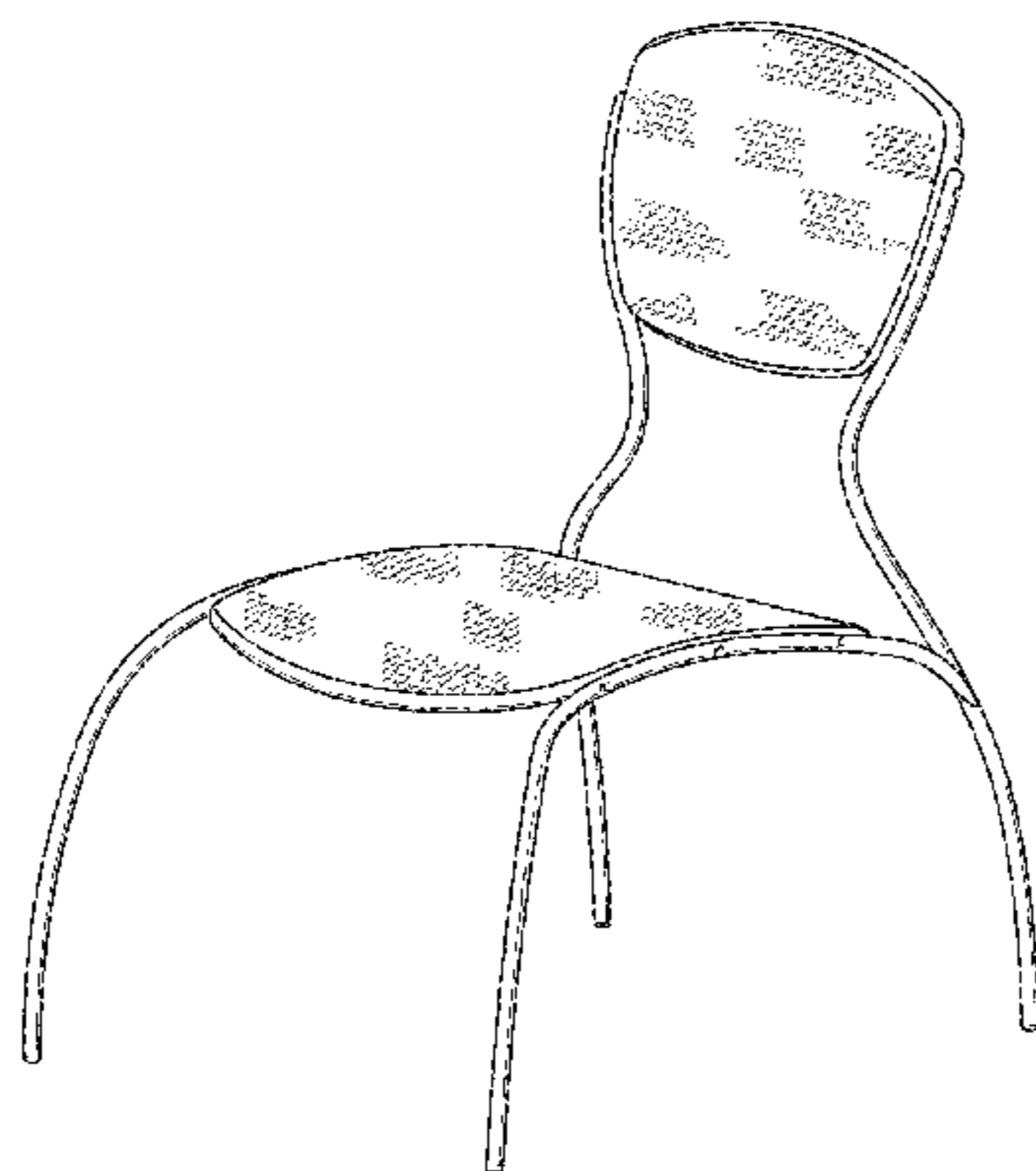
2.6 is a left right view thereof; and

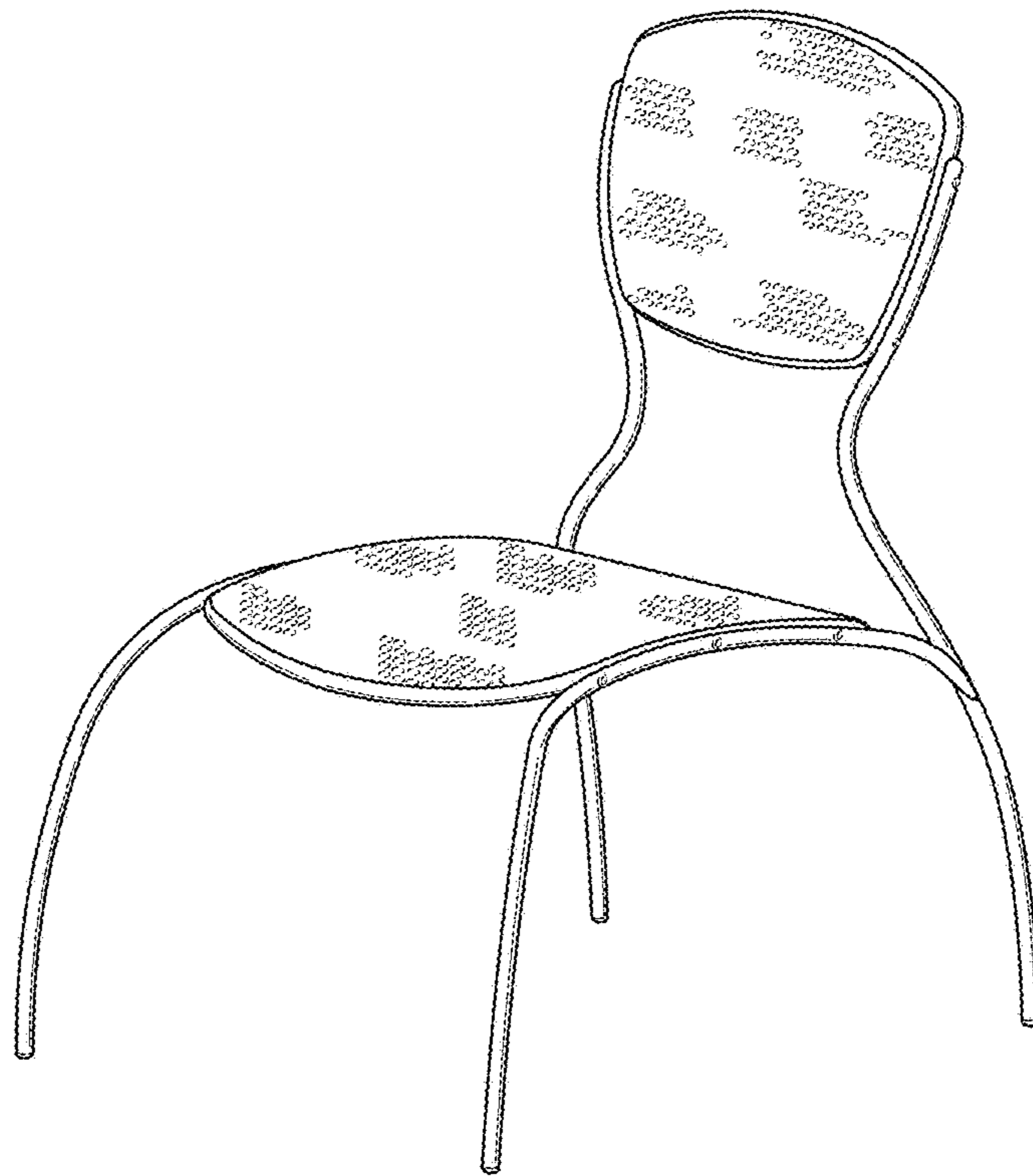

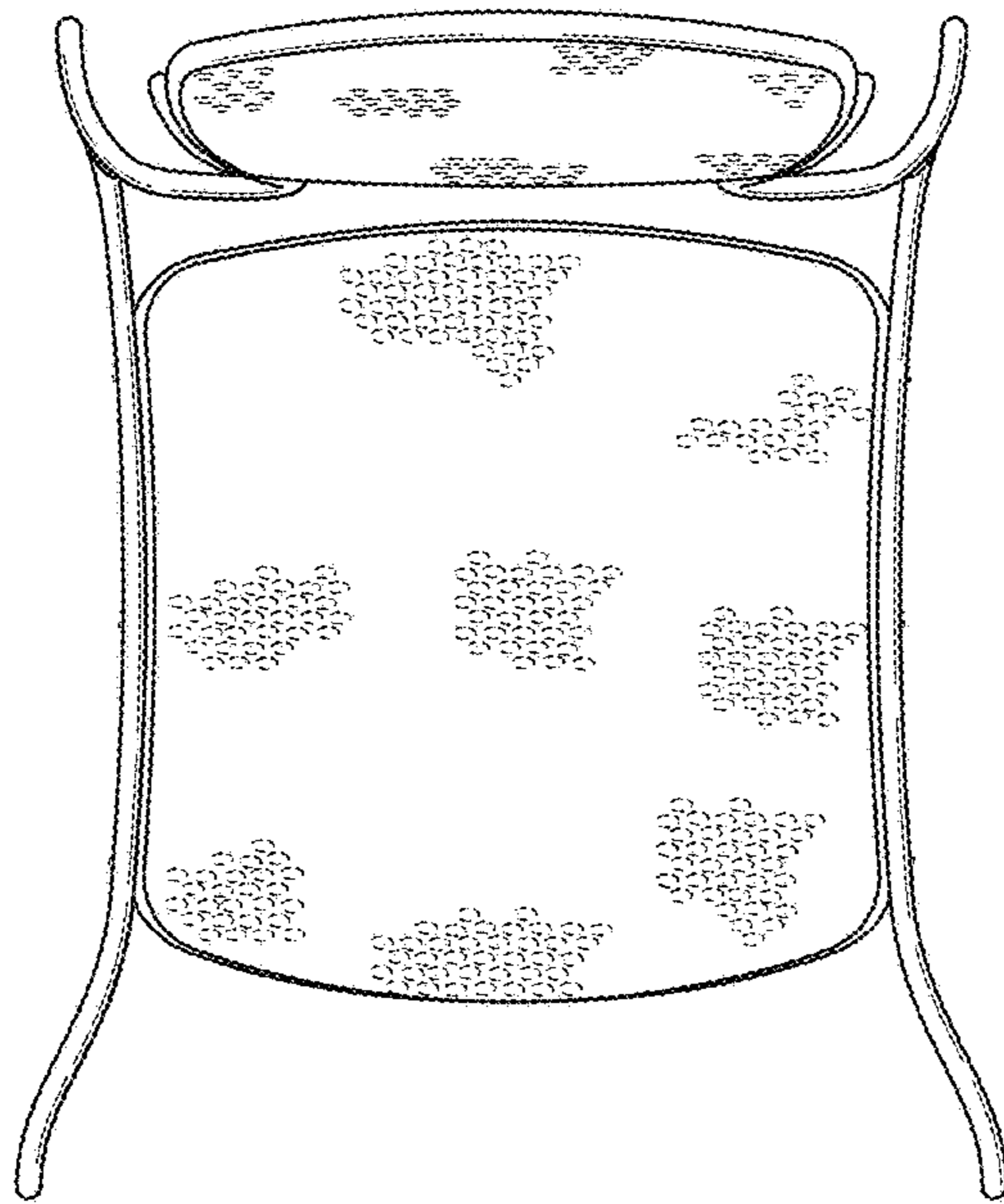

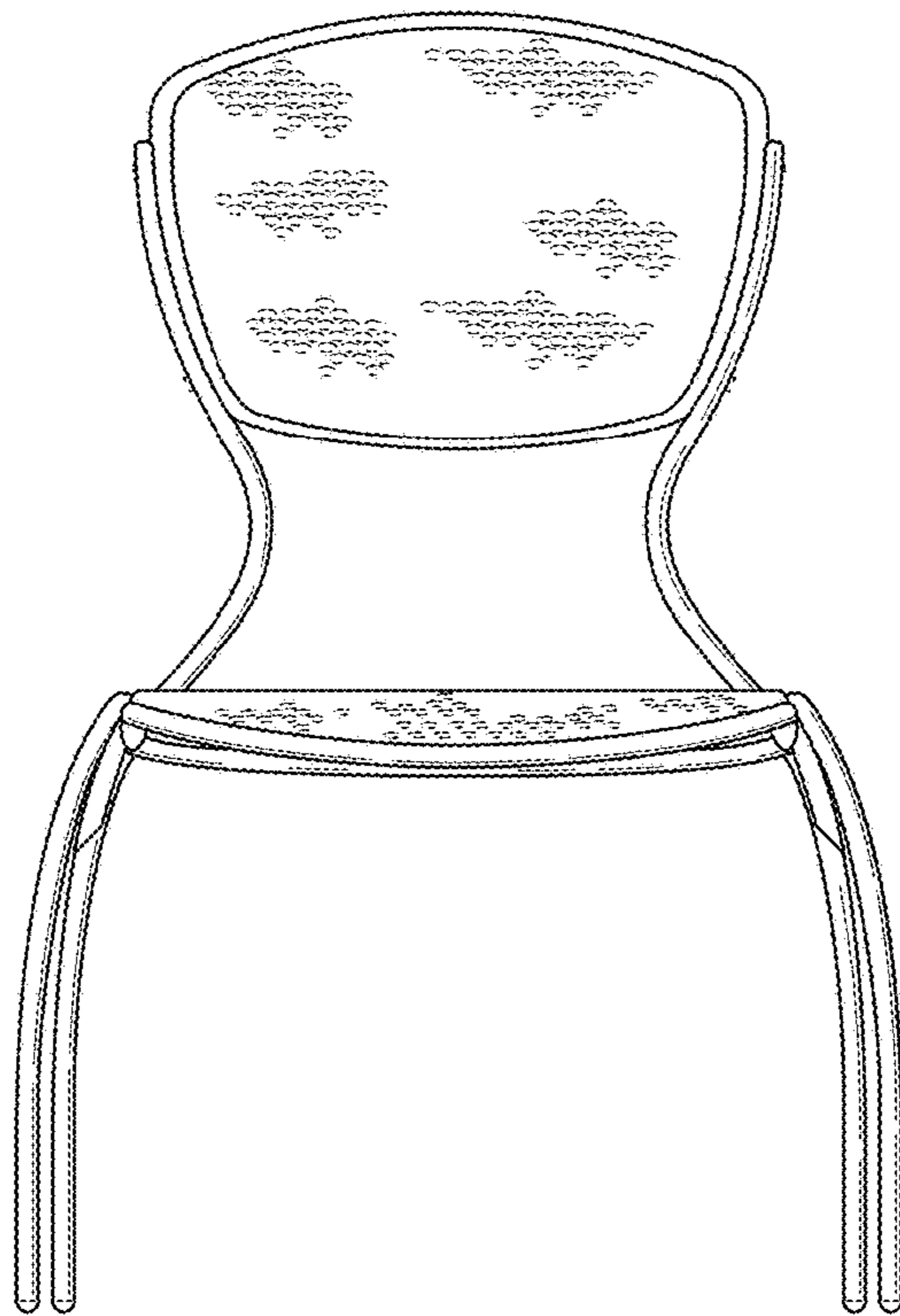

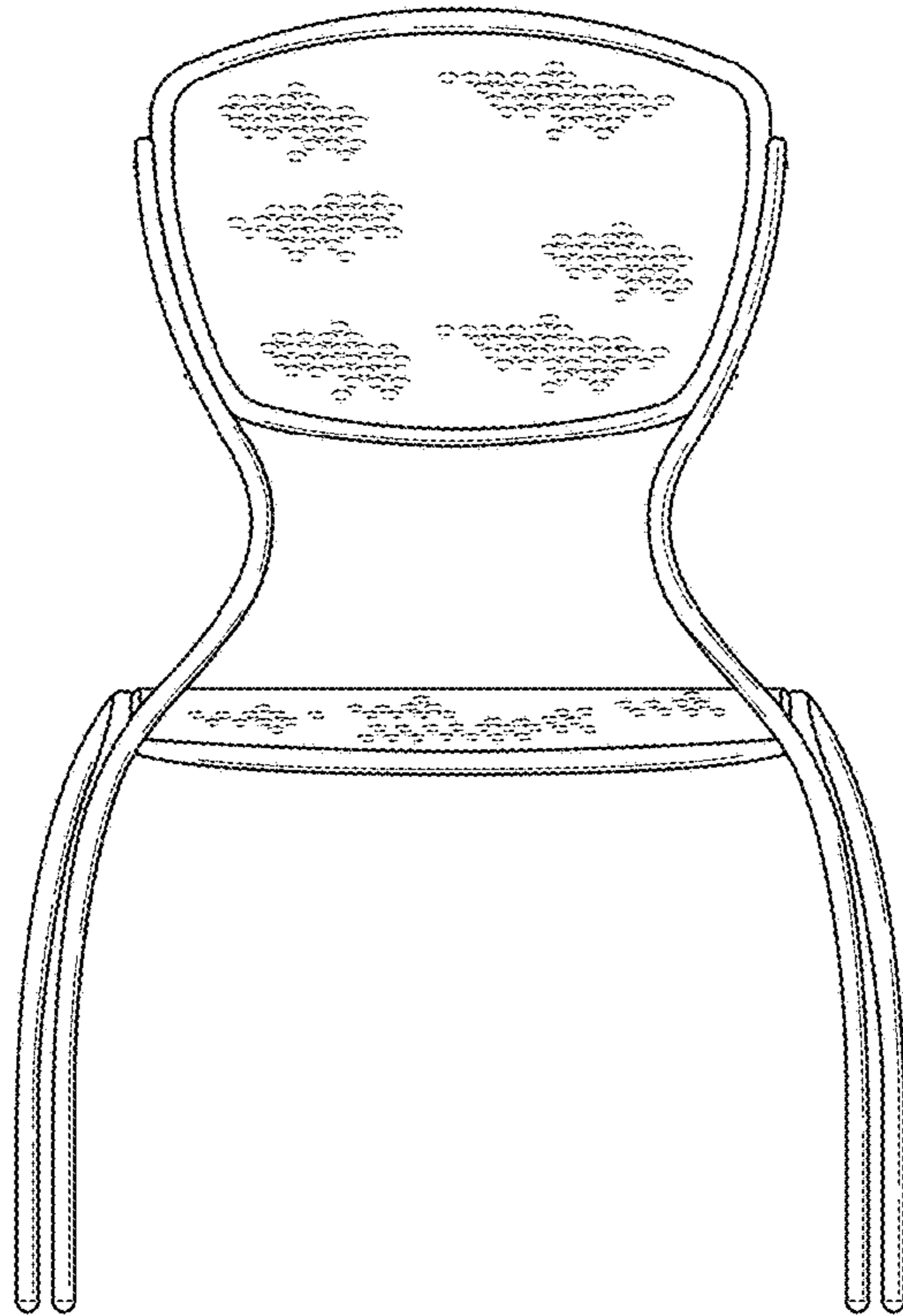

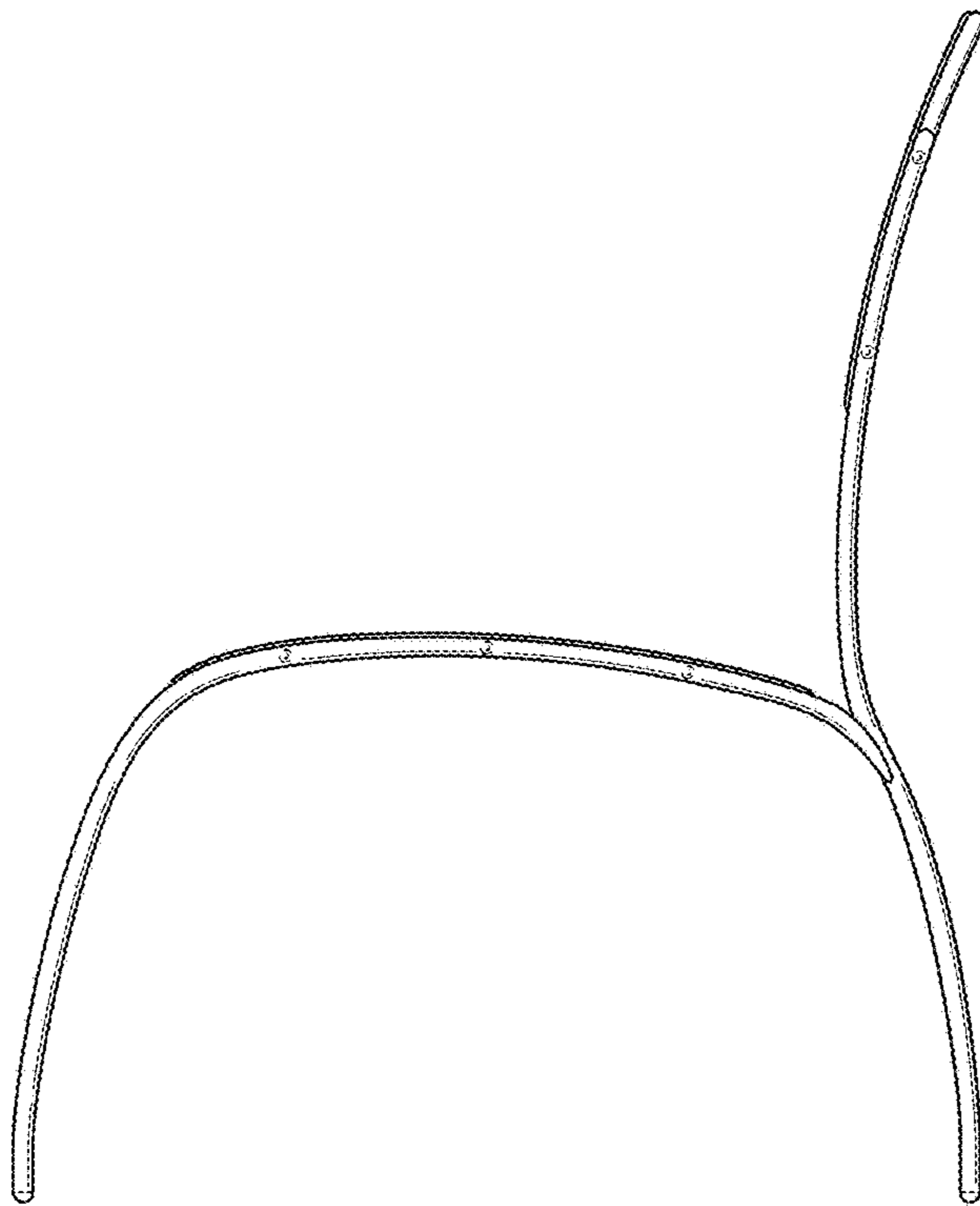

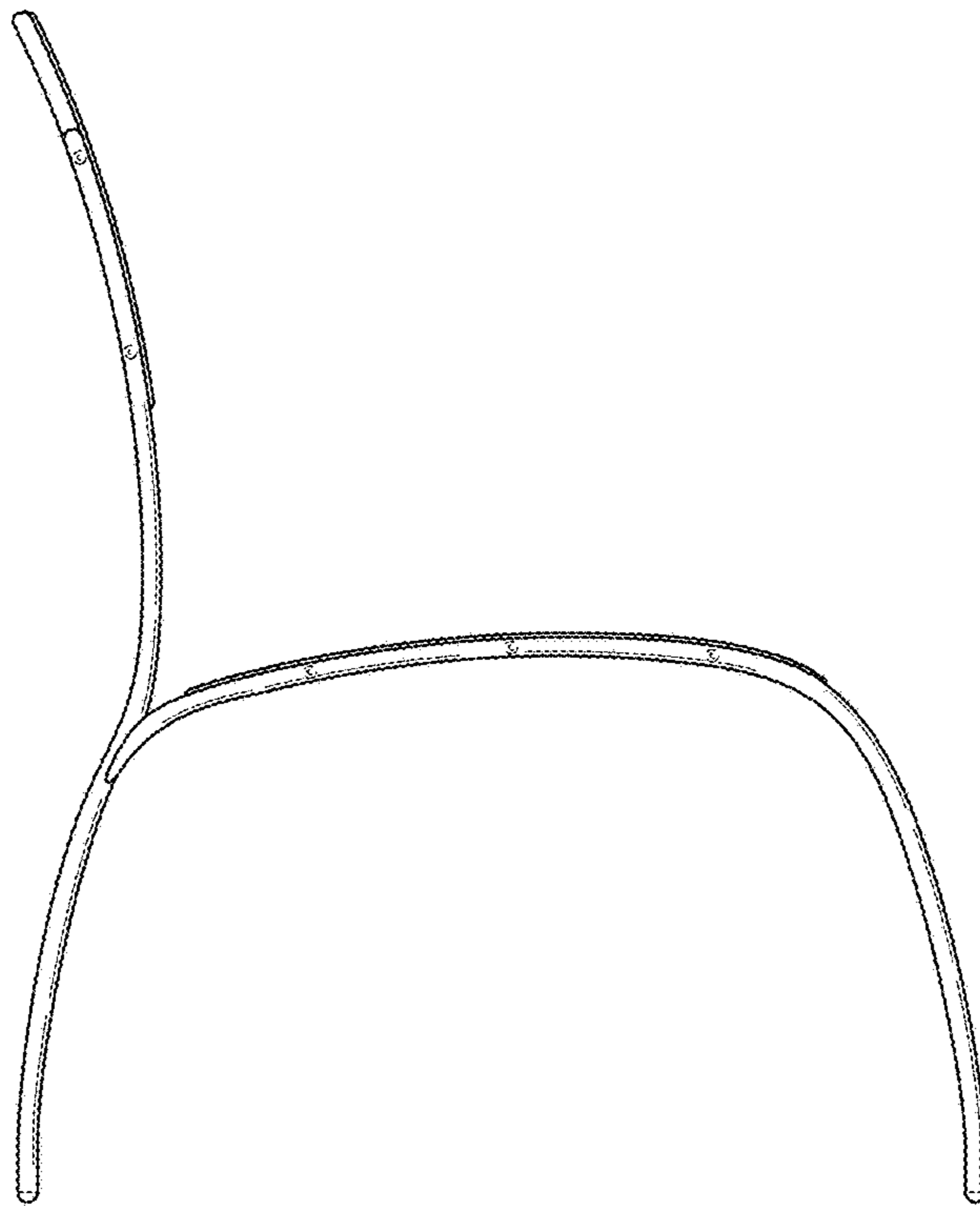

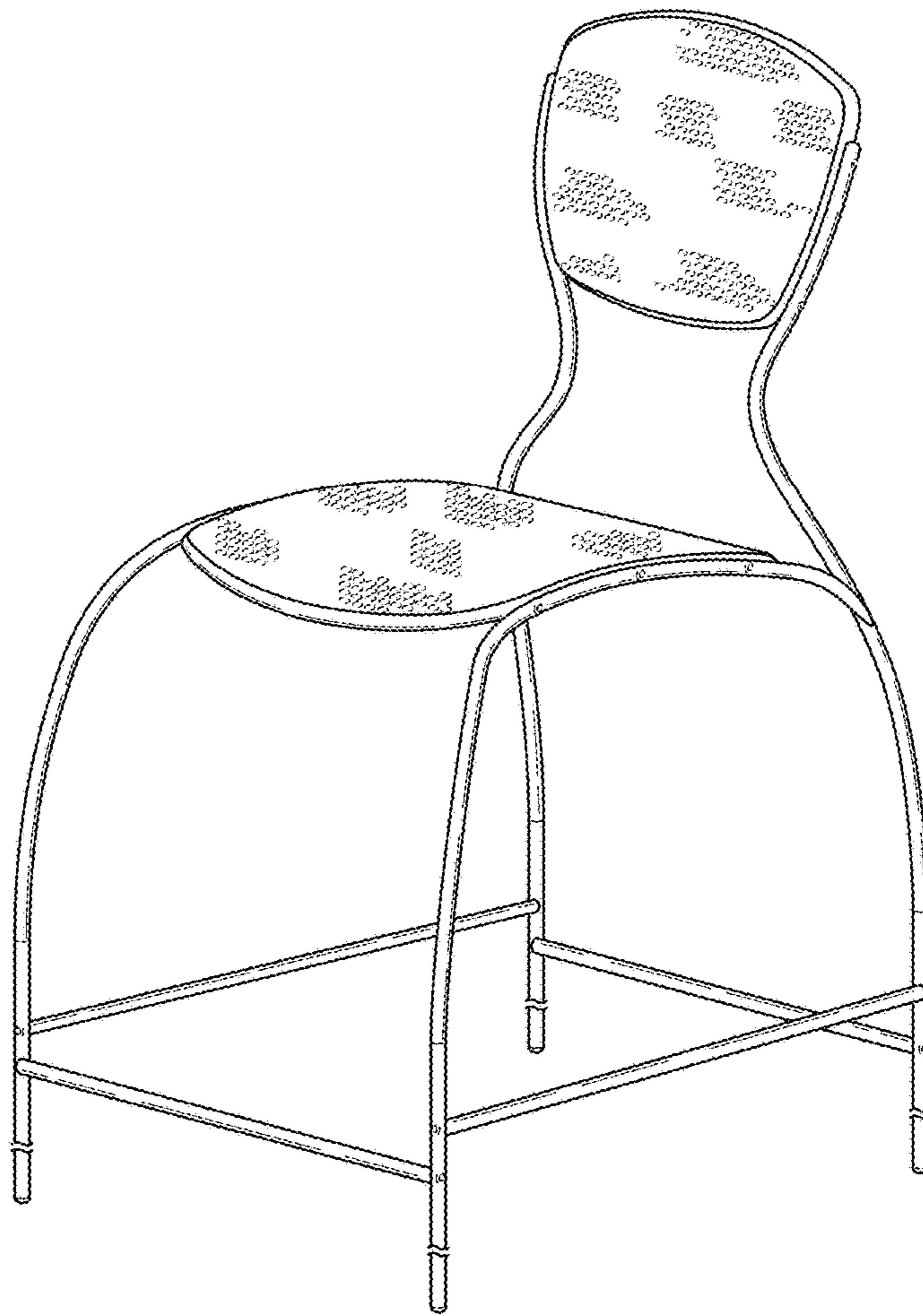

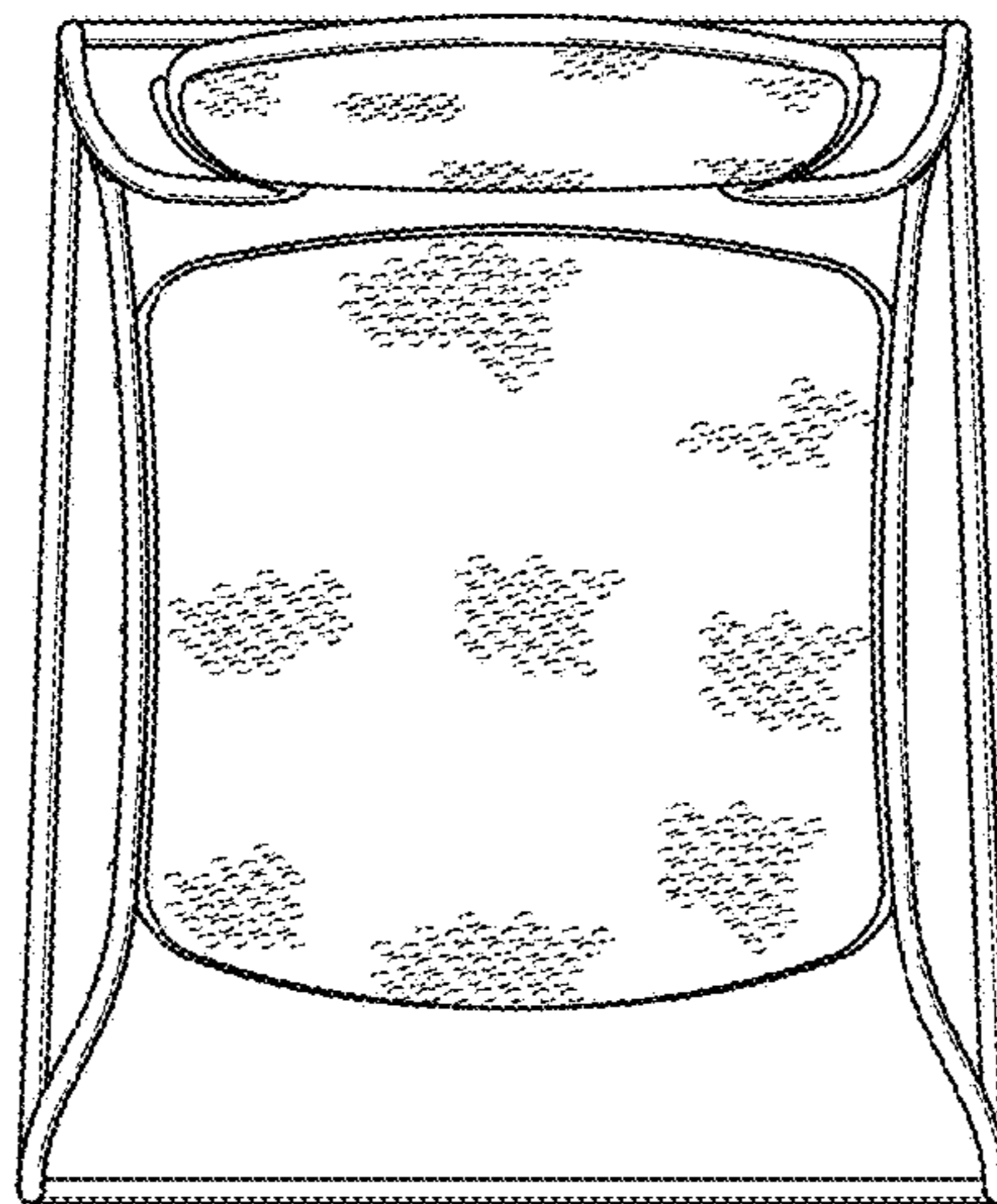

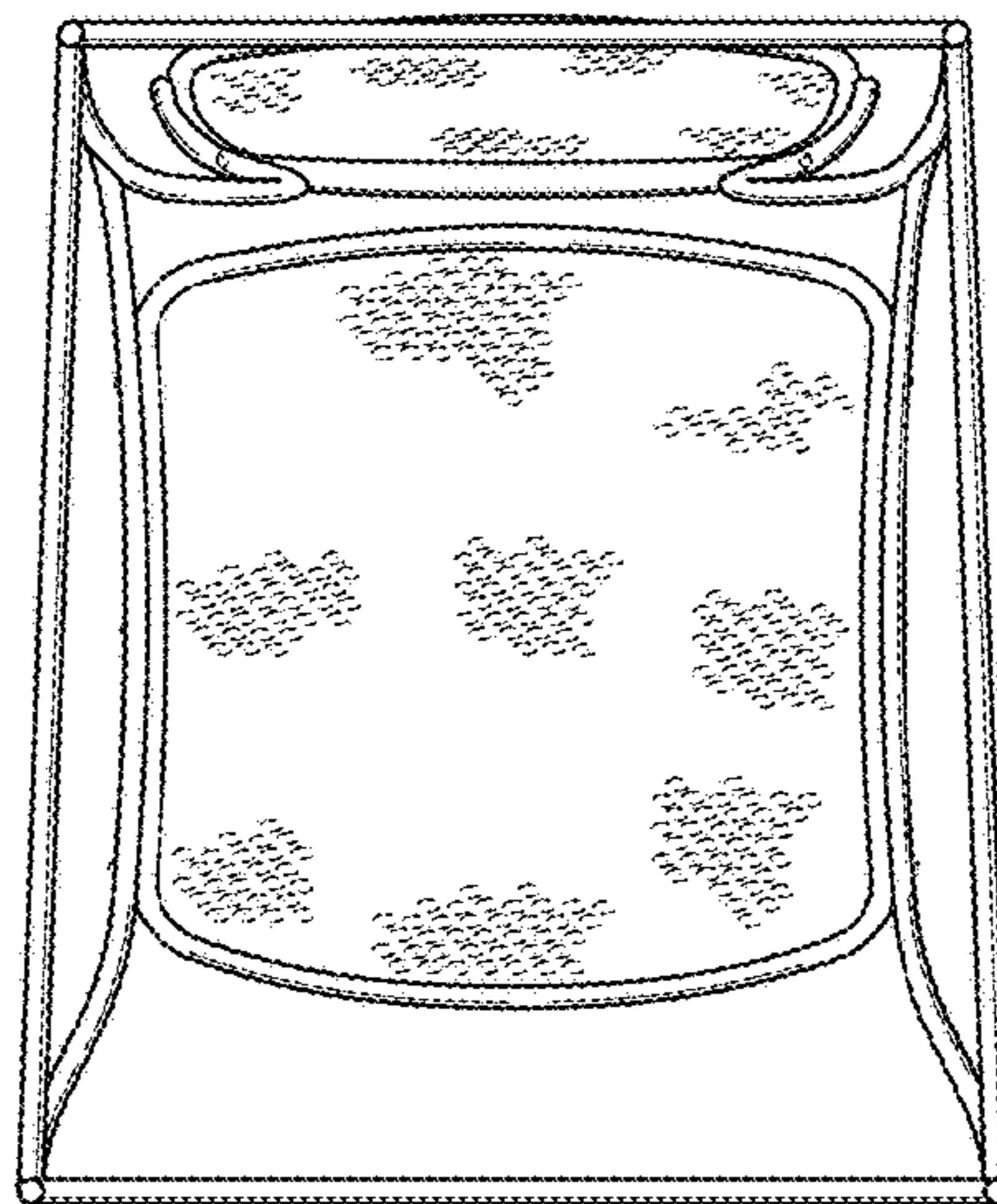

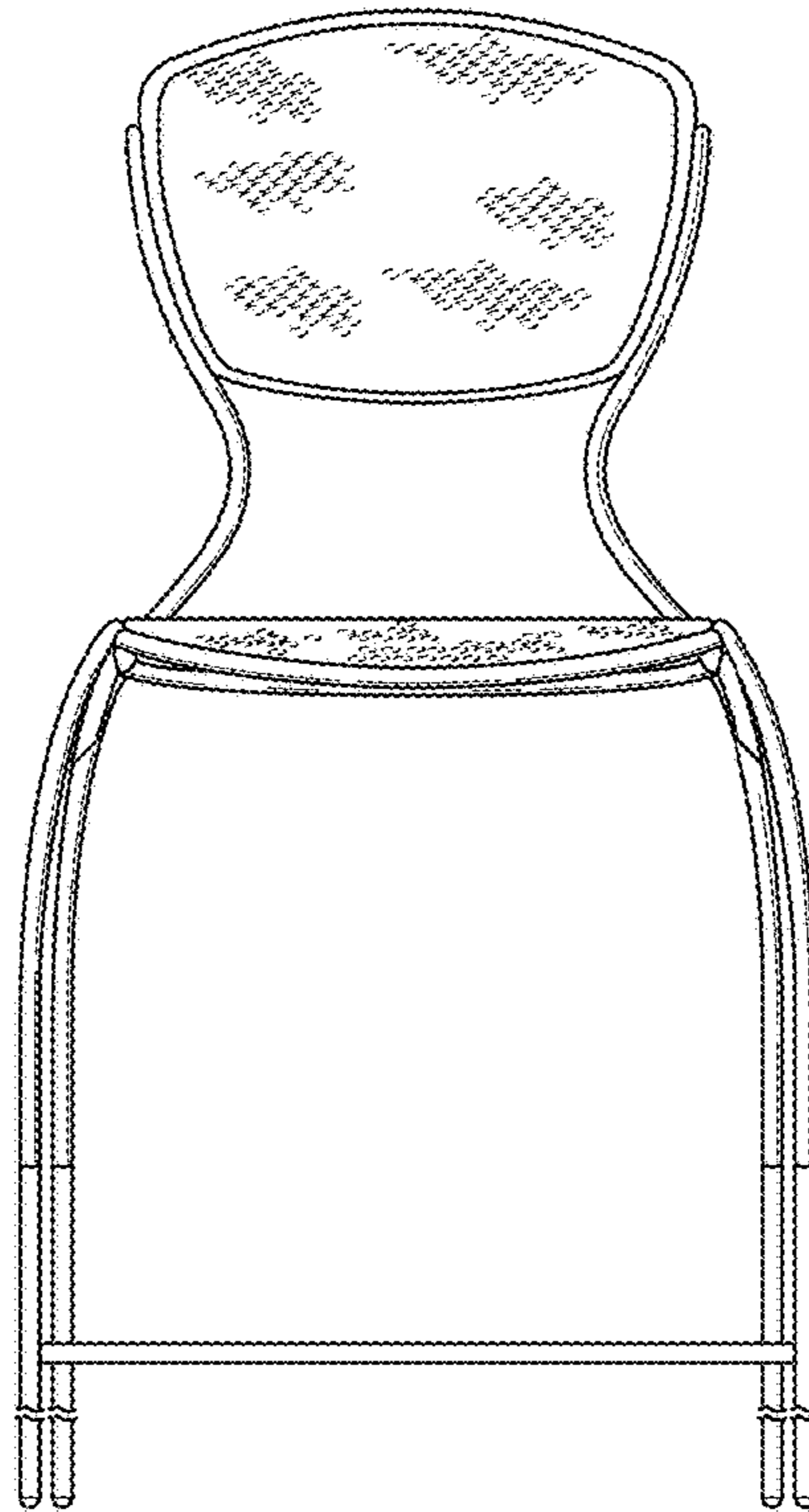
