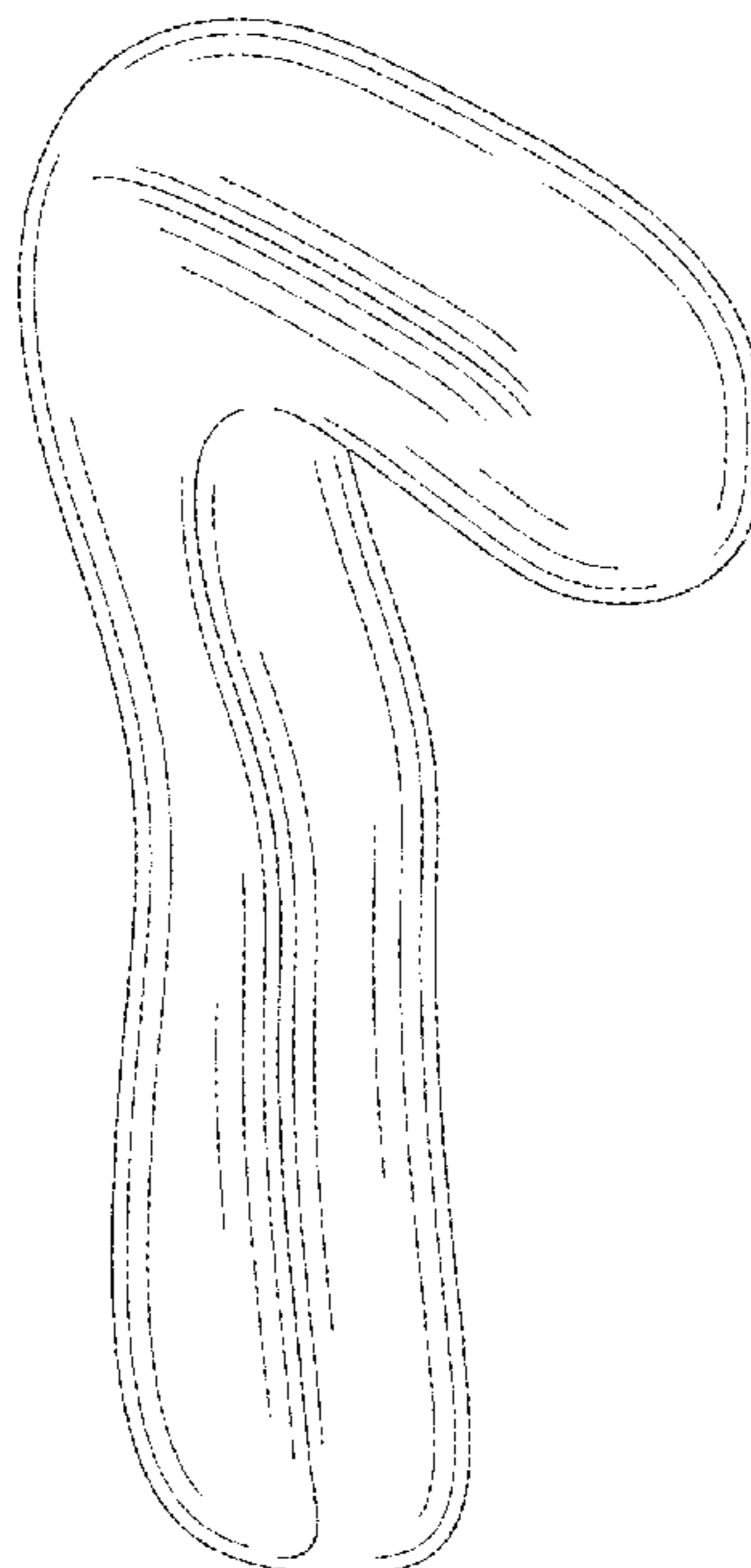

DESCRIPTION
FIG. 1 is a top front perspective view of a pillow, showing my new design;
FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof;

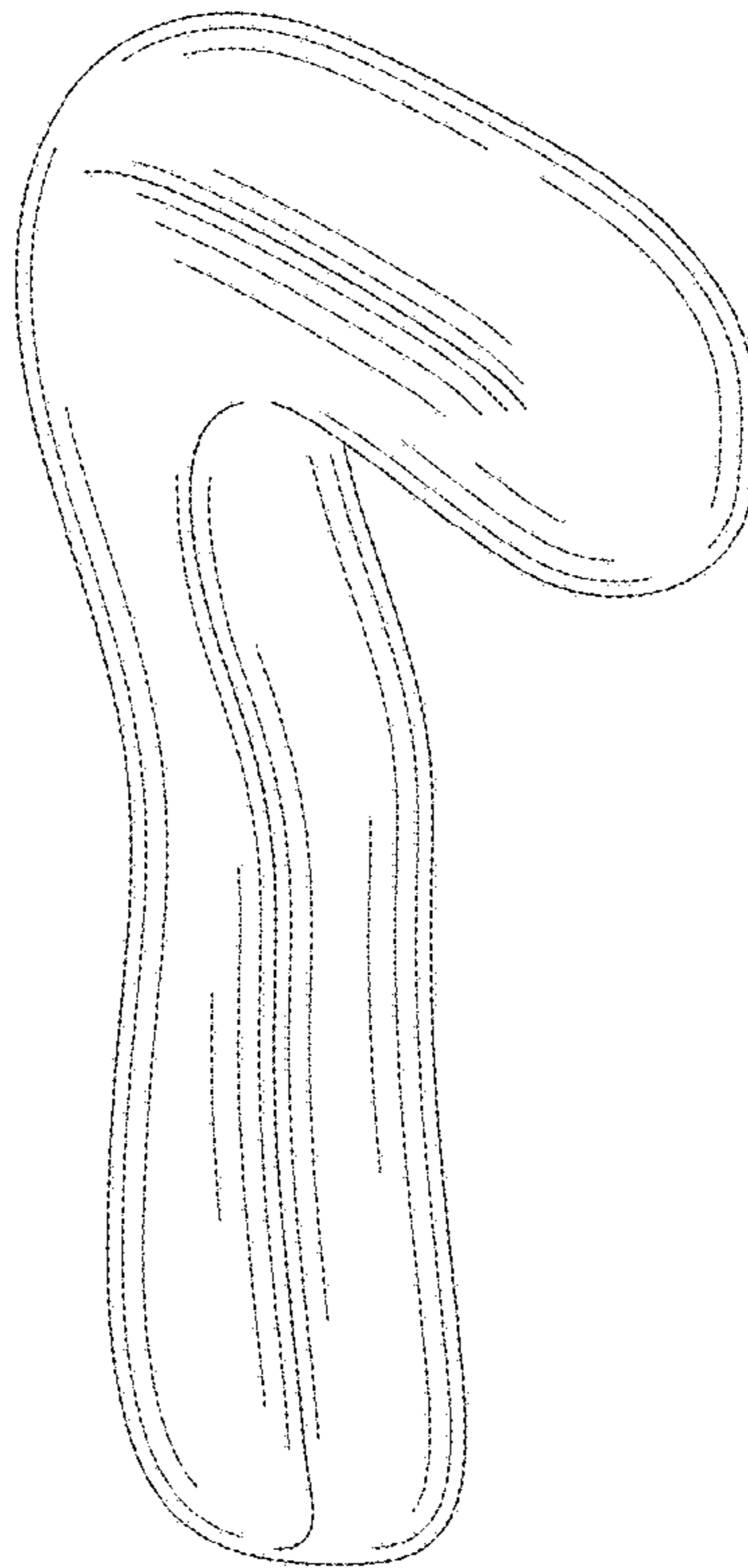

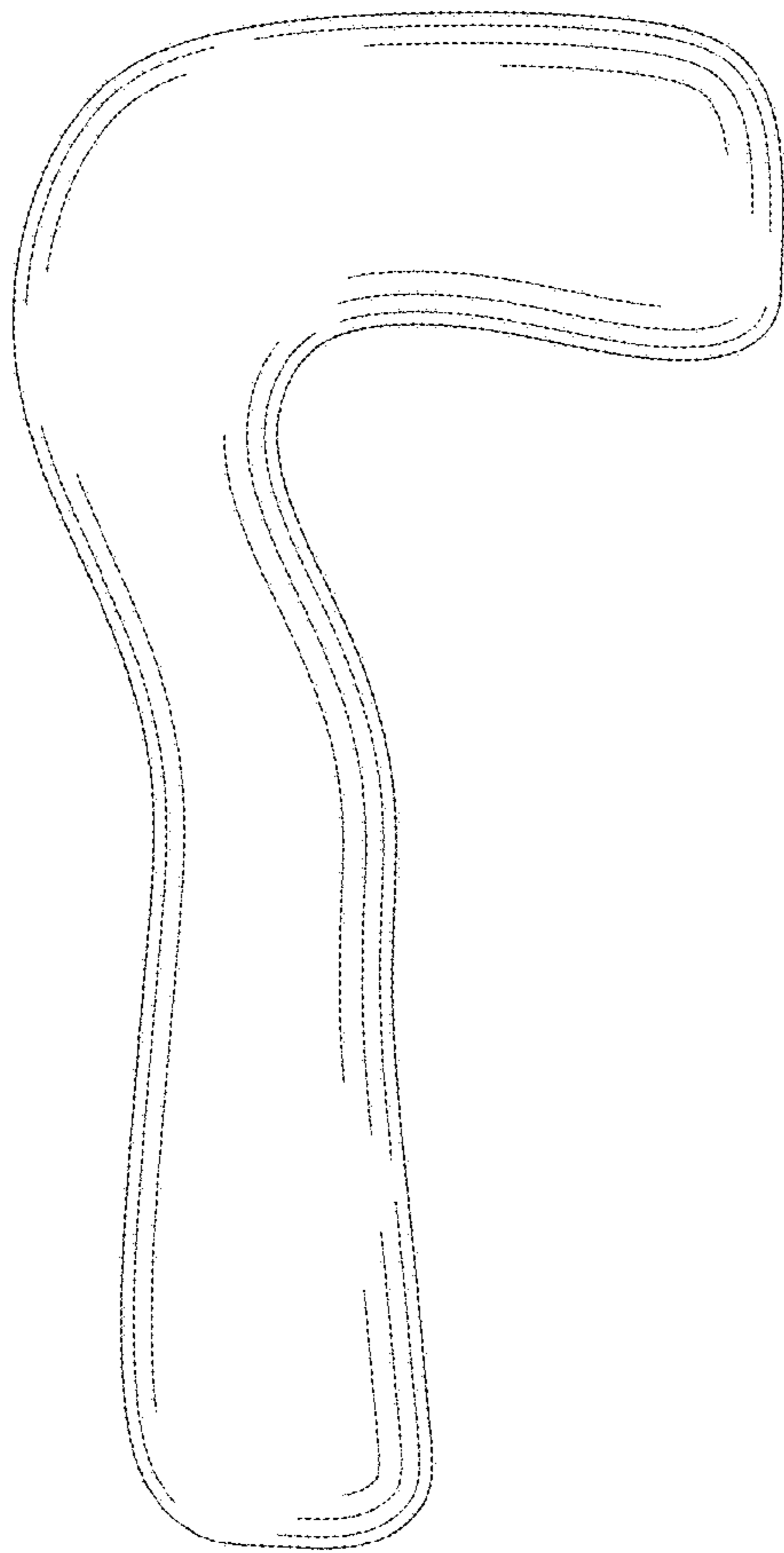

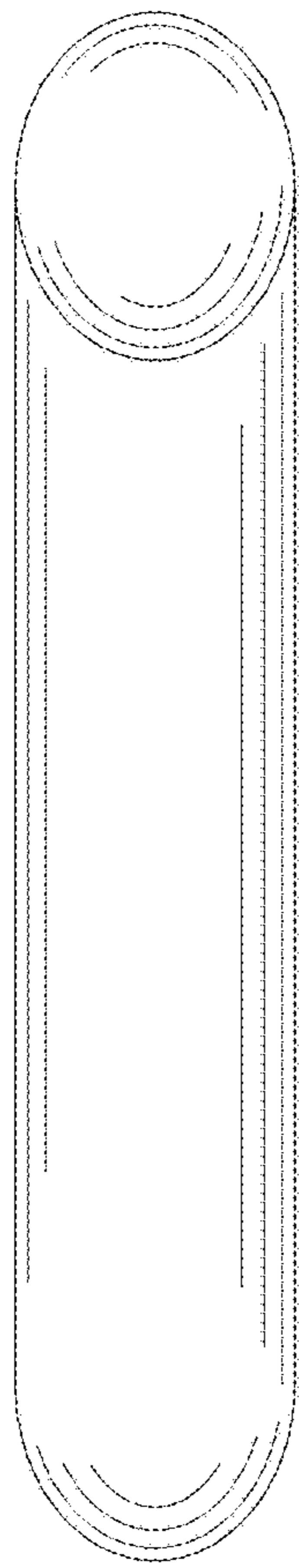

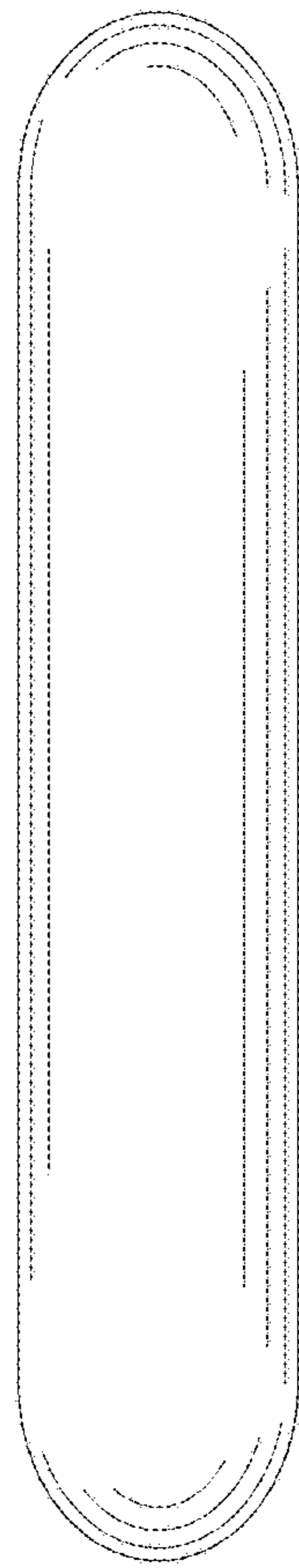

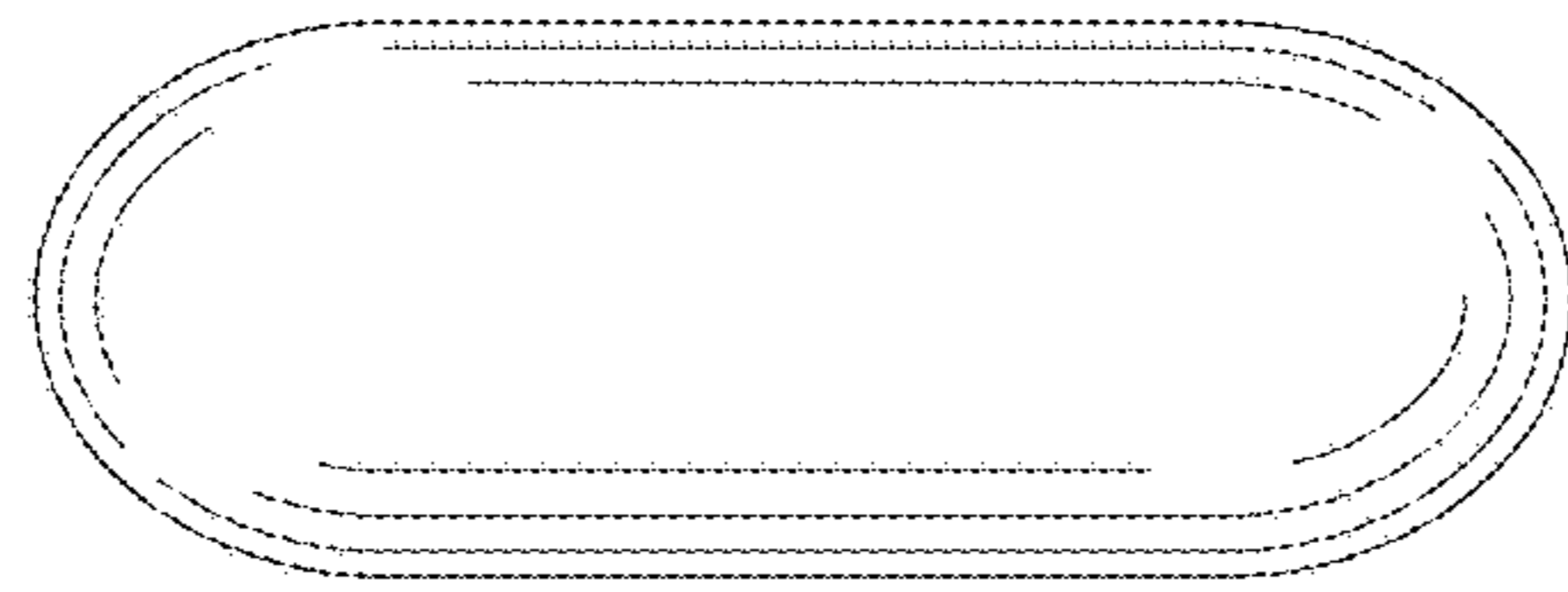

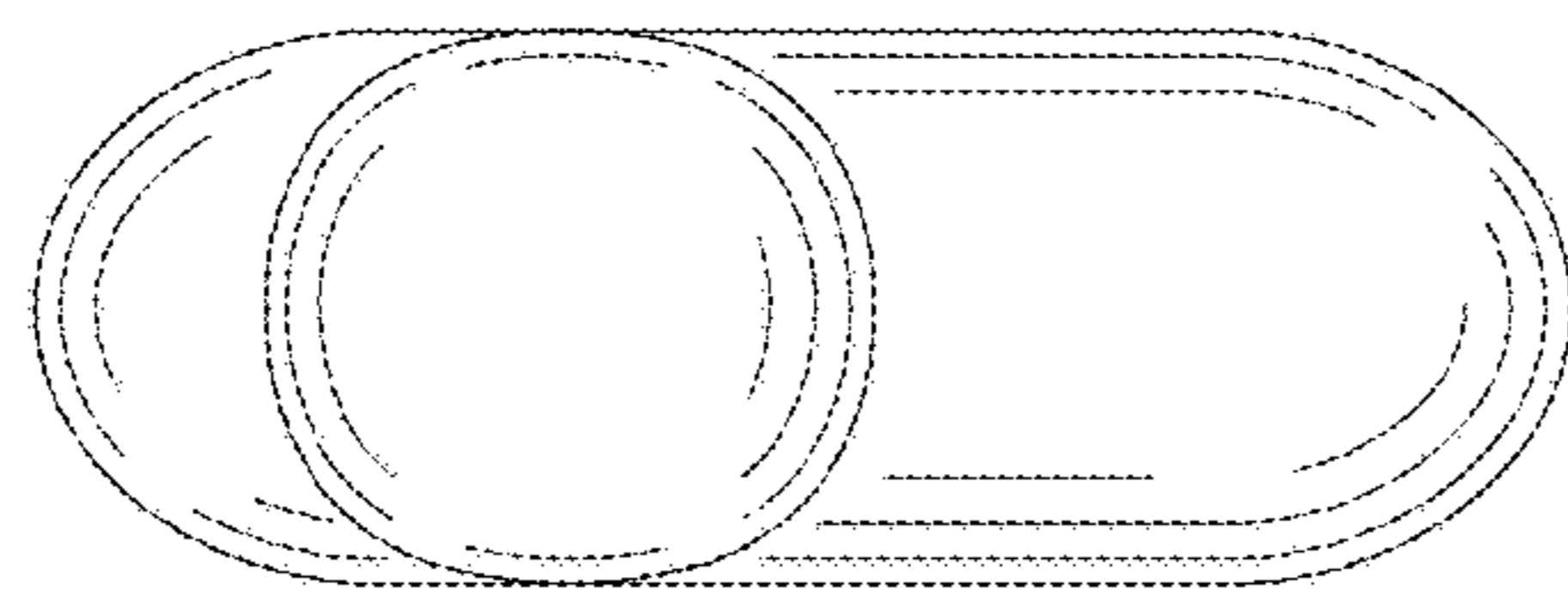
