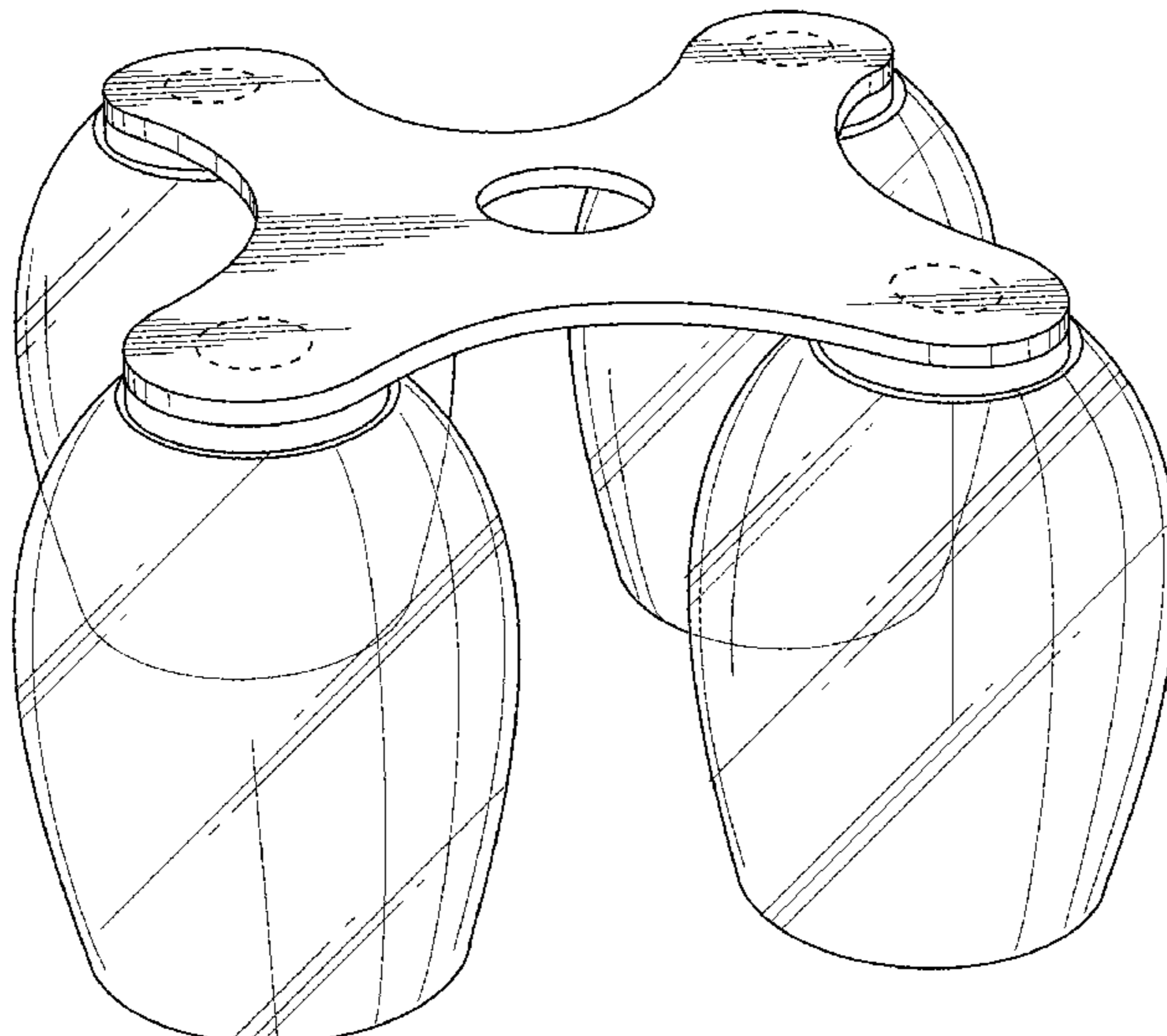
(57) **CLAIM**

The ornamental design for a holder for drinking vessels, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the holder for drinking vessels of Embodiment 1 showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a perspective view of the holder for drinking vessels of Embodiment 2 showing my new design; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a top plan view thereof, the bottom view being identical. The broken lines are for the purpose of illustrating portions of the holder for drinking vessels and form no part of the claimed design.

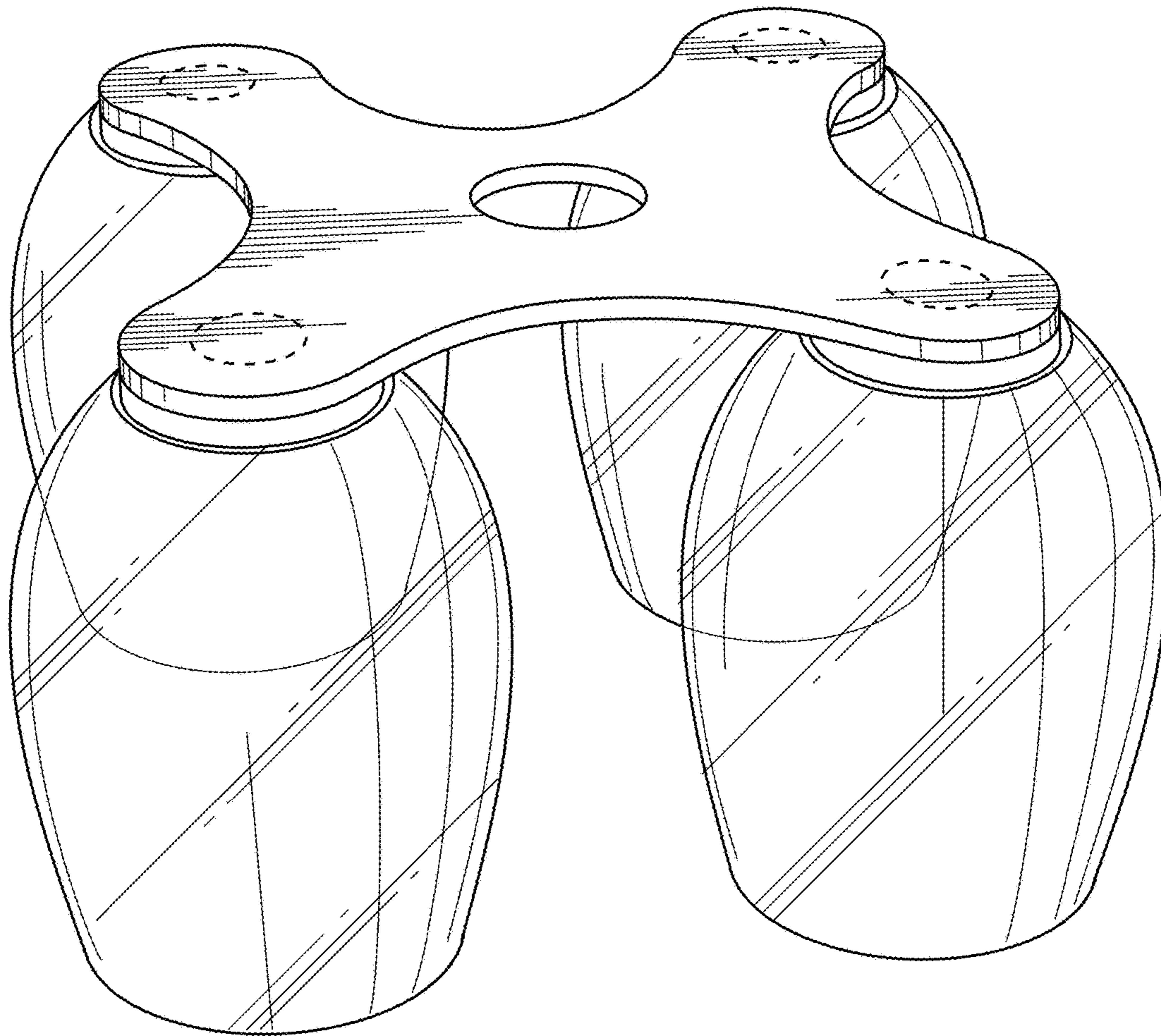

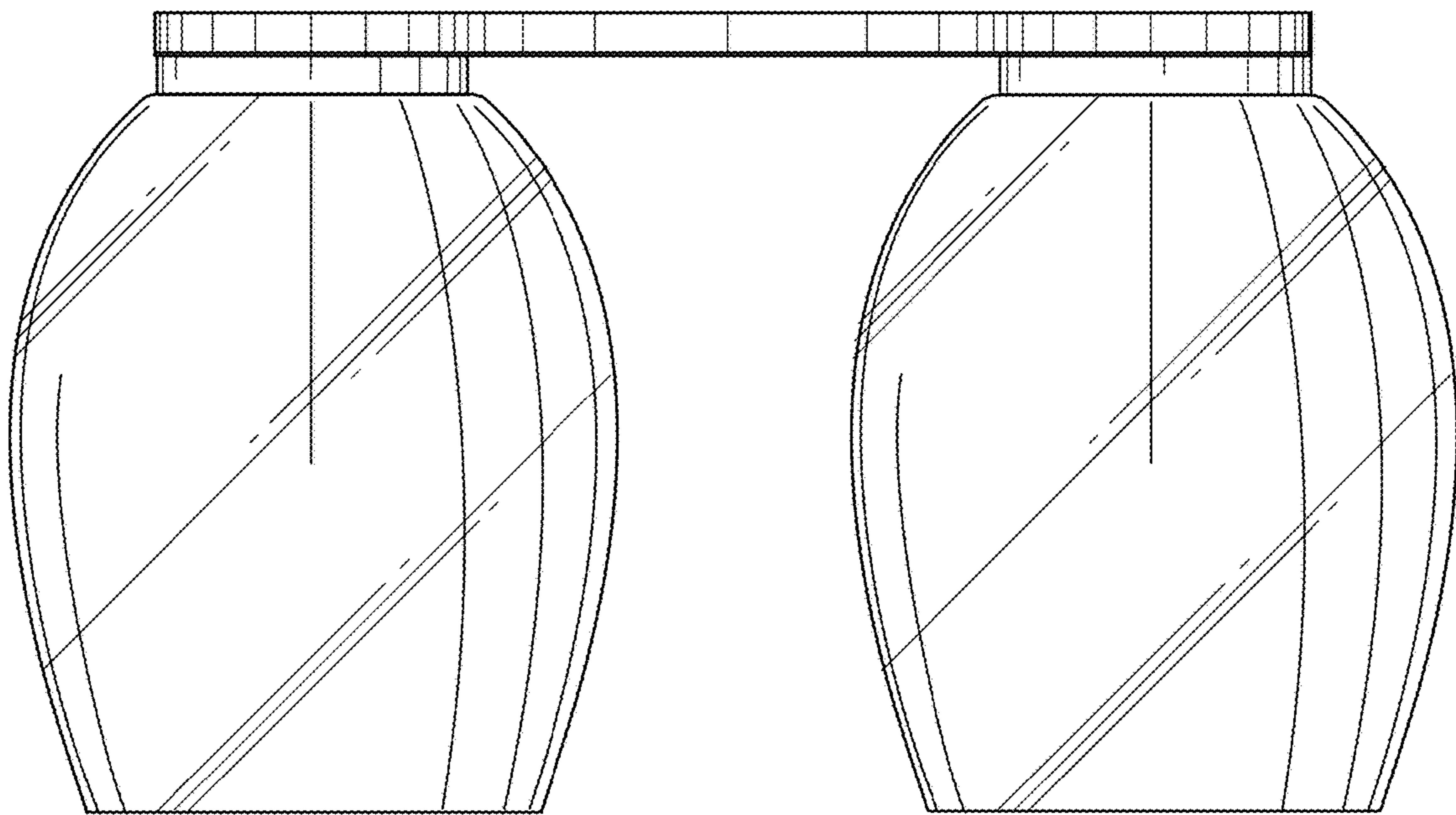

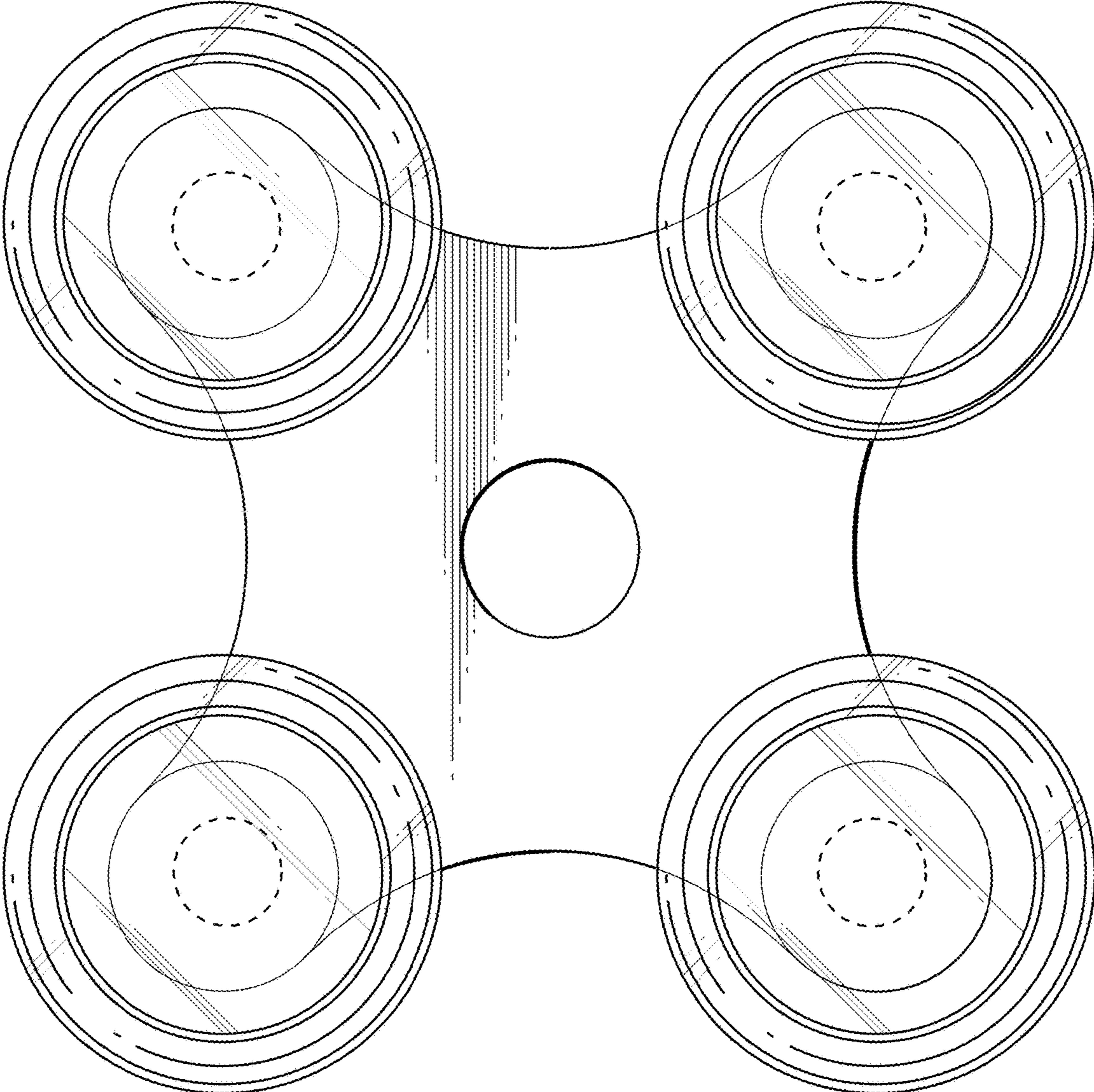

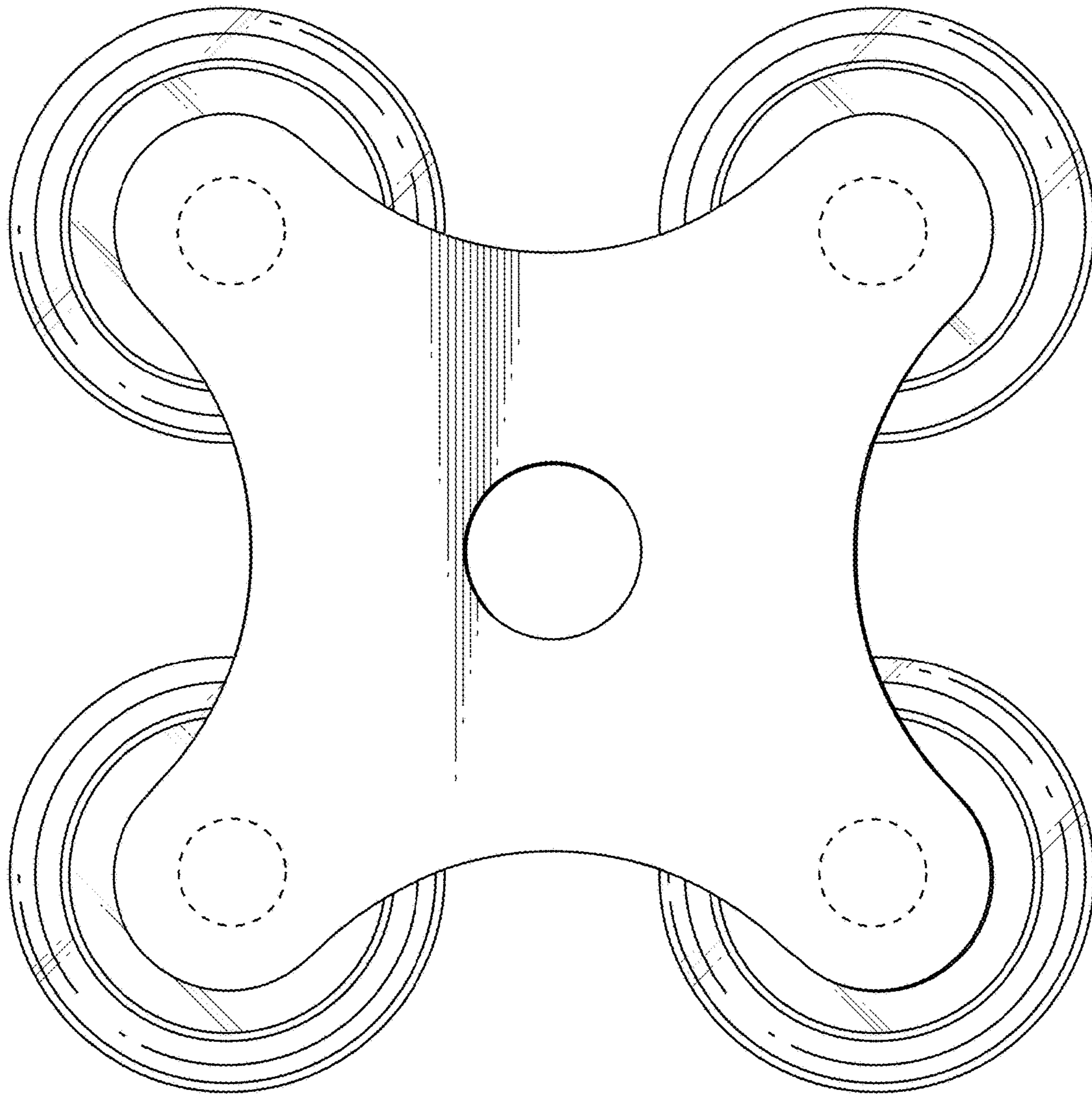

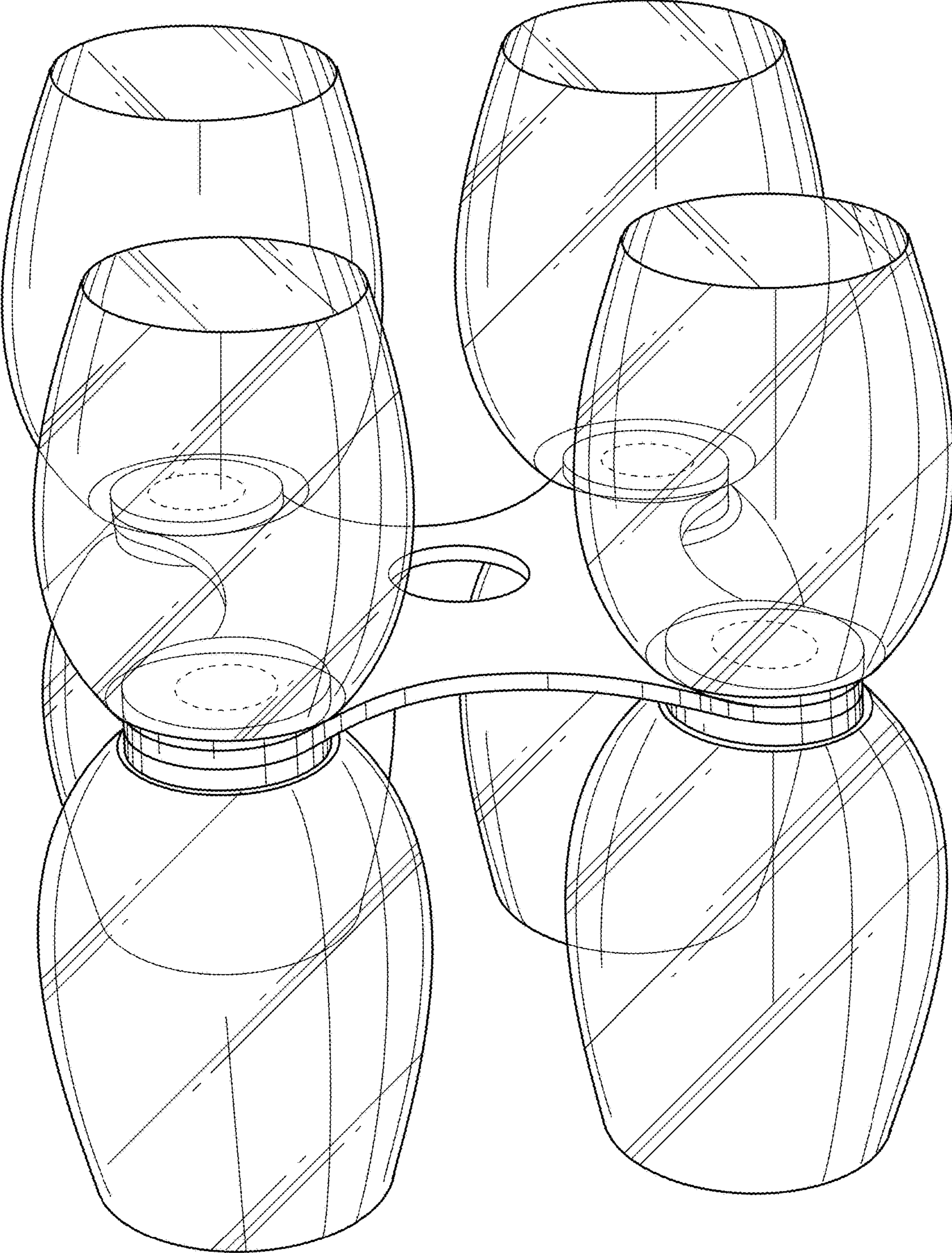

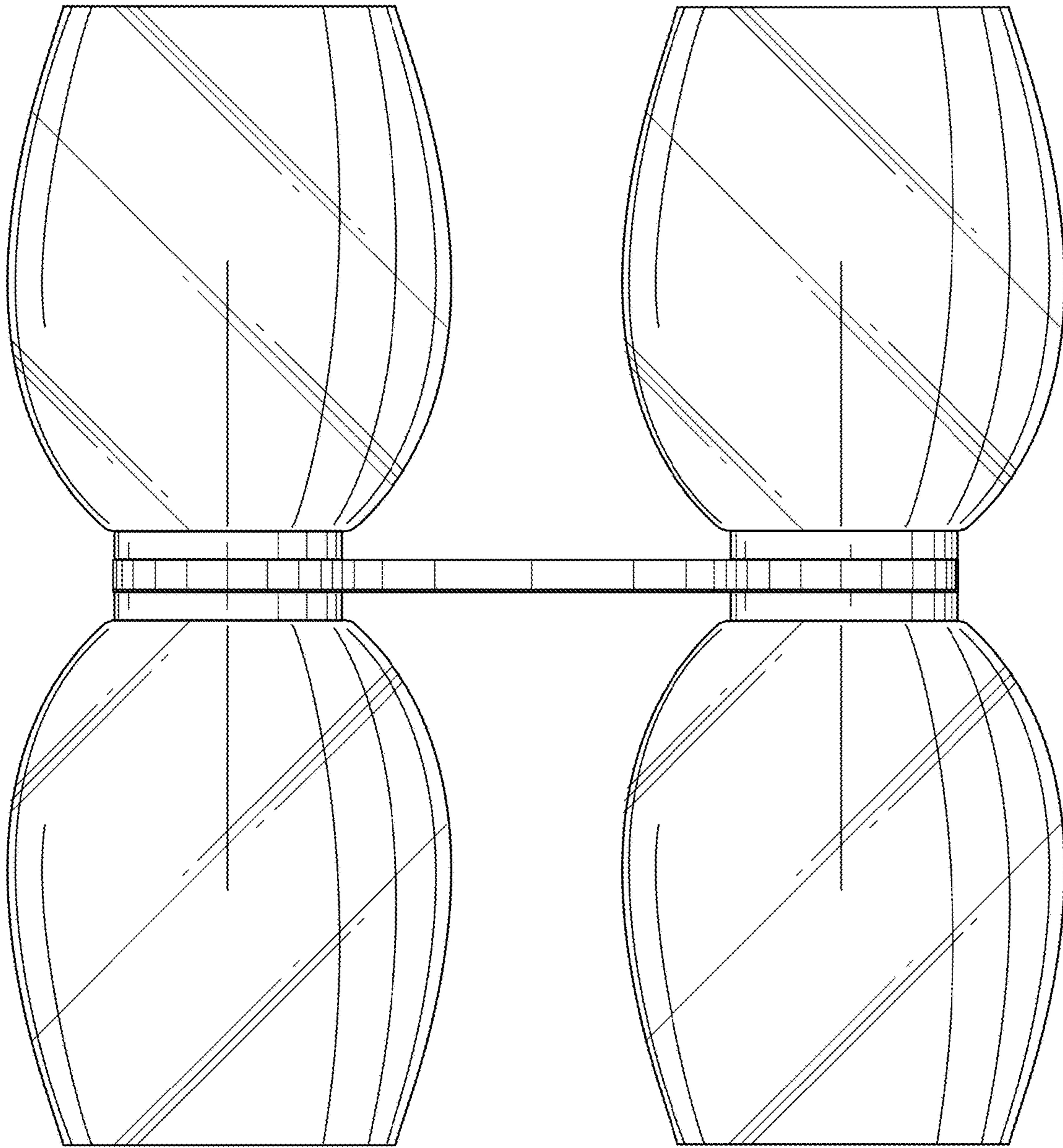

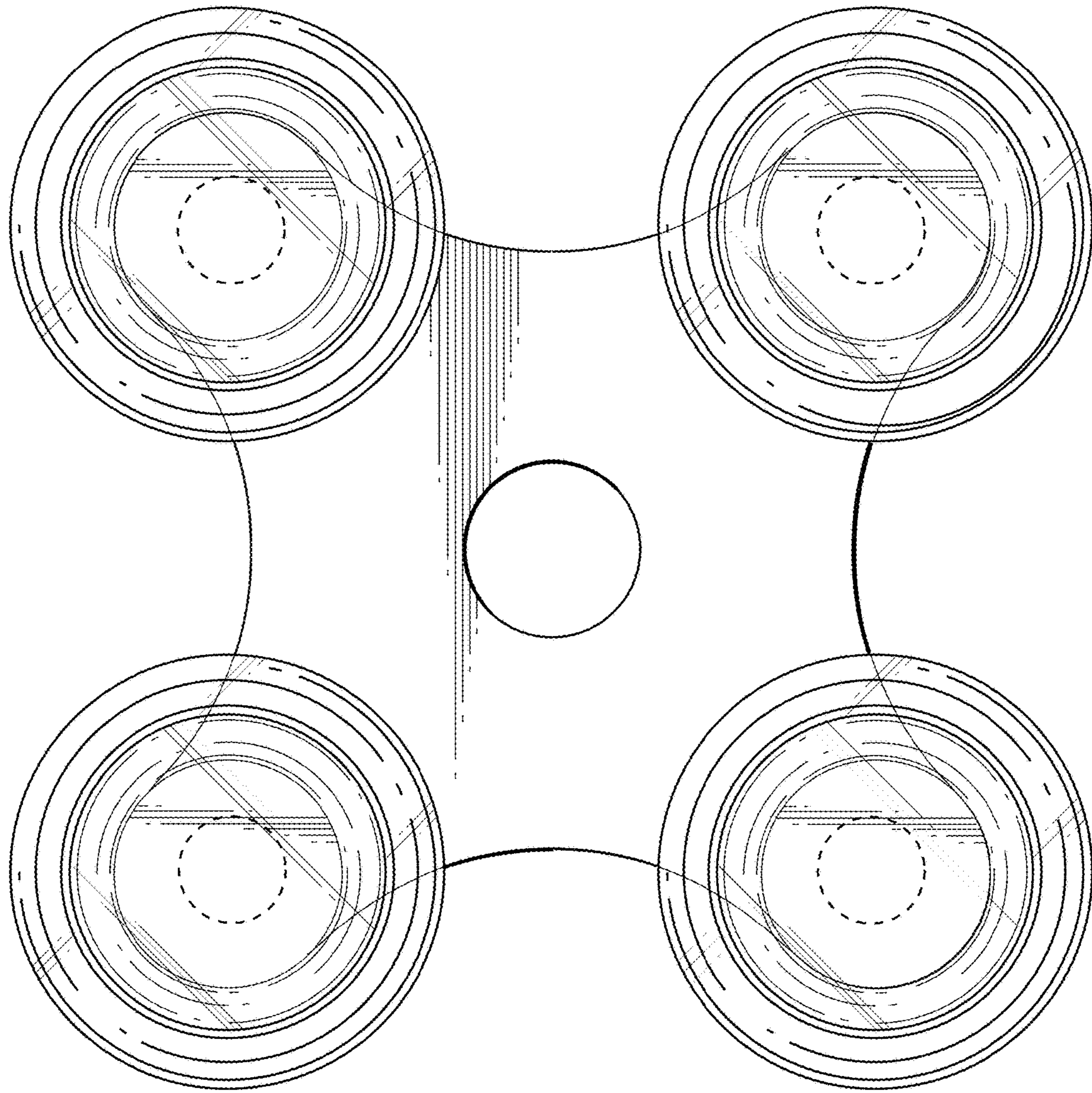
