 FIG. 14 is an isometric view thereof.

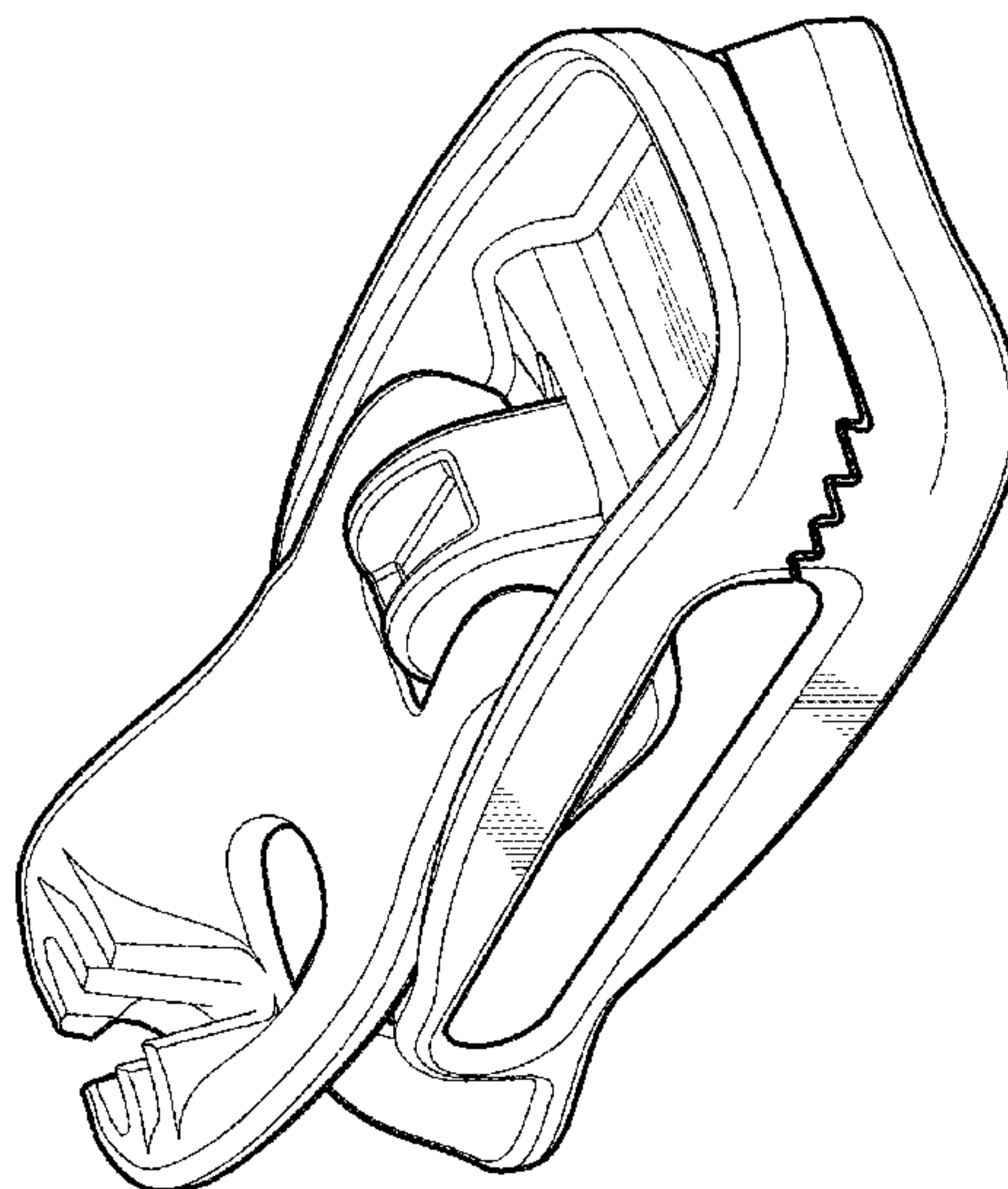

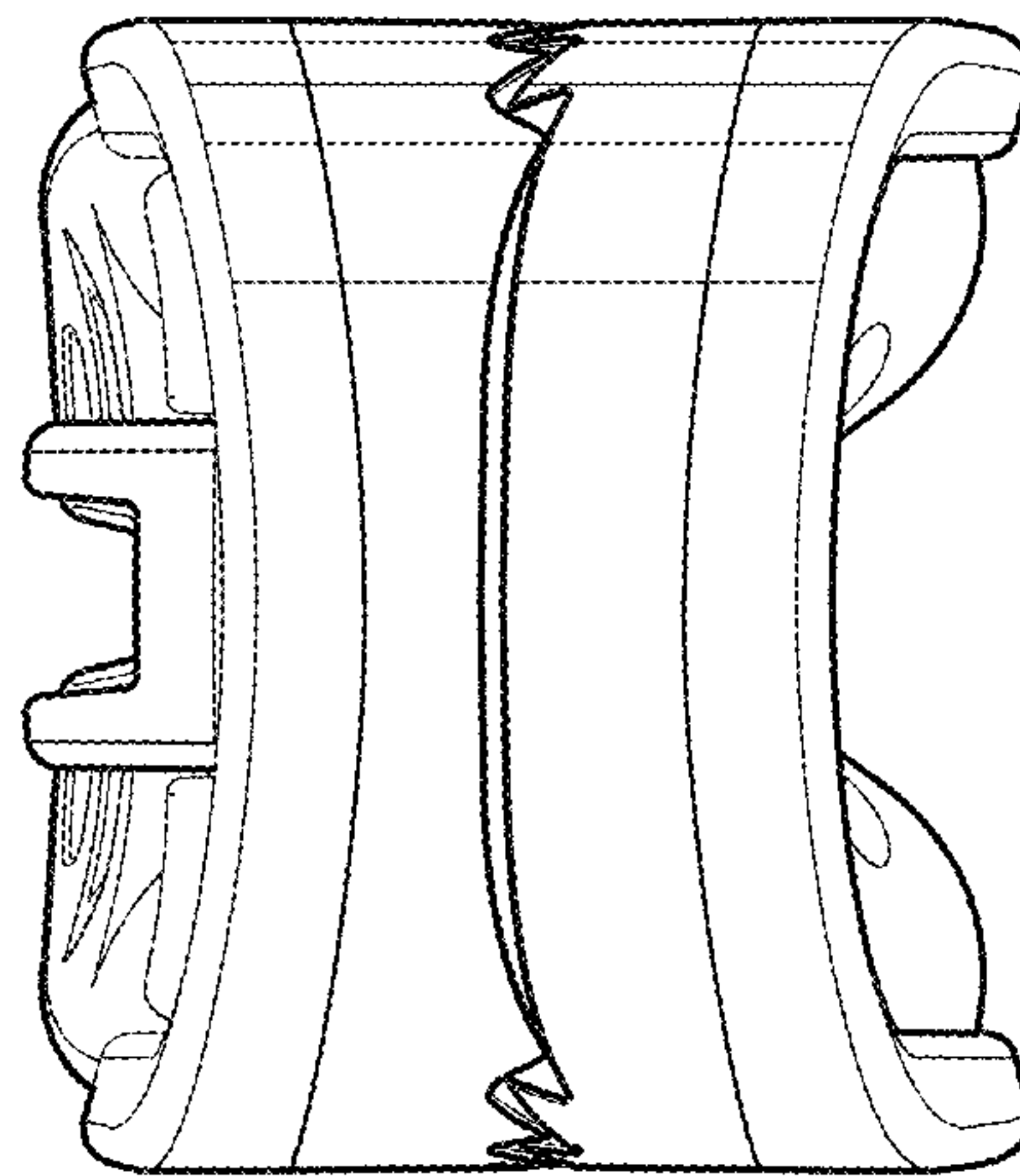

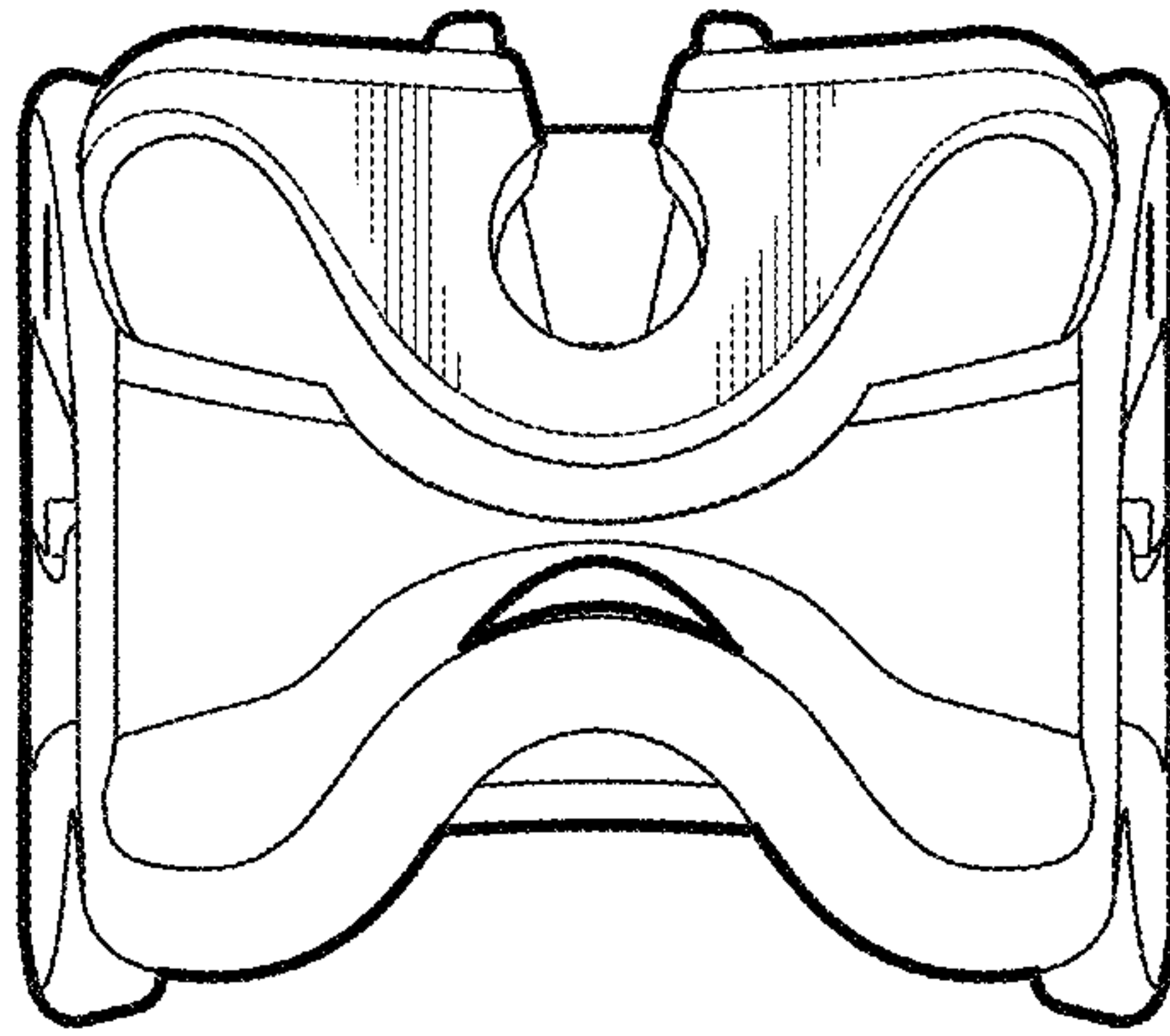

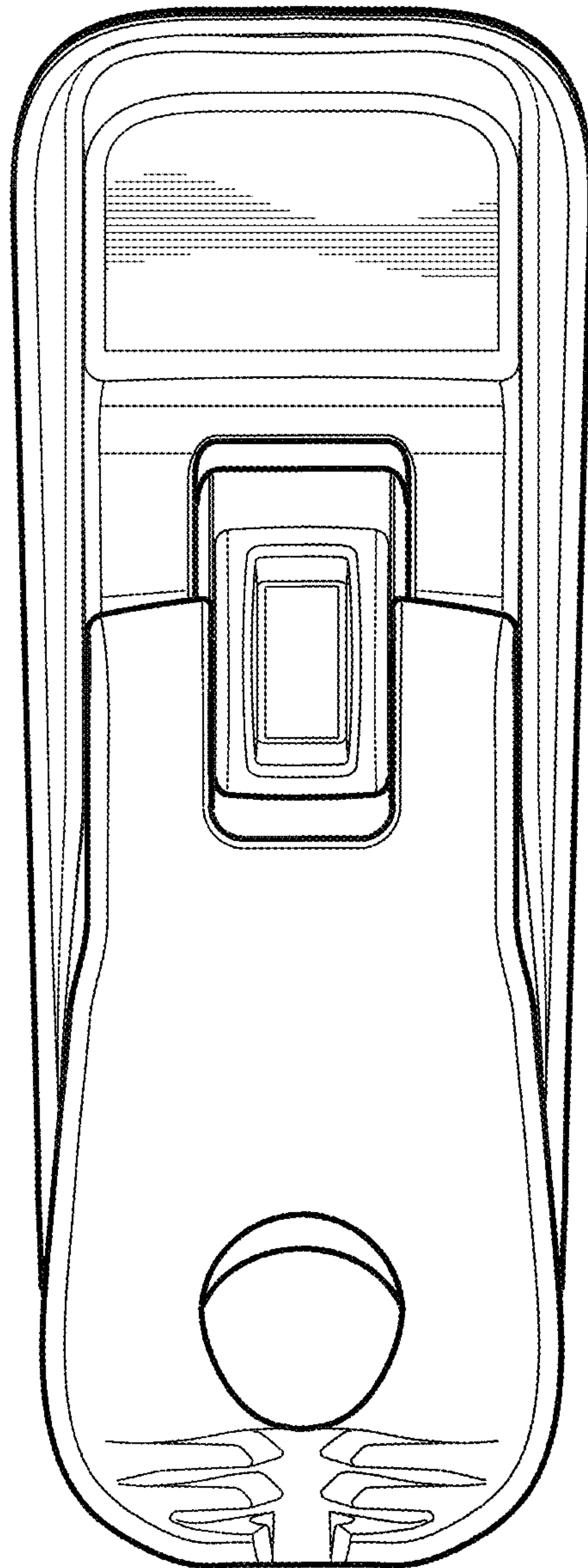

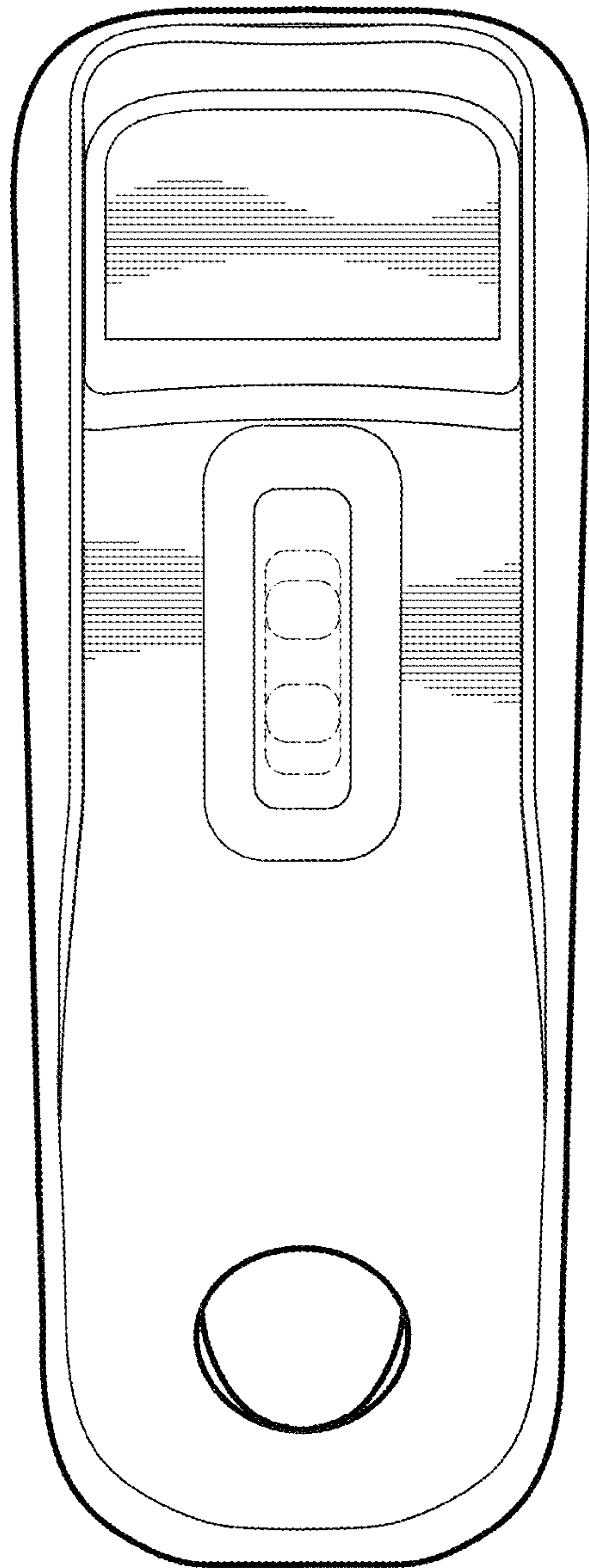

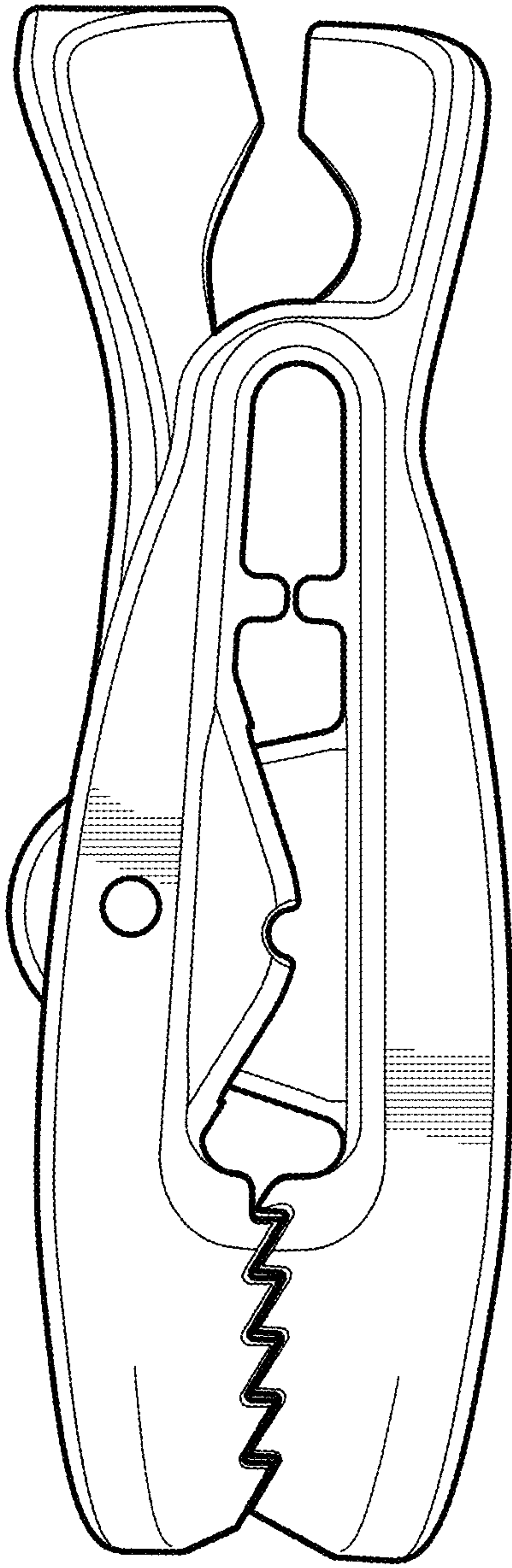

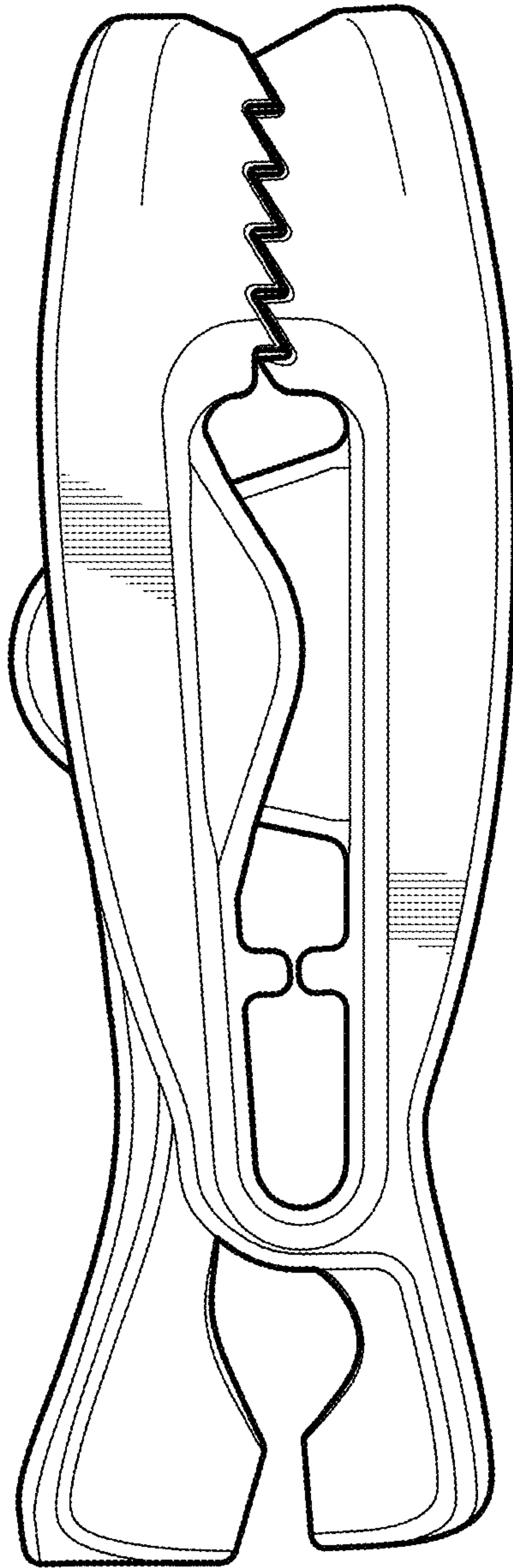

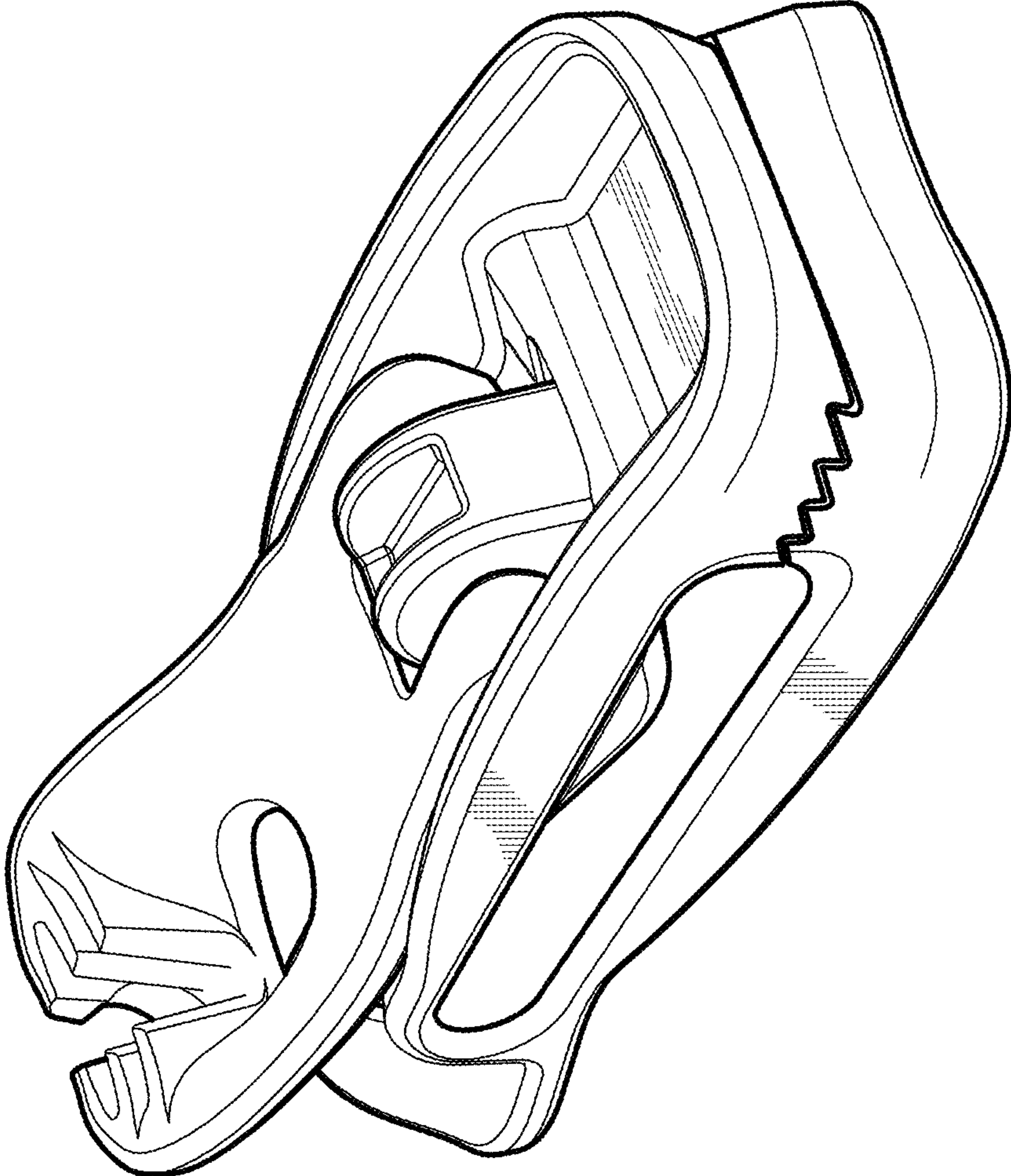

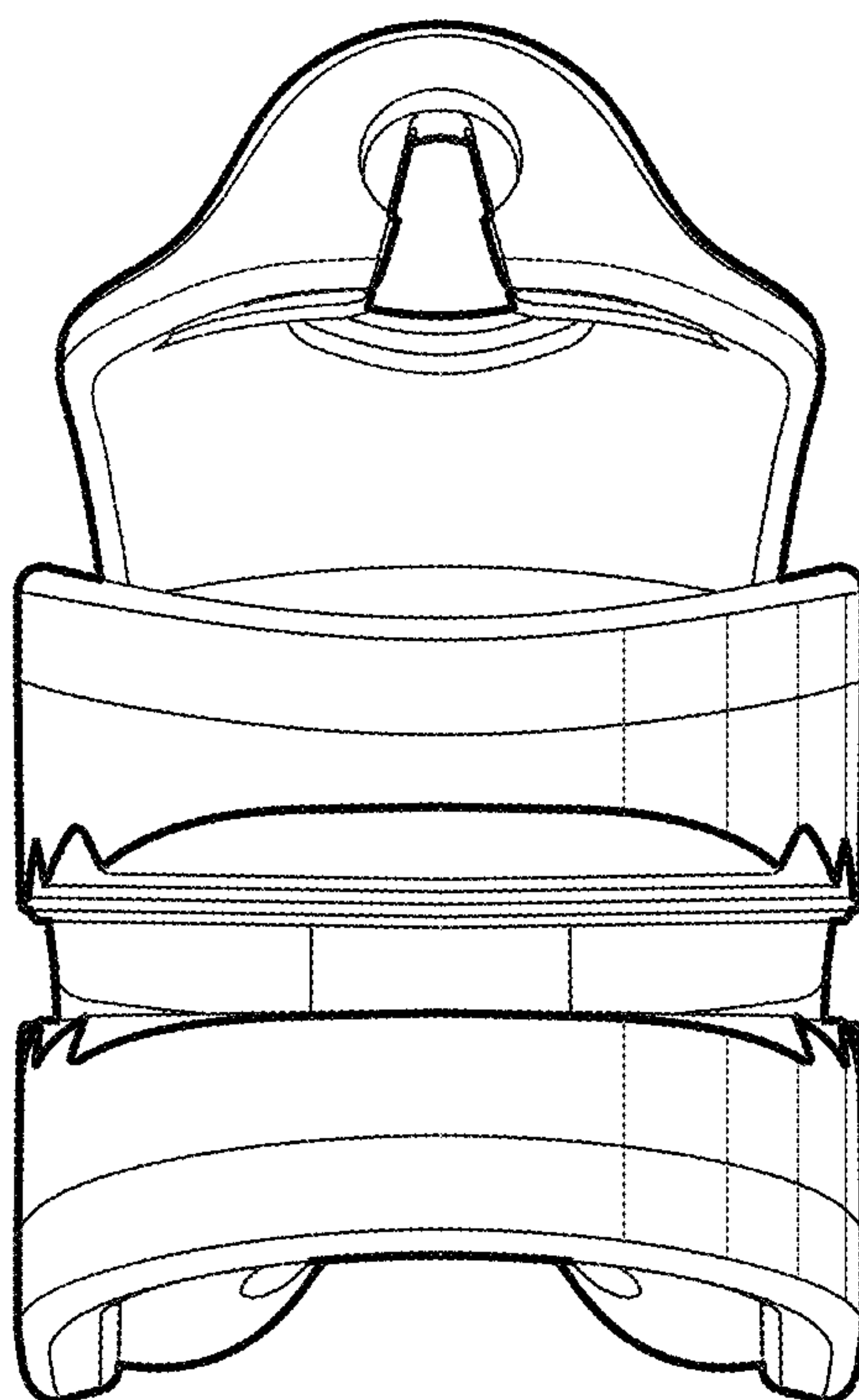

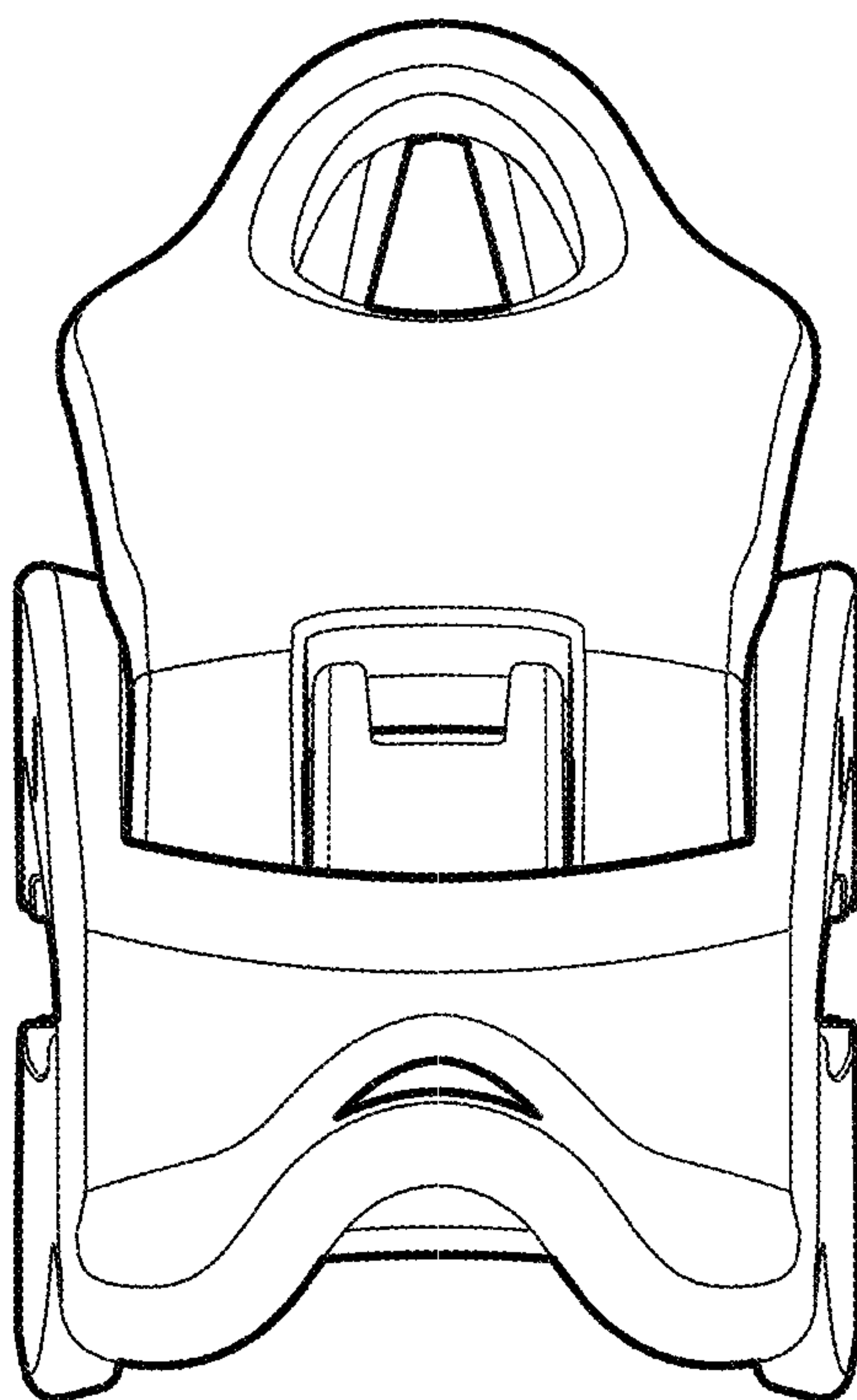

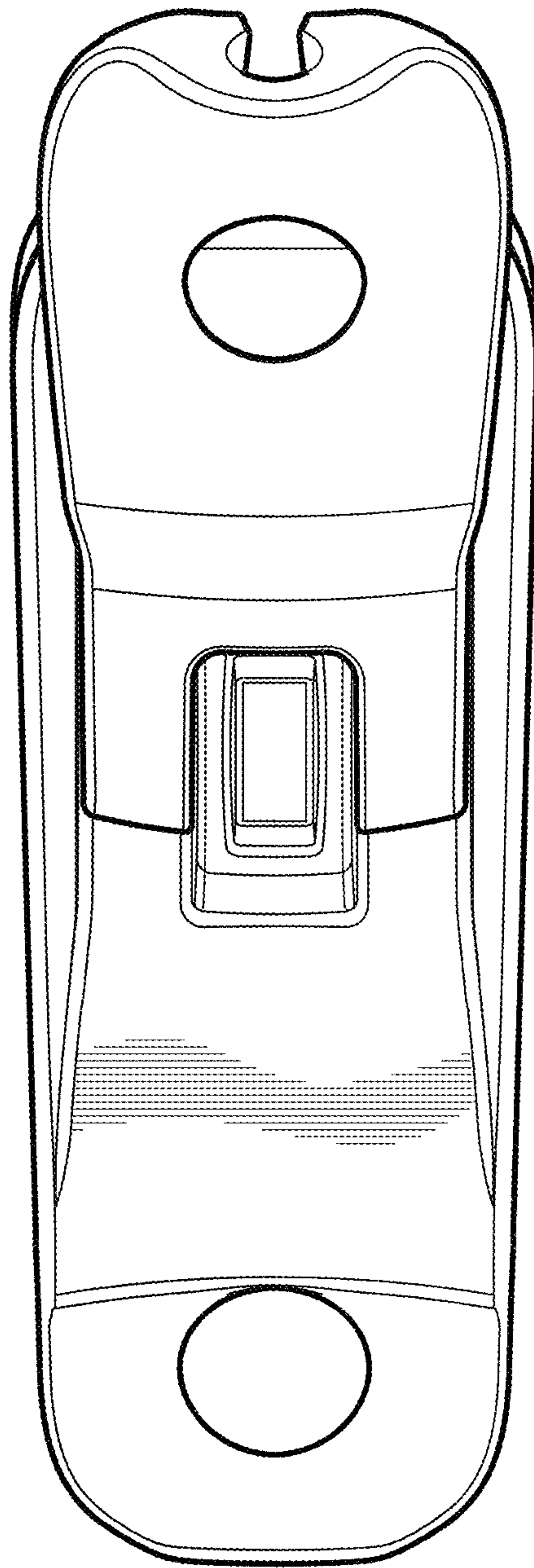

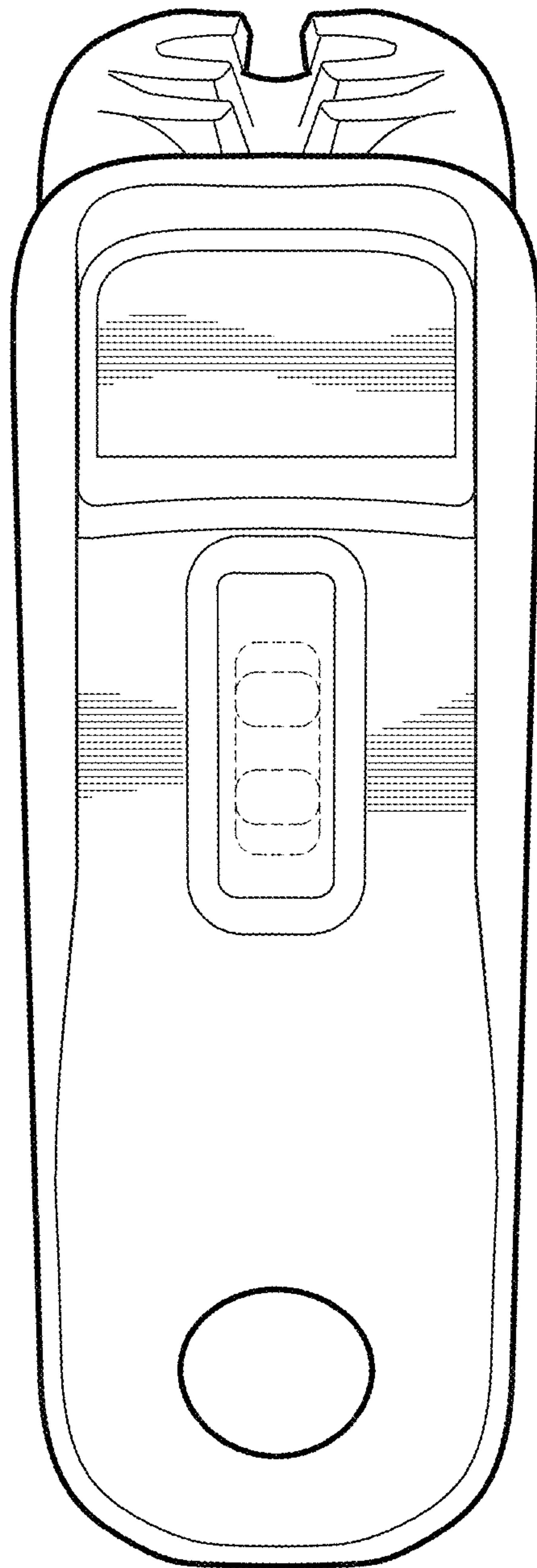

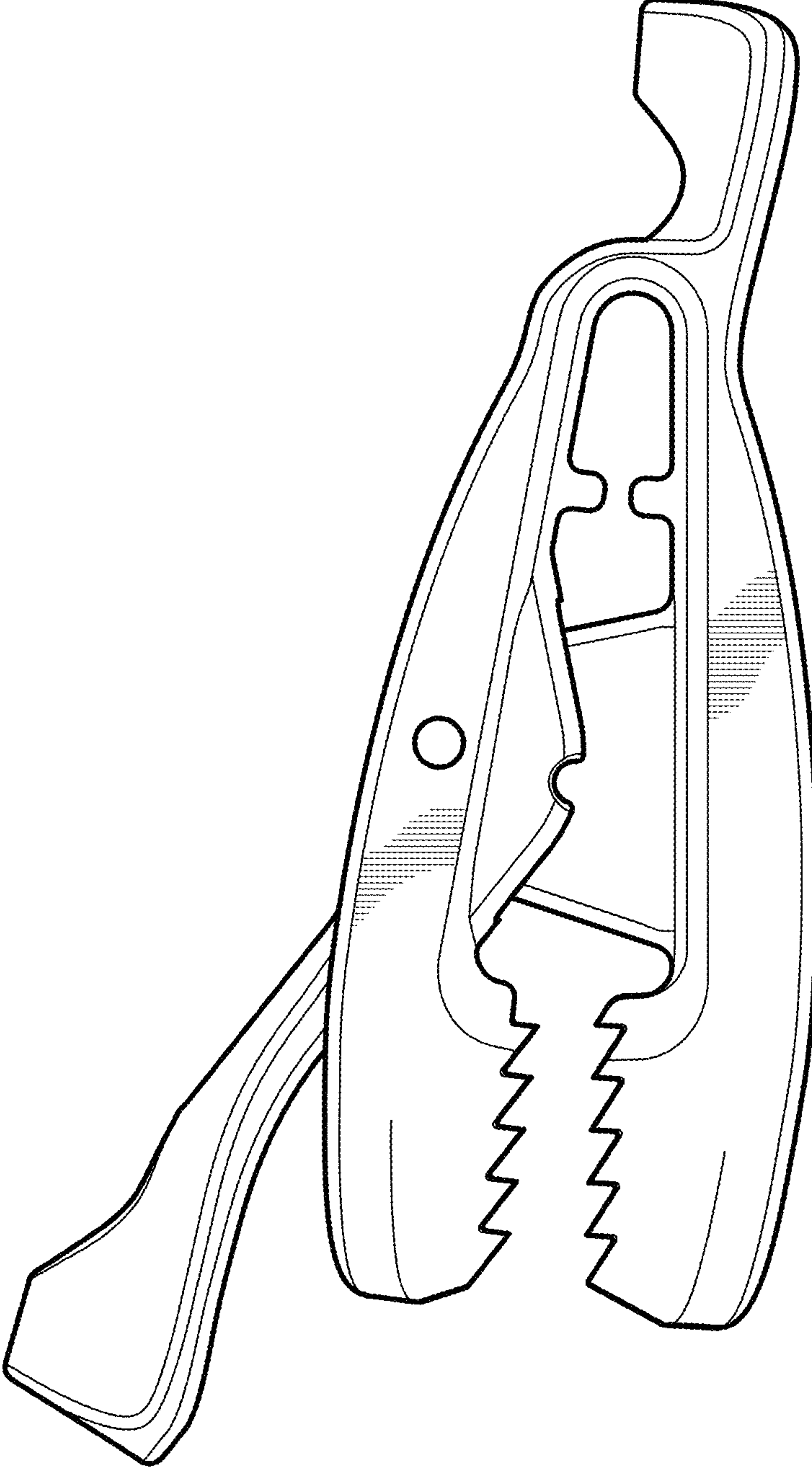

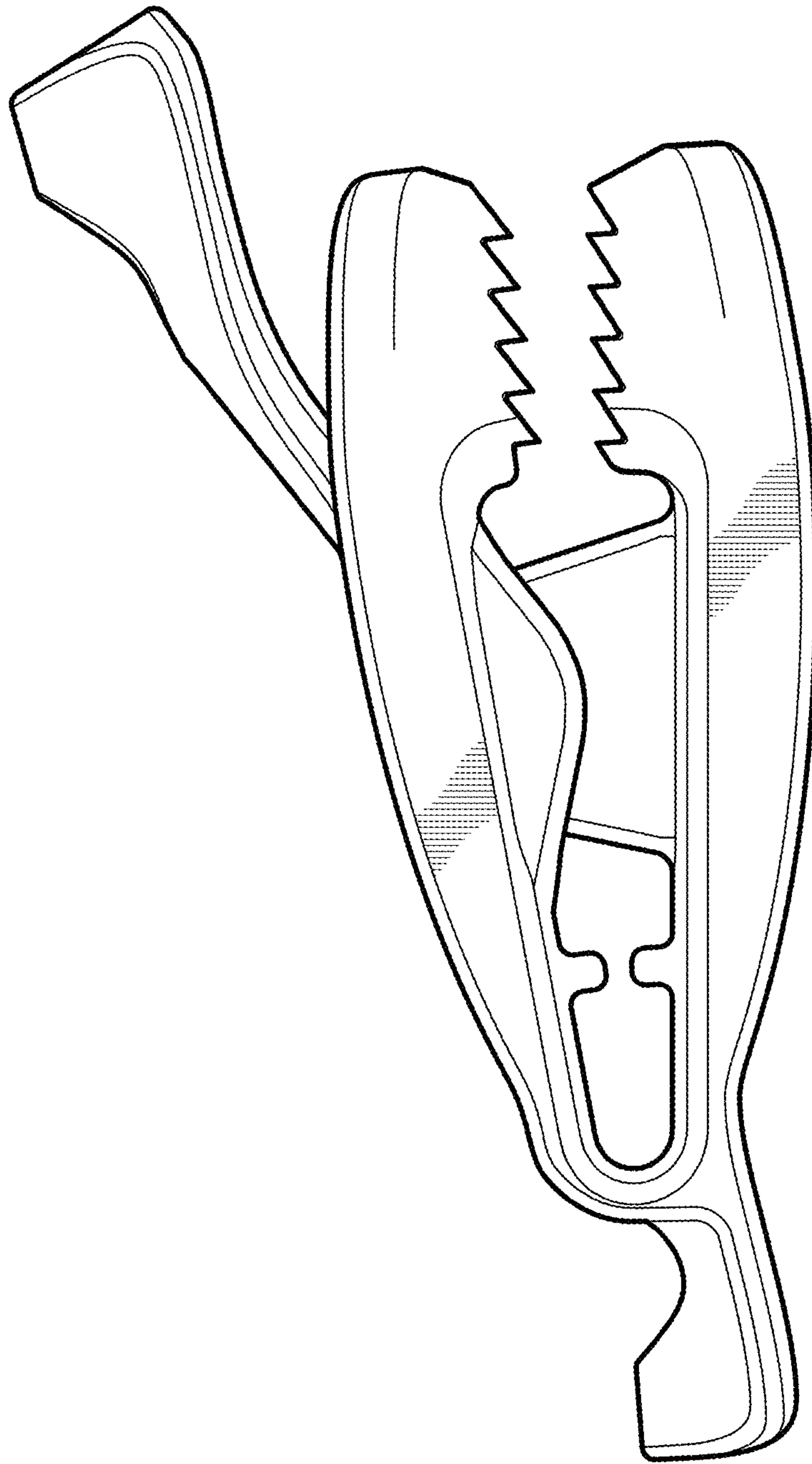

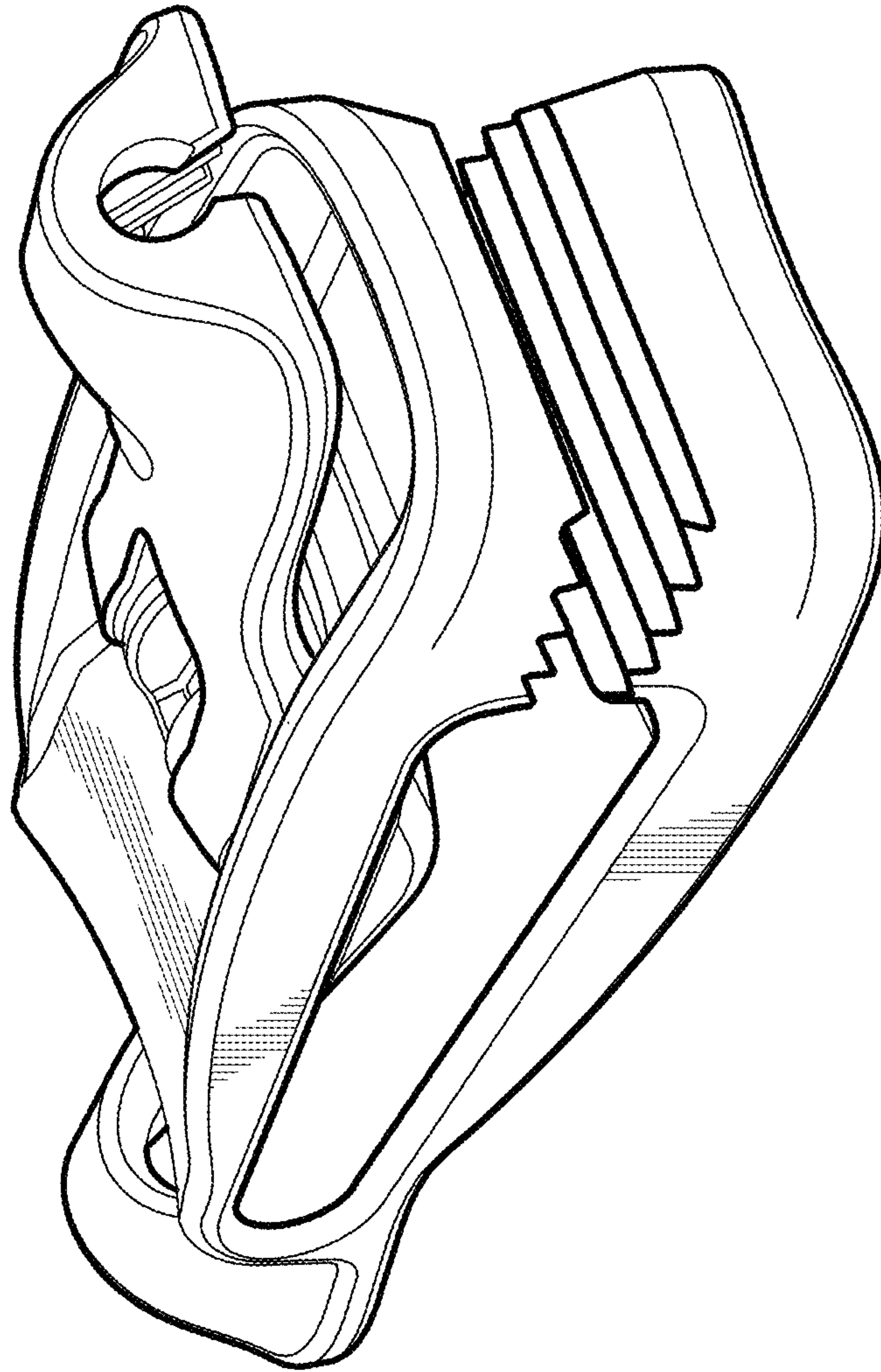
