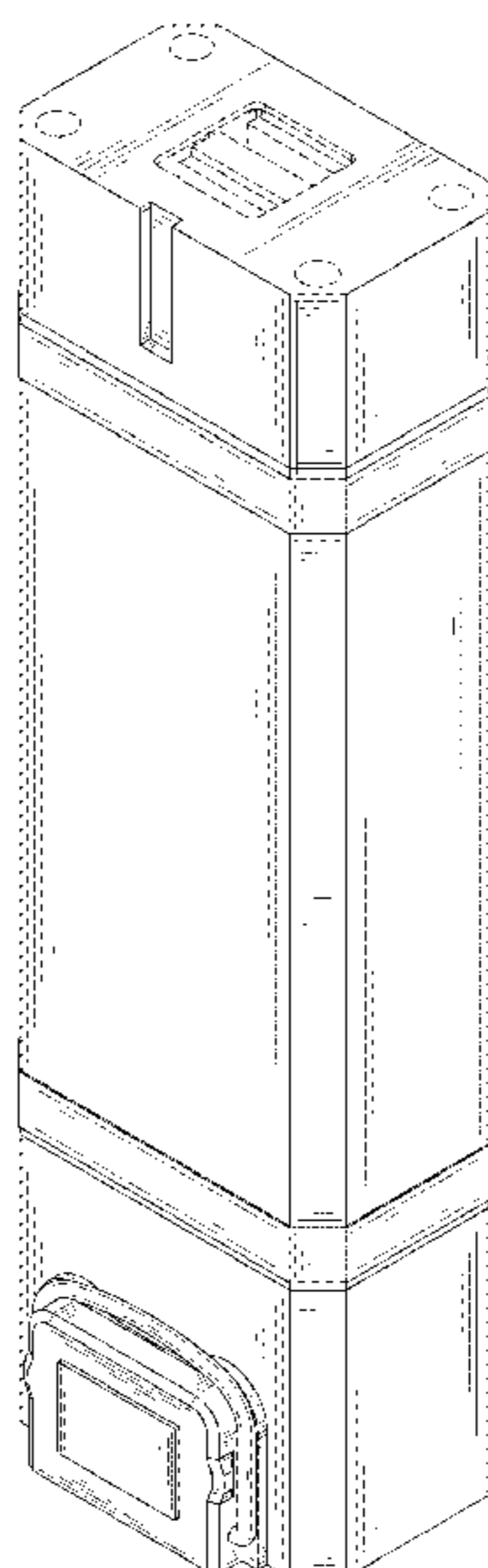

DESCRIPTION
FIG. 1 is a top left perspective view of the portable power bank showing my new design;
FIG. 2 is bottom right perspective view thereof;

FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;

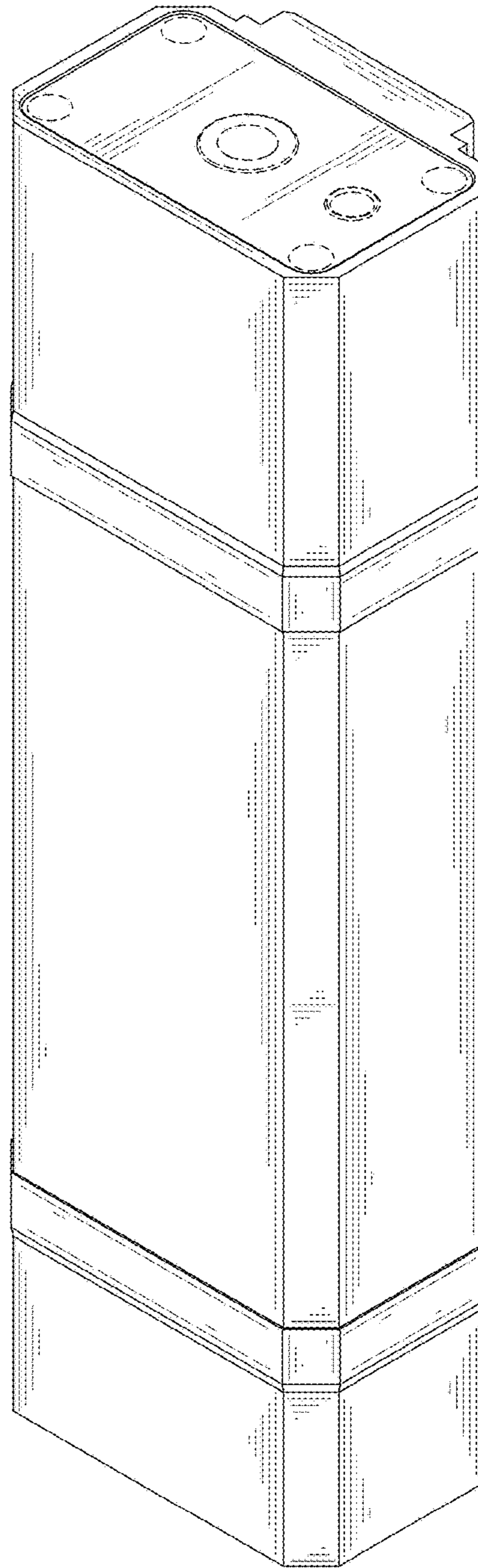

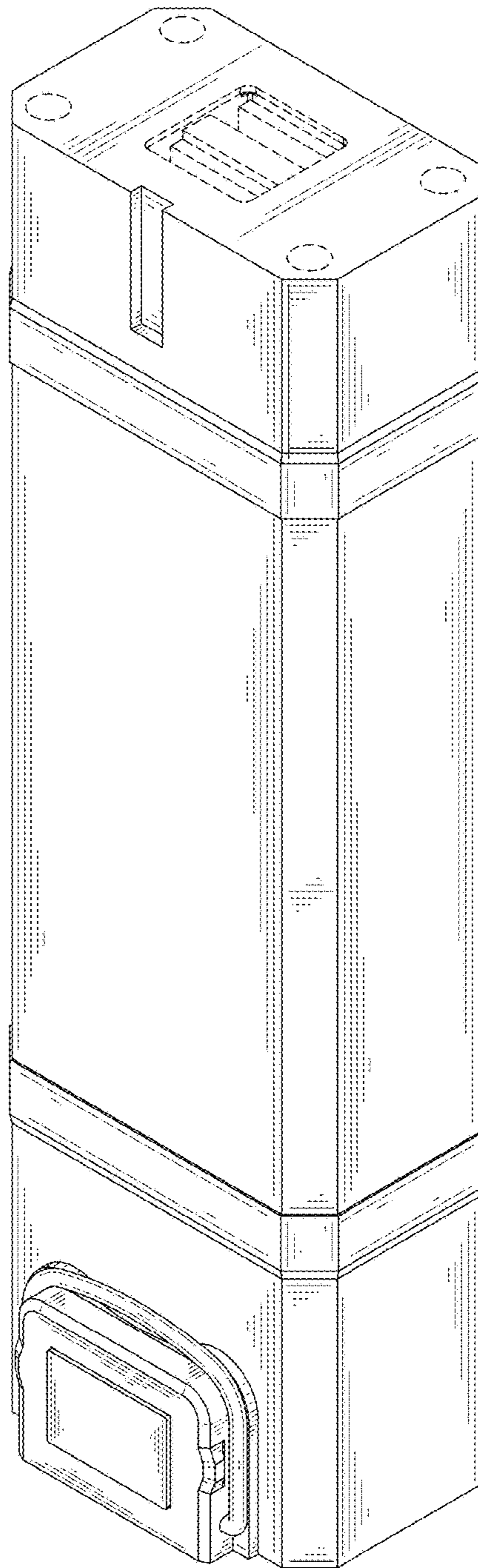

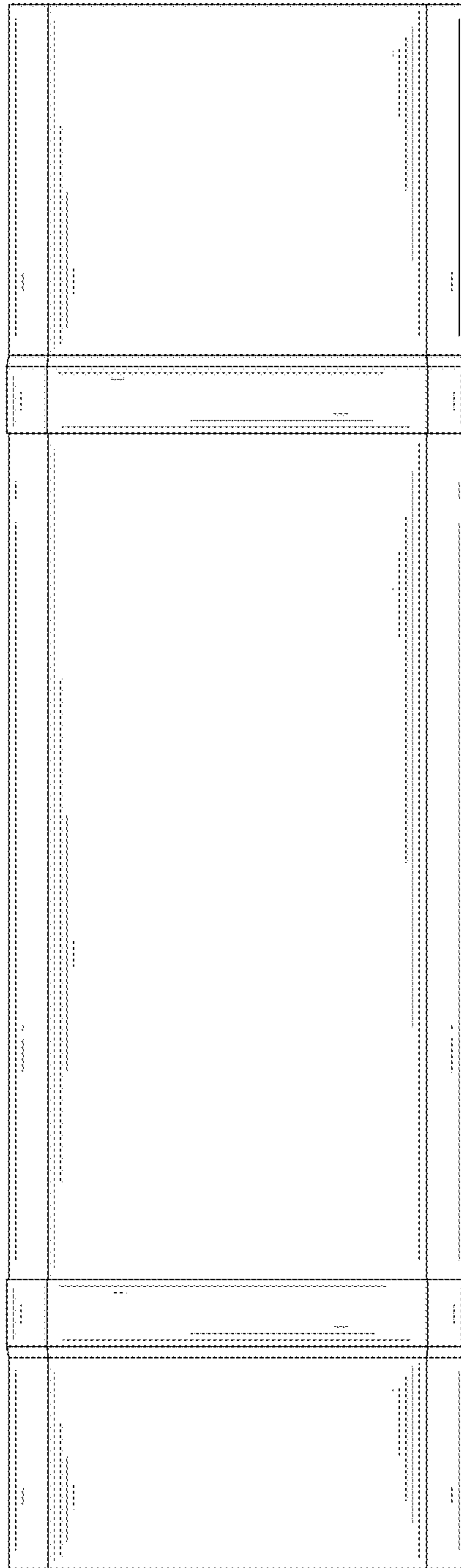

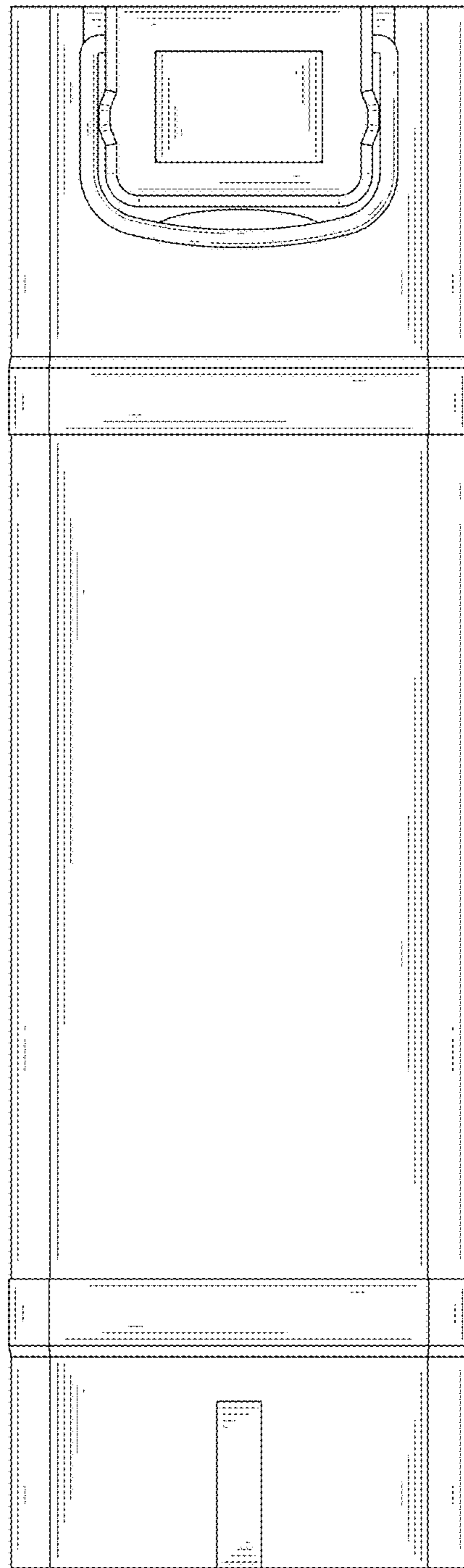

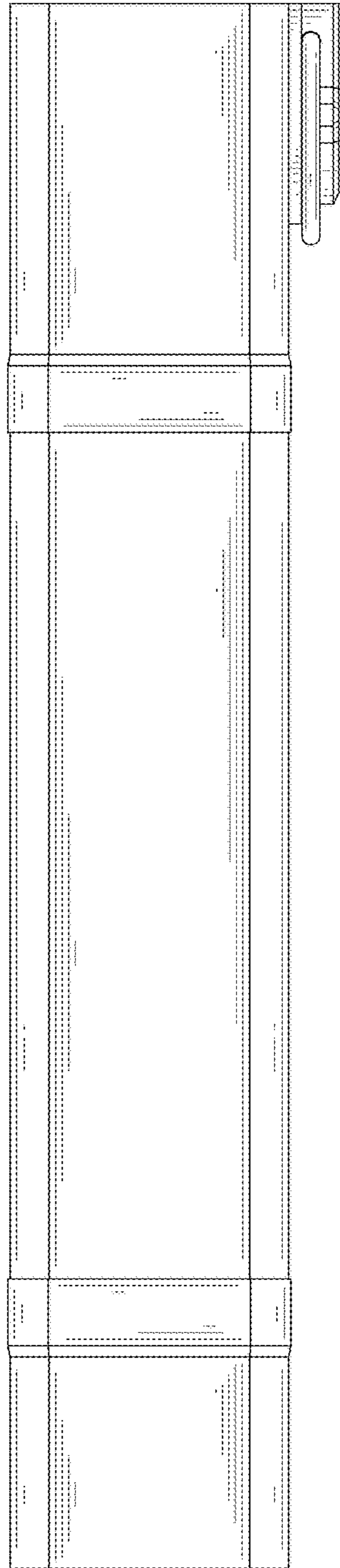

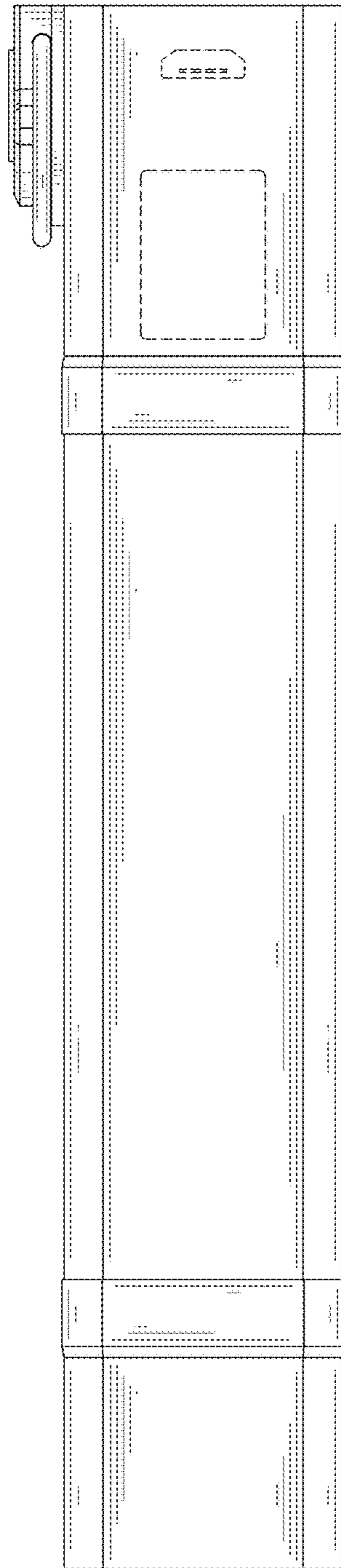

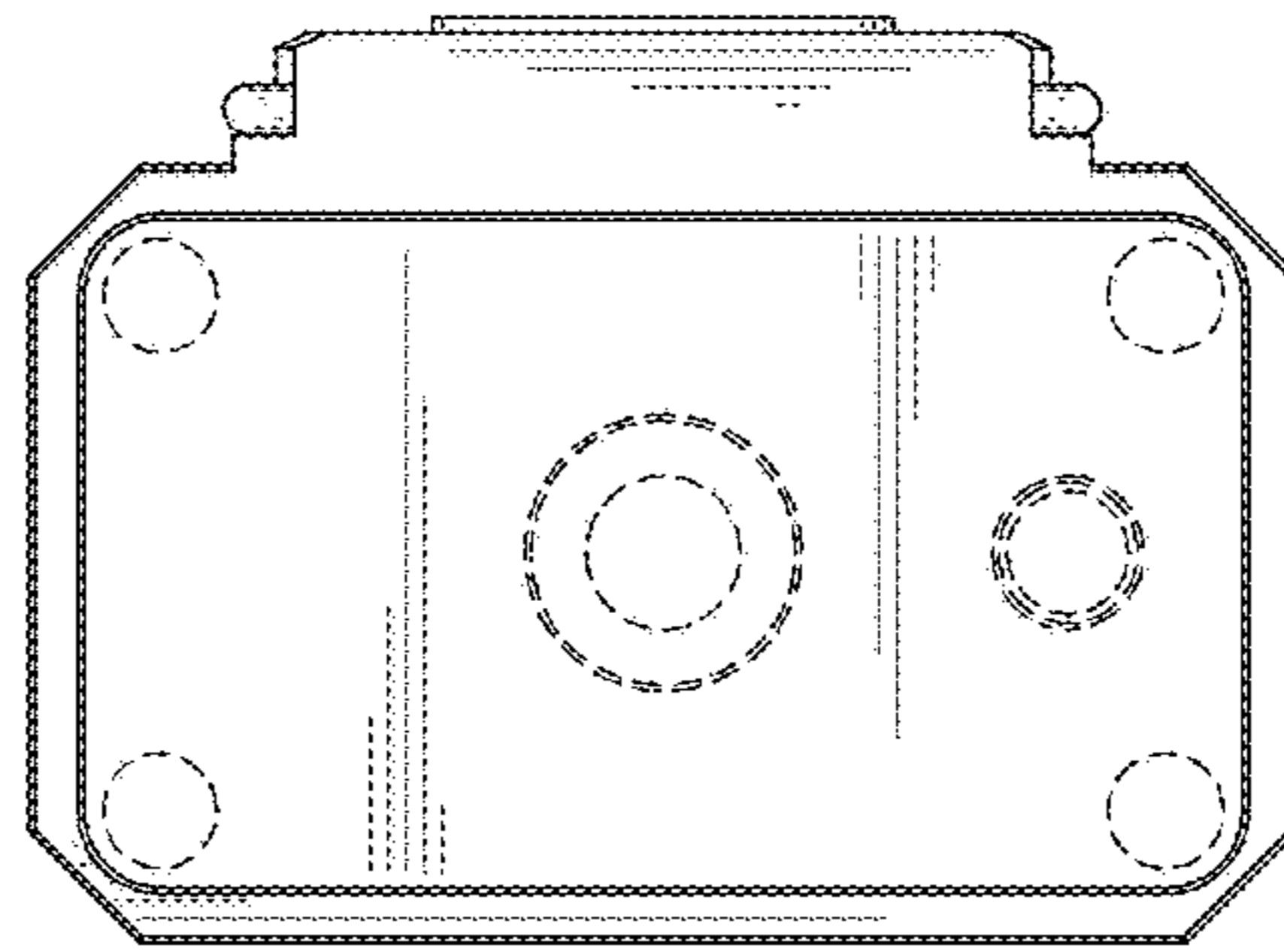

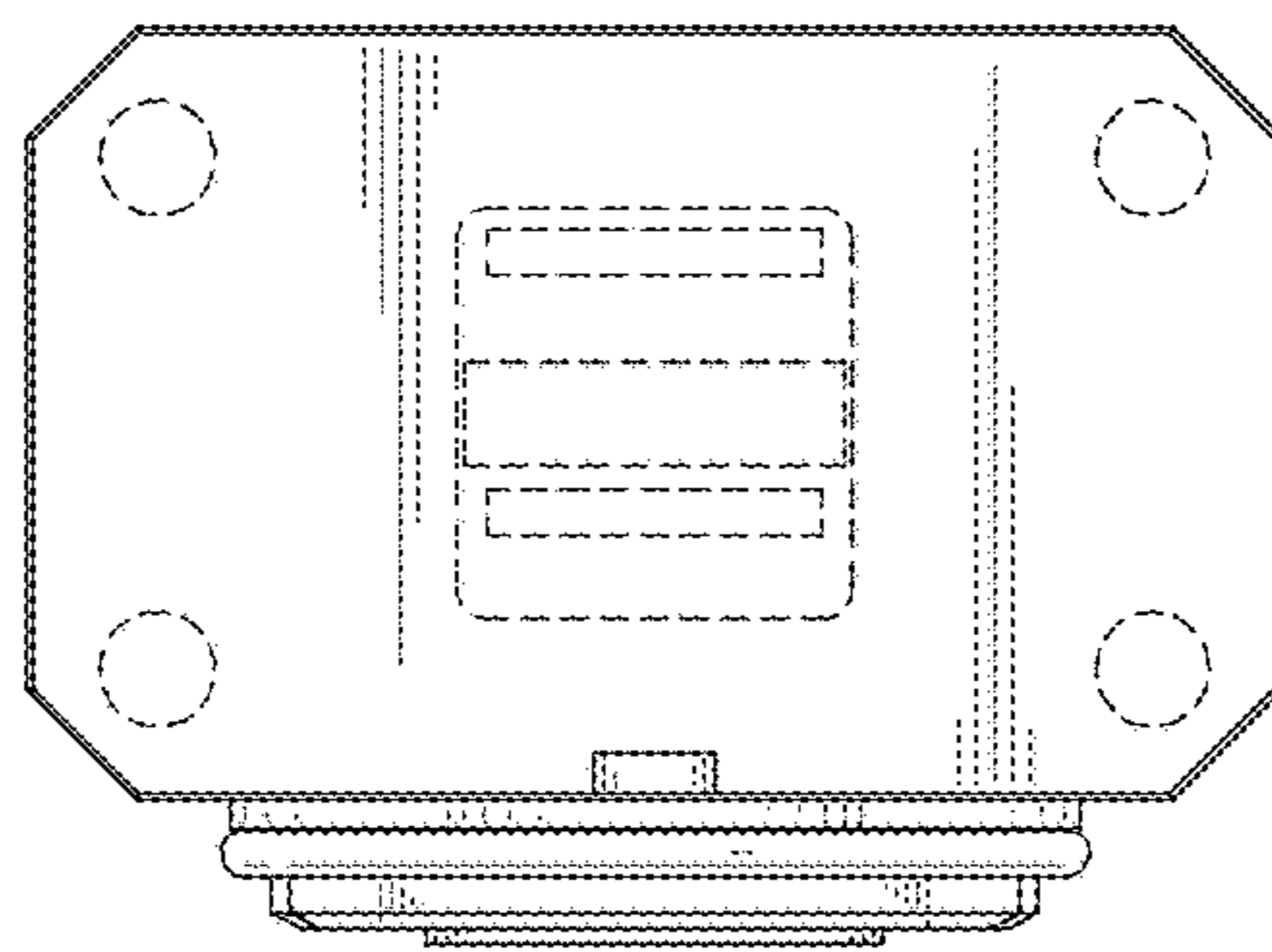
