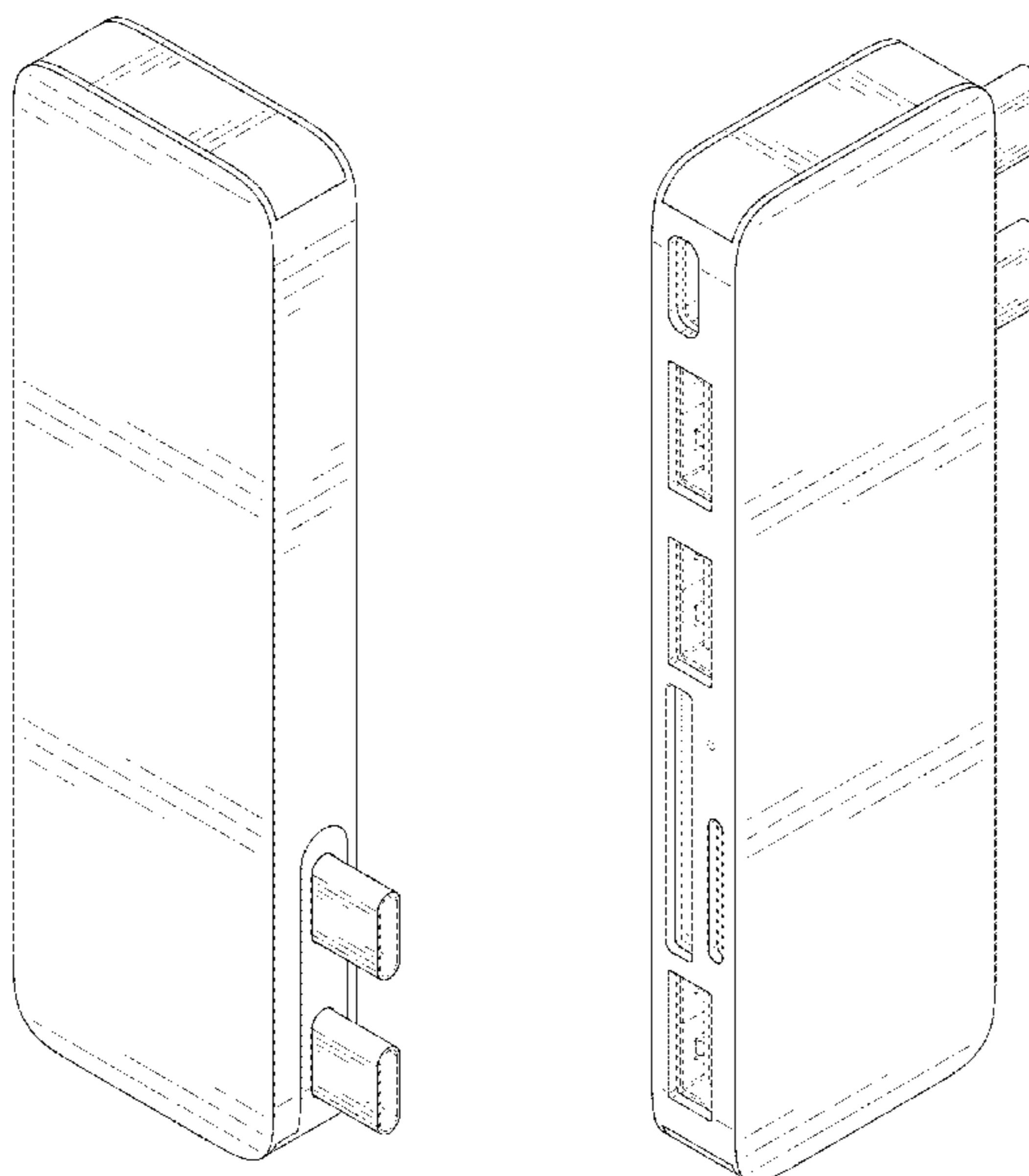
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a double port type-c multi-function hub, showing my new design;

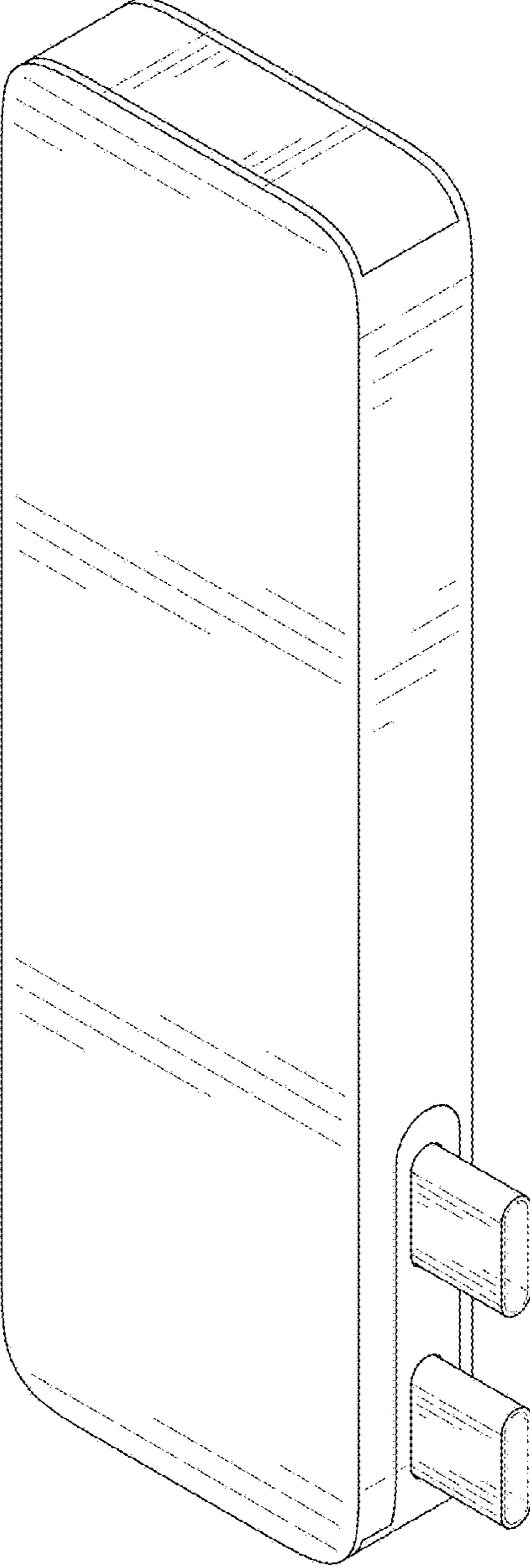

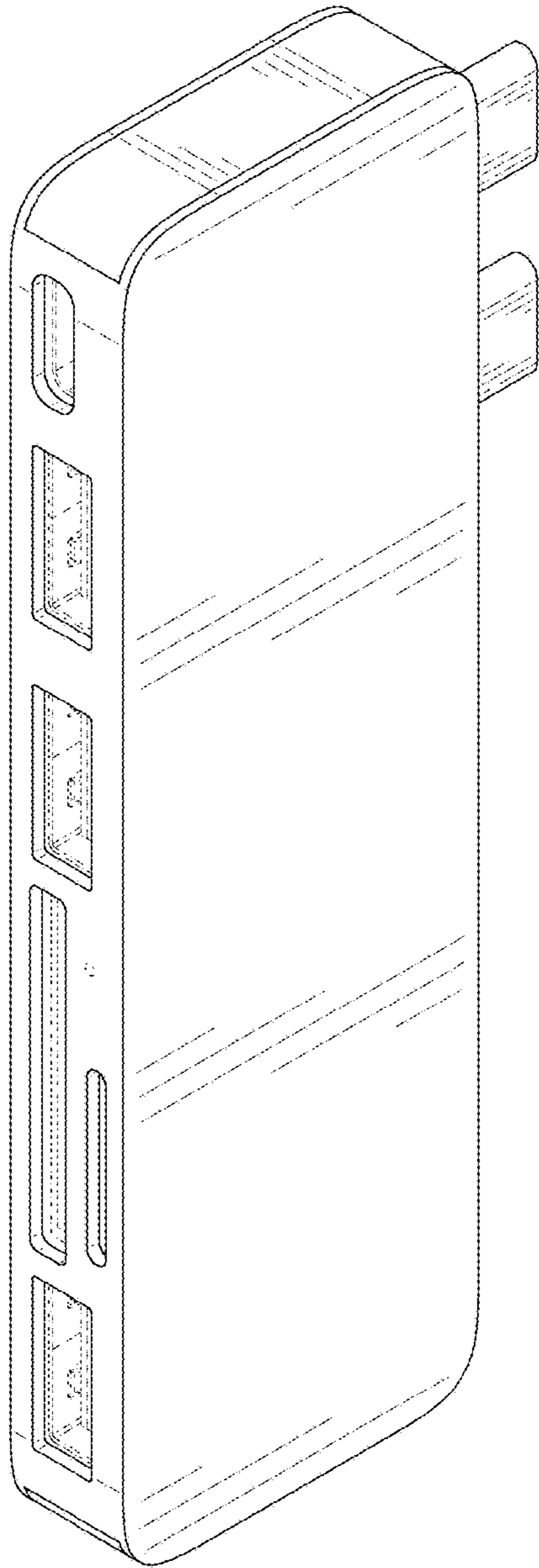

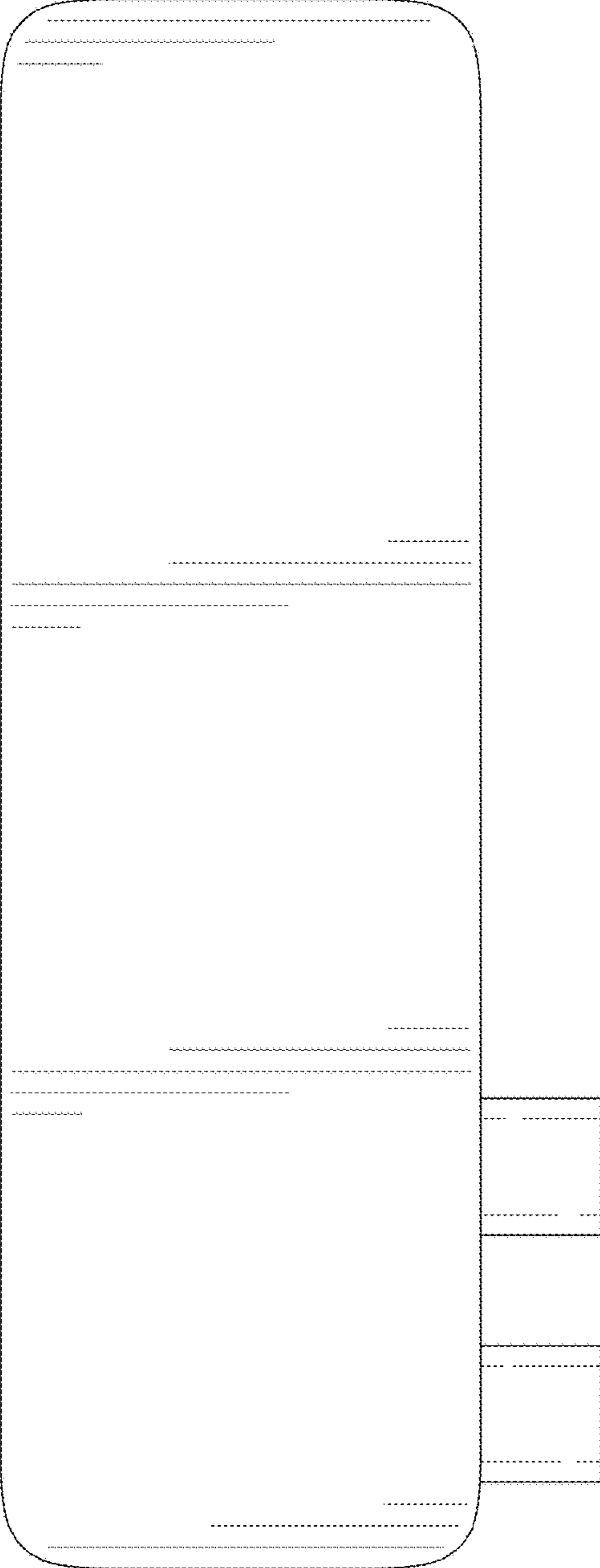

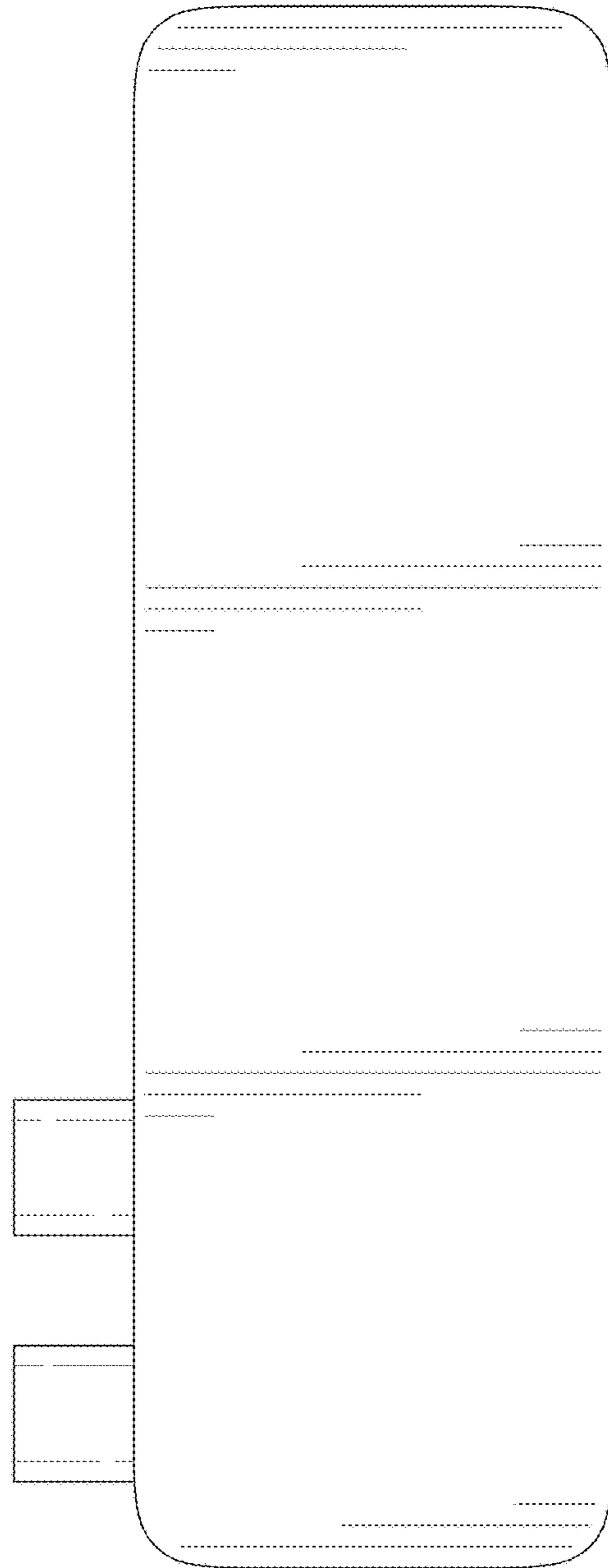

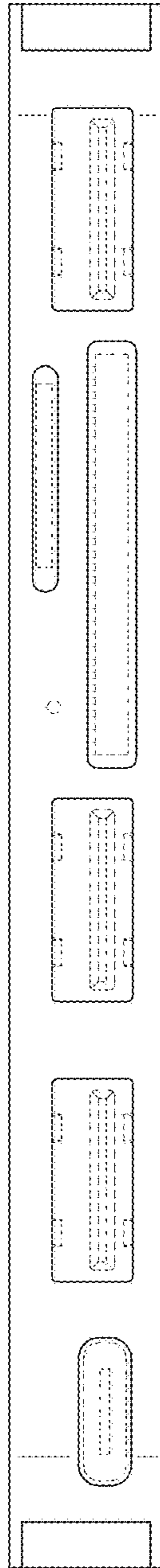

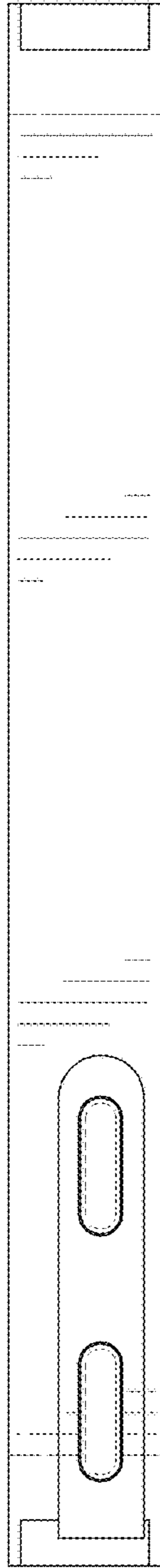

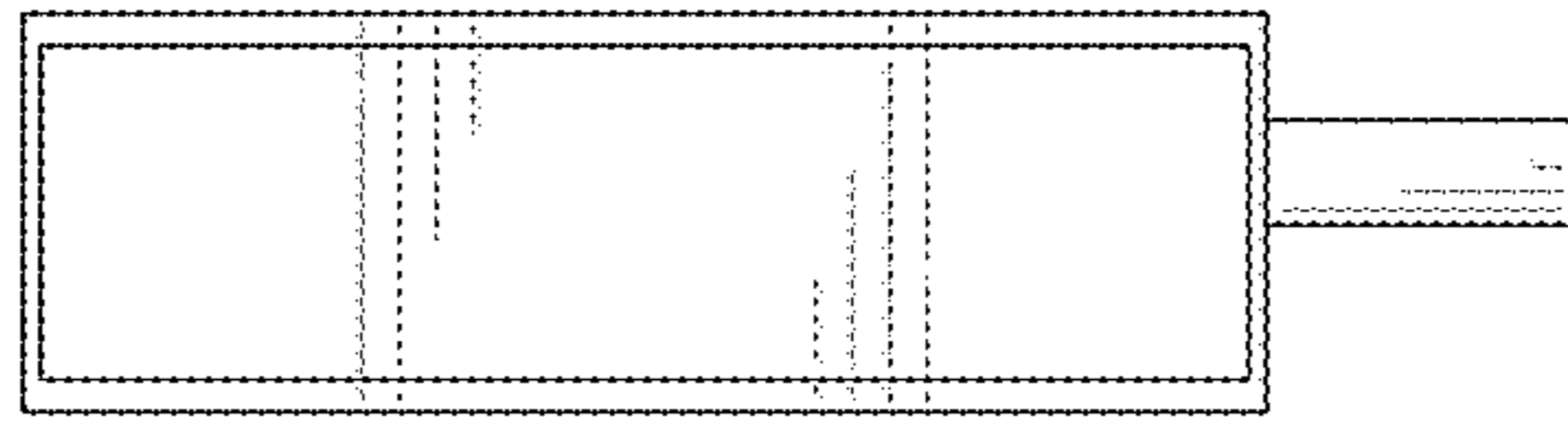

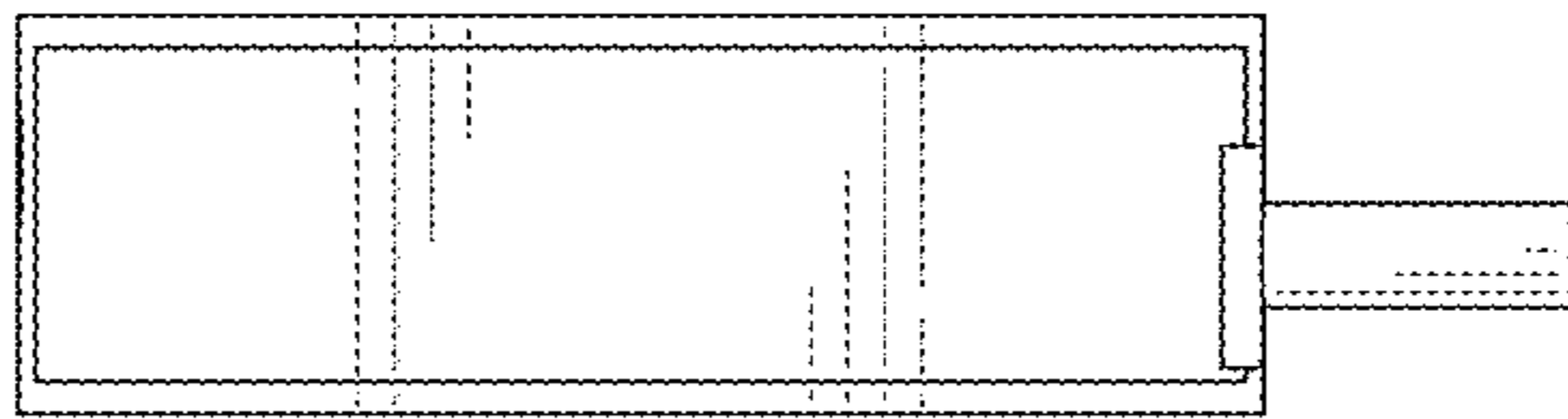
