FIG. 1 is a front view of a first image of a display screen or portion thereof with animated graphical user interface for selection of a food item for cooking in a cooking device;

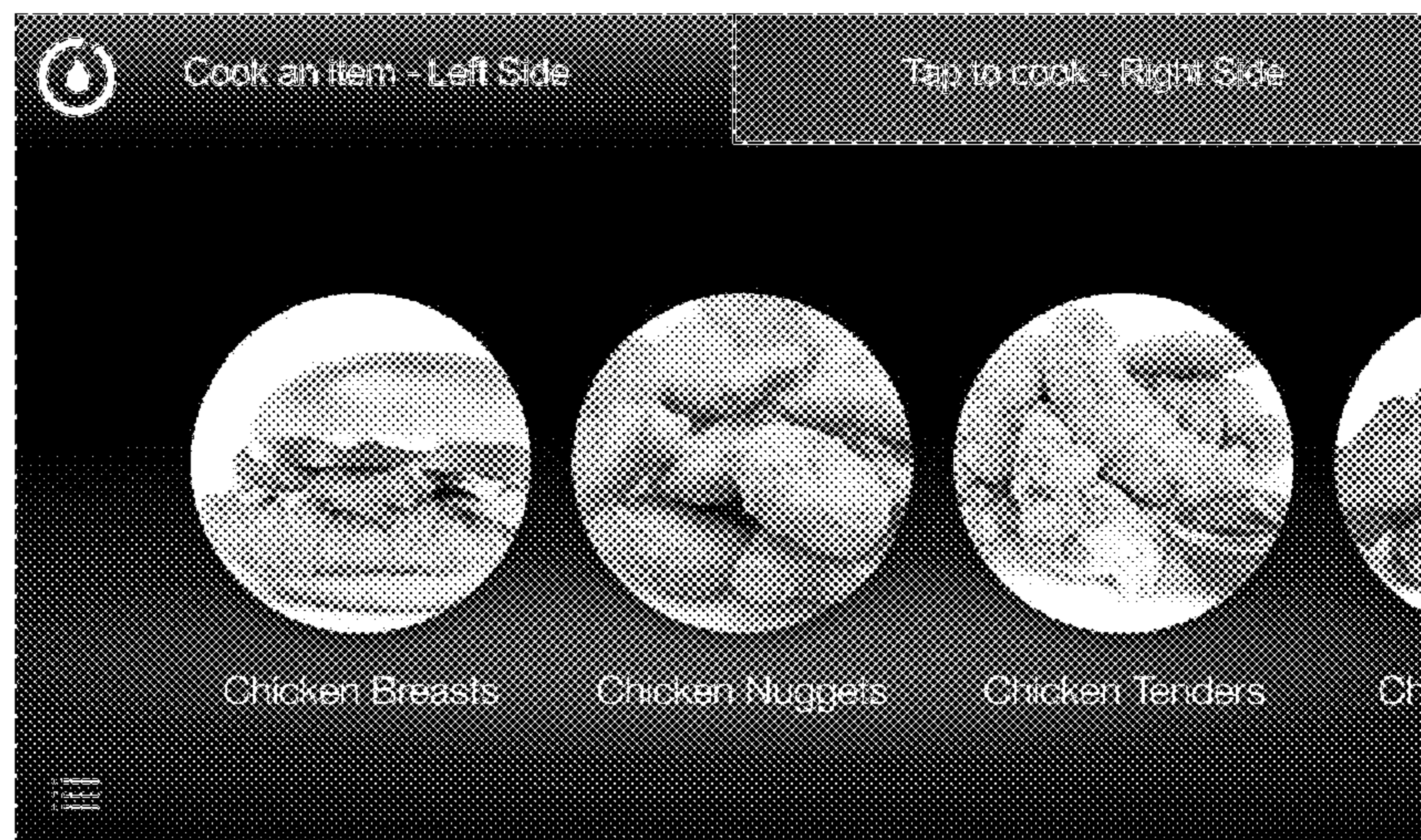
FIG. 2 is a front view of a second image of the display screen or portion thereof;

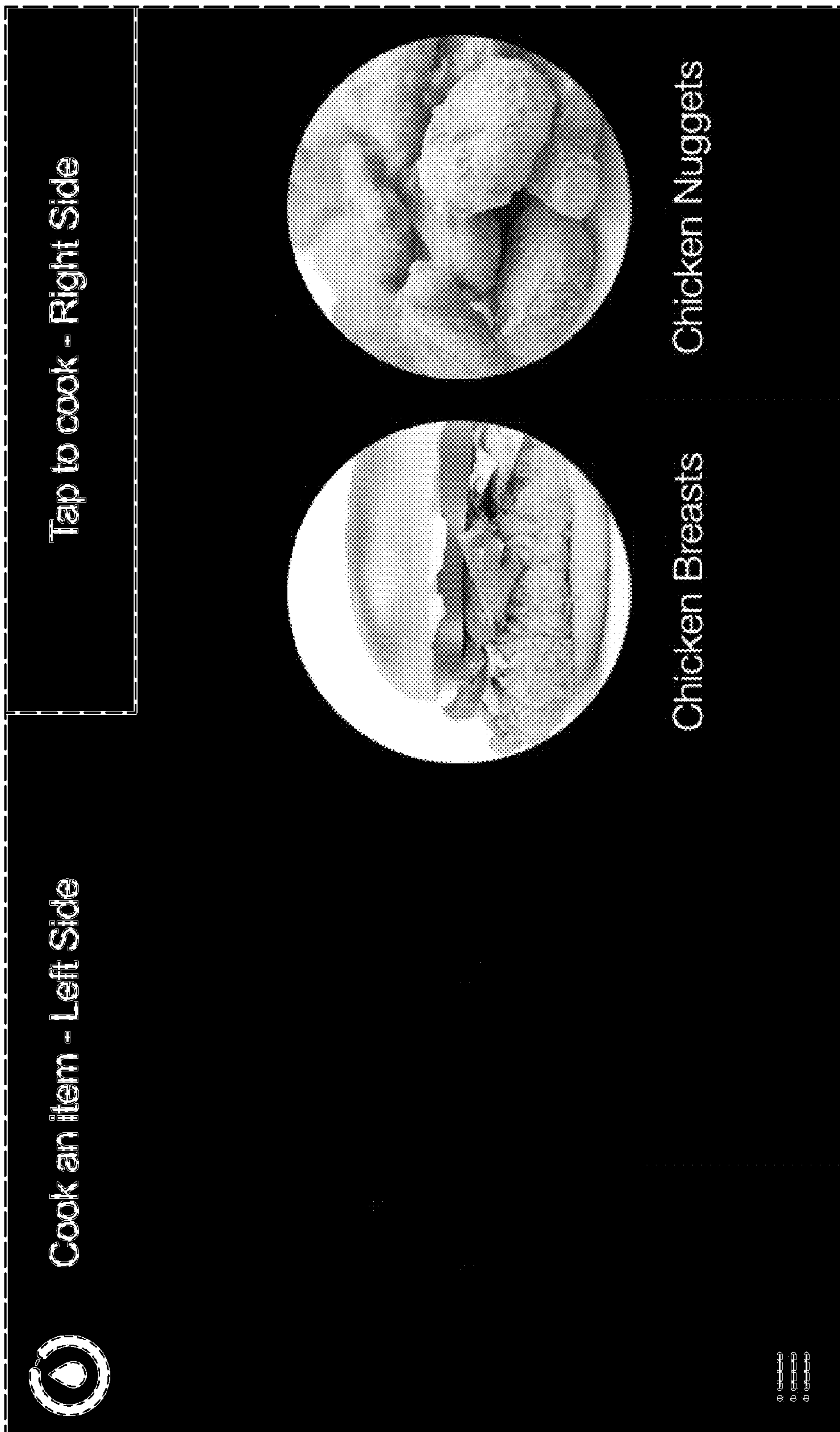

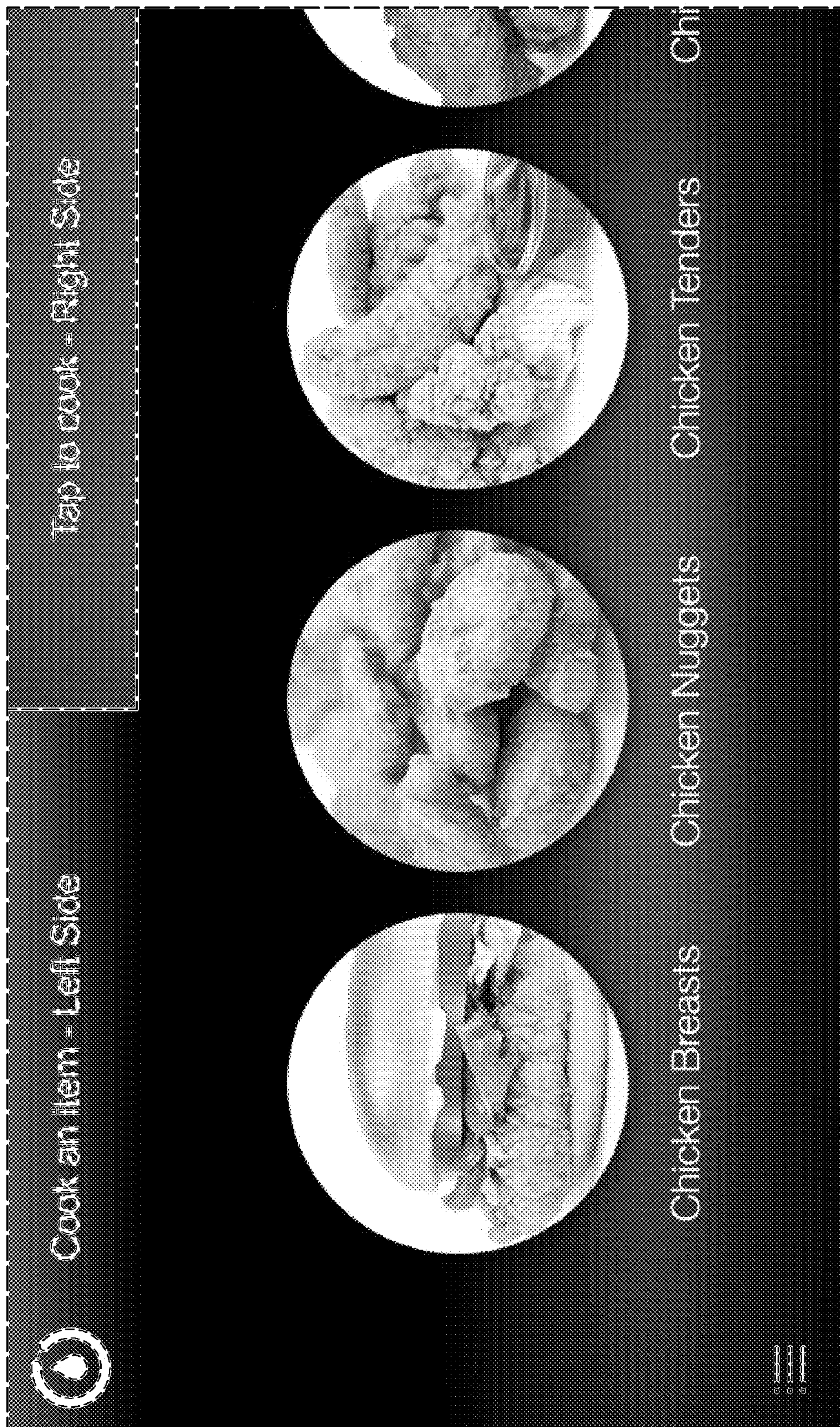

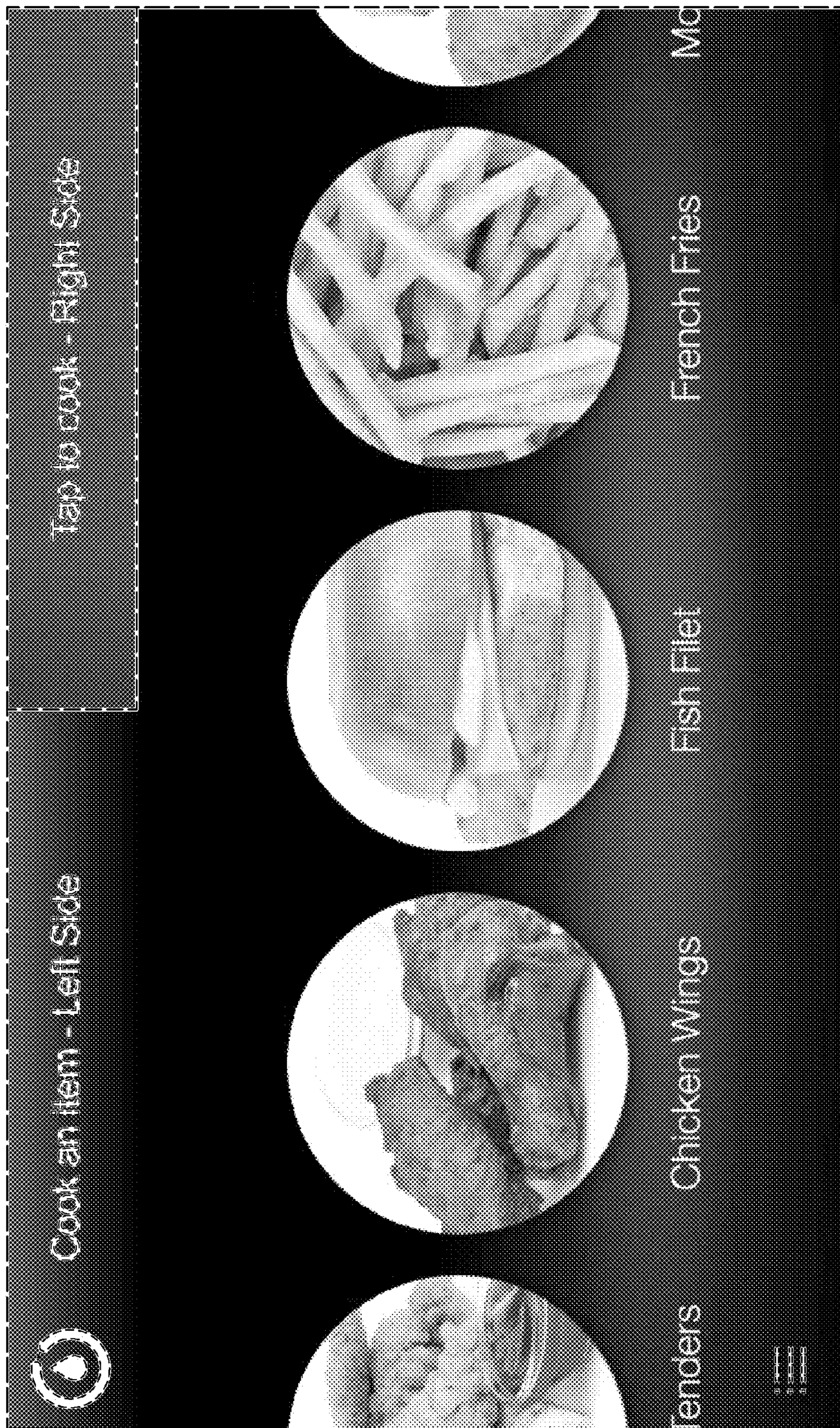

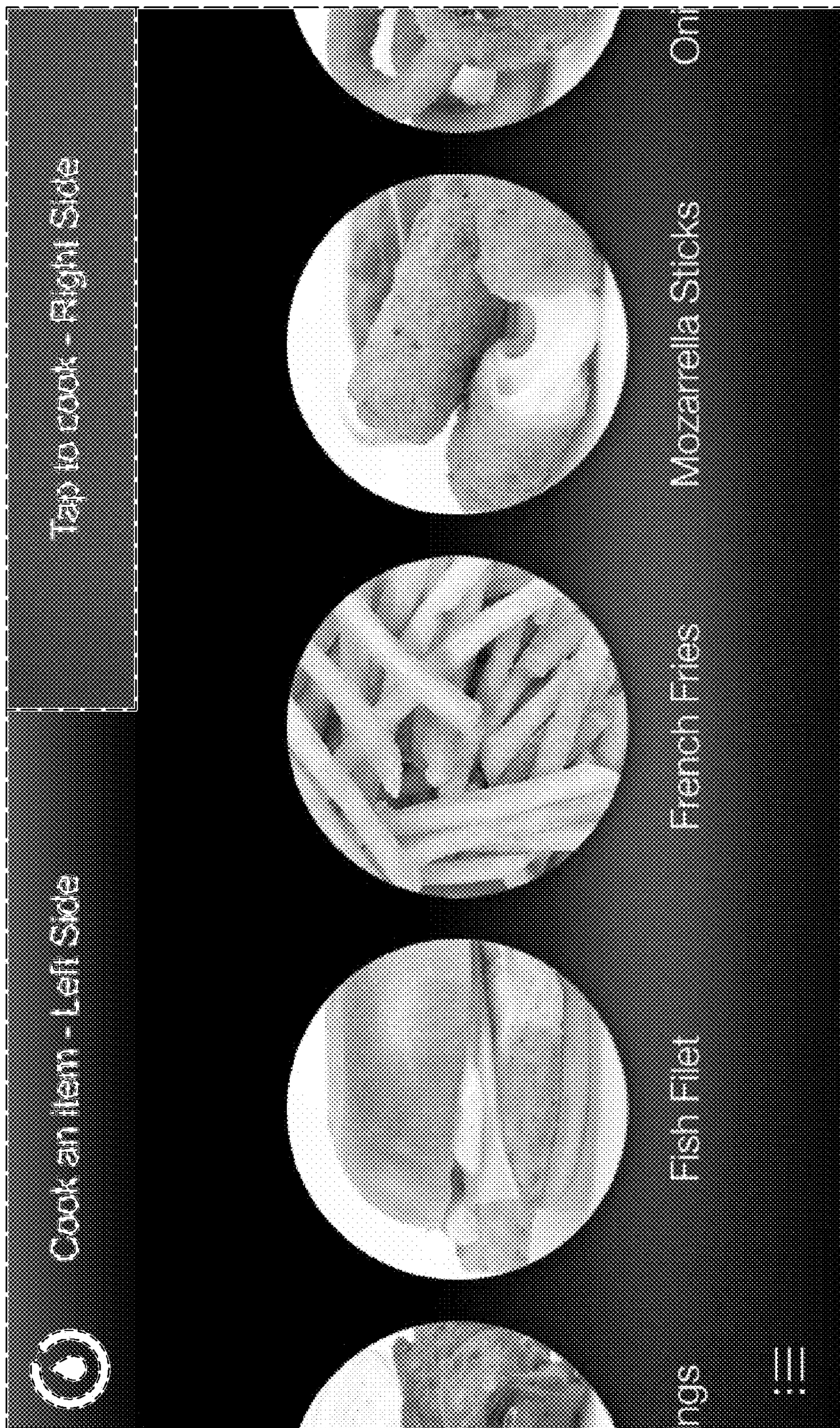
