The ornamental design for a collection of paint color display cards, as shown and described.

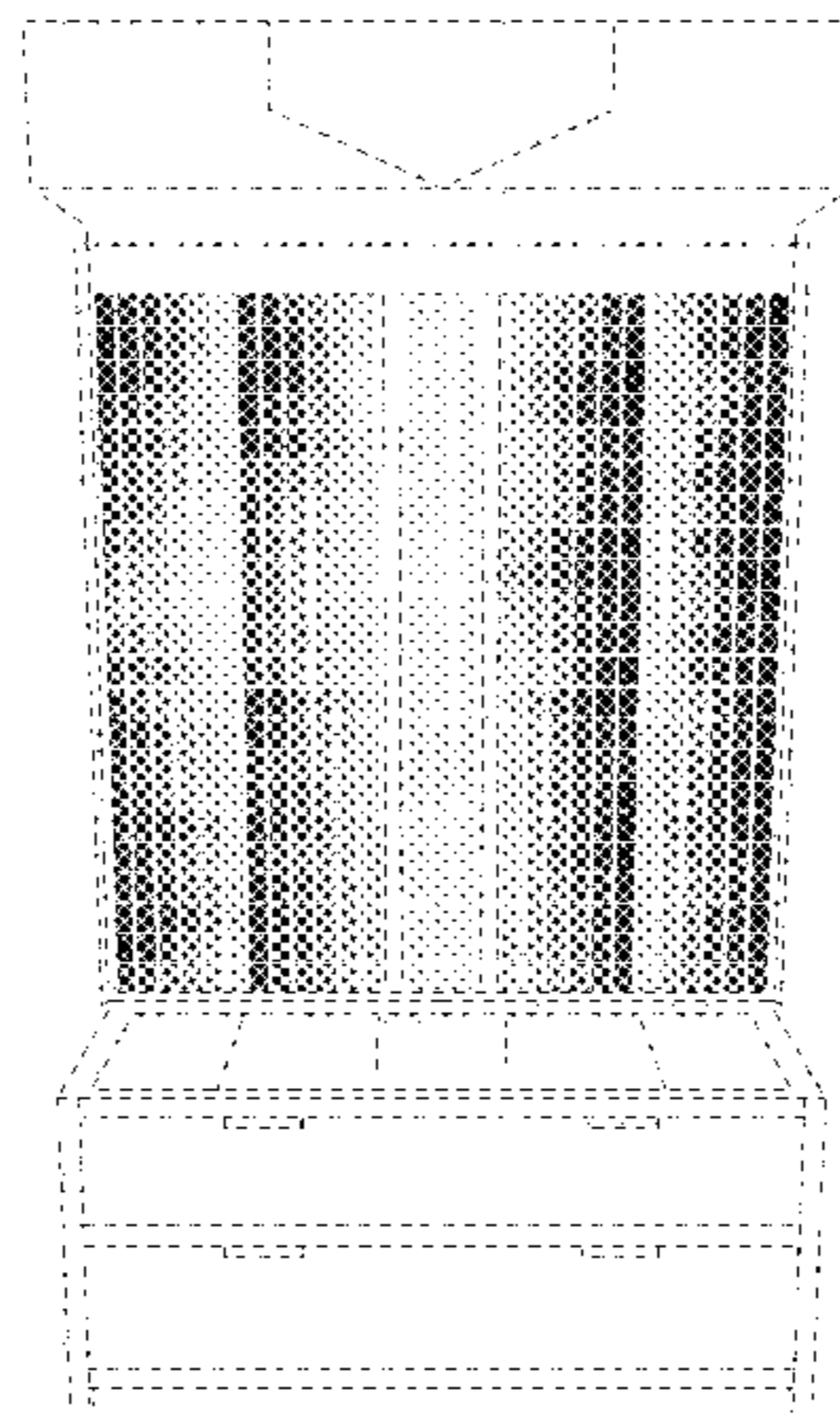
**DESCRIPTION**

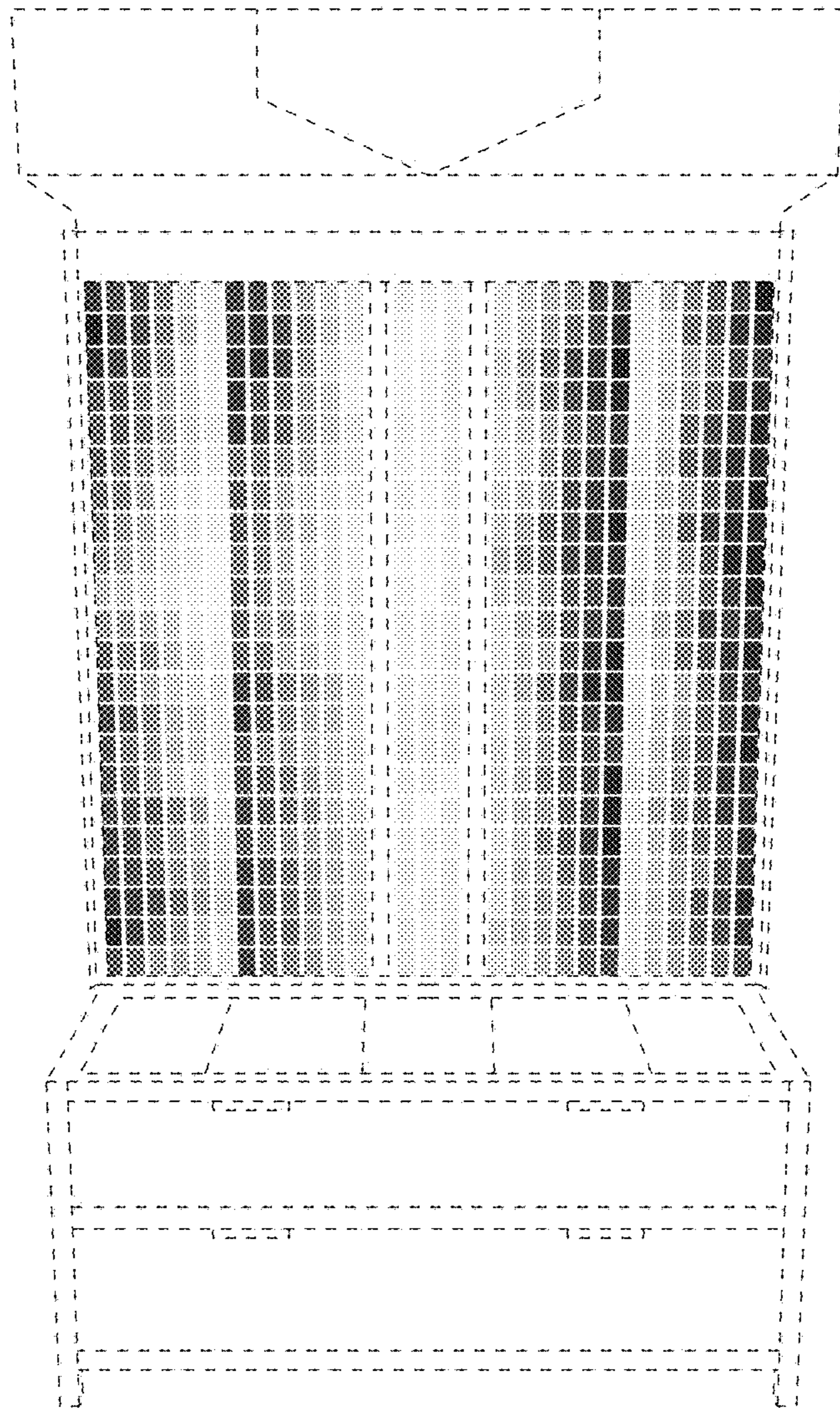

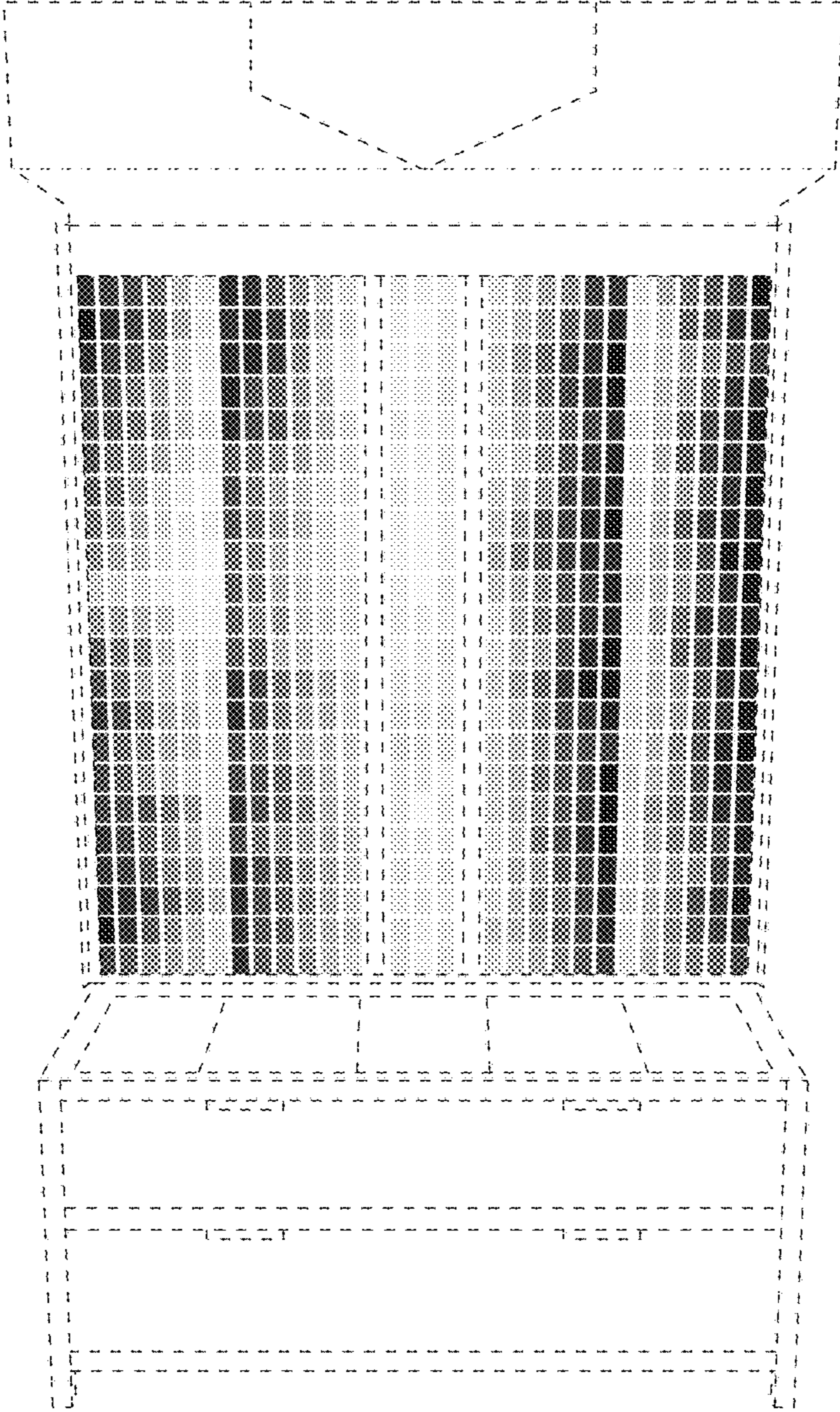
