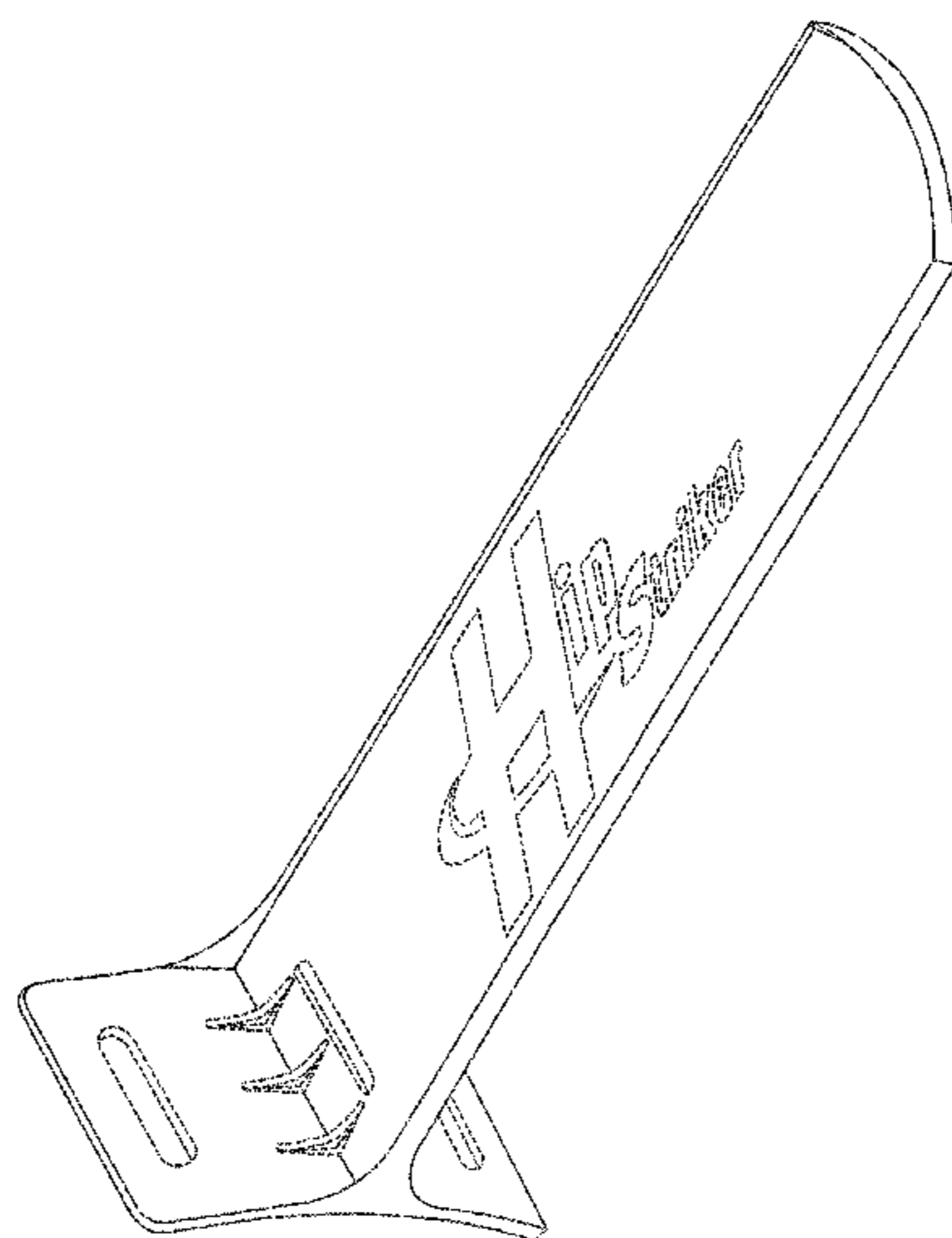
(57) **CLAIM**

I claim the ornamental design for a hip rotation training apparatus, as shown and described.

DESCRIPTION

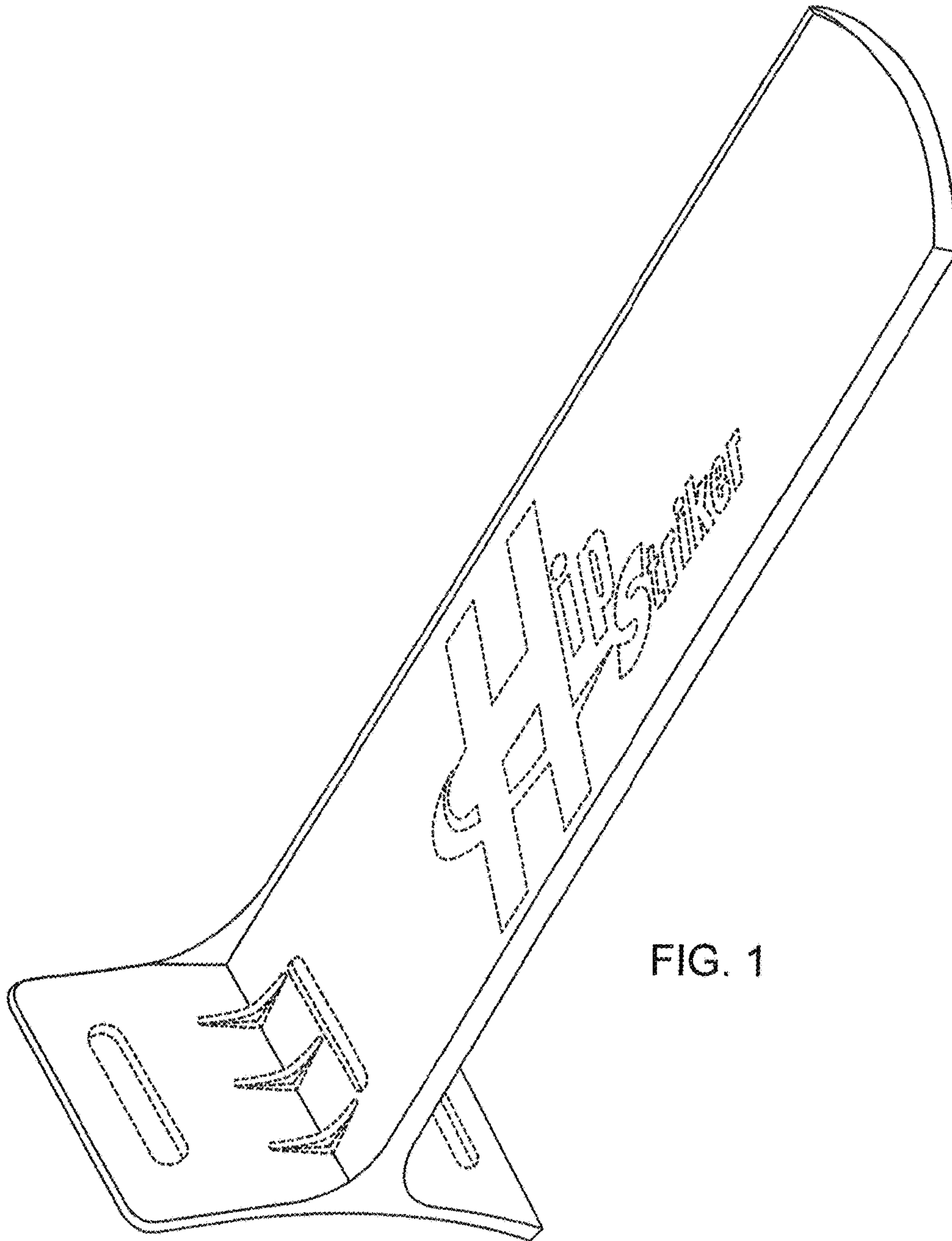

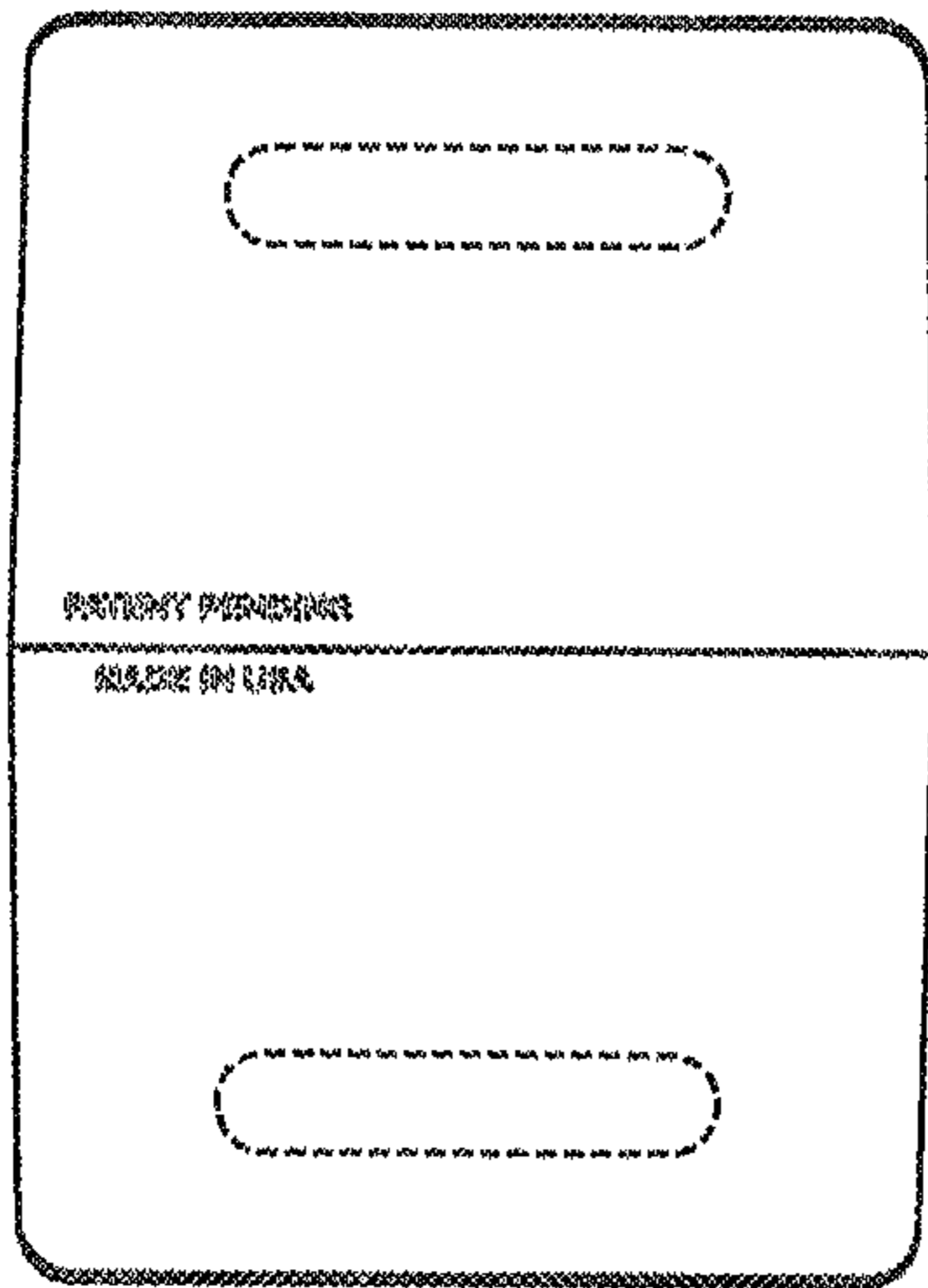

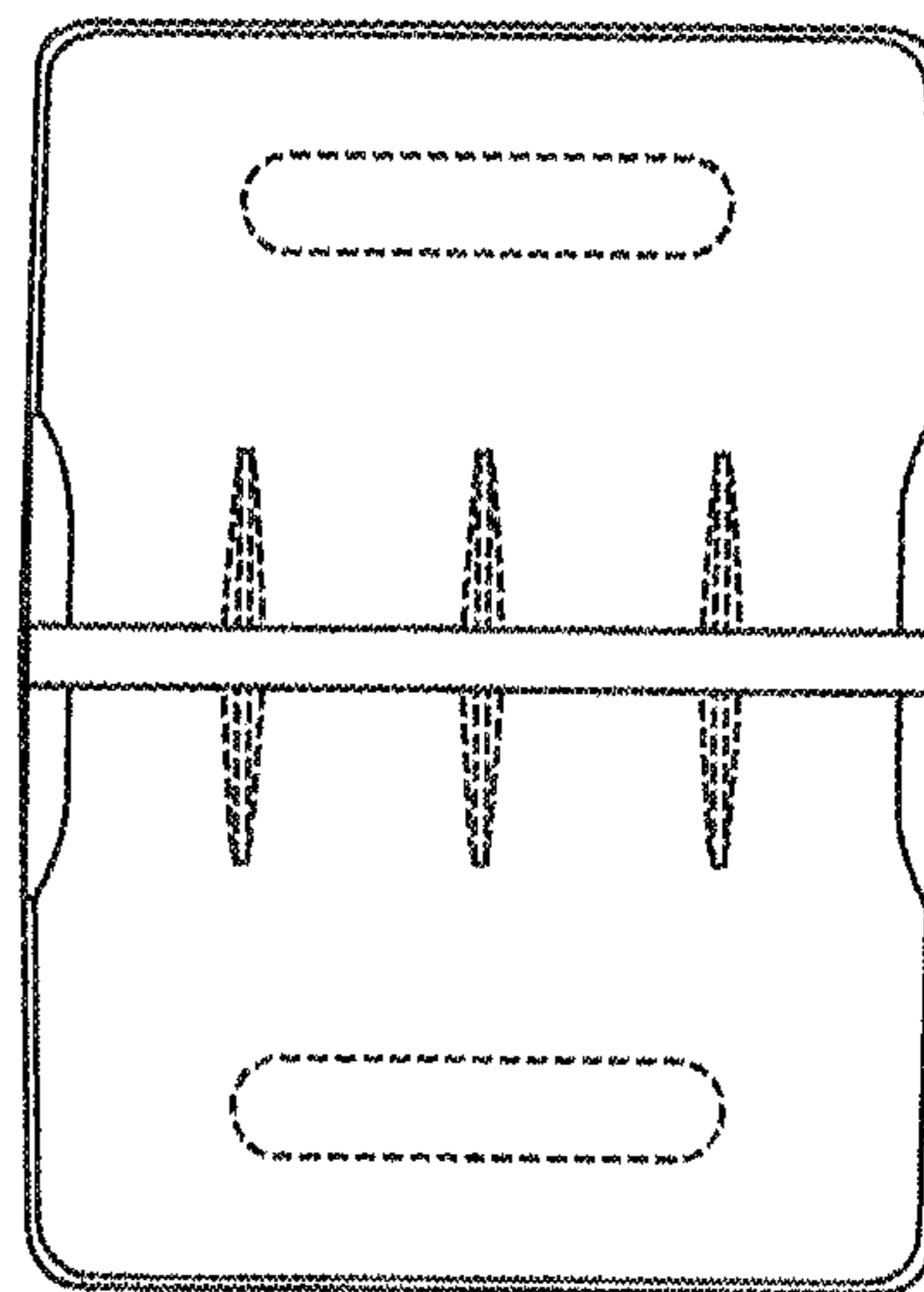

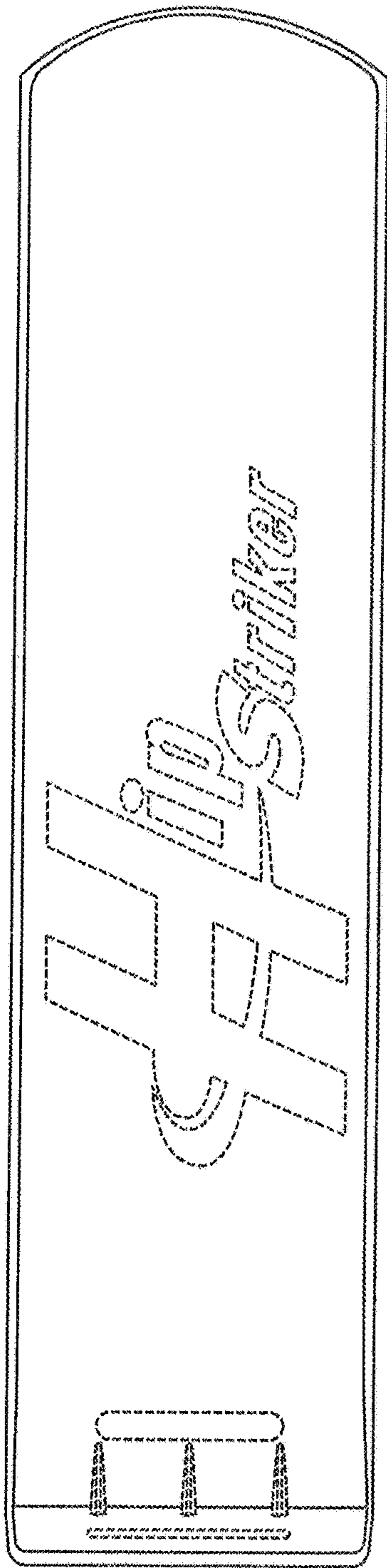

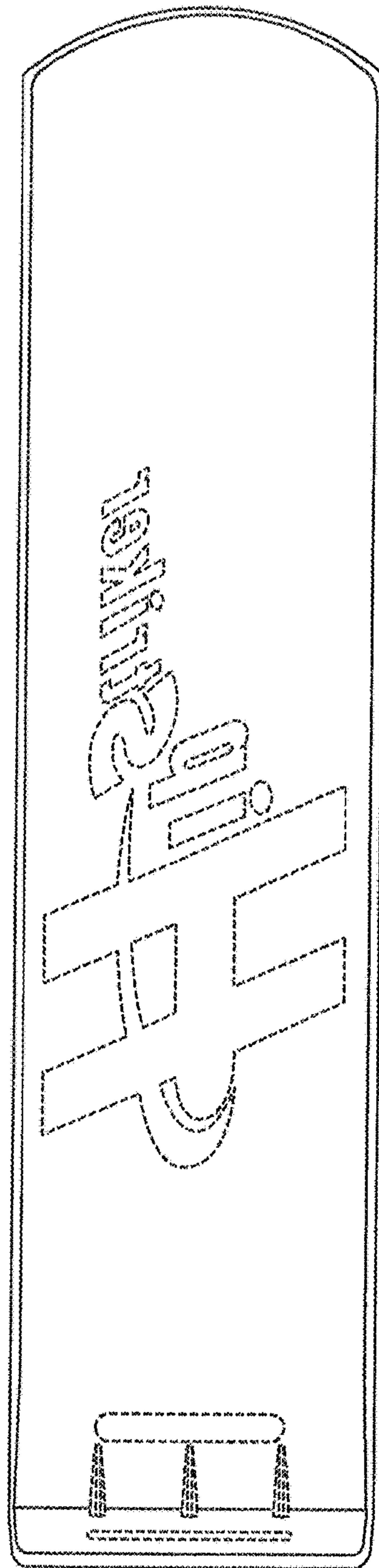

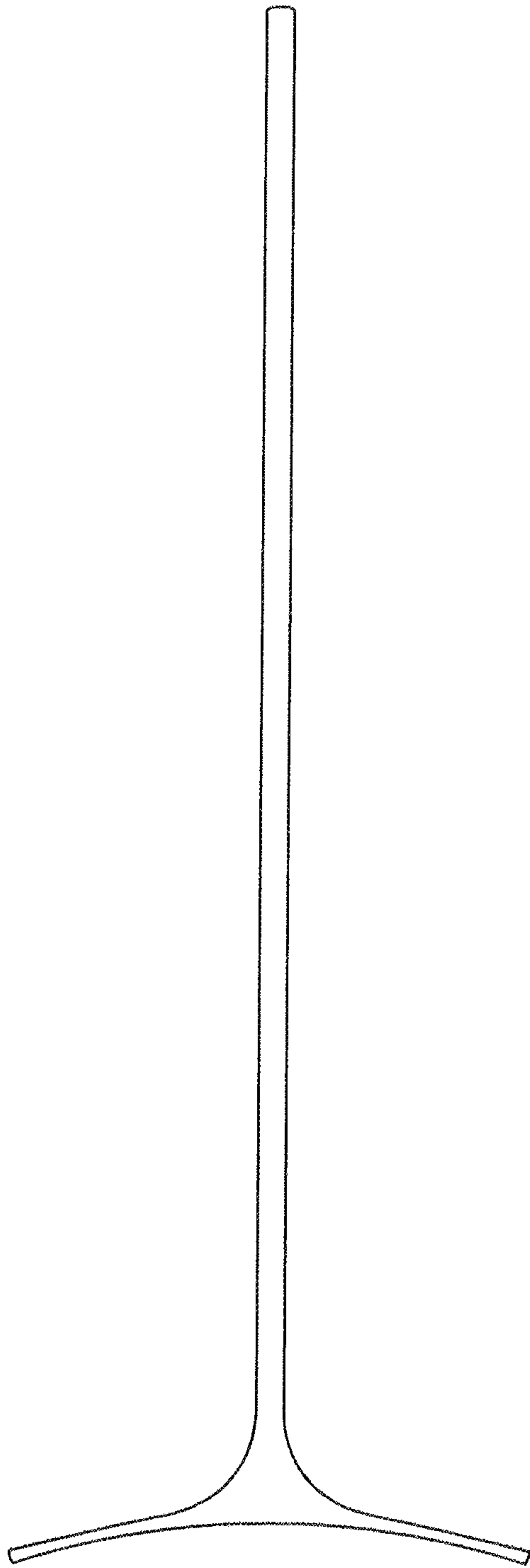

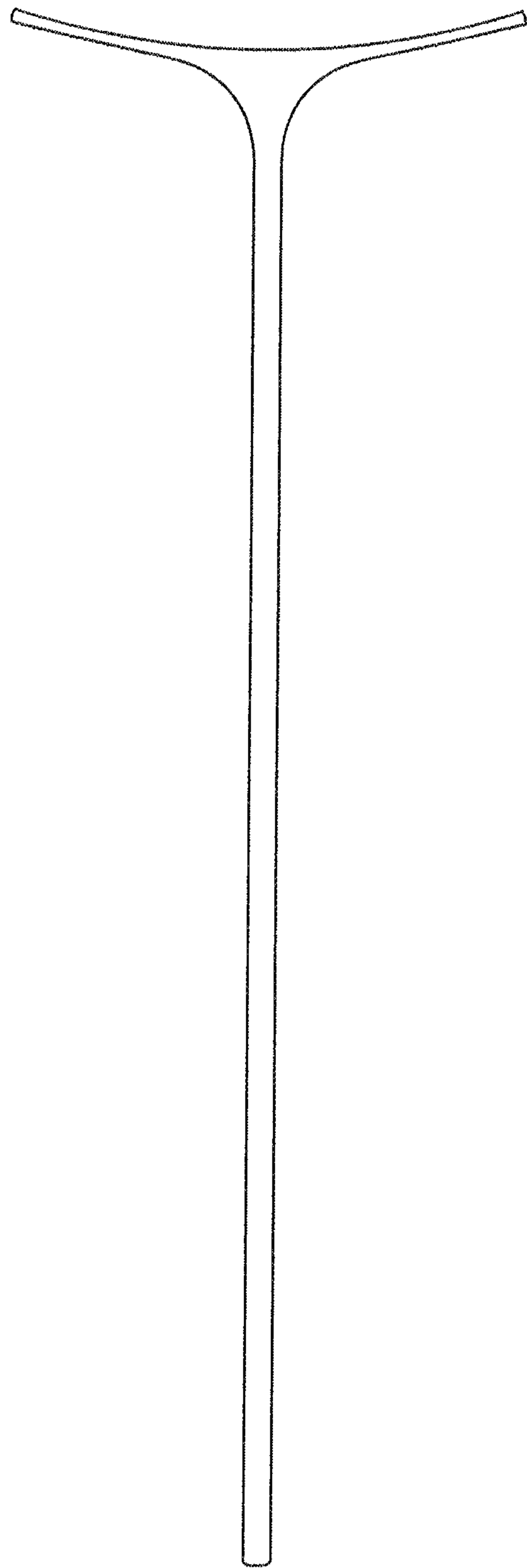
