FIG. 2.3 is a top plan view thereof;

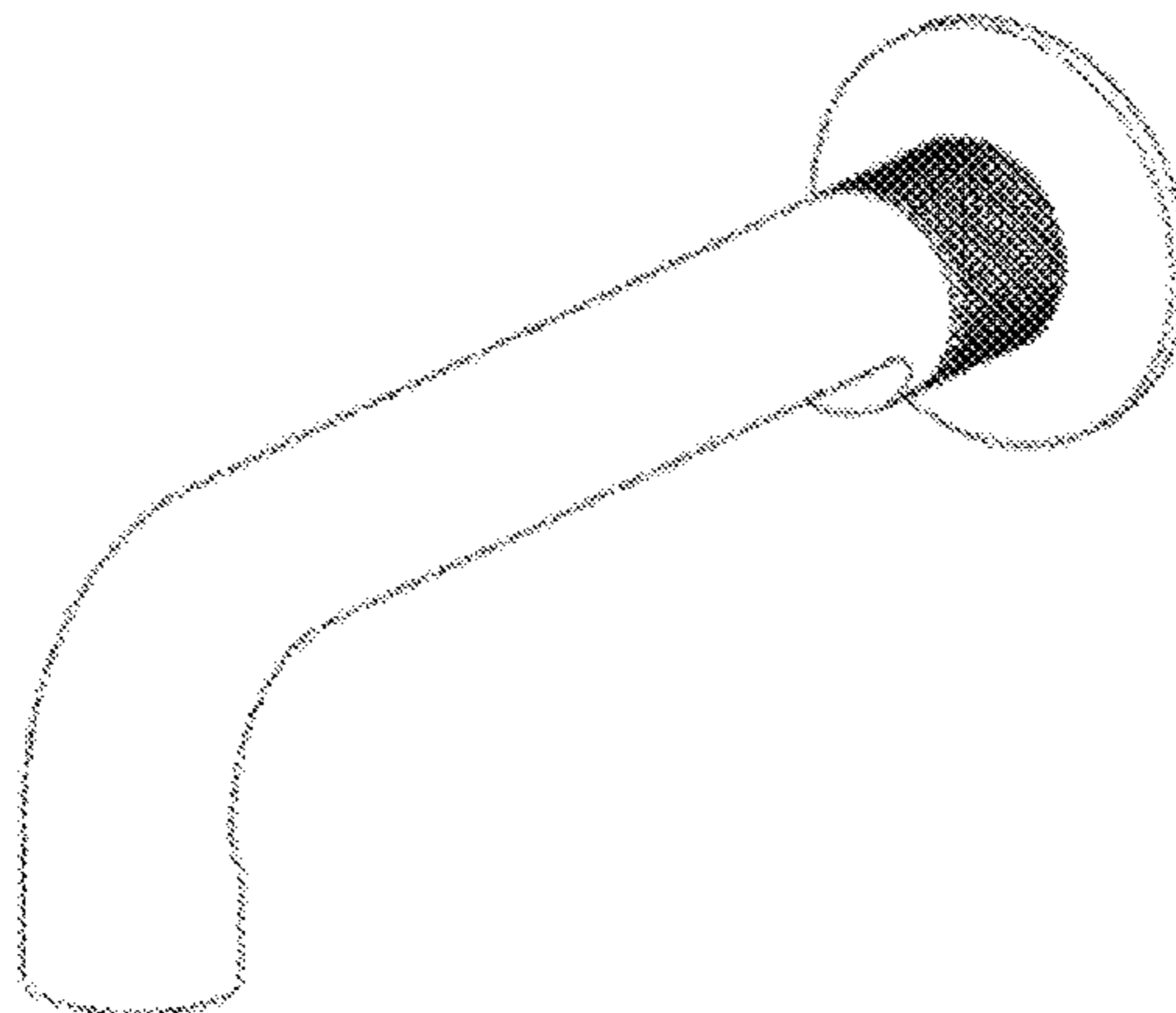
FIG. 2.4 is a side elevation view thereof;

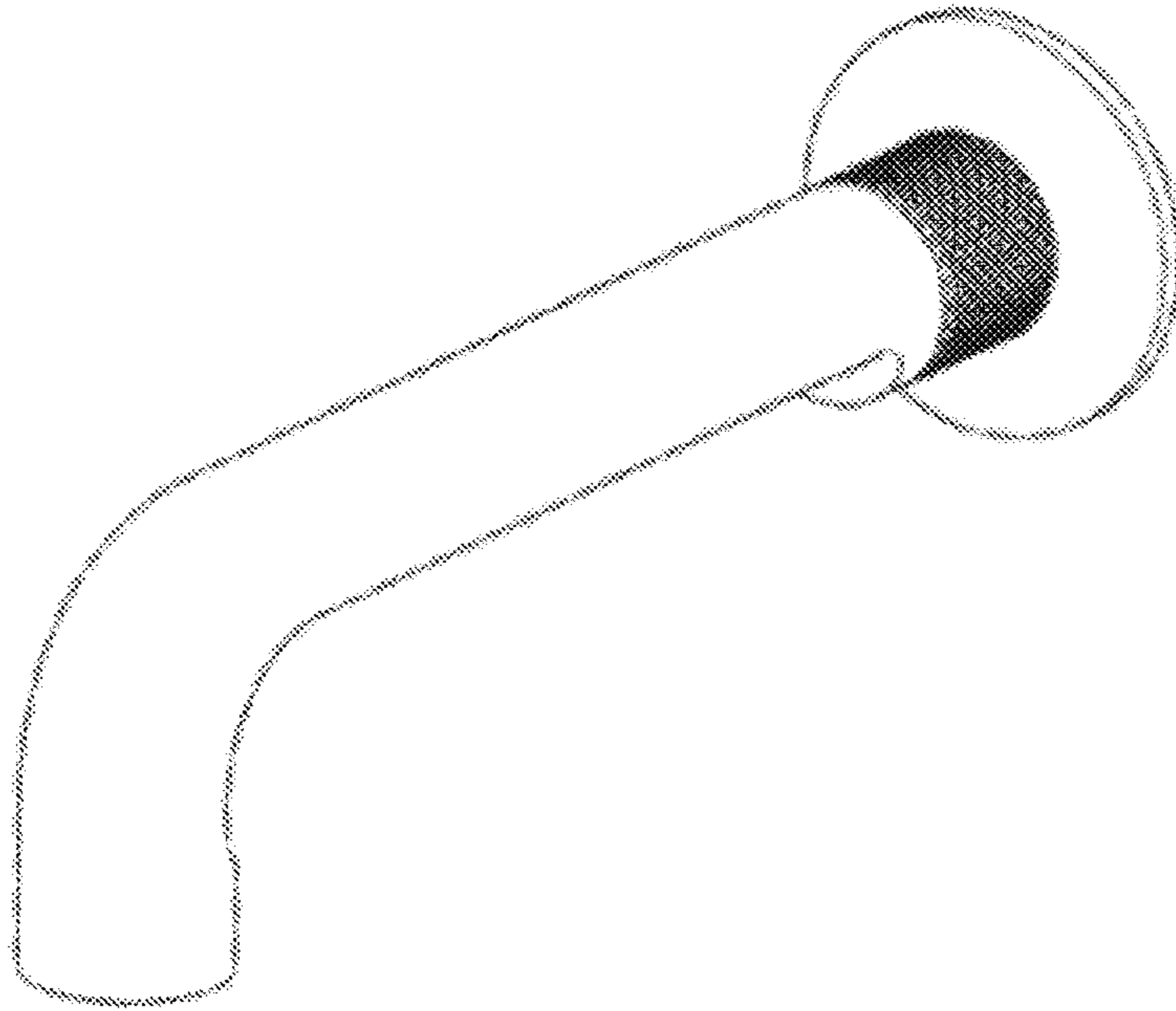

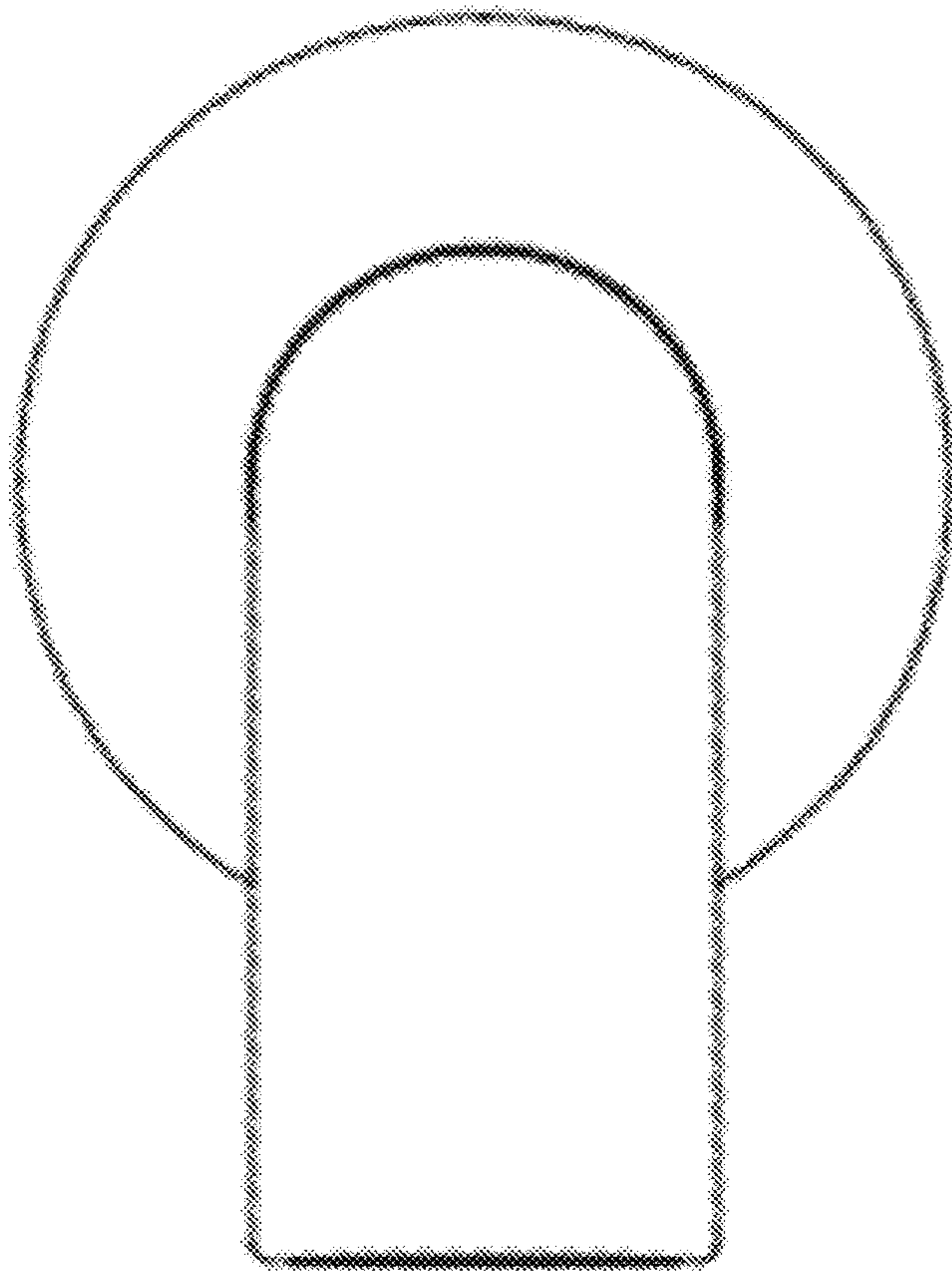

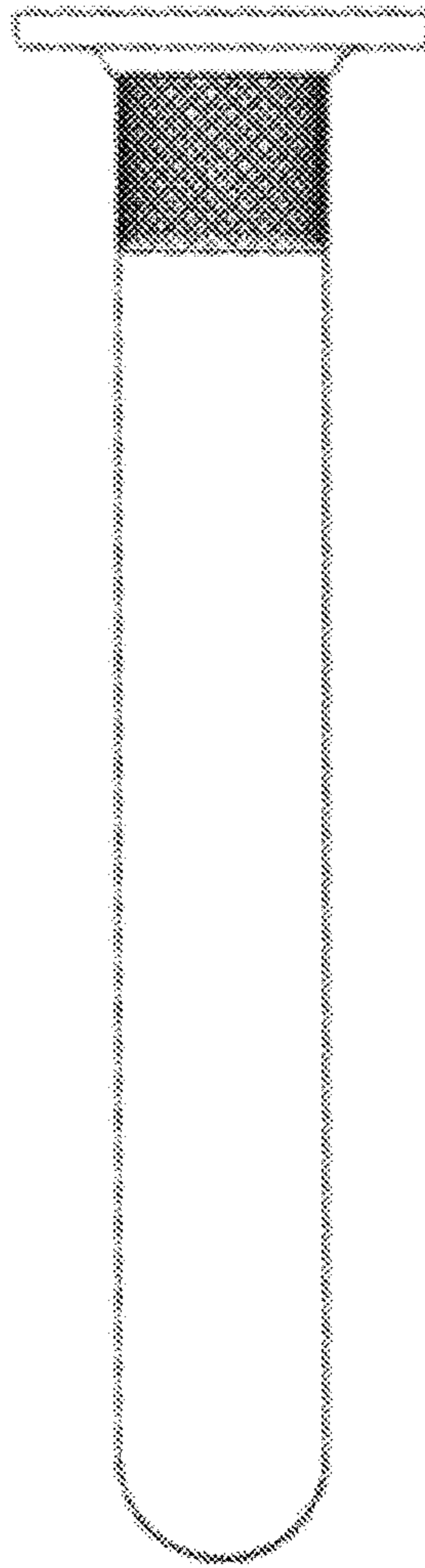

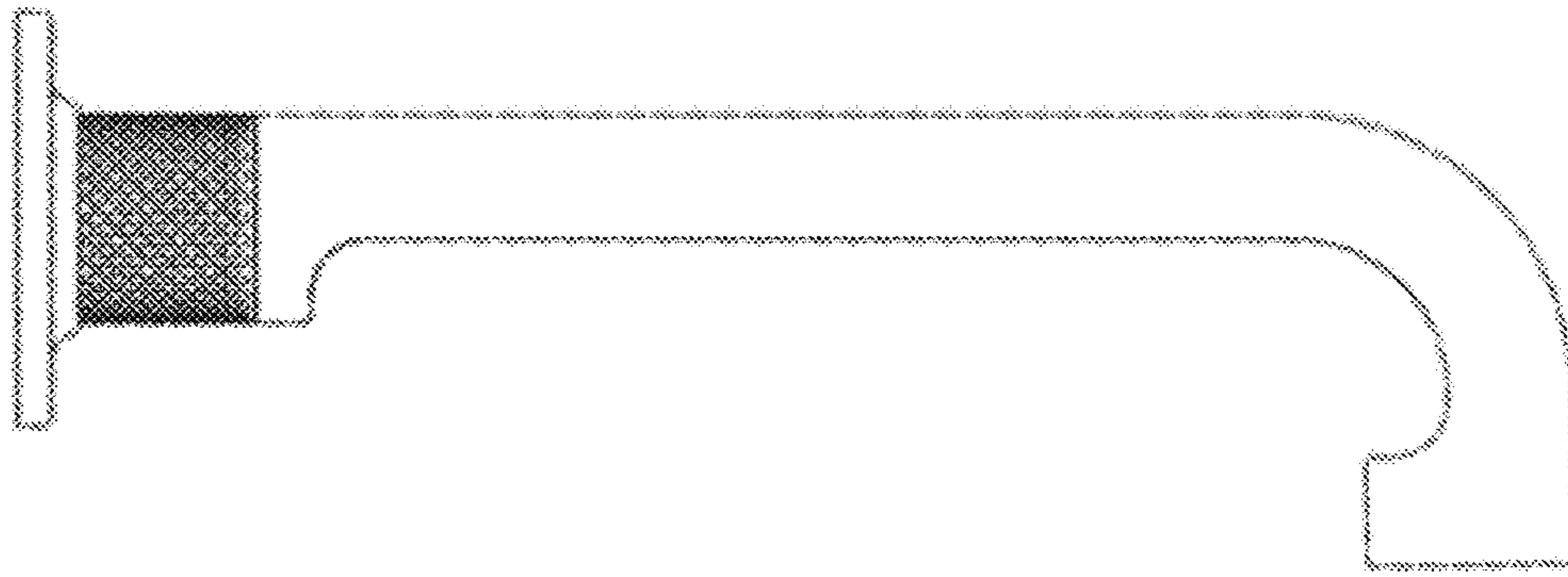

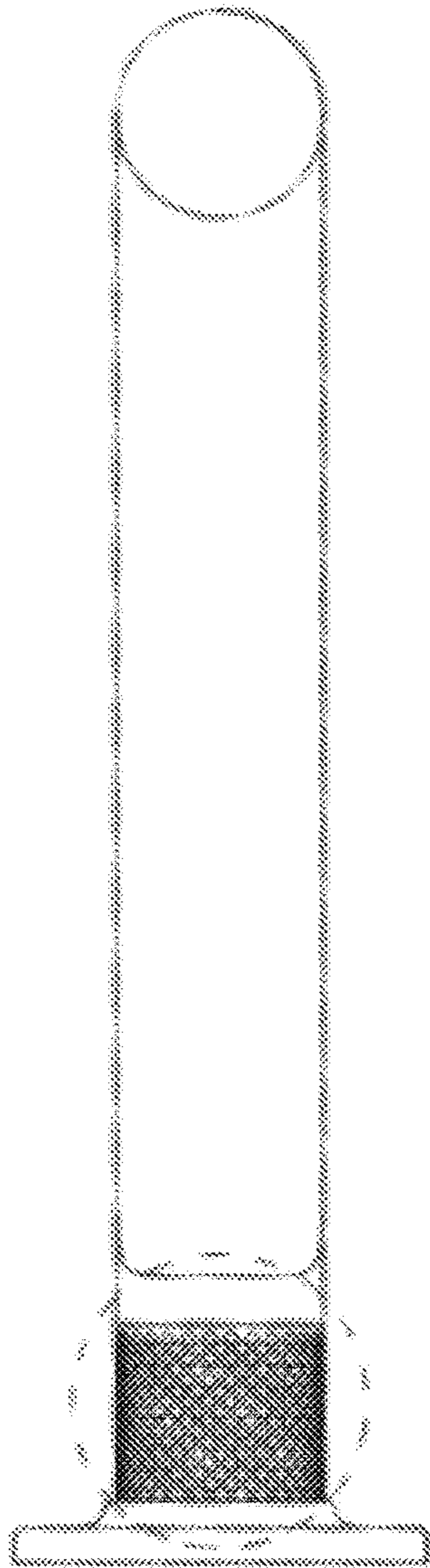

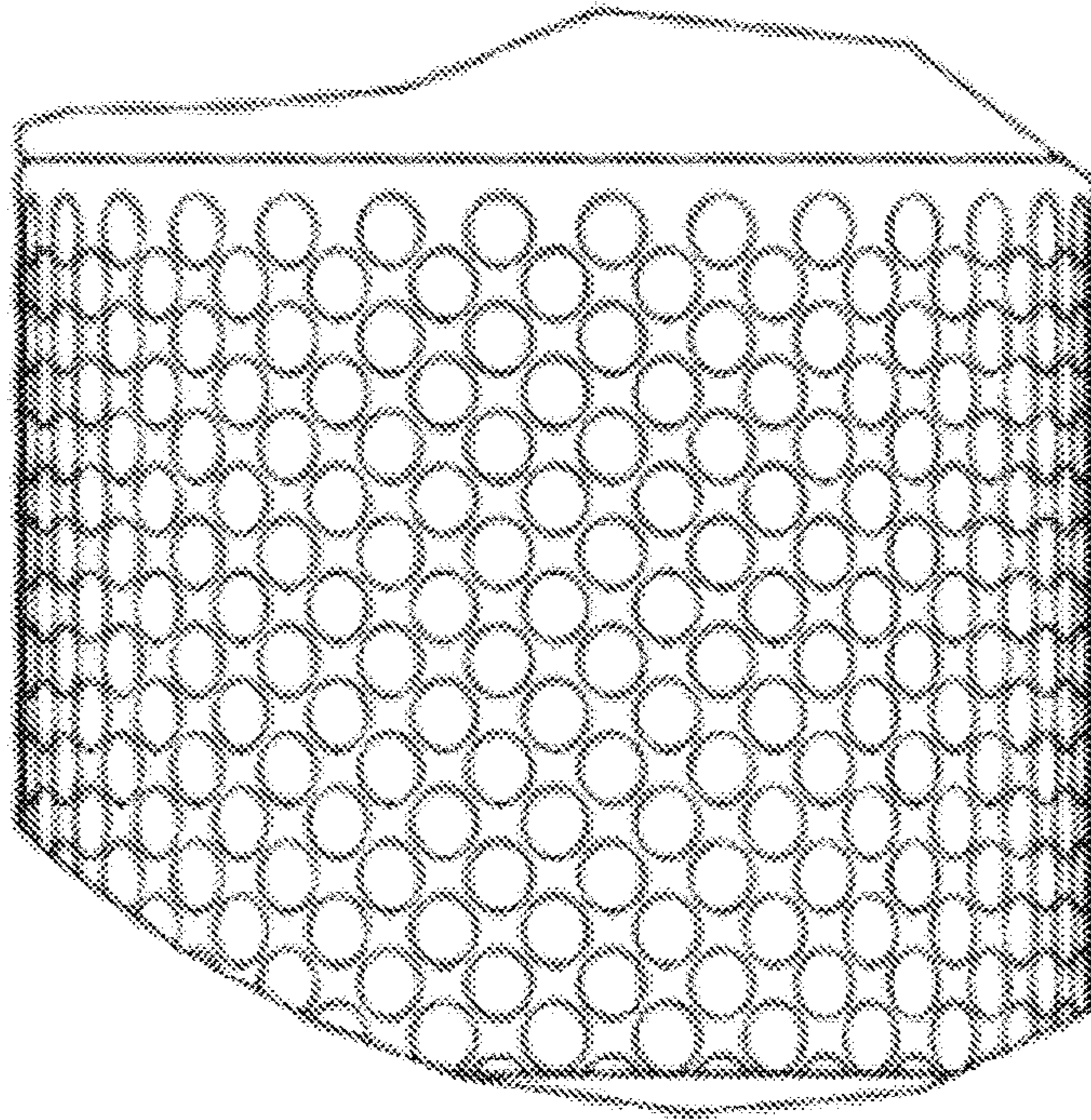

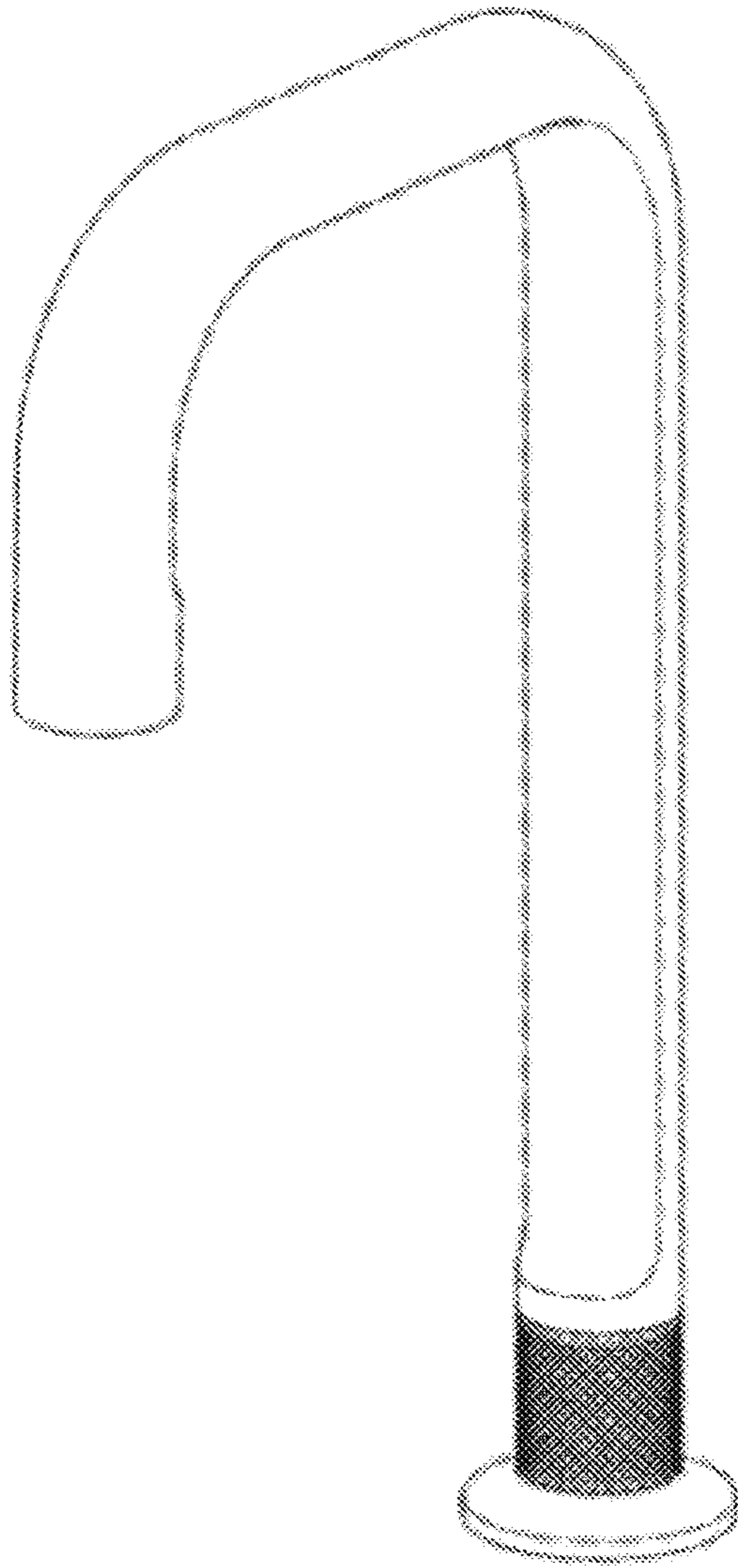

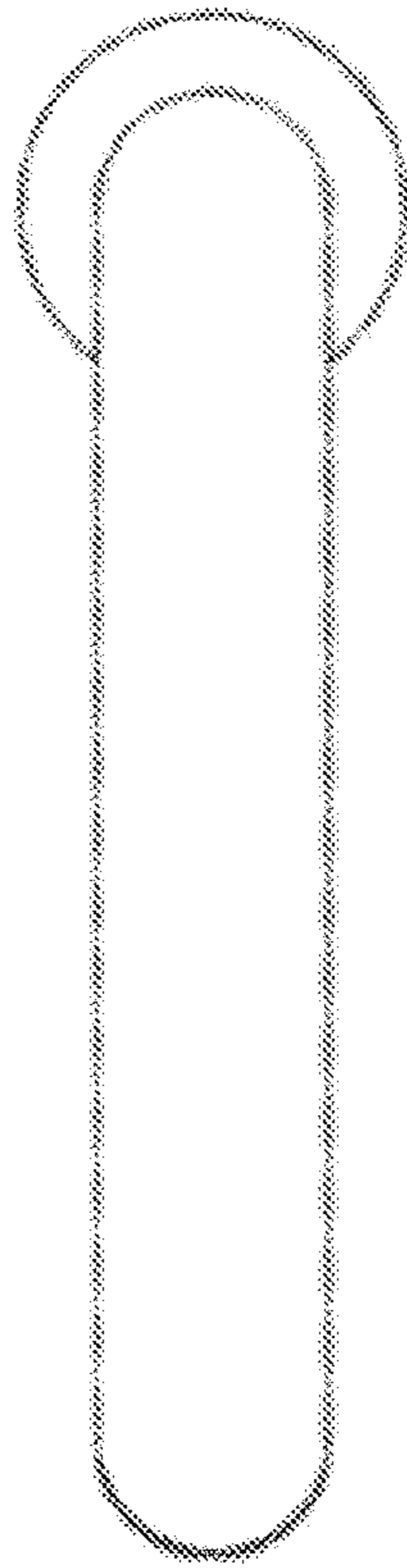

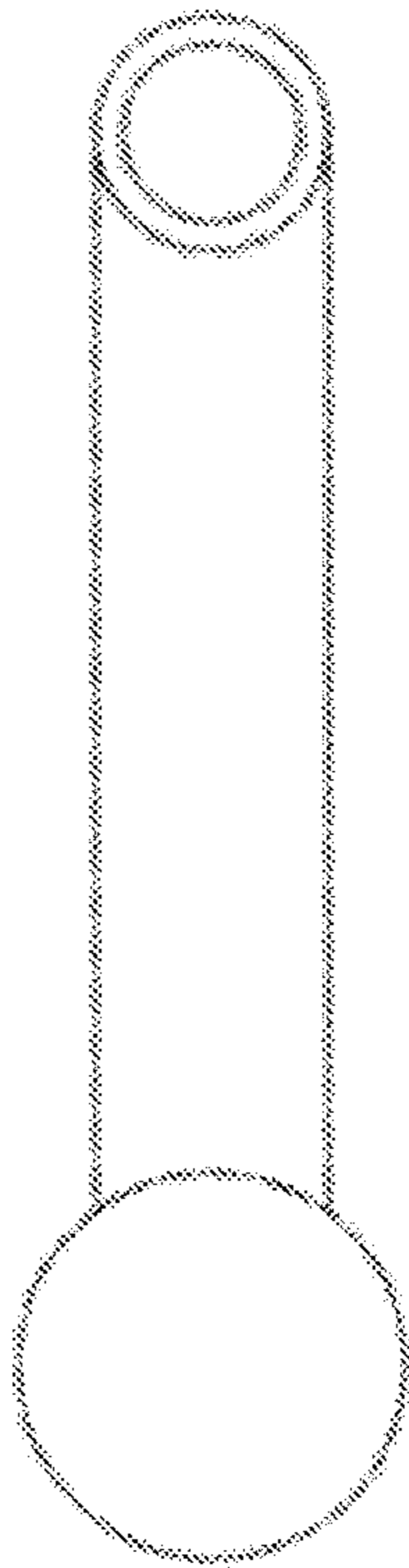

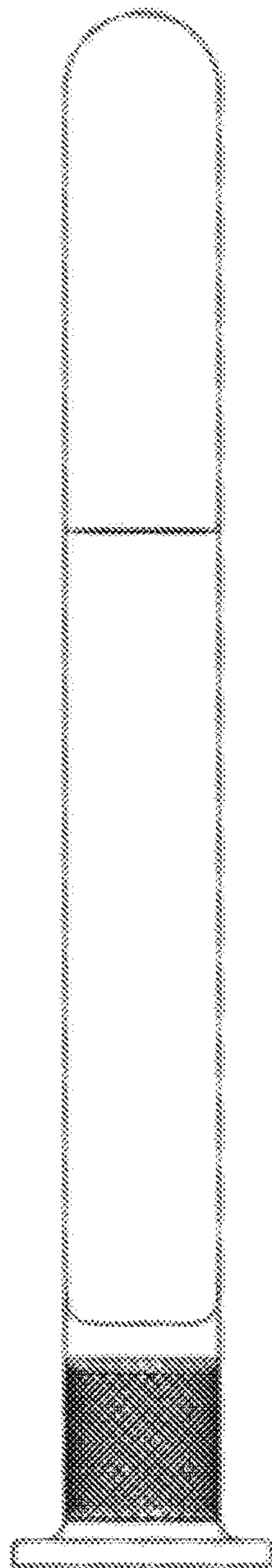

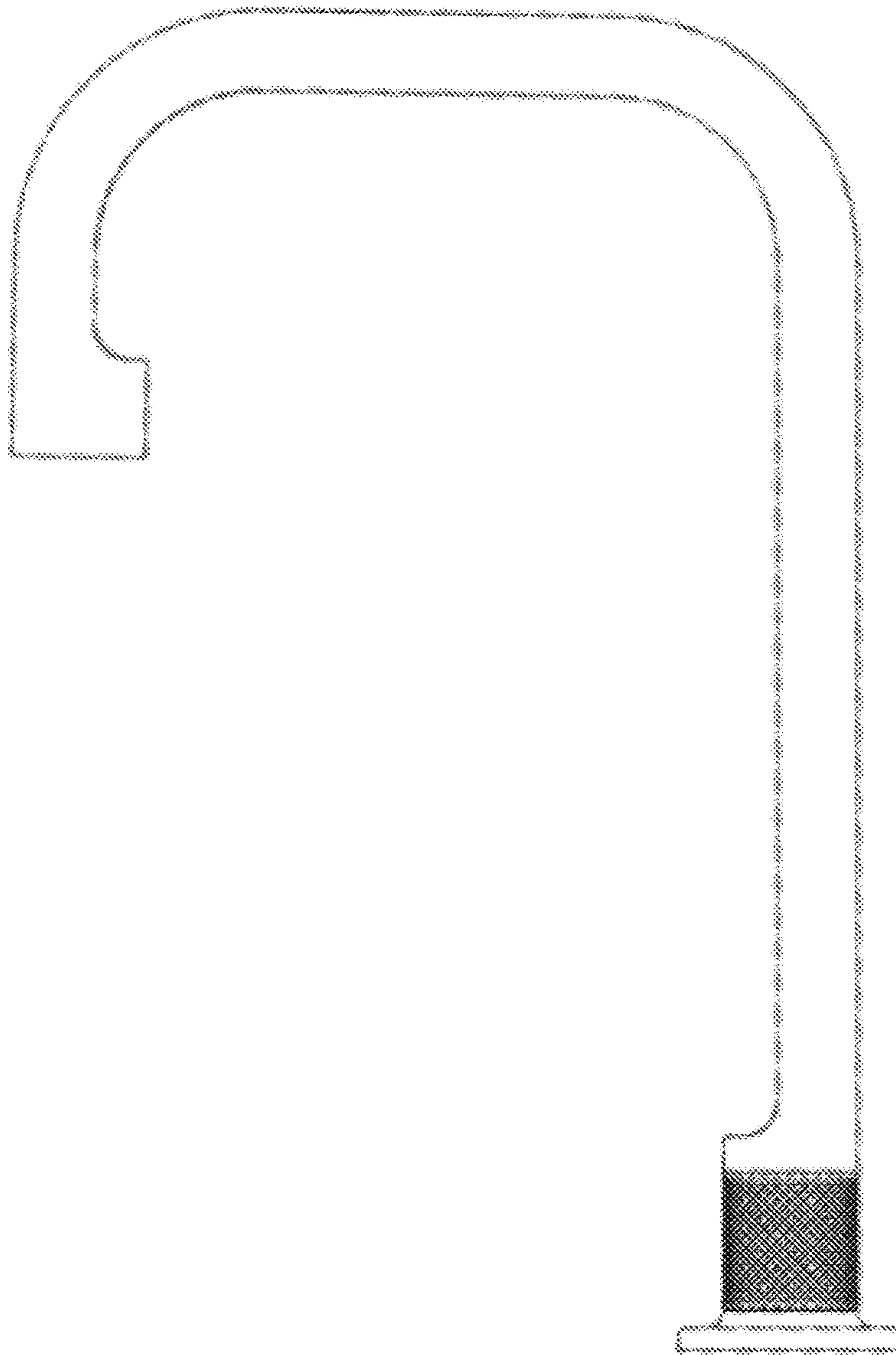

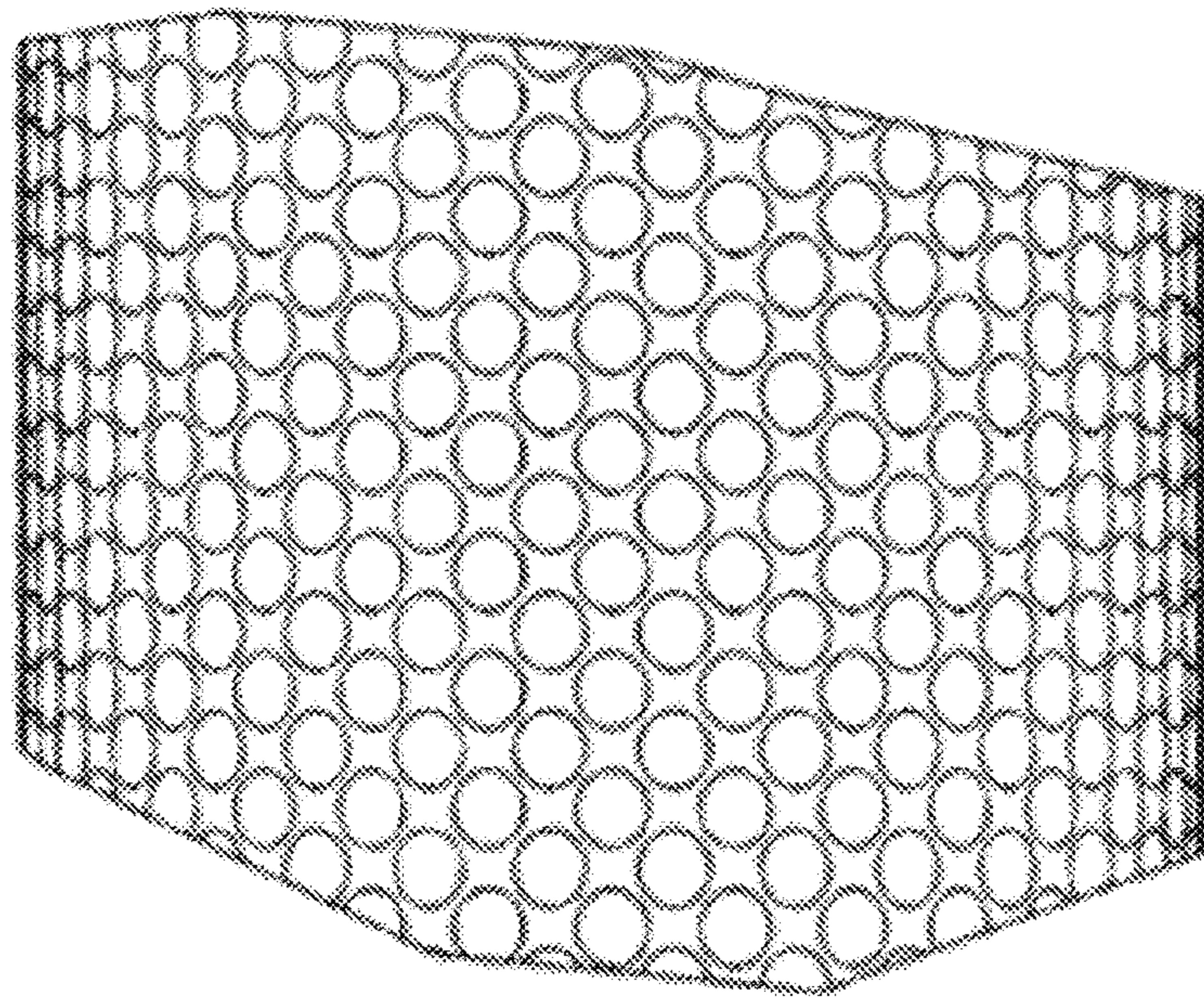
