We claim the ornamental design for a screen mounting tube, as shown and described.

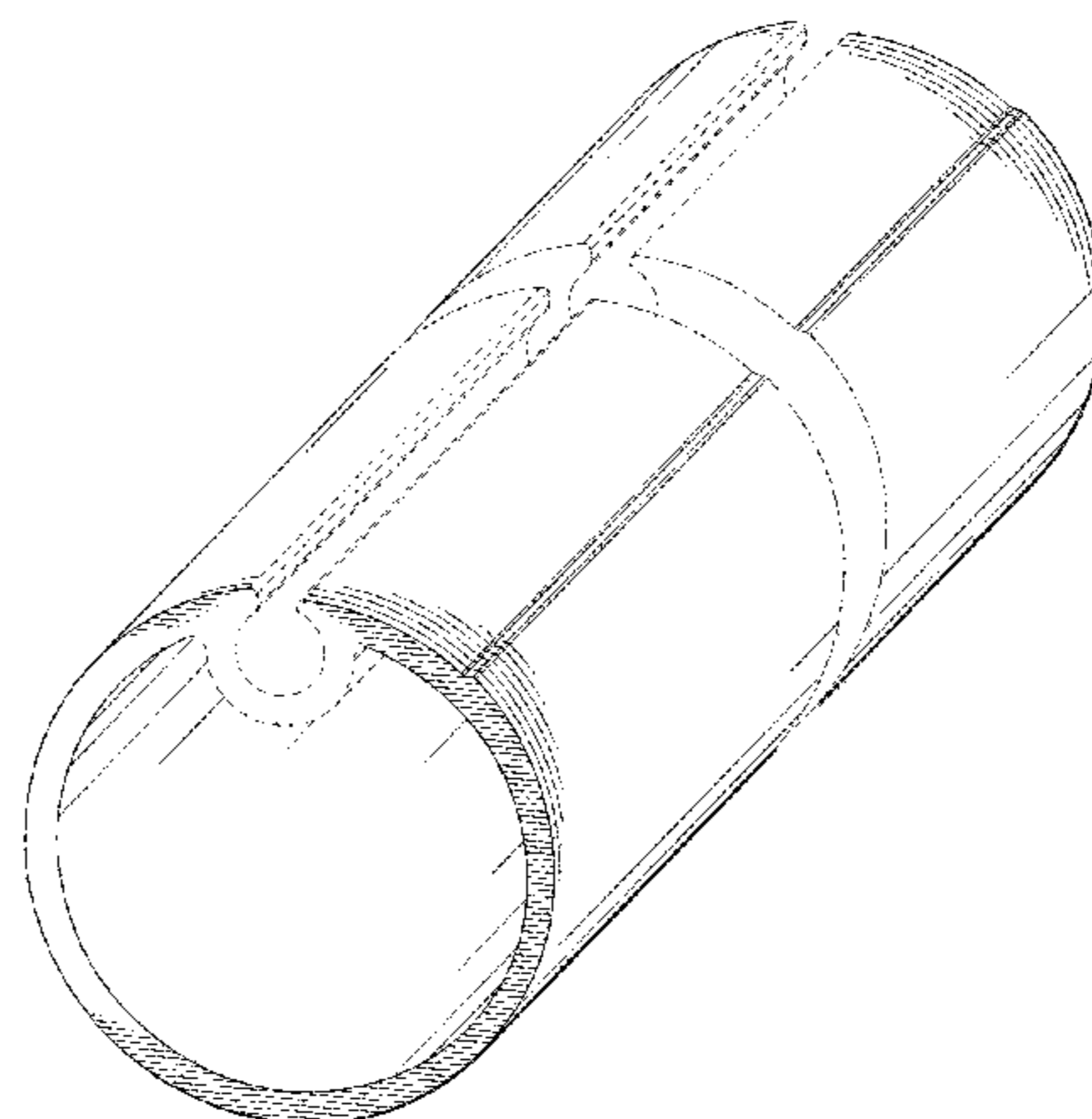
DESCRIPTION

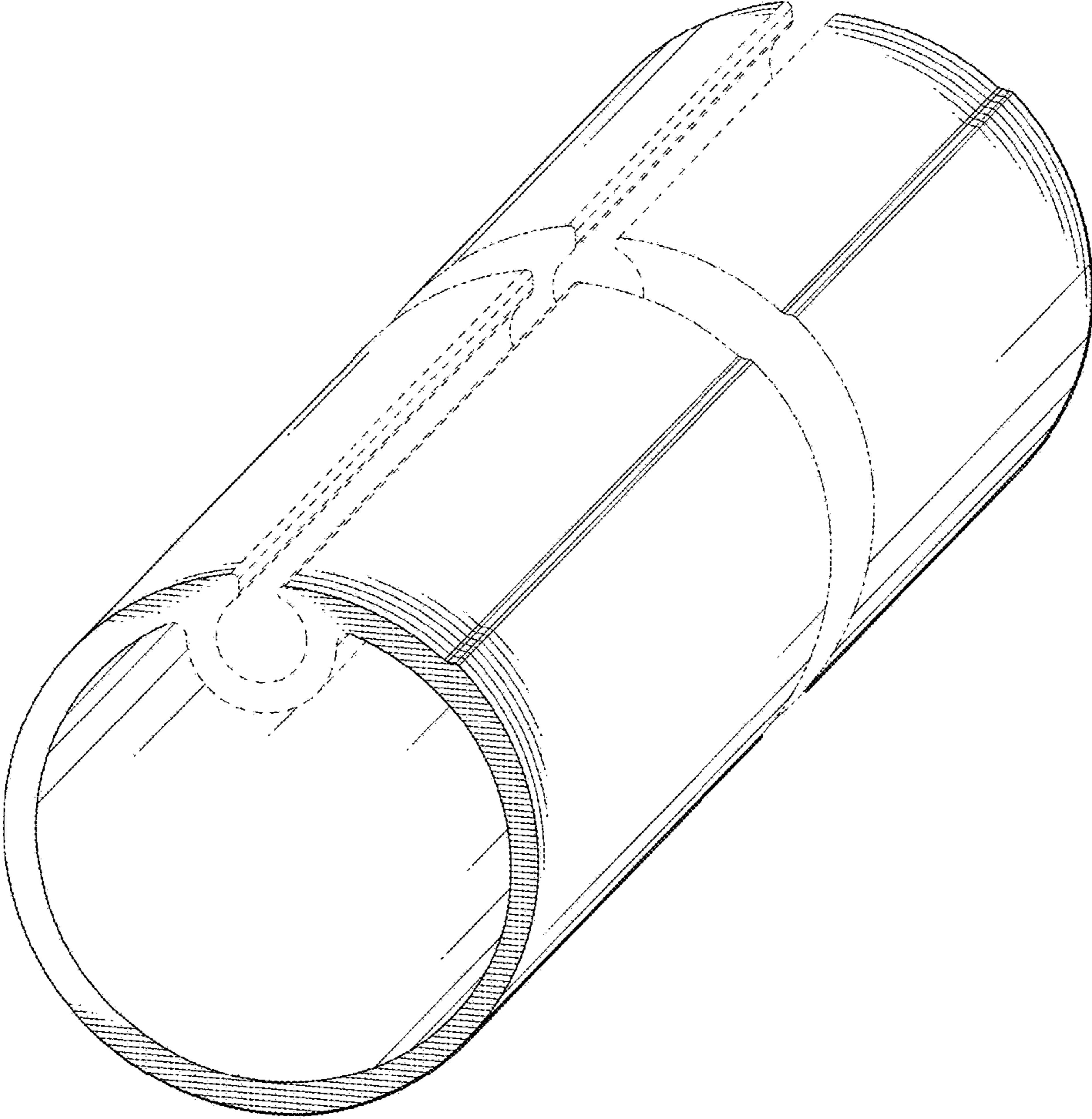

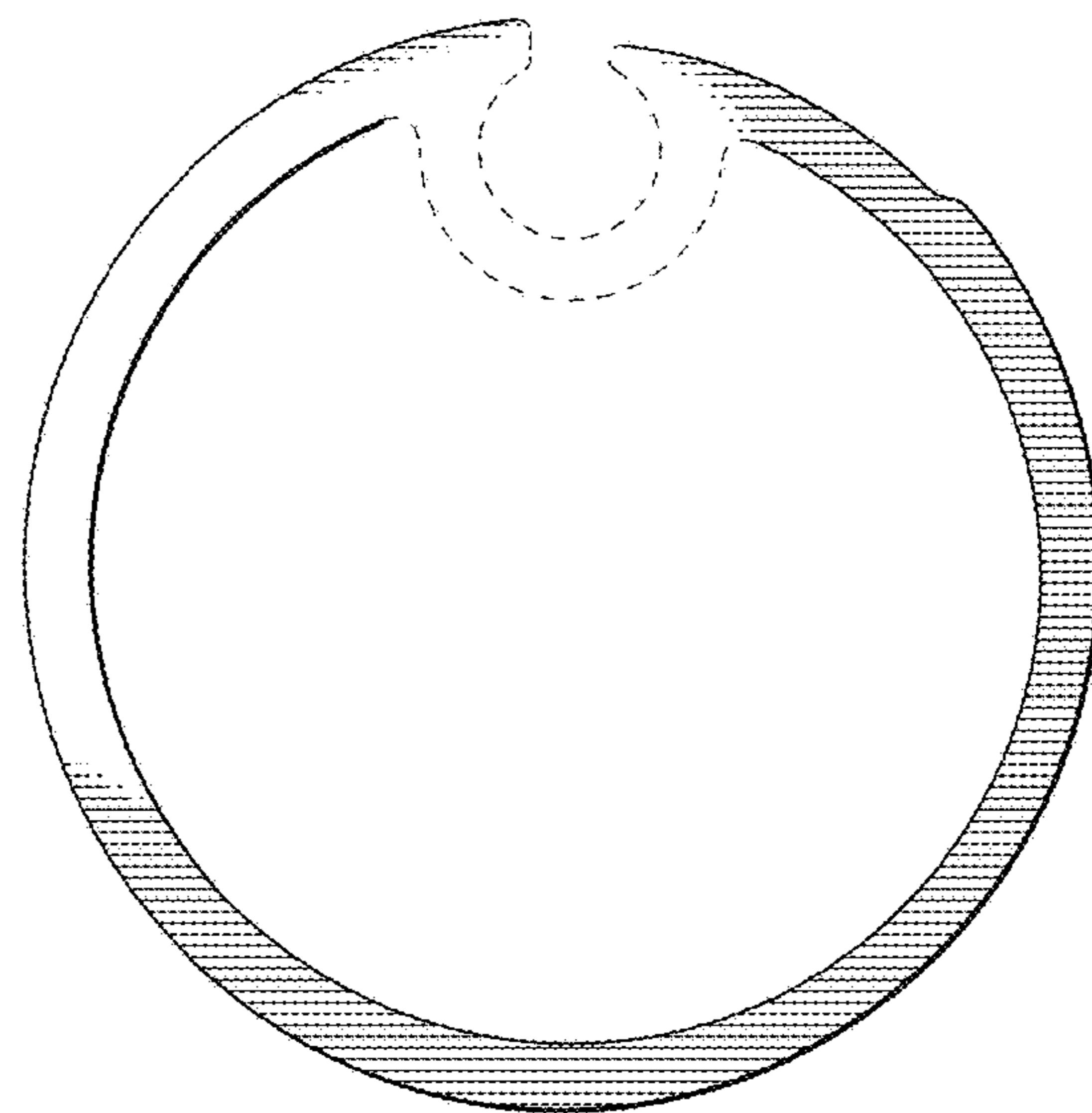

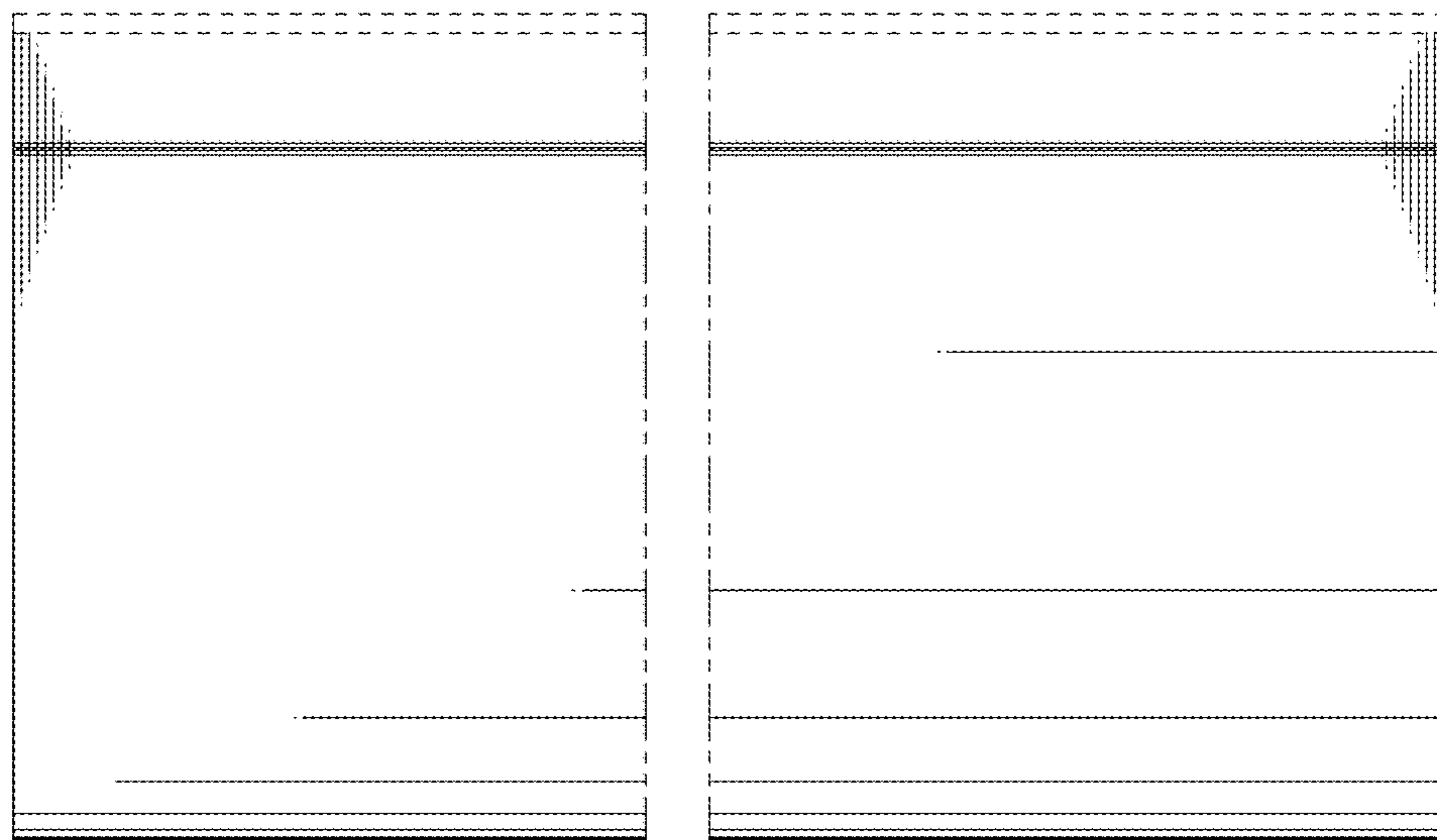

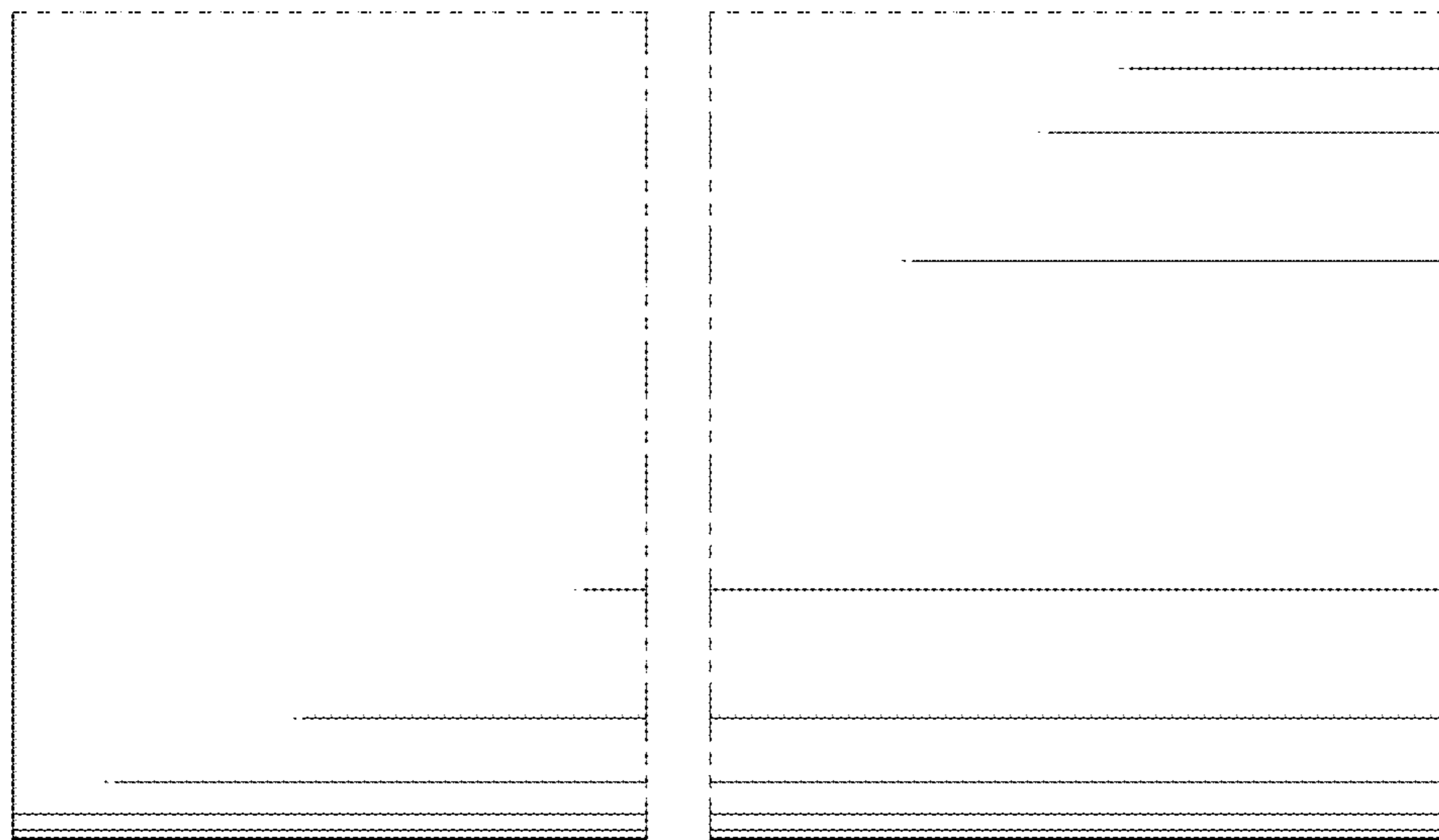

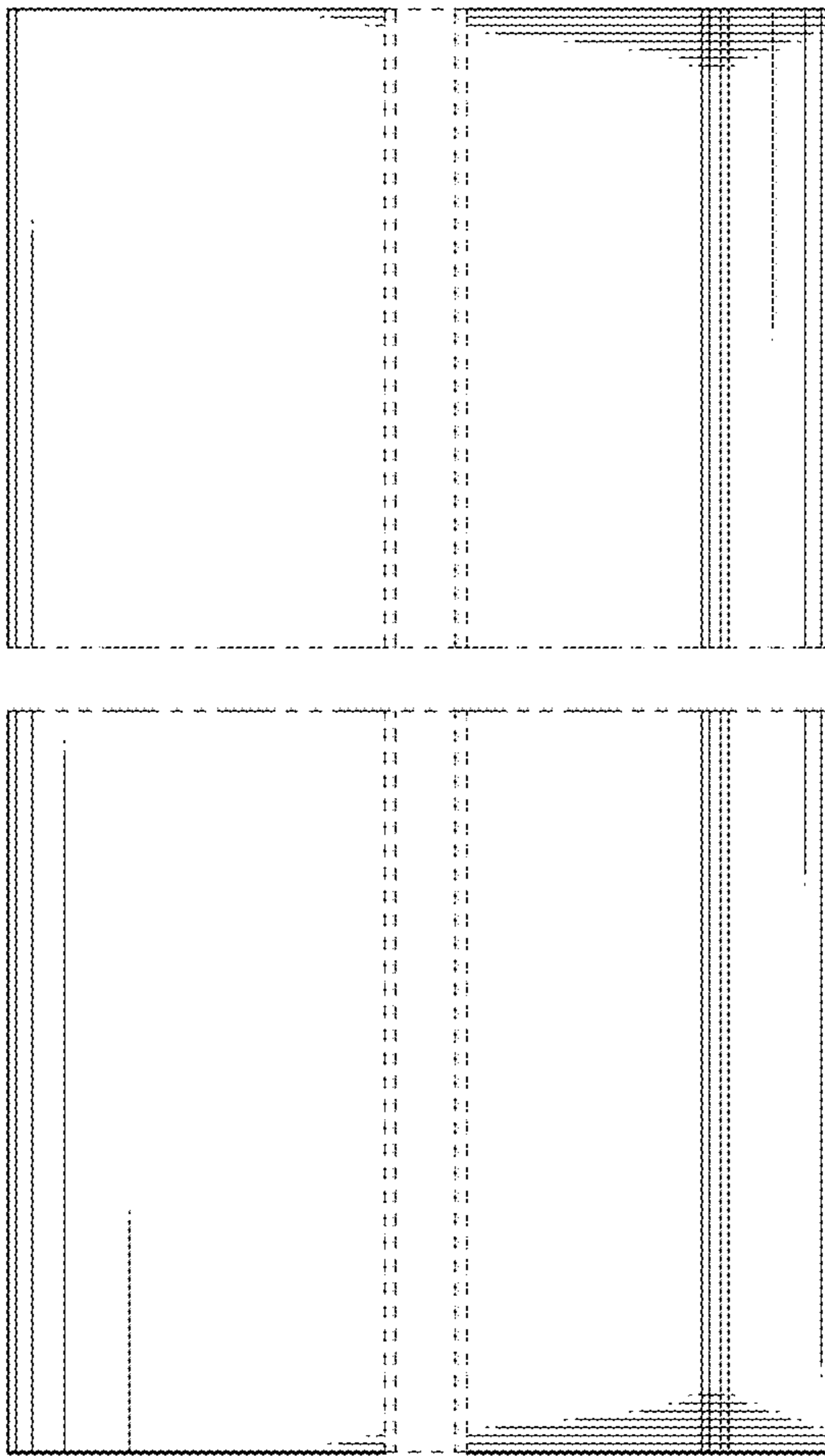

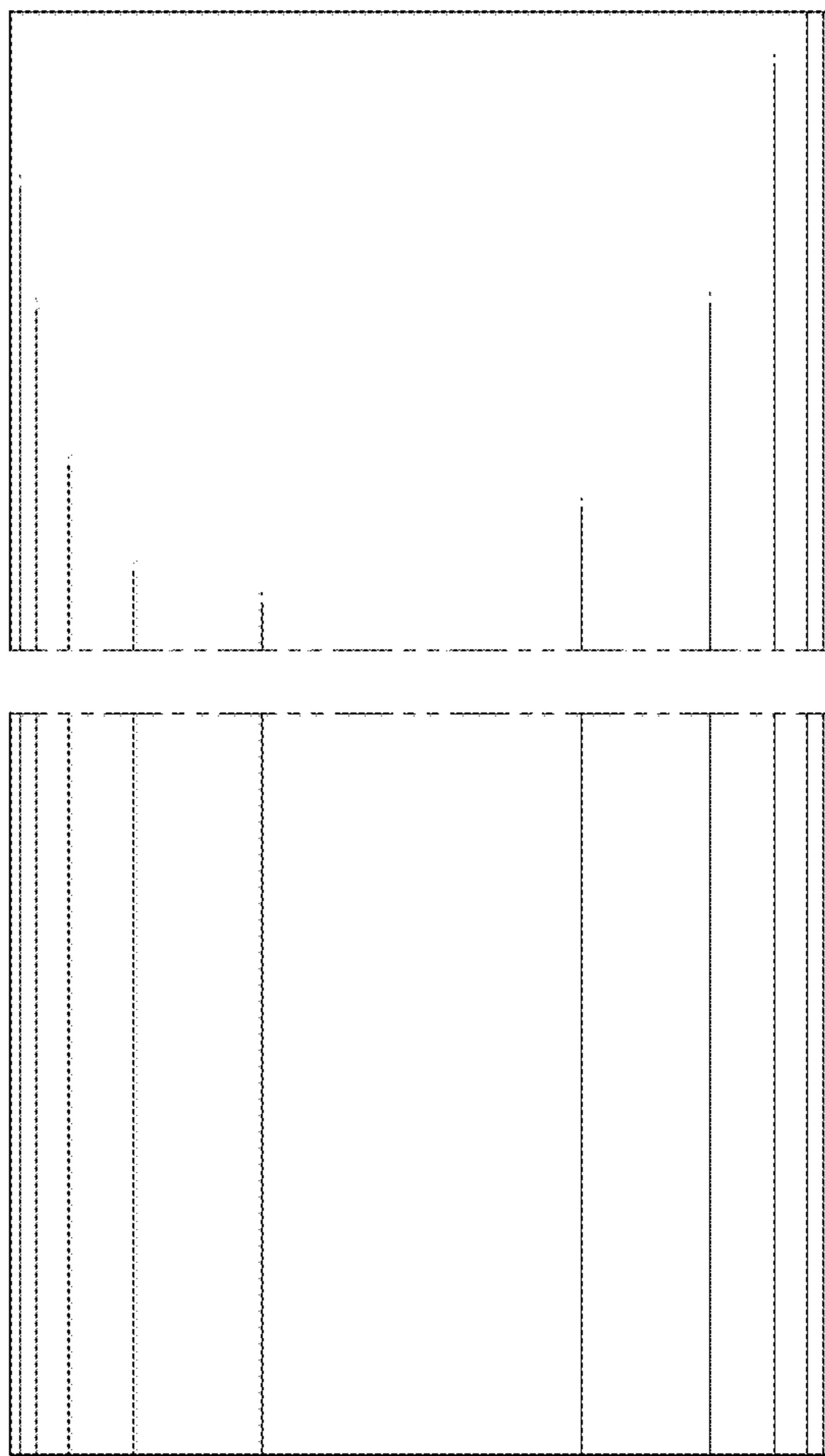

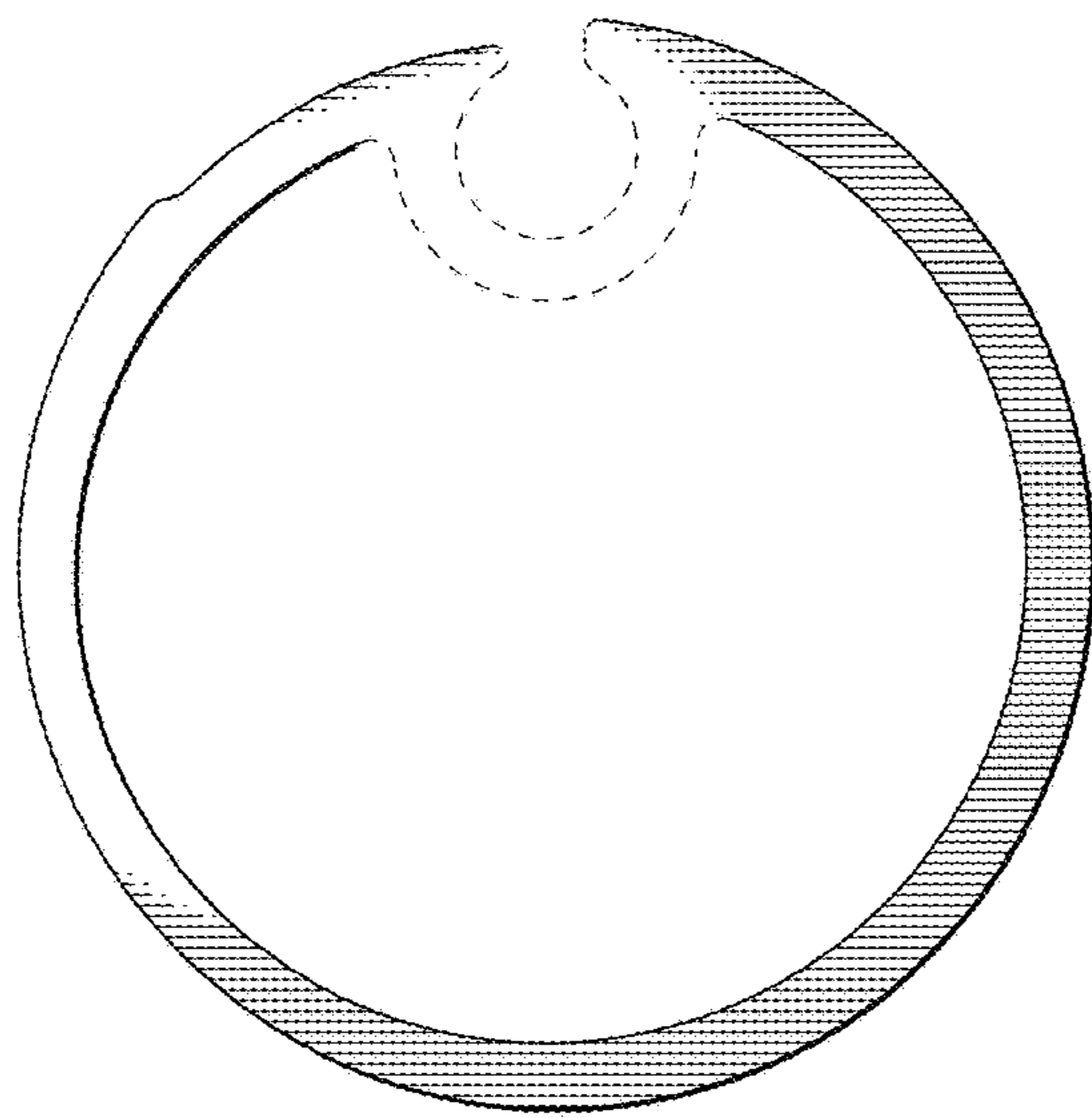
