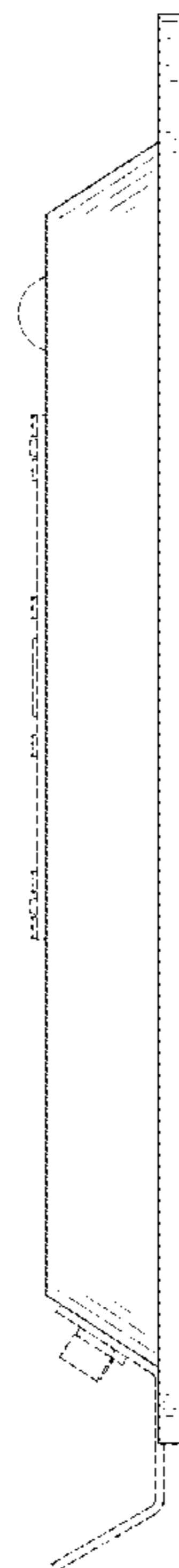
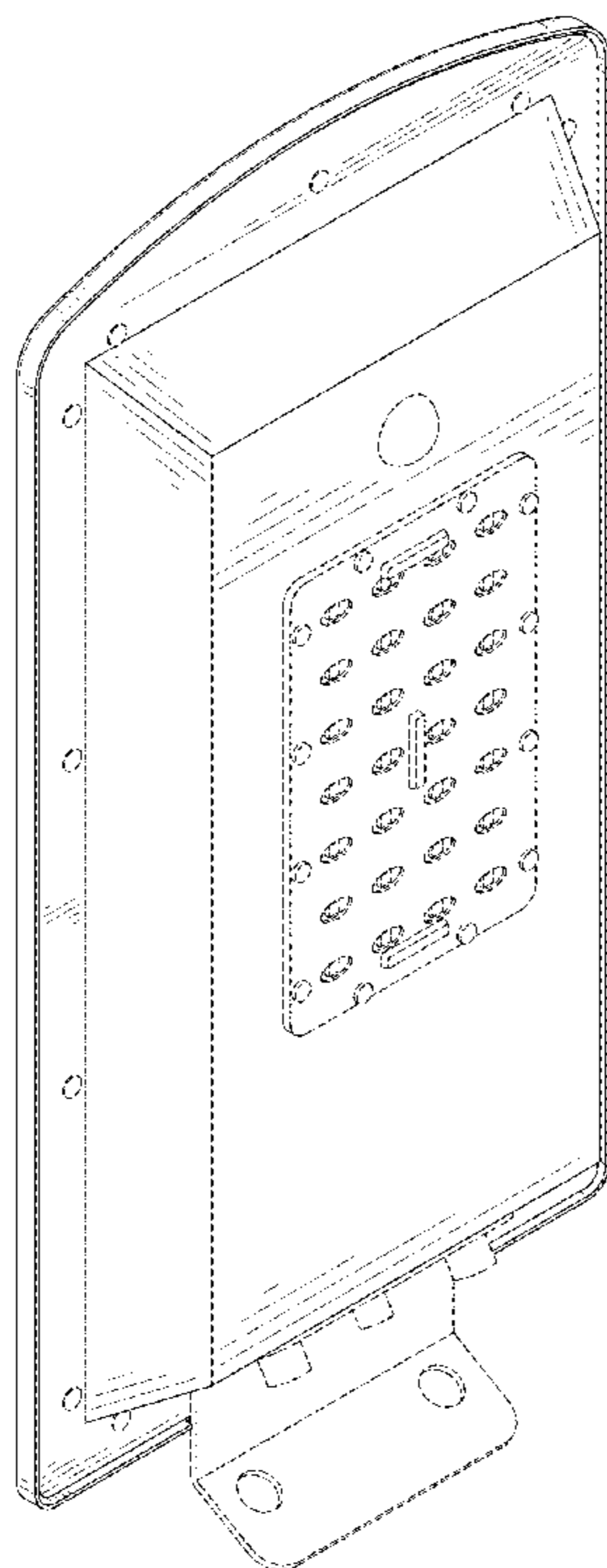
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of the solar lamp showing the claimed new design;

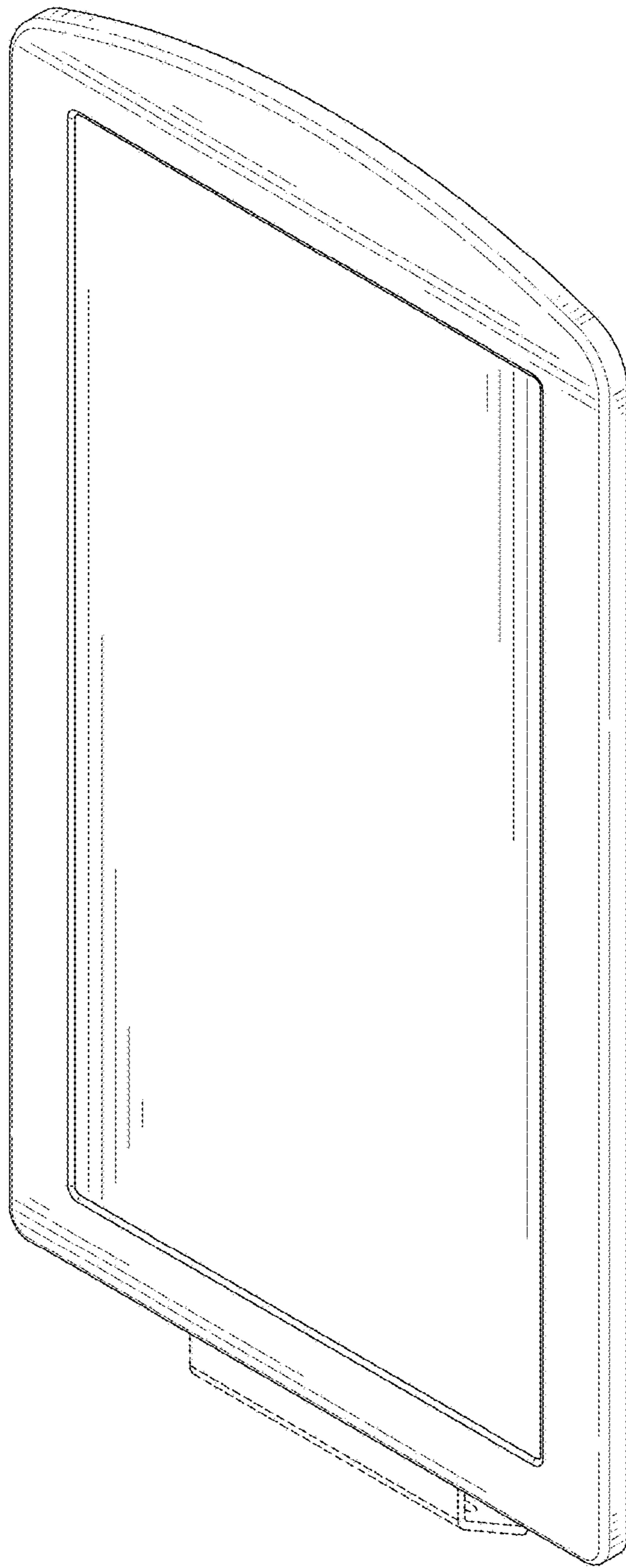

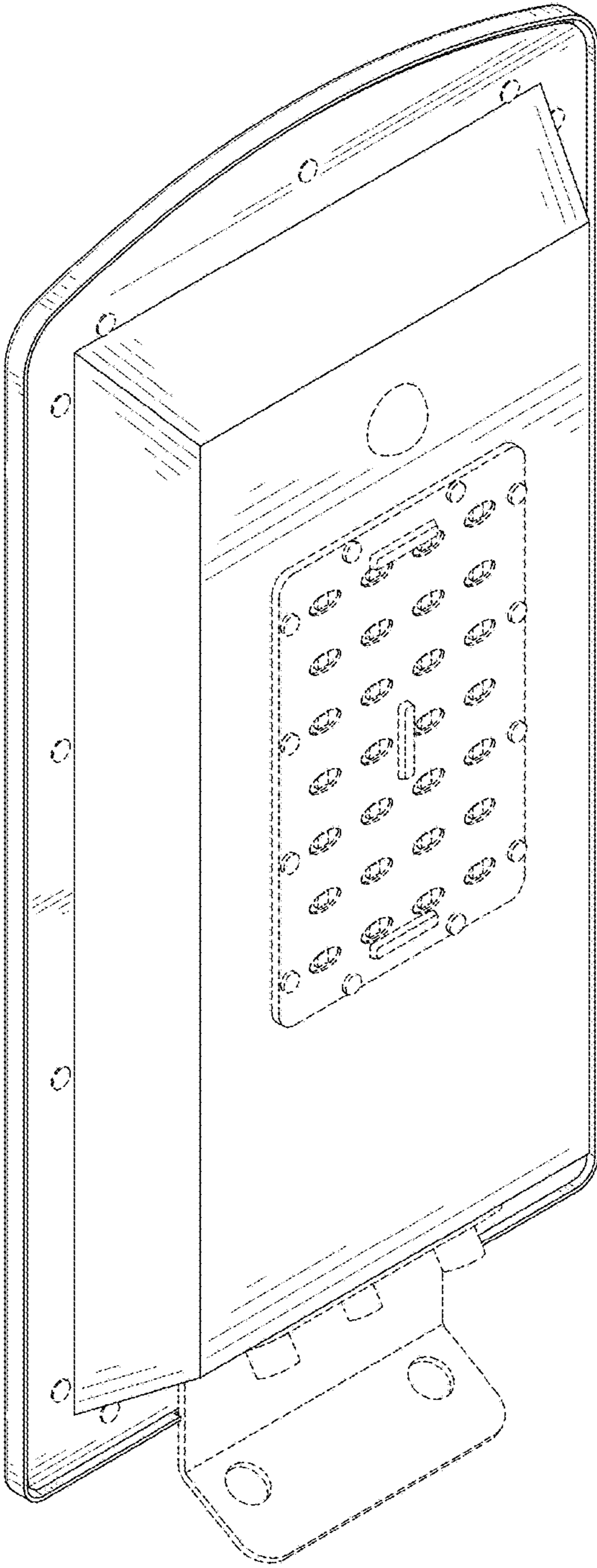

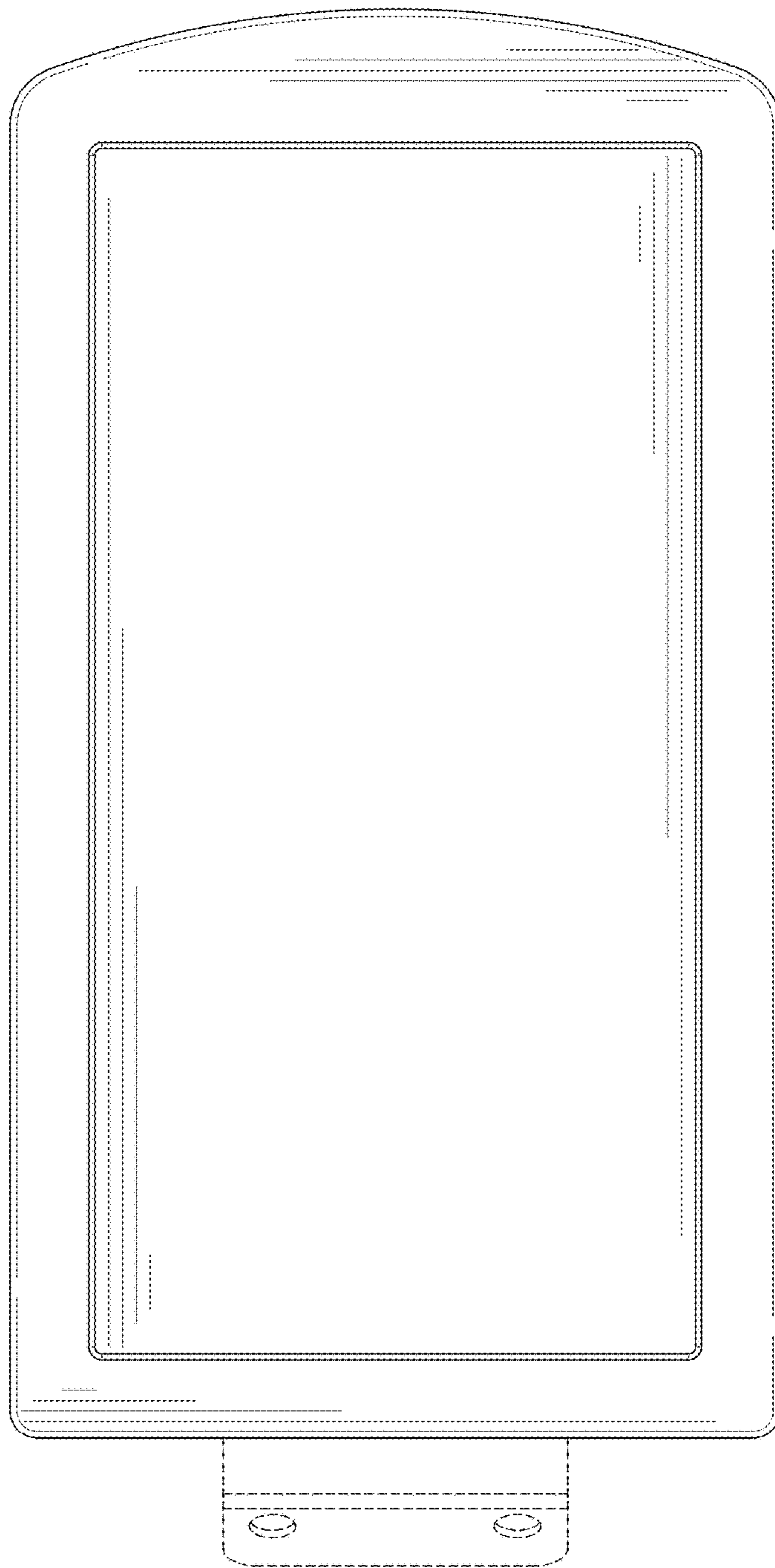

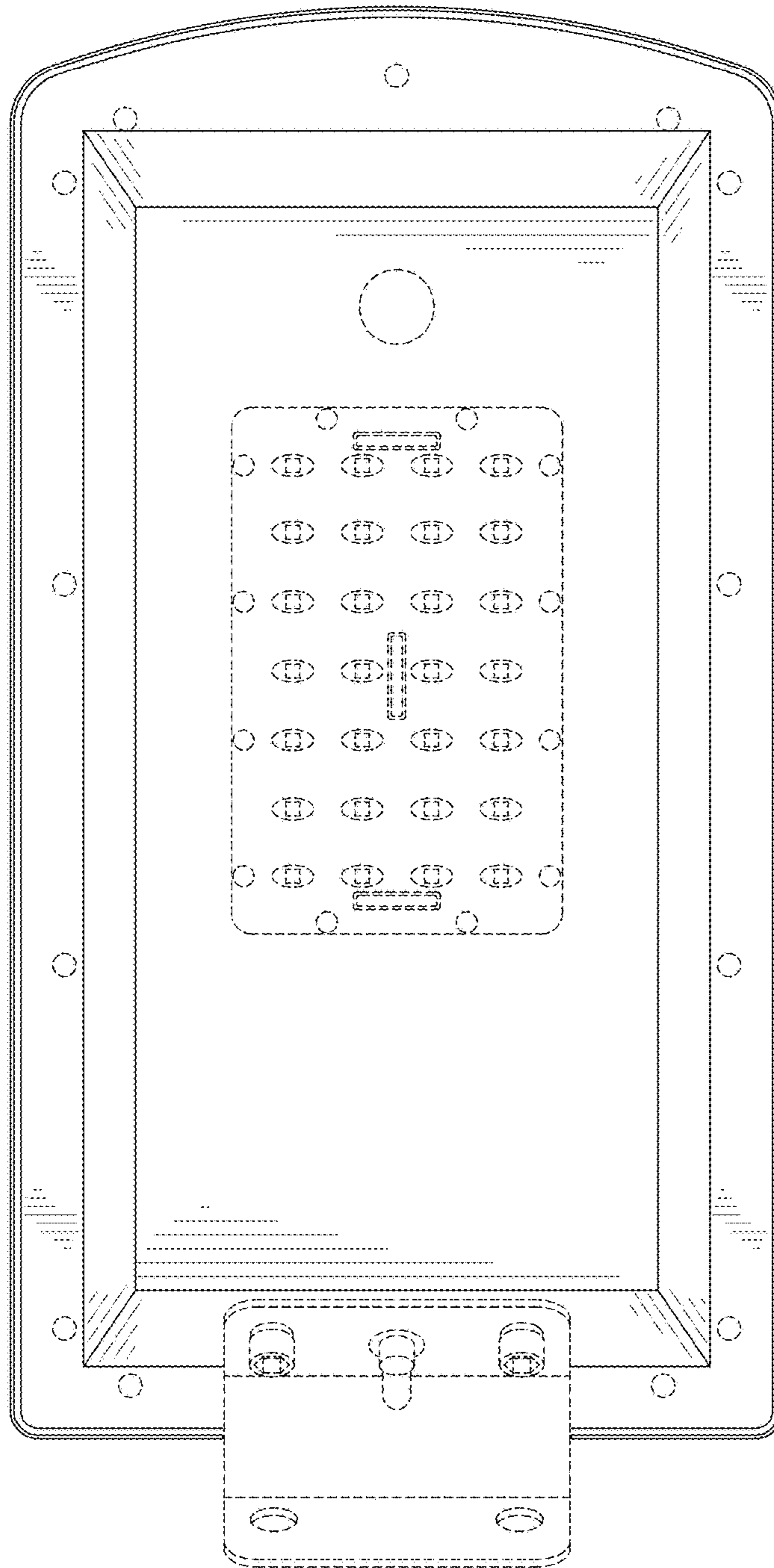

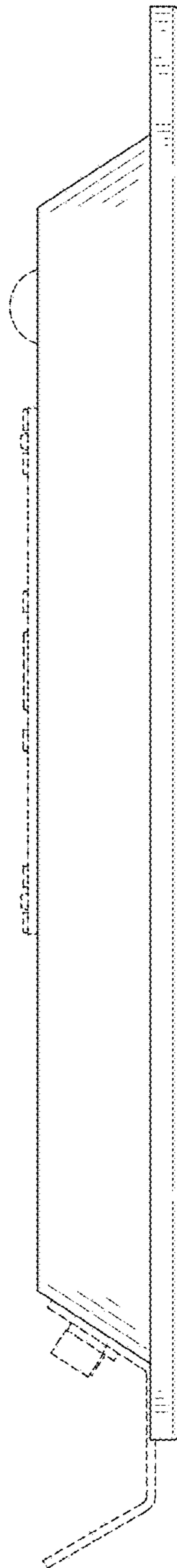

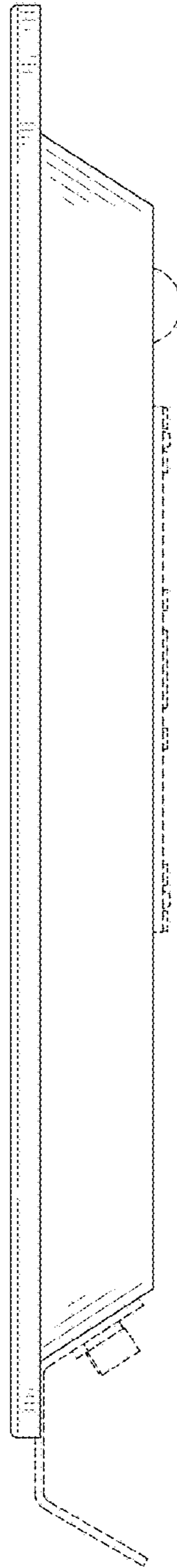

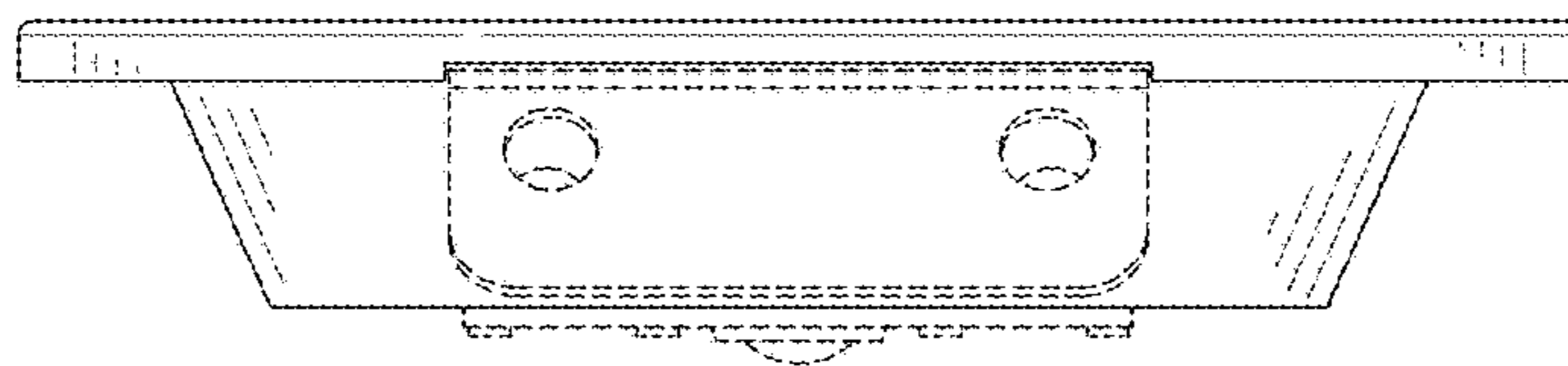
