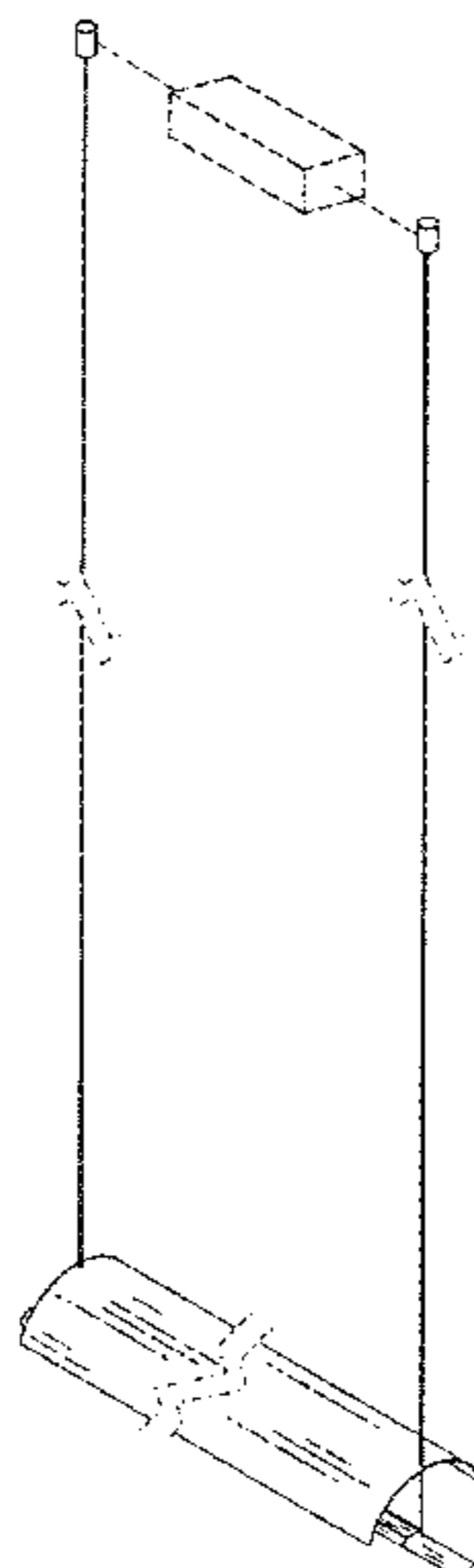

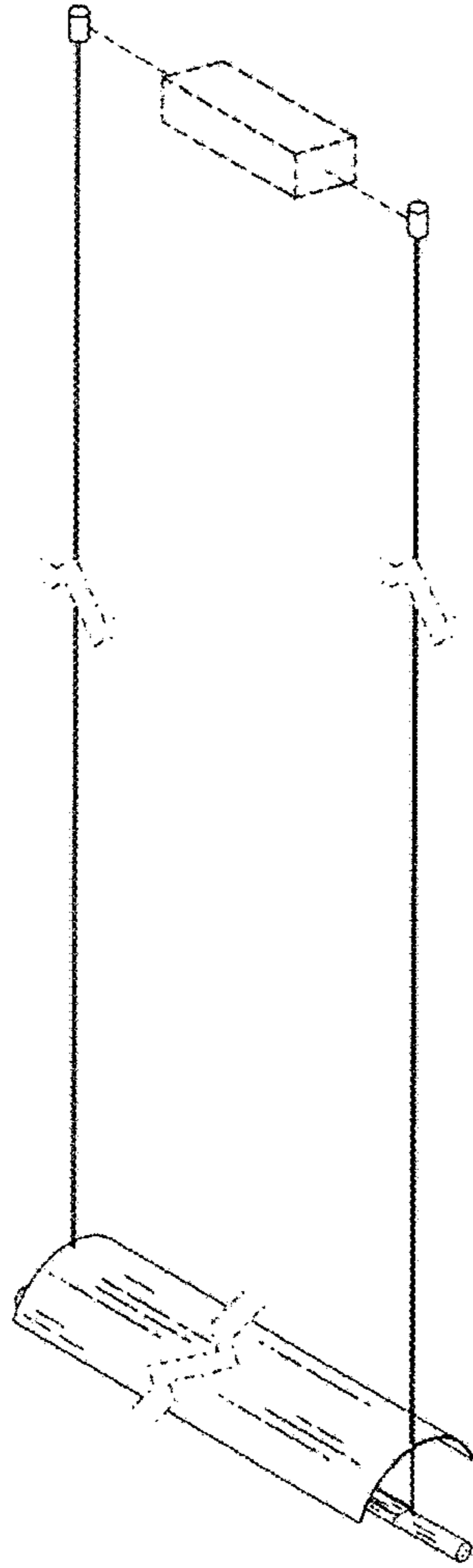

The dot-dash broken line break lines in the drawings indicate that the appearance of any portion of the lamp between the break lines forms no part of the claimed design.

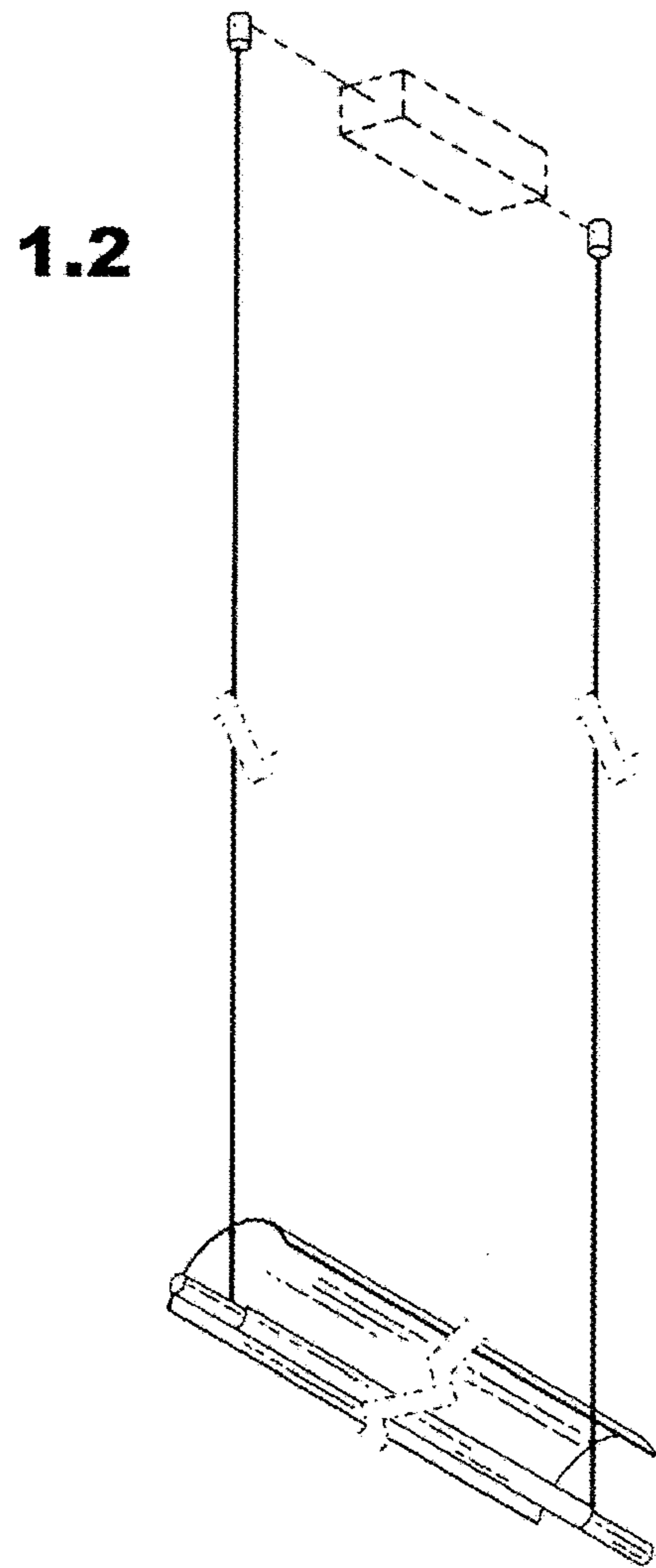

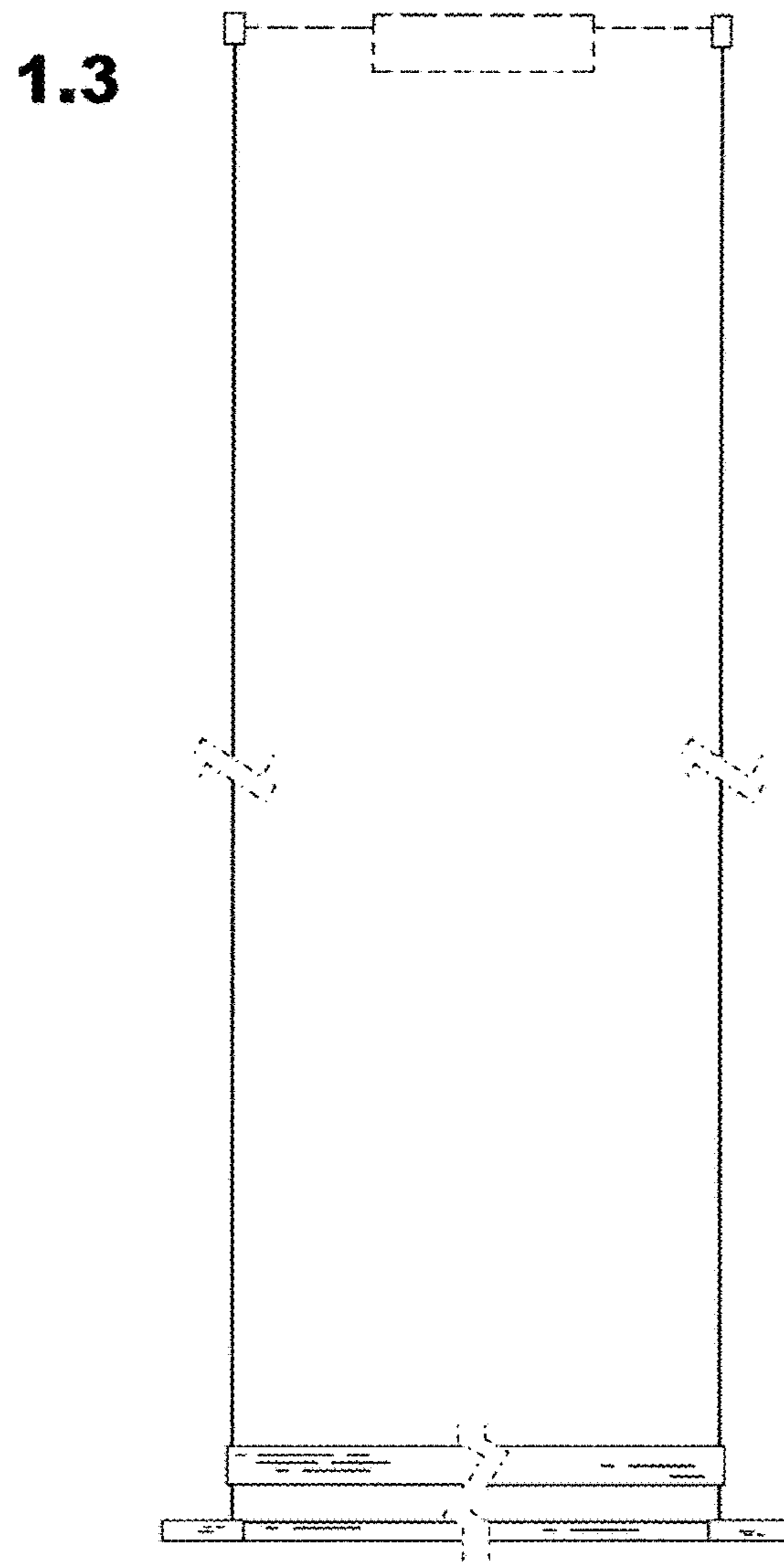

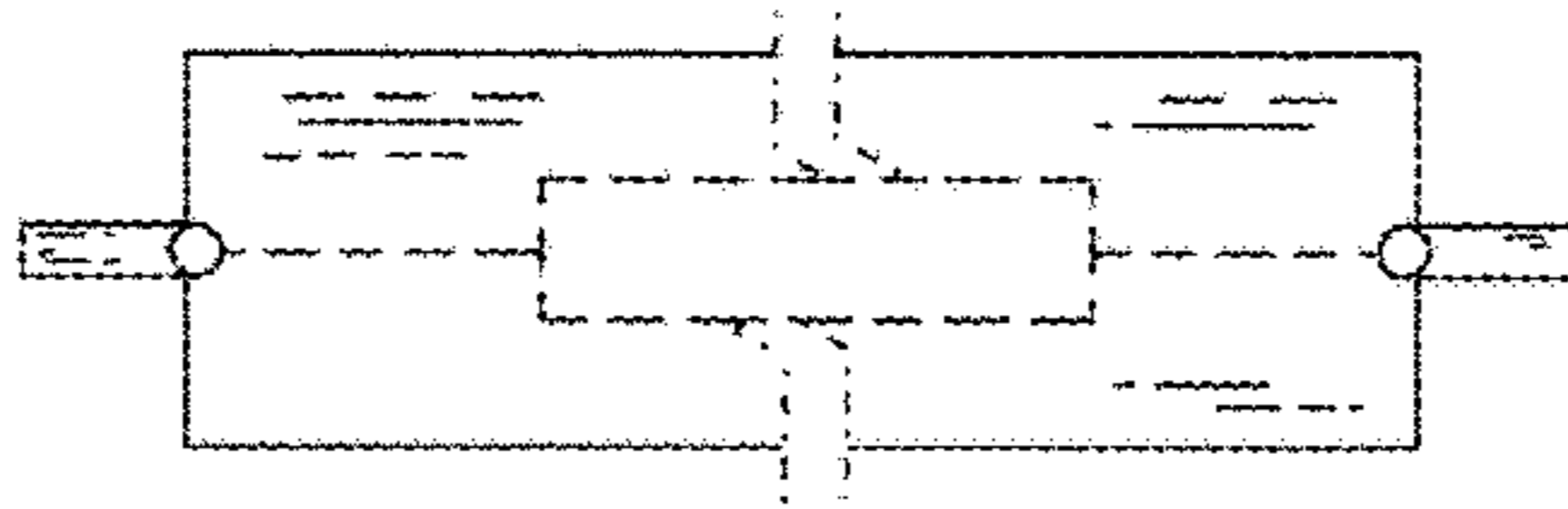




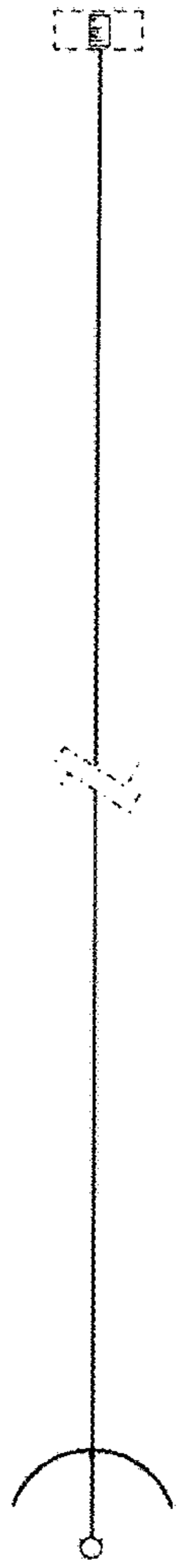
