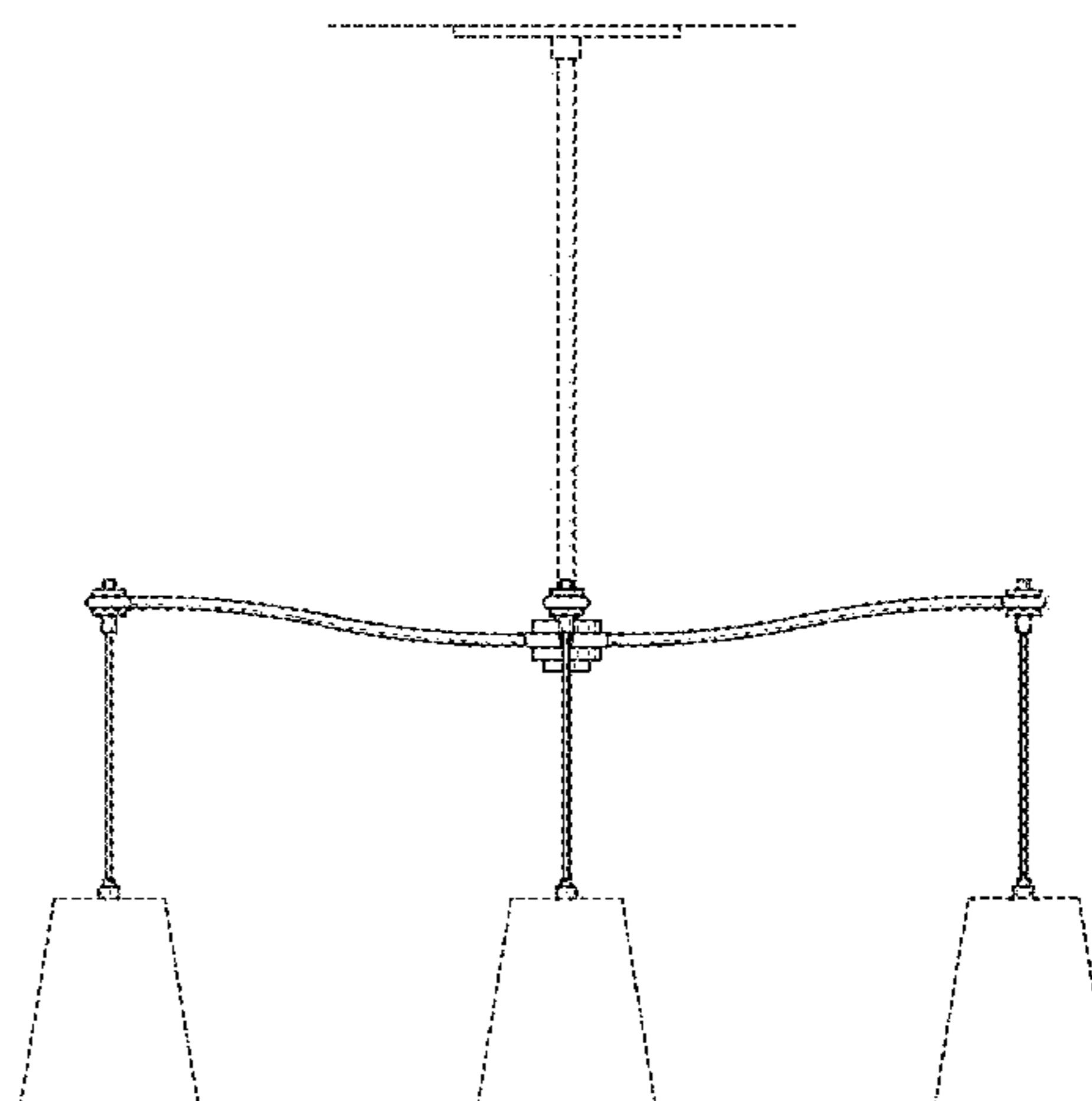
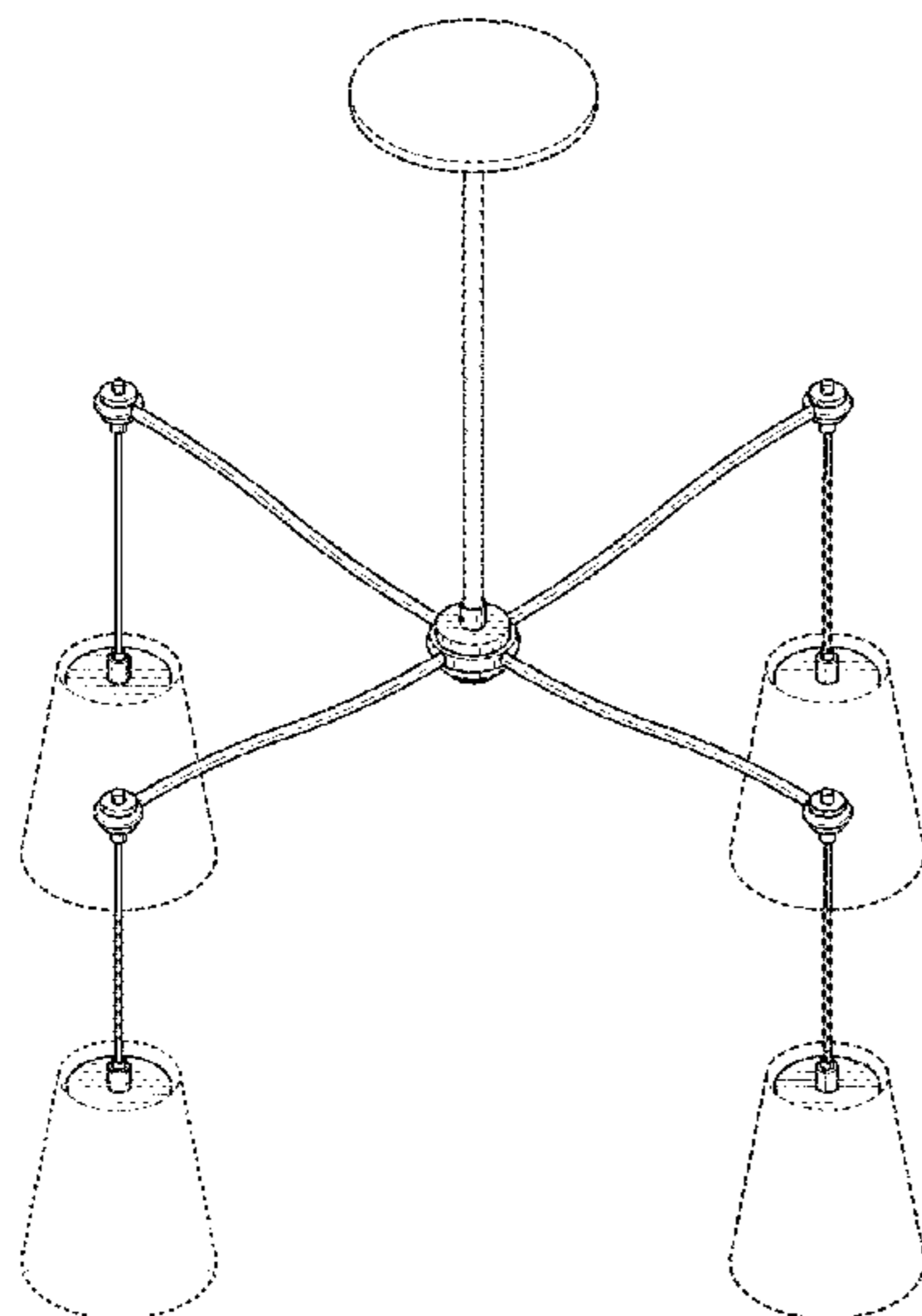
The ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a lighting fixture depicting a new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a back elevational view thereof;
FIG. 5 is a right elevational view thereof;
FIG. 6 is a left elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.

The horizontal broken lines extending out beyond the perimeter of the top surface of the fixture in FIGS. 3-6 are intended to demonstrate environment only and form no part of the claimed design. 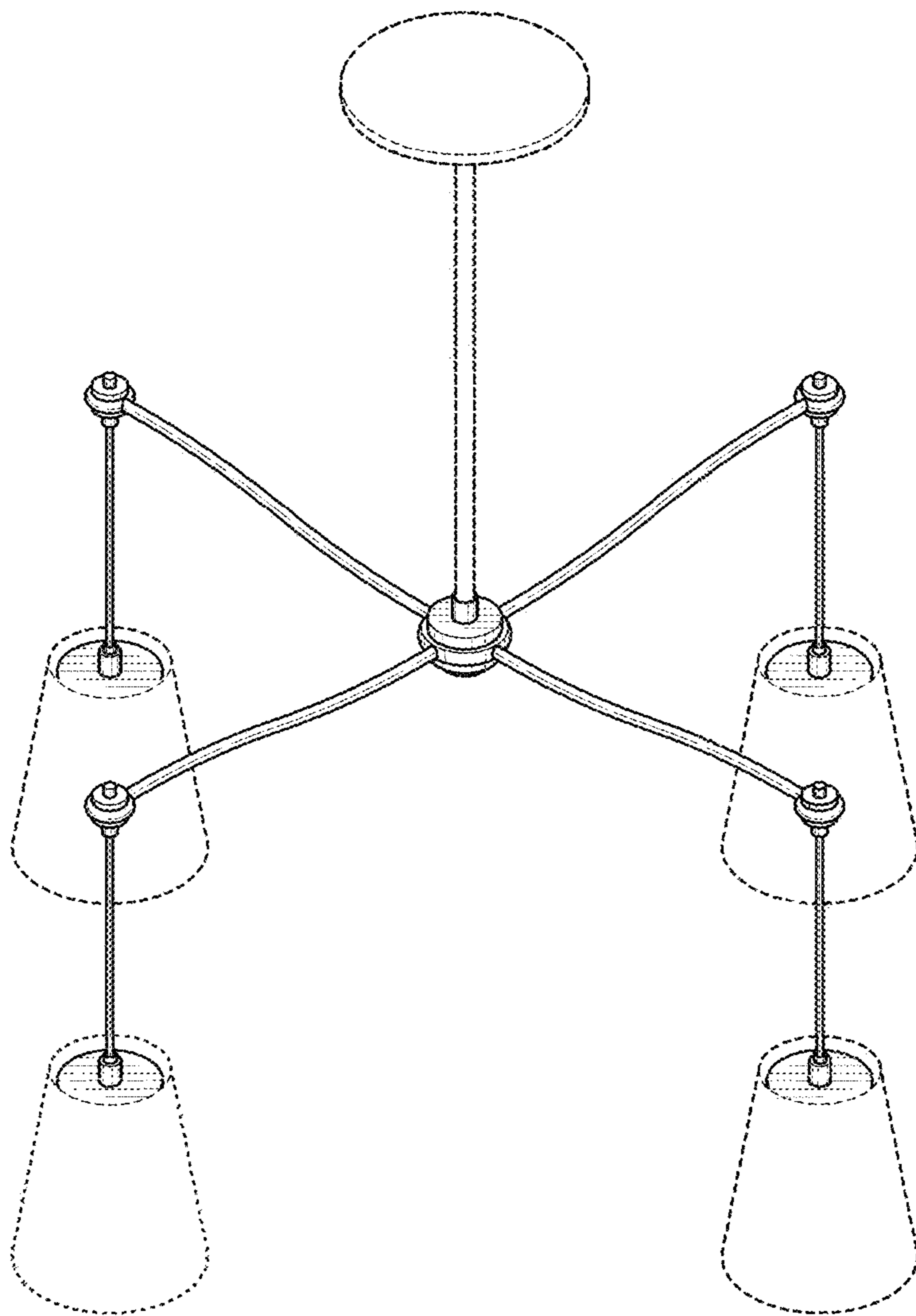

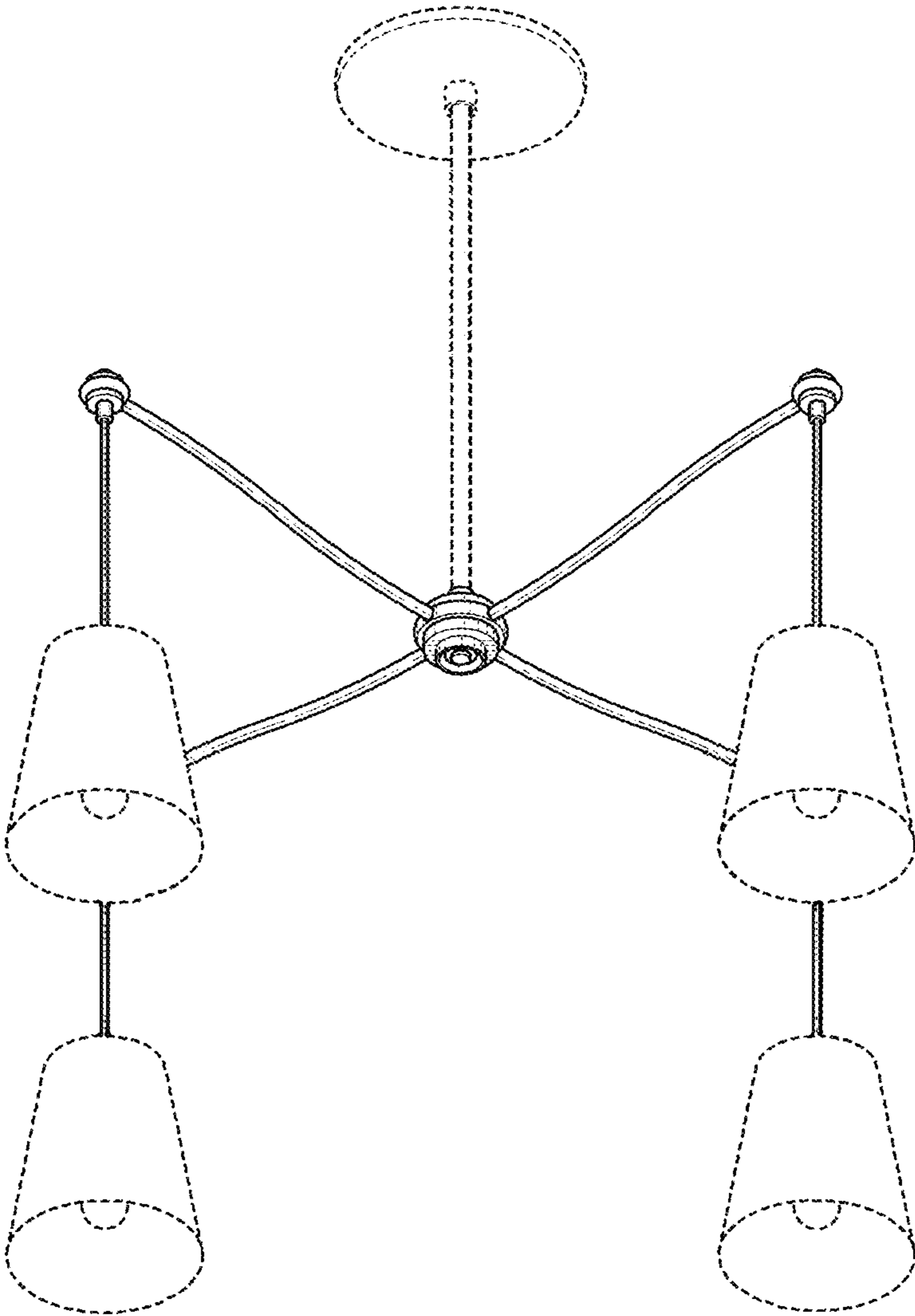

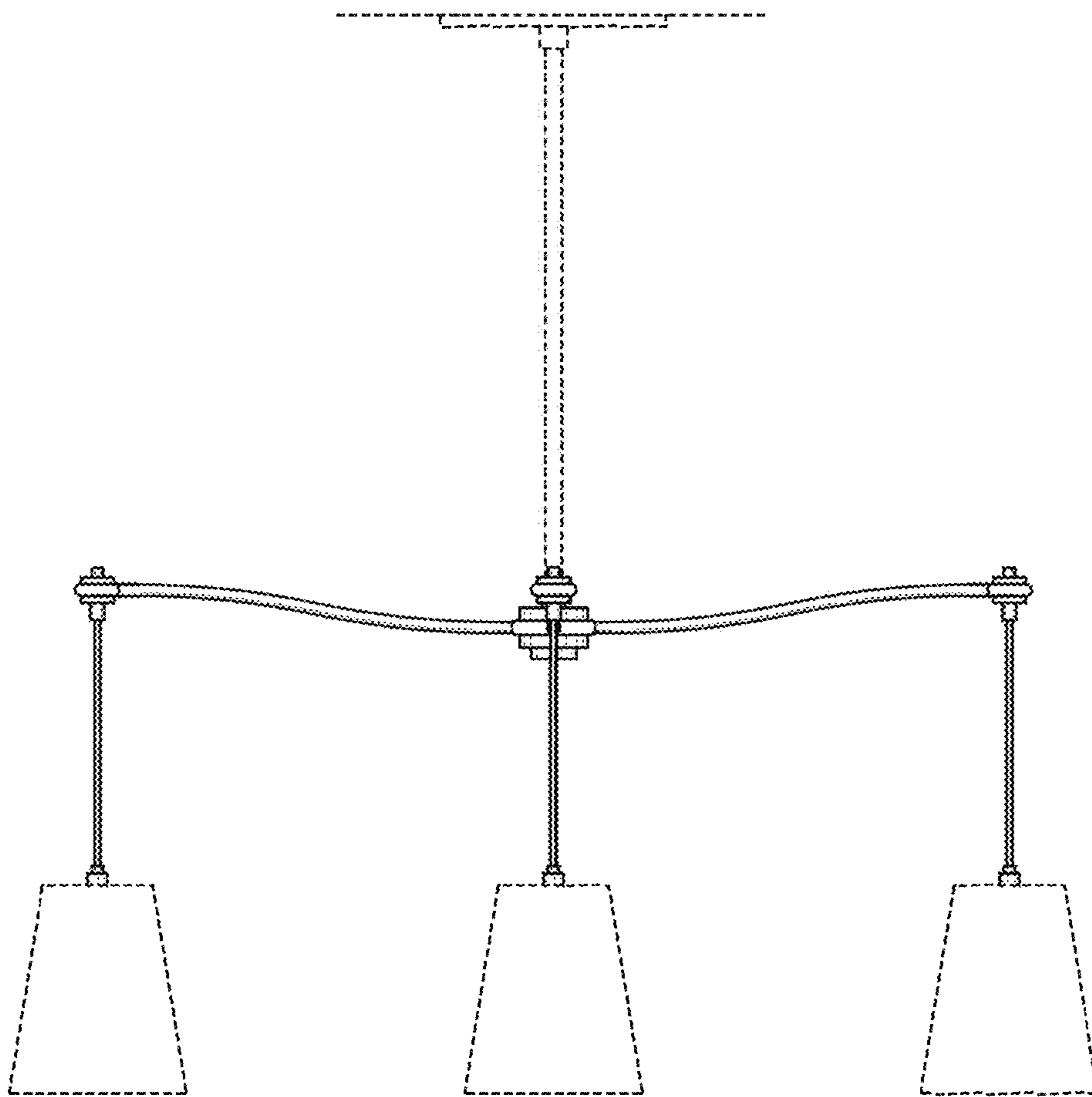

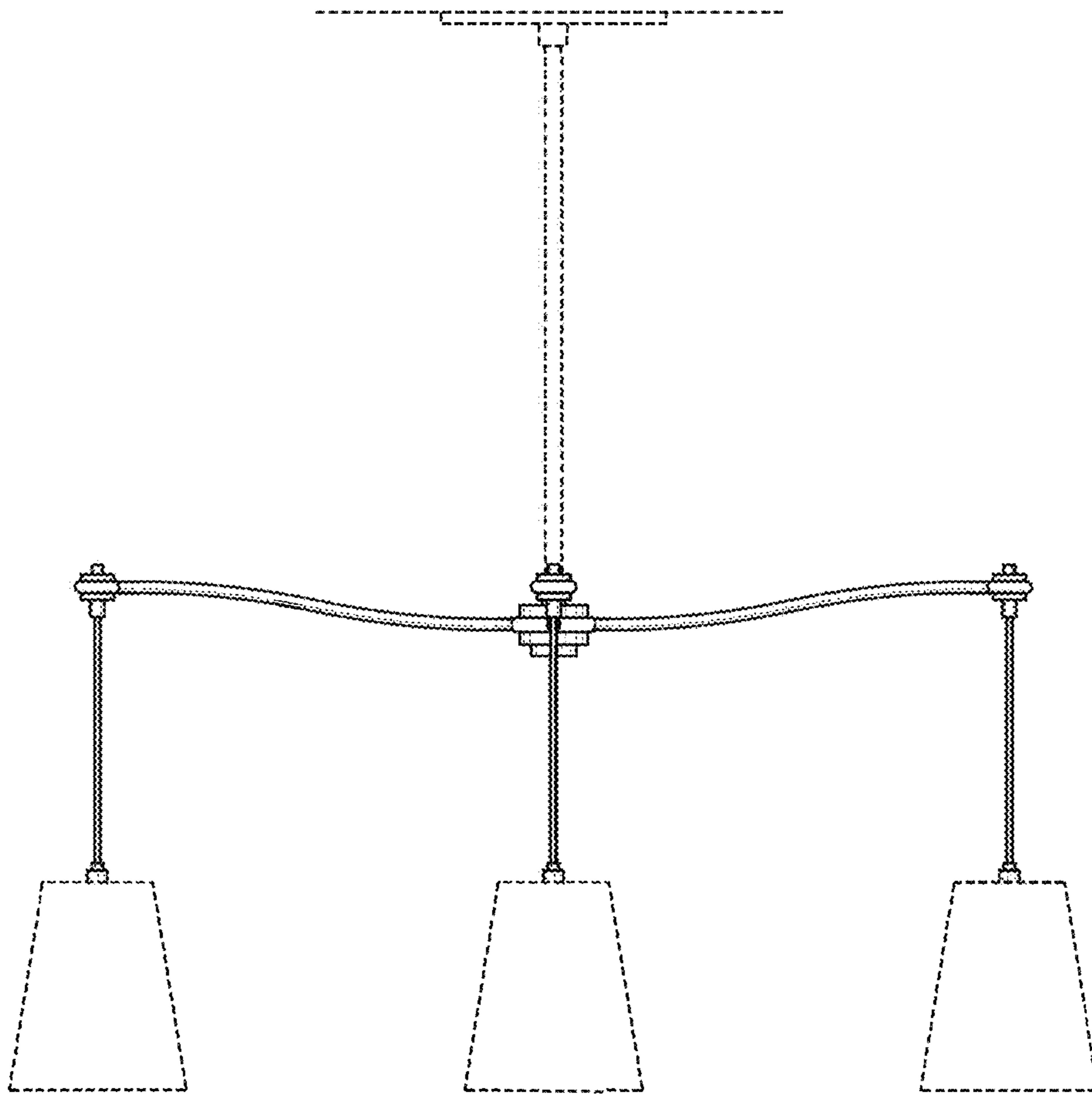

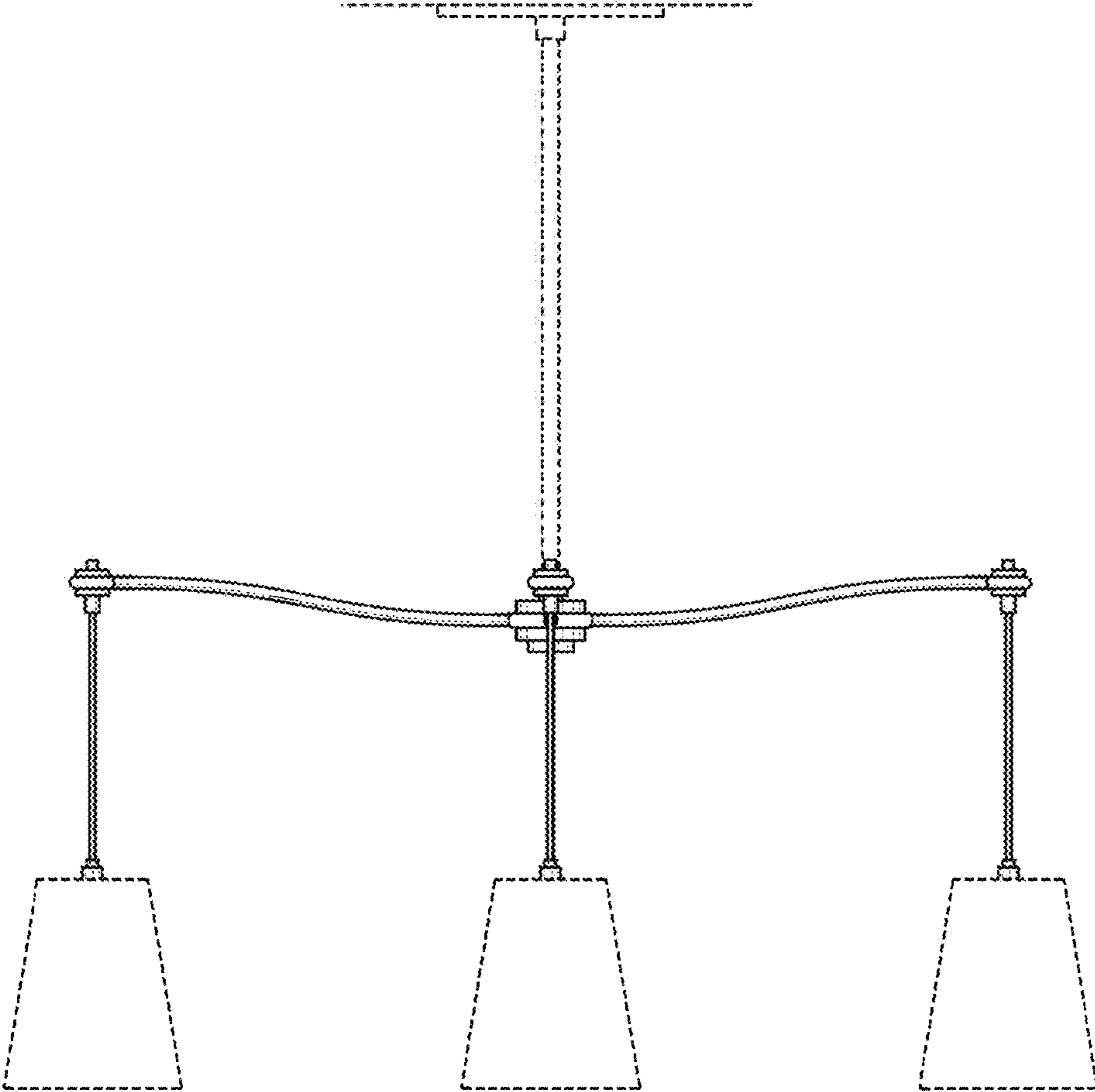

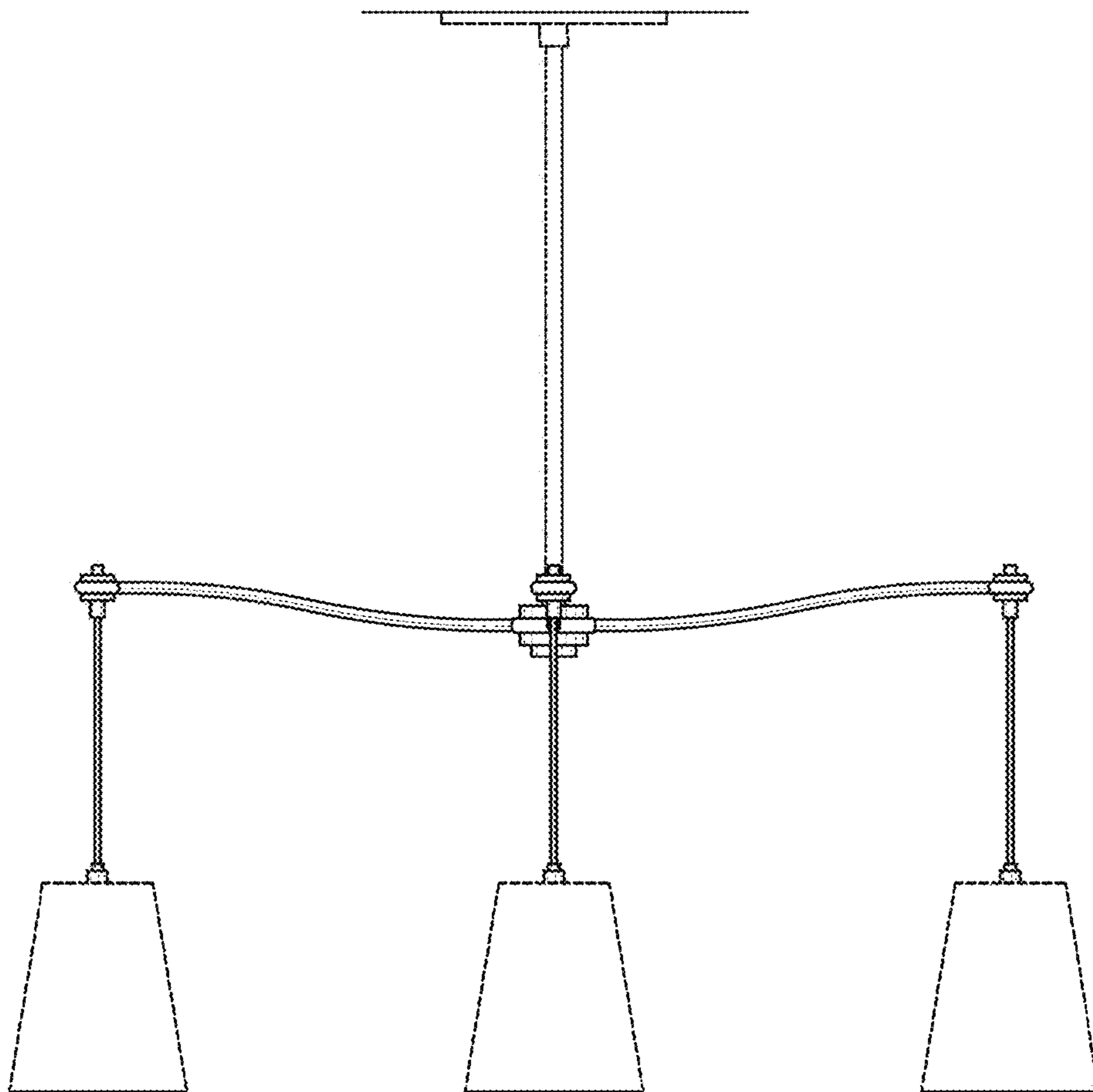

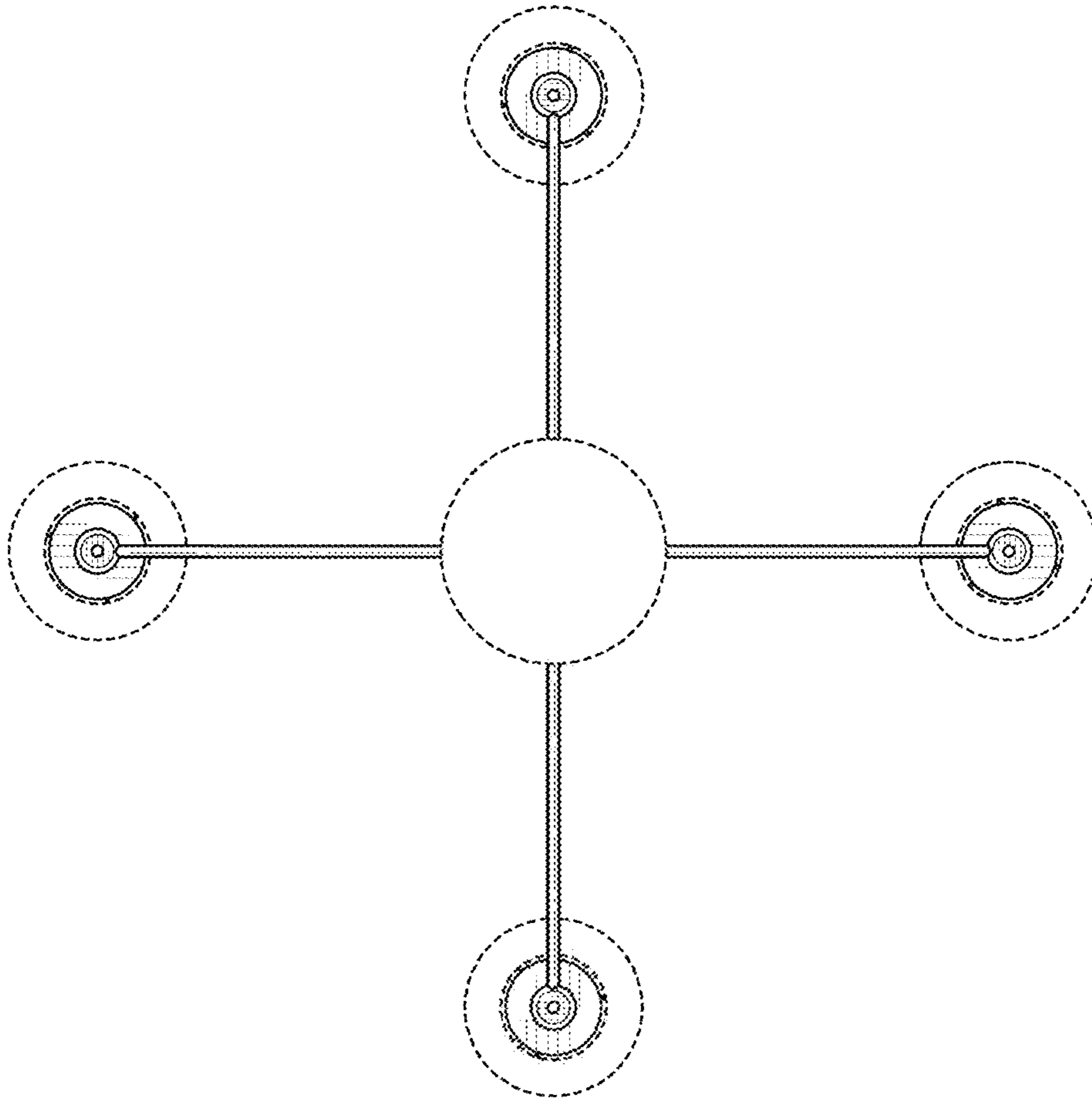

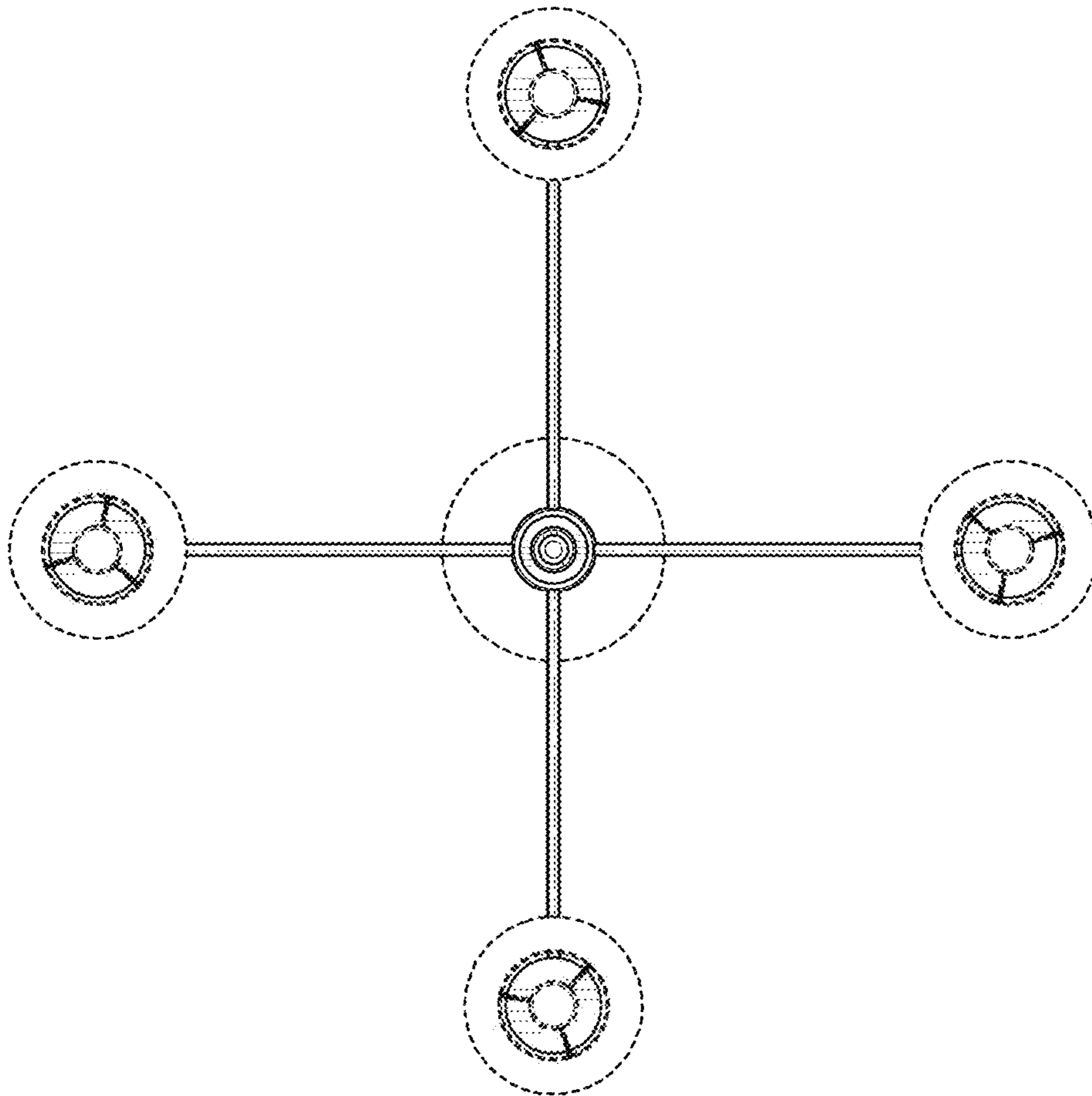
