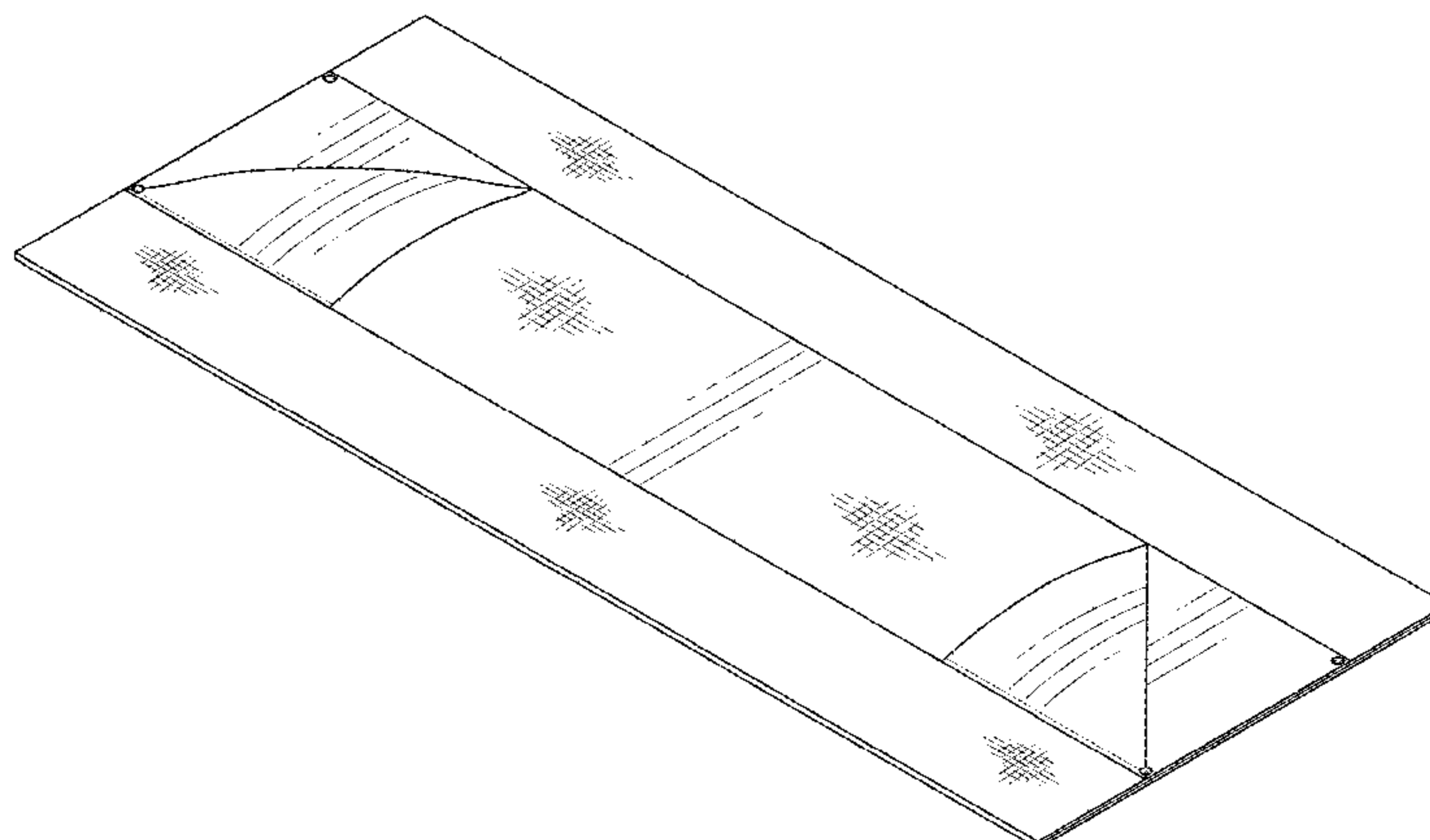
(57) **CLAIM**

The ornamental design for a sun blocking scarf having sleeve panels, as shown and described.

**DESCRIPTION**

FIG. 1 is a back perspective view of the sun blocking scarf having sleeve panels of the present invention; FIG. 2 is a back view thereof; FIG. 3 is a top view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a left-side view thereof; and, FIG. 7 is a right-side view thereof. The broken lines represent stitching which forms part of the claimed design. The hashing only reflects fabric type material.

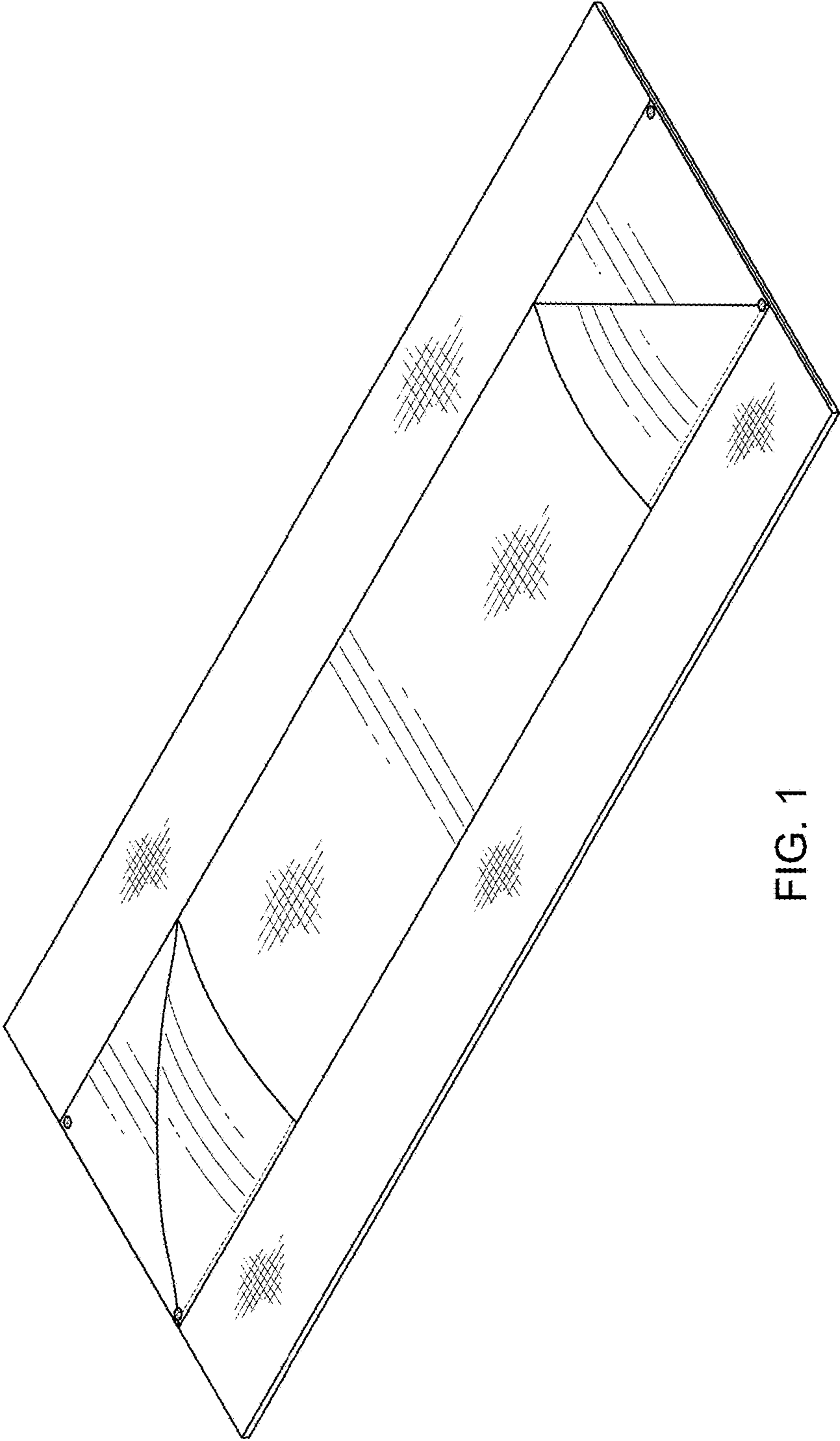

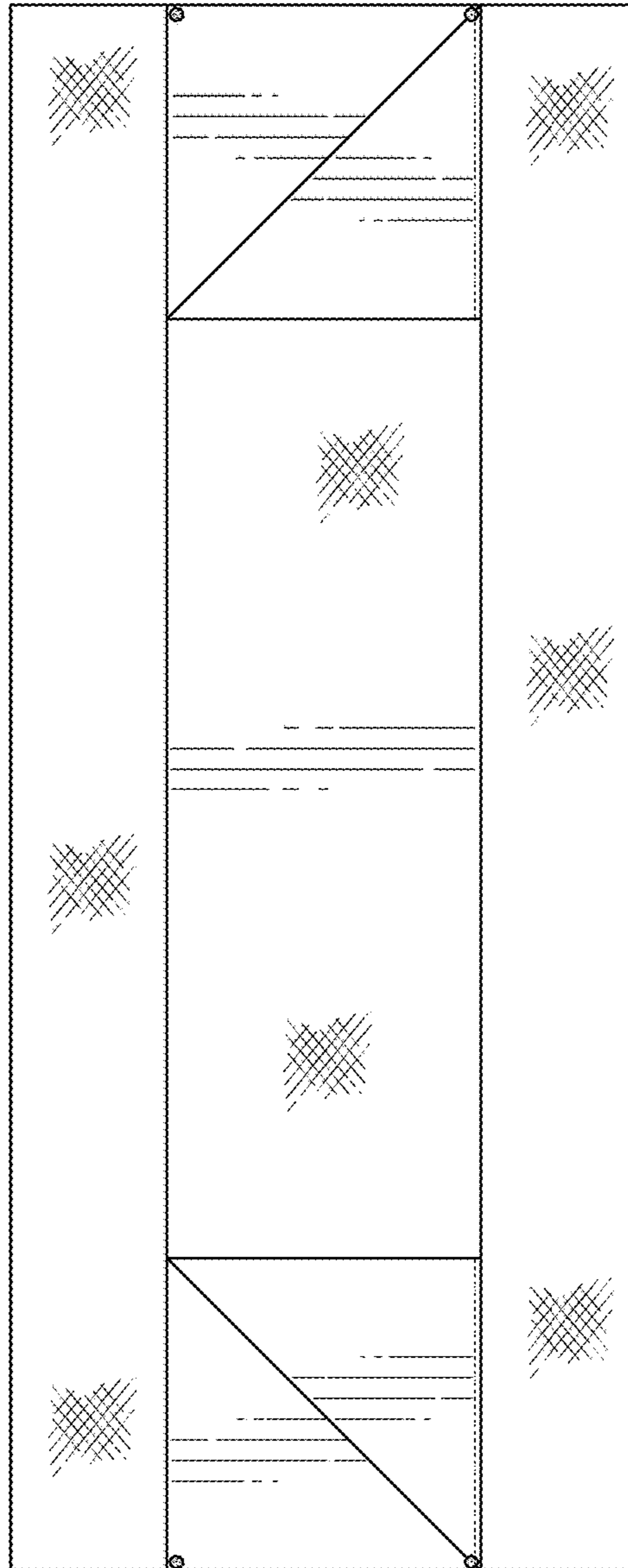

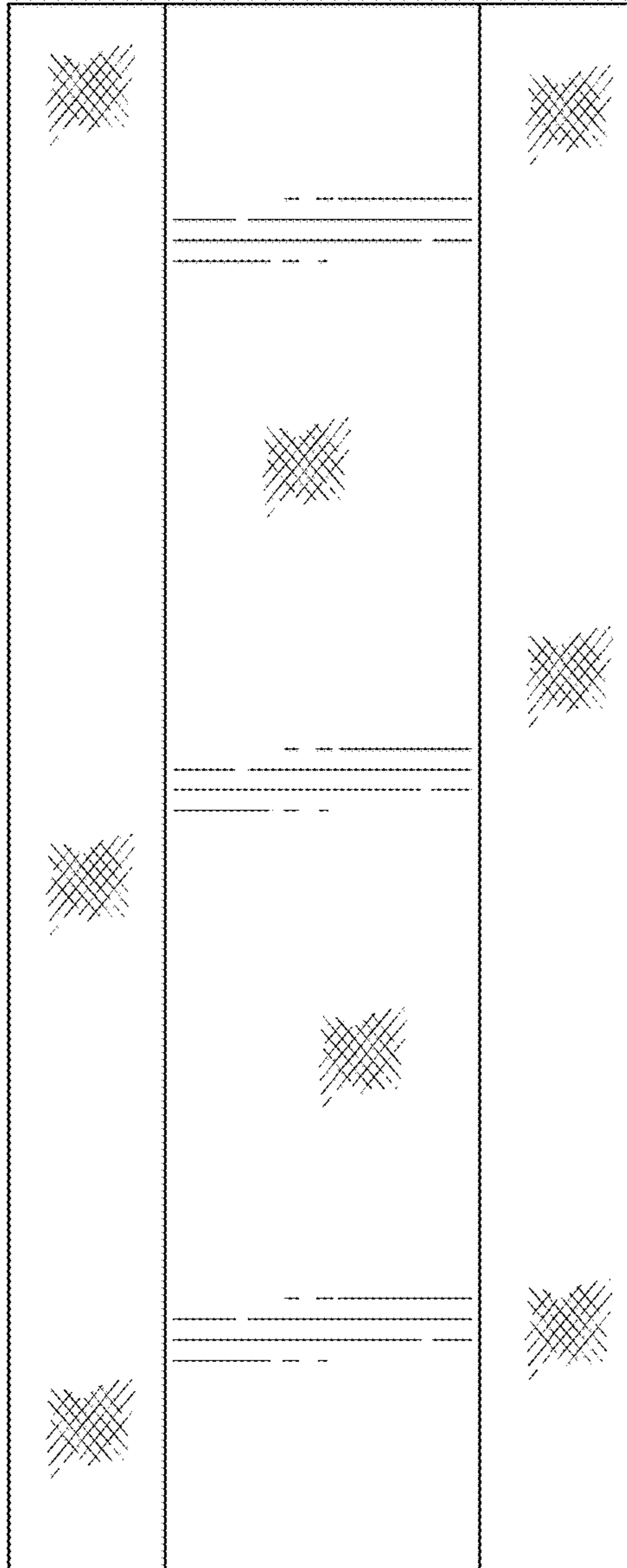

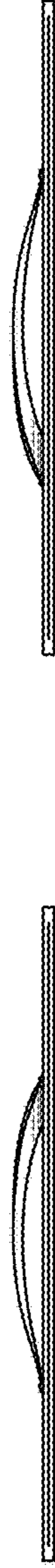
