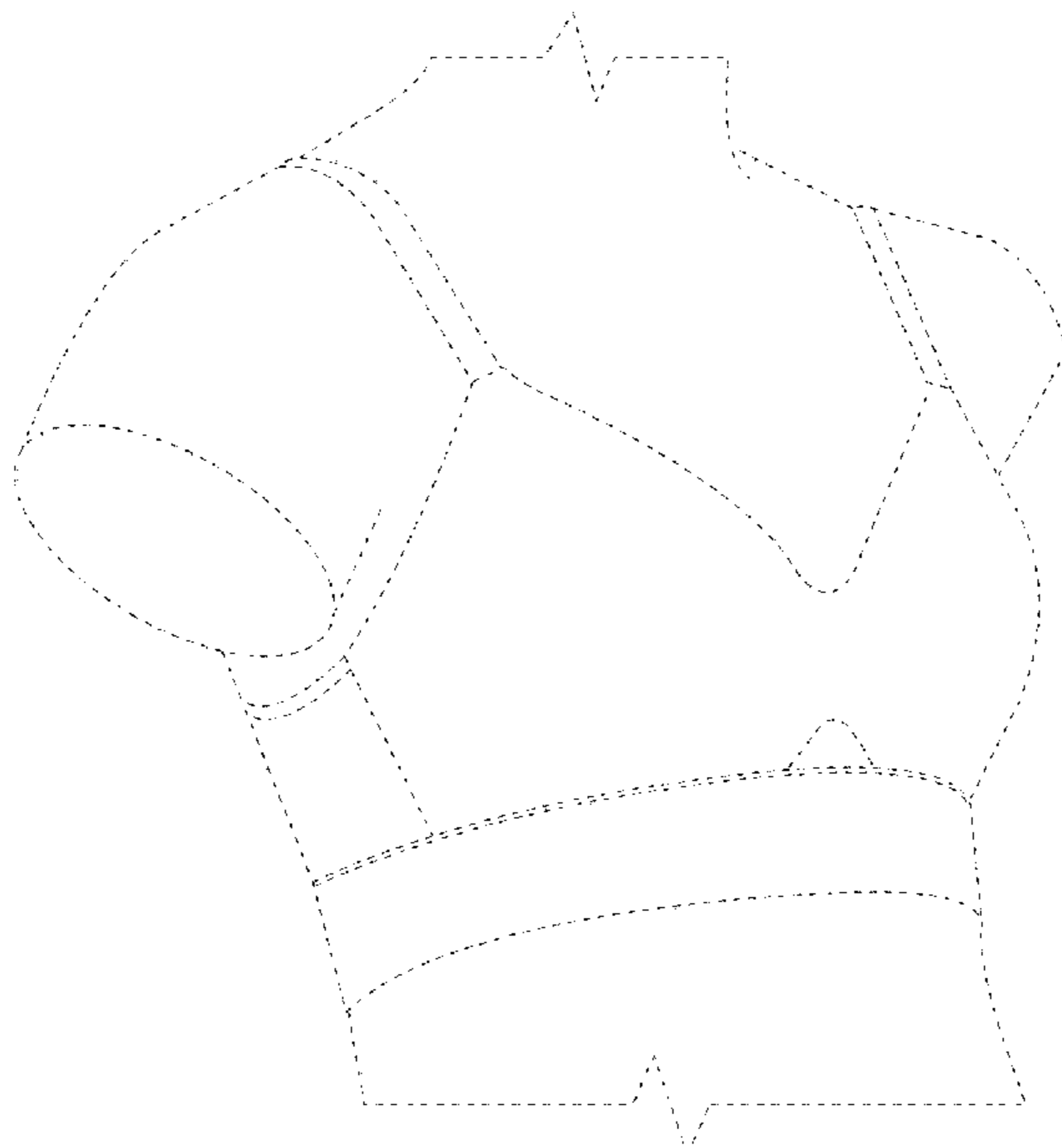
(57) **CLAIM**

The ornamental design for a sports bra, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our new design in use. FIG. 2 is a front view thereof. FIG. 3 is a rear view thereof. FIG. 4 is a right-side view thereof. FIG. 5 is a left-side view thereof. FIG. 6 is a top view thereof. FIG. 7 is a bottom view thereof; and, FIG. 8 is a top view of our new design when not in use. The partial human figure rendered in short broken lines in FIGS. 1-7 illustrates environmental subject matter intended to assist in showing how the design appears when in use and forms no part of the claim. The short broken lines showing elements of the sports bra in the drawings illustrate features of the article of manufacture that form no part of the claimed design. The portions of the design shown in large broken lines are stitching and form no part of the claim. The broken lines consisting of dot-dash lines are boundary lines that show that the claimed design extends to the boundary line, but does not include the boundary line.

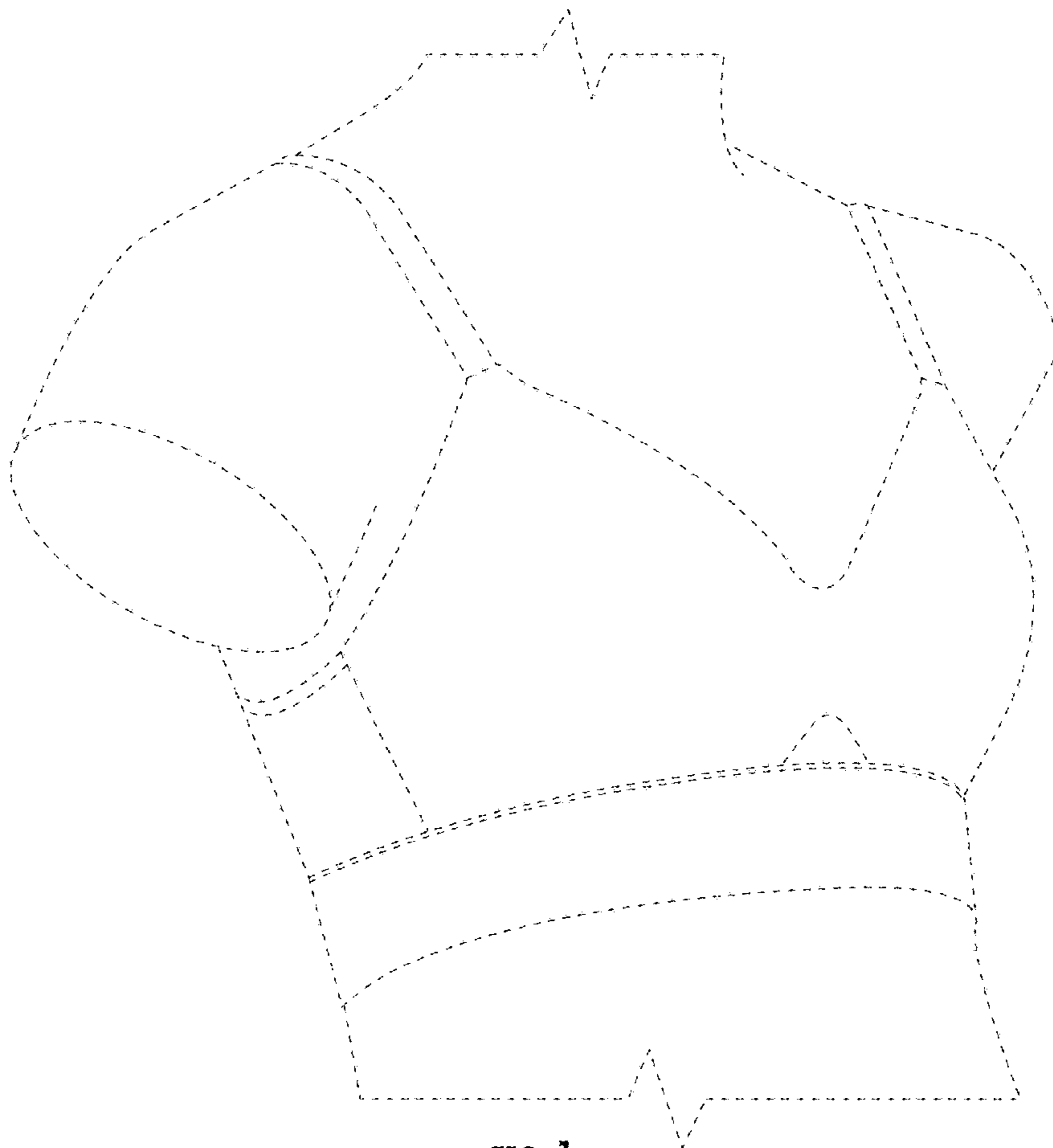

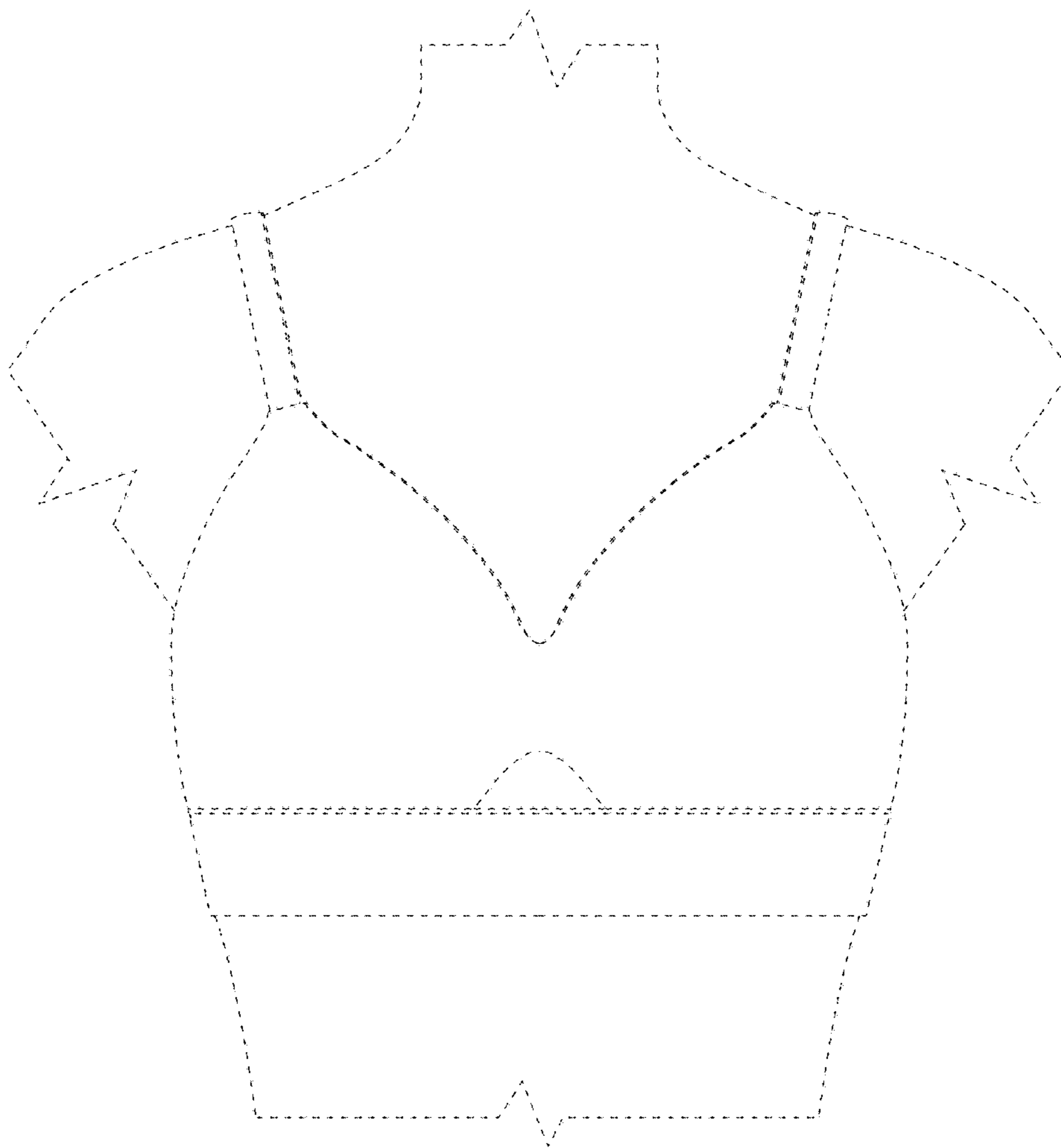

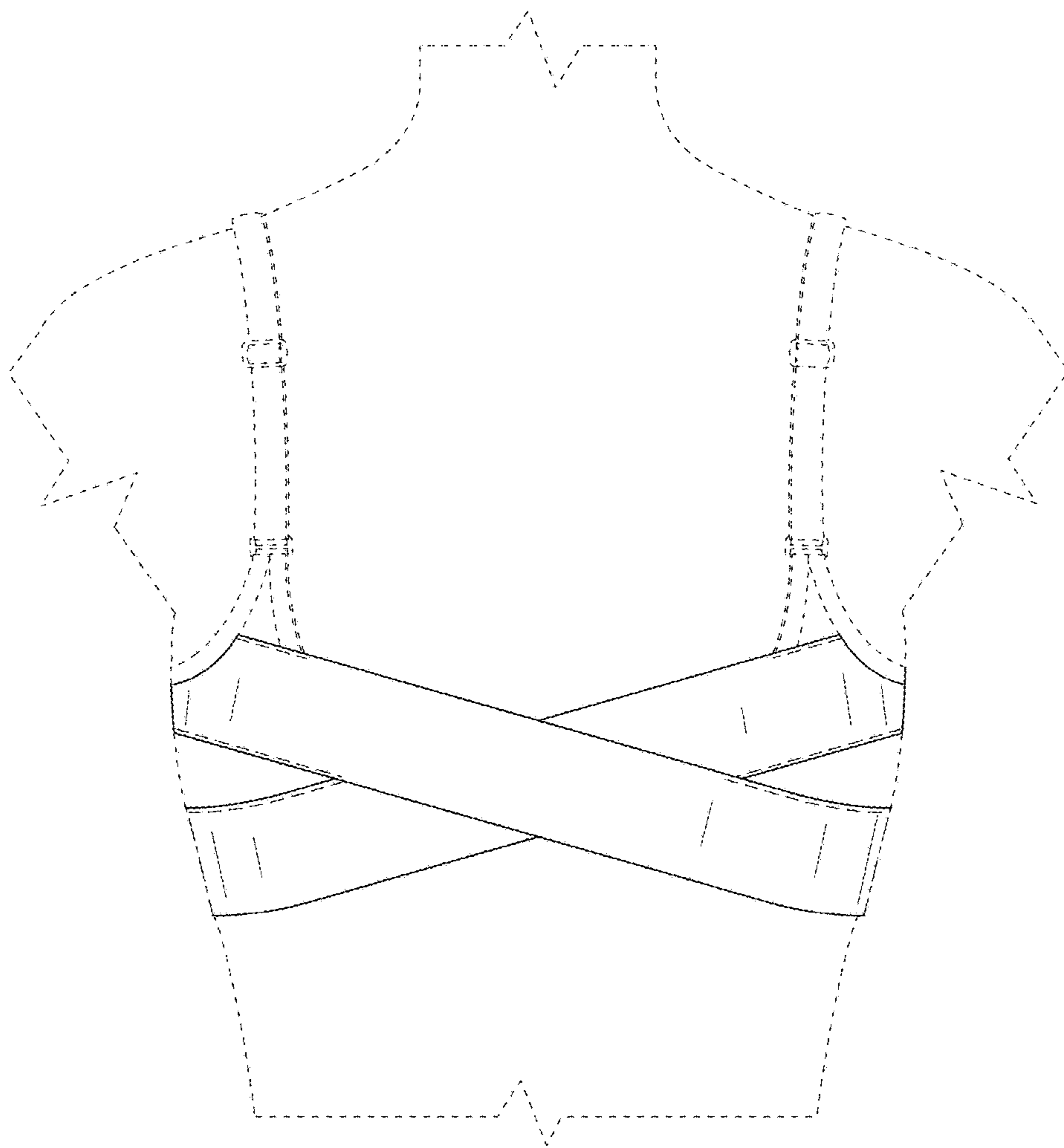

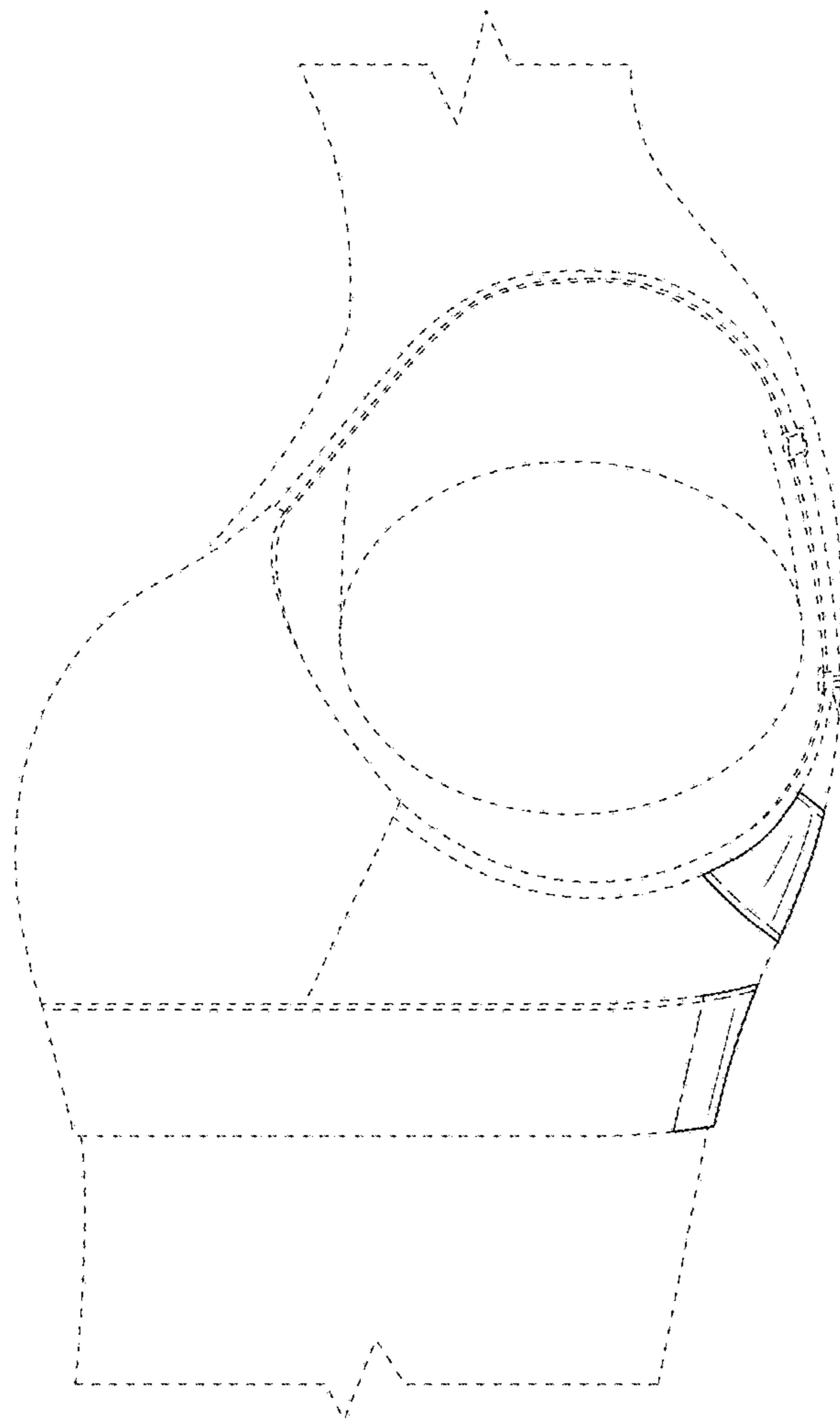

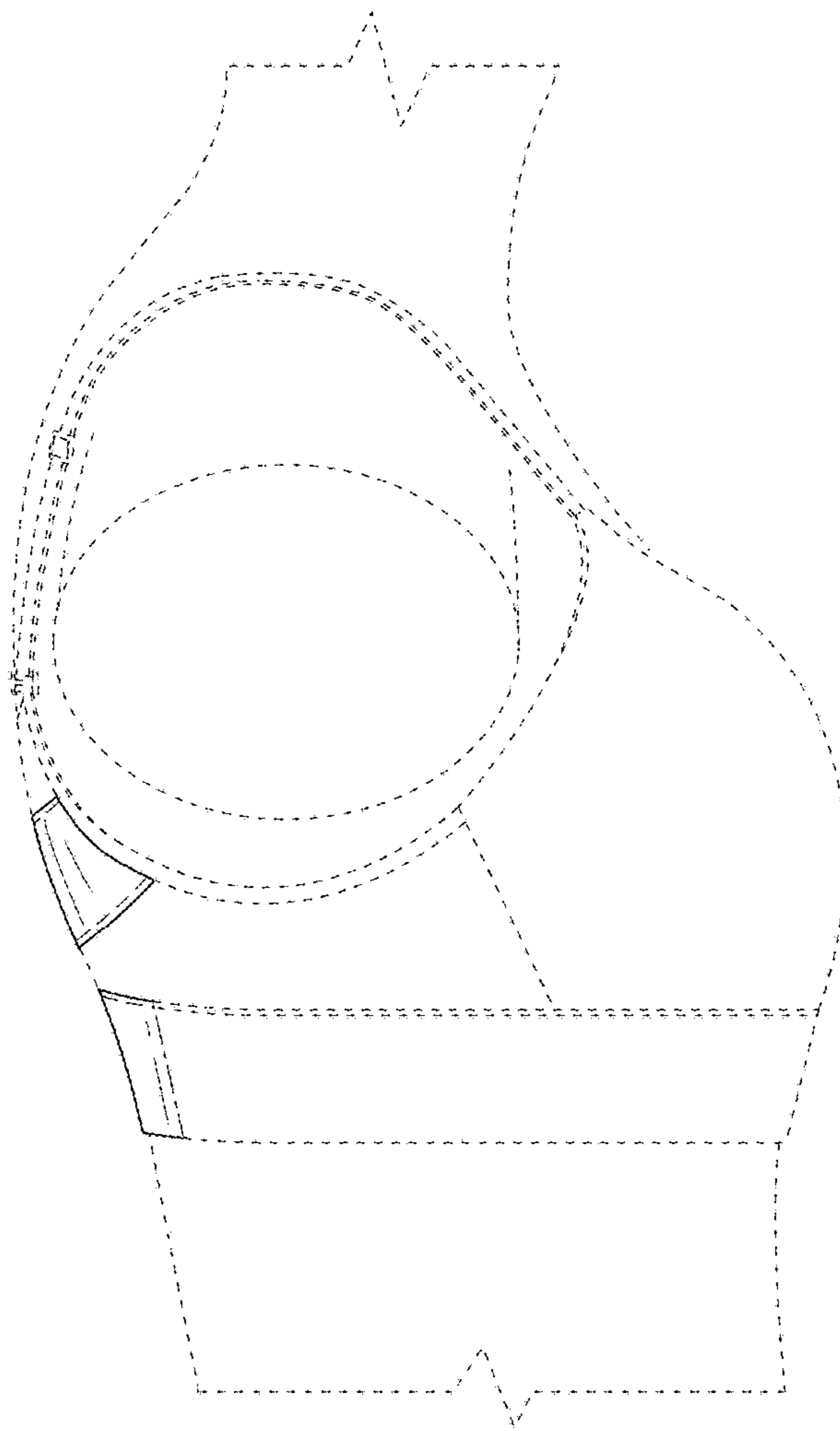

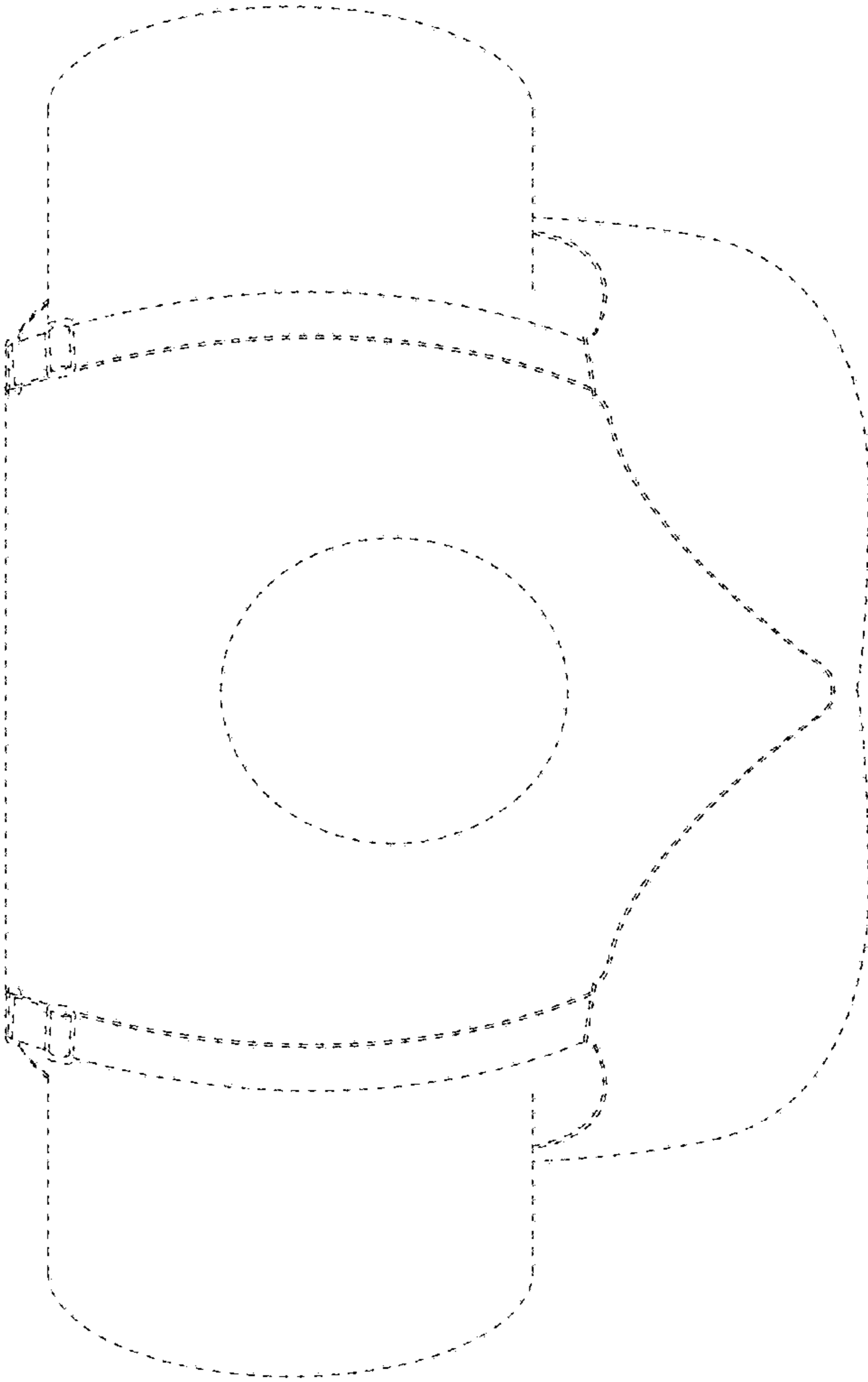

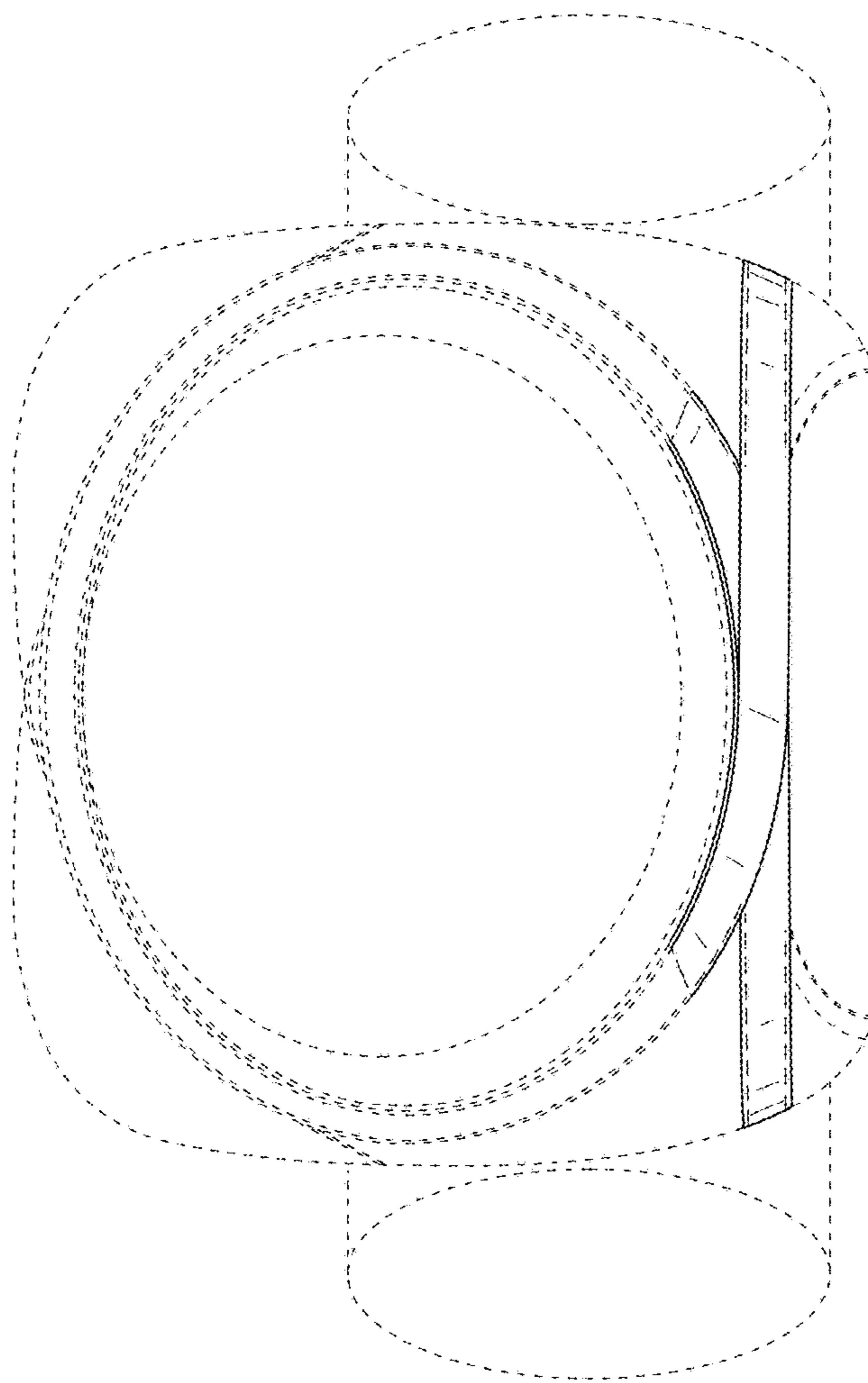

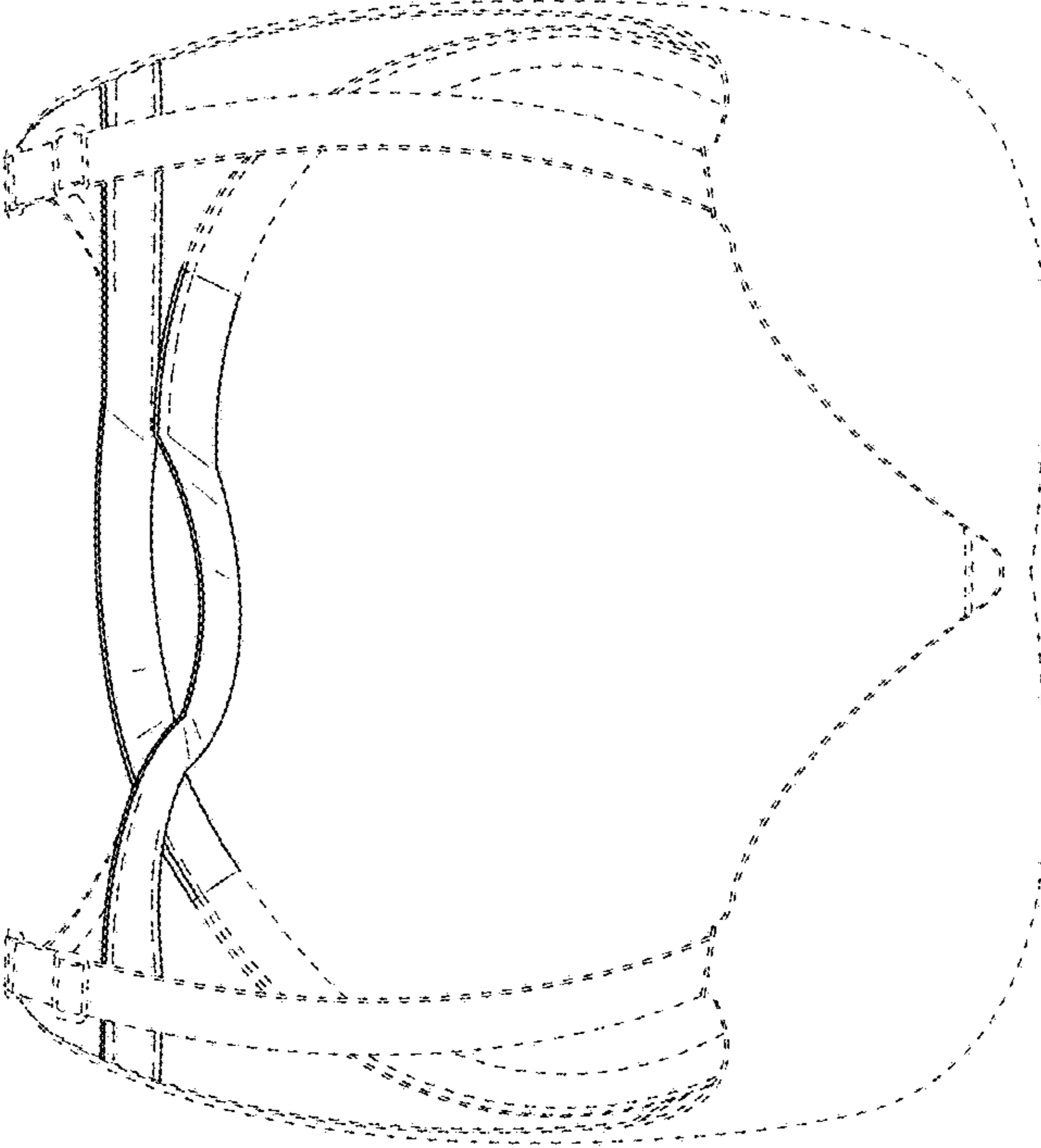
