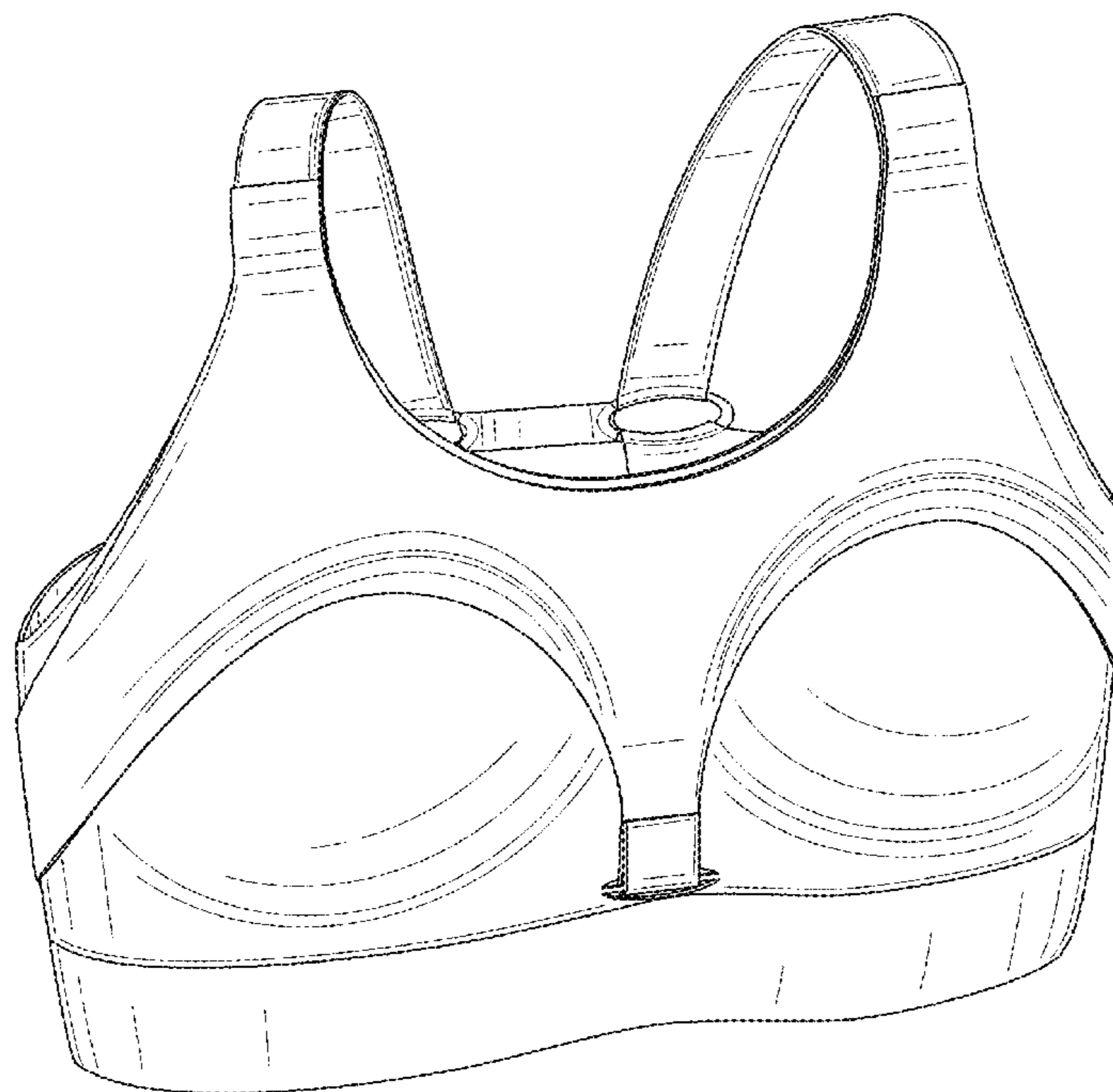
(57) **CLAIM**

We claim the ornamental design for an upper body garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an upper body garment showing our new design;

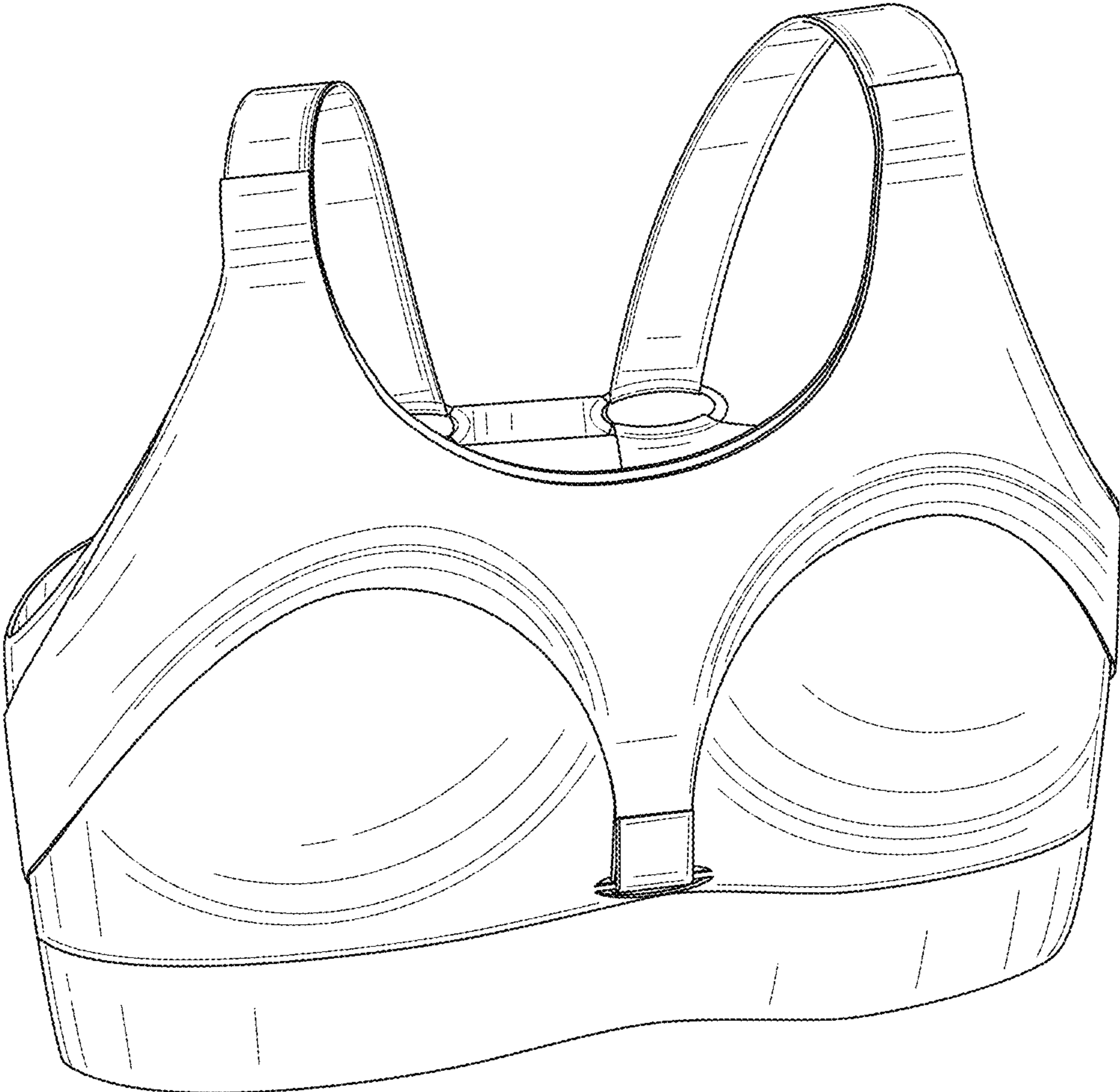

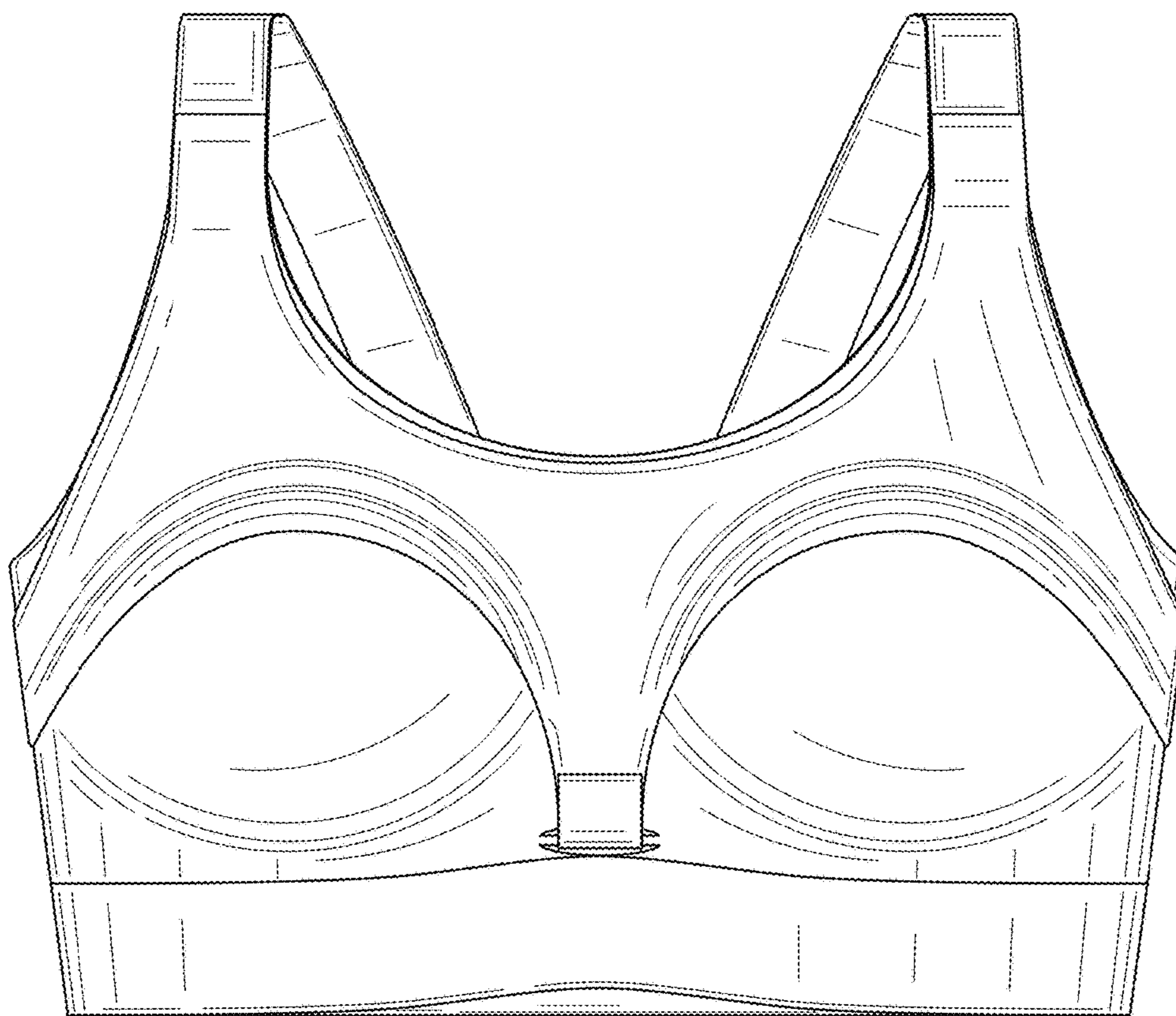

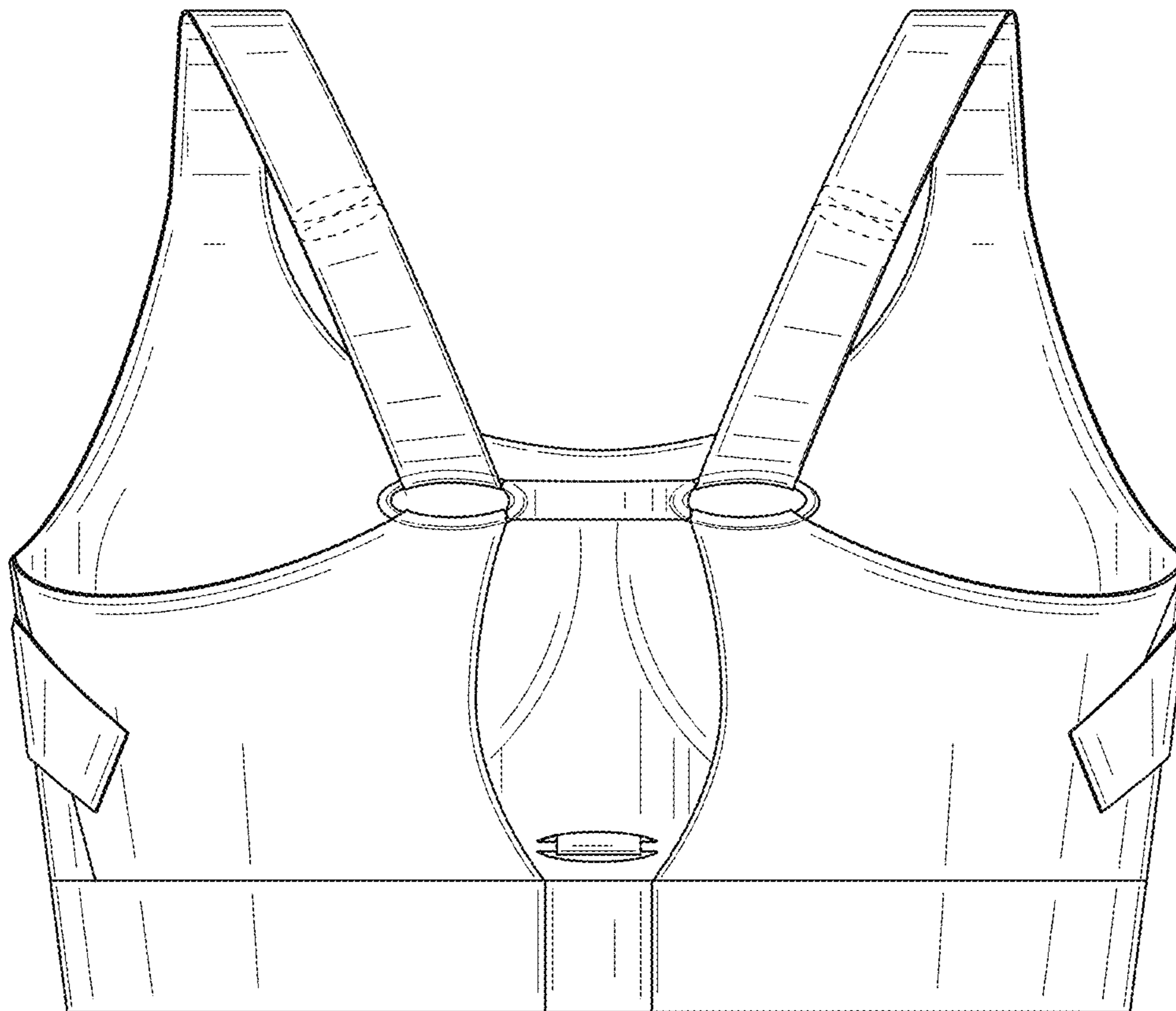

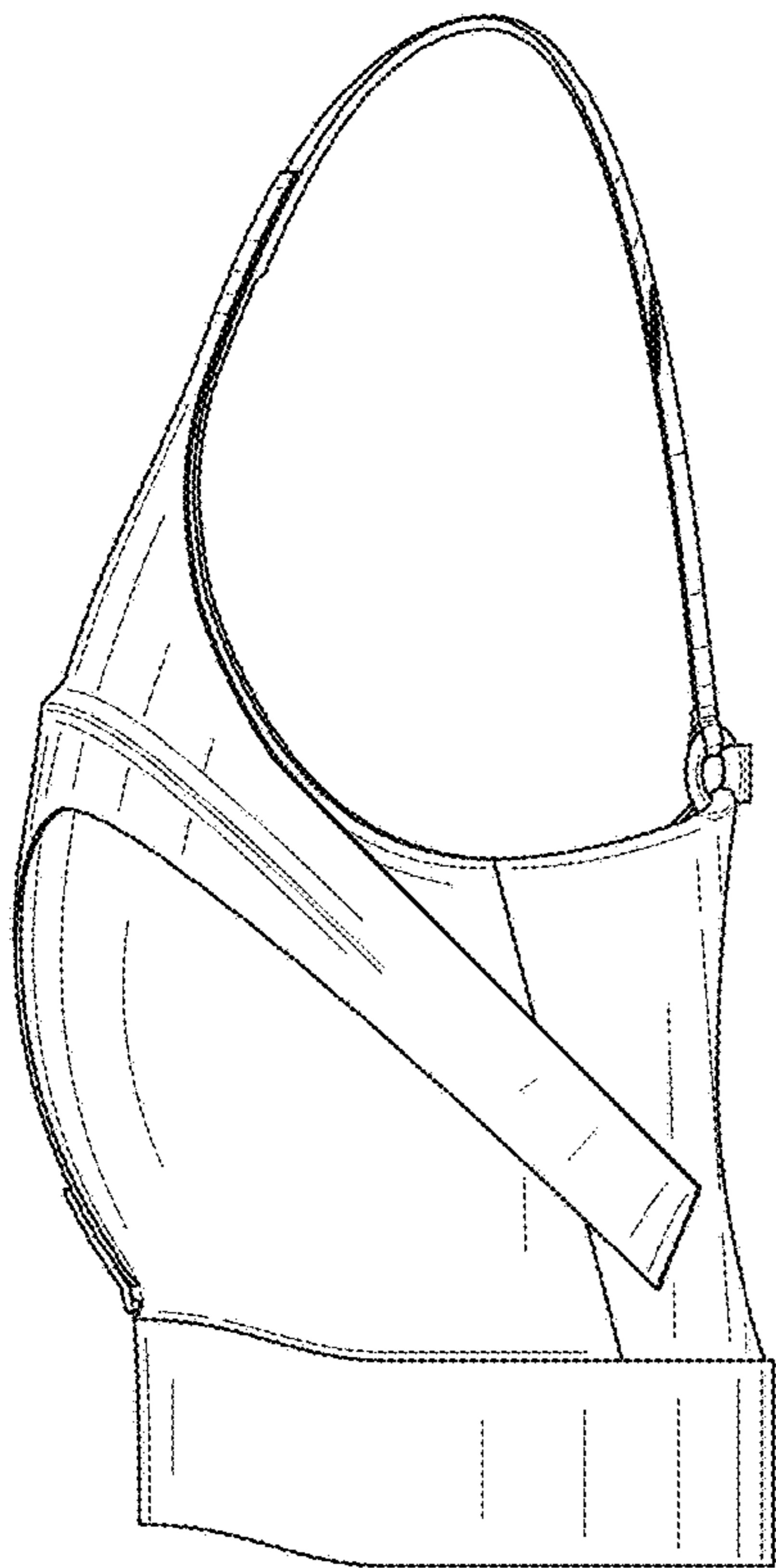

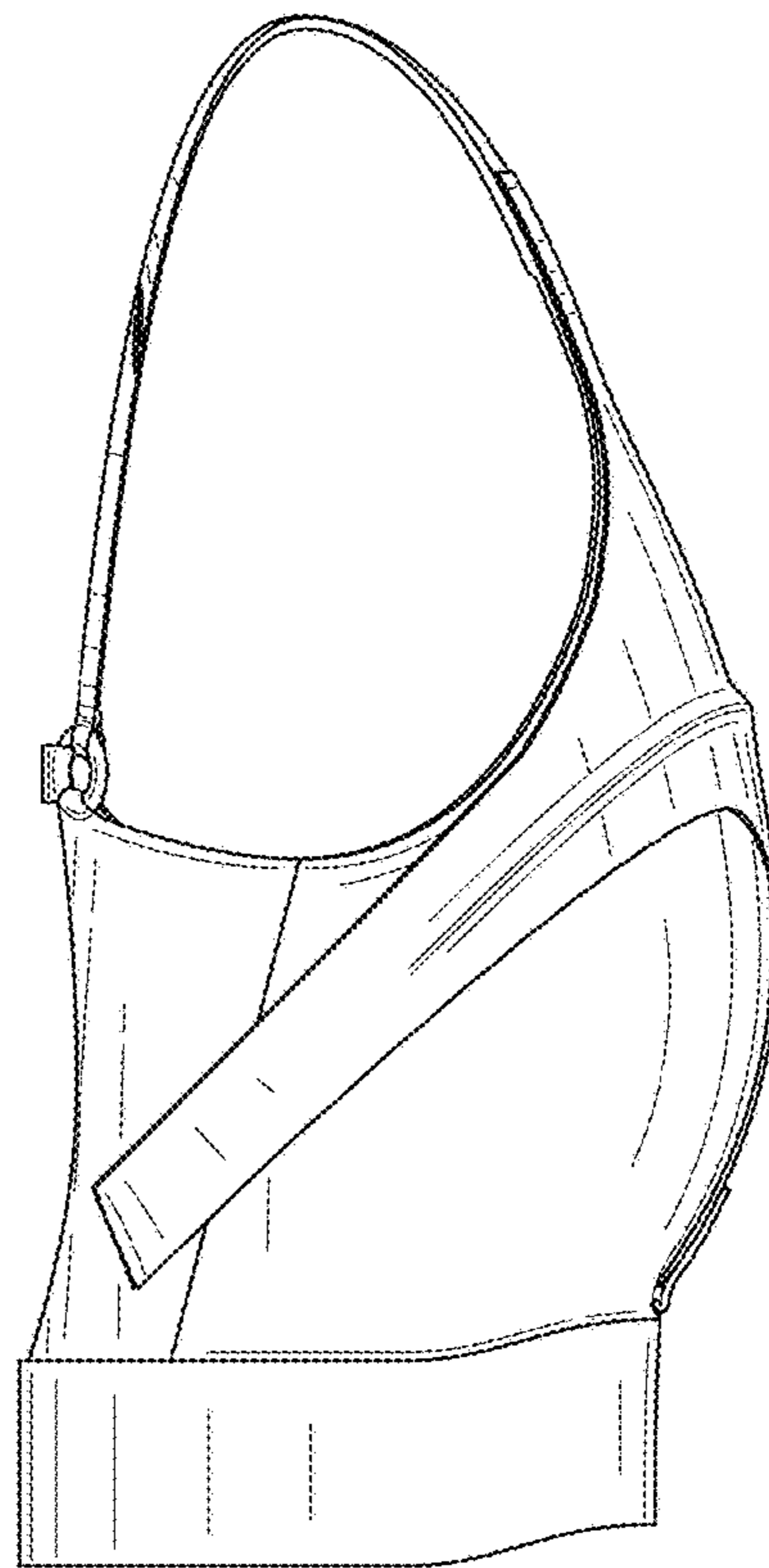

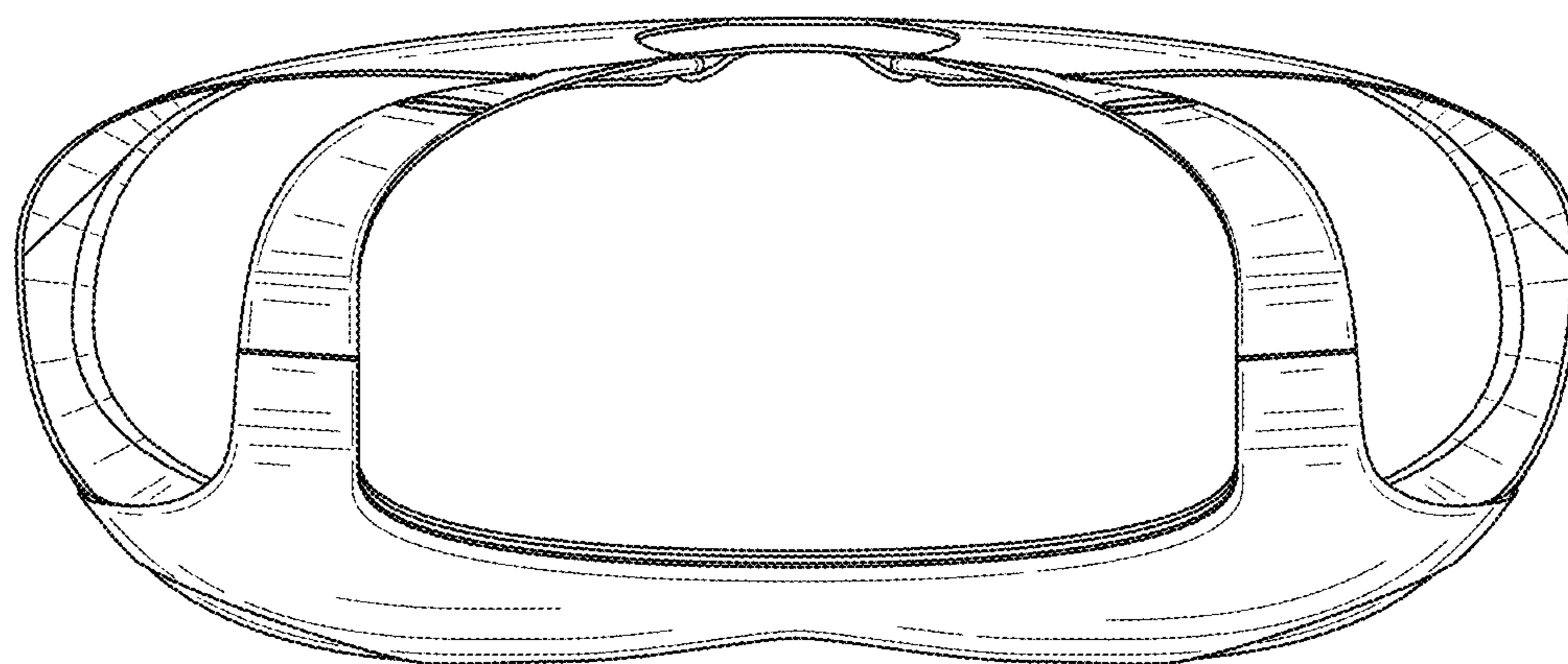

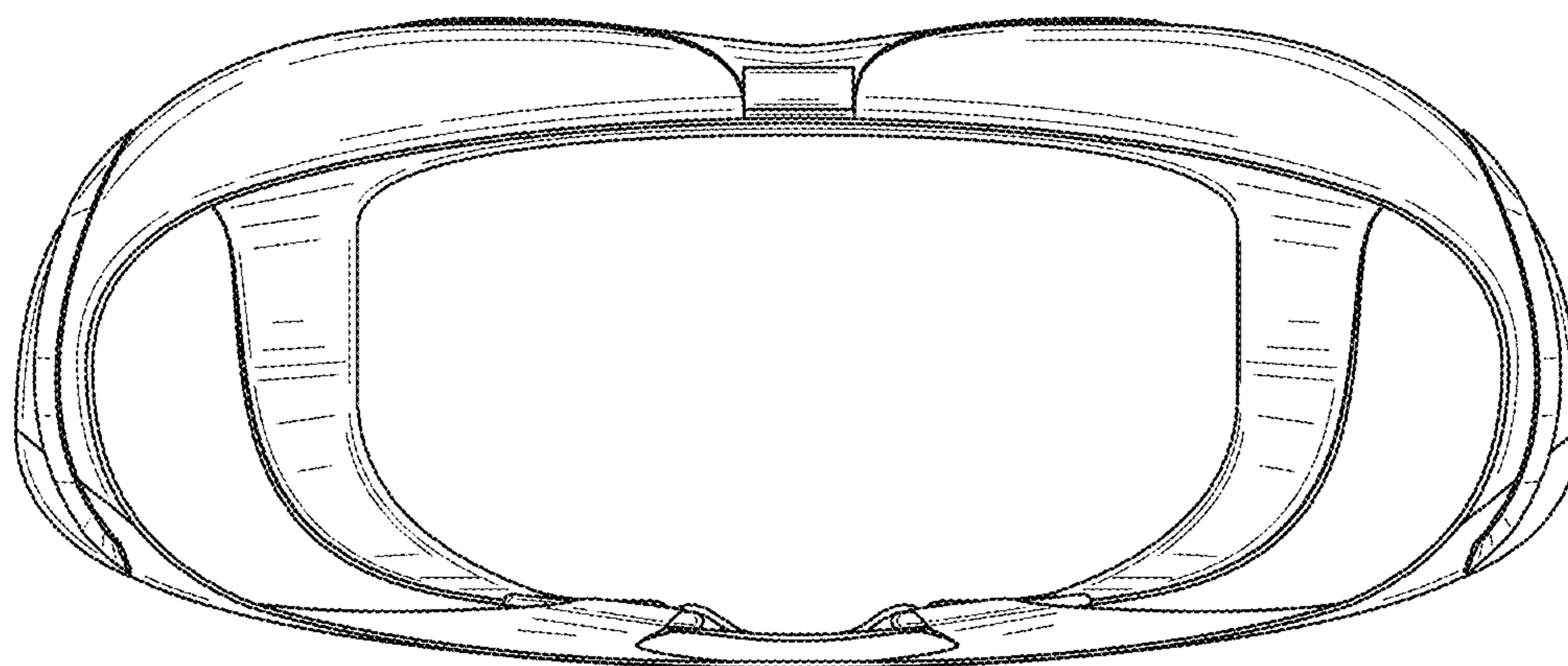

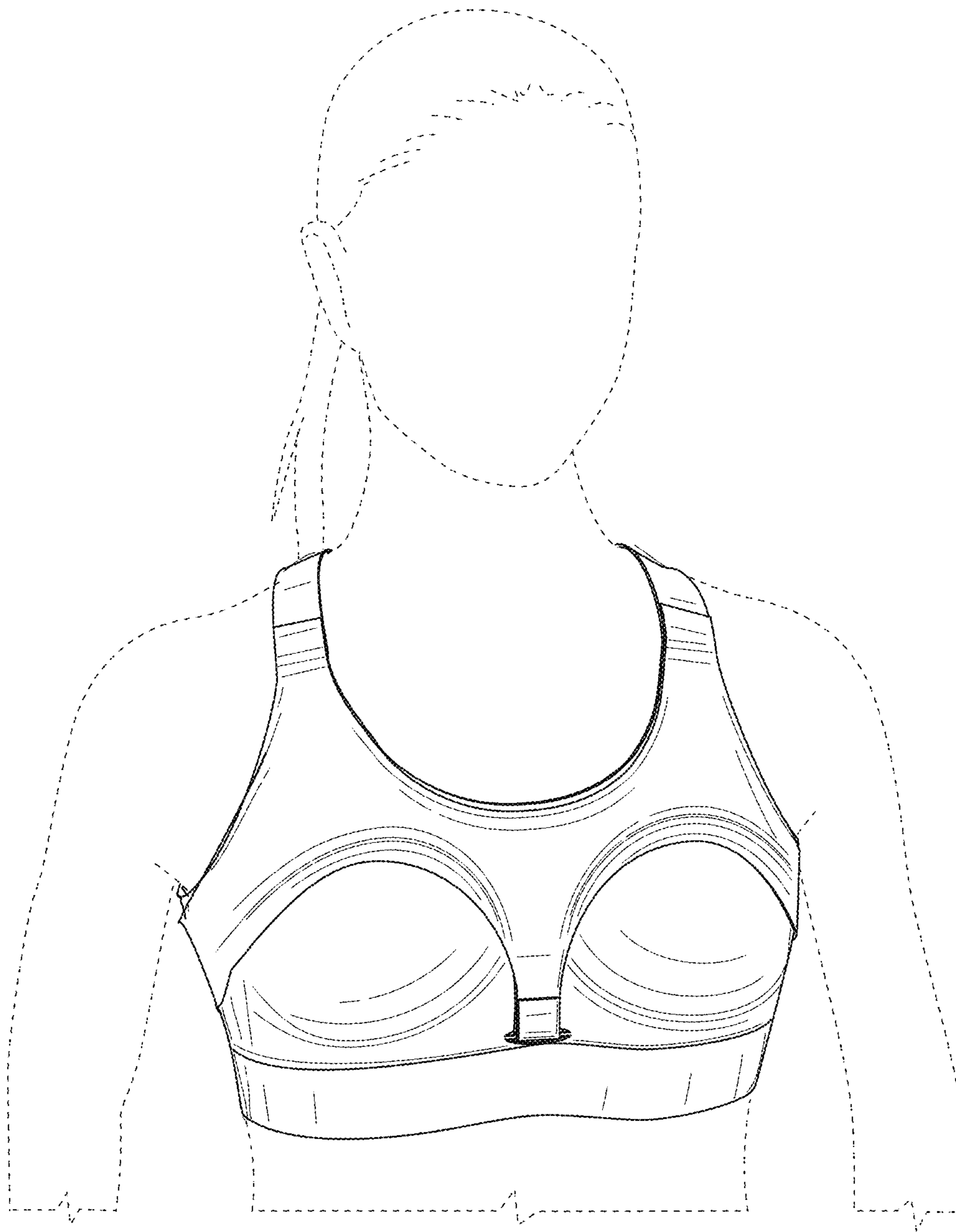
