(57) **CLAIM**

The ornamental design for a medical scrub top with reversible sleeves, as shown and described.

**DESCRIPTION**

FIG. 1 shows a front view of a medical scrub top with reversible sleeves on;

FIG. 2 shows a cross-section view of the reversible sleeves, taken along line 2-2 in FIG. 1;

FIG. 3 shows a left view of the medical scrub top of FIG. 1; FIG. 4 shows a right view of the medical scrub top of FIG. 1;

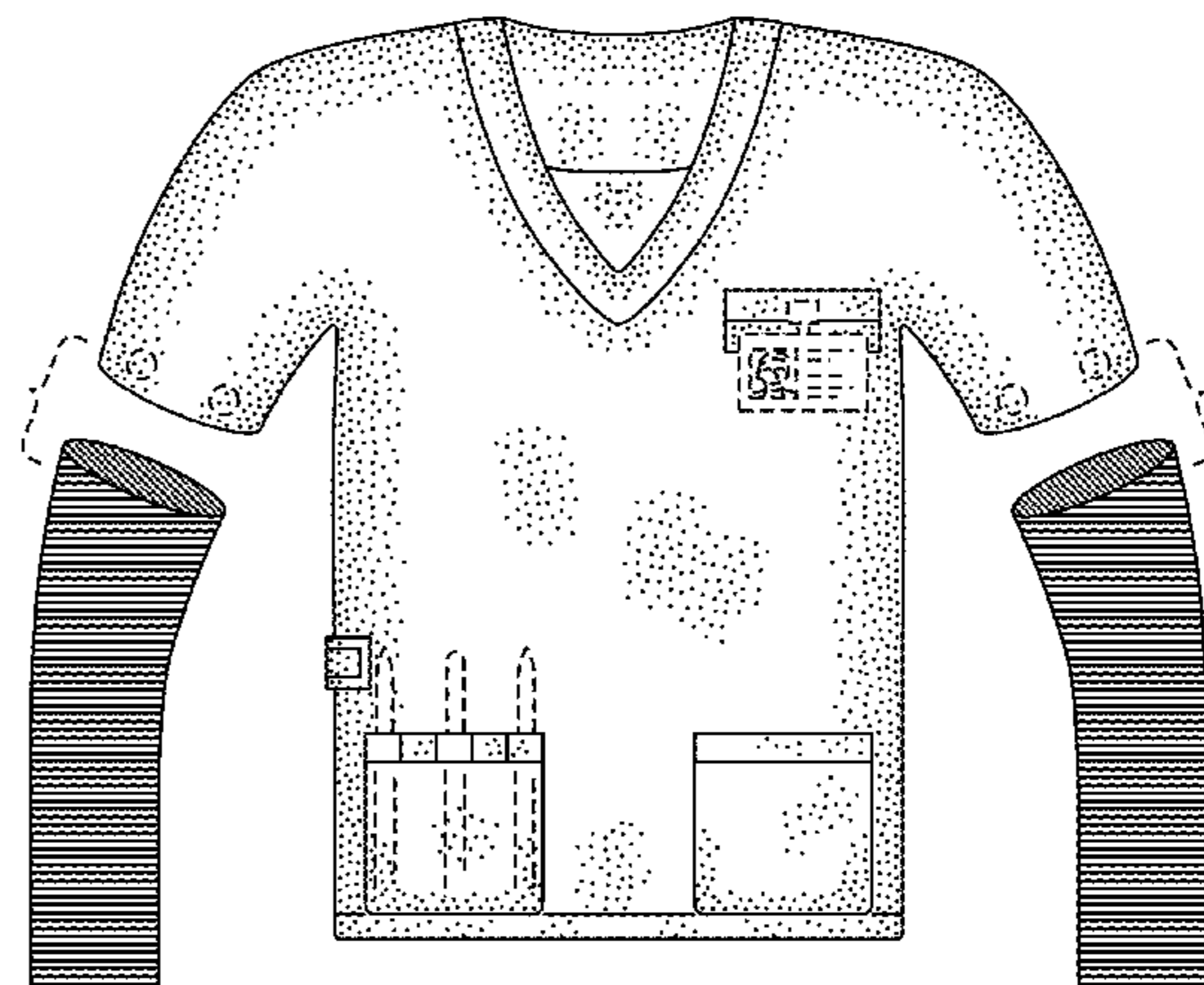
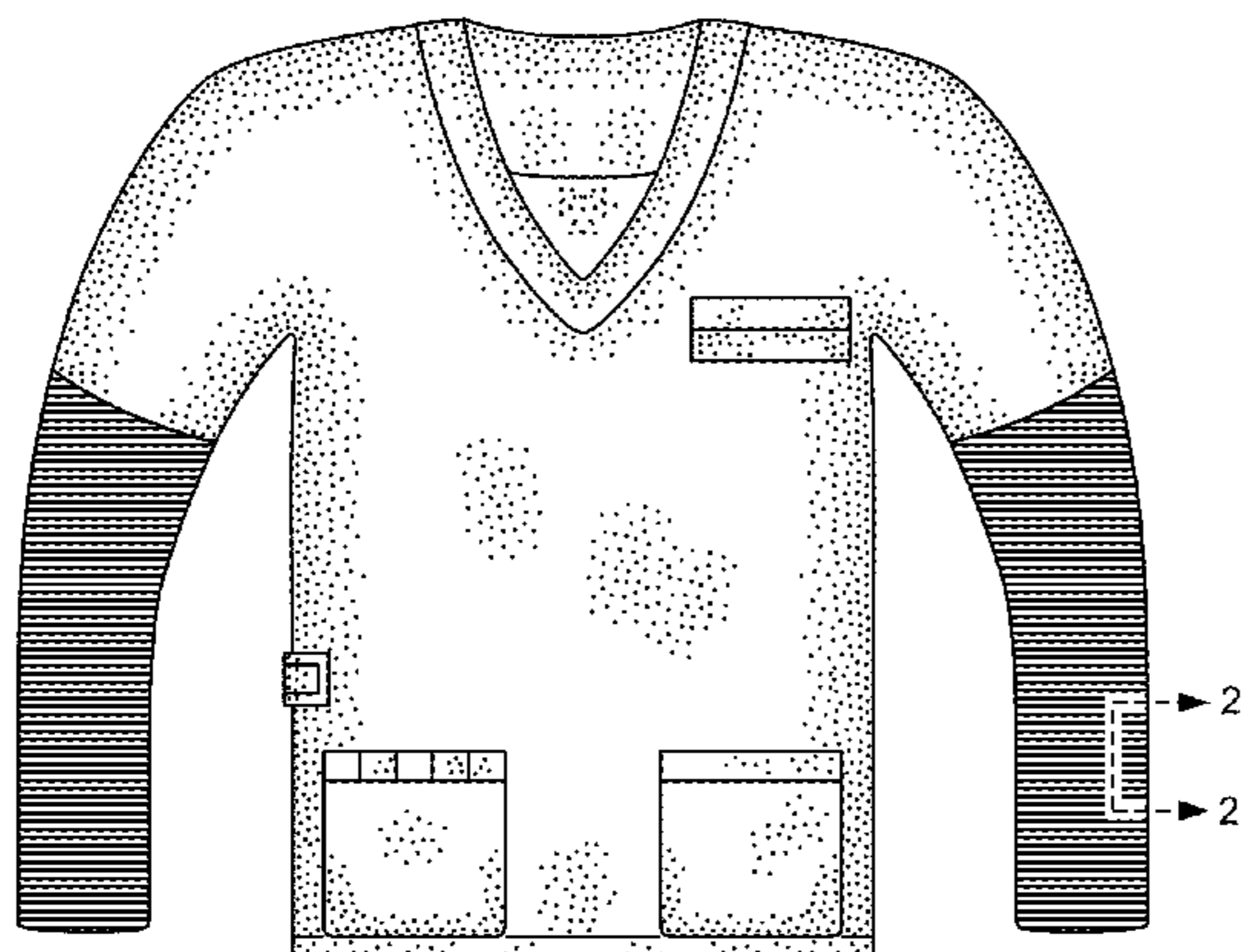
FIG. 5 shows a top view of the medical scrub top of FIG. 1; FIG. 6 shows a left view of the medical scrub top of FIG. 1, with a portion of a sleeve ignored to show the strap of the medical scrub top;

FIG. 8 shows a back view of the medical scrub top of FIG. 1.

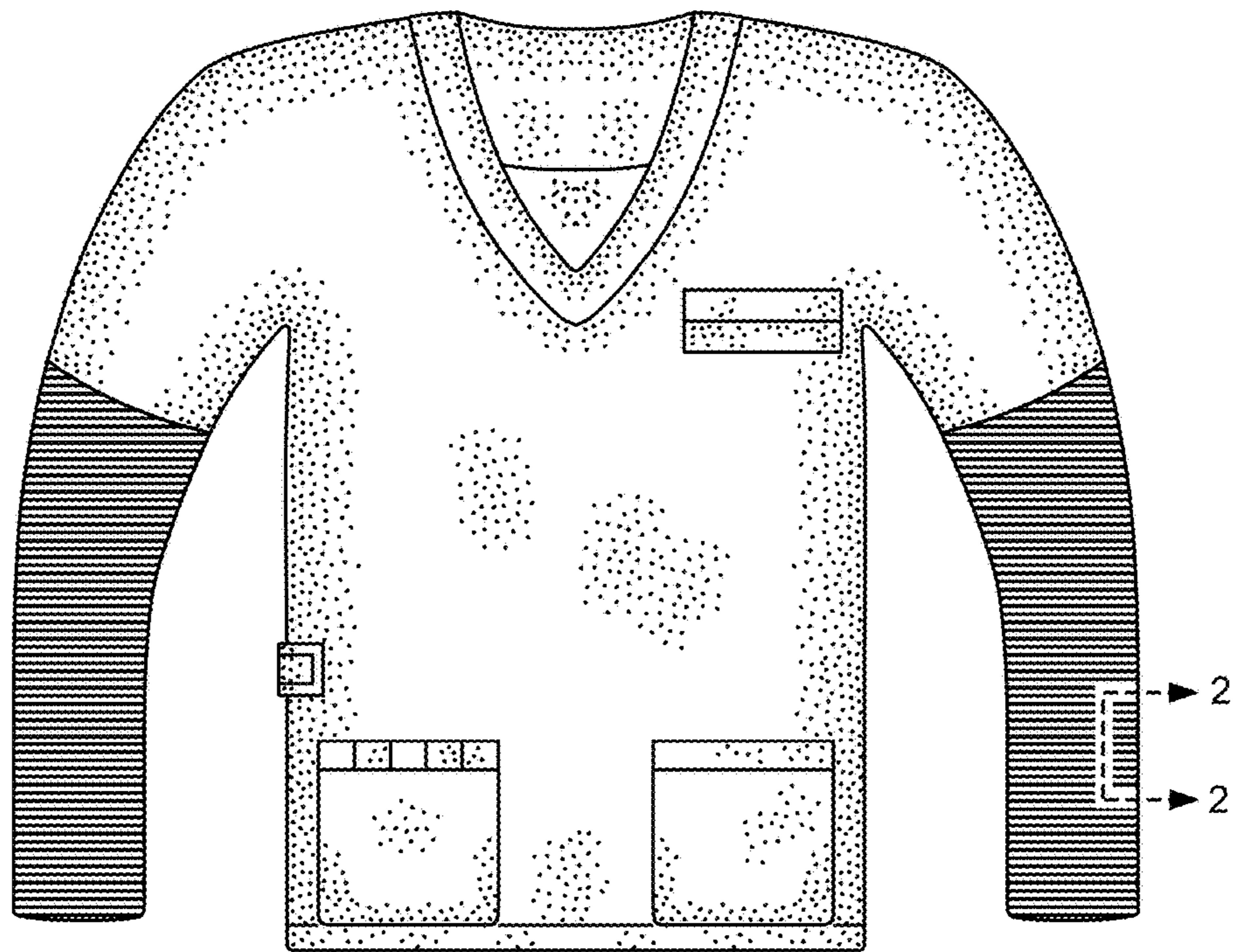

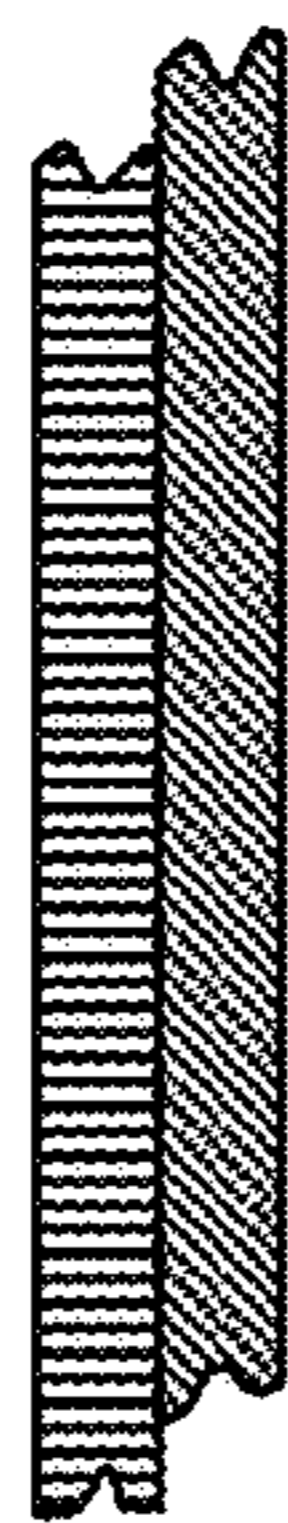

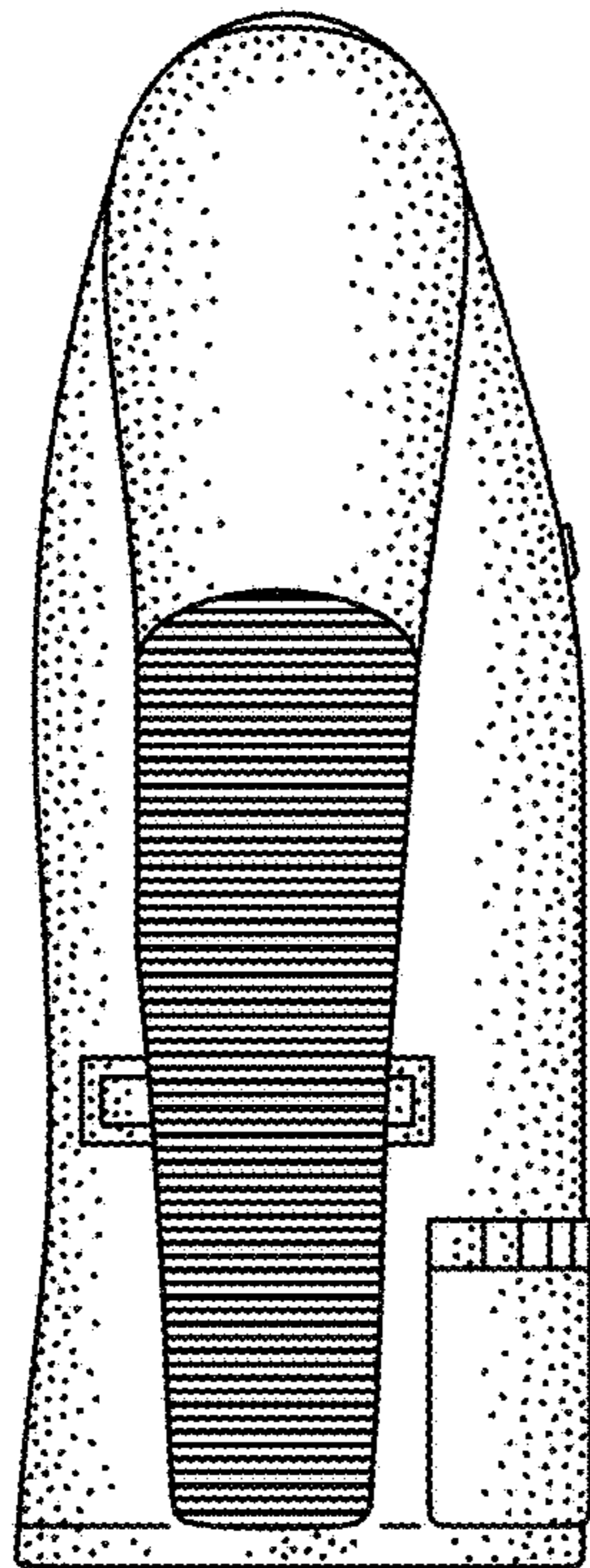

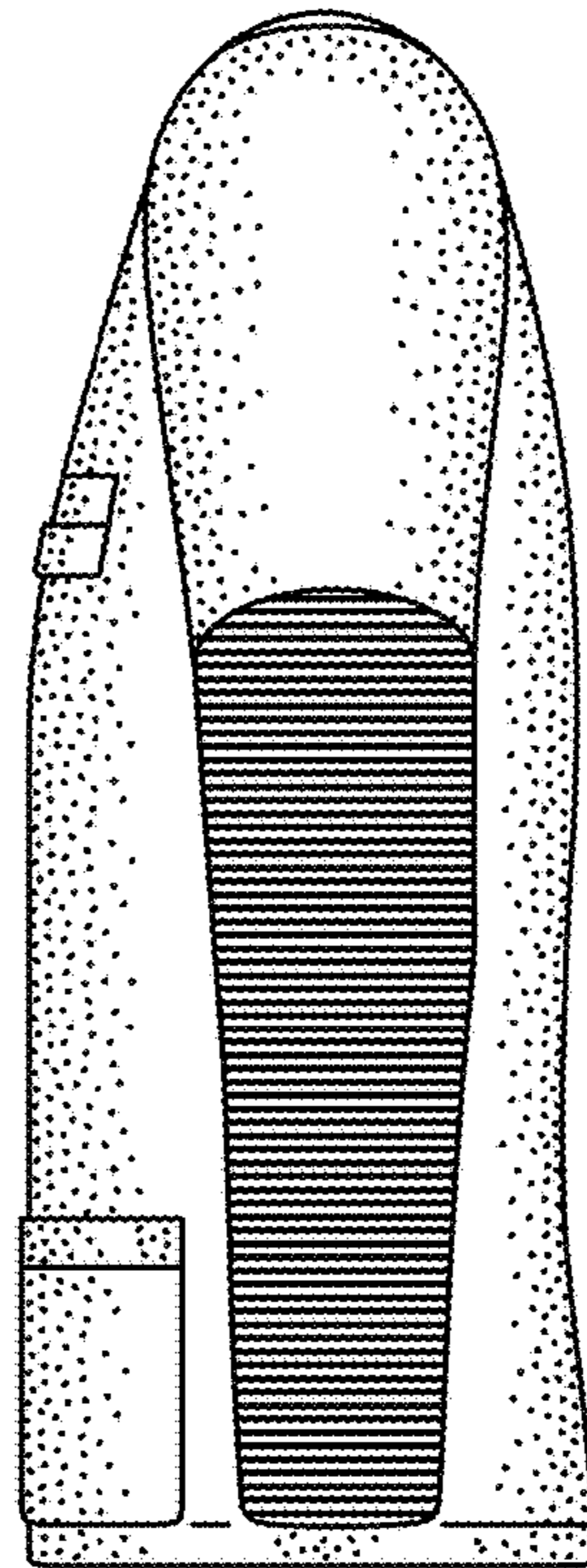

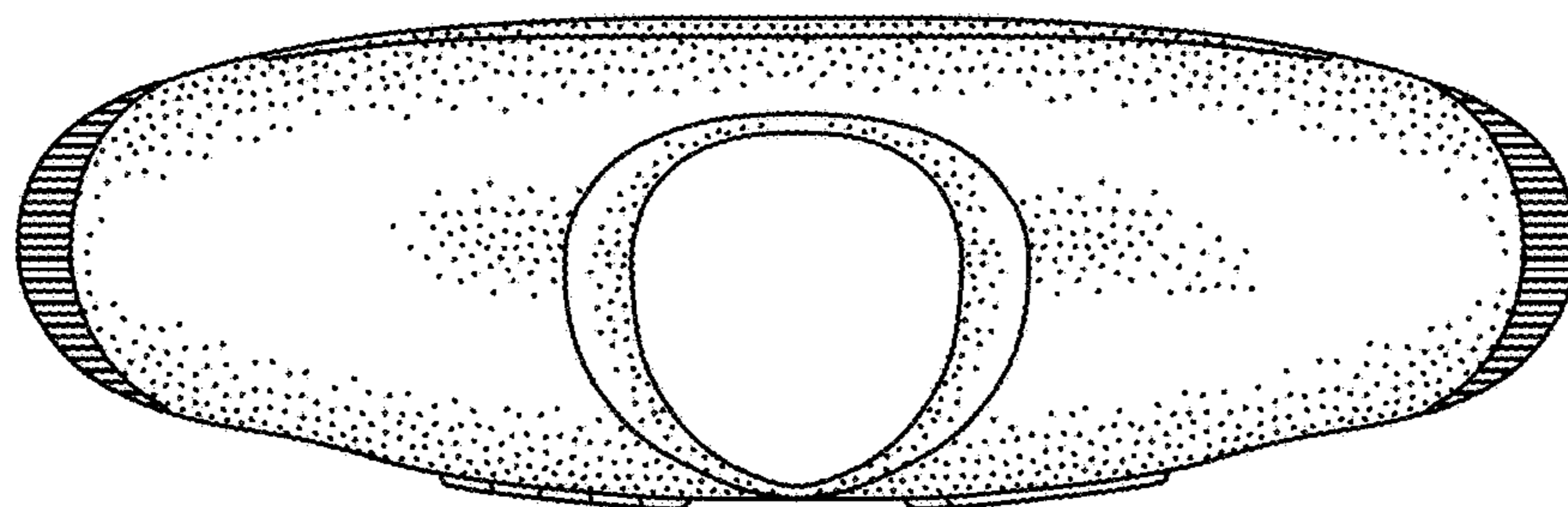

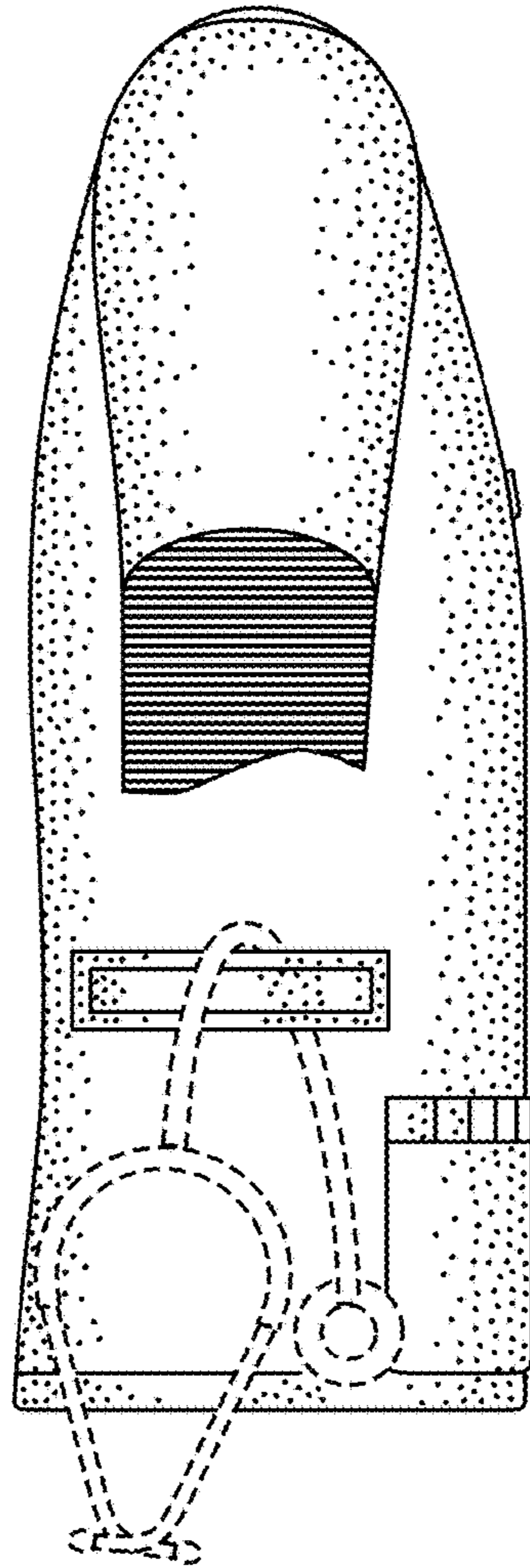

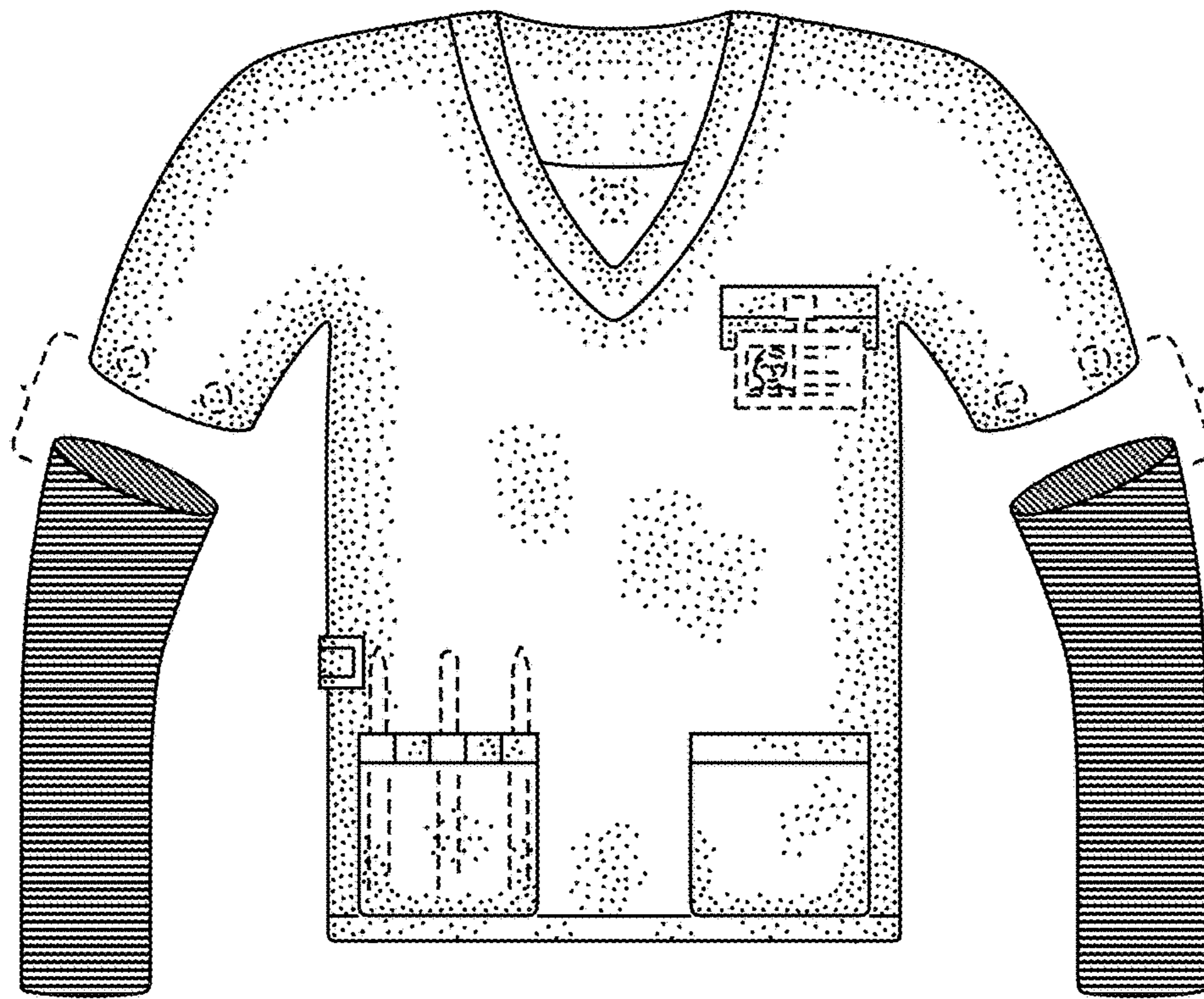

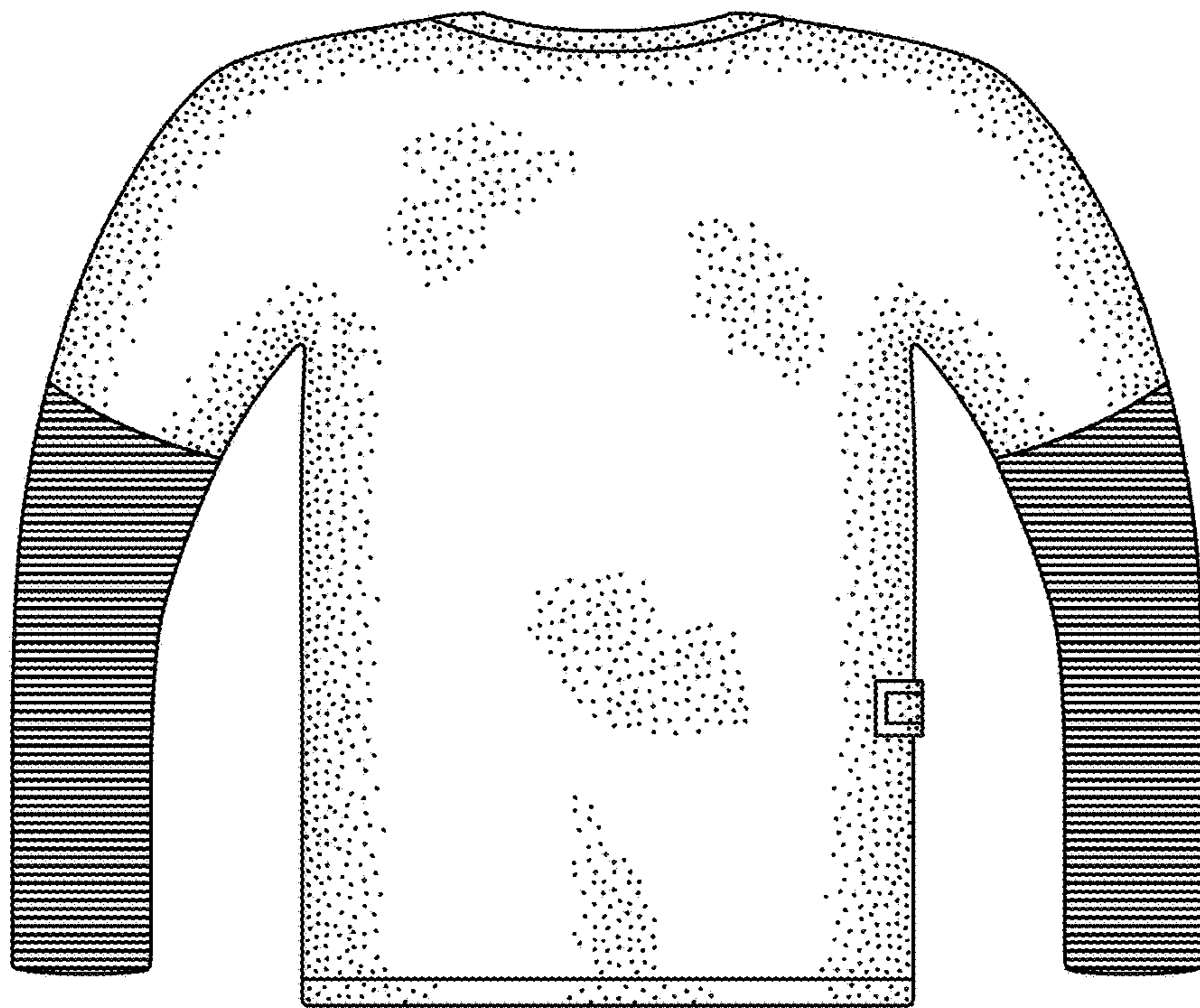
