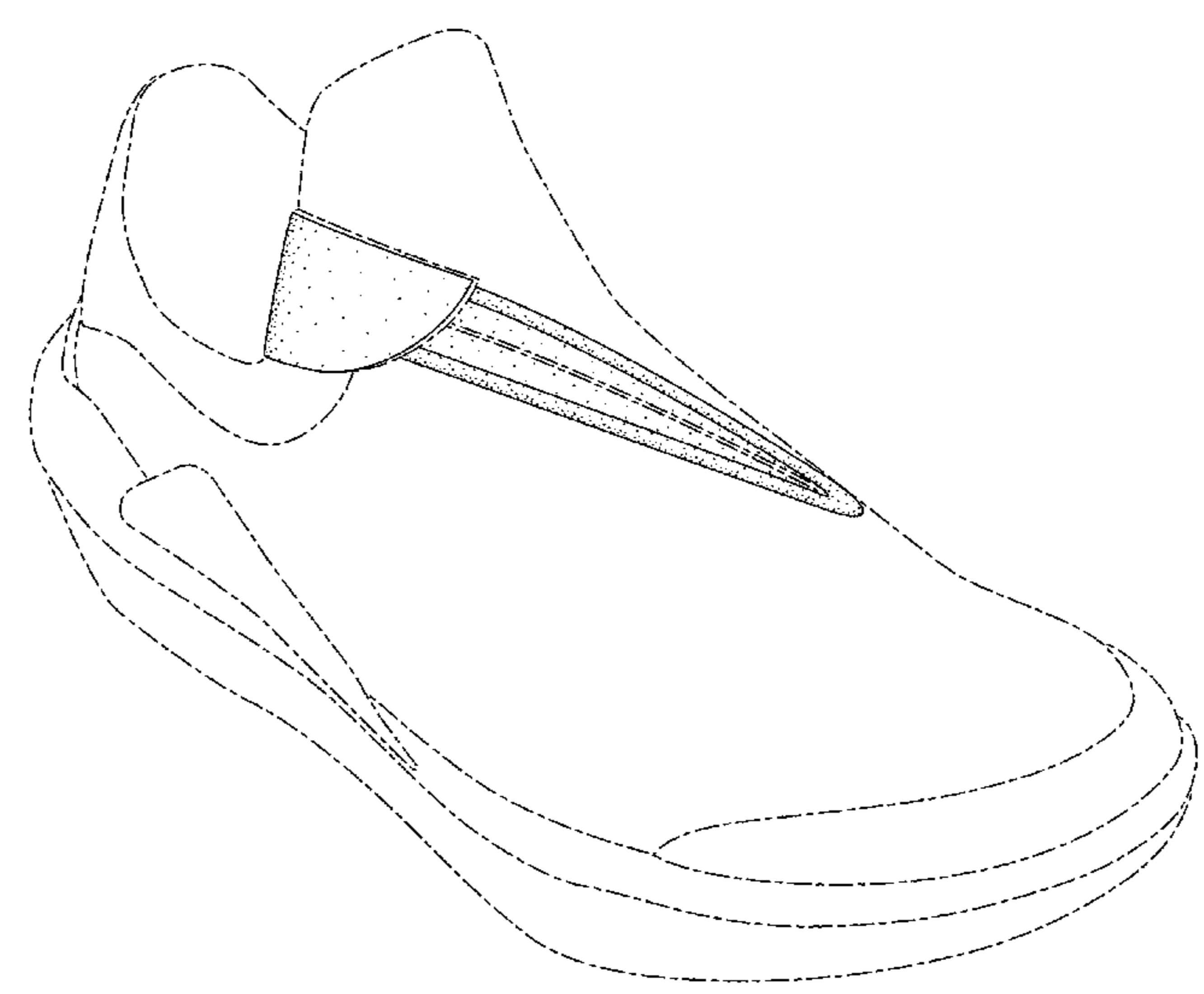
(57) The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is an opposite side front perspective view thereof;  
FIG. 3 is a side view thereof;  
FIG. 4 is a top view thereof; and,  
FIG. 5 is a front view thereof.  
The two parallel broken lines within the shaded area represent a material slit that forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

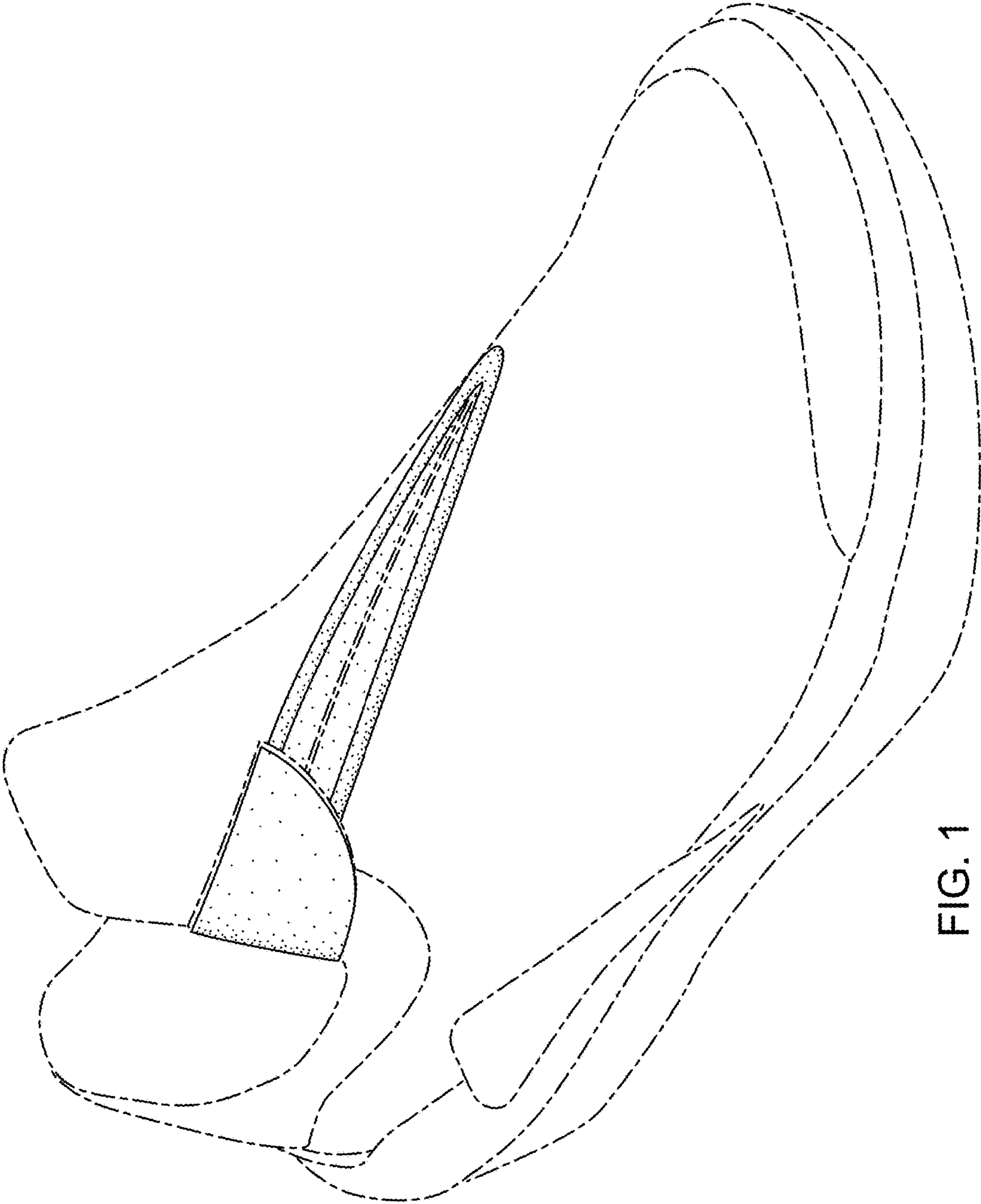

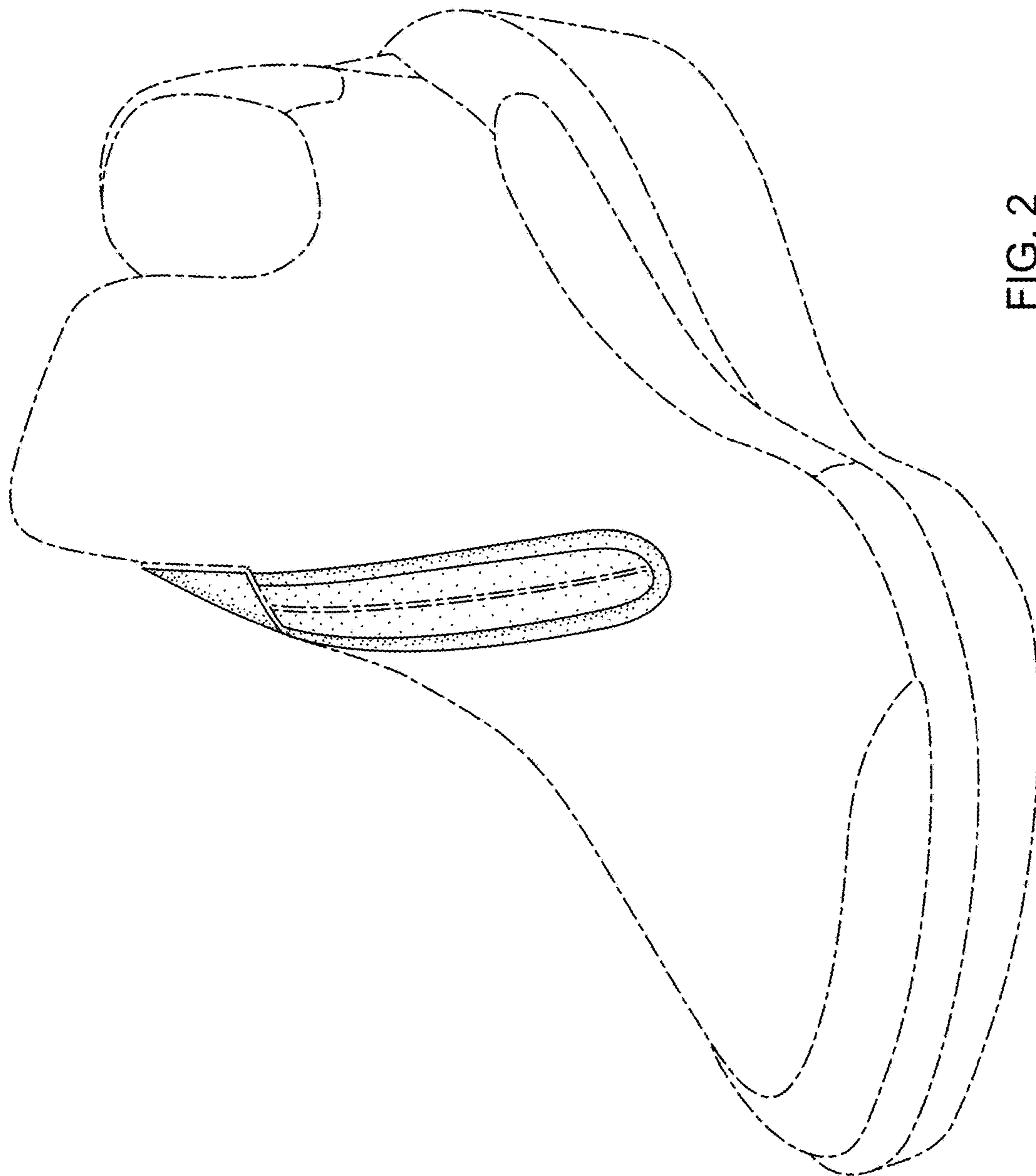

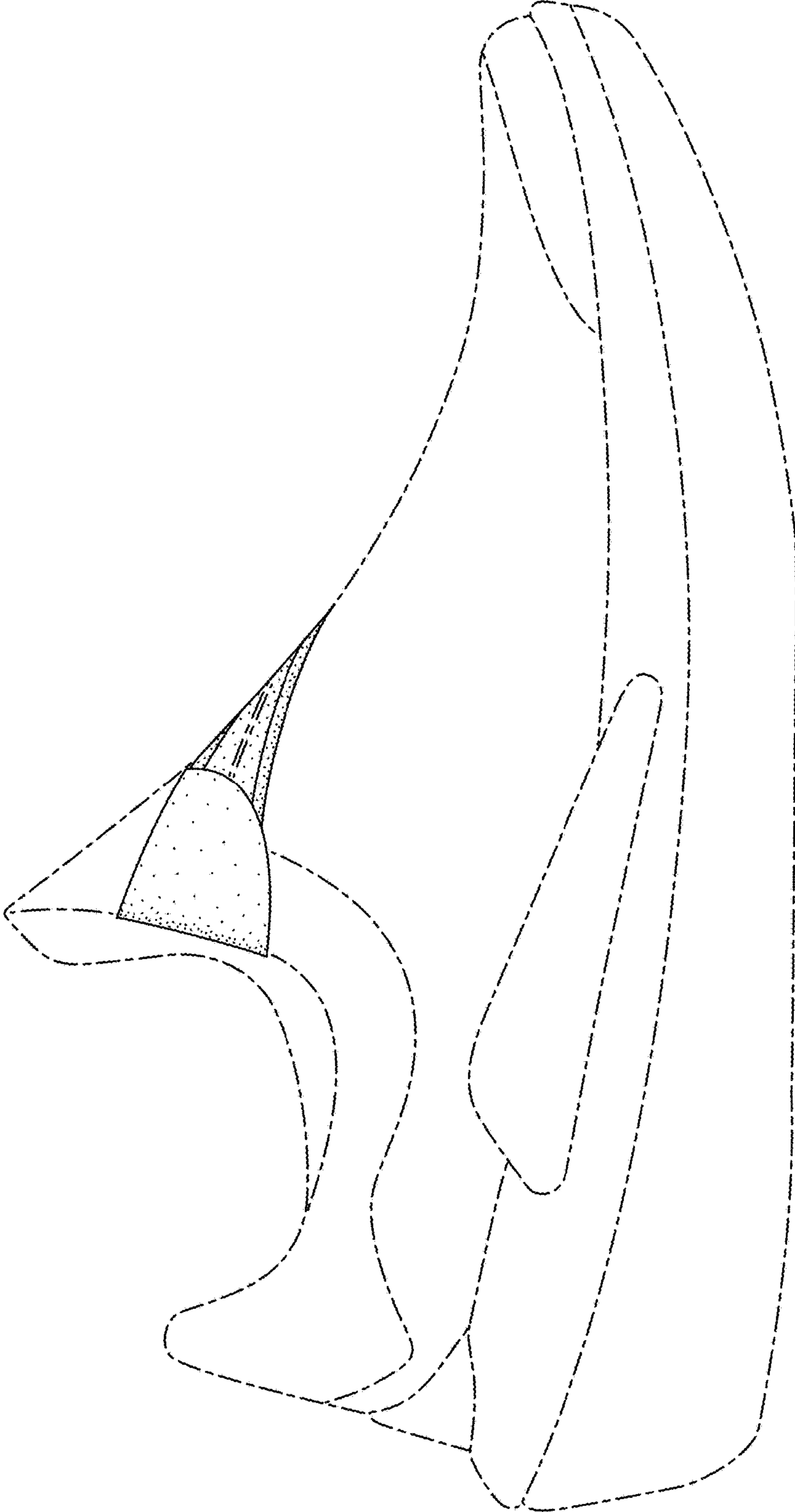

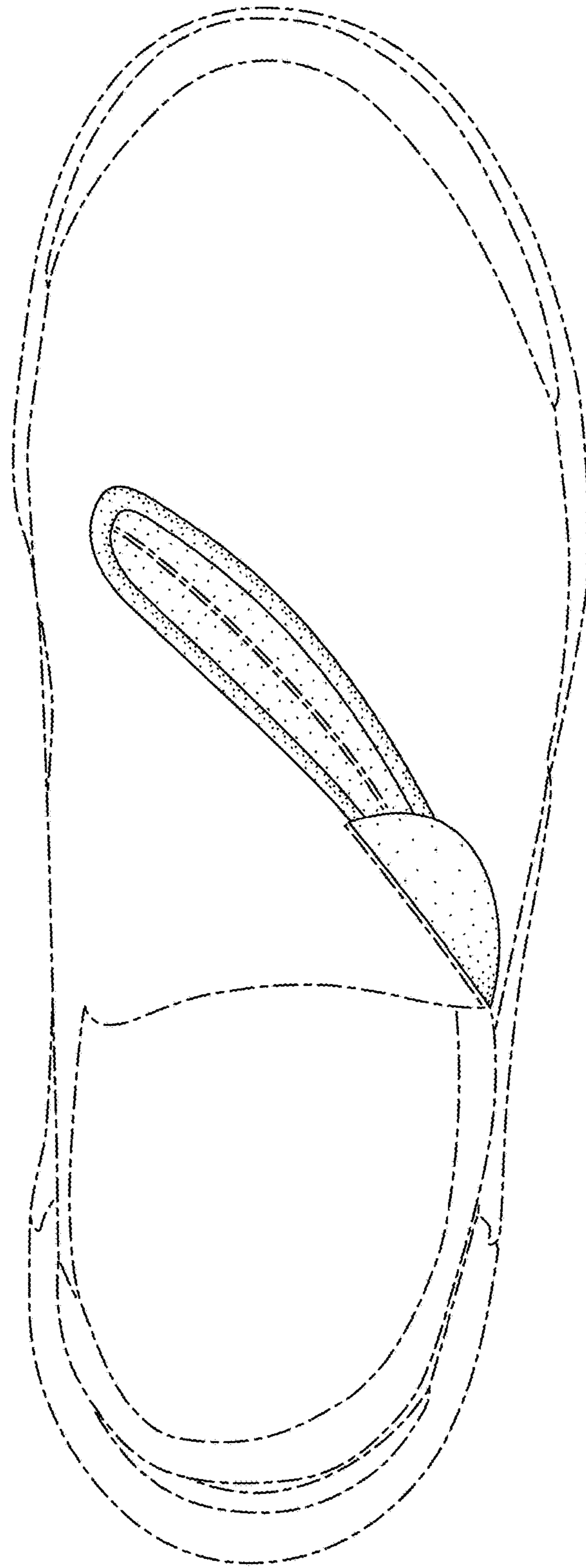

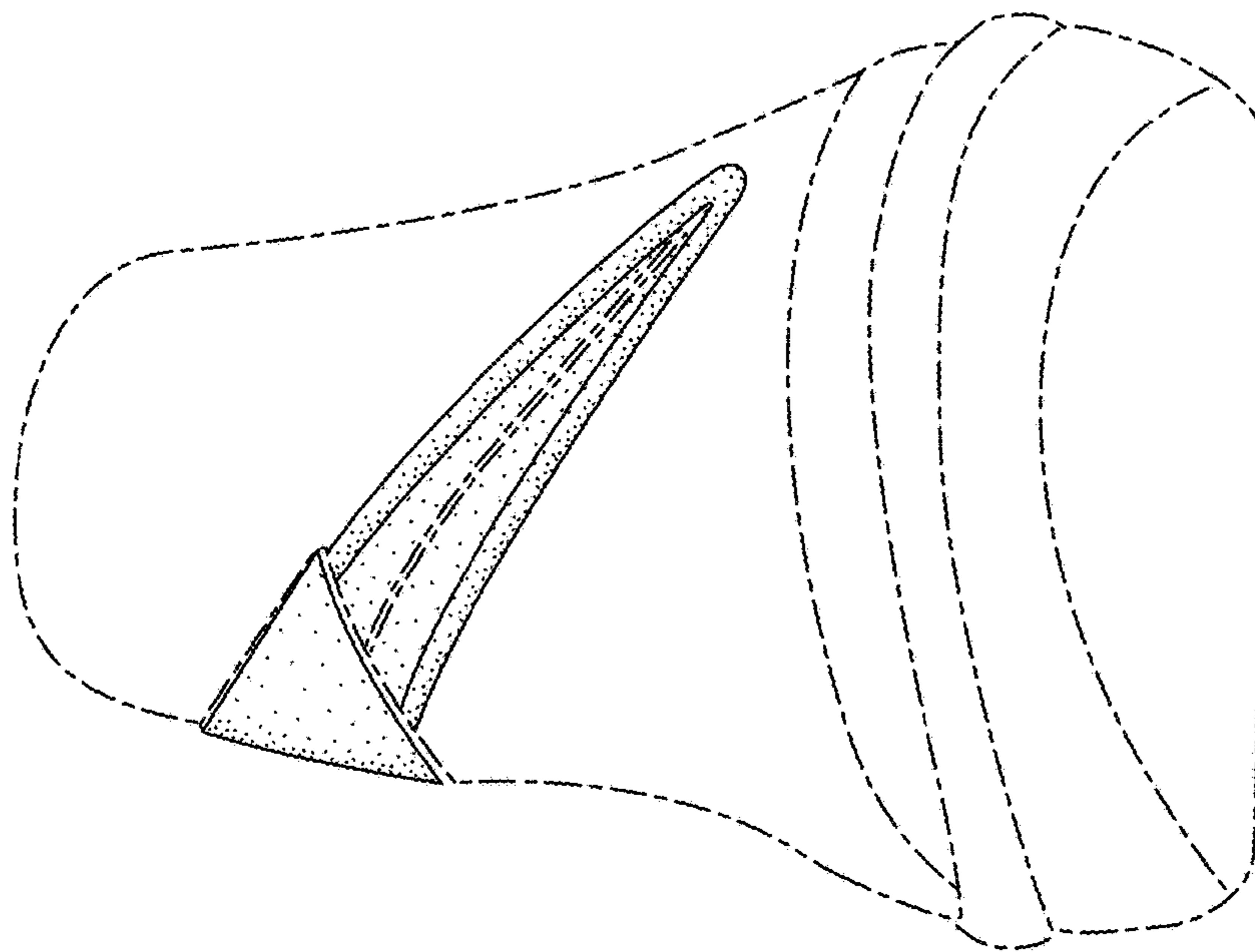
