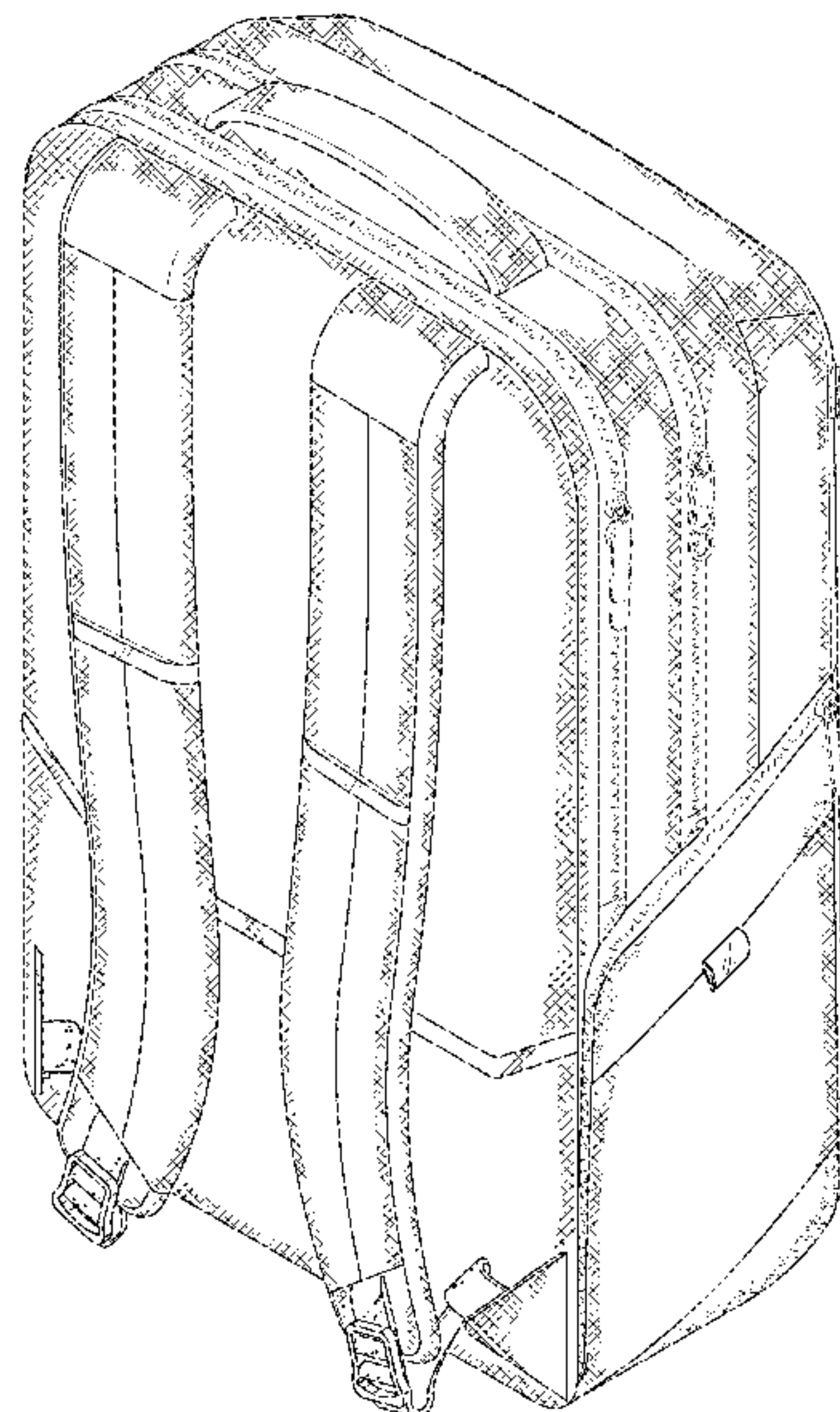
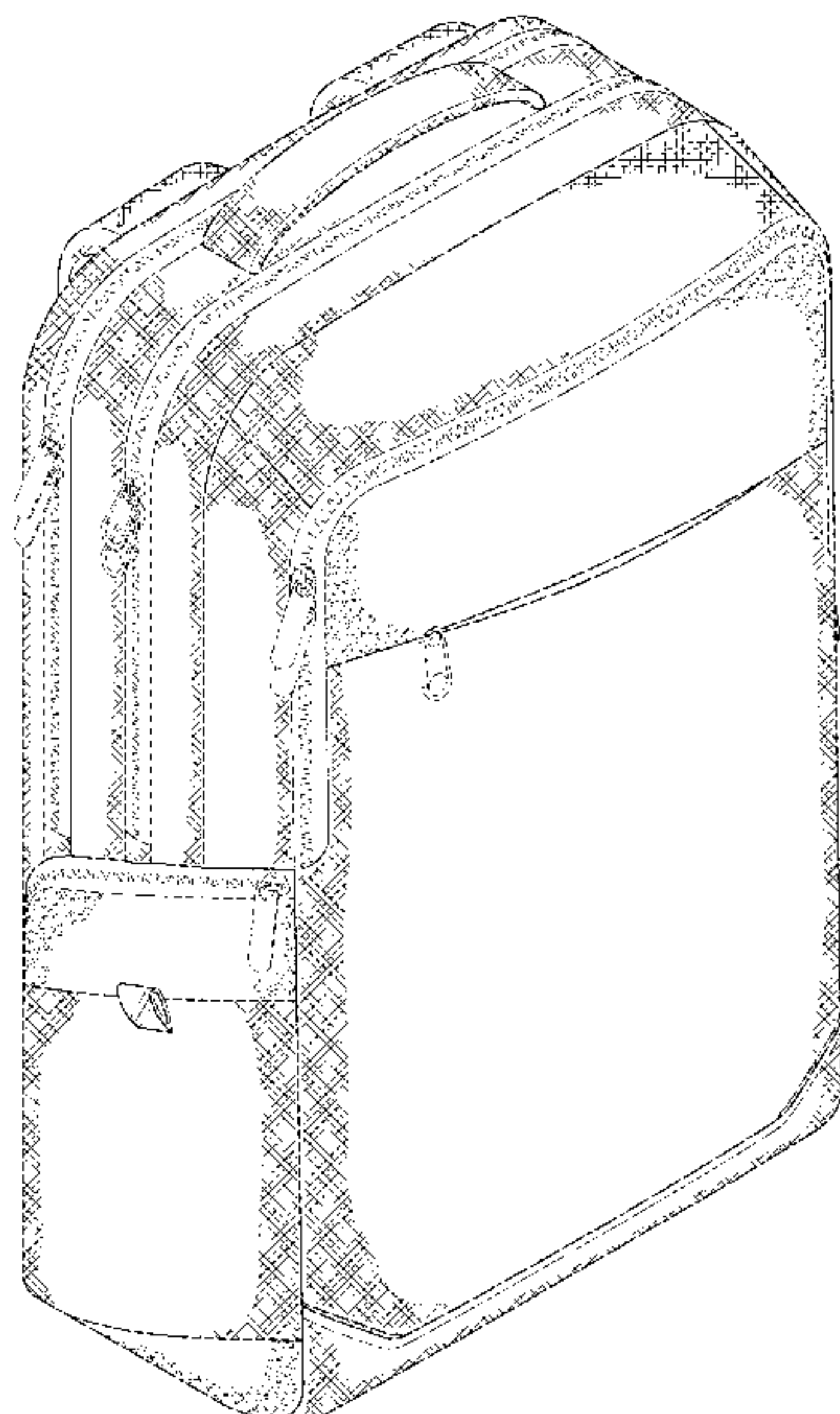
(57) **CLAIM**

We claim the ornamental design for a carry case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a carry case comprising the present invention;  
FIG. 2 is a front elevation view thereof;

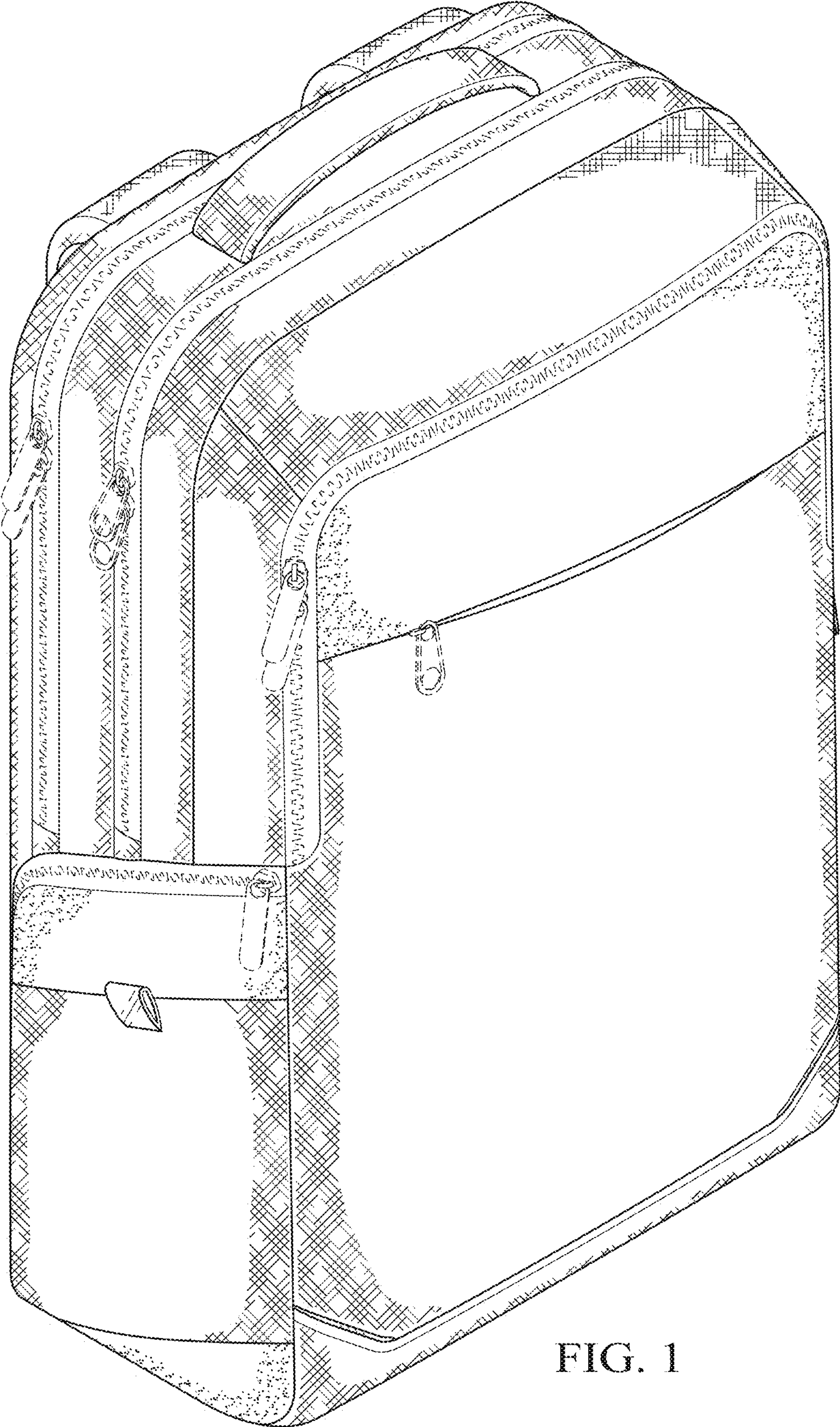

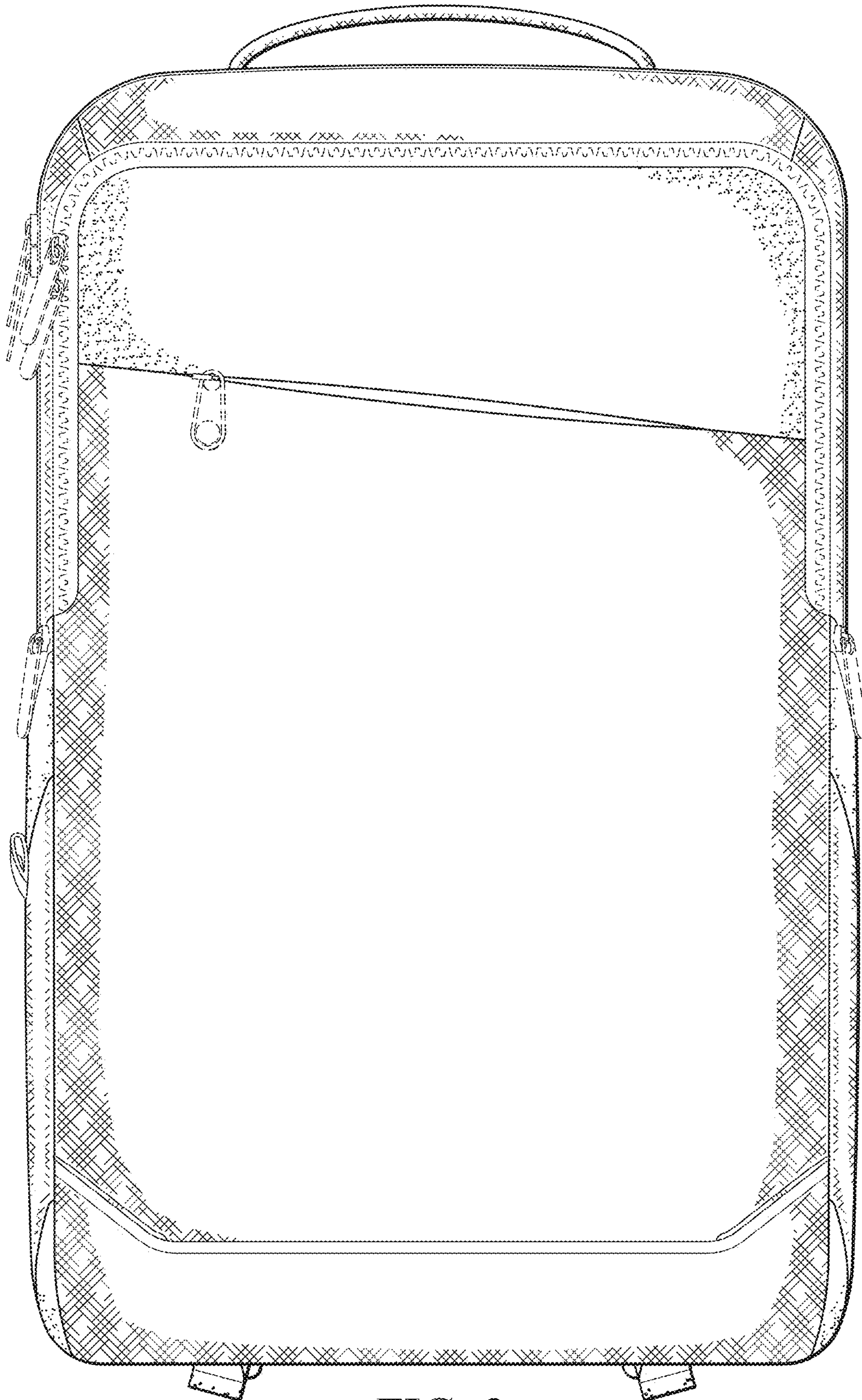

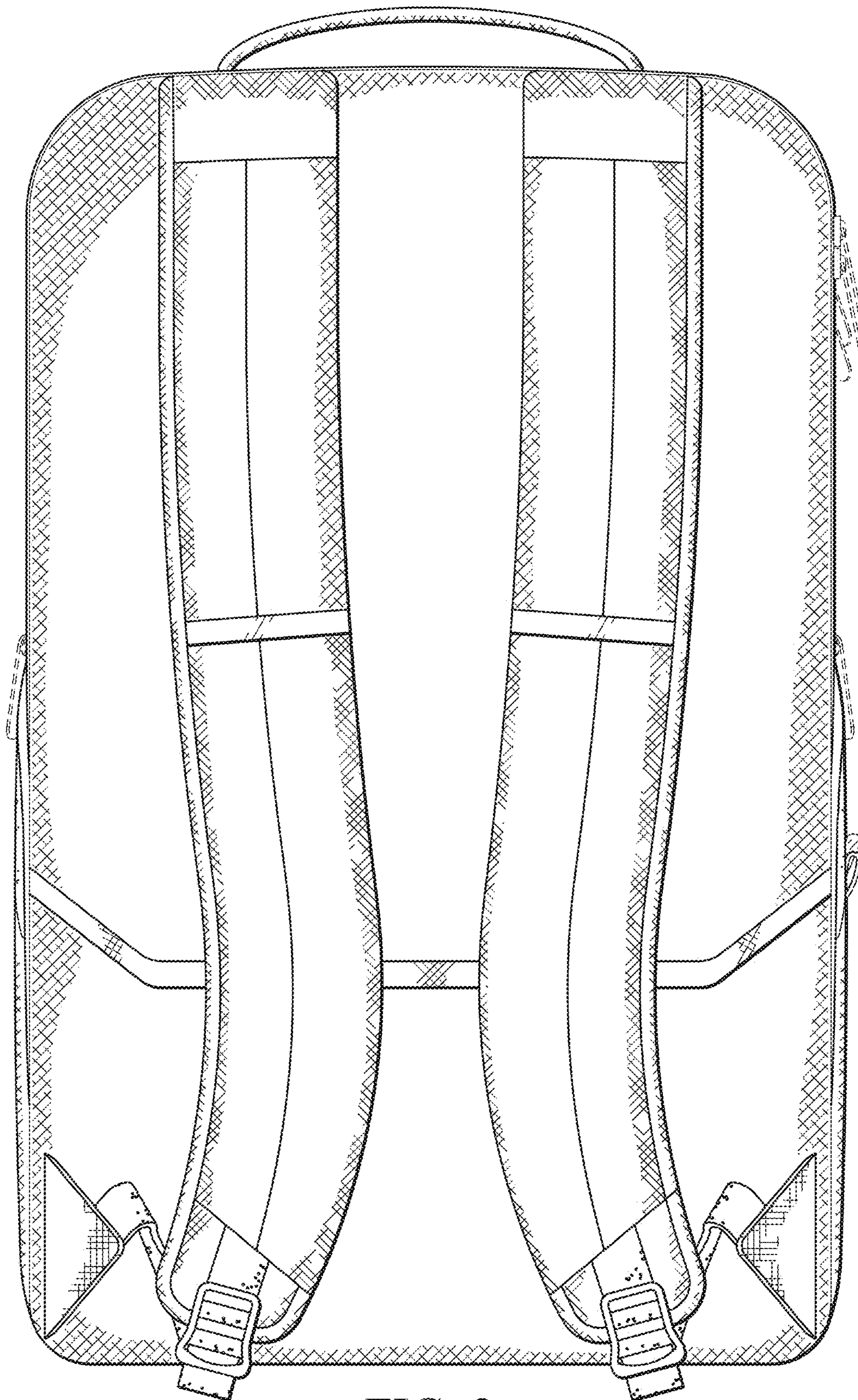

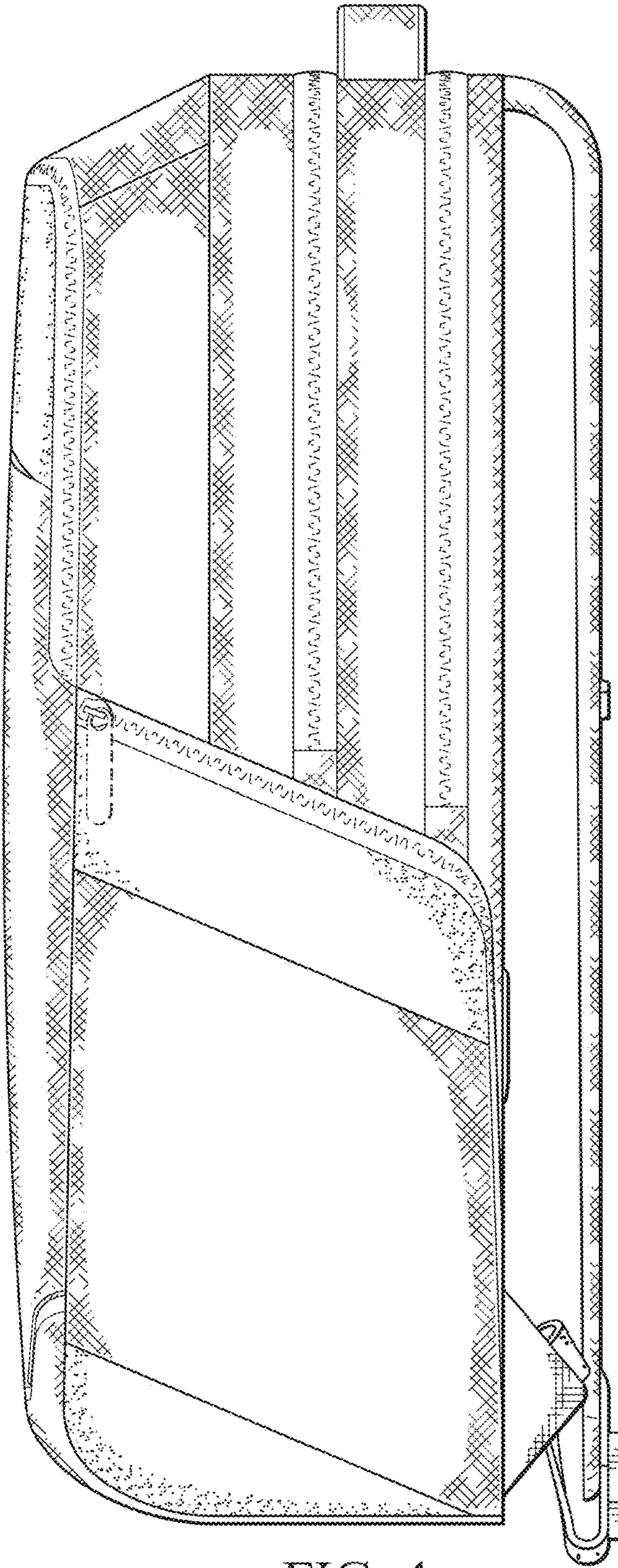

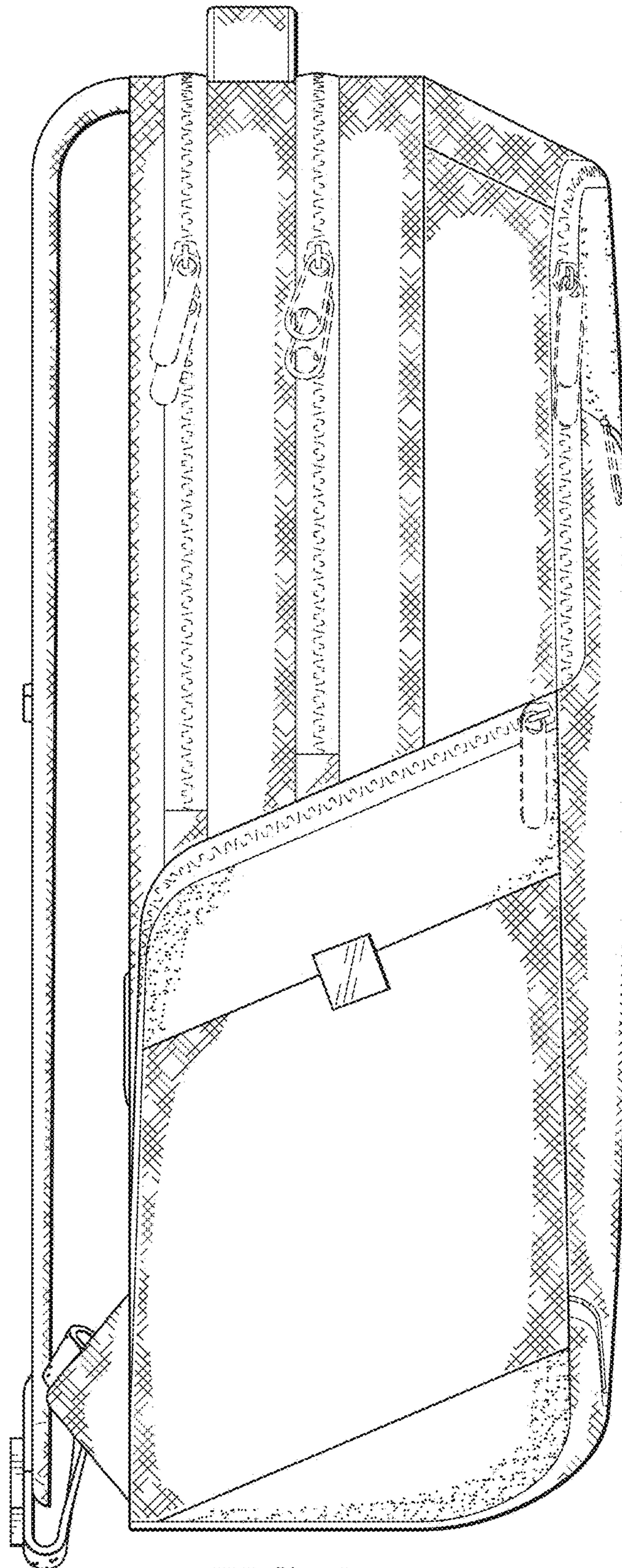

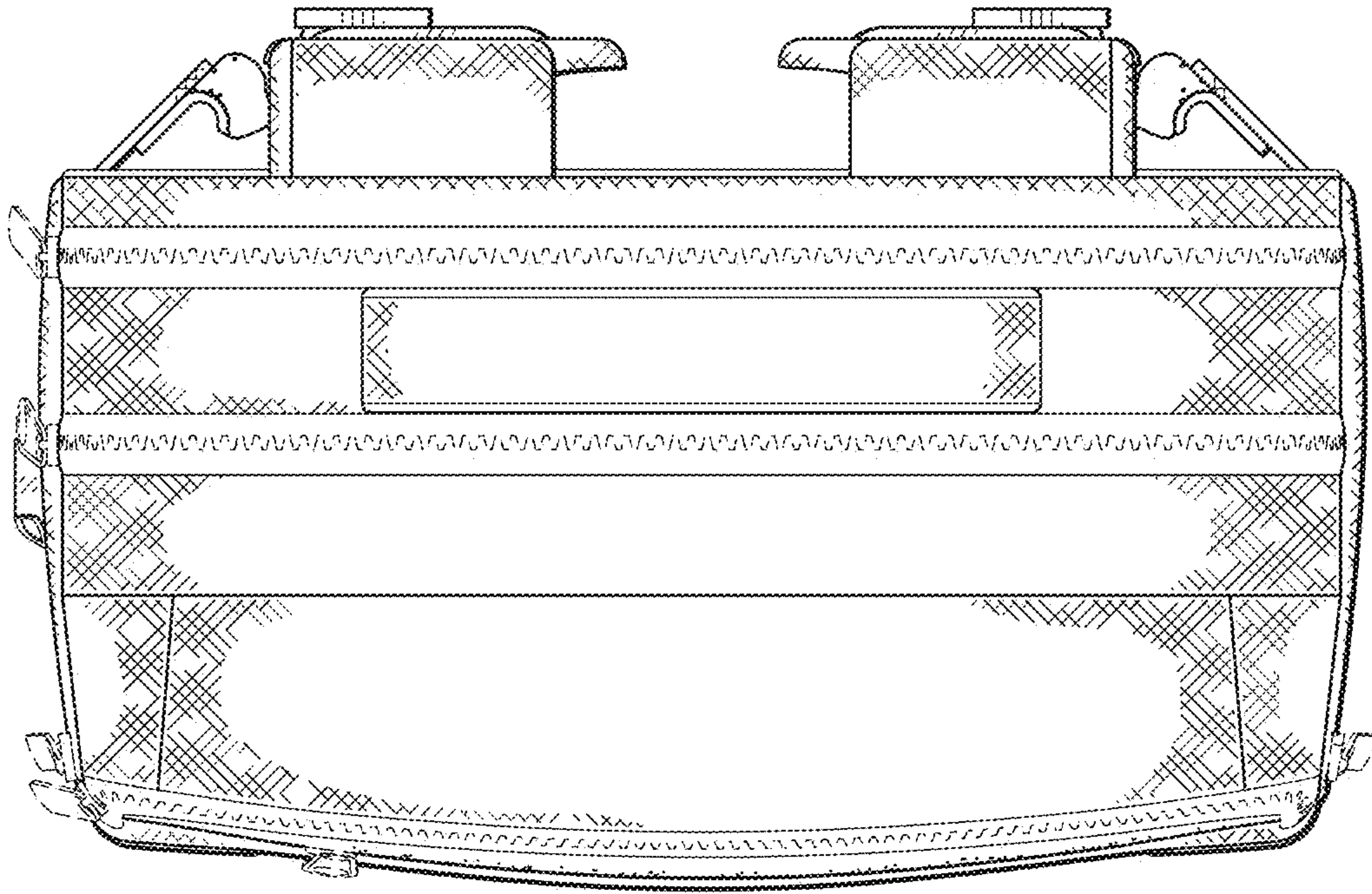

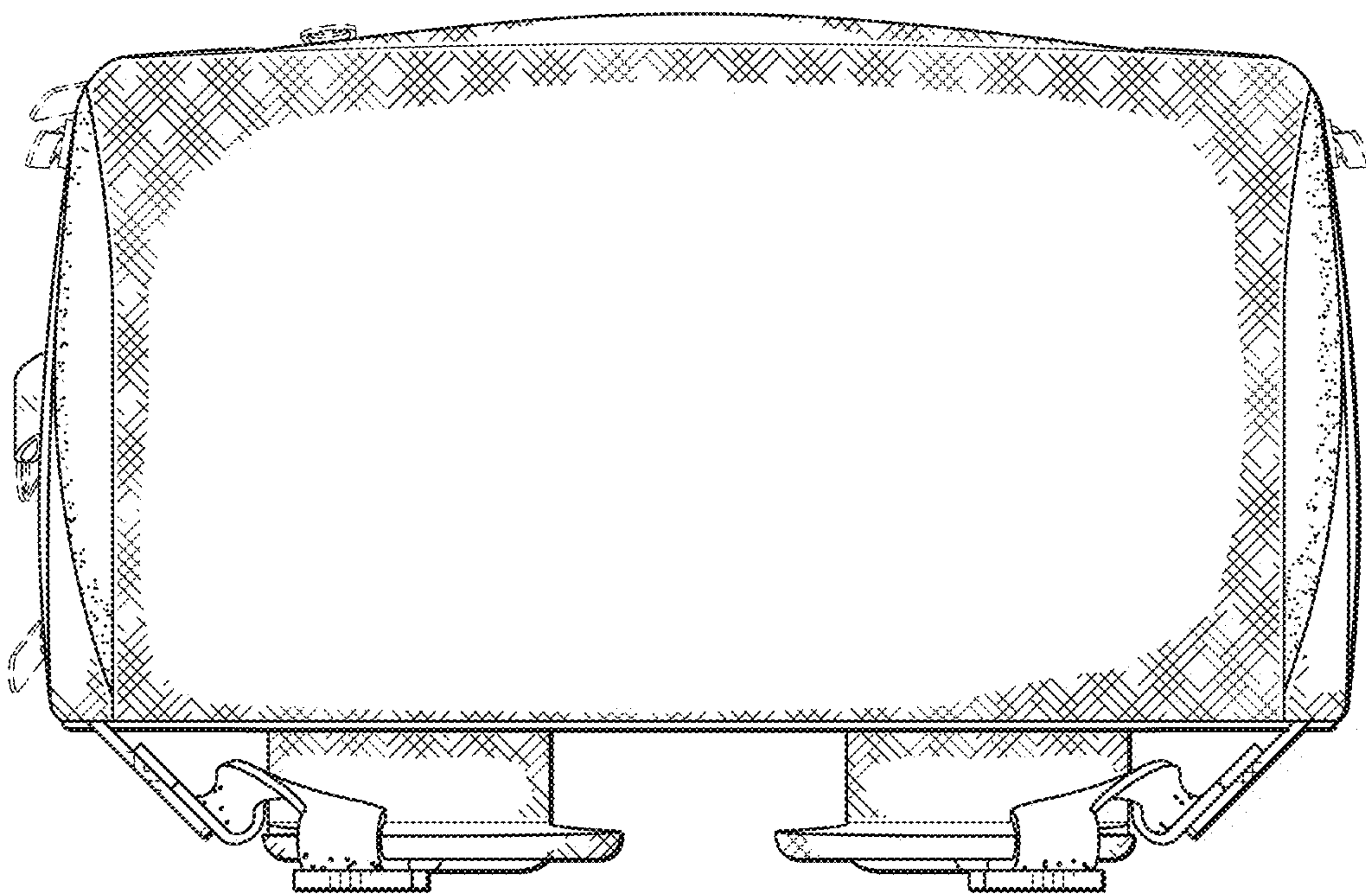

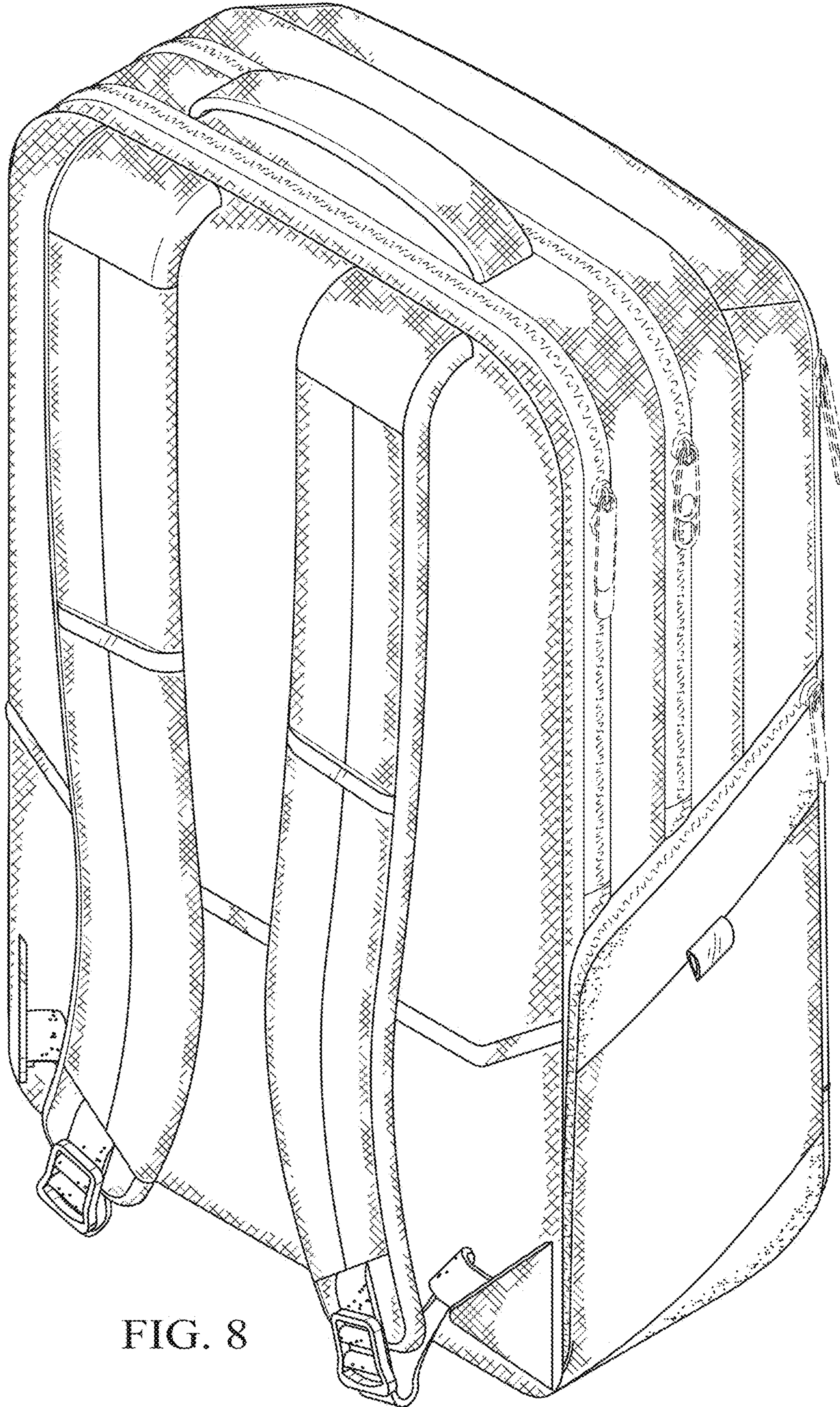
