The ornamental design for a handbag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a handbag showing the new design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a side view thereof; FIG. 5 is another side view thereof, shown from the side opposite that shown in FIG. 4; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines shown in the drawings illustrate environmental structure that forms no part of the claimed design.

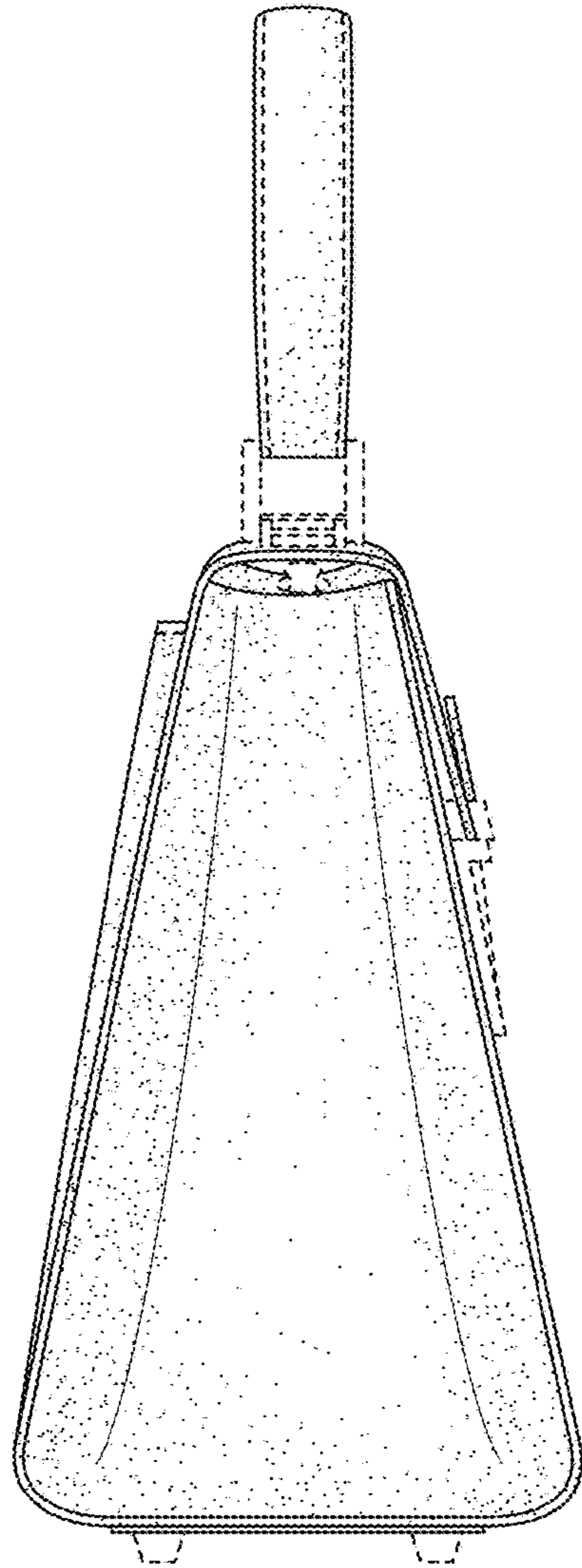

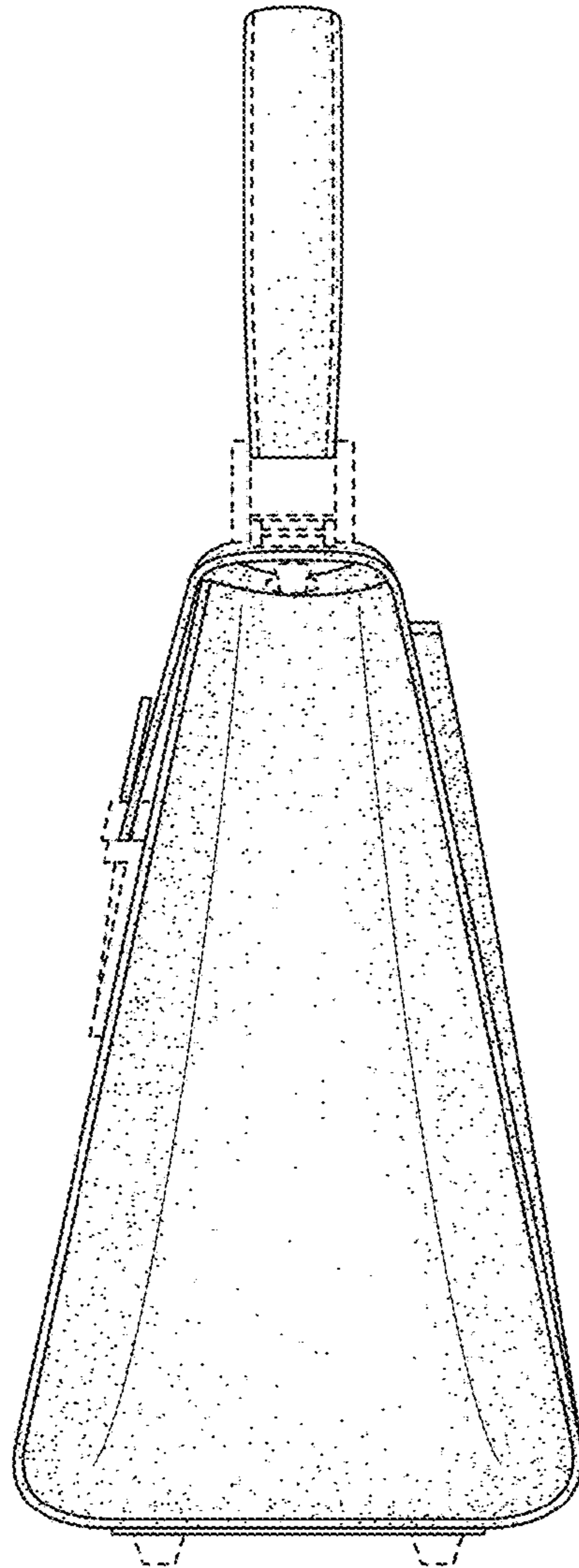

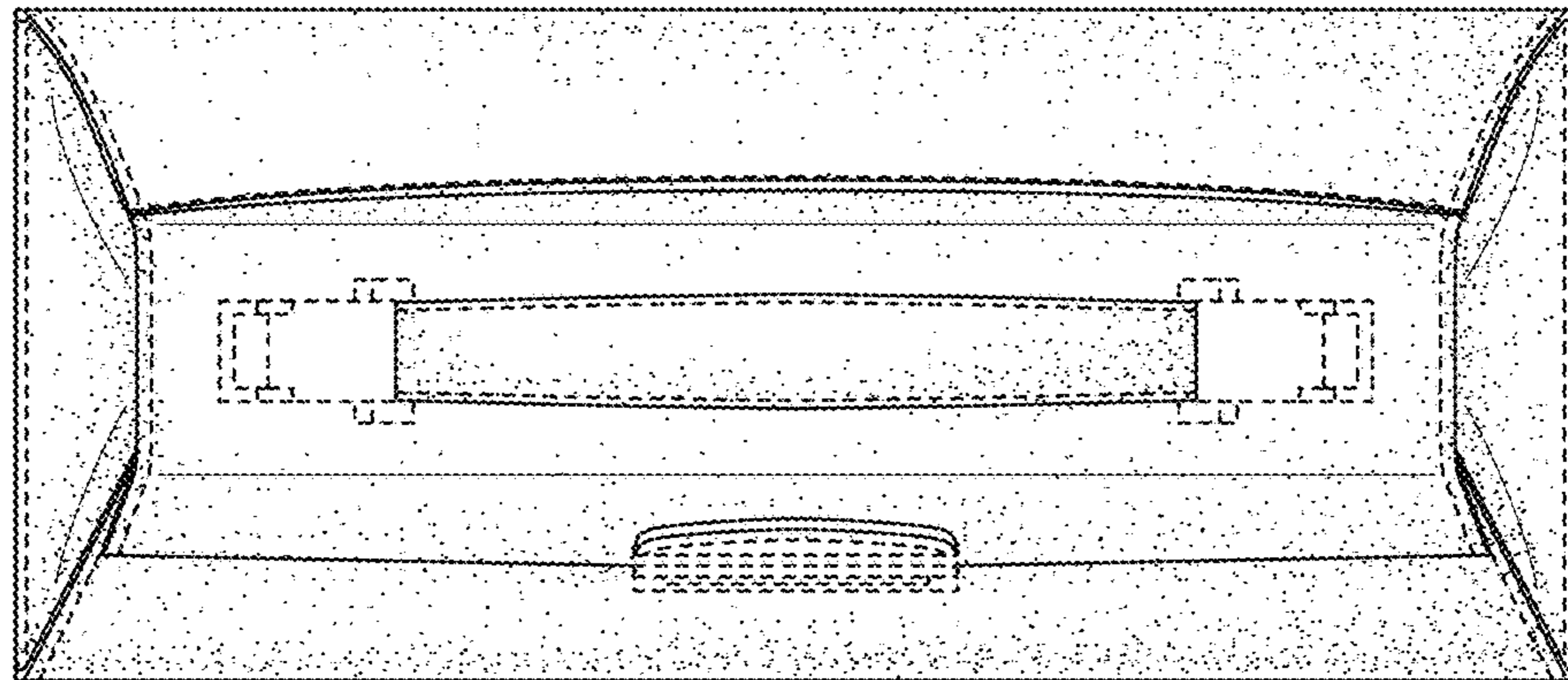

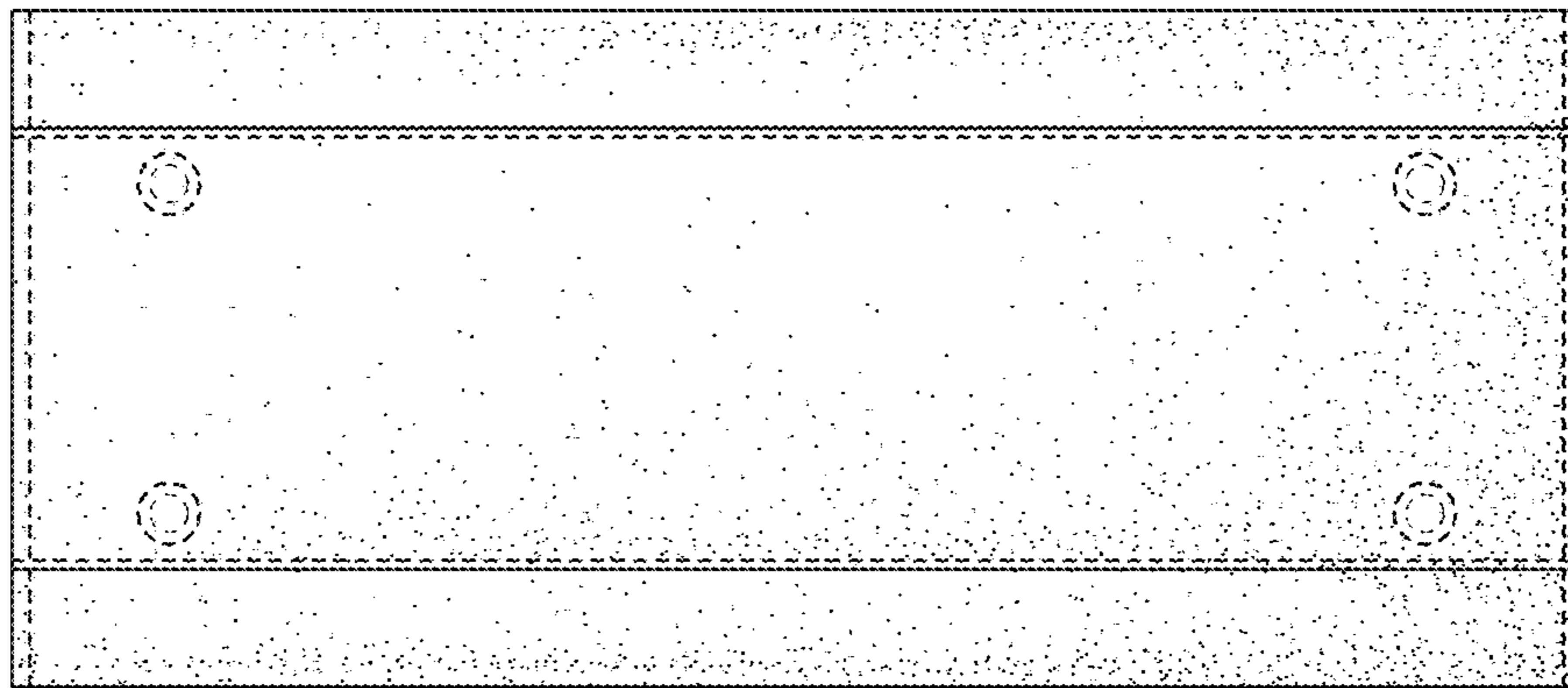
