(57) **CLAIM**

The ornamental design for a grill brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a grill brush, showing my new design, said view being reduced to show an entire assembly in use;

FIG. 2 is an enlarged perspective view of FIG. 1;

FIG. 3 is a front elevation view of FIG. 2, the rear elevation view being a mirror image thereof;

FIG. 4 is a top plan view of FIG. 2;

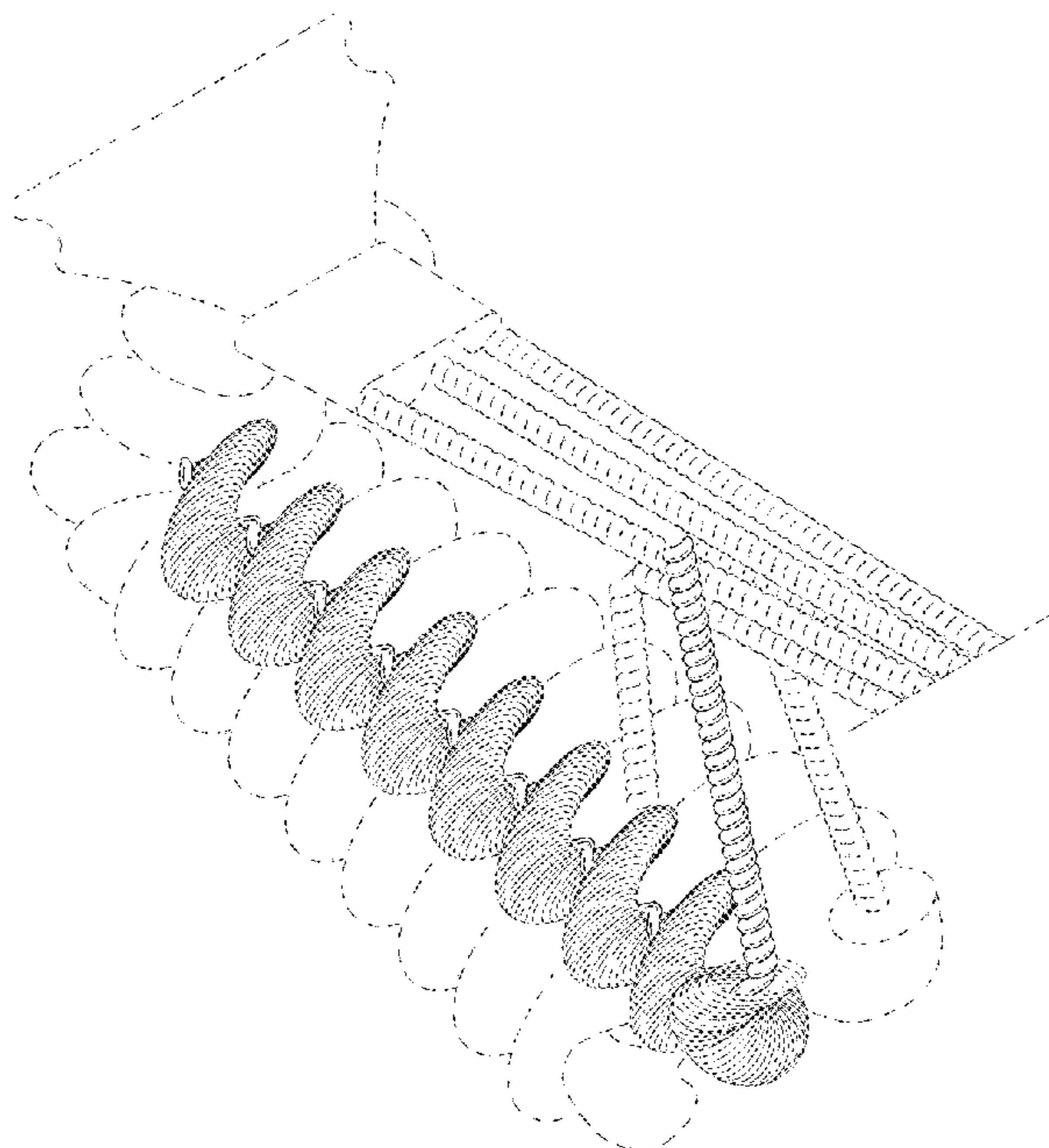
FIG. 5 is a bottom plan view of FIG. 2;

FIG. 6 is a right elevation view of FIG. 2; and,

FIG. 7 is a left elevation view of FIG. 2.

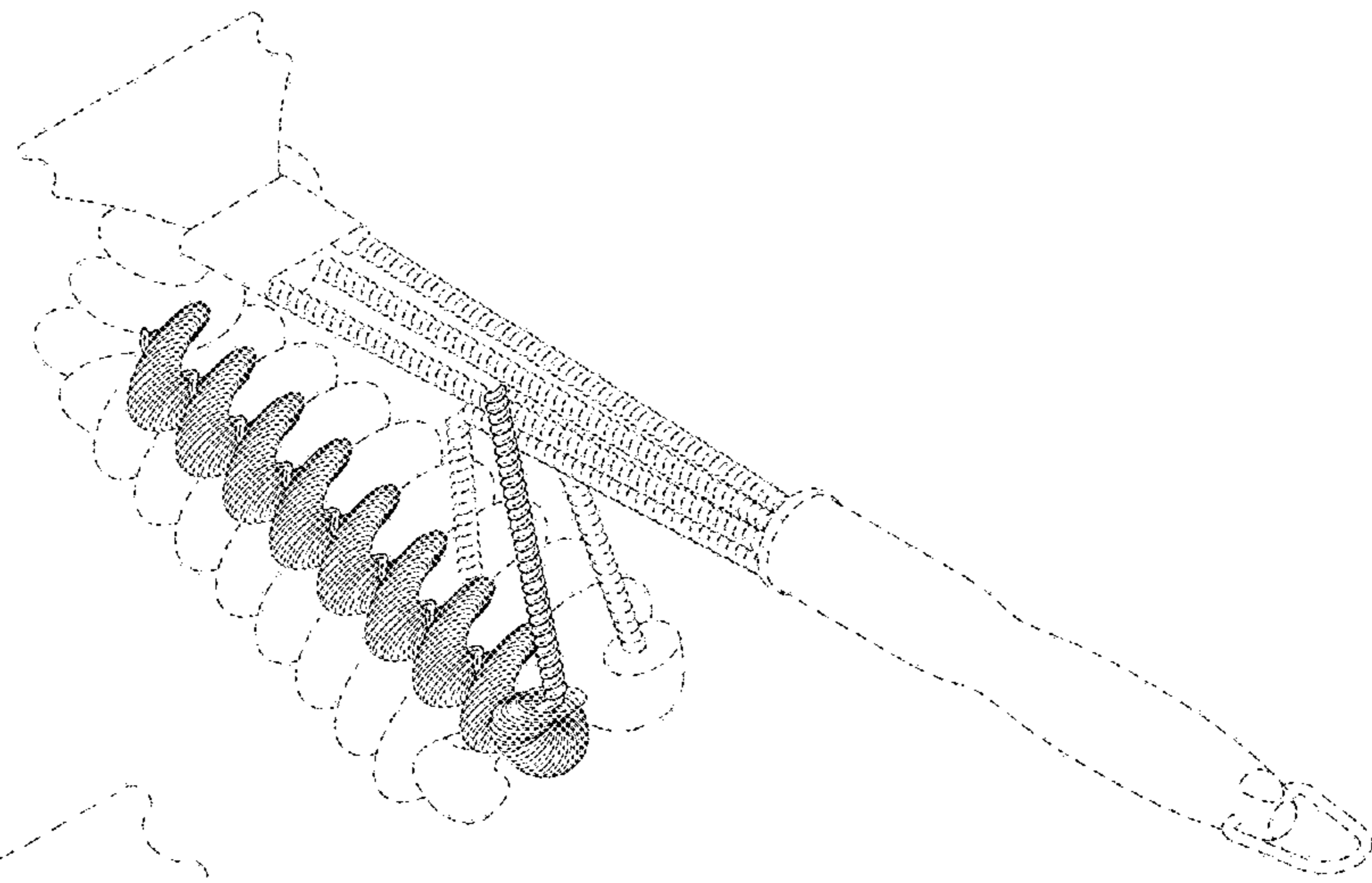

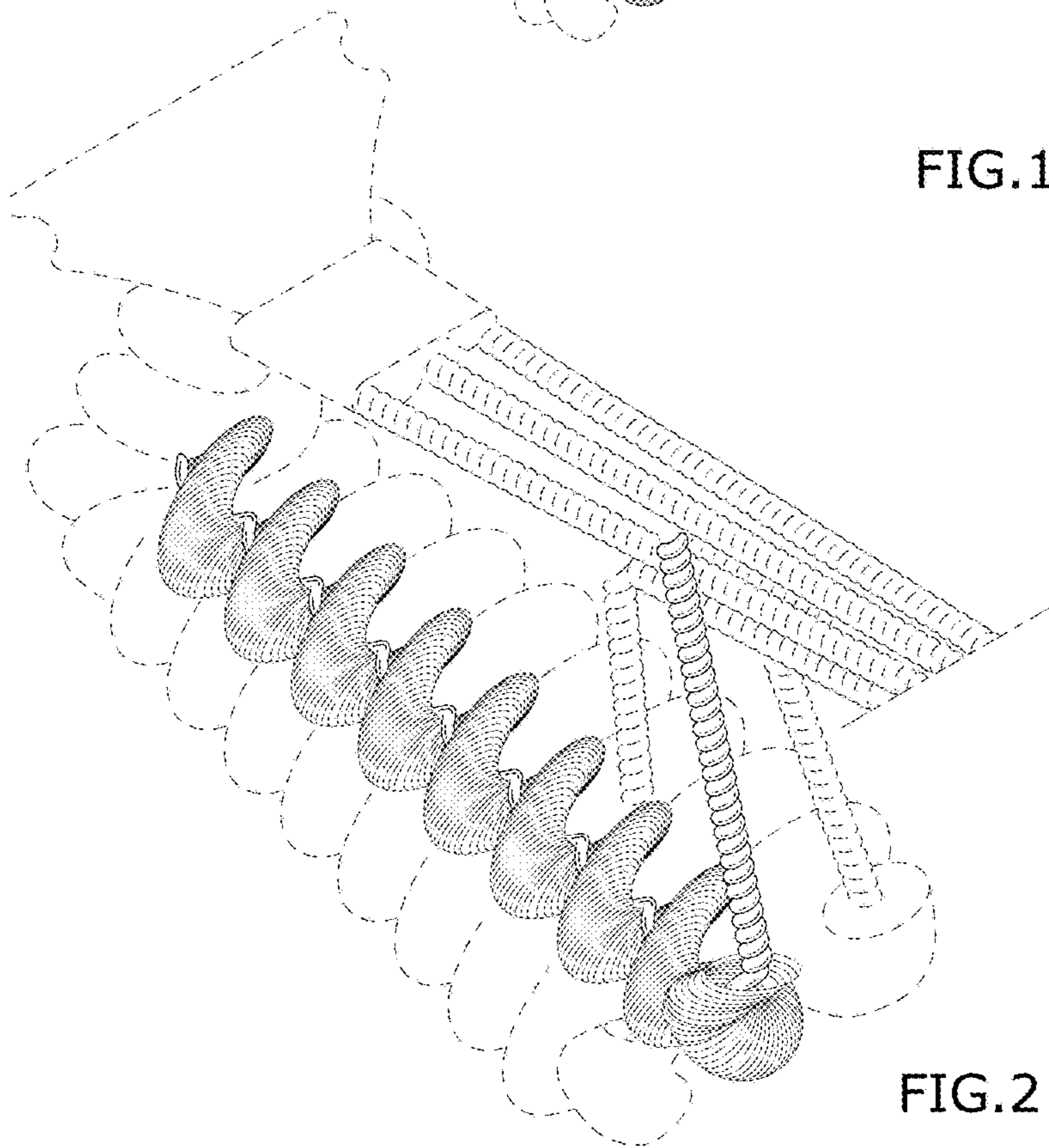

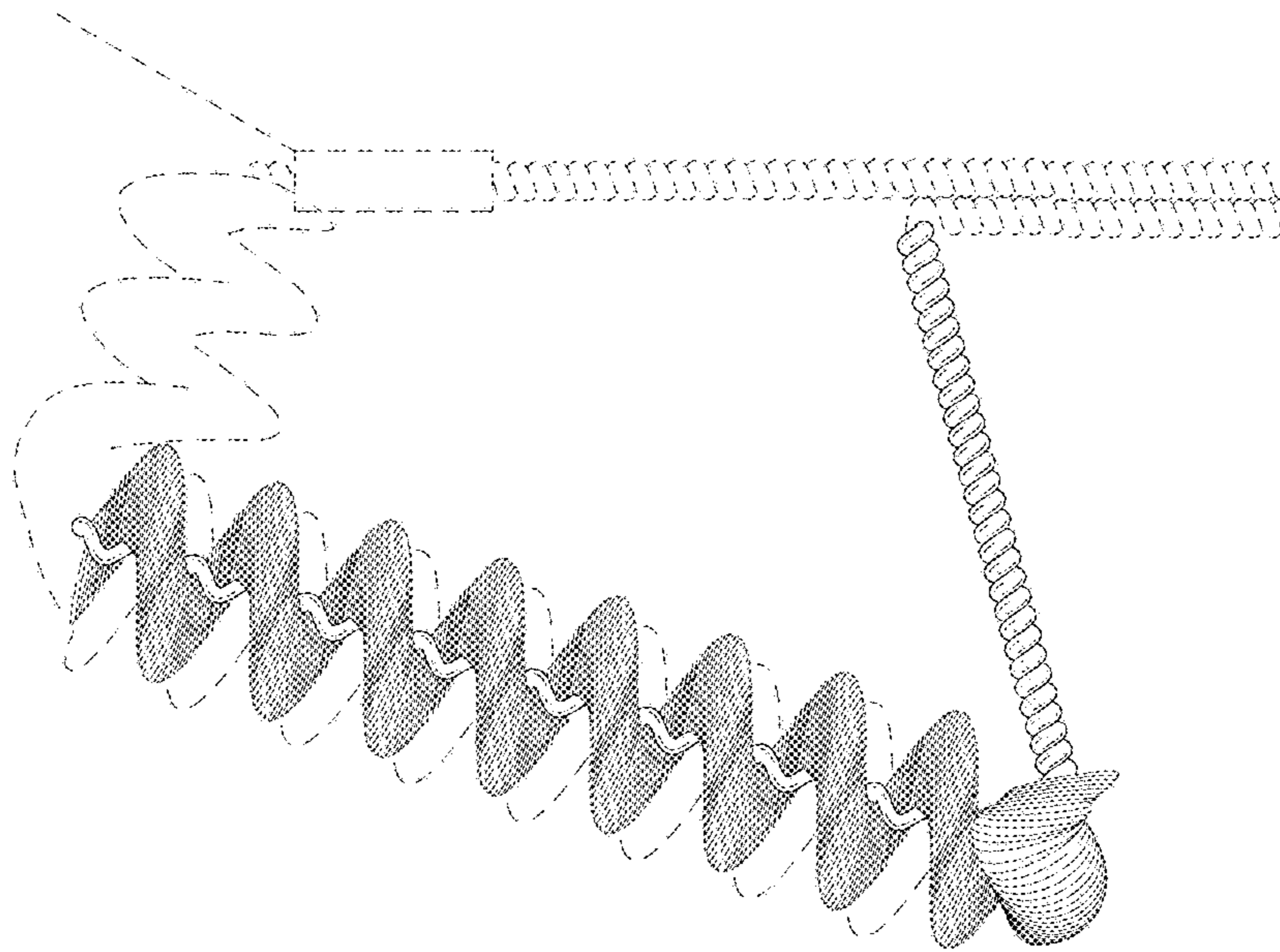

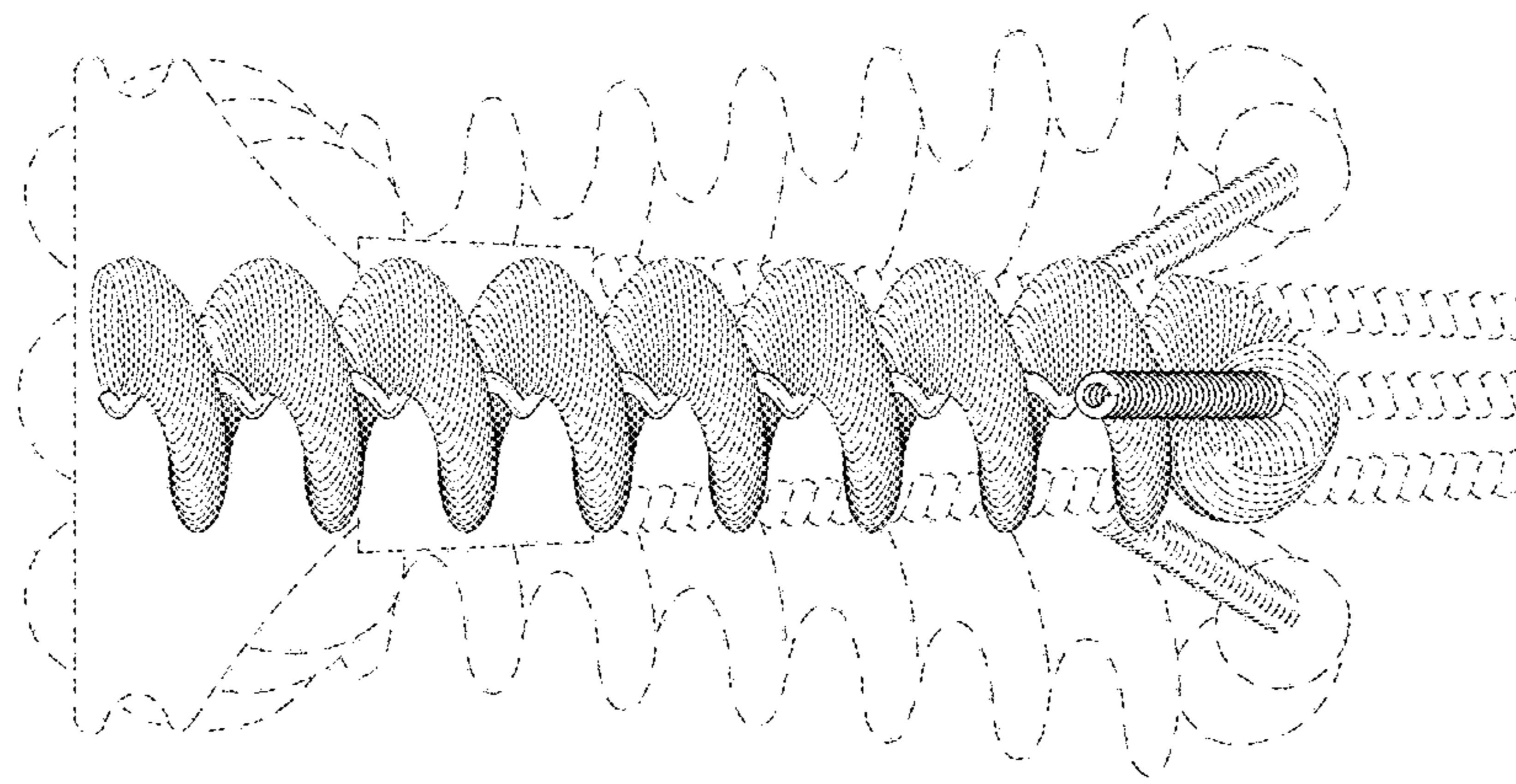

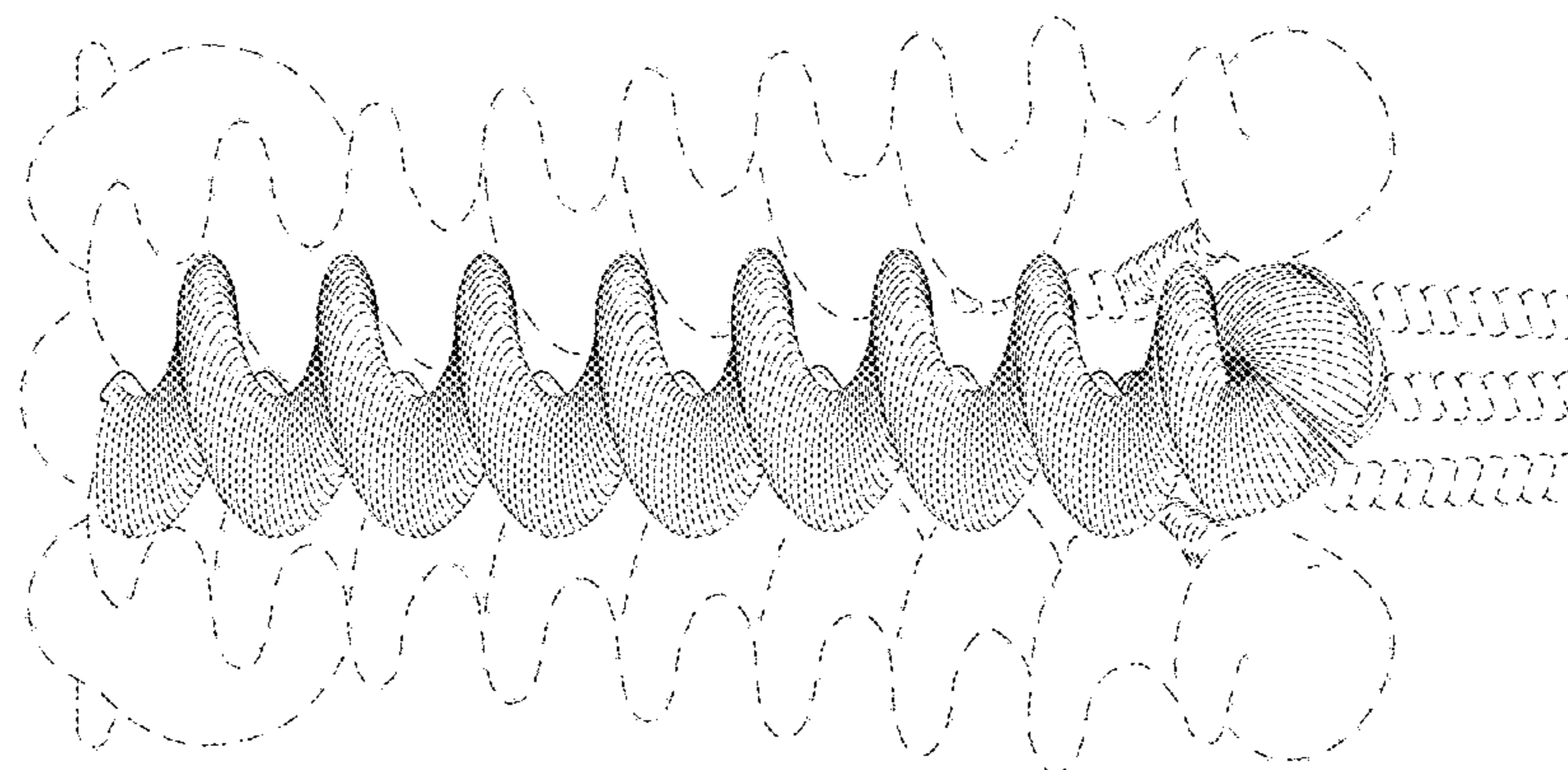

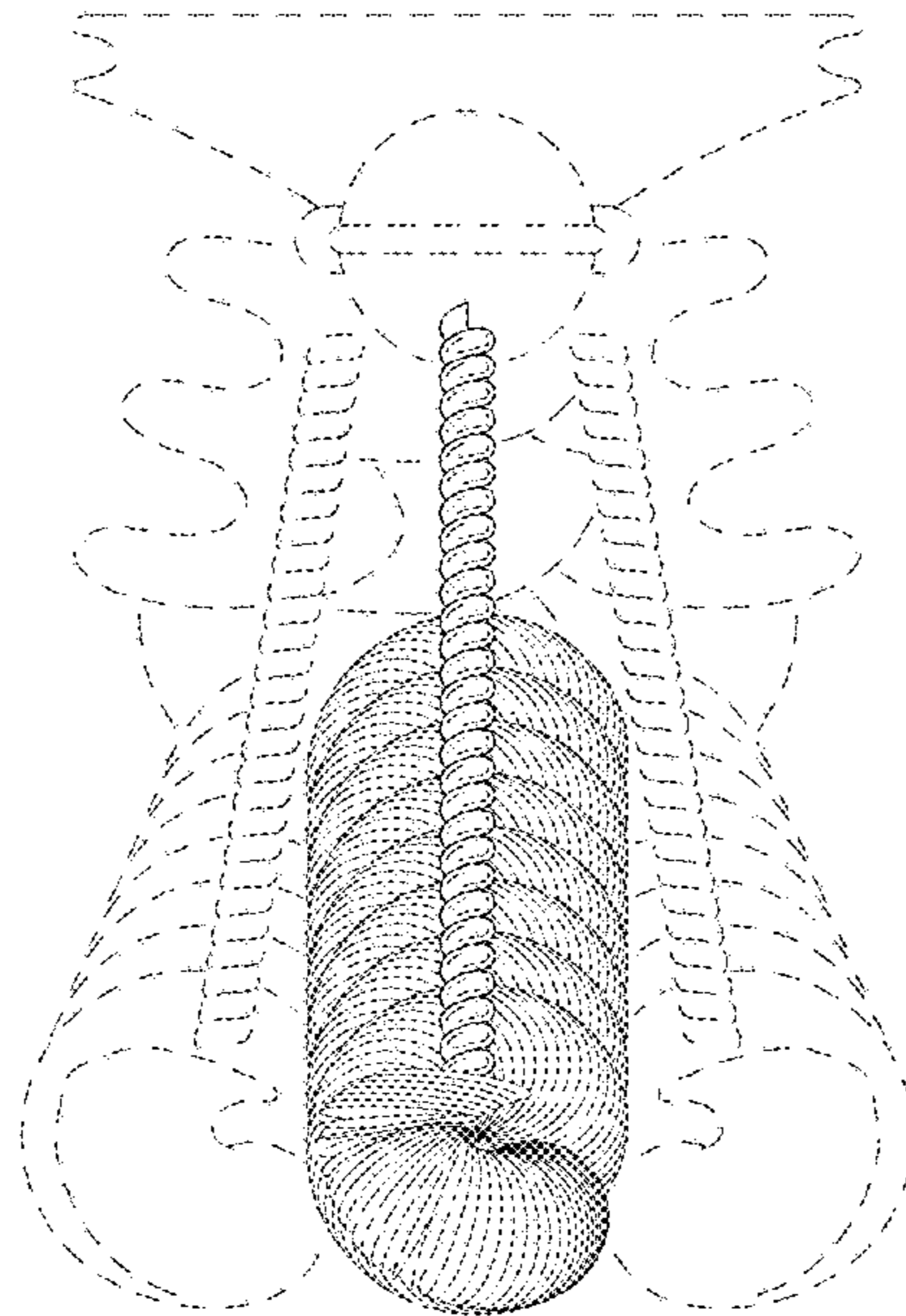

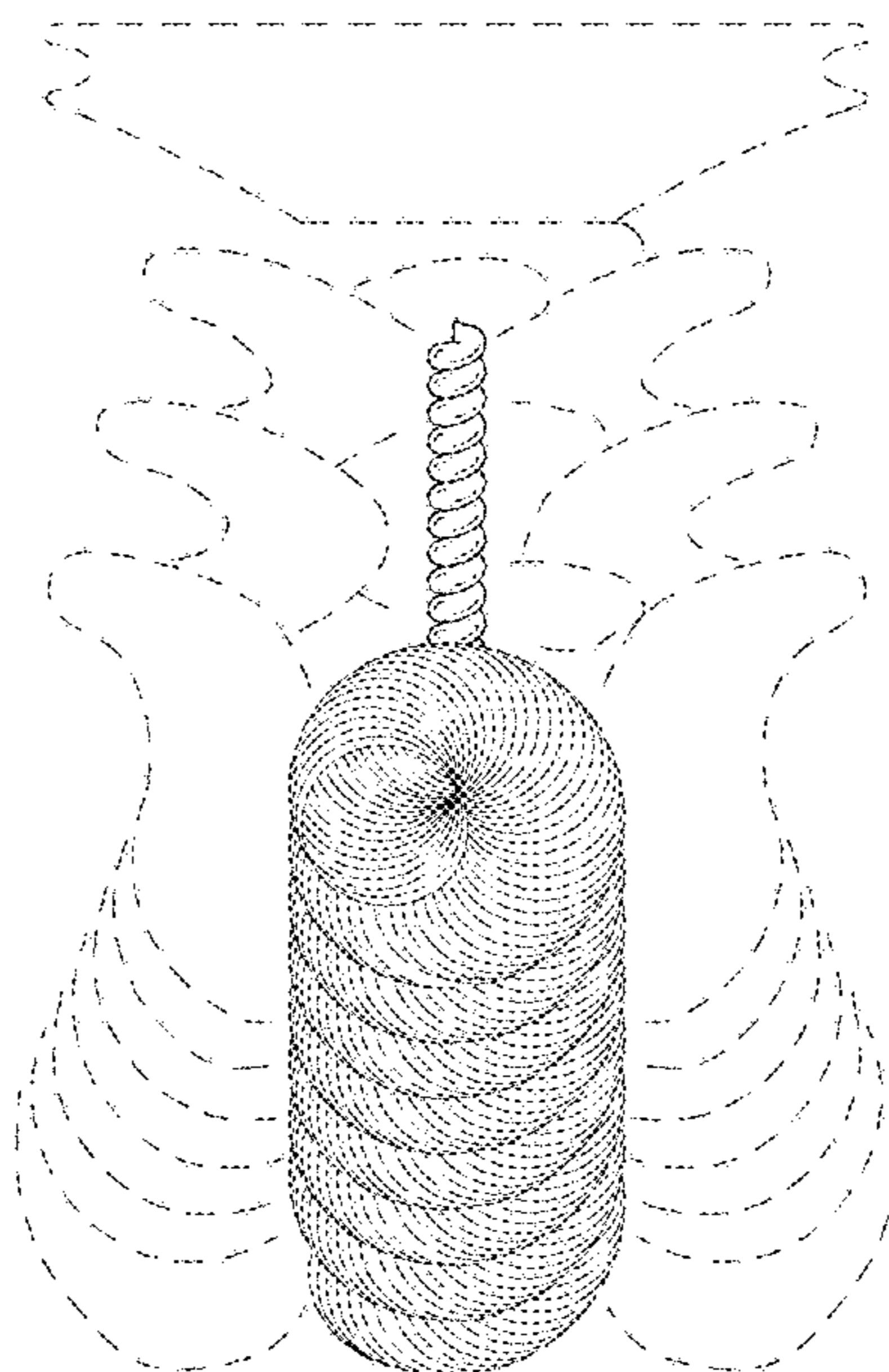
