The ornamental design for a cosmetic brush, as shown and described.

**DESCRIPTION**  
FIG. 1 is a front perspective view of the cosmetic brush showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;

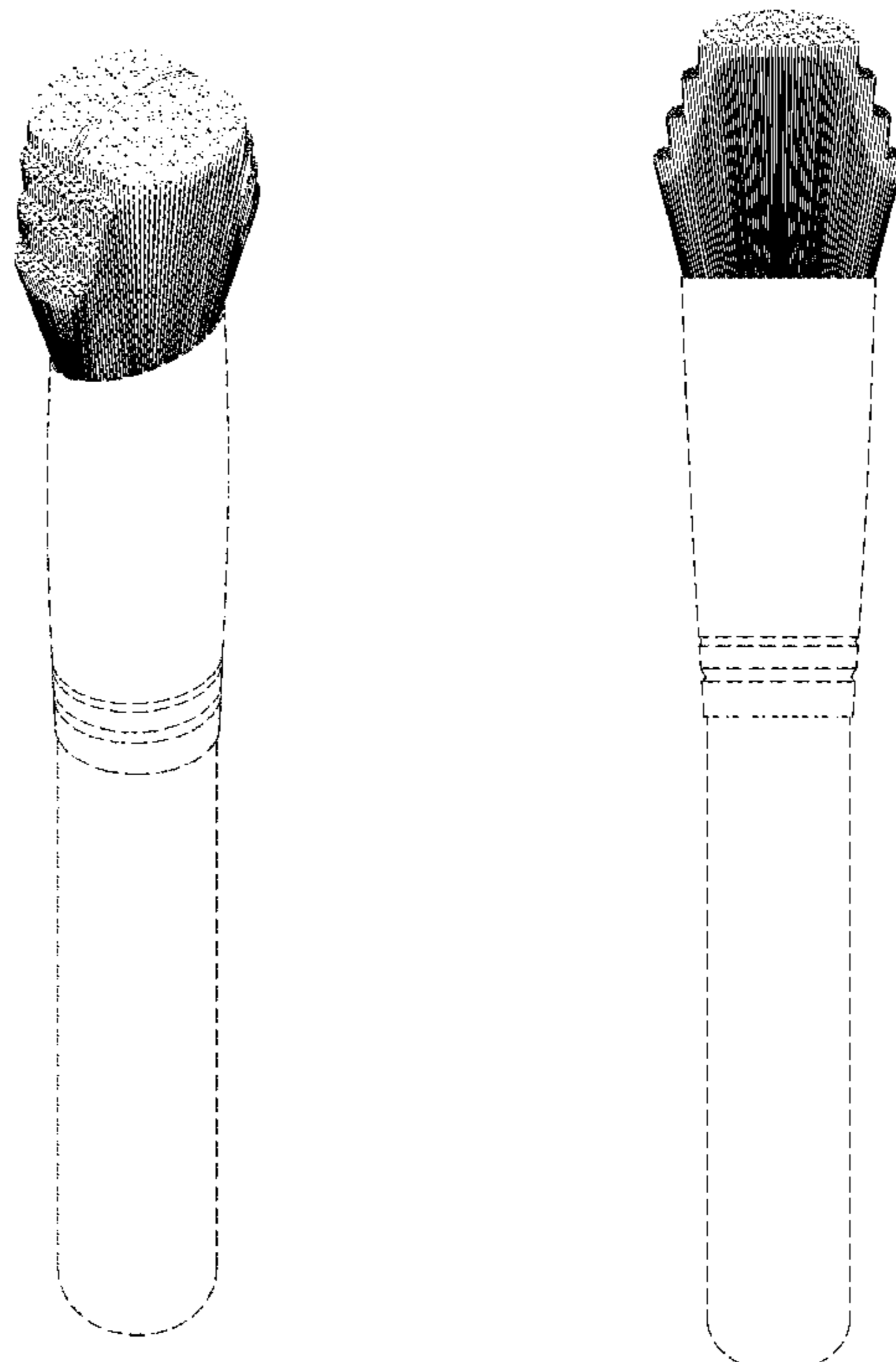

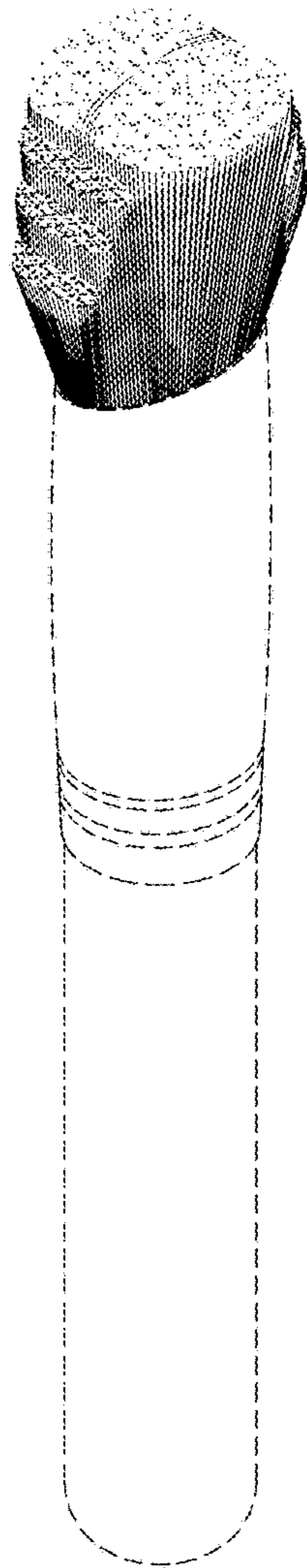

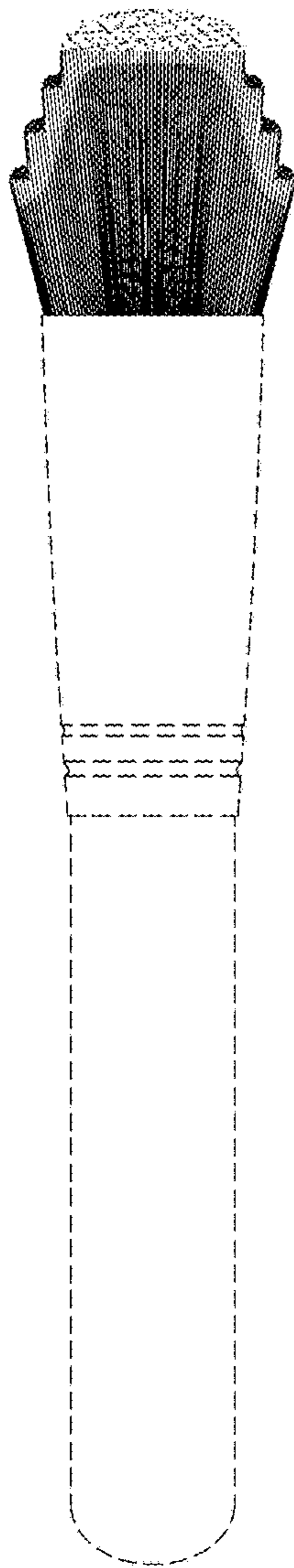

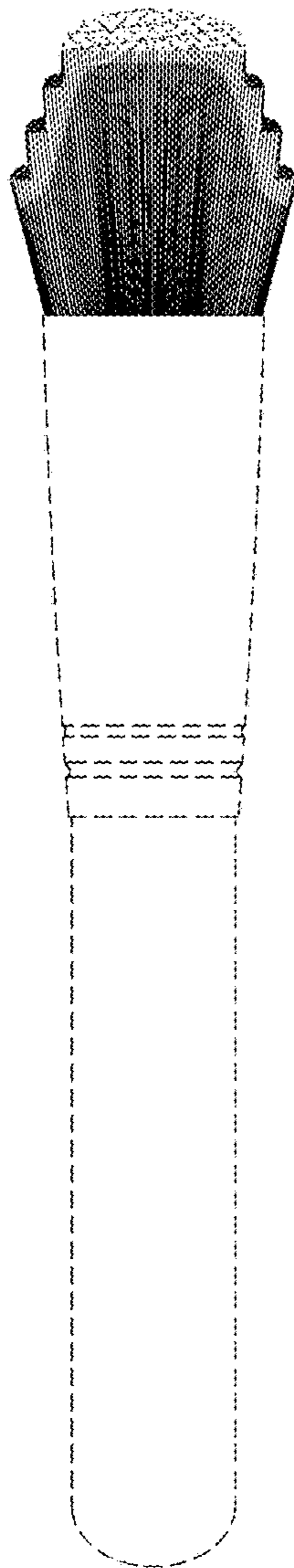

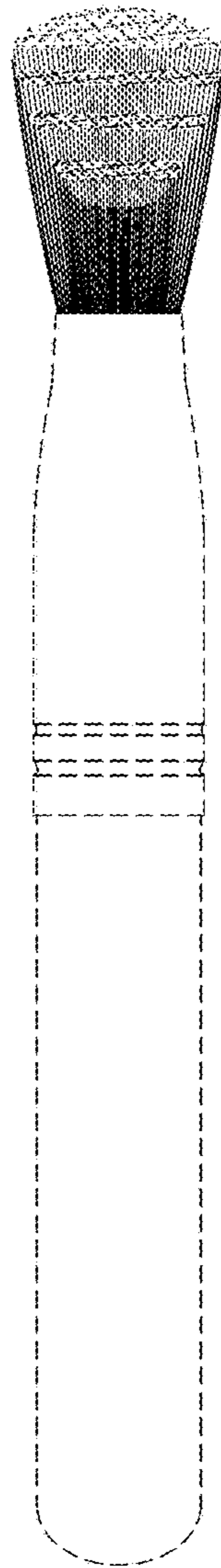

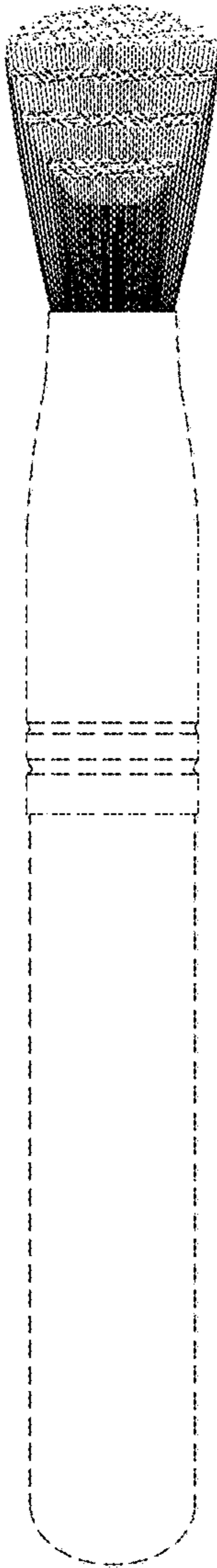

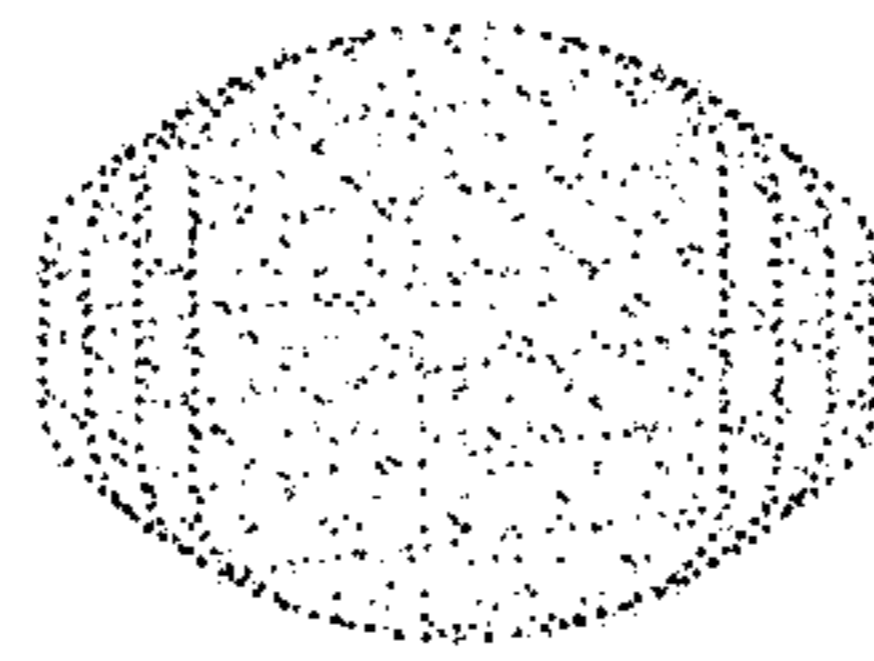
