(57) **CLAIM**

I claim the ornamental design for a garment hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a garment hanger according to a first embodiment of the new design.

FIG. 2 is a front view of the garment hanger of FIG. 1.

FIG. 3 is a top view of the garment hanger of FIG. 1.

FIG. 4 is a right-side view of the garment hanger of FIG. 1.

FIG. 5 is a rear view of the garment hanger of FIG. 1.

FIG. 6 is a bottom view of the garment hanger of FIG. 1.

FIG. 7 is a left-side view of the garment hanger of FIG. 1.

FIG. 8 is a perspective view of a garment hanger according to a second embodiment of the new design.

FIG. 9 is a front view of the garment hanger of FIG. 8.

FIG. 10 is a top view of the garment hanger of FIG. 8.

FIG. 11 is a right-side view of the garment hanger of FIG. 8.

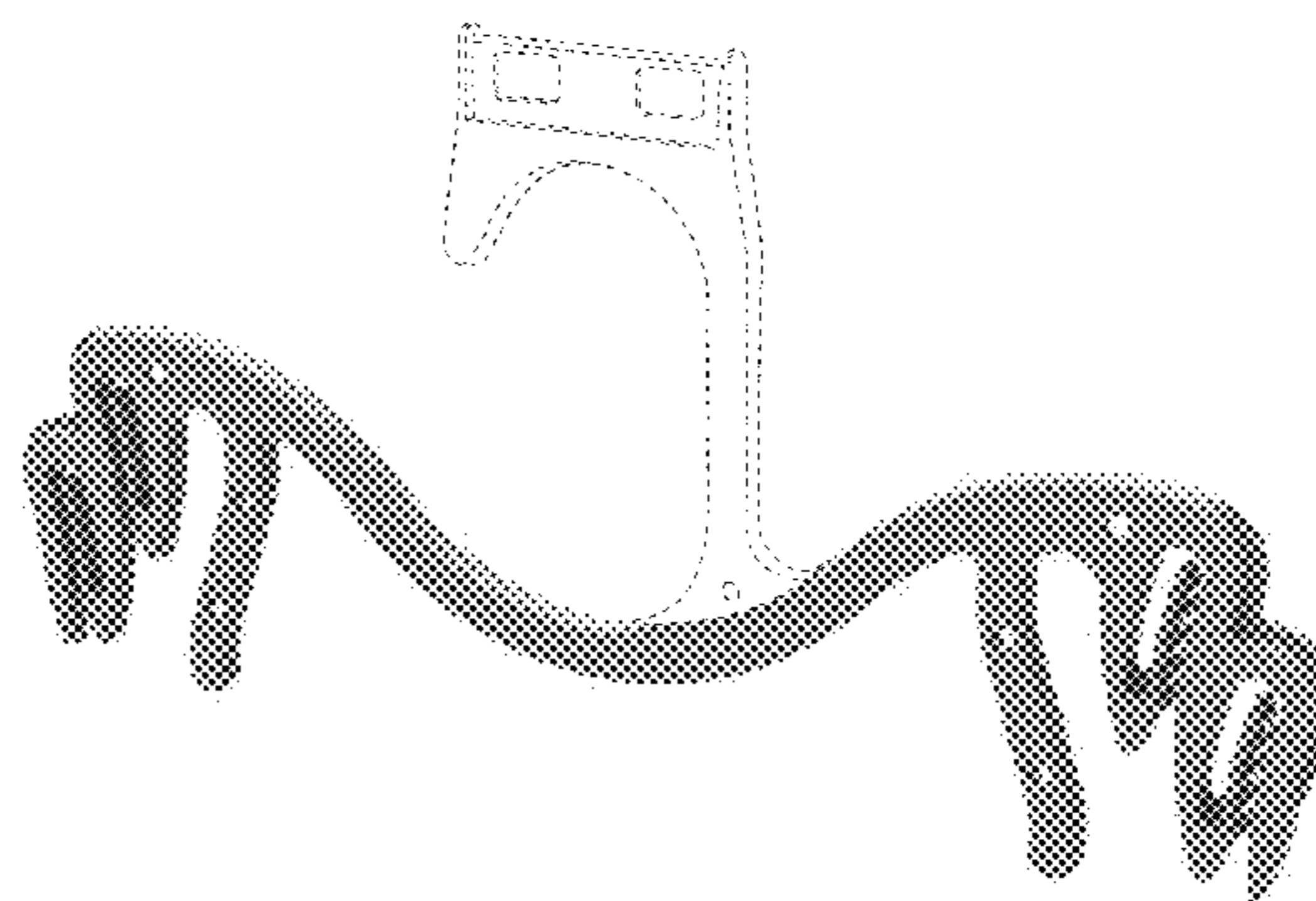
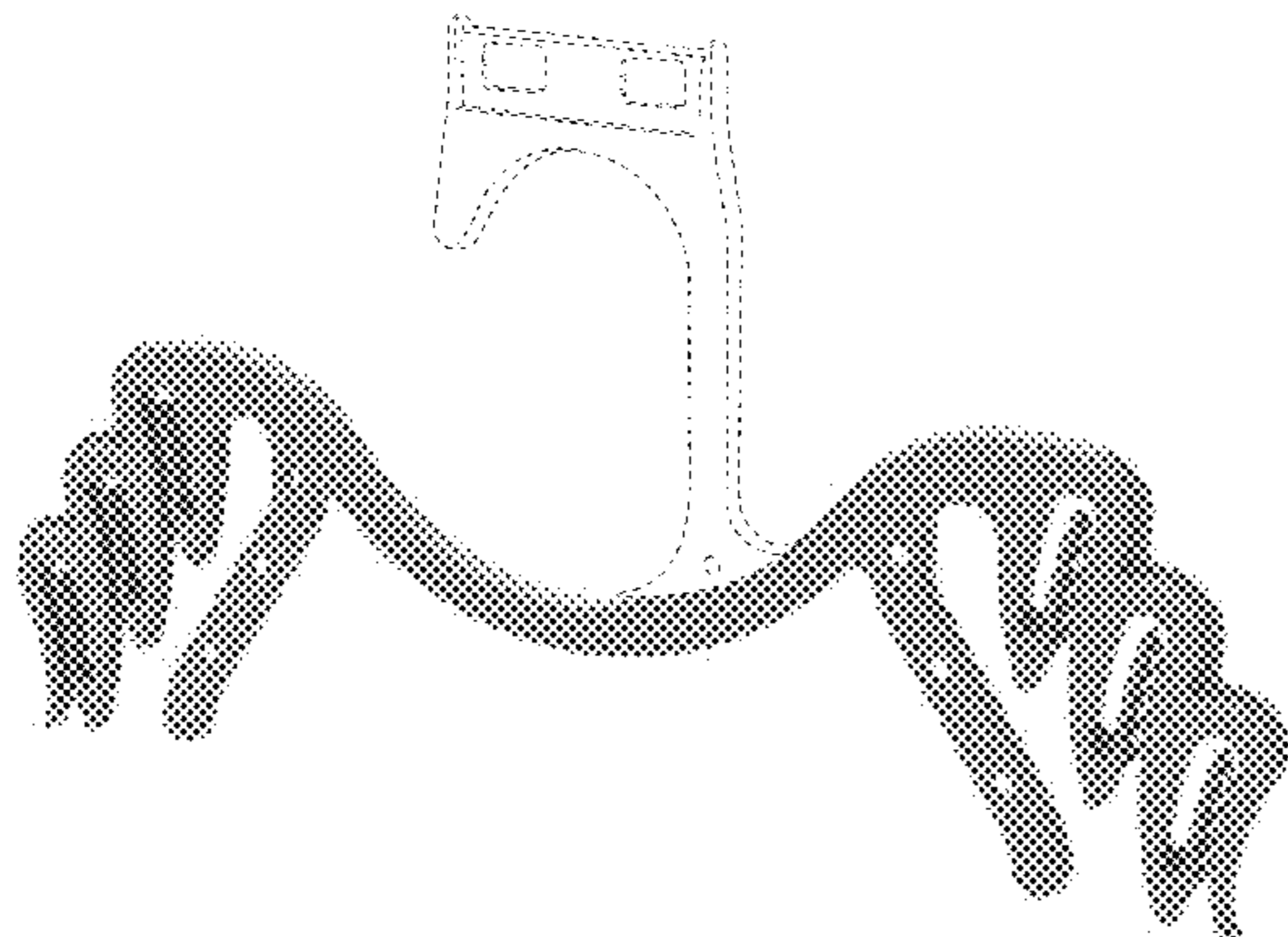
FIG. 12 is a rear view of the garment hanger of FIG. 8.

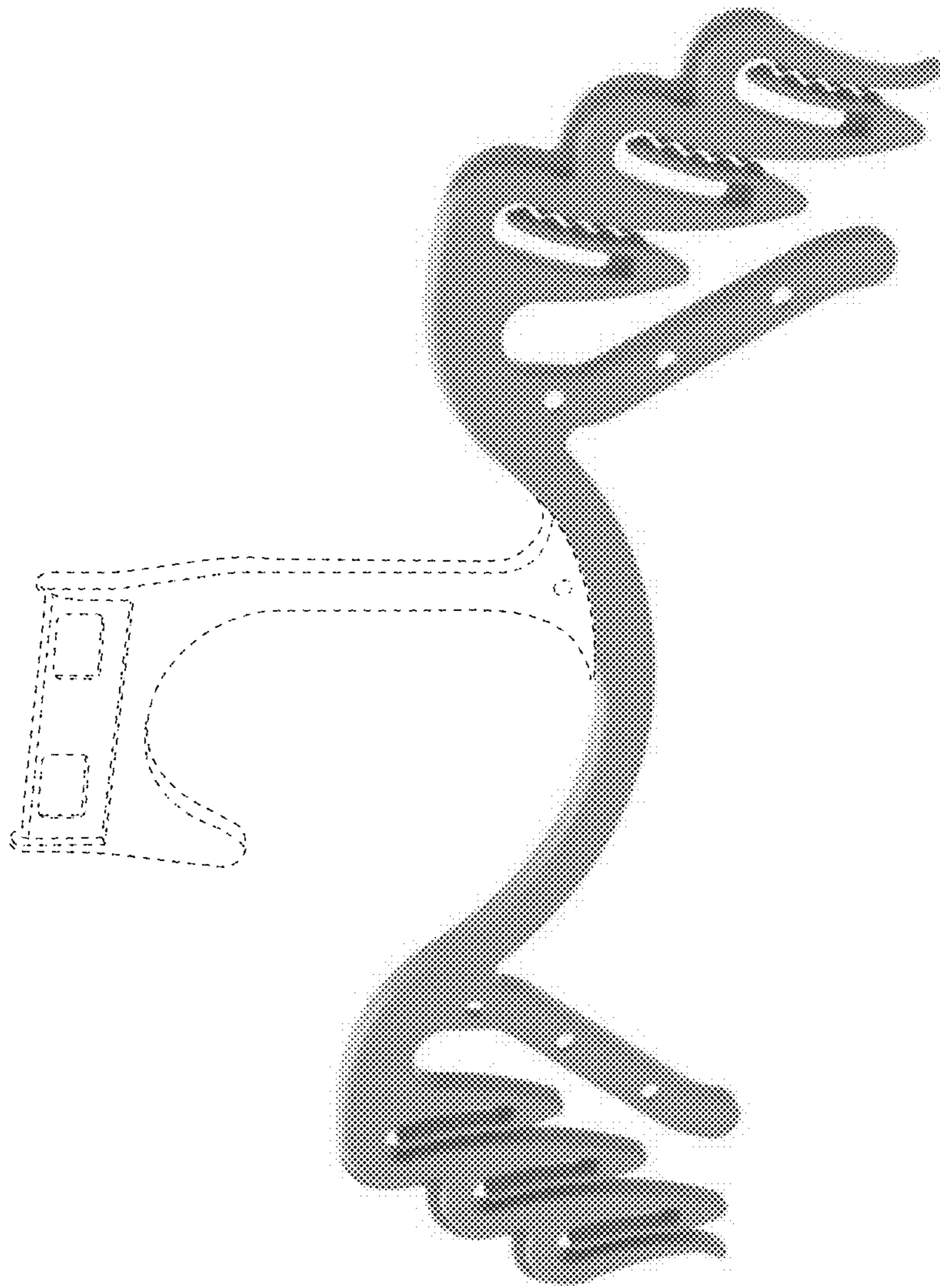

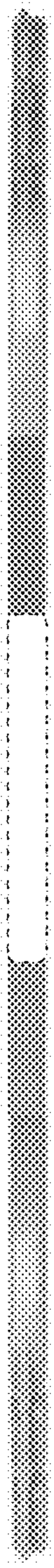

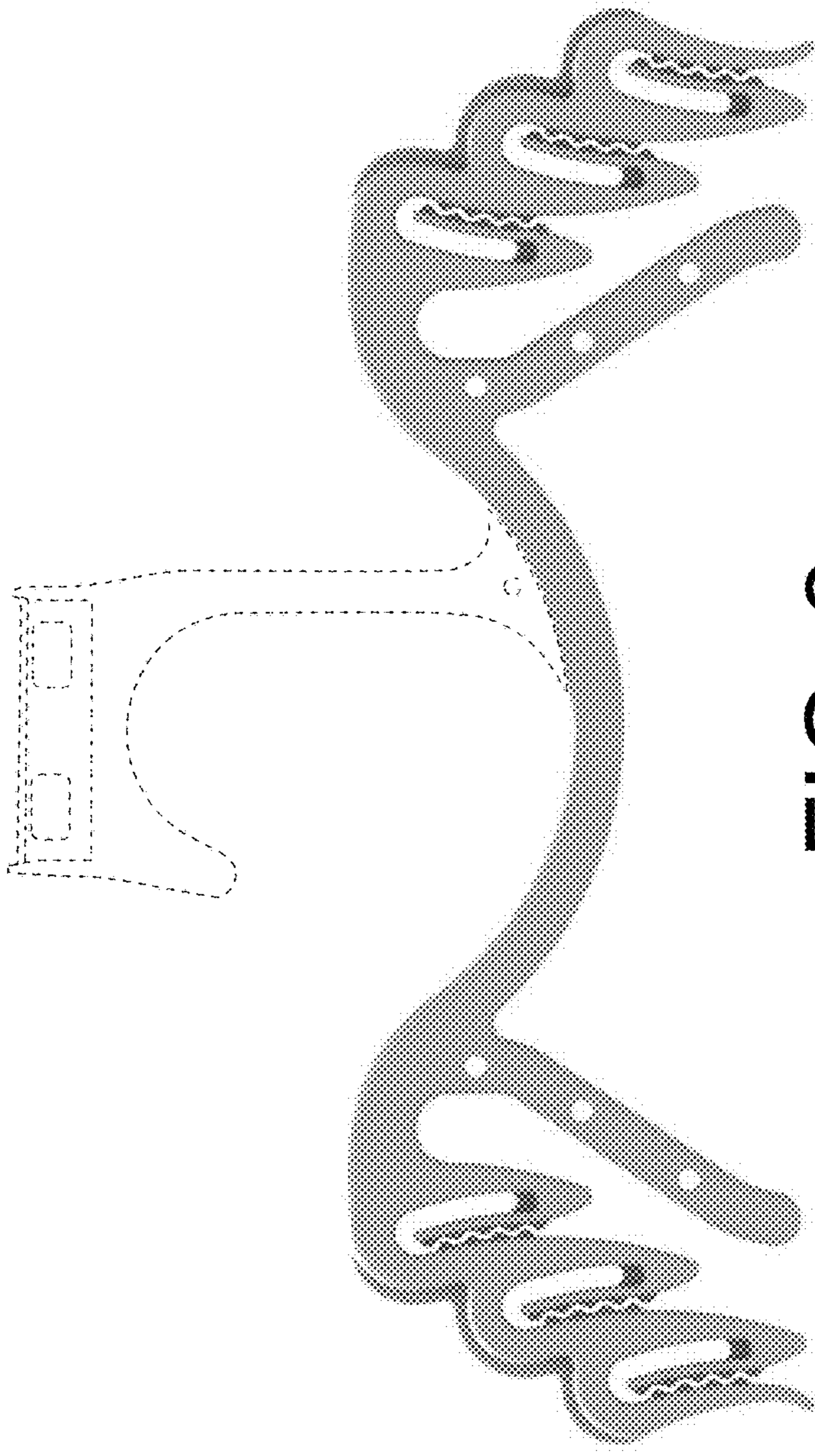

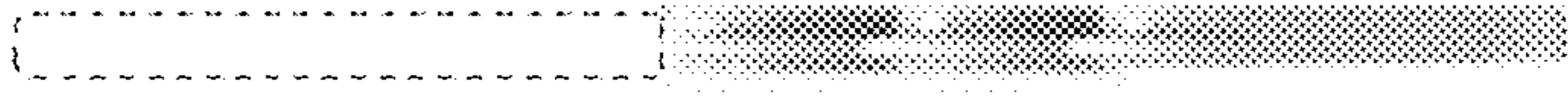

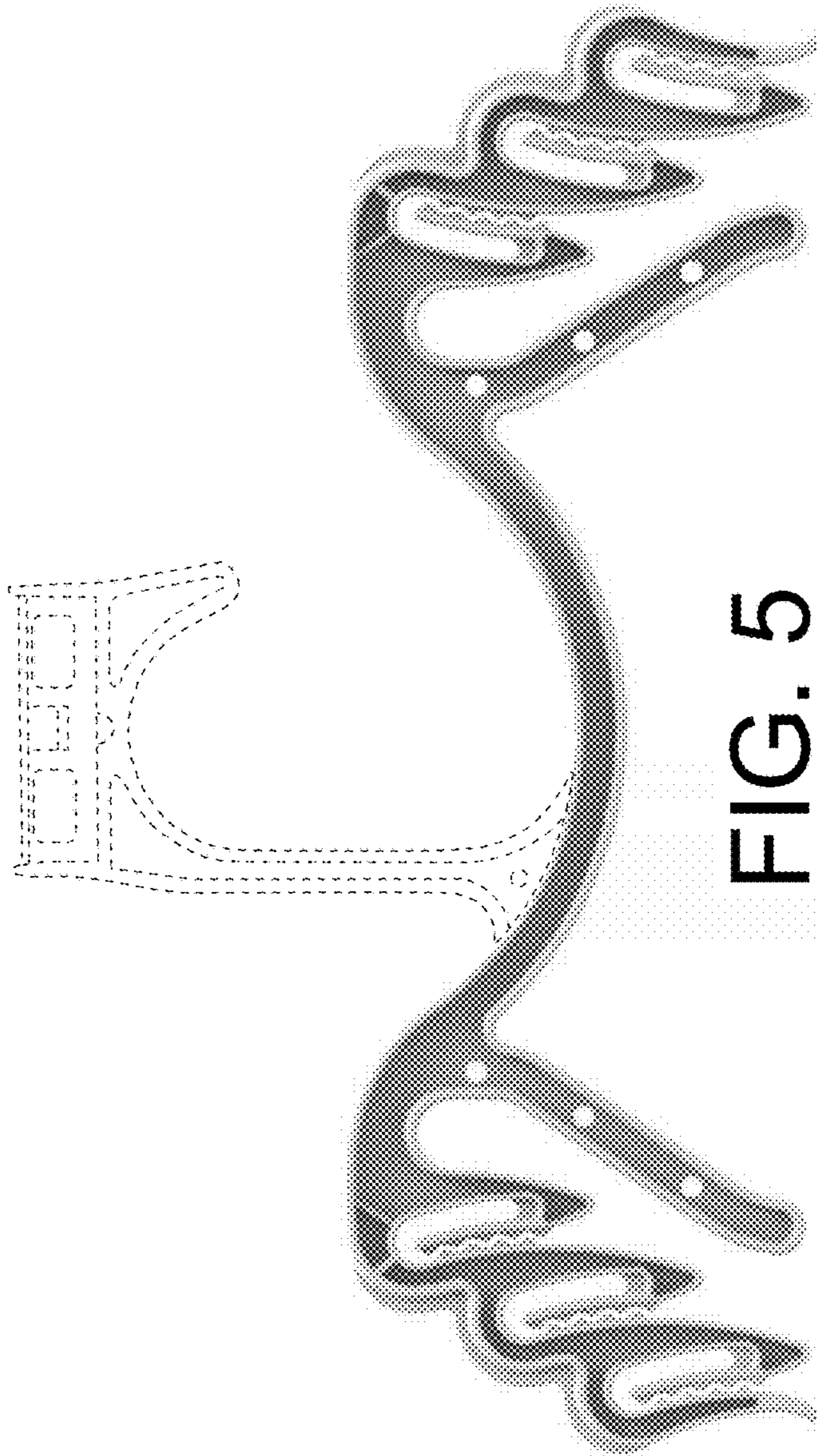

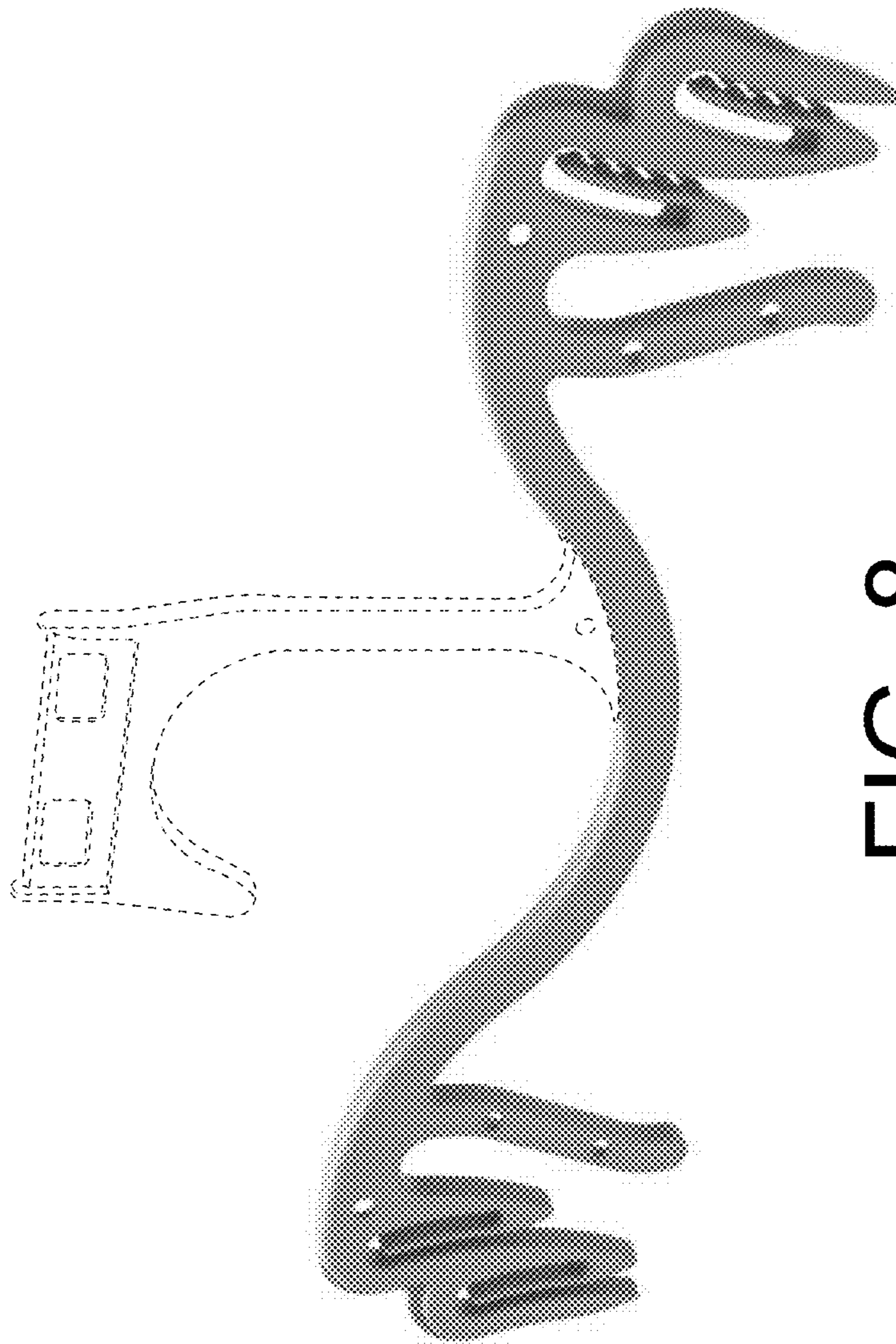

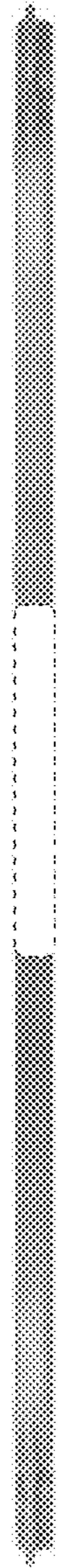

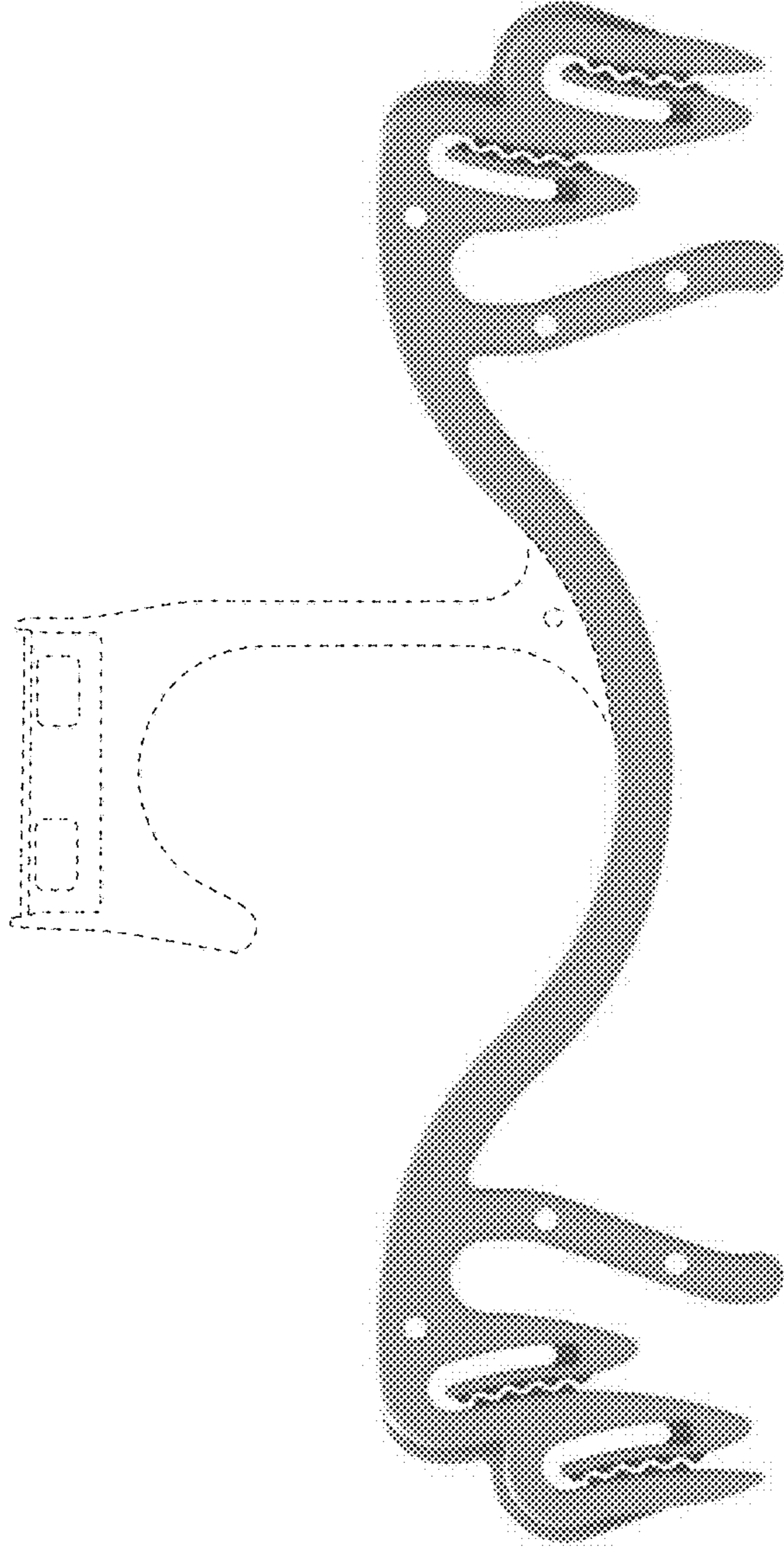

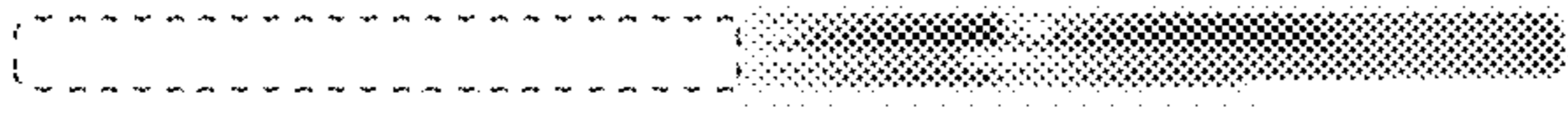

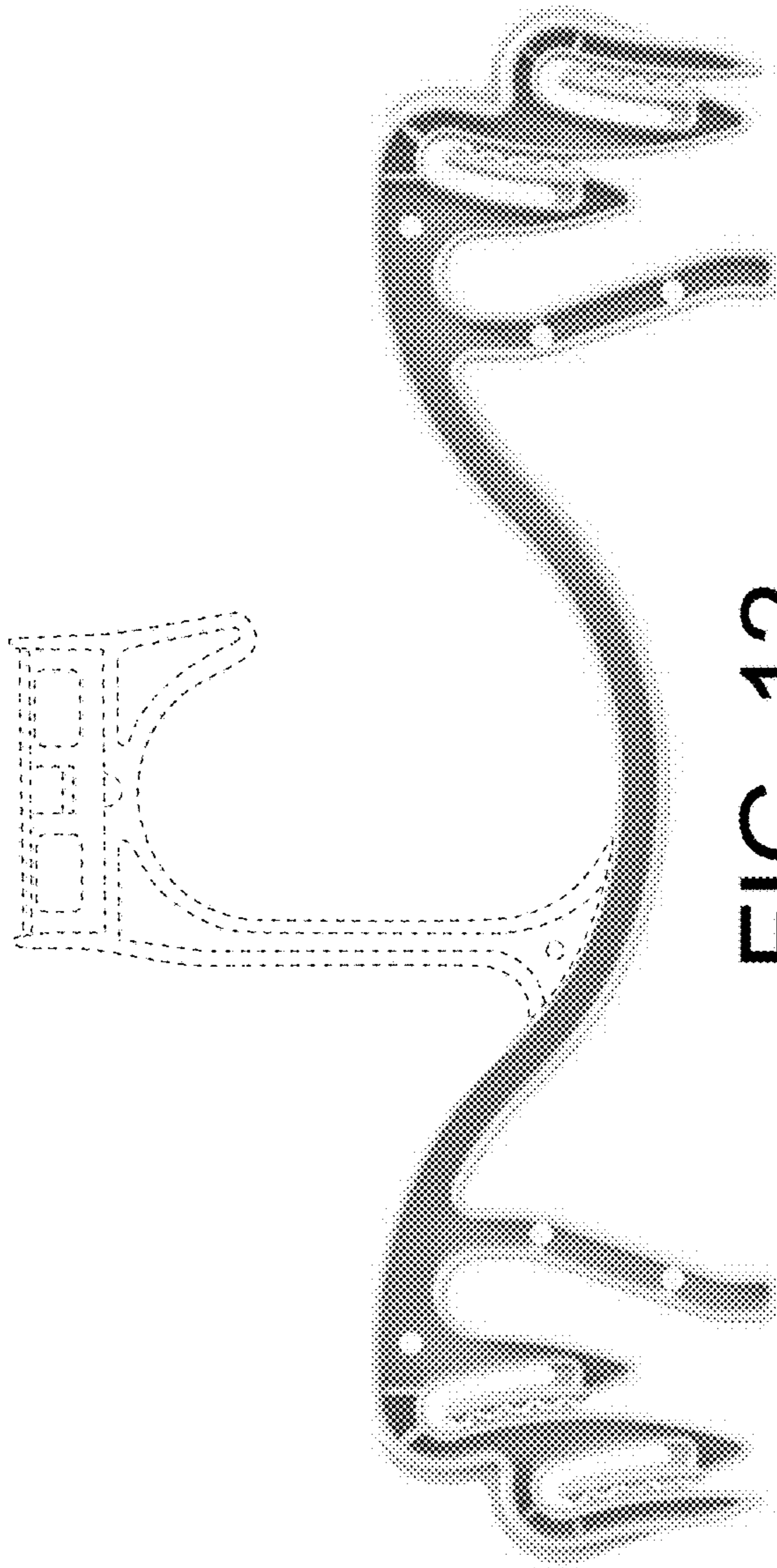

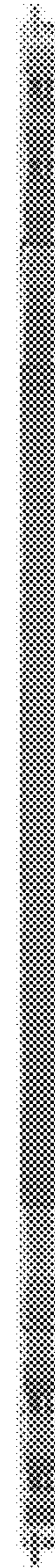
