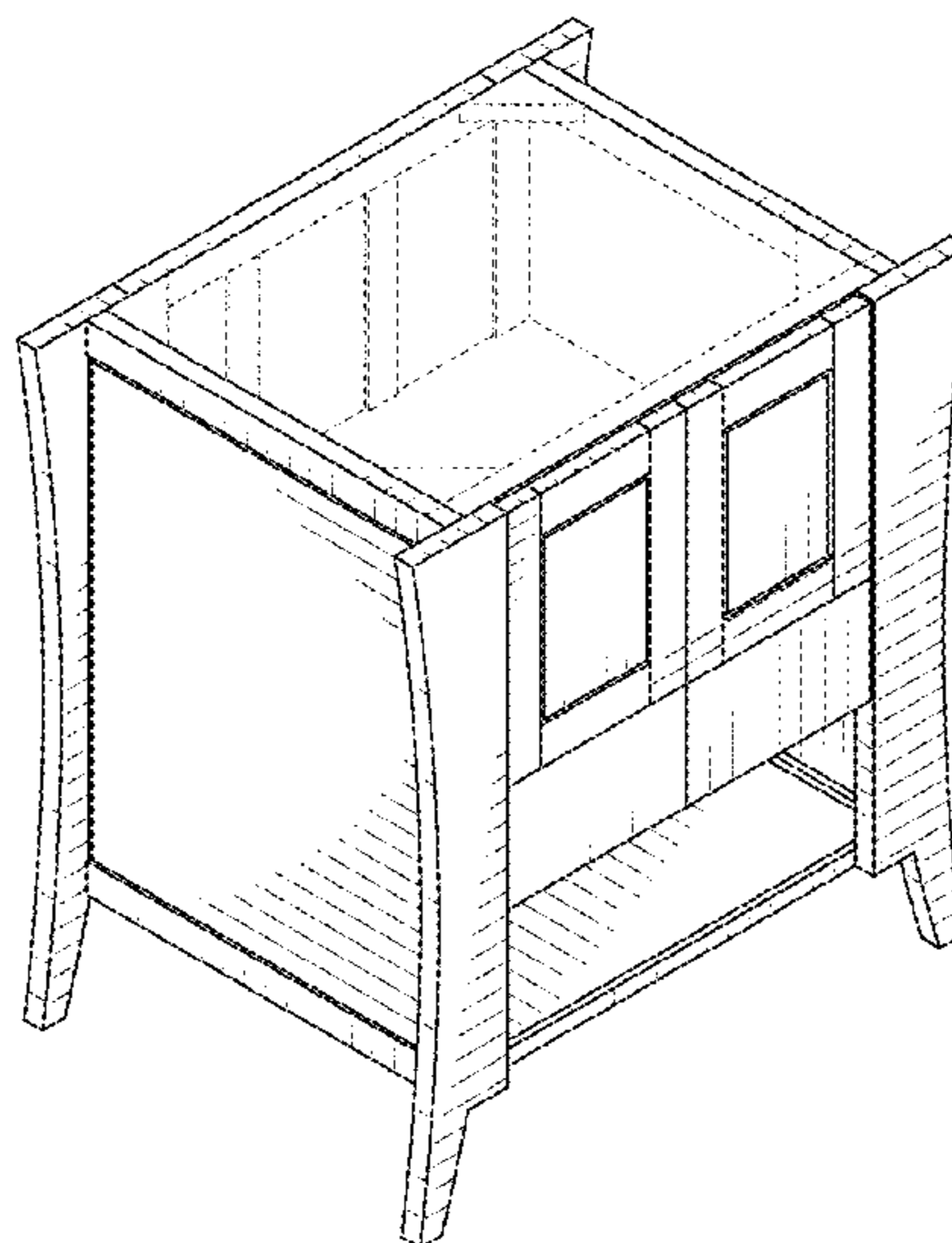
(57) **CLAIM**

The ornamental design for a vanity, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a vanity according to the present invention.
FIG. 2 is a front elevation view of the vanity illustrated in FIG. 1.
FIG. 3 is a rear elevation view of the vanity illustrated in FIG. 1.
FIG. 4 is a side elevation view of the vanity illustrated in FIG. 1.
FIG. 5 is another side elevation view of the vanity illustrated in FIG. 1.
FIG. 6 is a top plan view of the vanity illustrated in FIG. 1.
FIG. 7 is a bottom plan view of the vanity illustrated in FIG. 1; and,

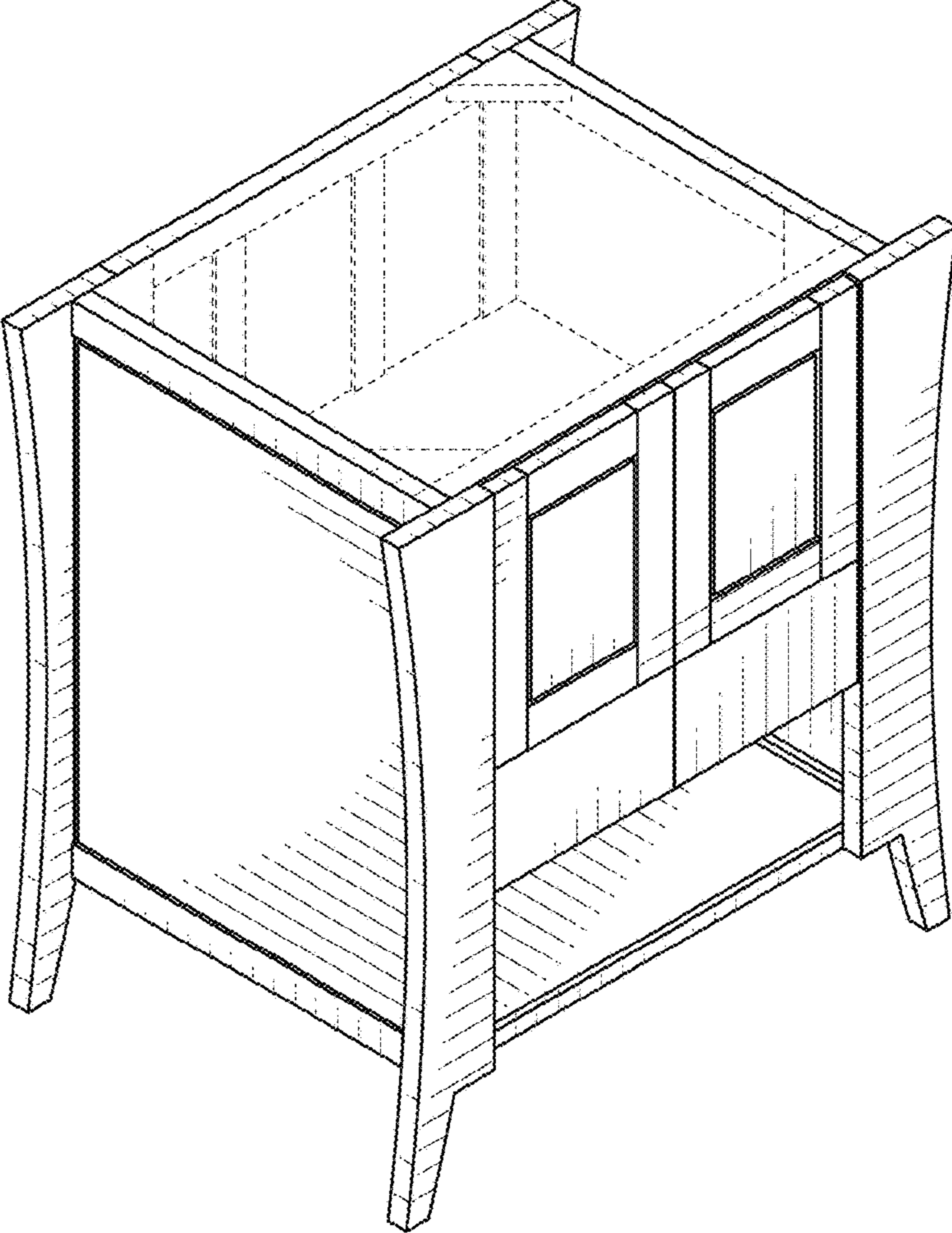

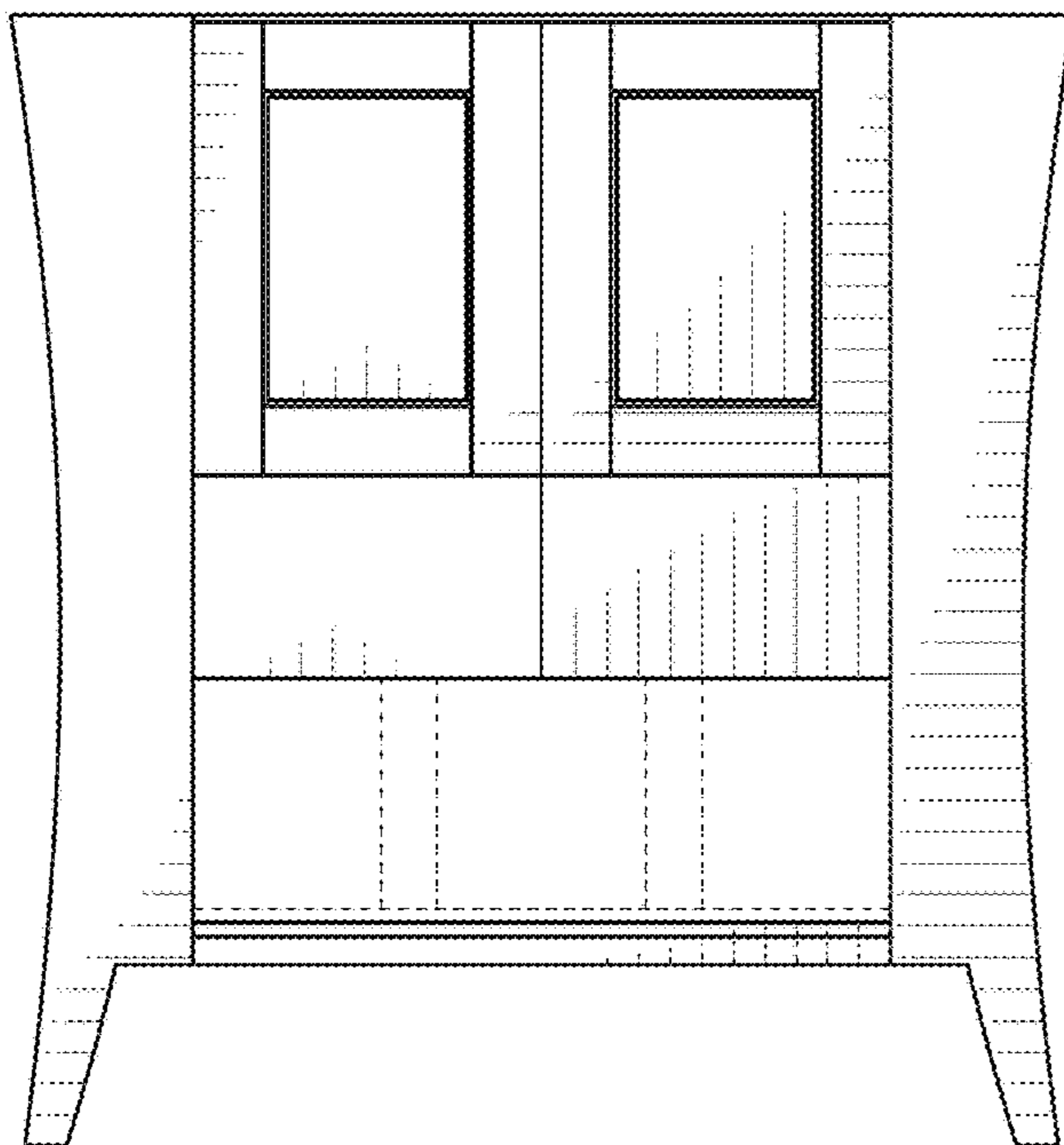

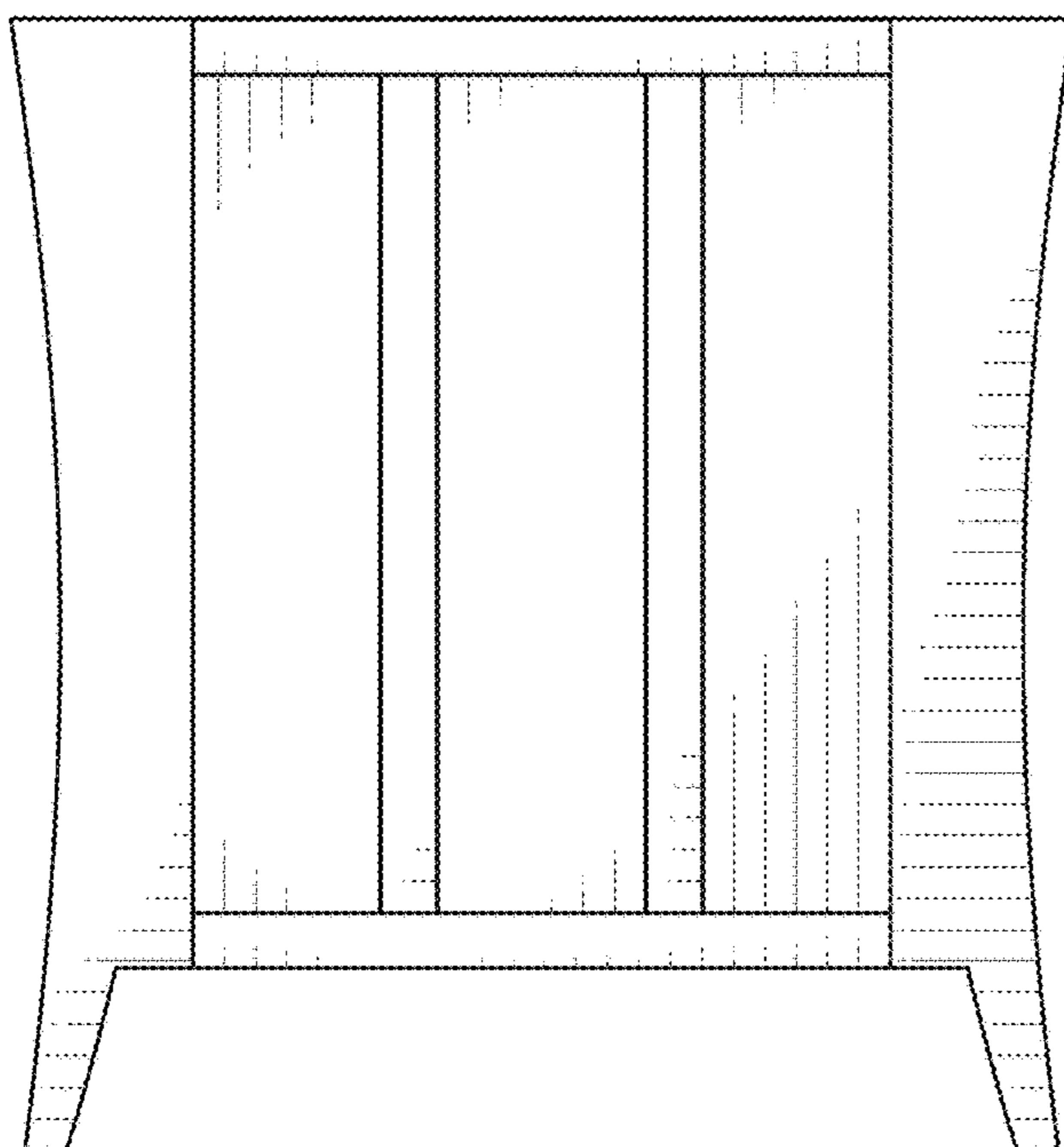

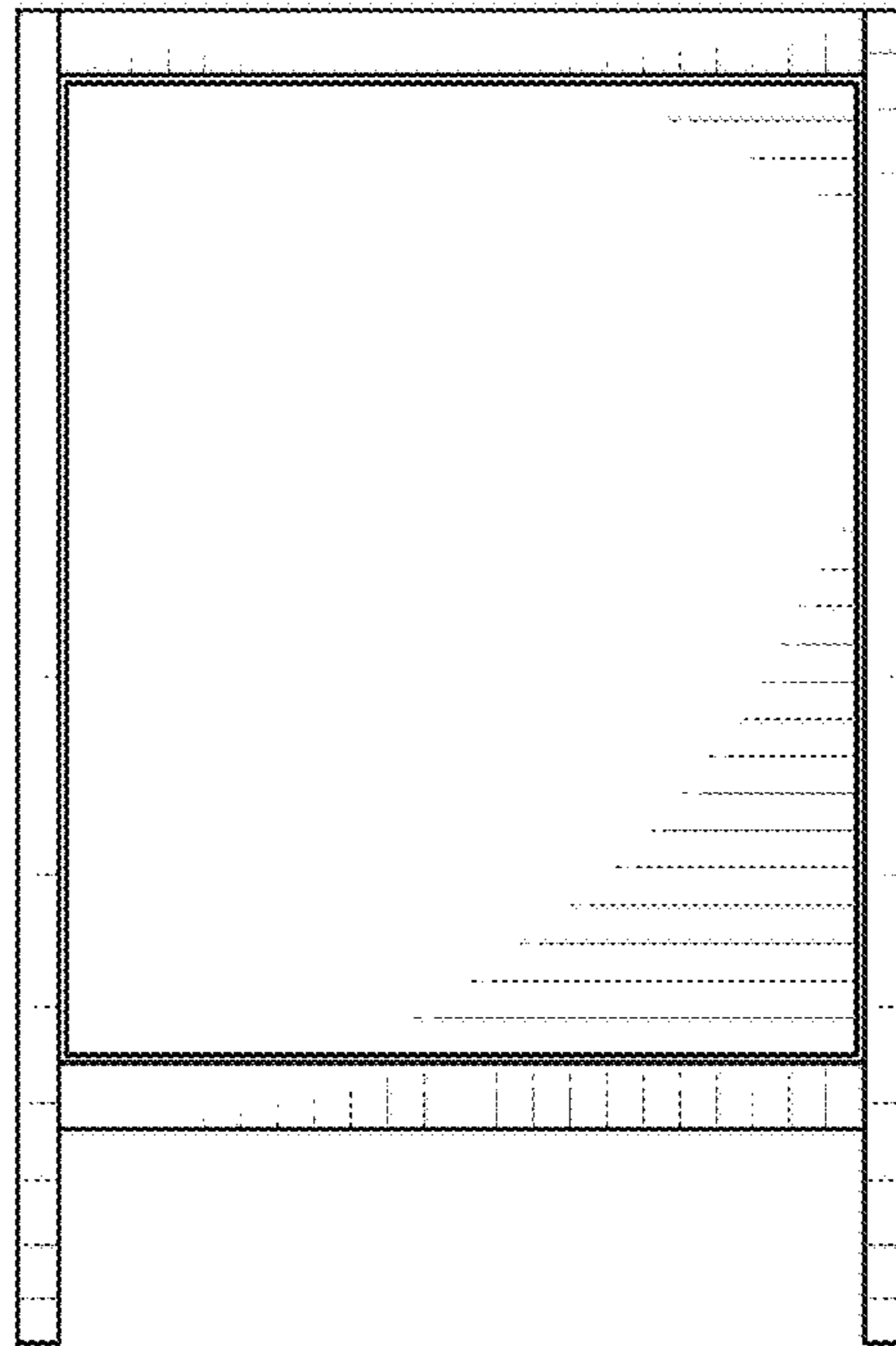

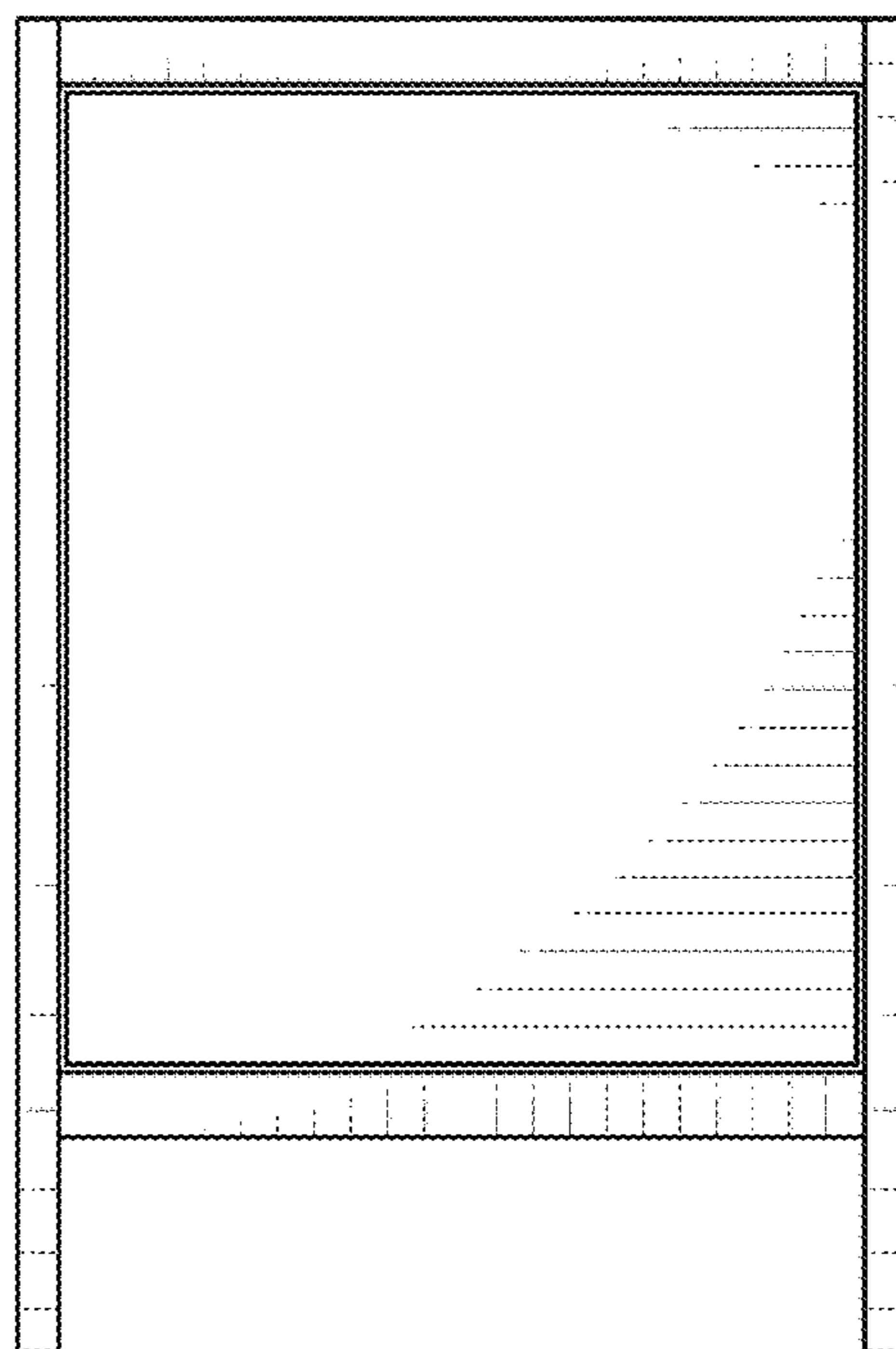

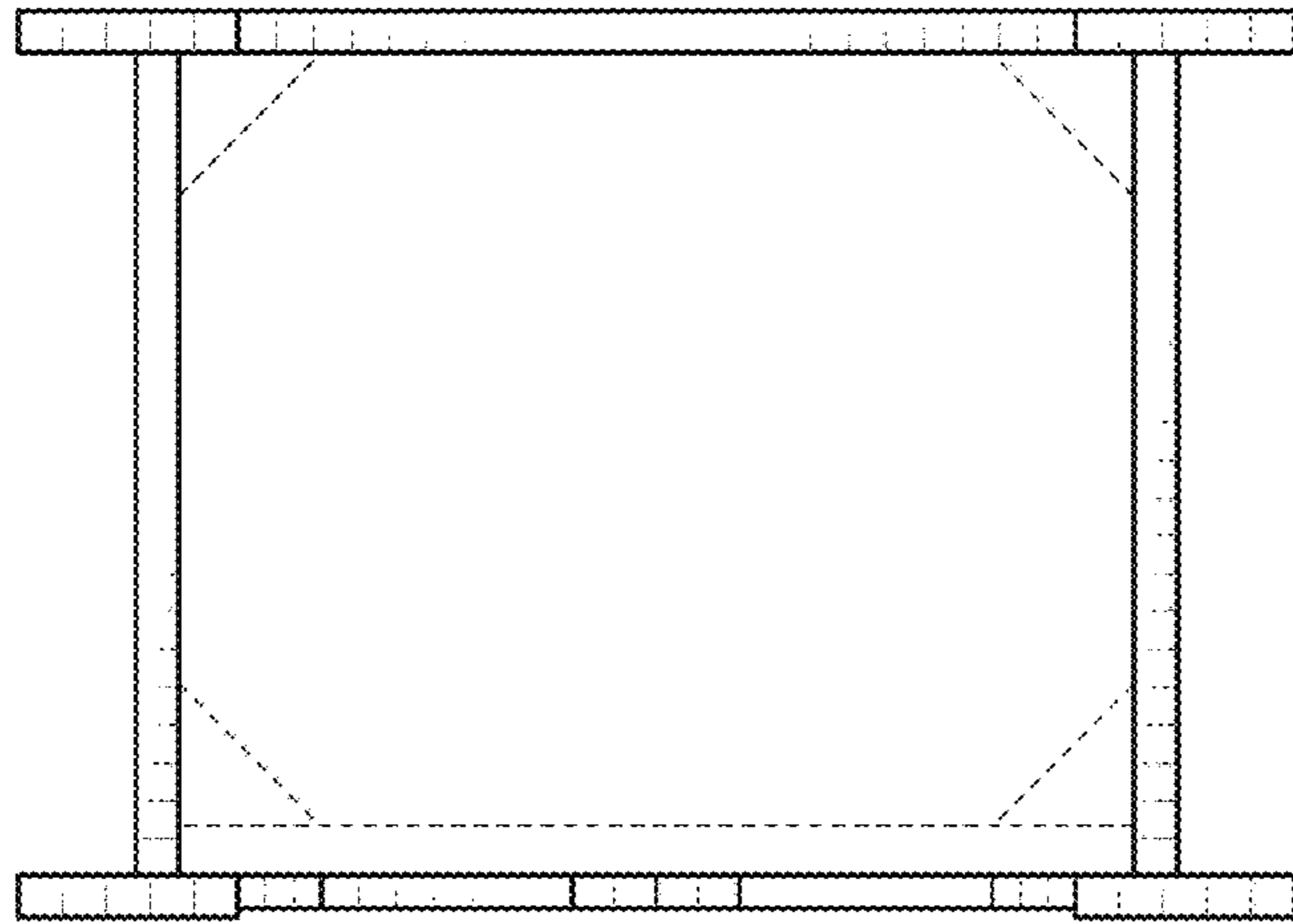

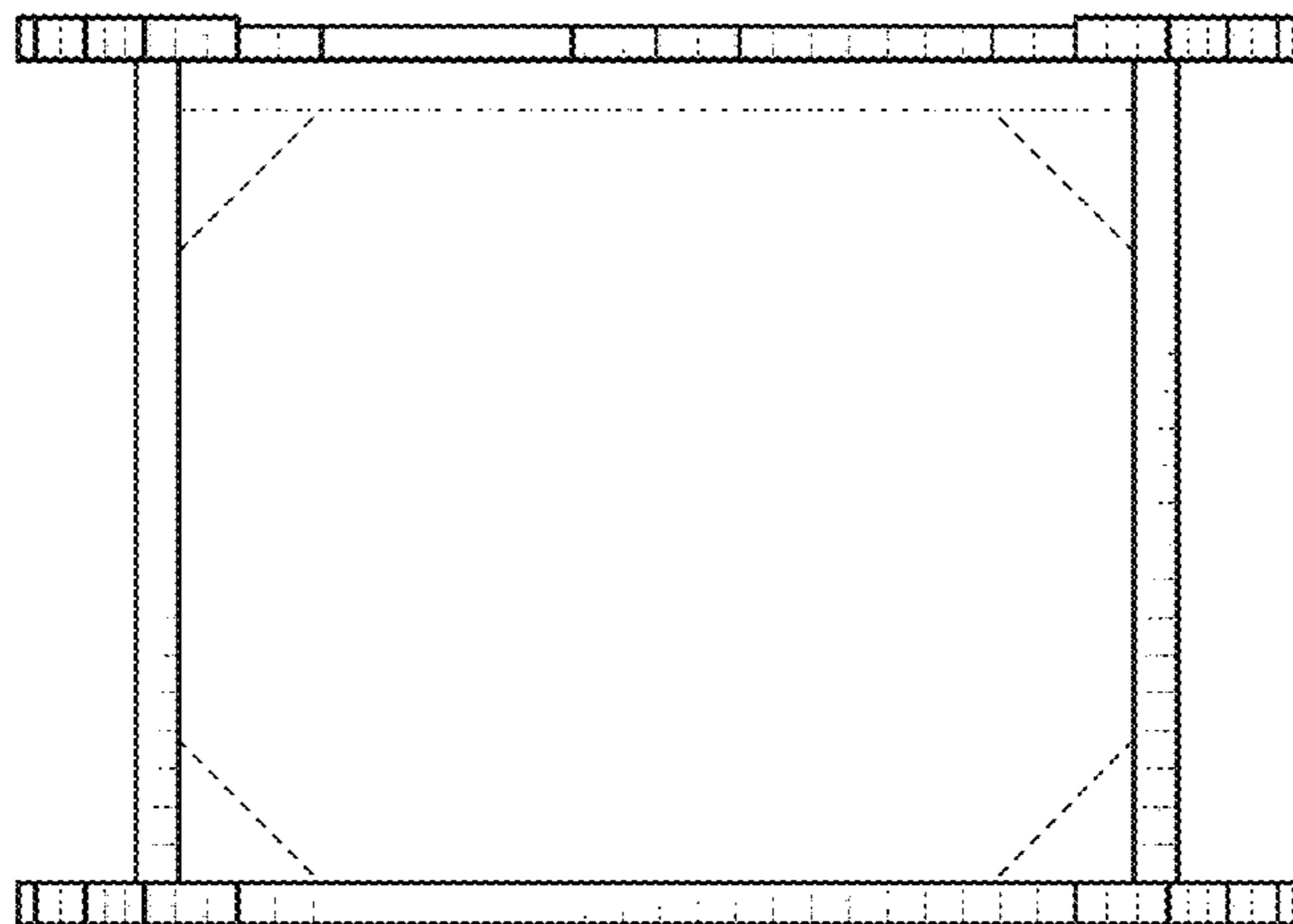

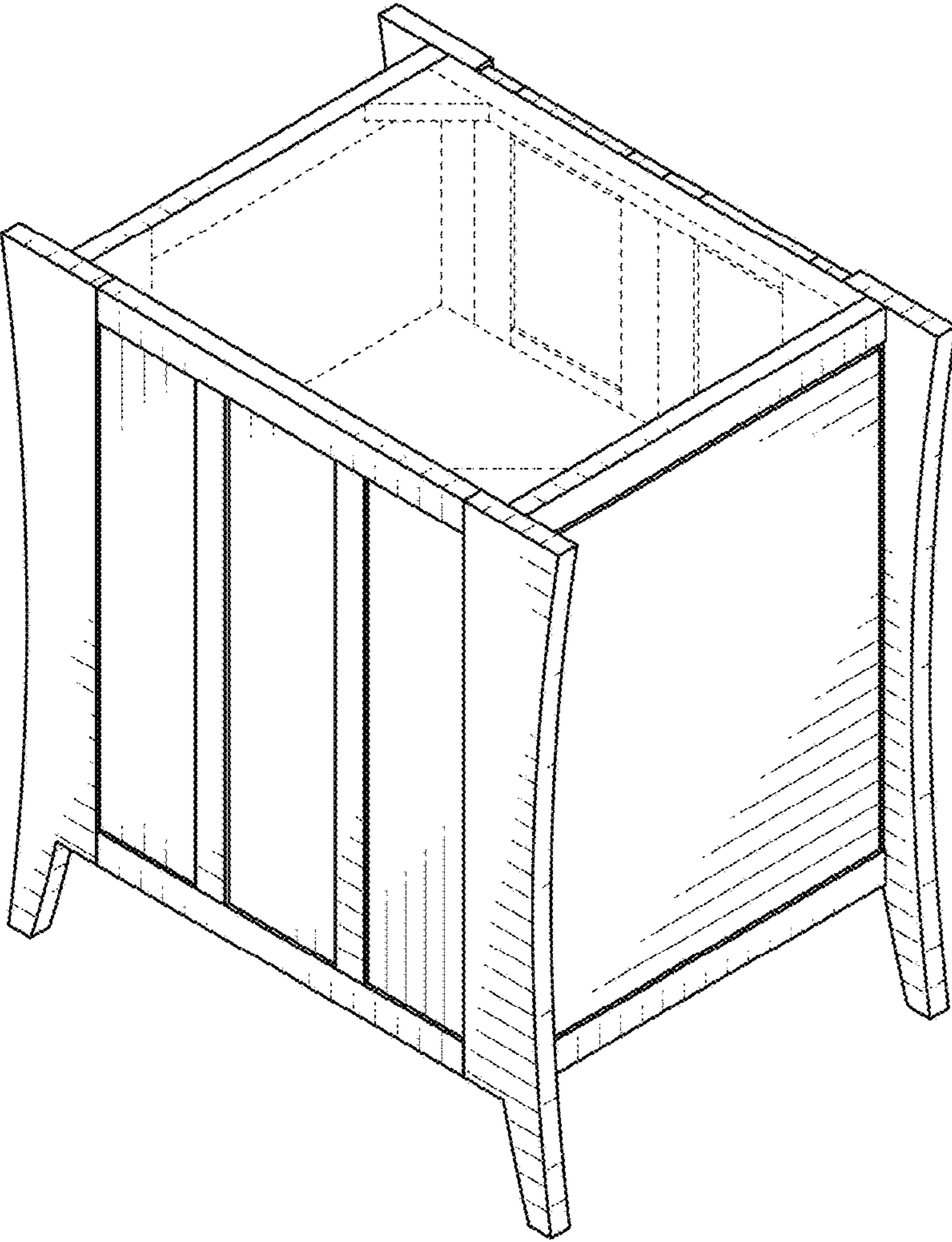
