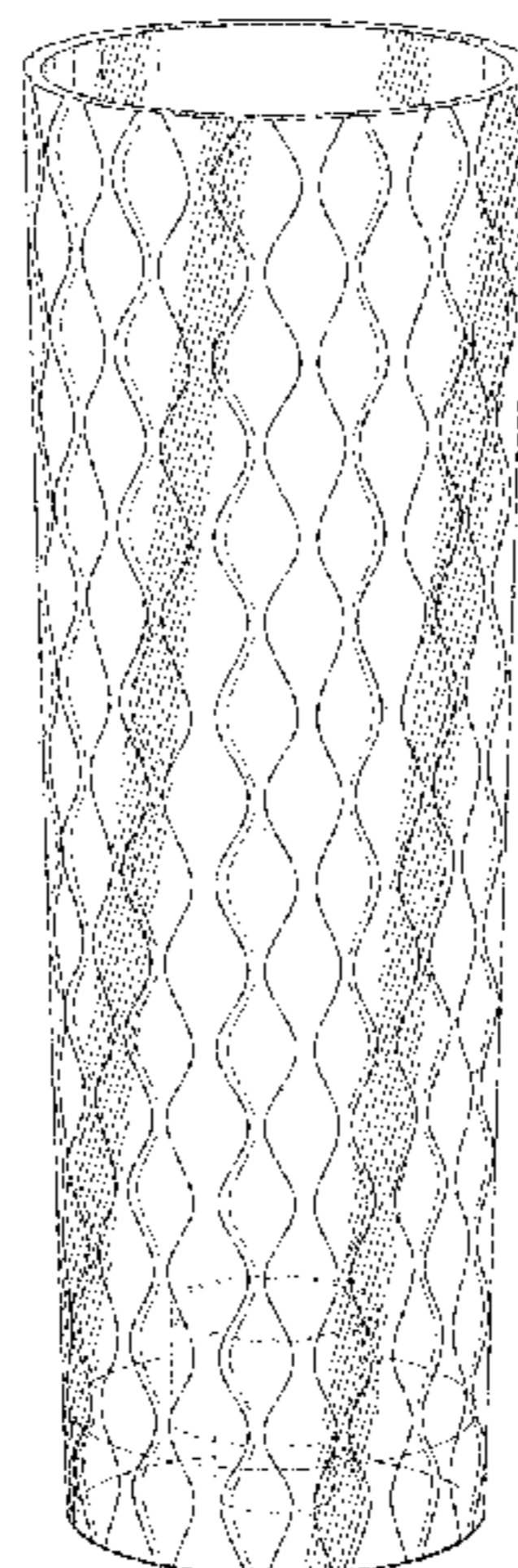
(57) **CLAIM**

We claim the ornamental design for a water tank for a coffee machine or the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water tank for a coffee machine or the like showing our new design;
FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof;
FIG. 3 is a left side elevation view thereof, the right side elevation view being a mirror image thereof; and,
FIG. 4 is a top plan view thereof.
The broken lines shown in the figure drawings are for the purpose of illustrating portions of the water tank for a coffee machine or the like only and form no part of the claimed design.

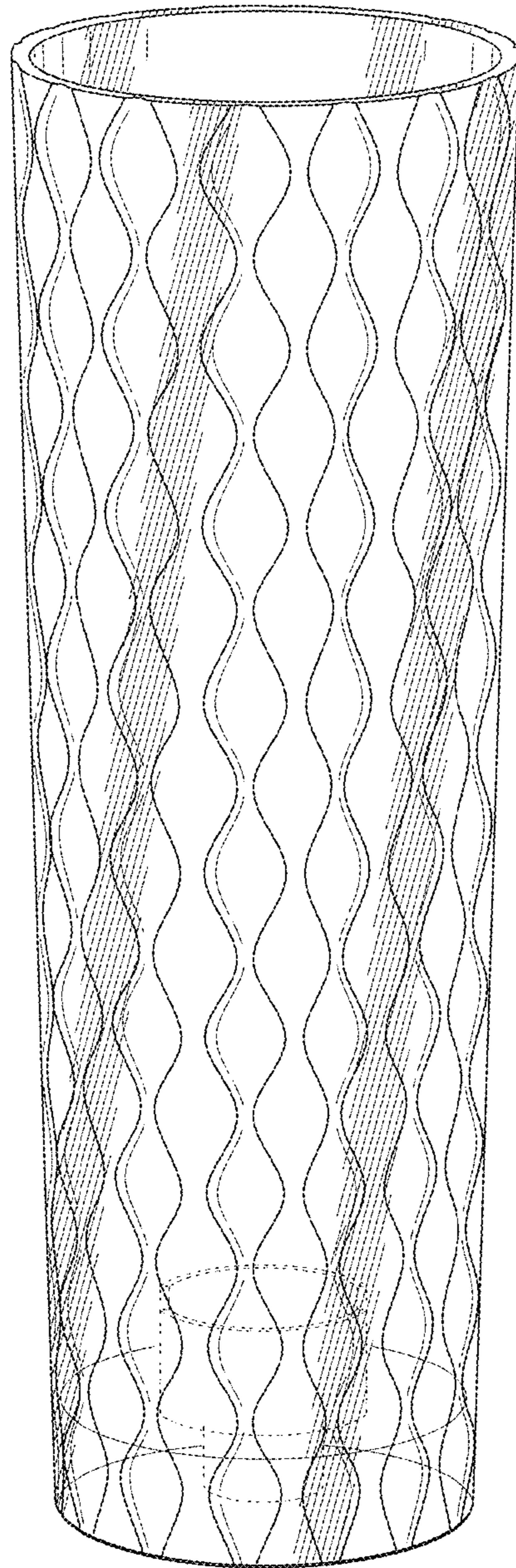

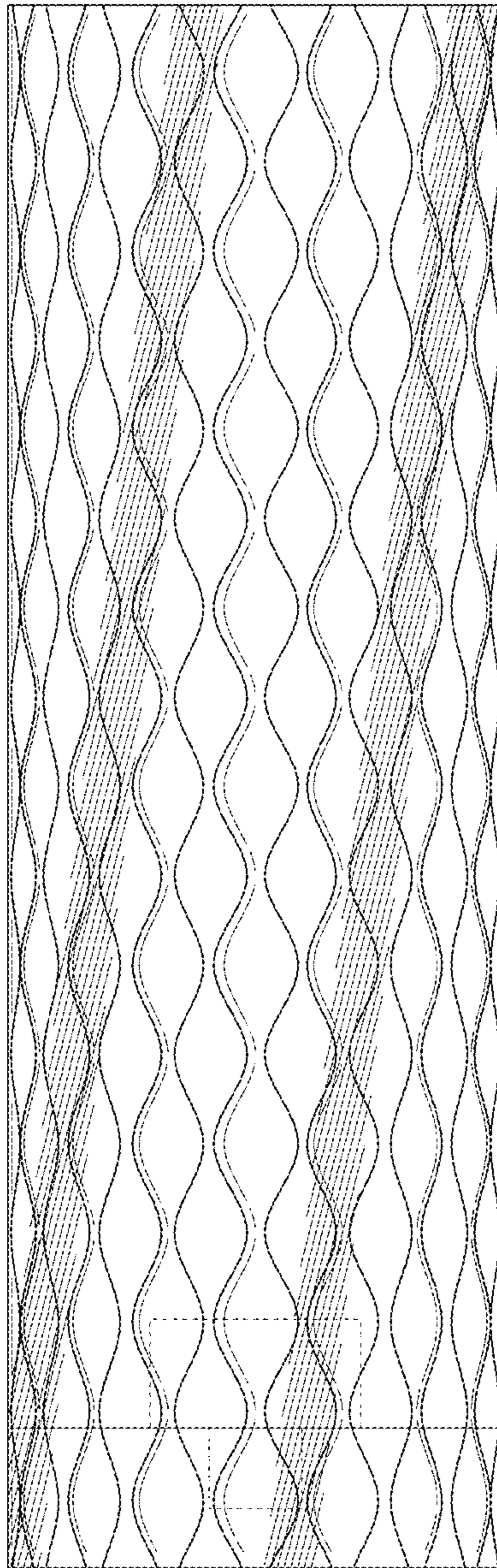

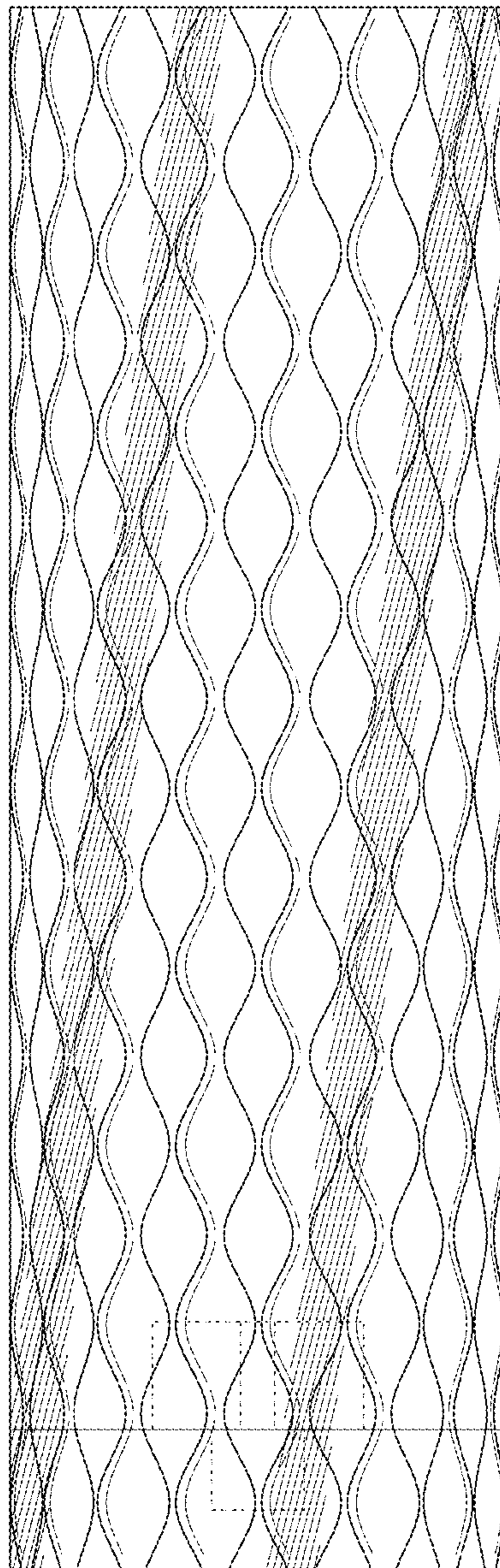

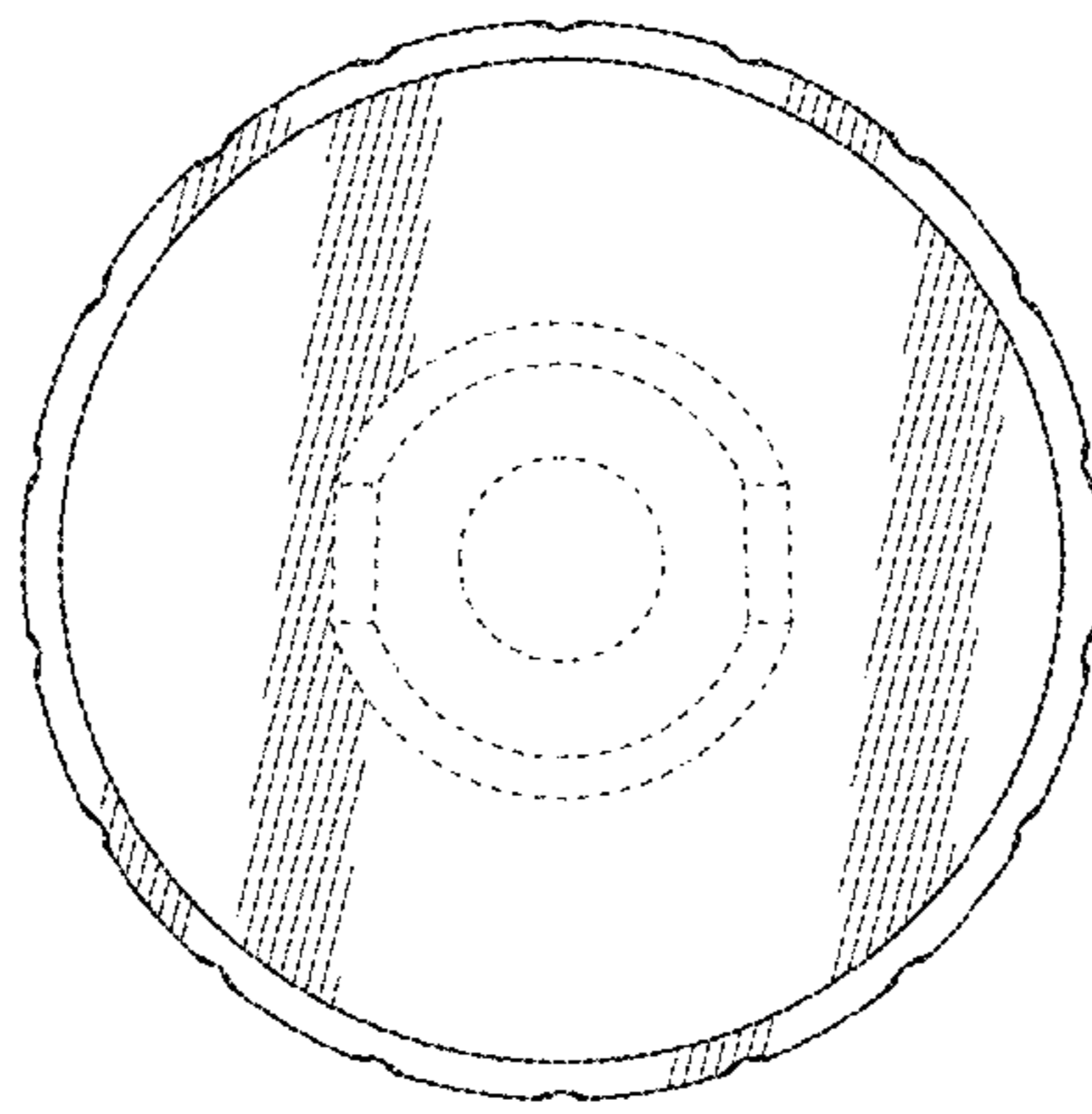
