(57) **CLAIM**

The ornamental design for a clamp rack, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric perspective view of a clamp rack in accordance with our design showing a first plate and a second plate of the clamp rack in an exemplary first assembled configuration;

FIG. 2 is an isometric perspective of the clamp rack in accordance with our design showing the first plate and the second plate of the clamp rack in an exemplary second assembled configuration;

FIG. 3 is a front, top, right end, perspective view of the first plate of the clamp rack shown in FIG. 1 or FIG. 2;

FIG. 4 is a front elevation view of the first plate;

FIG. 5 is a rear elevation view of the first plate

FIG. 6 is a top plan view of the first plate;

FIG. 7 is a bottom plan view of the first plate;

FIG. 8 is a left end elevation view of the first plate; and

FIG. 9 is a right end elevation view of the first plate;

FIG. 10 is a front, top, right end, isometric perspective view of the second plate of the clamp rack shown in FIG. 1 or FIG. 2;

FIG. 11 is a front elevation of the second plate;

FIG. 12 is a rear elevation view of the second plate;

FIG. 13 is a top plan view of the second plate

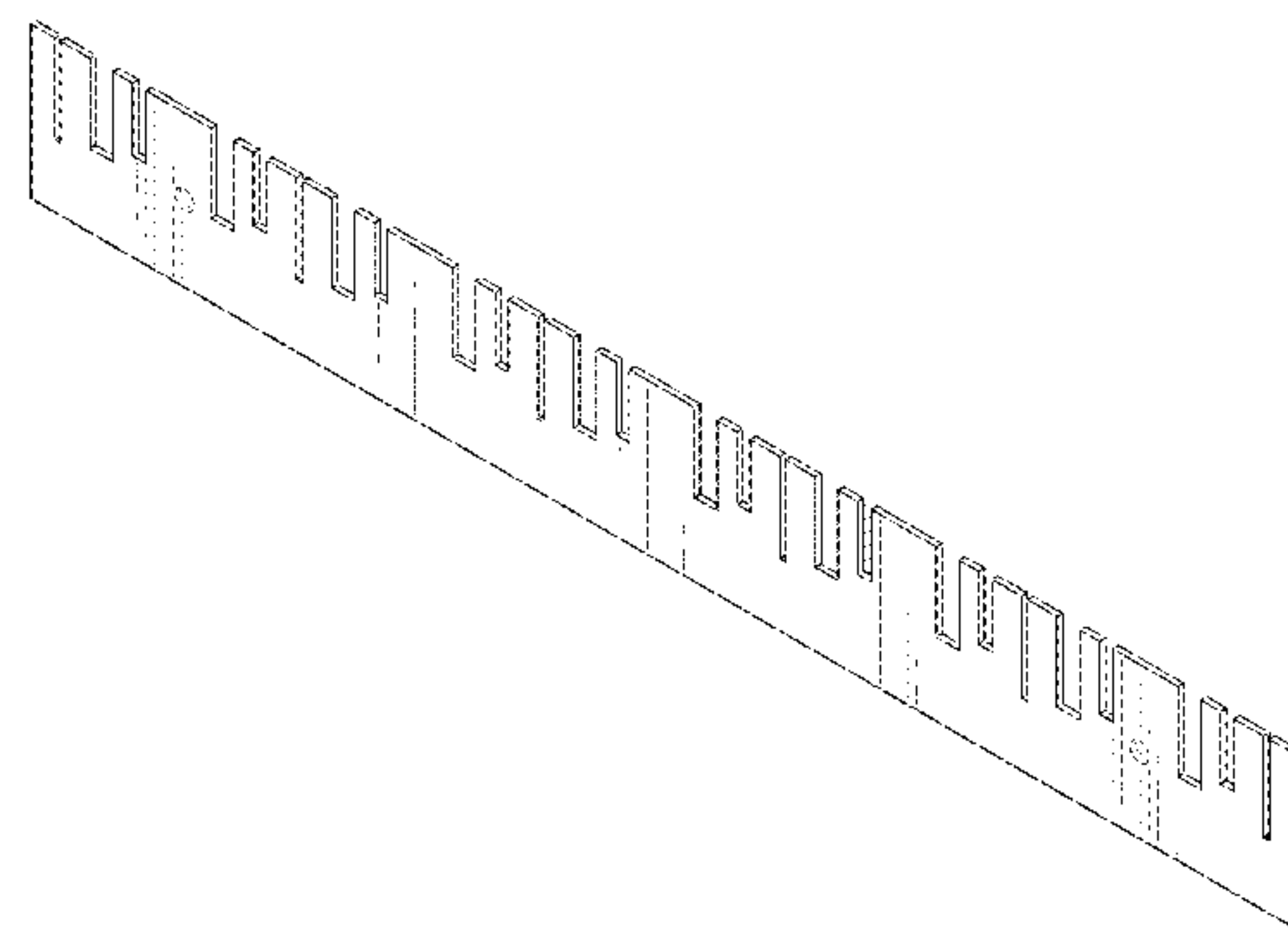
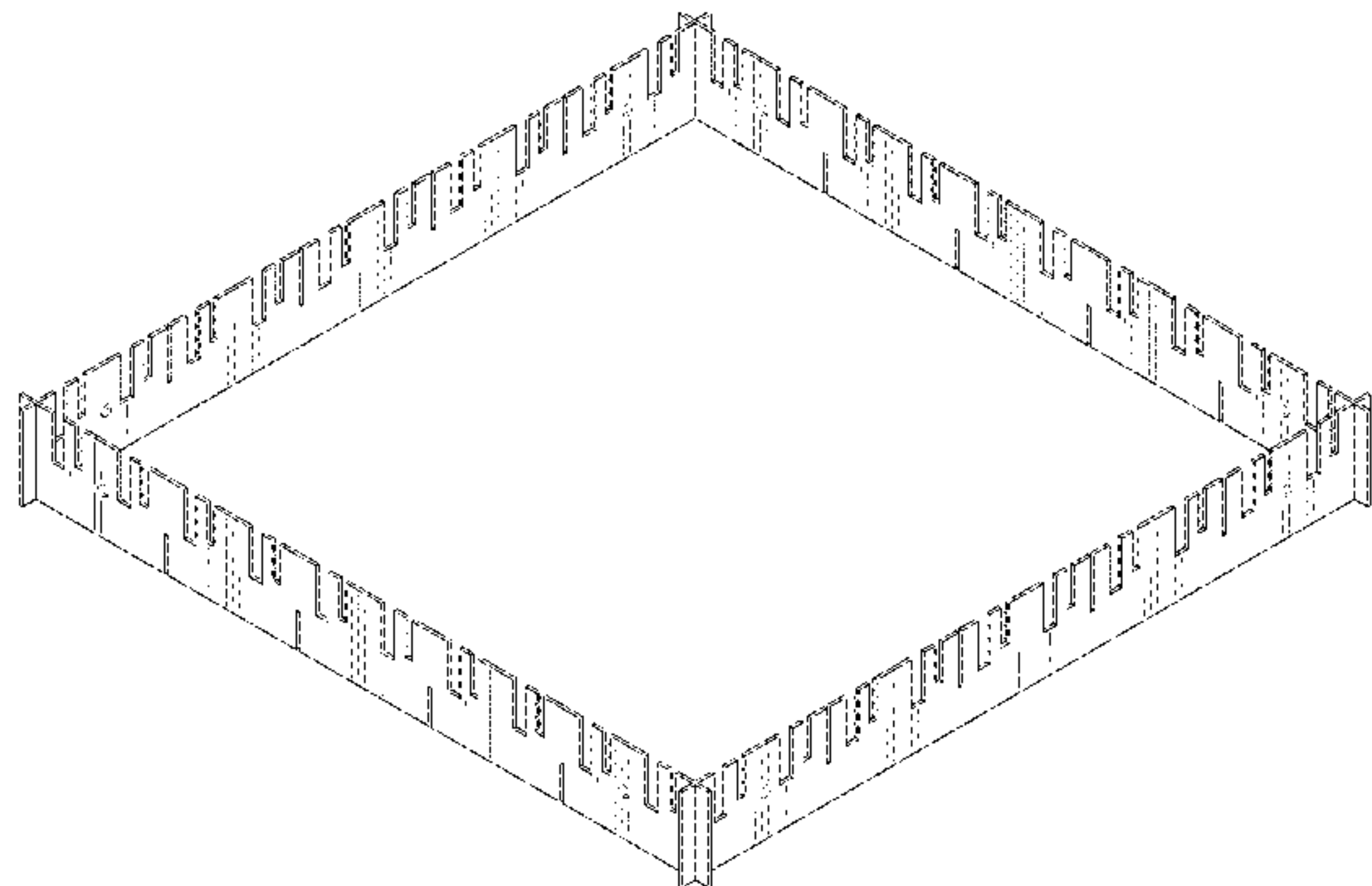
FIG. 14 is a bottom plan view of the second plate;

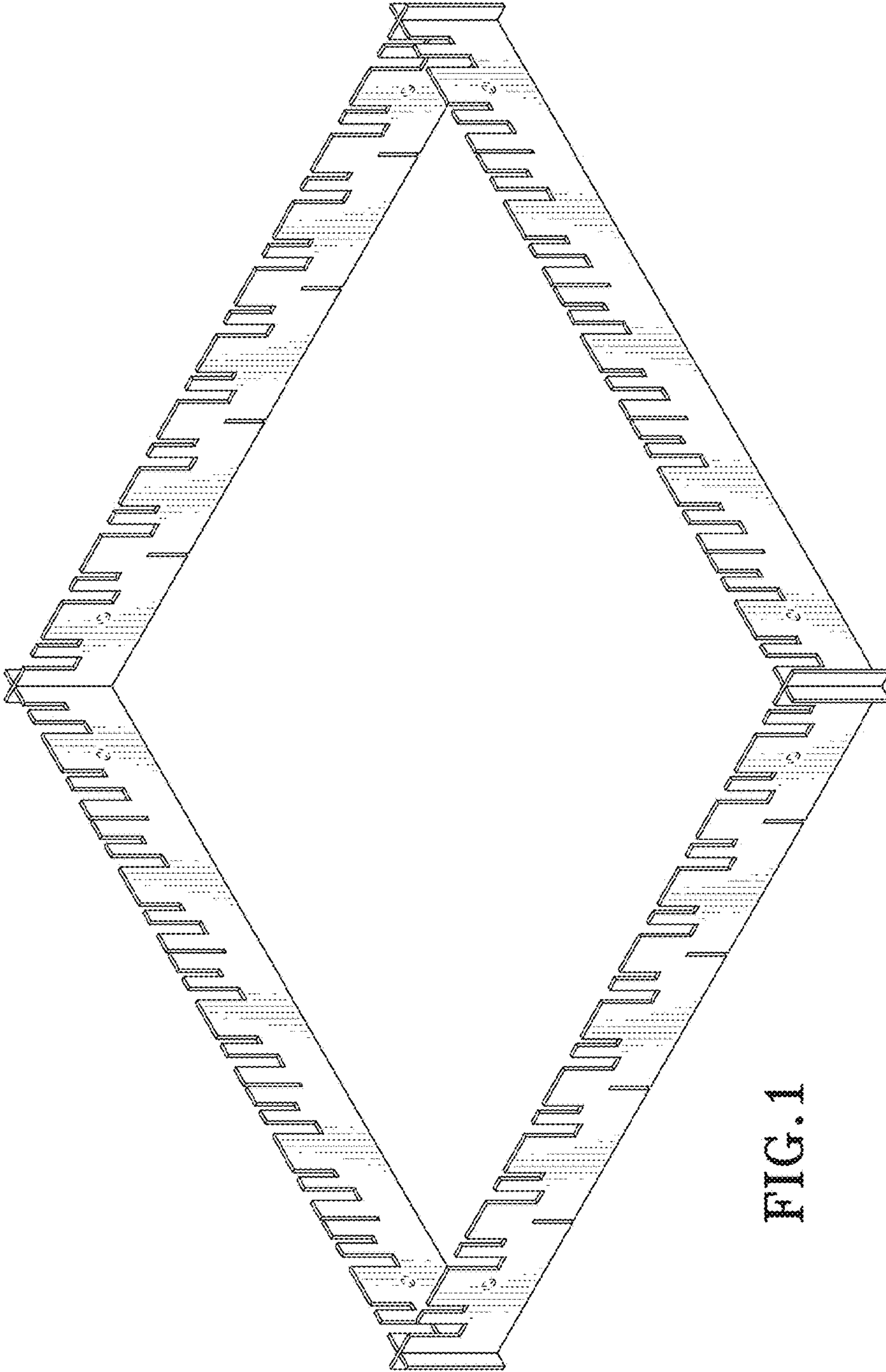
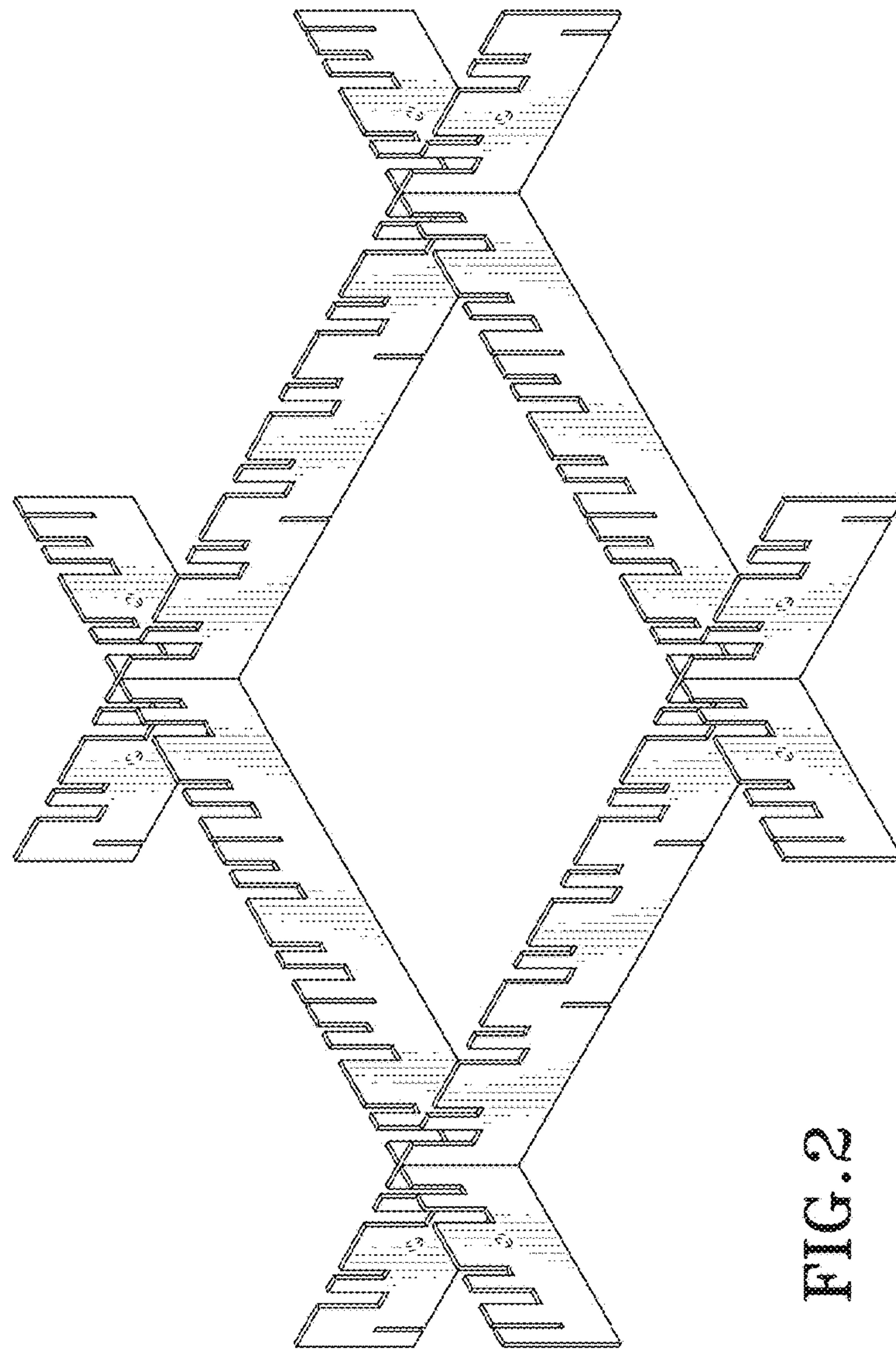

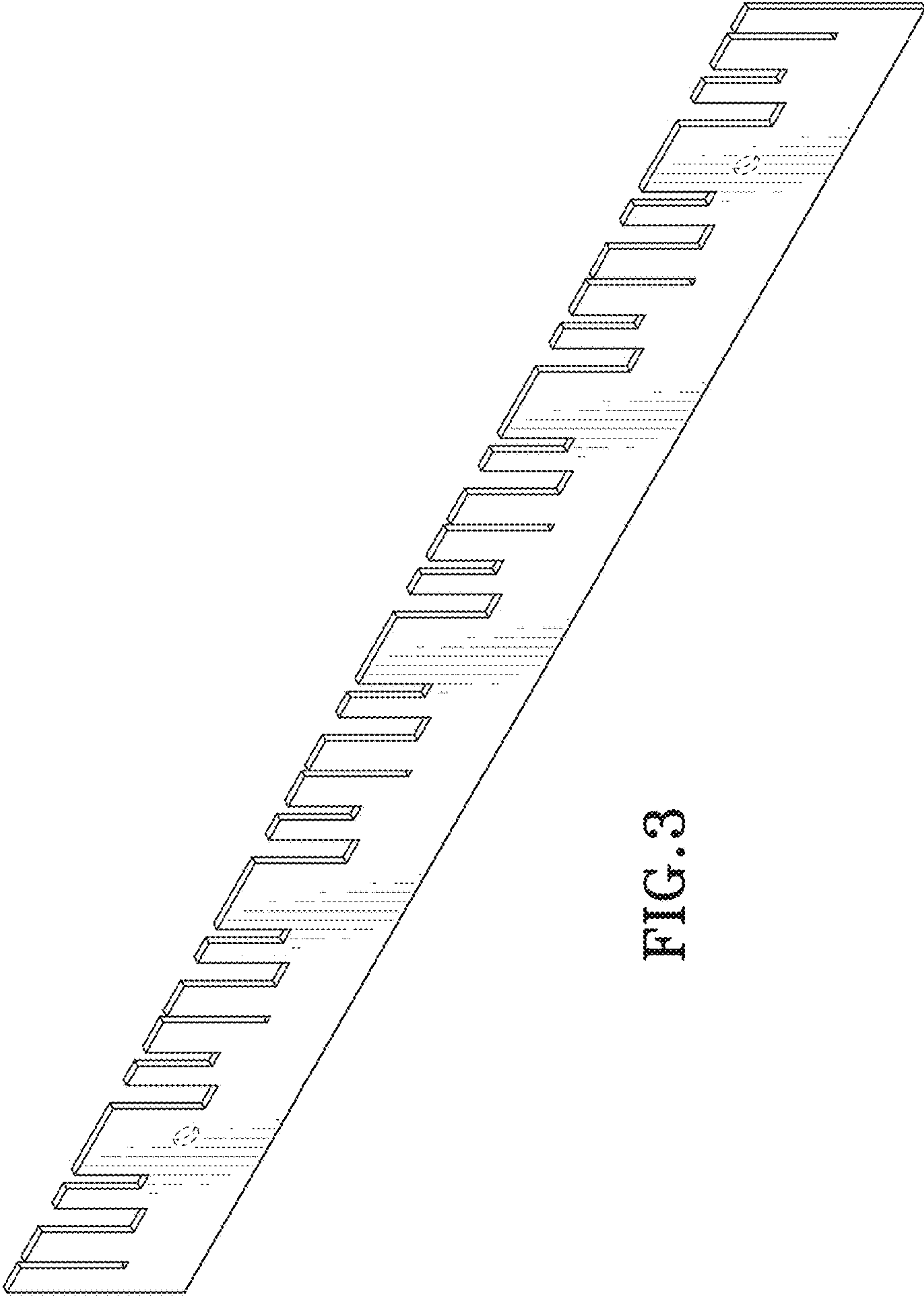
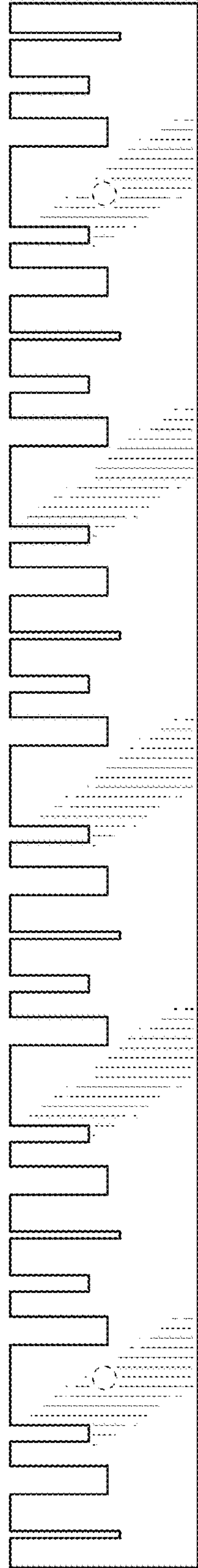
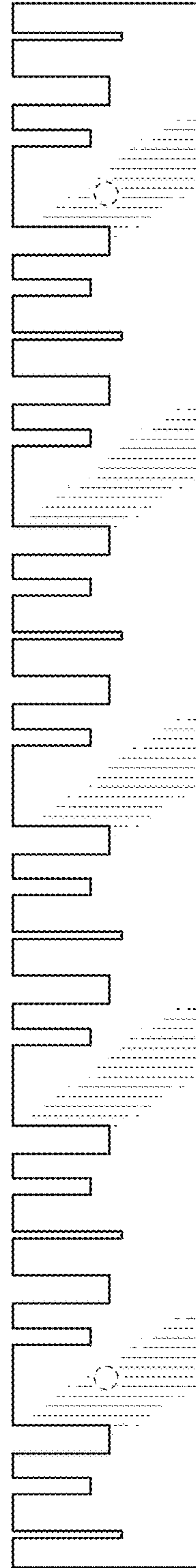

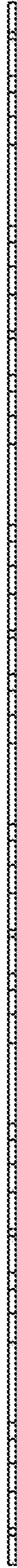

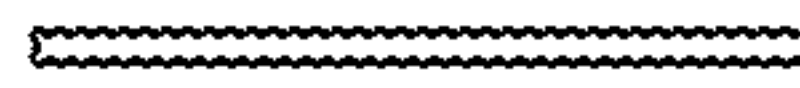

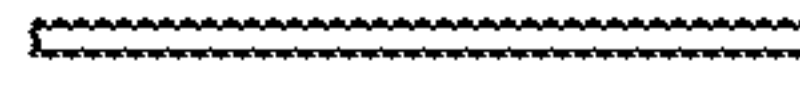

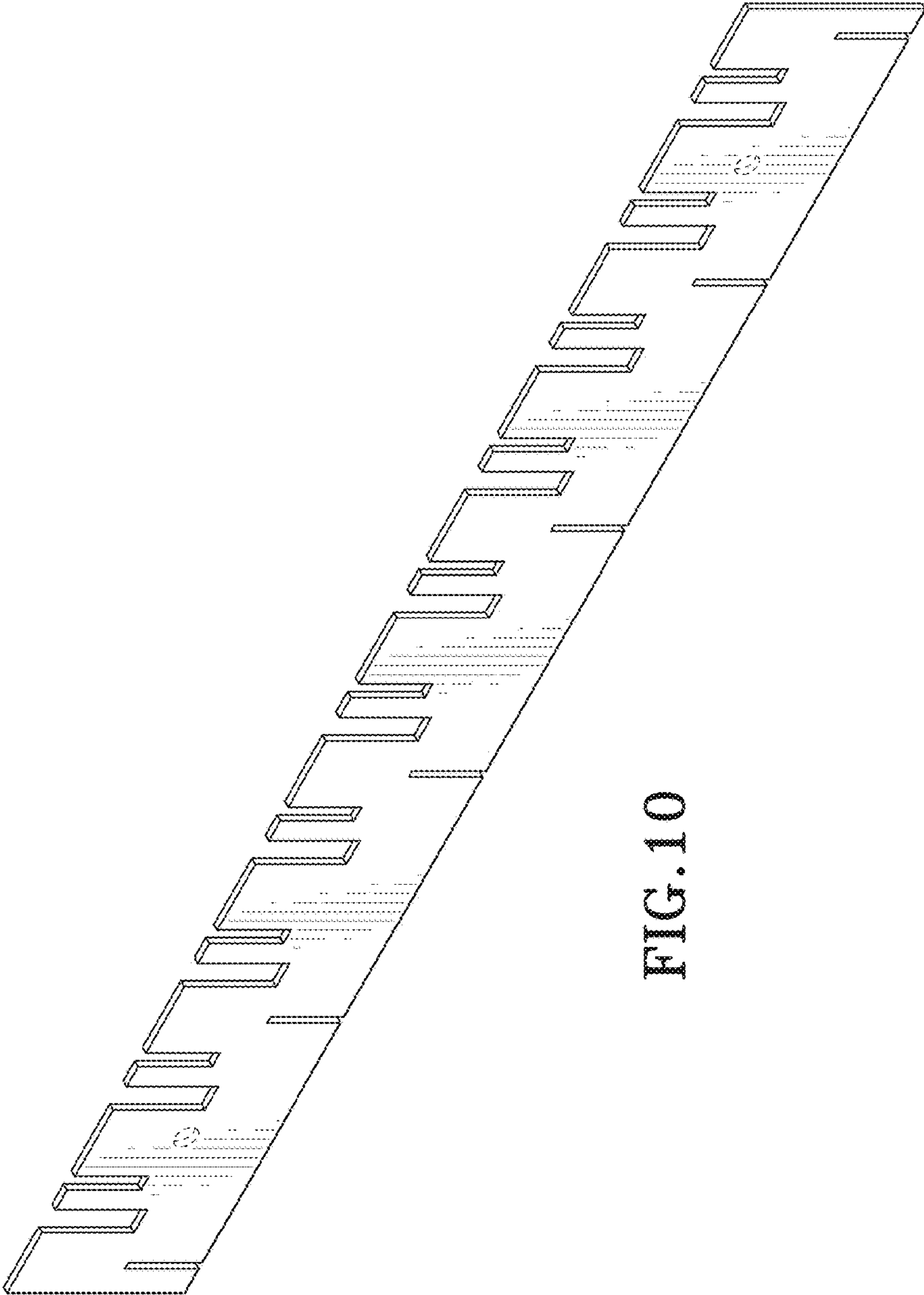

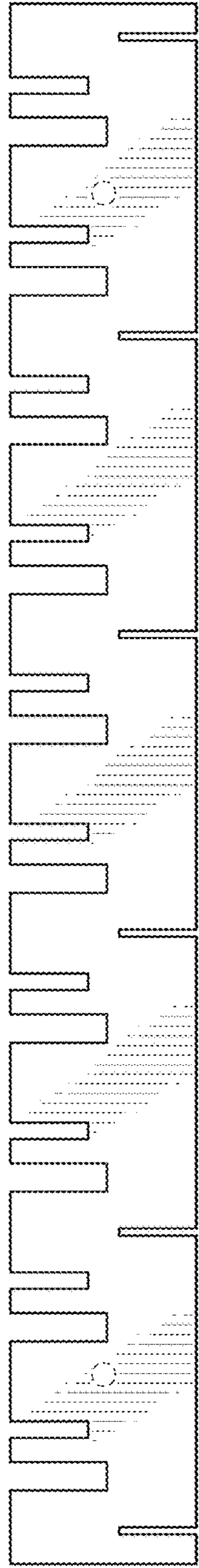

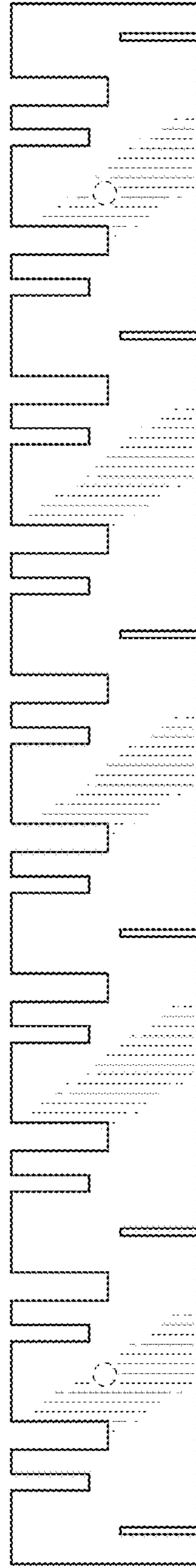
