(57) **CLAIM**

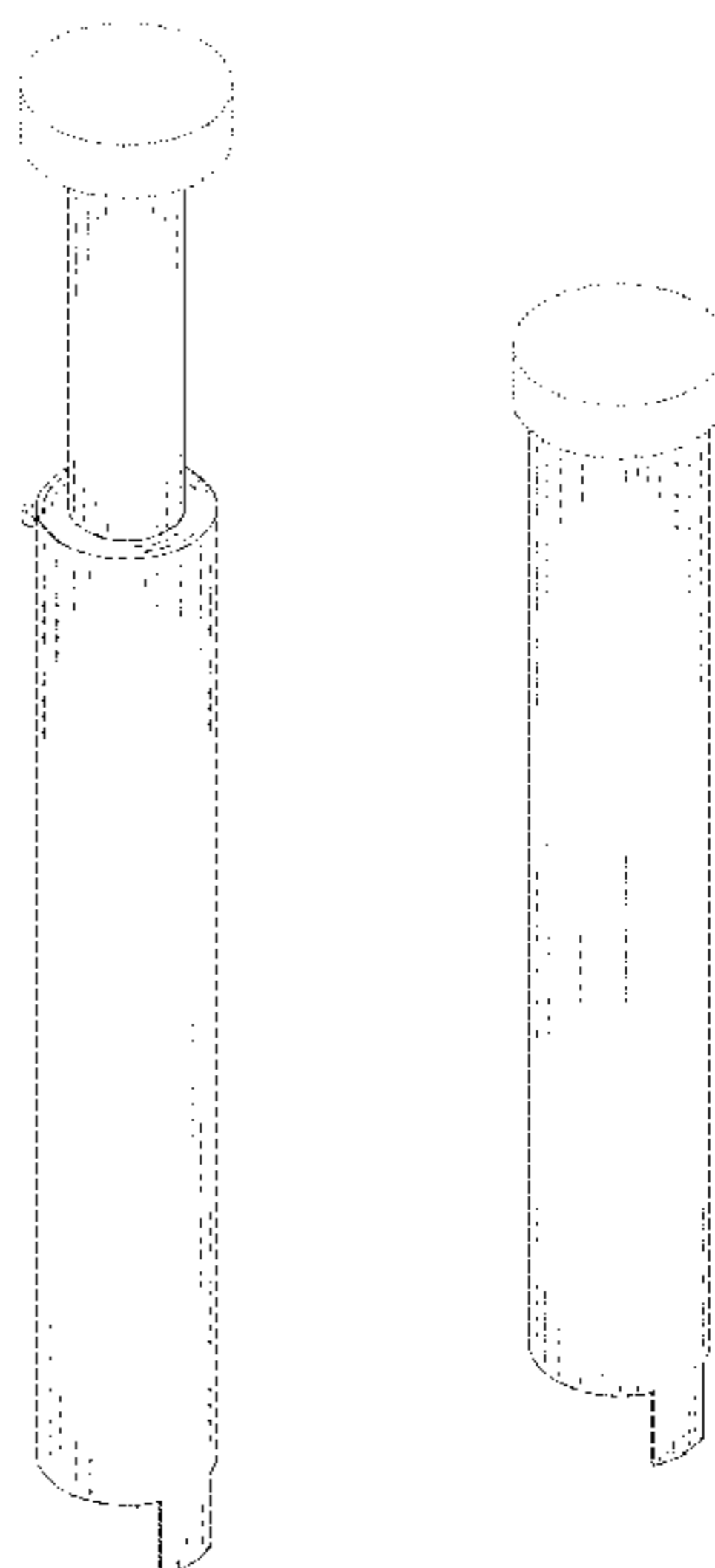
The ornamental design for a telescopic lock for sliding doors and windows, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a telescopic lock for sliding doors and windows in an expanded configuration showing our new design;

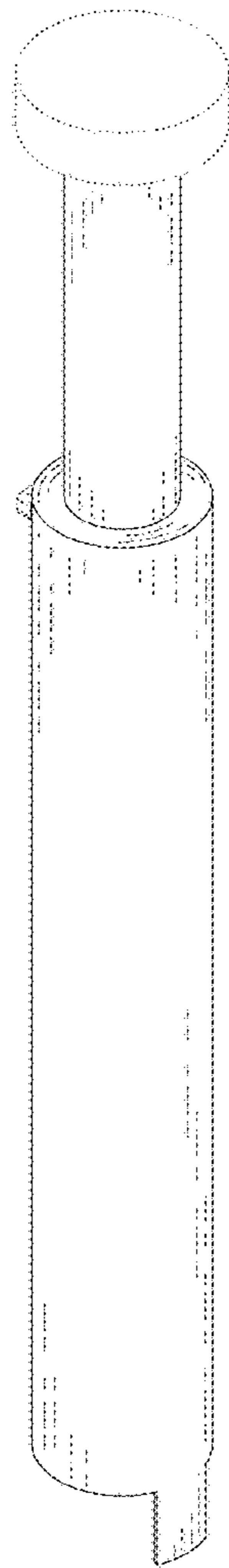

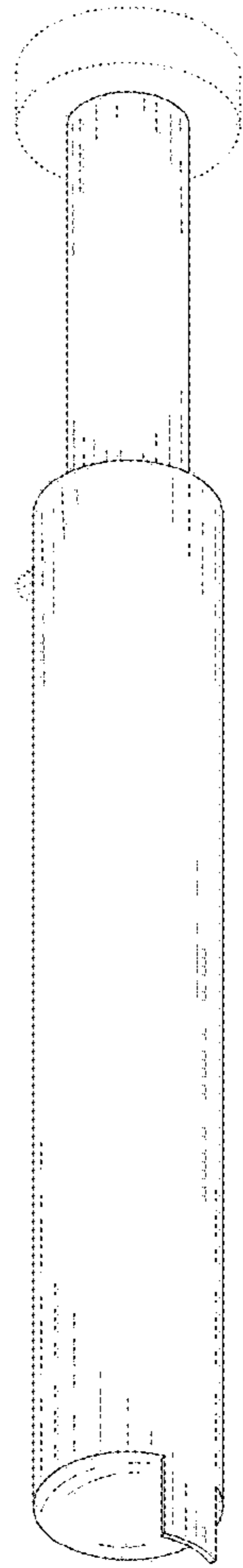

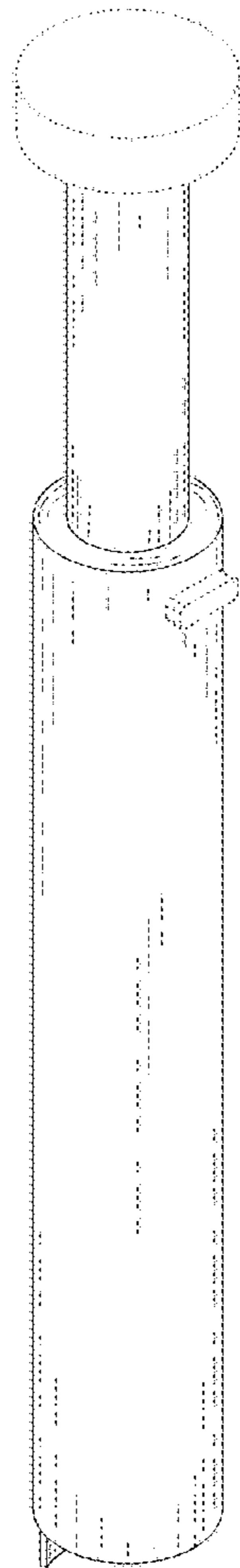

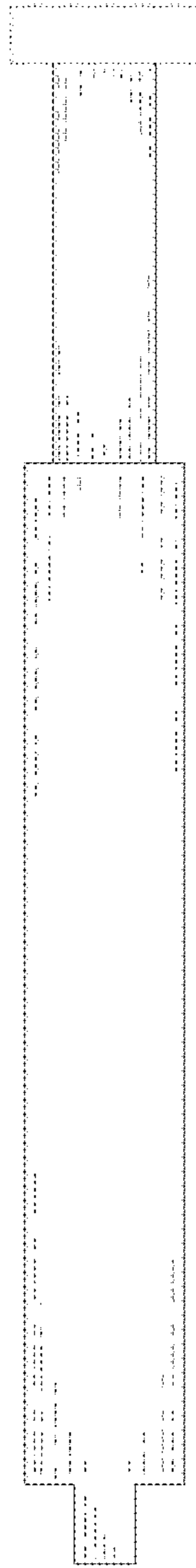

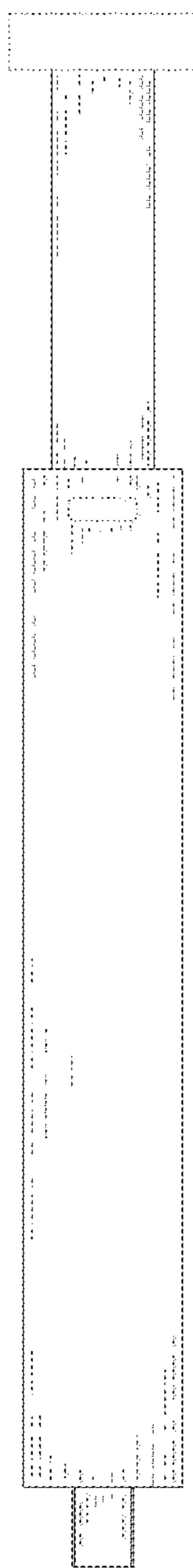

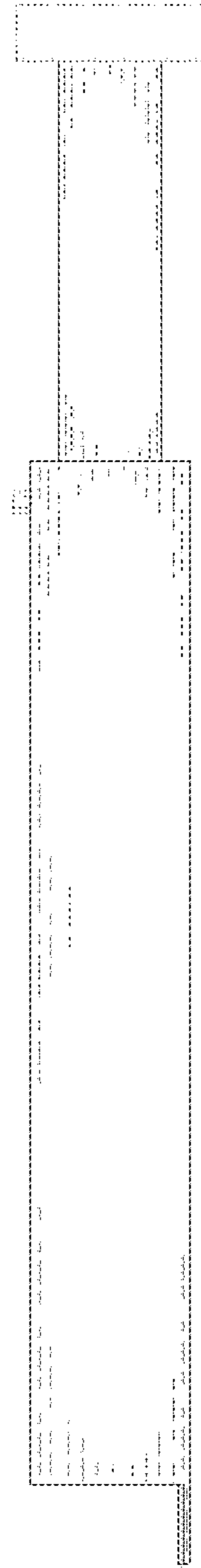

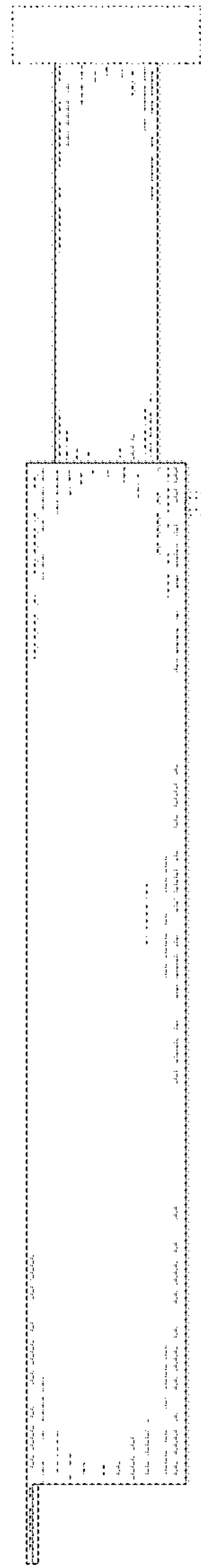

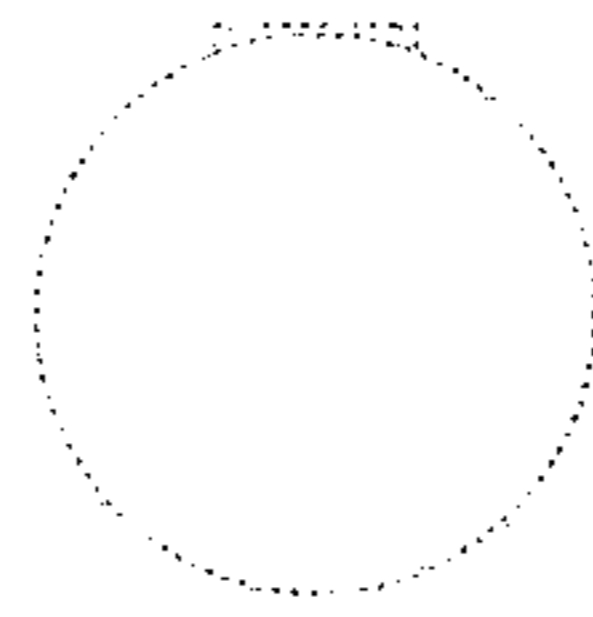

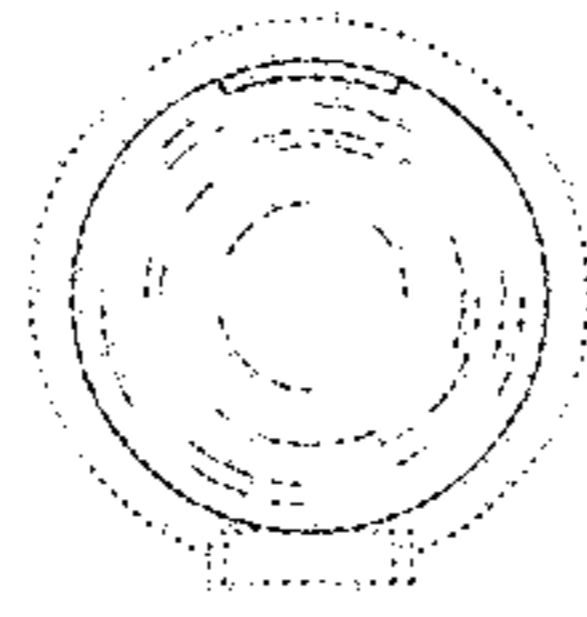

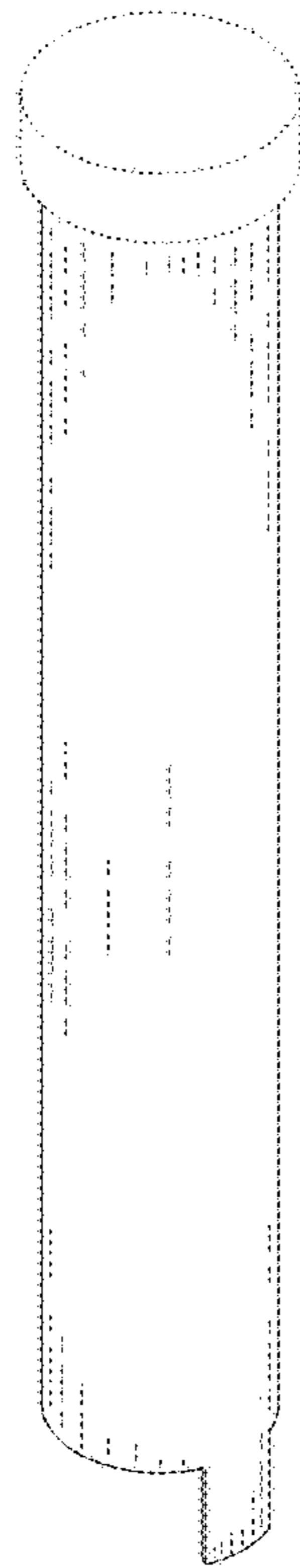

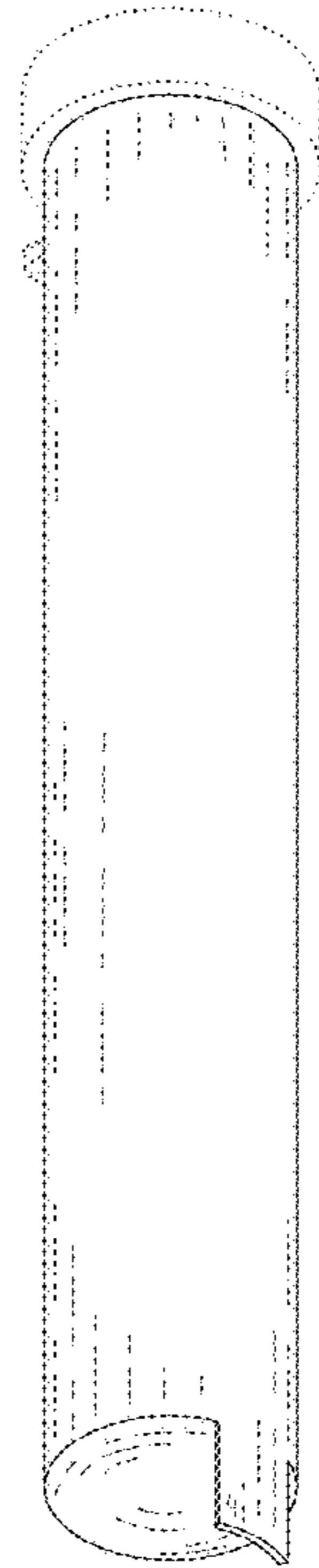

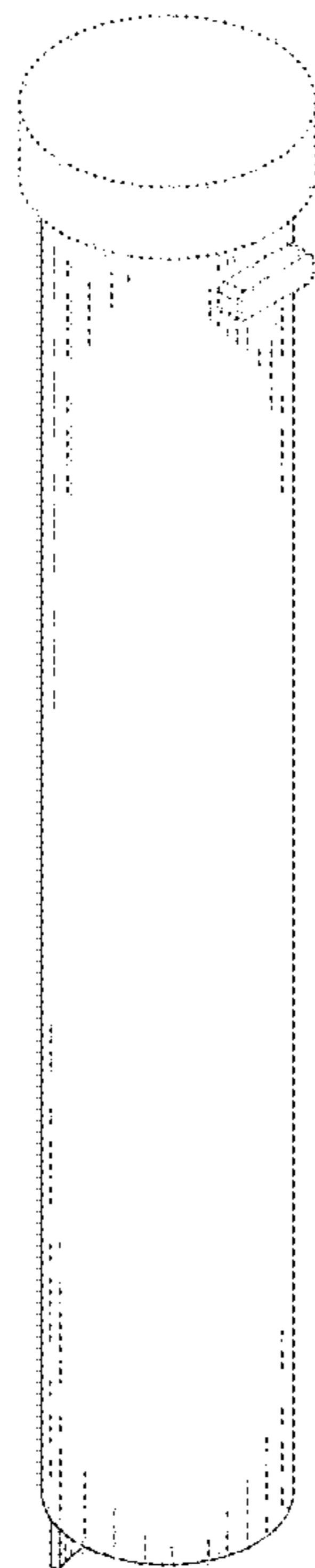

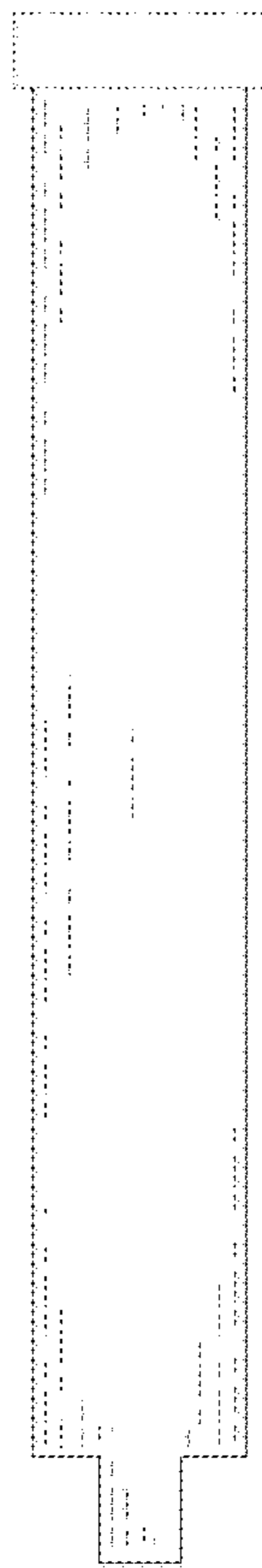

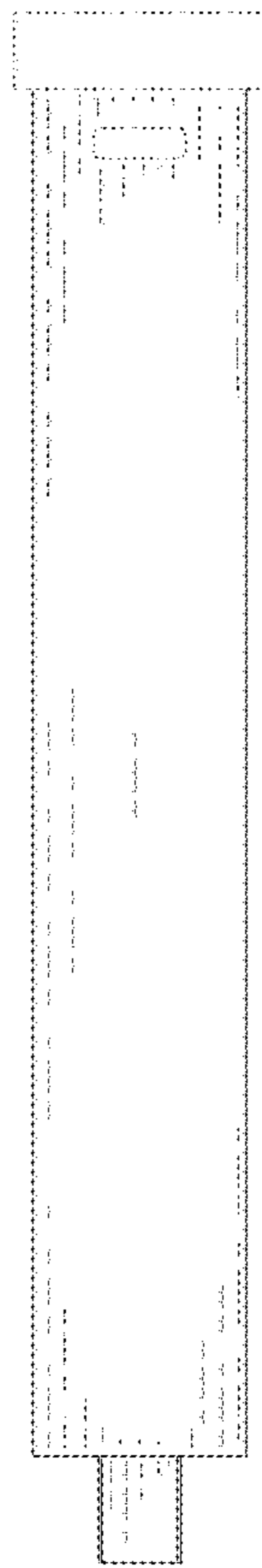

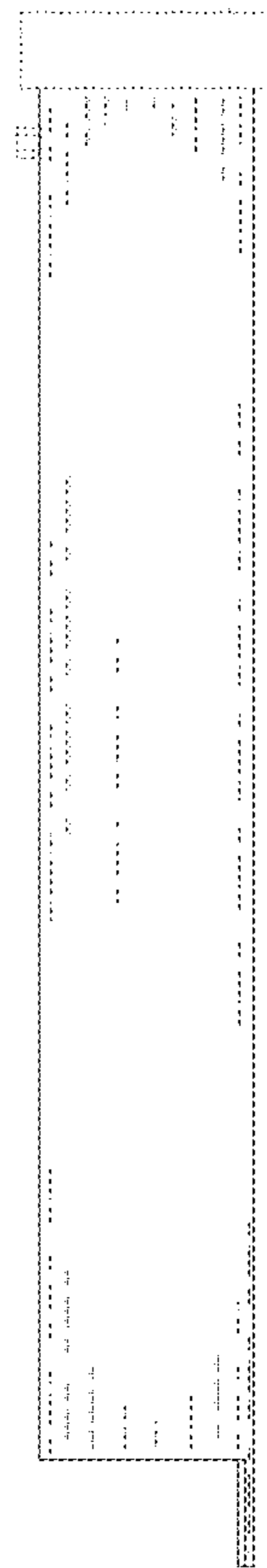

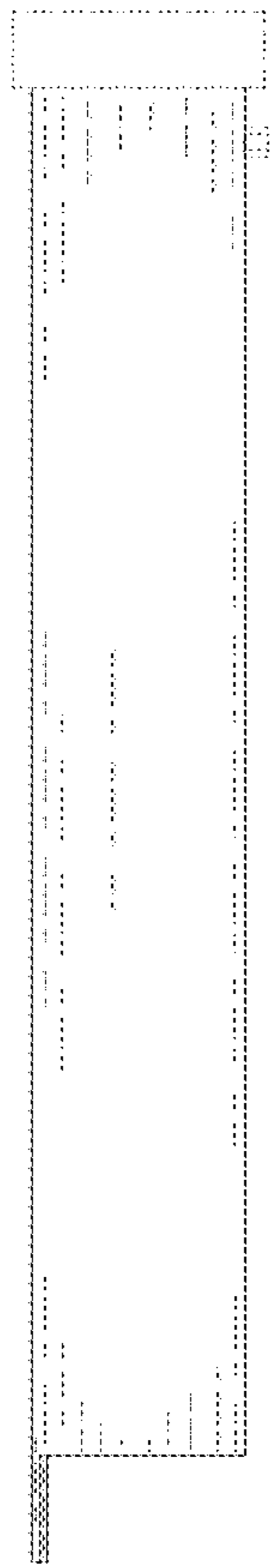
