**DESCRIPTION**

FIG. 1 is a front elevational view of a watch showing my  
new design;

FIG. 2 is a back elevational view thereof;

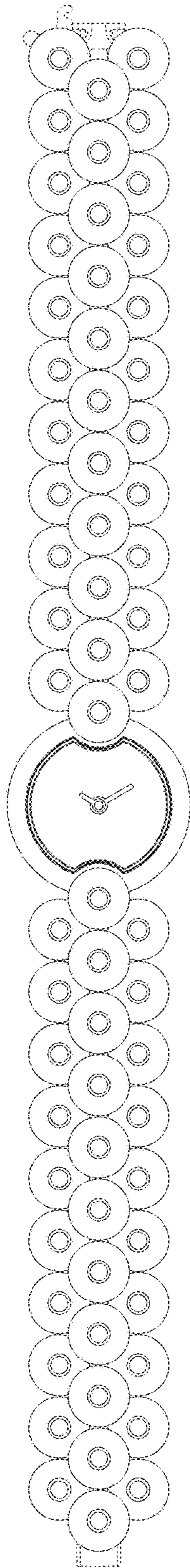

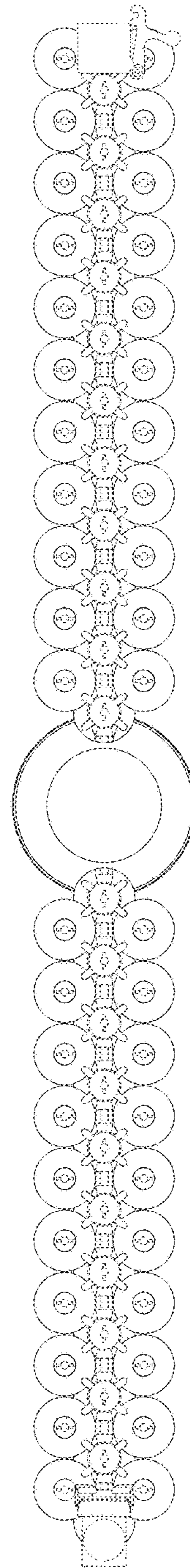

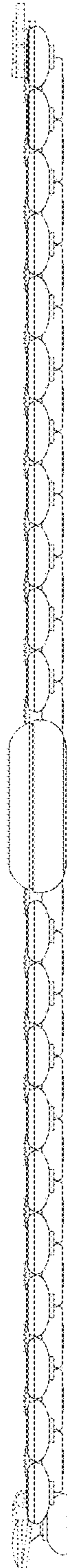

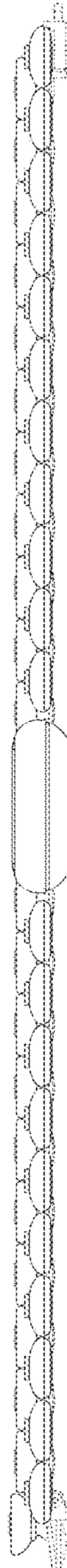
