(57) **CLAIM**

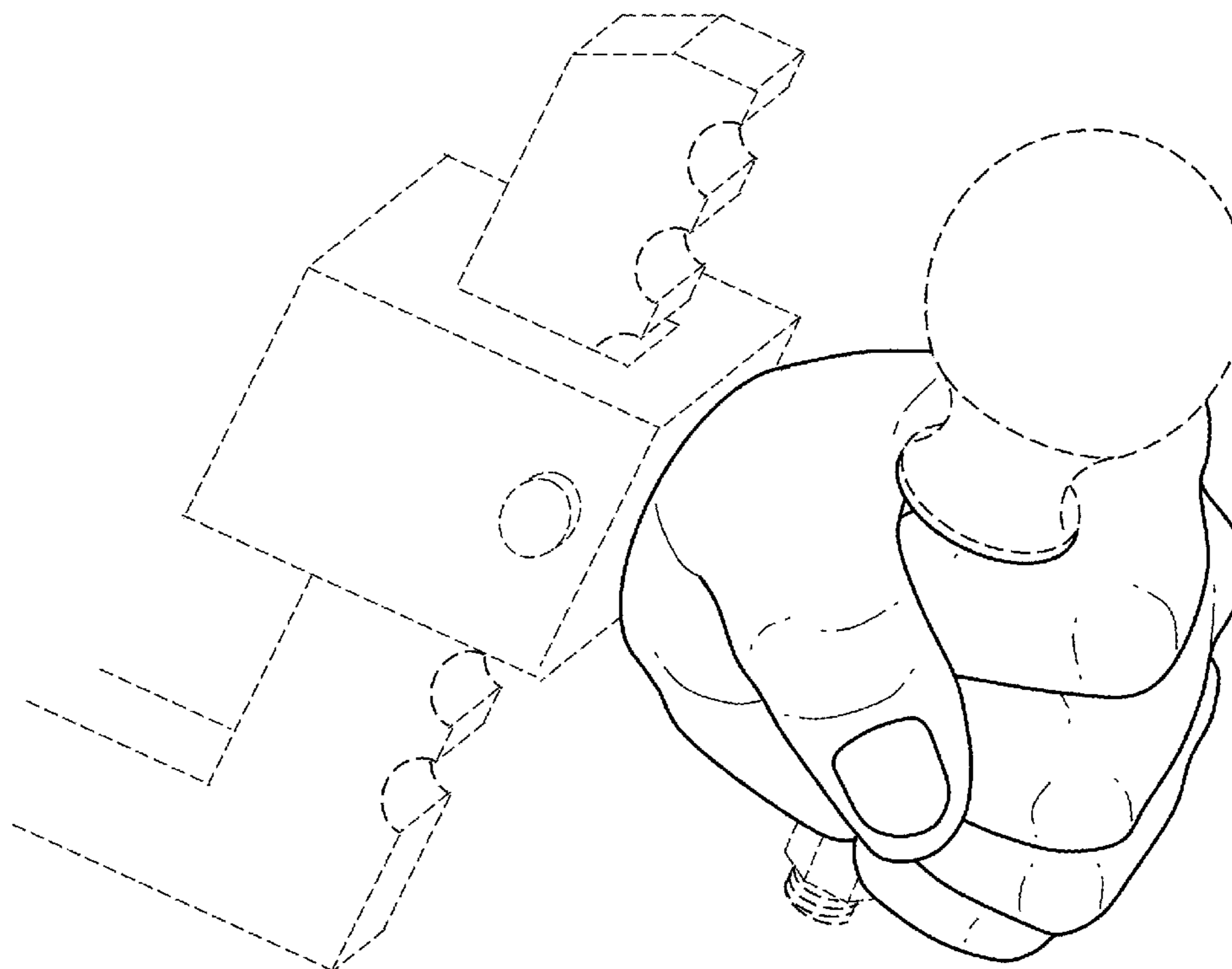
The ornamental design for a fist hitch, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a fist hitch, showing my new design;
FIG. 2 is a left side elevation view thereof;

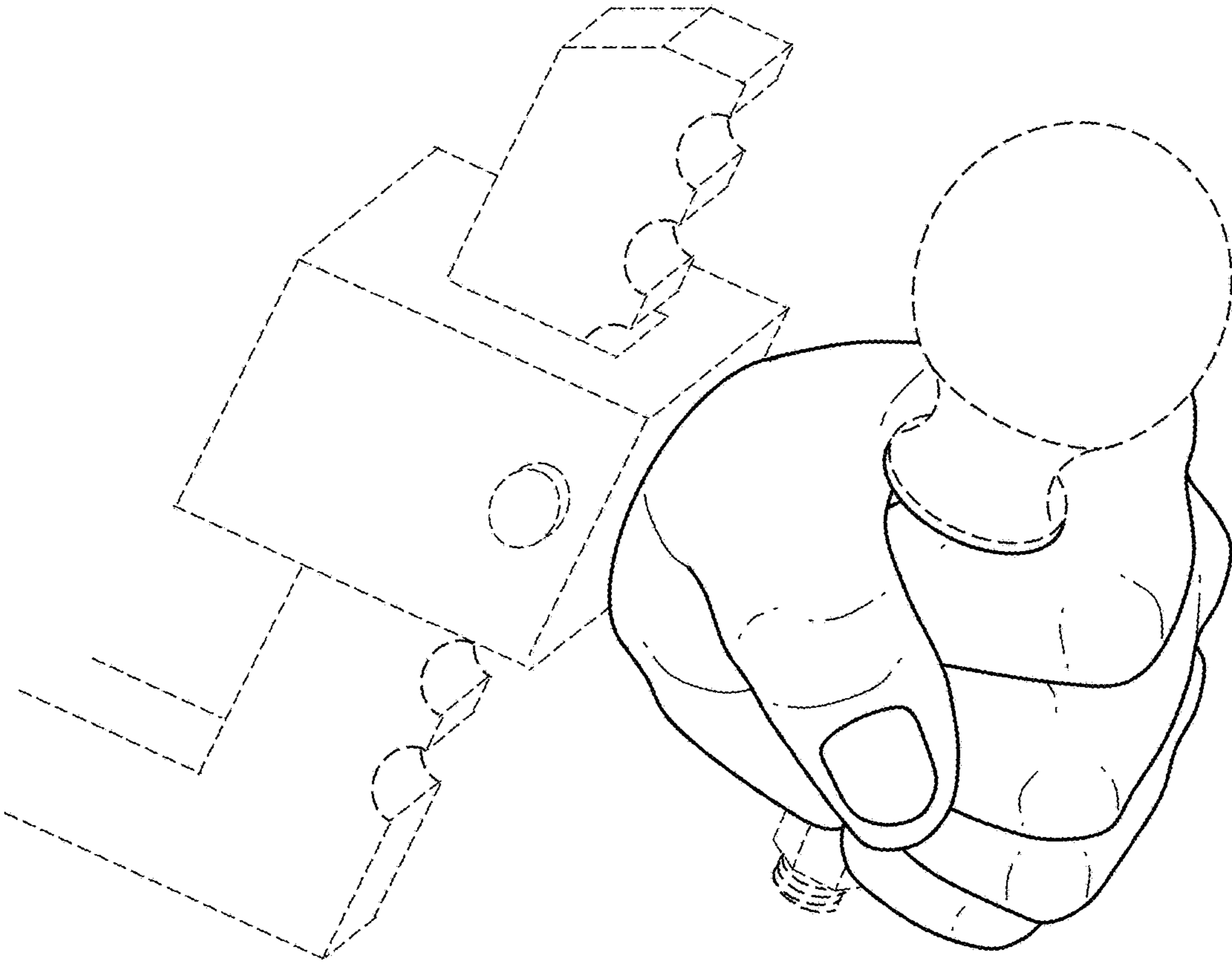

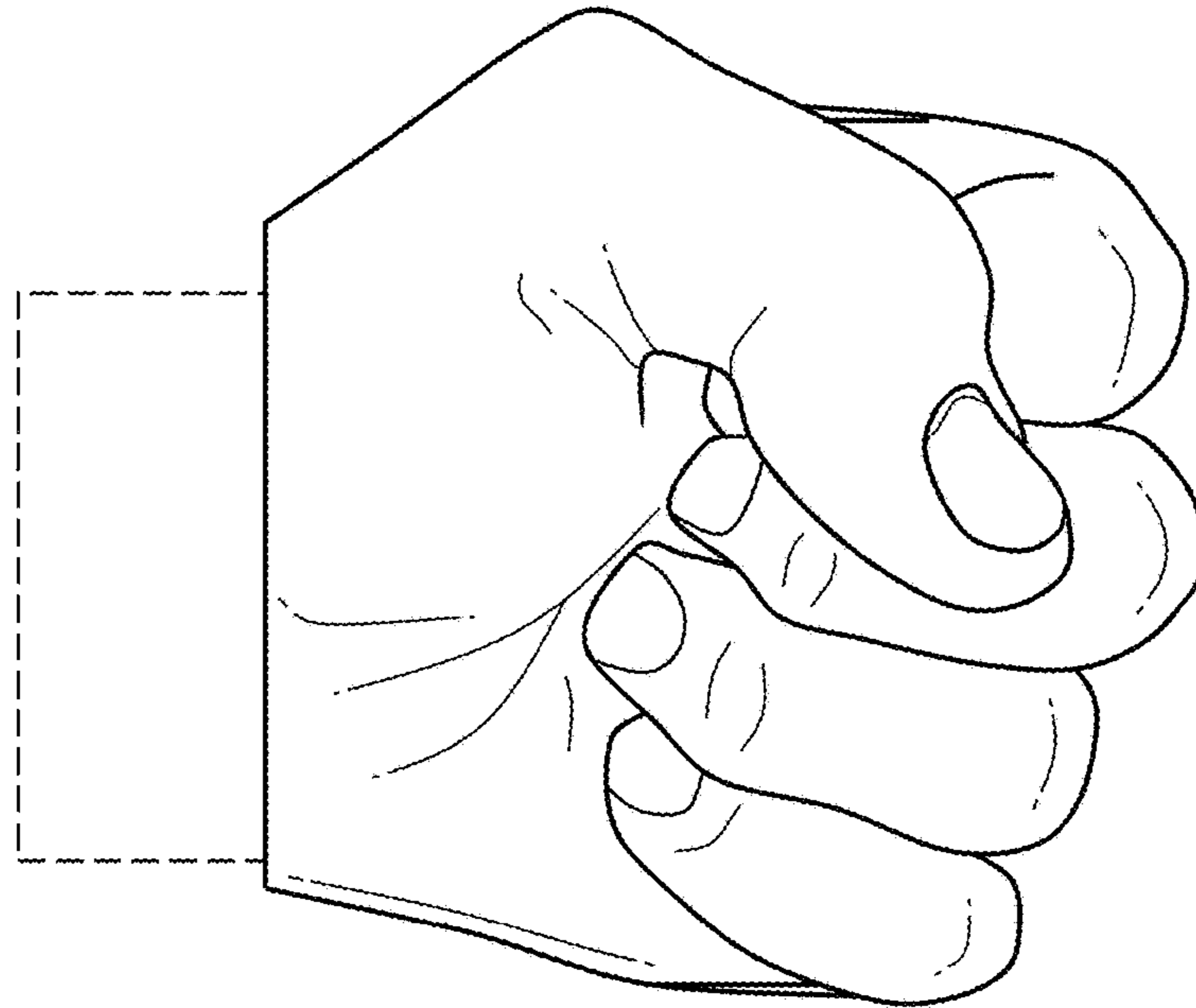

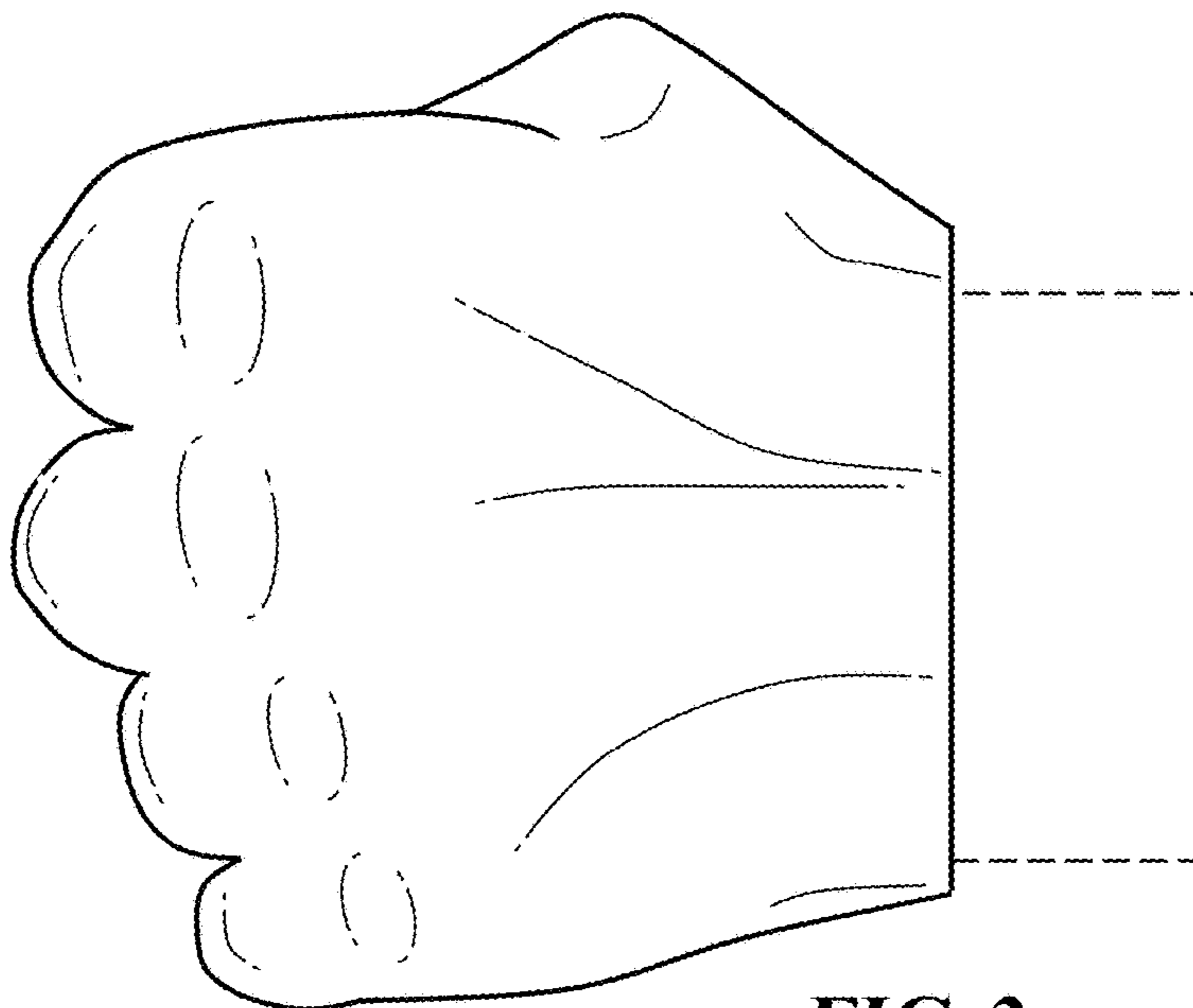

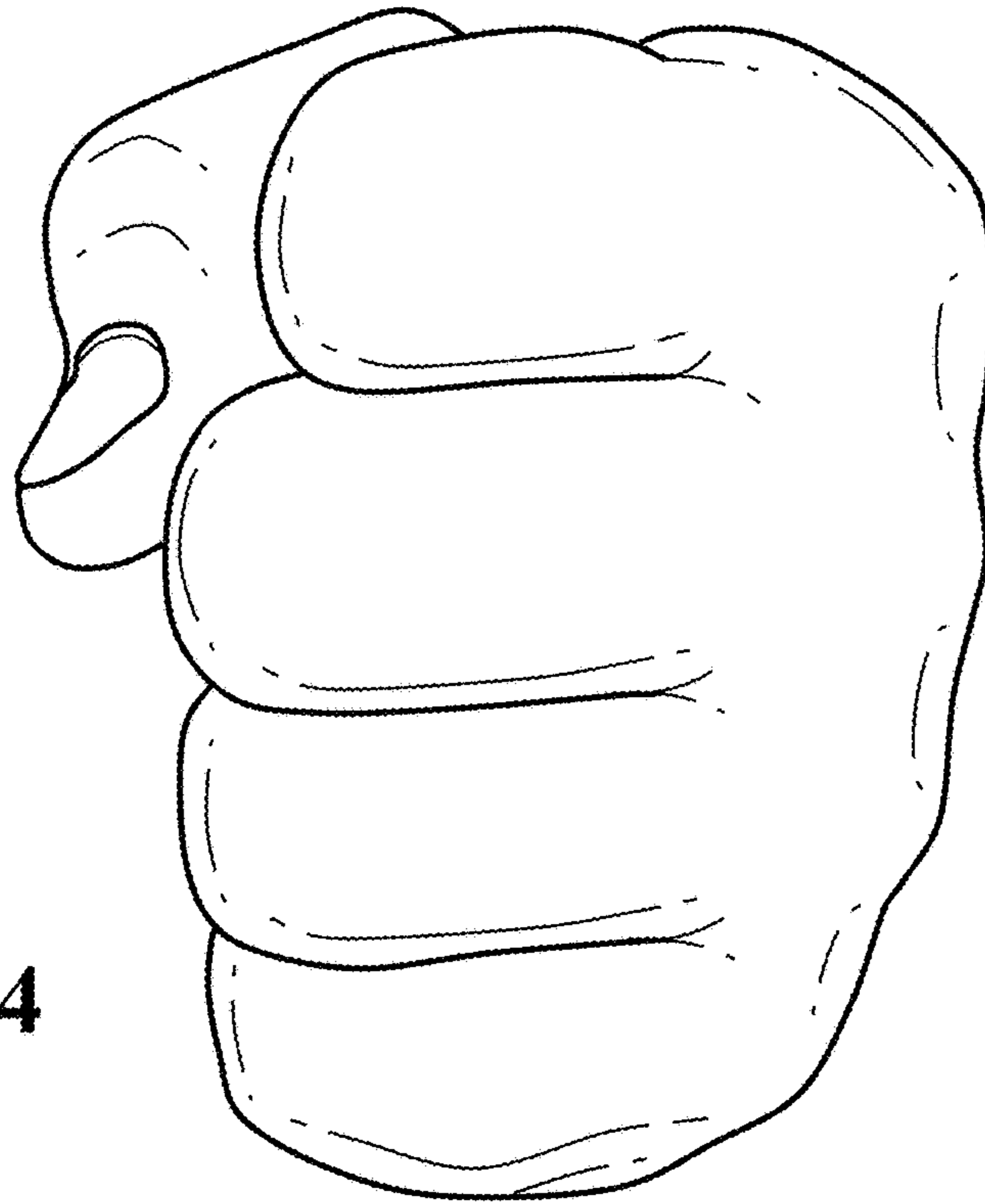

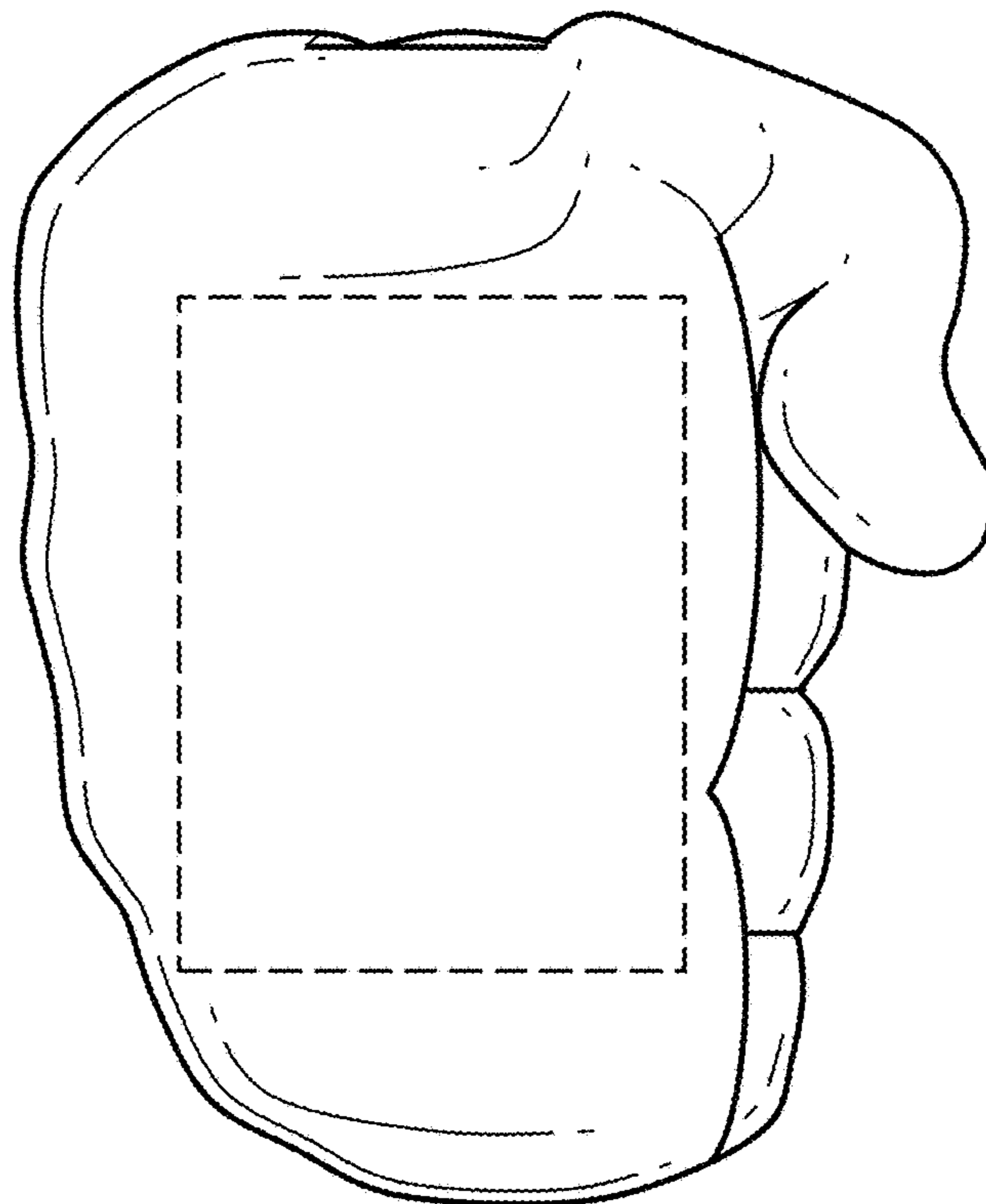

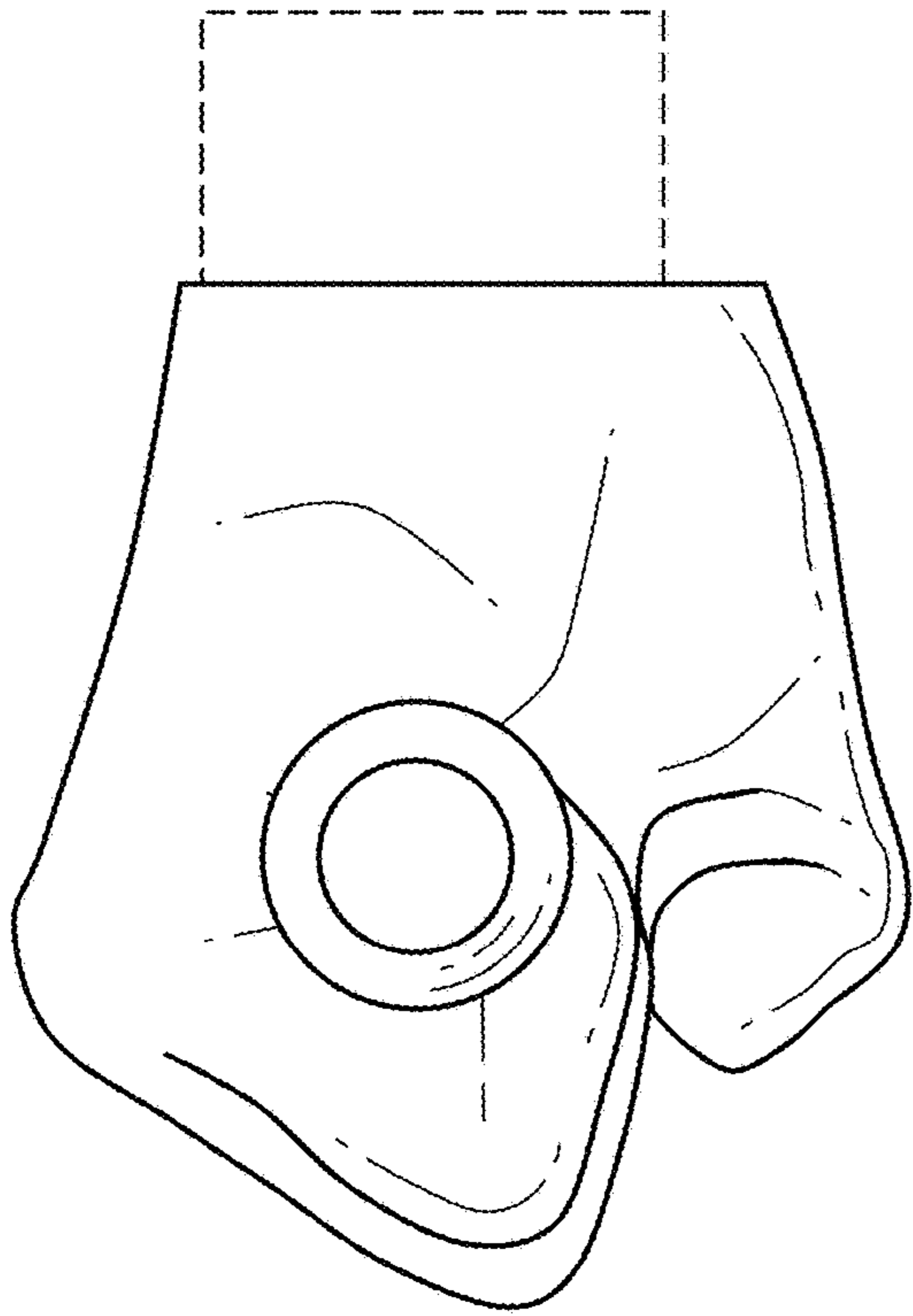

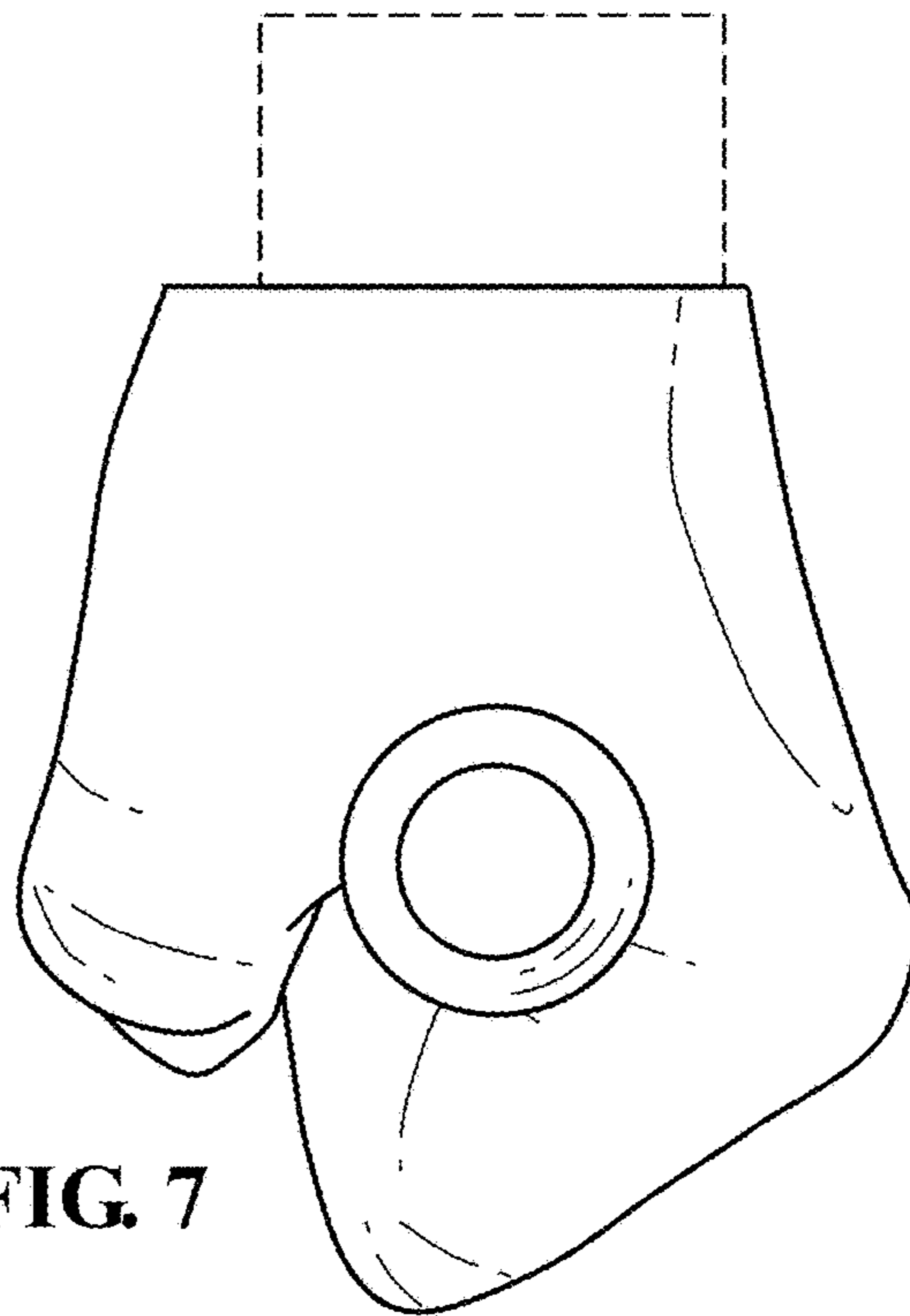
