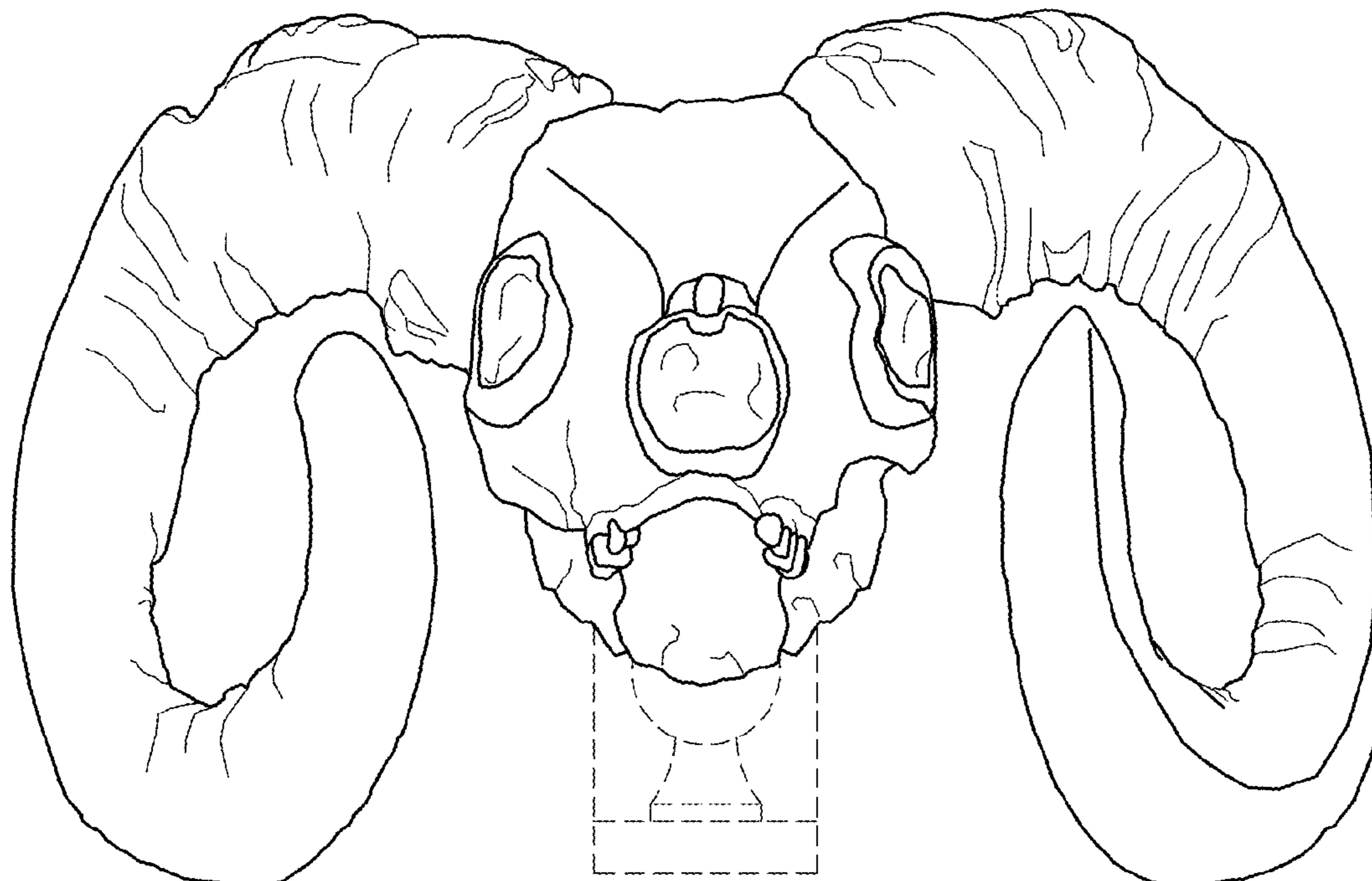
FIG. 1 is a top side perspective view thereof,

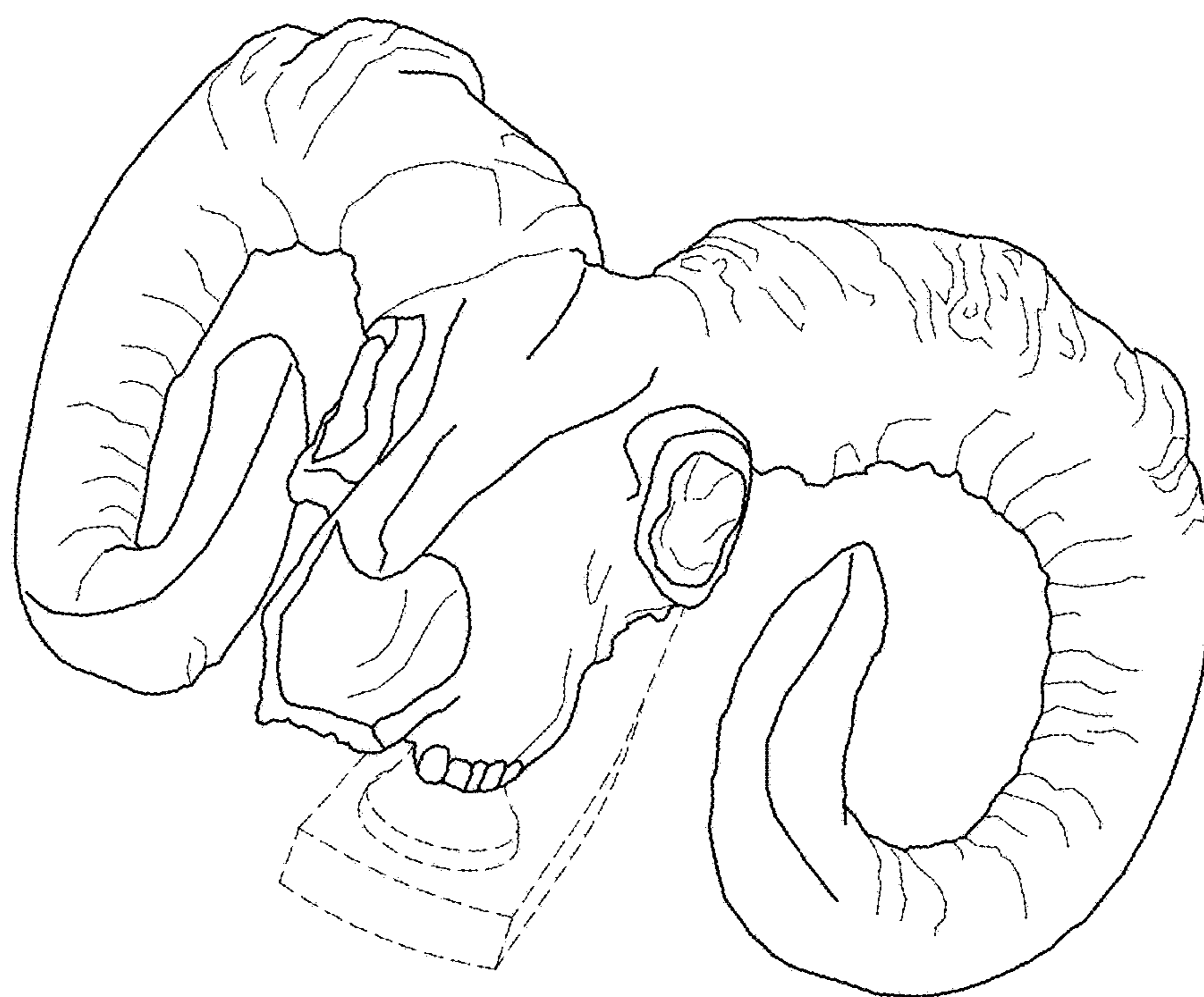

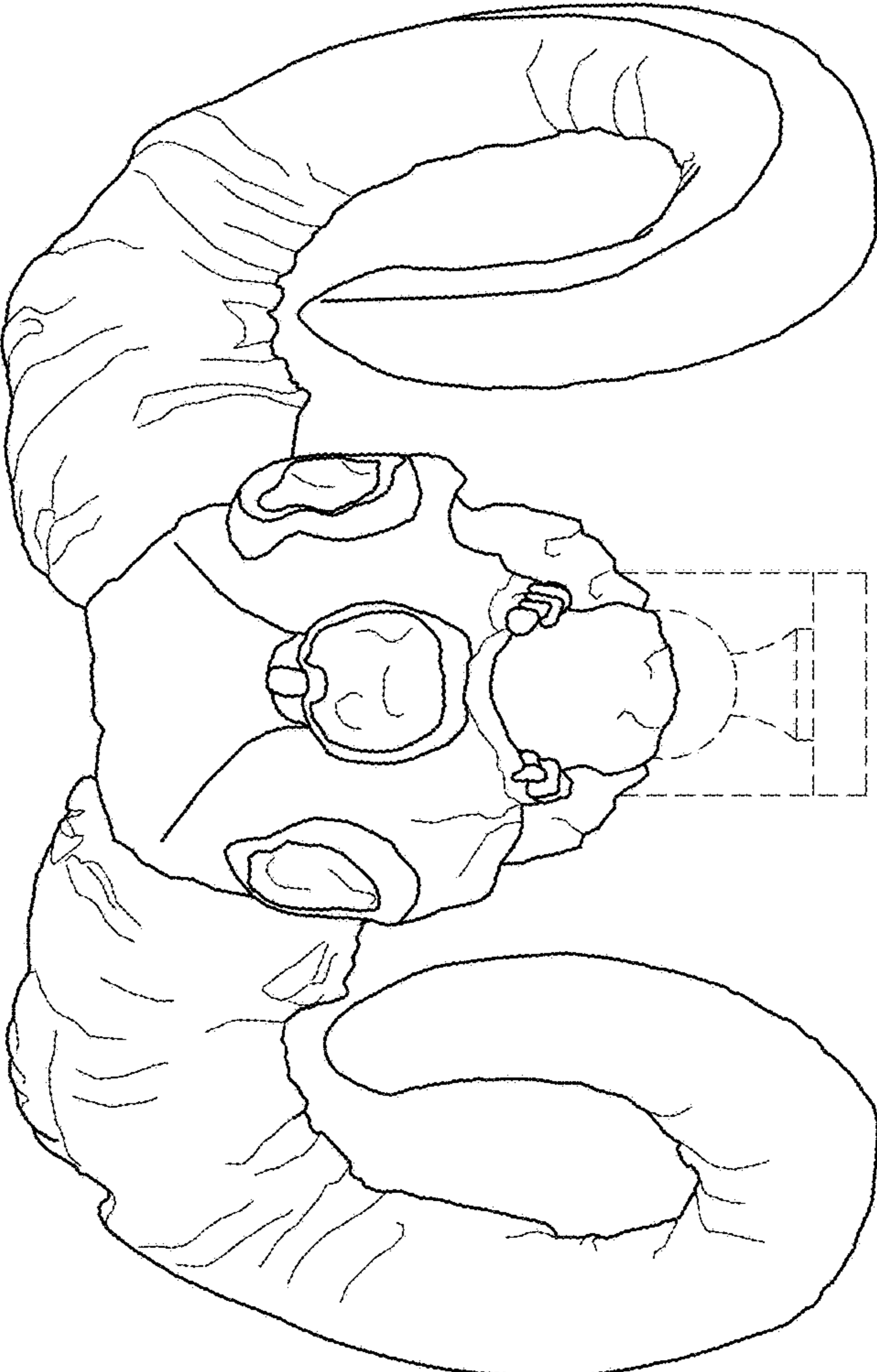

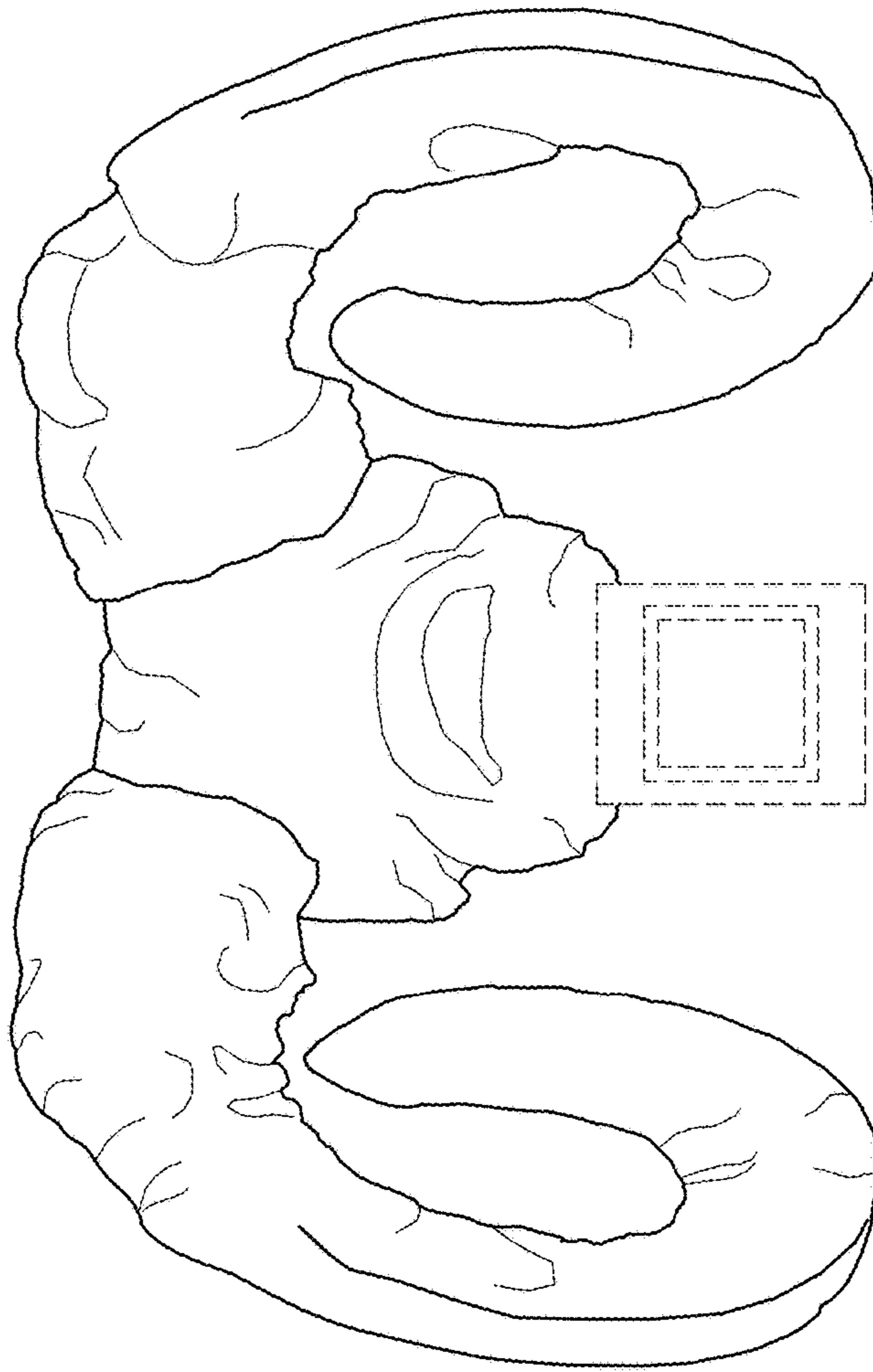

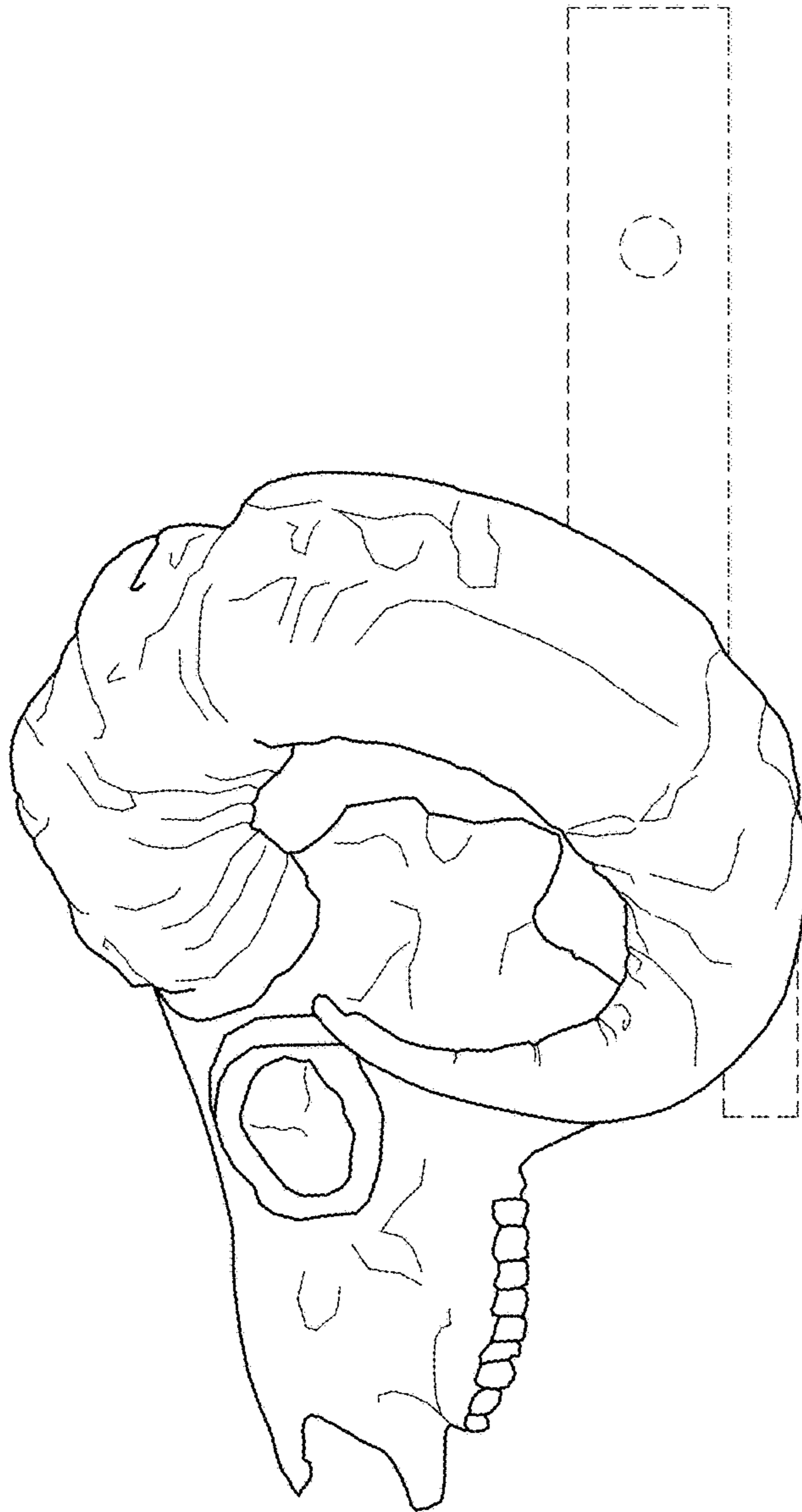

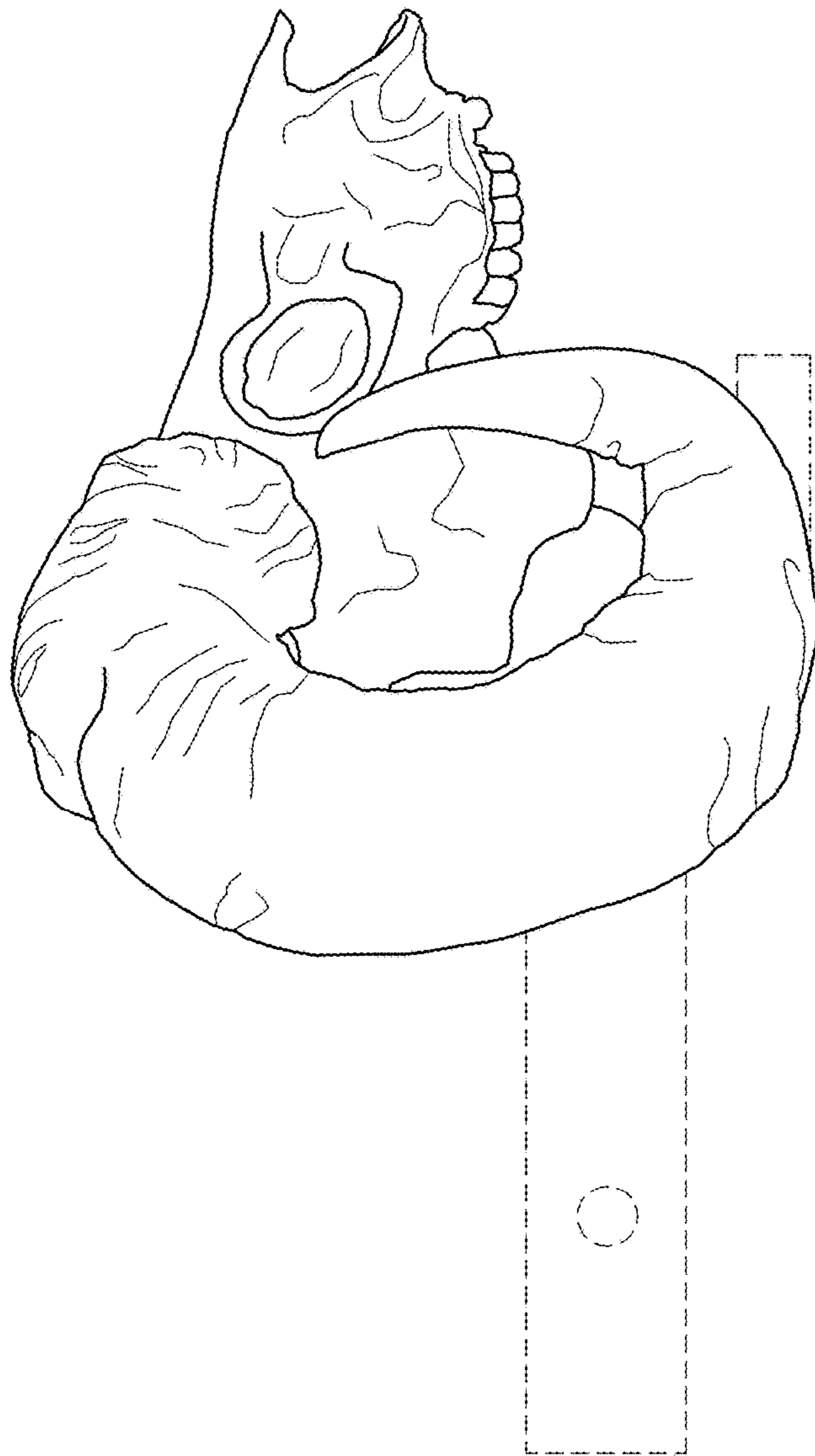

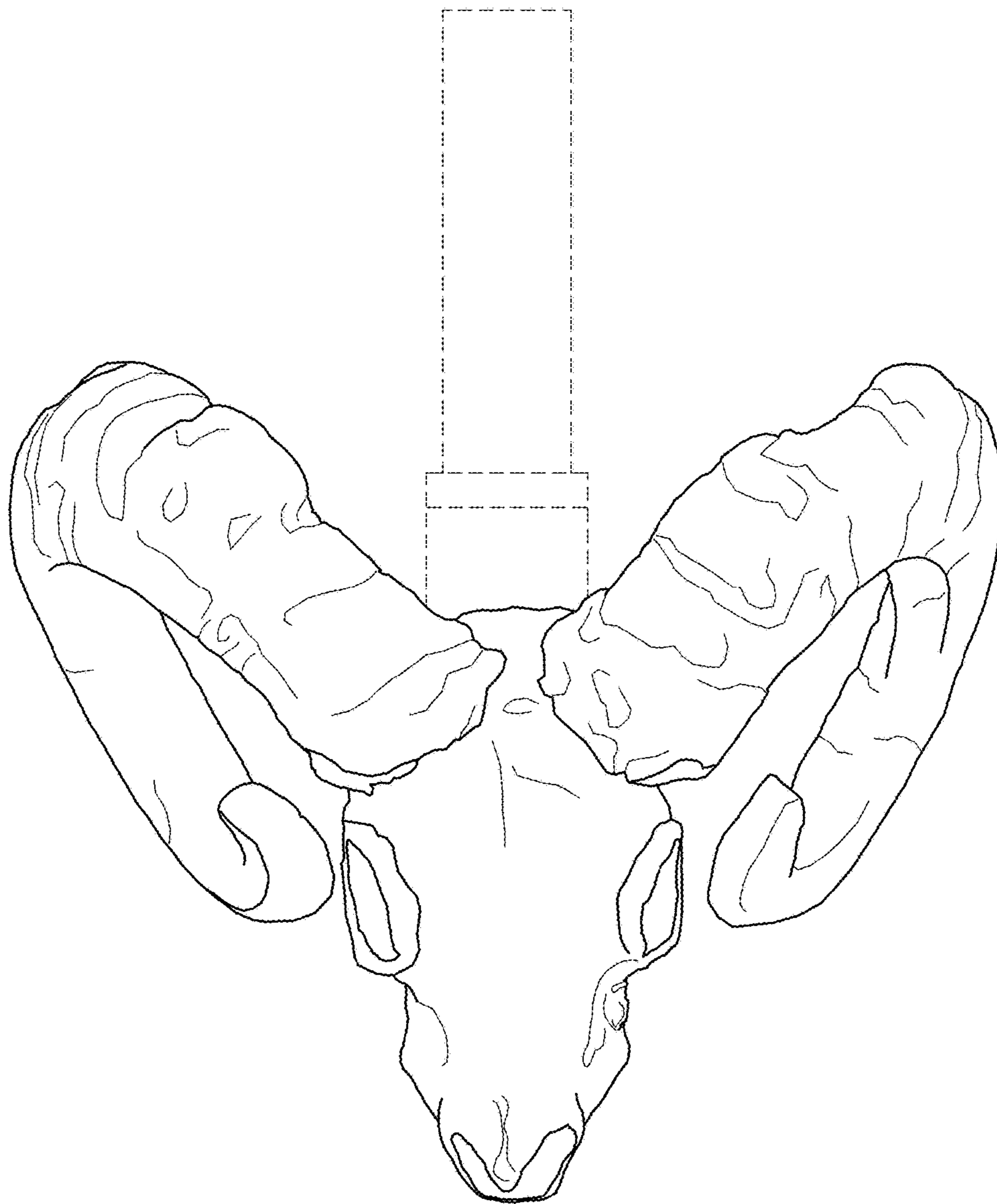
