The ornamental design for a vehicle wing mirror, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a front left elevated perspective view of a vehicle  
wing mirror according to the present invention.

FIG. 2 is a front left perspective view of the vehicle wing  
mirror shown in FIG. 1.

FIG. 3 is a rear right perspective view thereof.

FIG. 4 is a rear right elevated perspective view thereof.

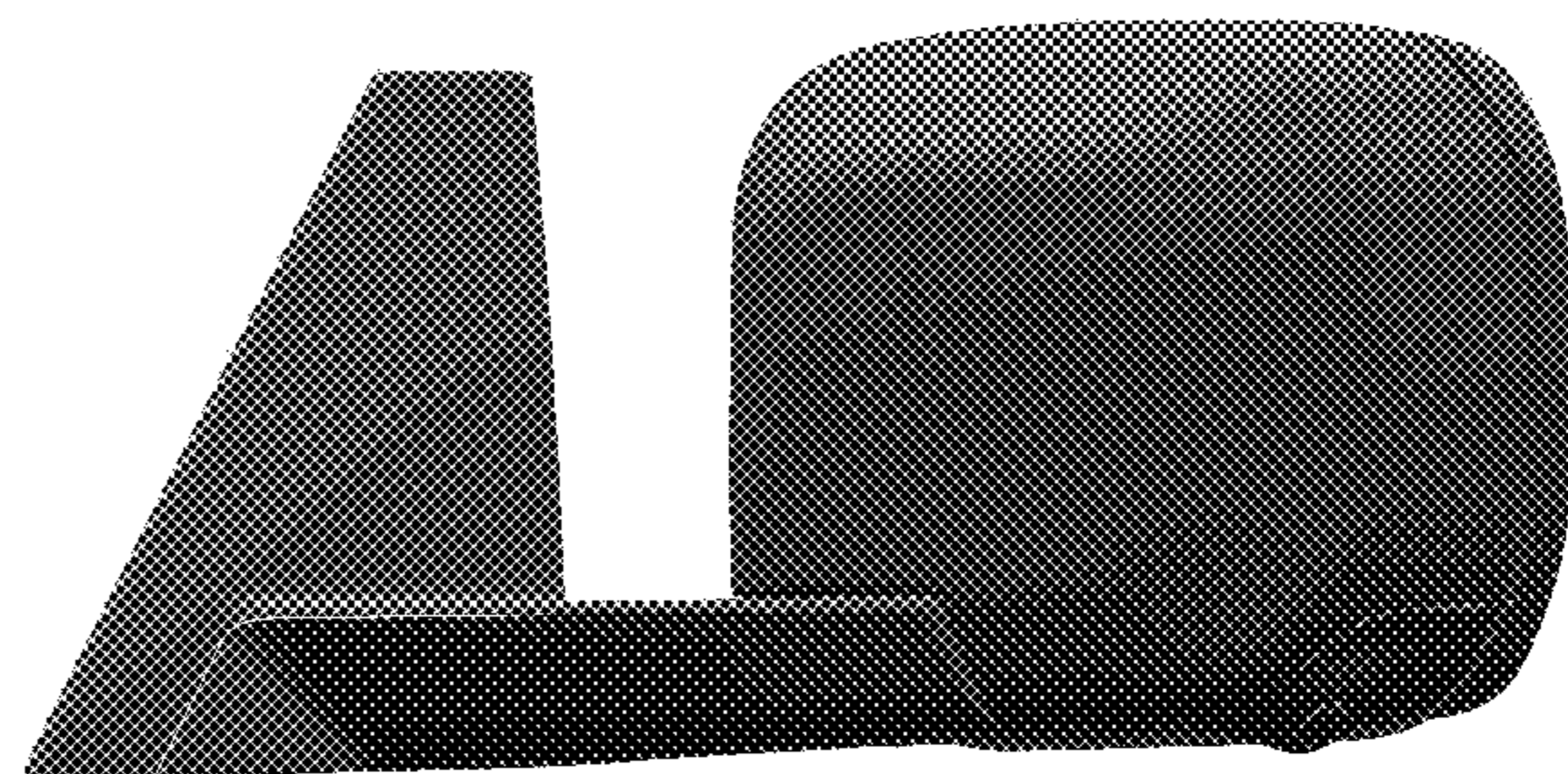
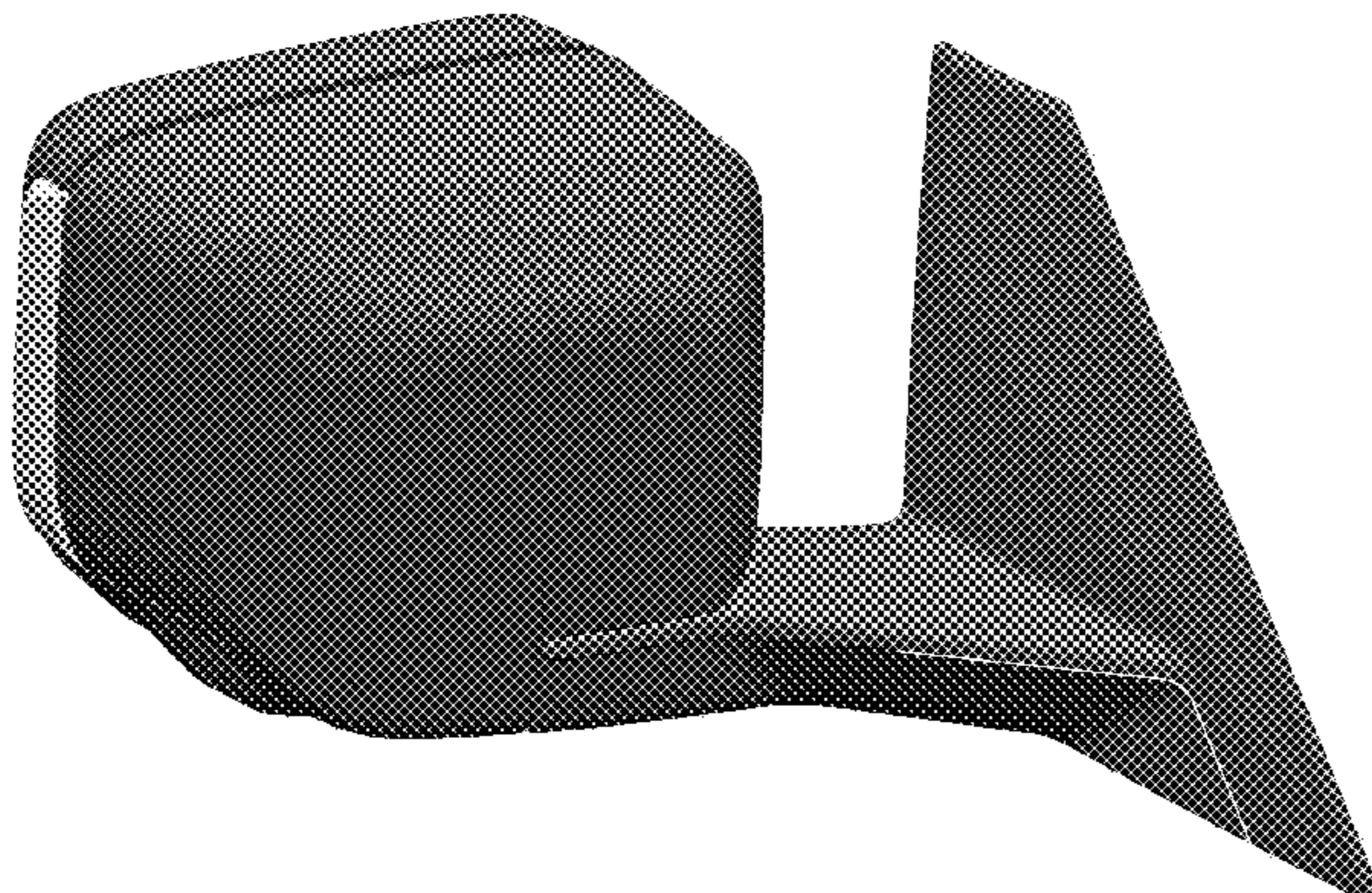

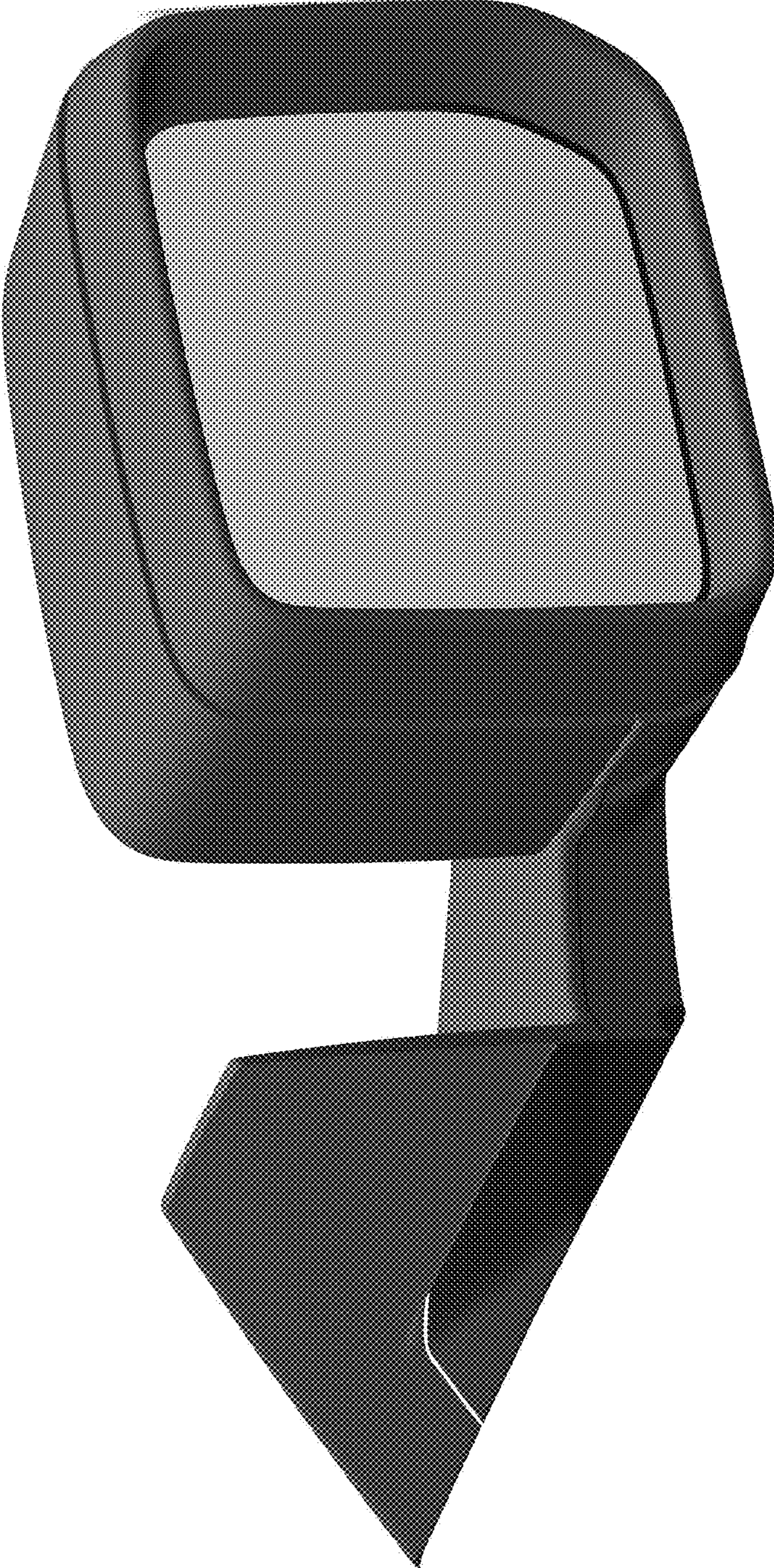

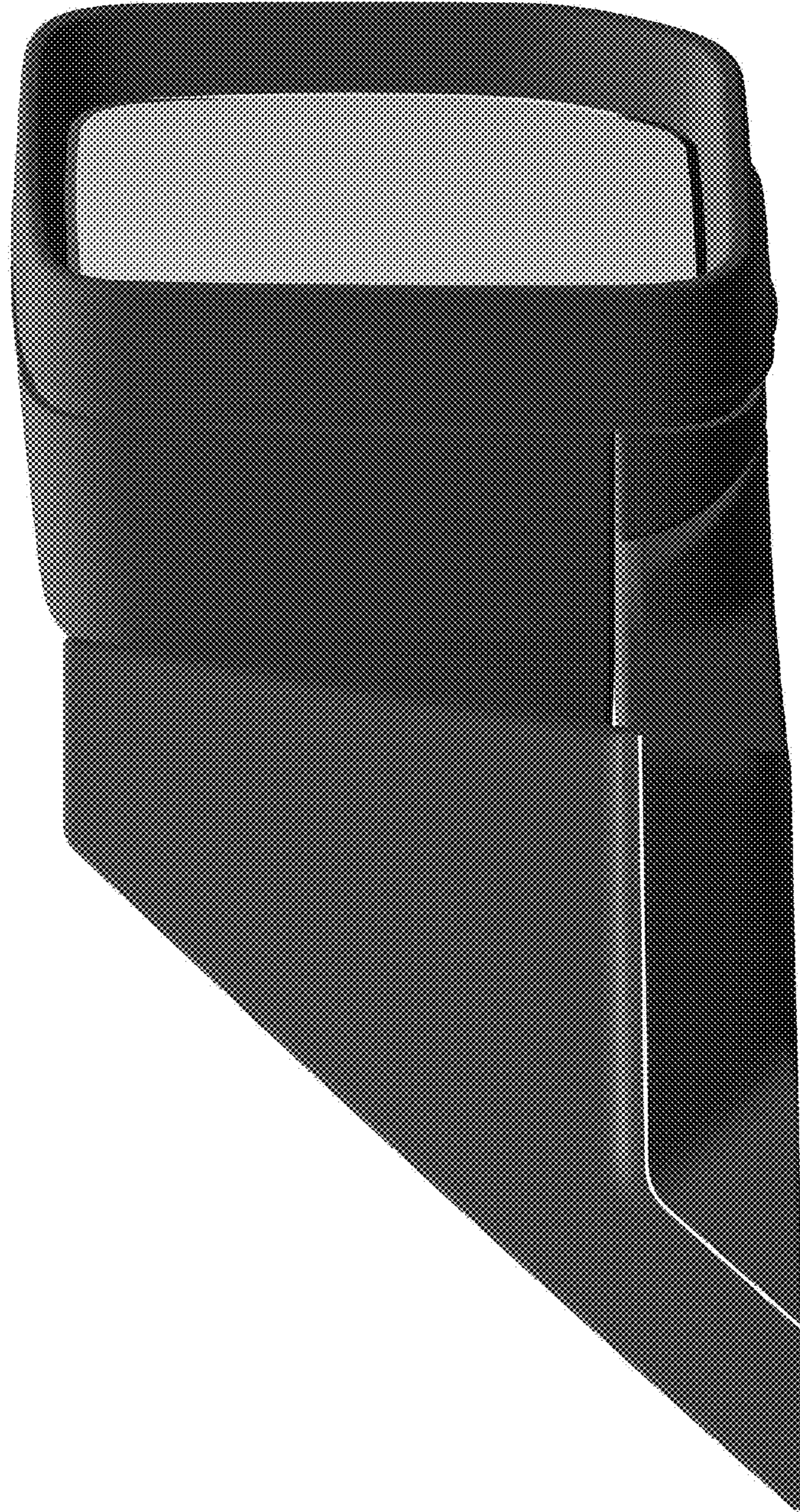

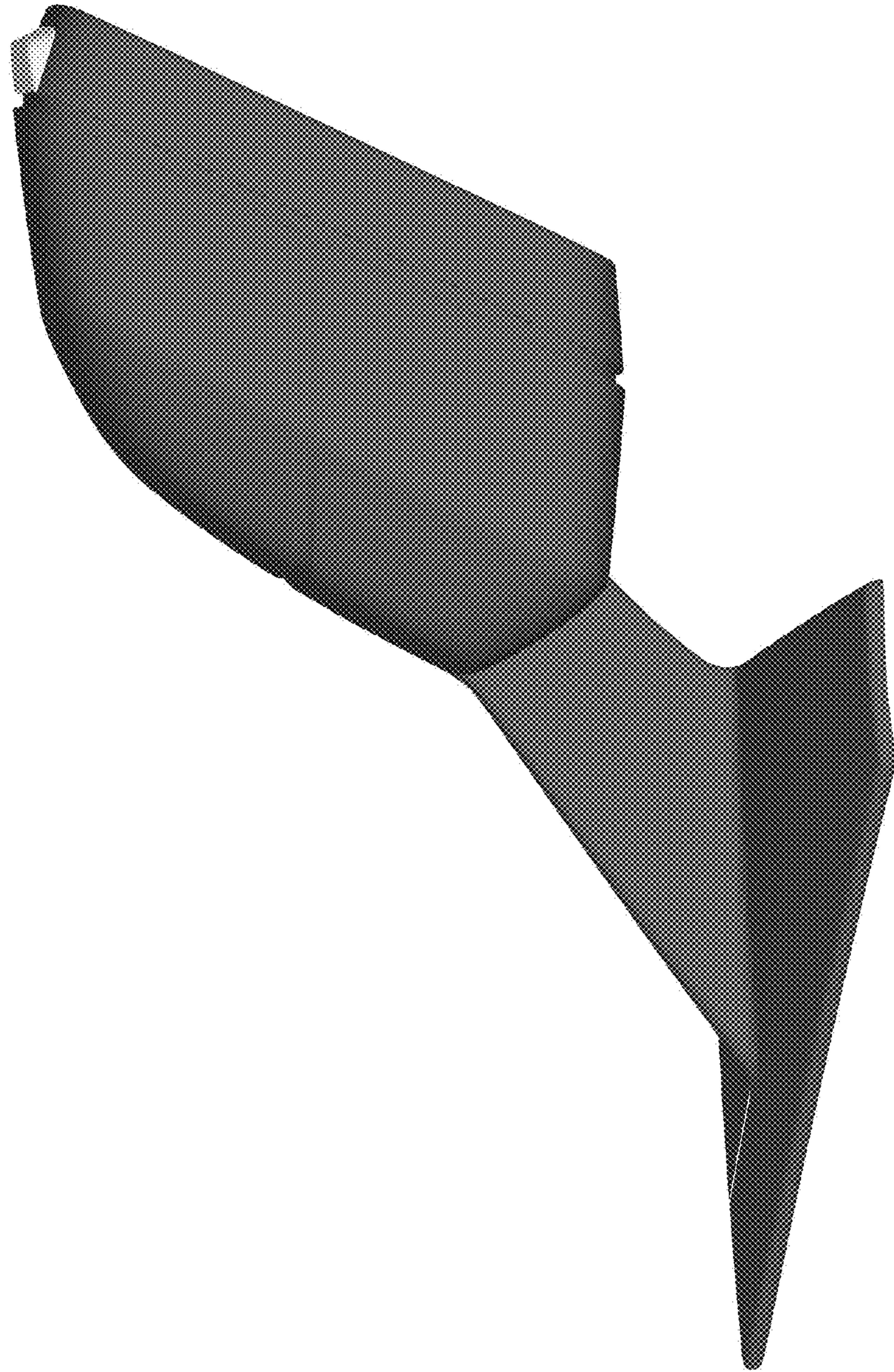

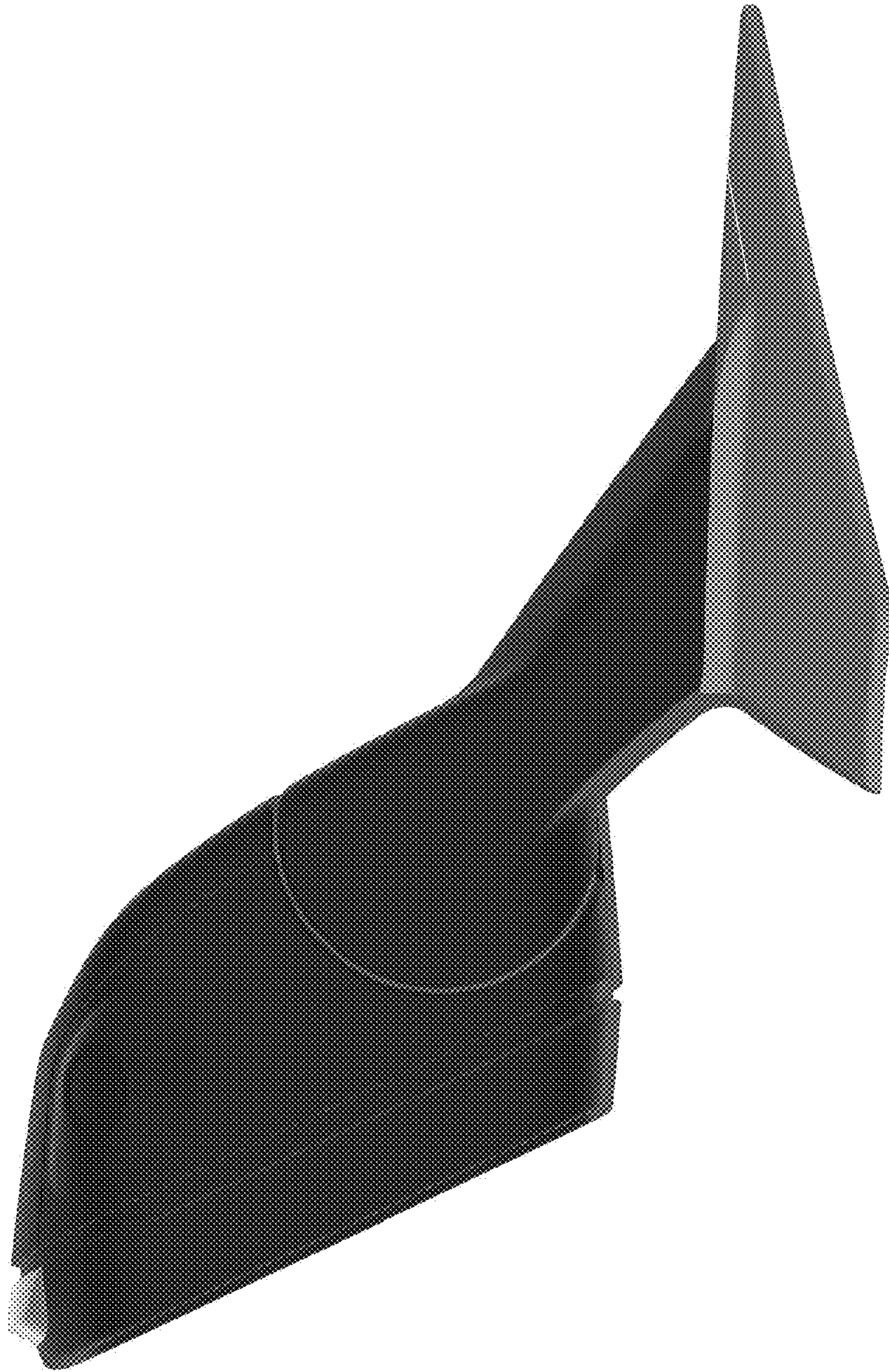

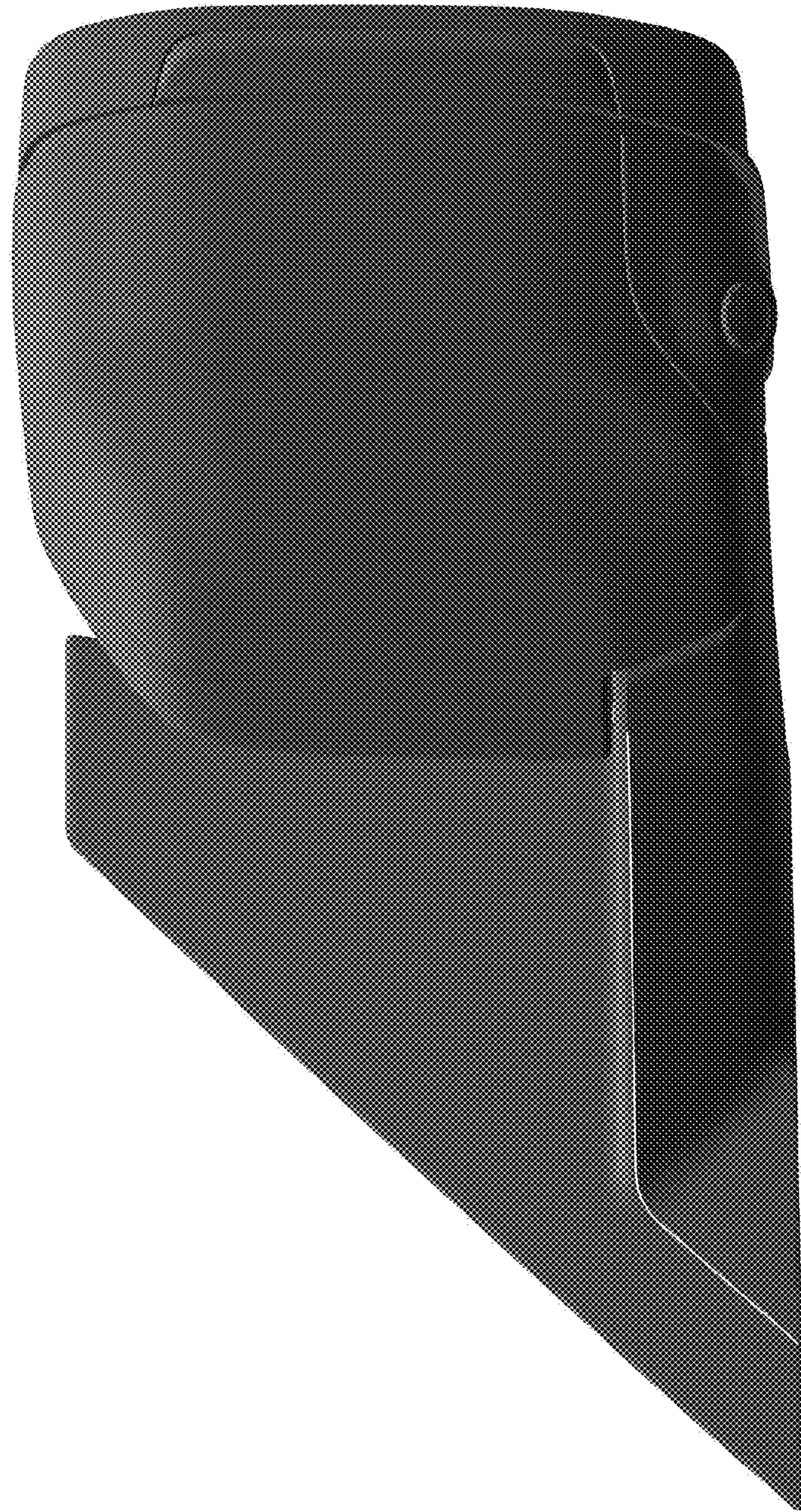

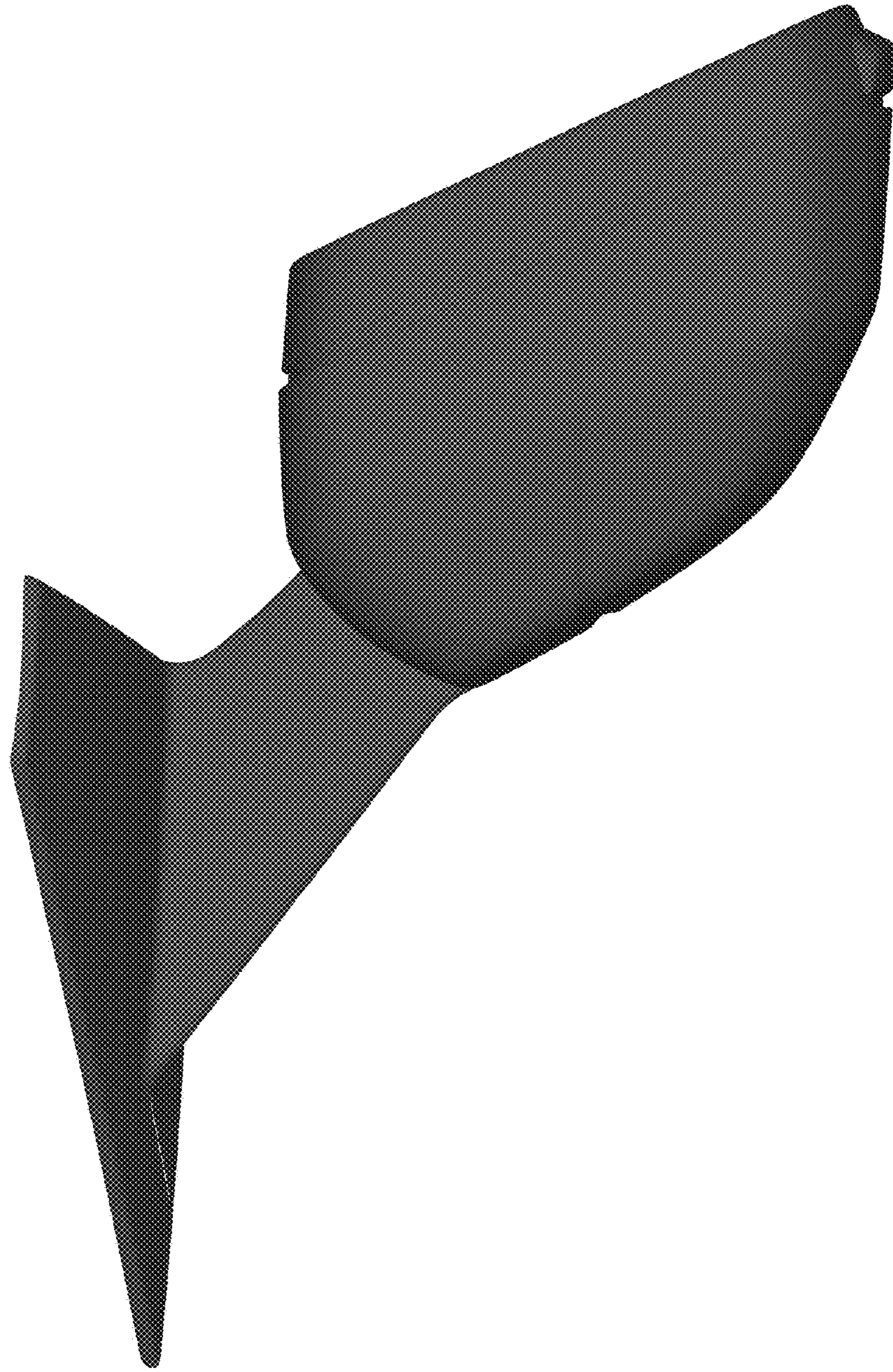
