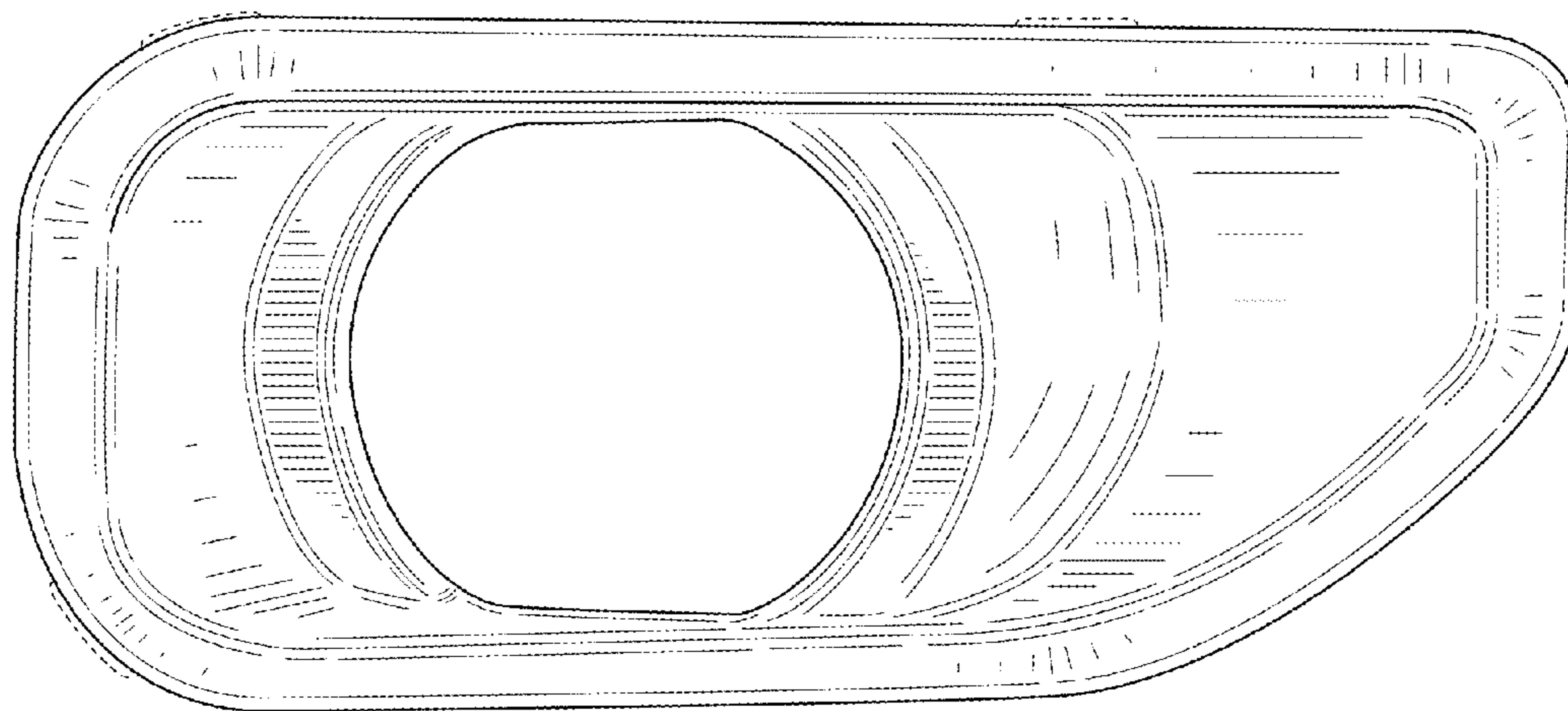
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a trim fog bezel insert showing our new design;

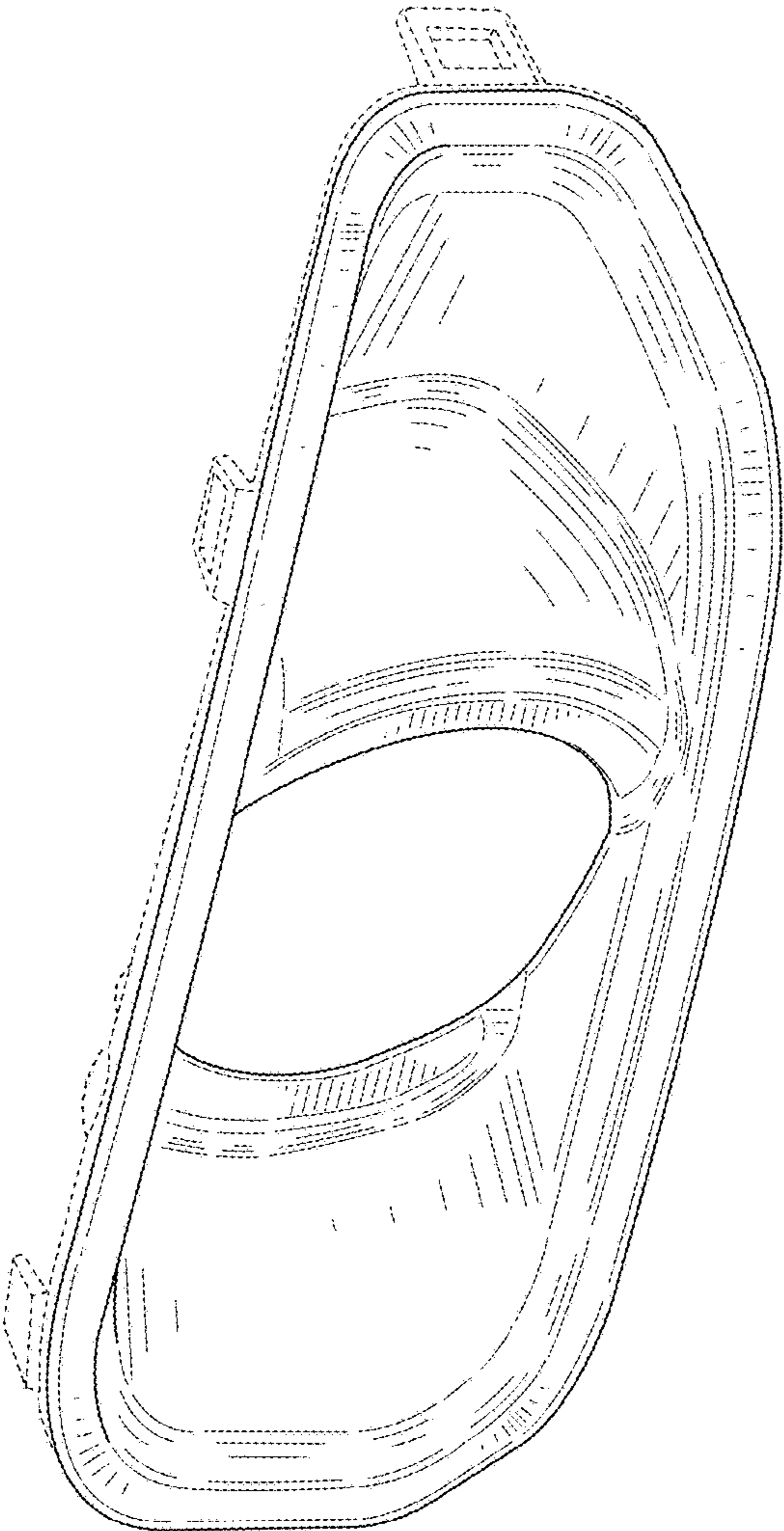

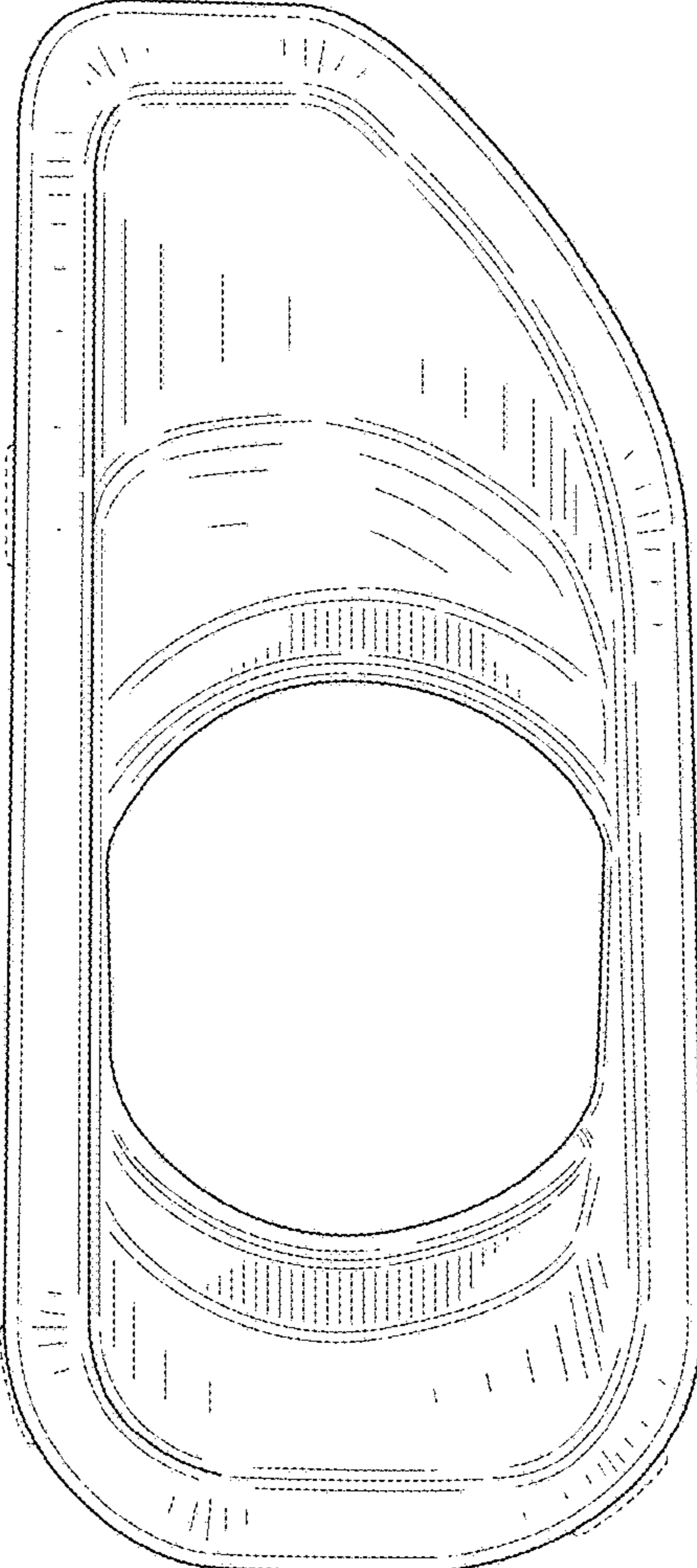

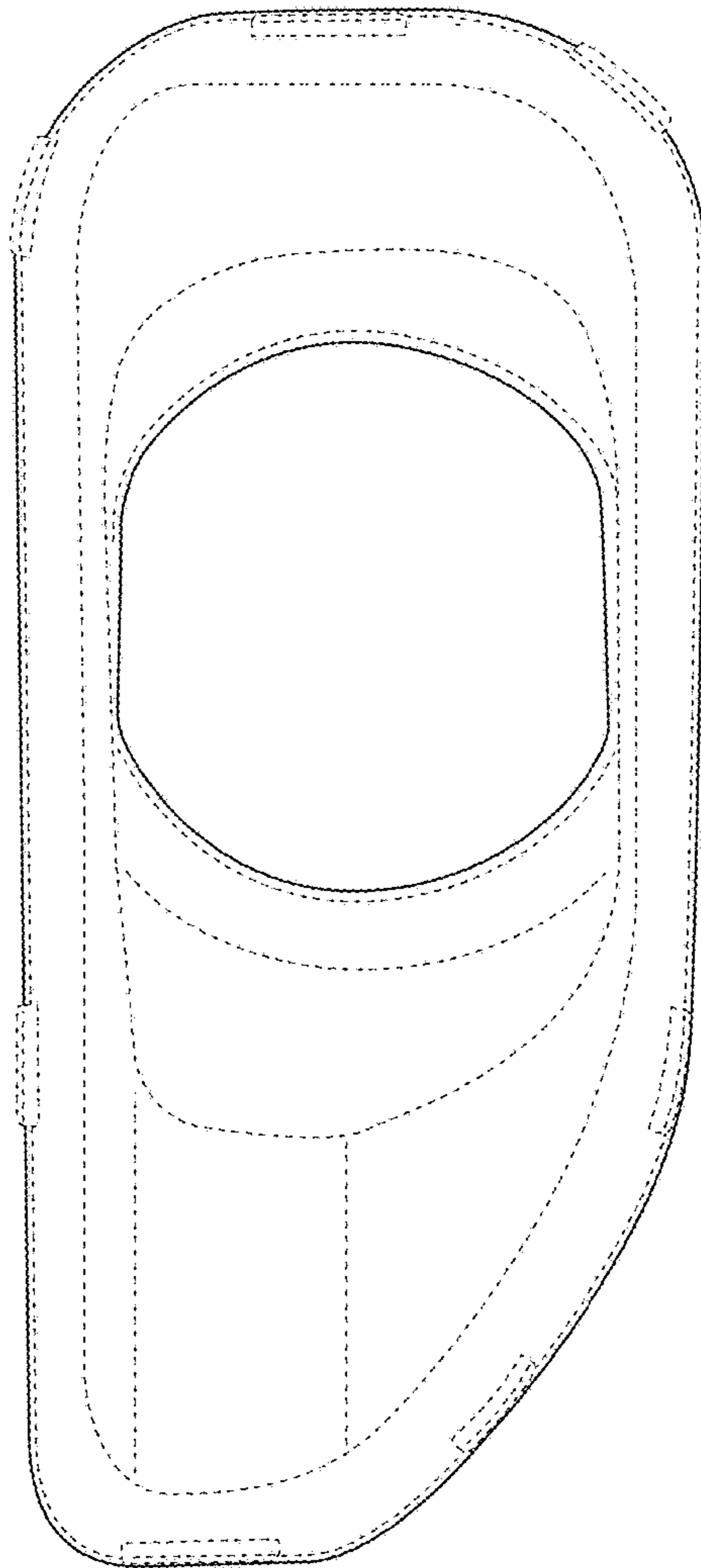

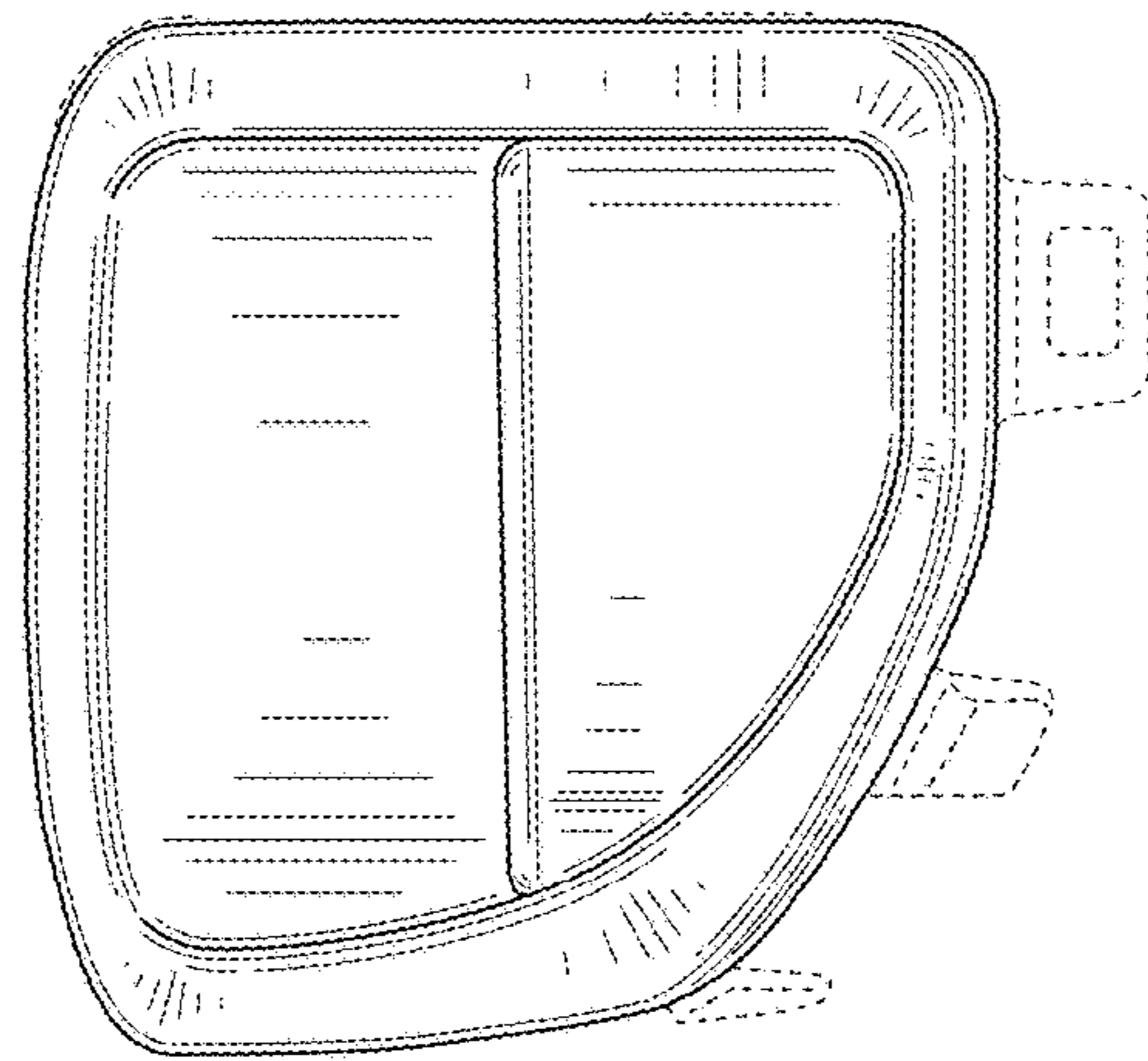

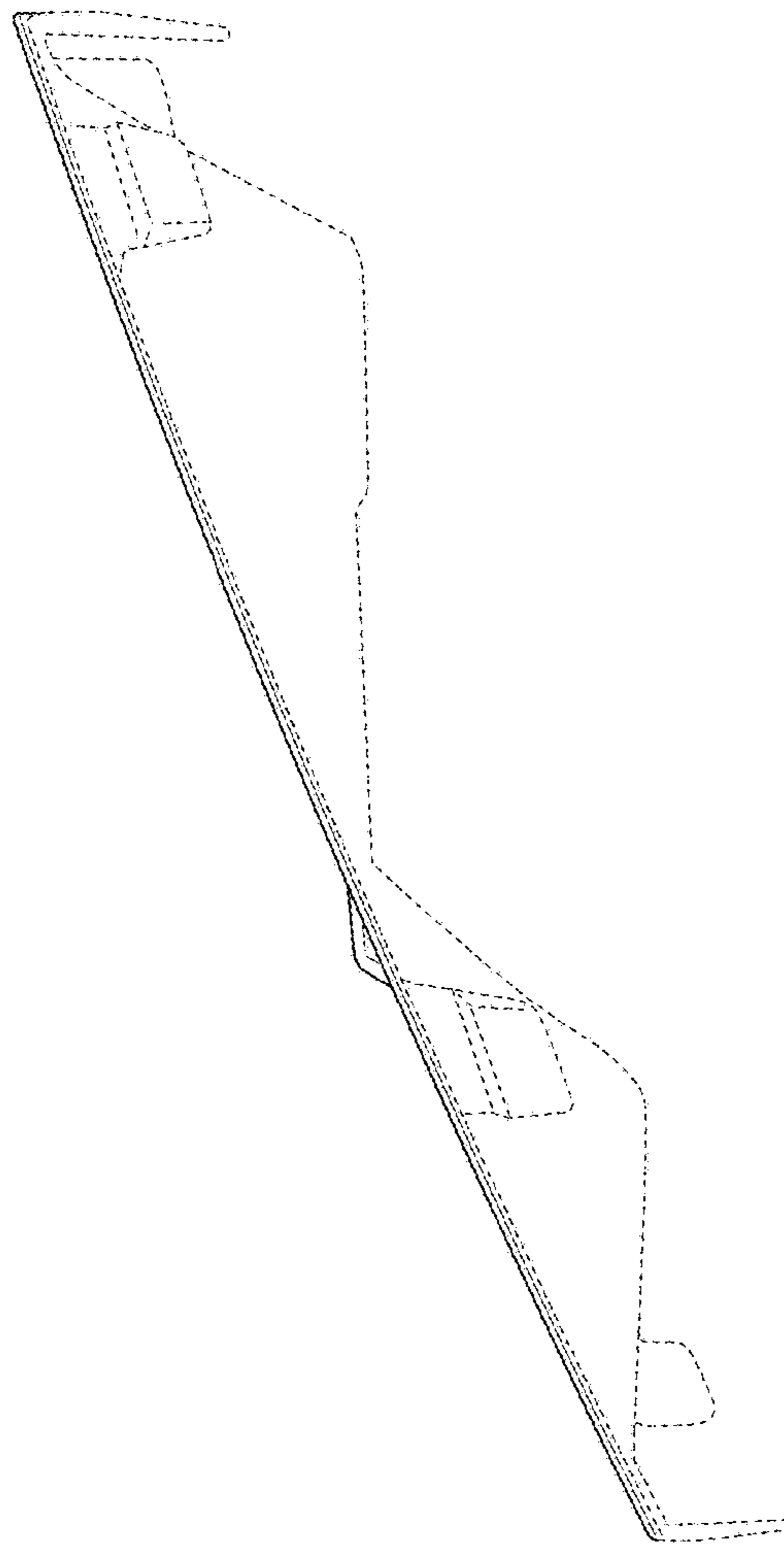

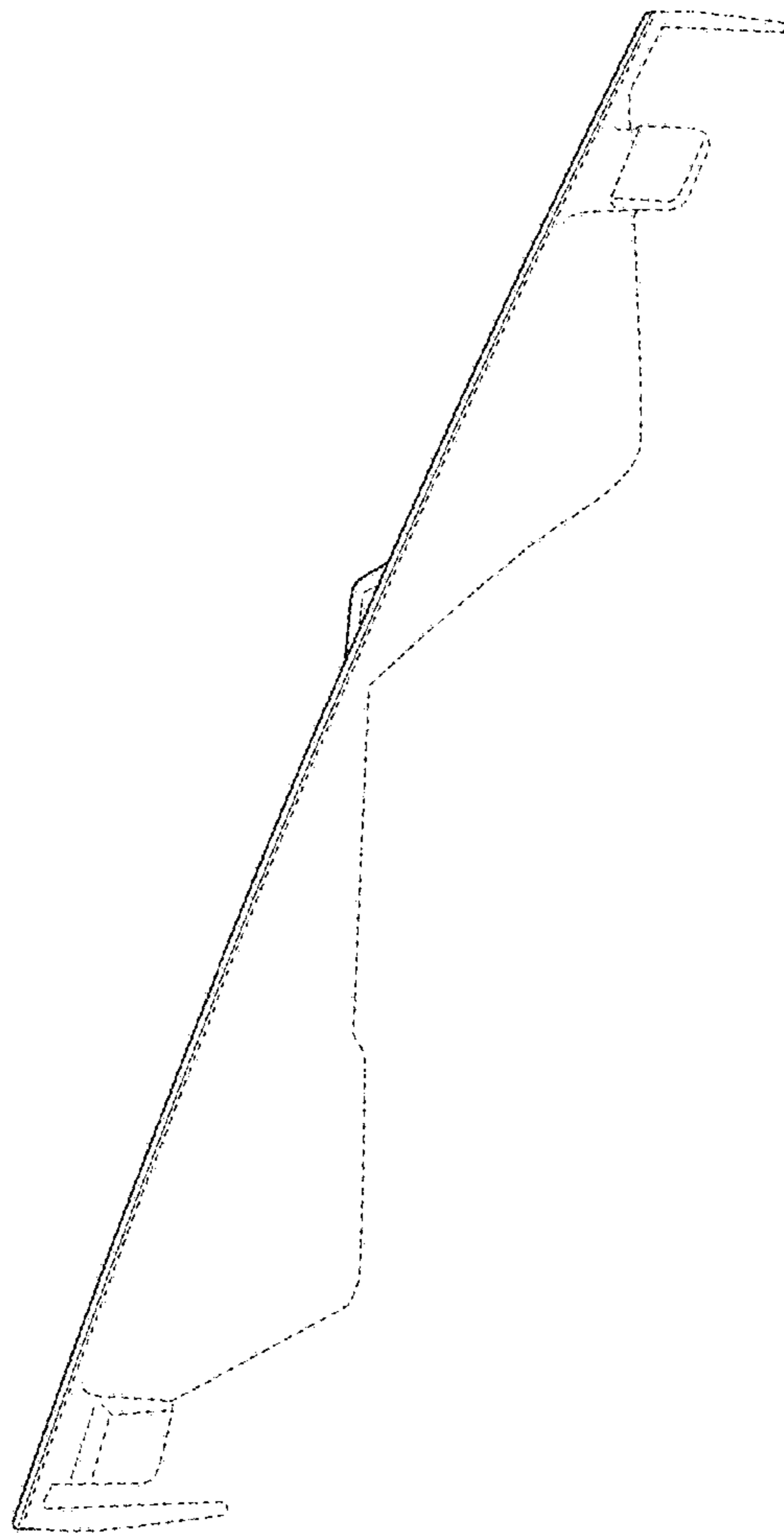
