(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a vehicle wheel according to our design;

FIG. 2 is a front view of the vehicle wheel;

FIG. 3 is a rear view of the vehicle wheel; and,

FIG. 4 is left side view of the vehicle wheel, with the right side view being a mirror image. The top and bottom views being the same as the side views.

The broken line showing of the aperture for a valve stem is shown for environmental purposes only; and the shape and location of the aperture for a valve stem forms no part of the claimed design.

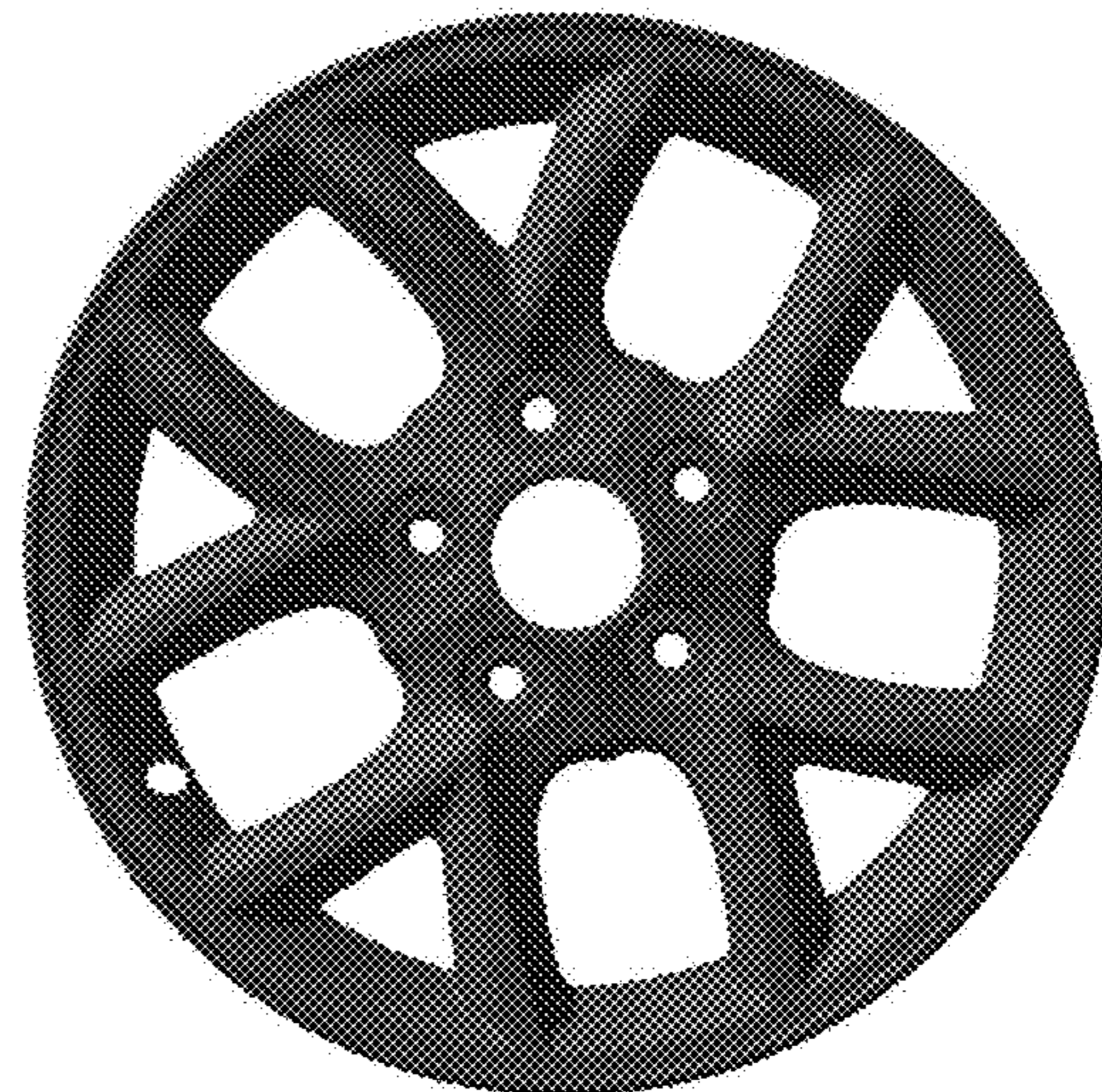

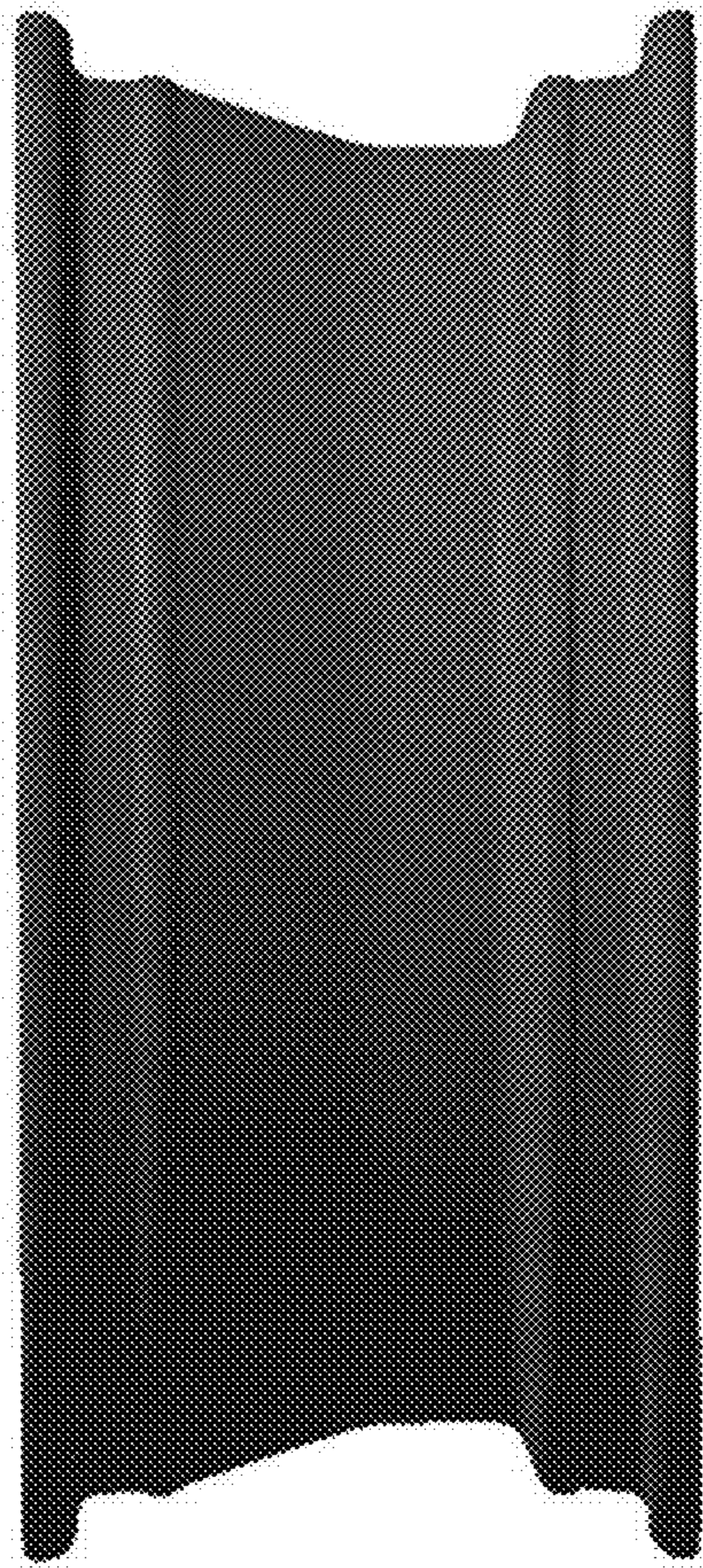
