FIG. 5 is a side elevation view thereof.

FIG. 6 is a side elevation view thereof, the side being the side opposite of the side shown in FIG. 5.

FIG. 7 is a top elevation view thereof; and,

FIG. 8 is bottom elevation view thereof, the side being the side opposite of the side shown in FIG. 7.

The broken lines, and adjacent unshaded regions, which depict a mobile communications device, represent environmental subject matter that forms no part of the claimed design. The broken line features on the back surface of the article represent portions of the pocket case for mobile communications devices with carrying compartment for credit card sized items that form no part of the claimed design.

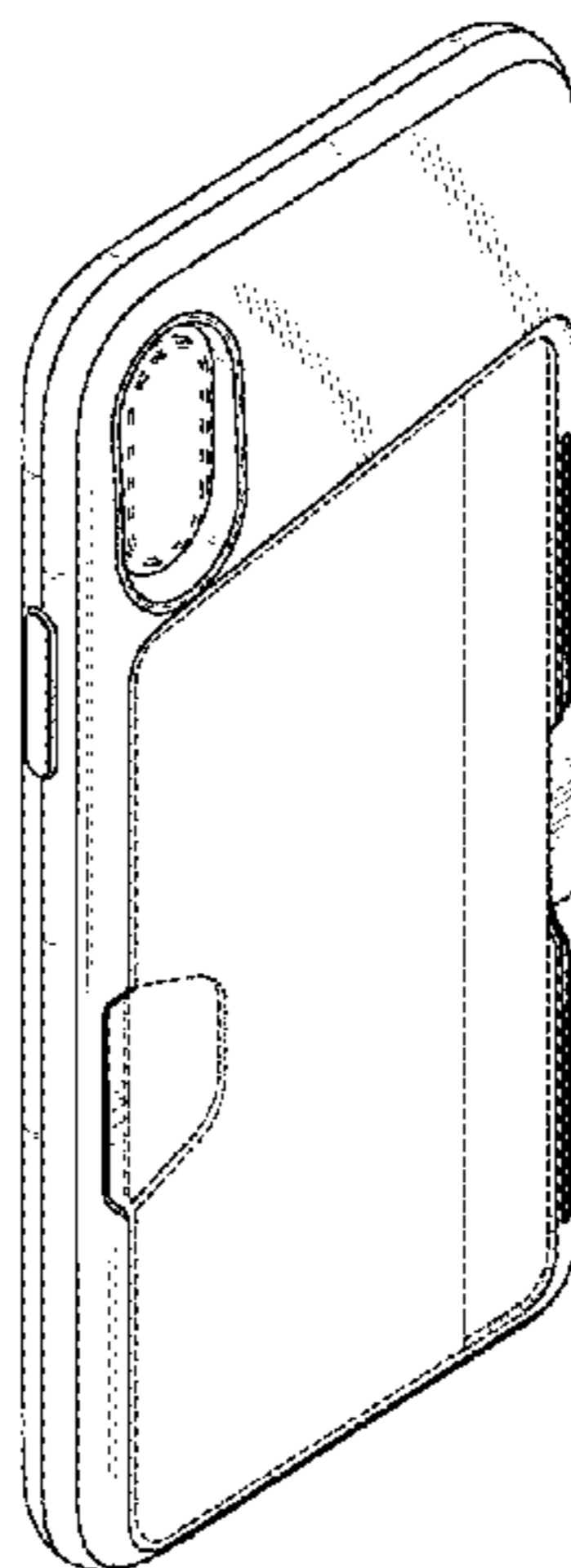

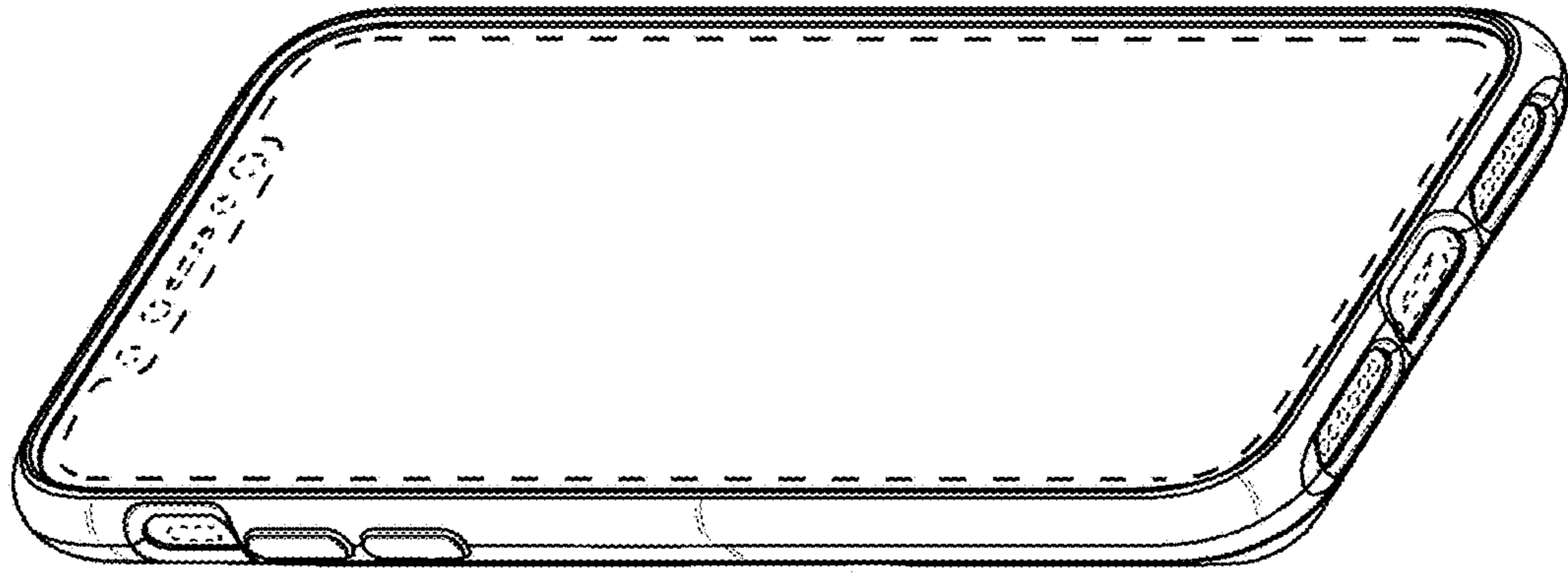

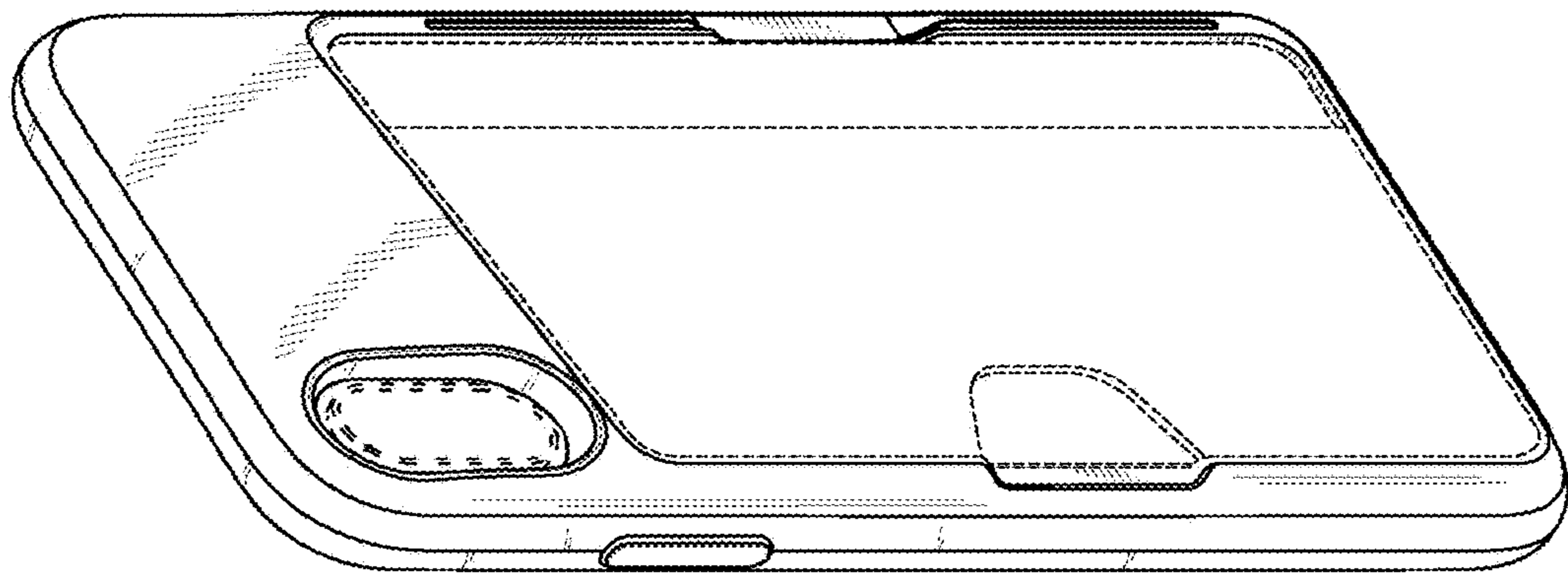

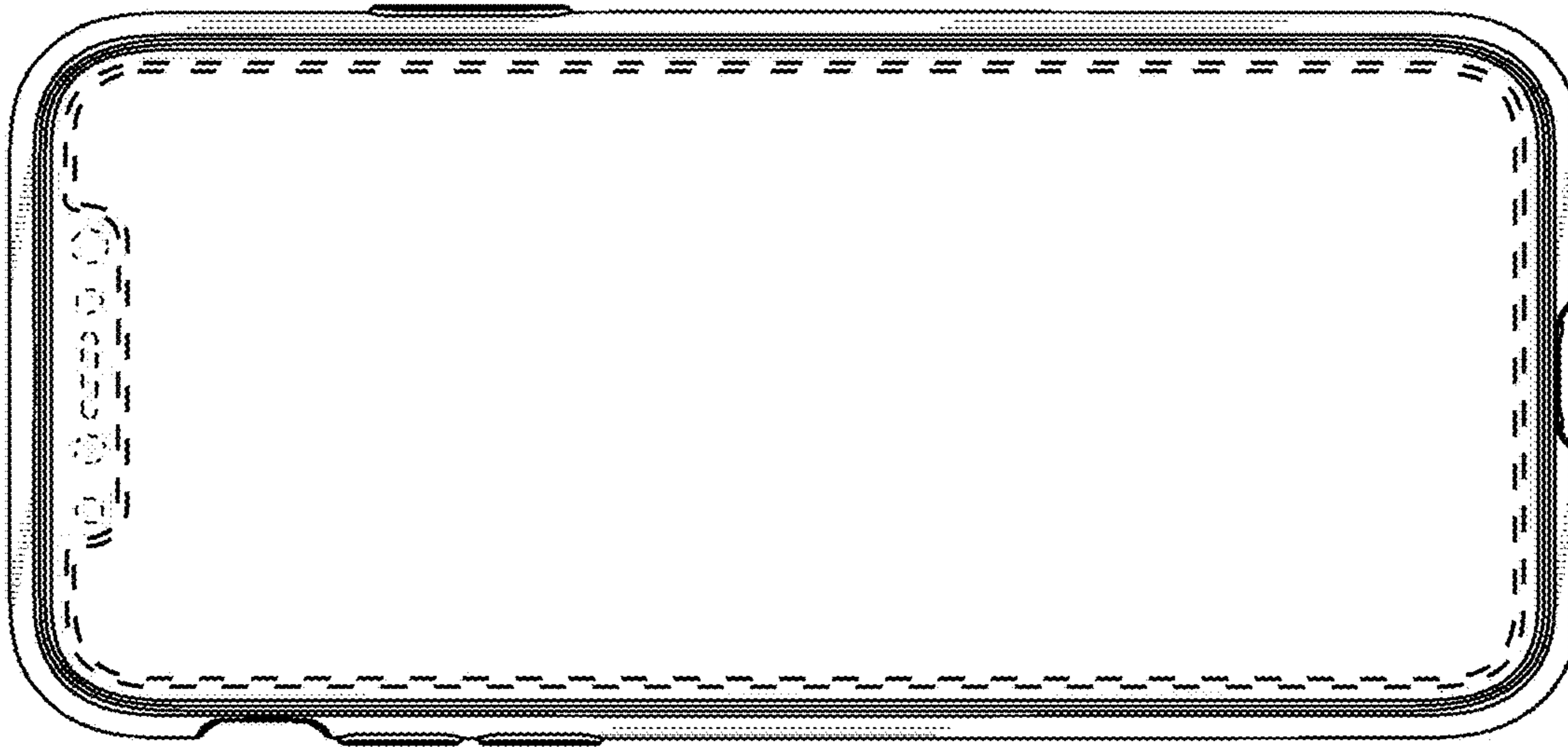

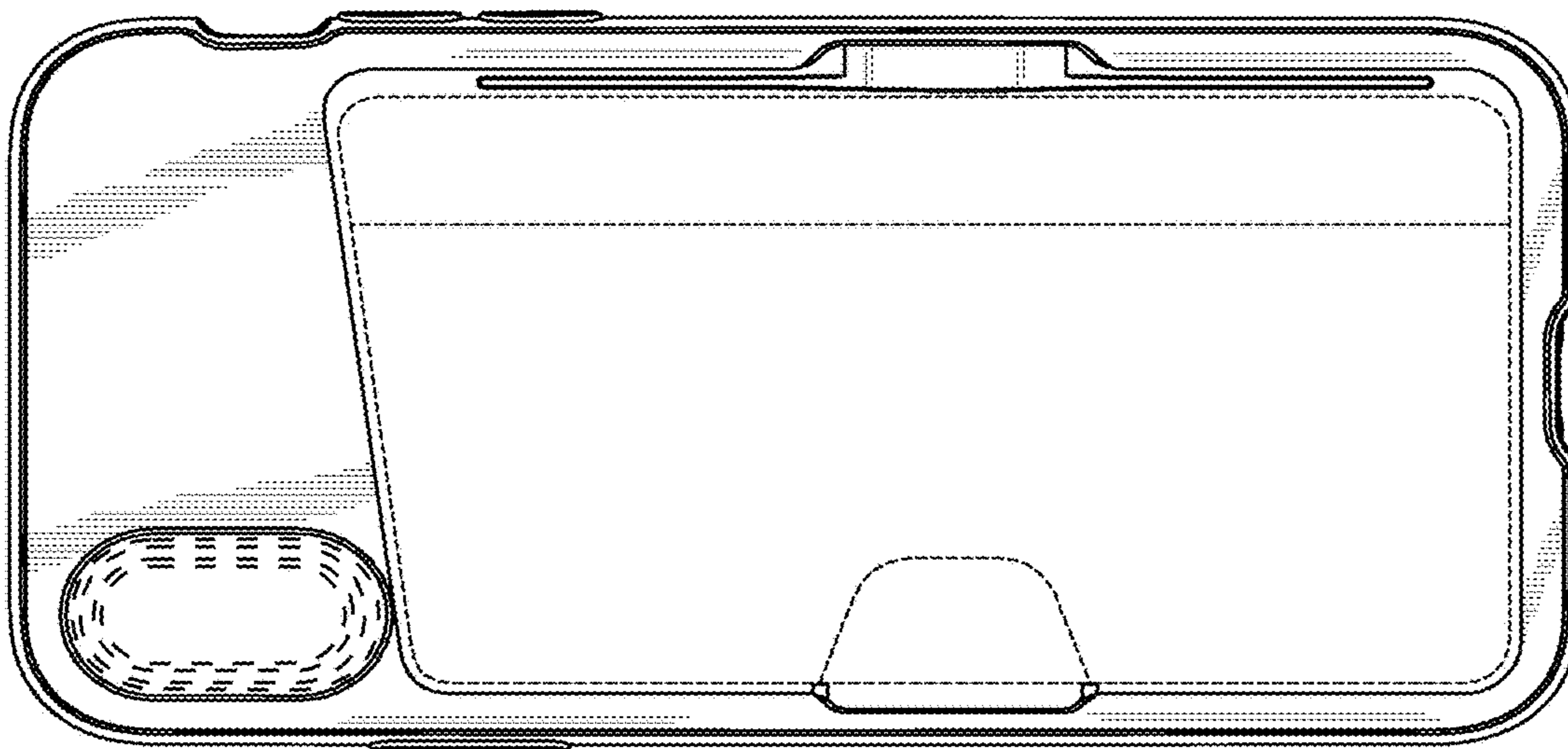

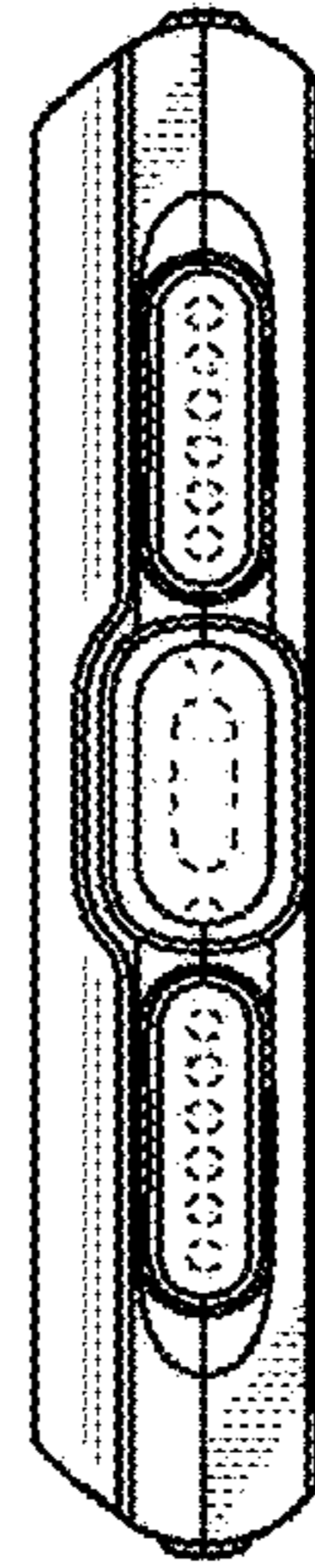
