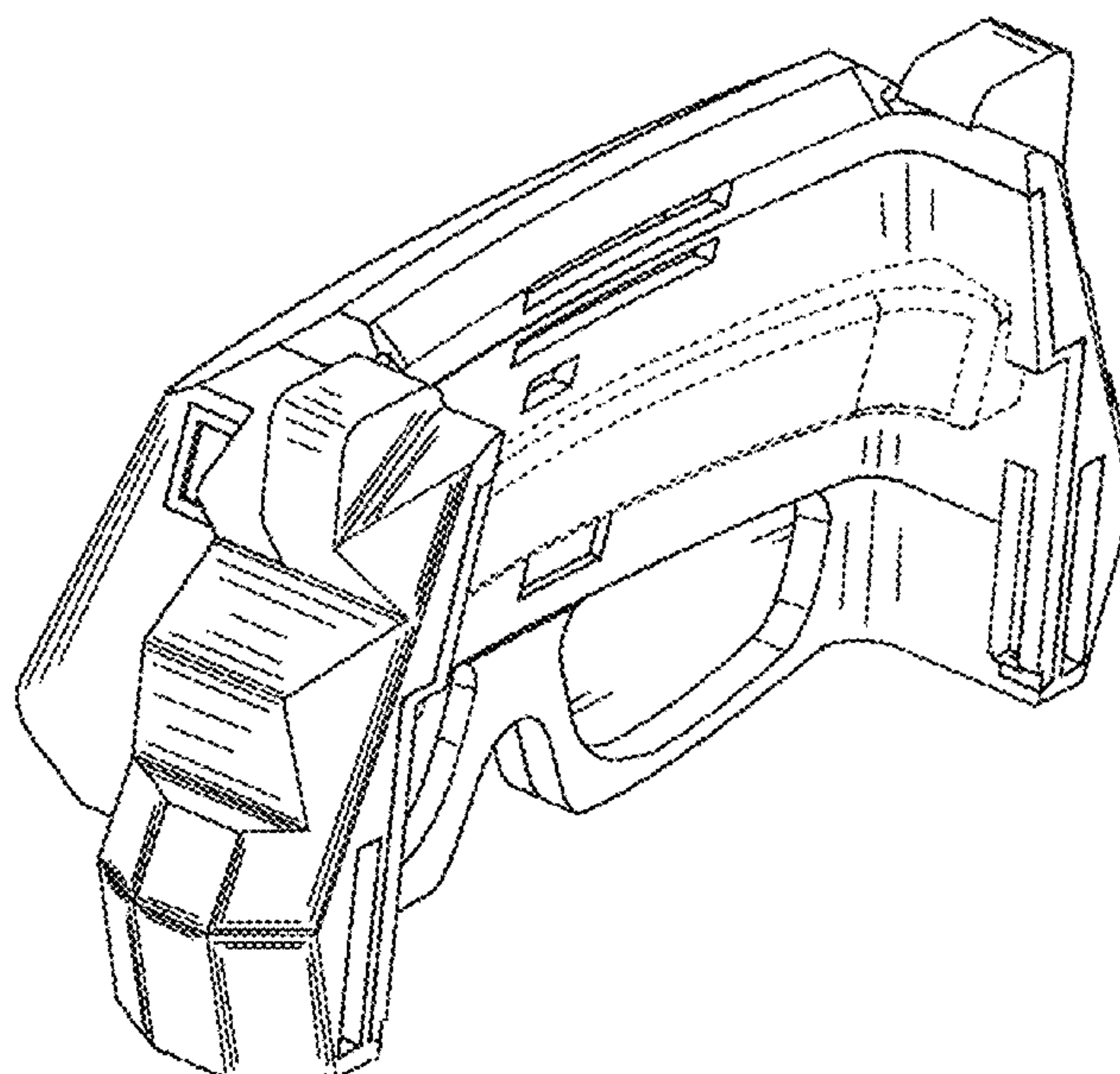
(57) **CLAIM**

The ornamental design for a head-mounted display device, as shown and described.

DESCRIPTION

FIG. 1 is a top, right-side perspective view of a head-mounted display device showing our new design; FIG. 2 is a top, left side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right-side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is bottom plan view thereof; and, FIG. 9 is top, rear perspective view thereof. The broken lines in the drawings represent portions of the head-mounted display device that form no part of the claimed design.

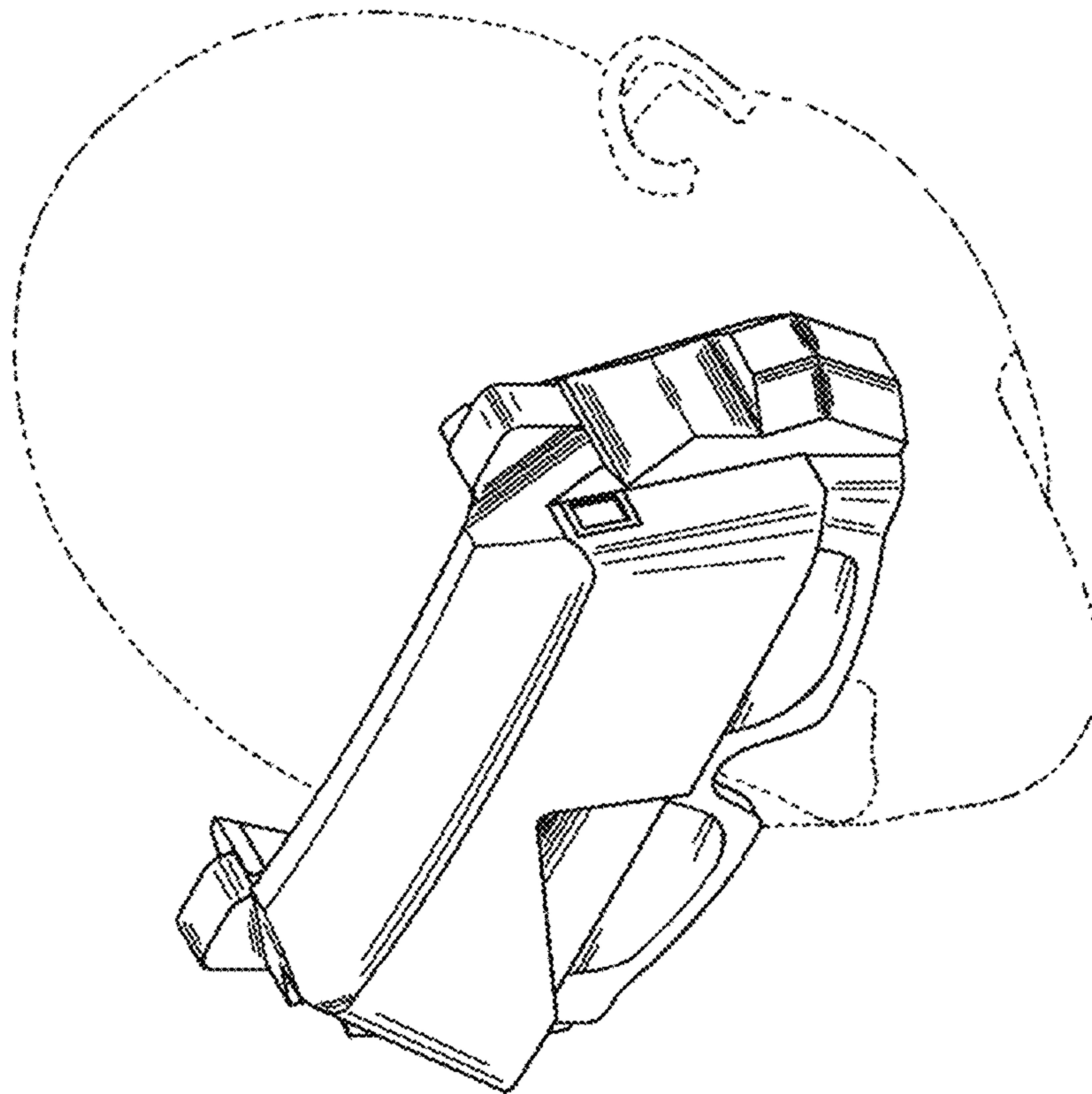

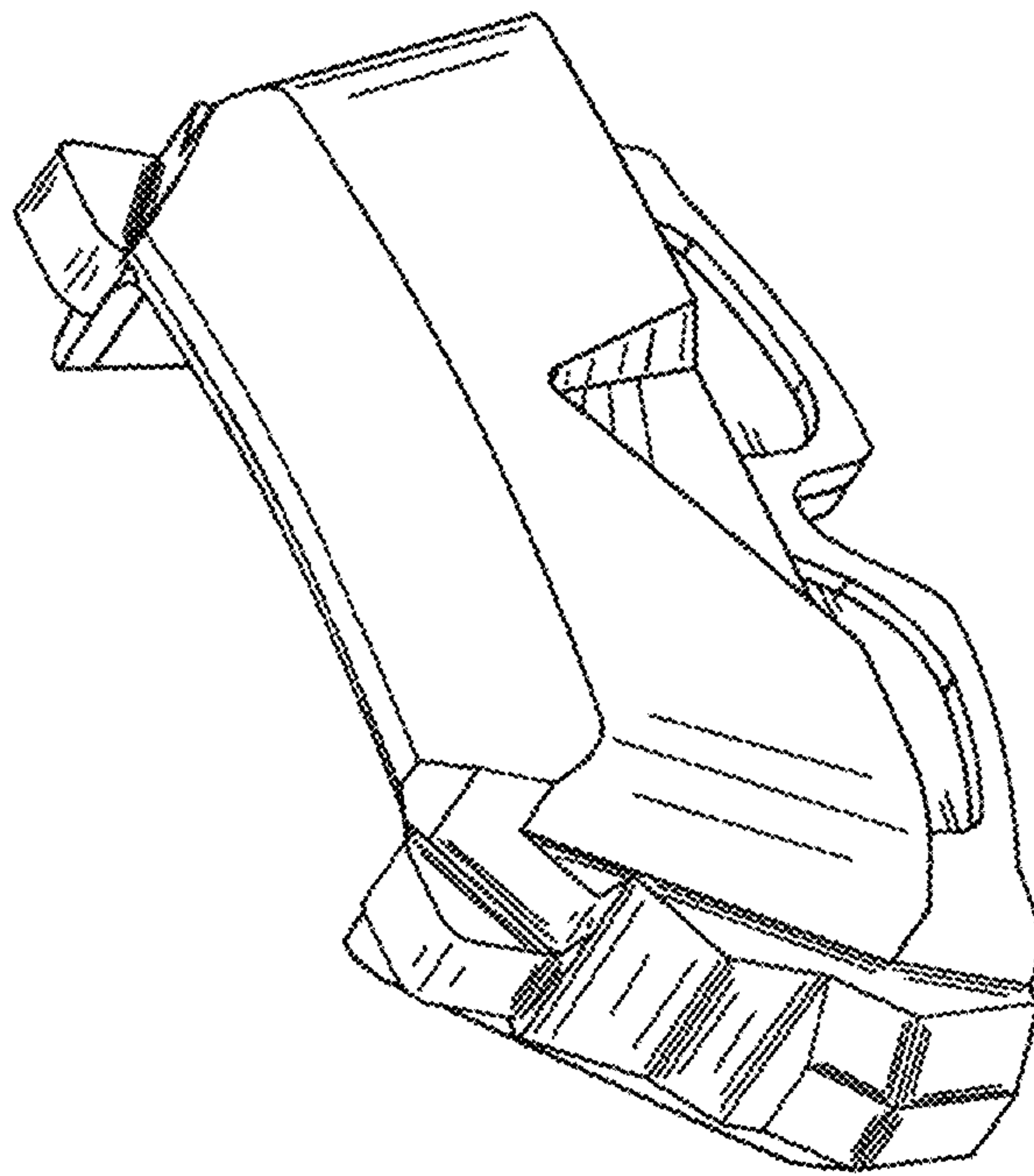

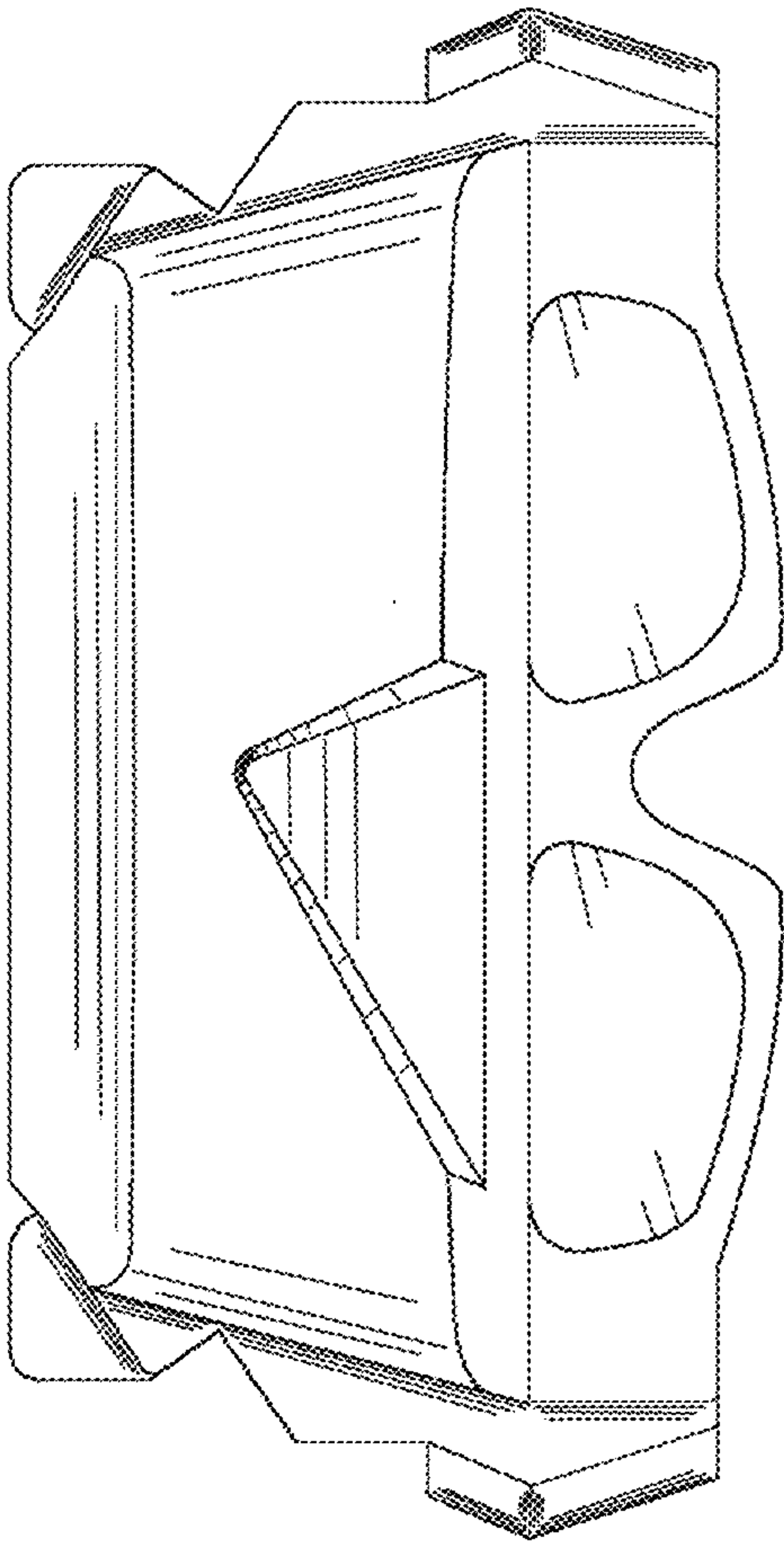

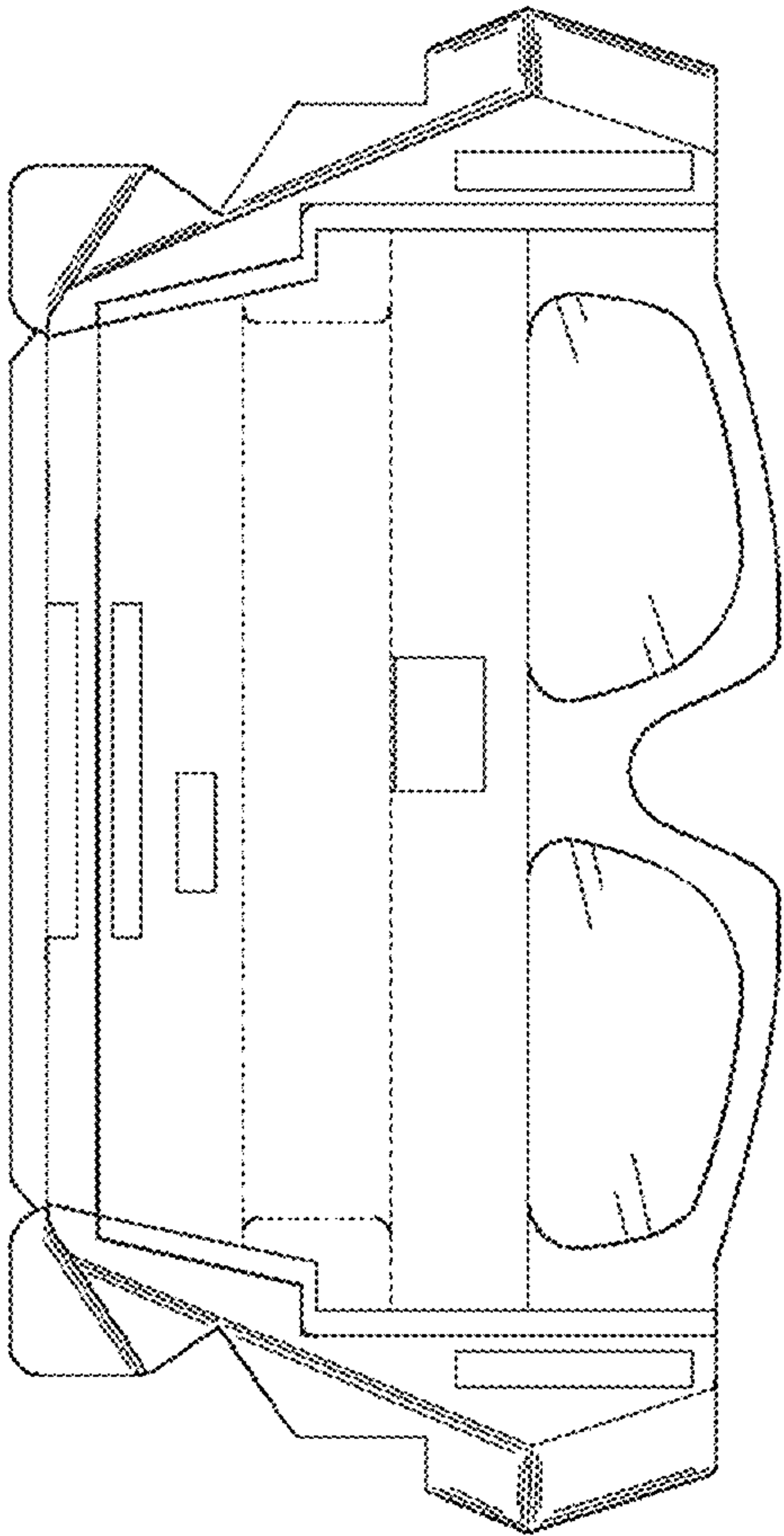

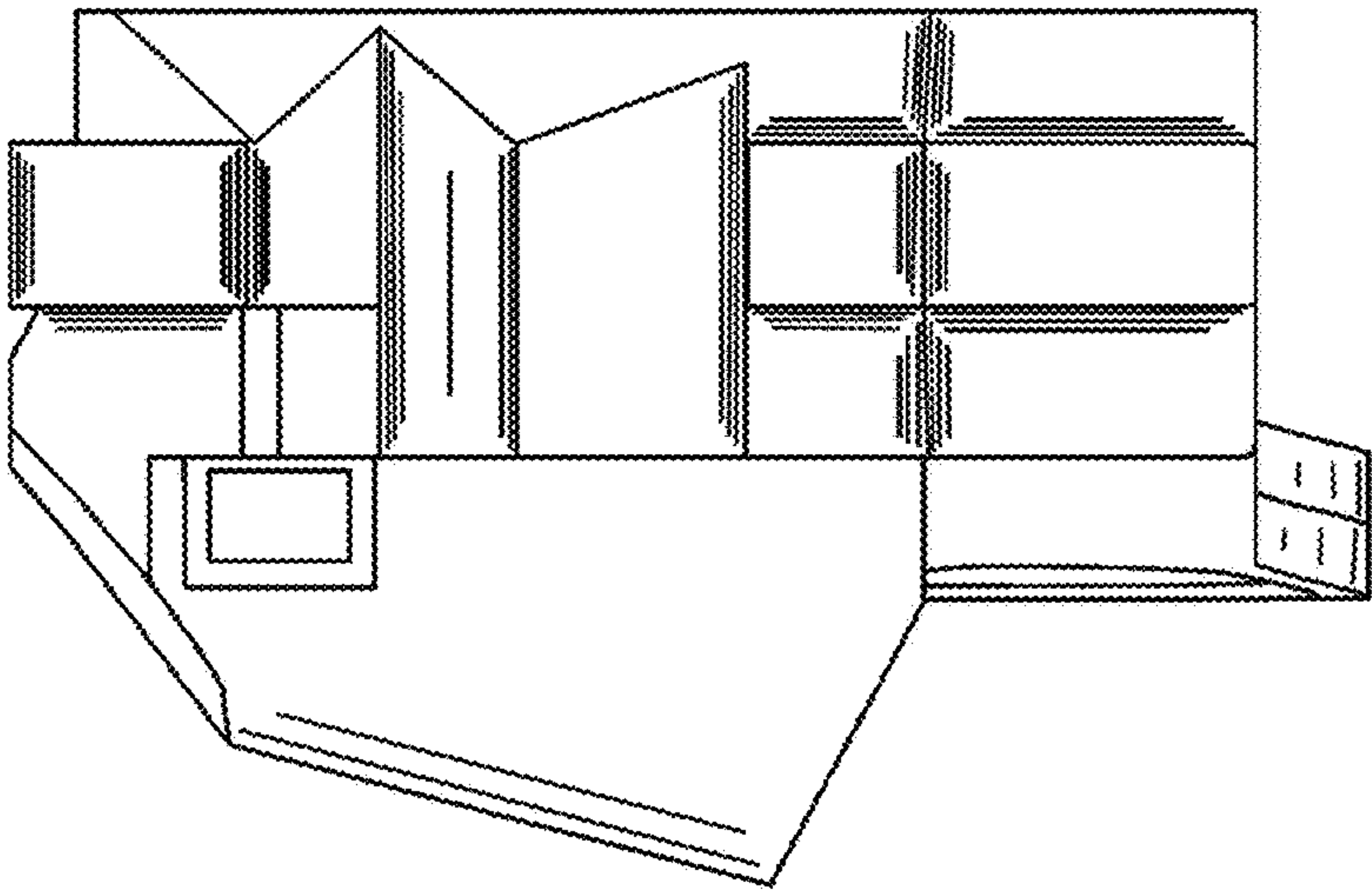

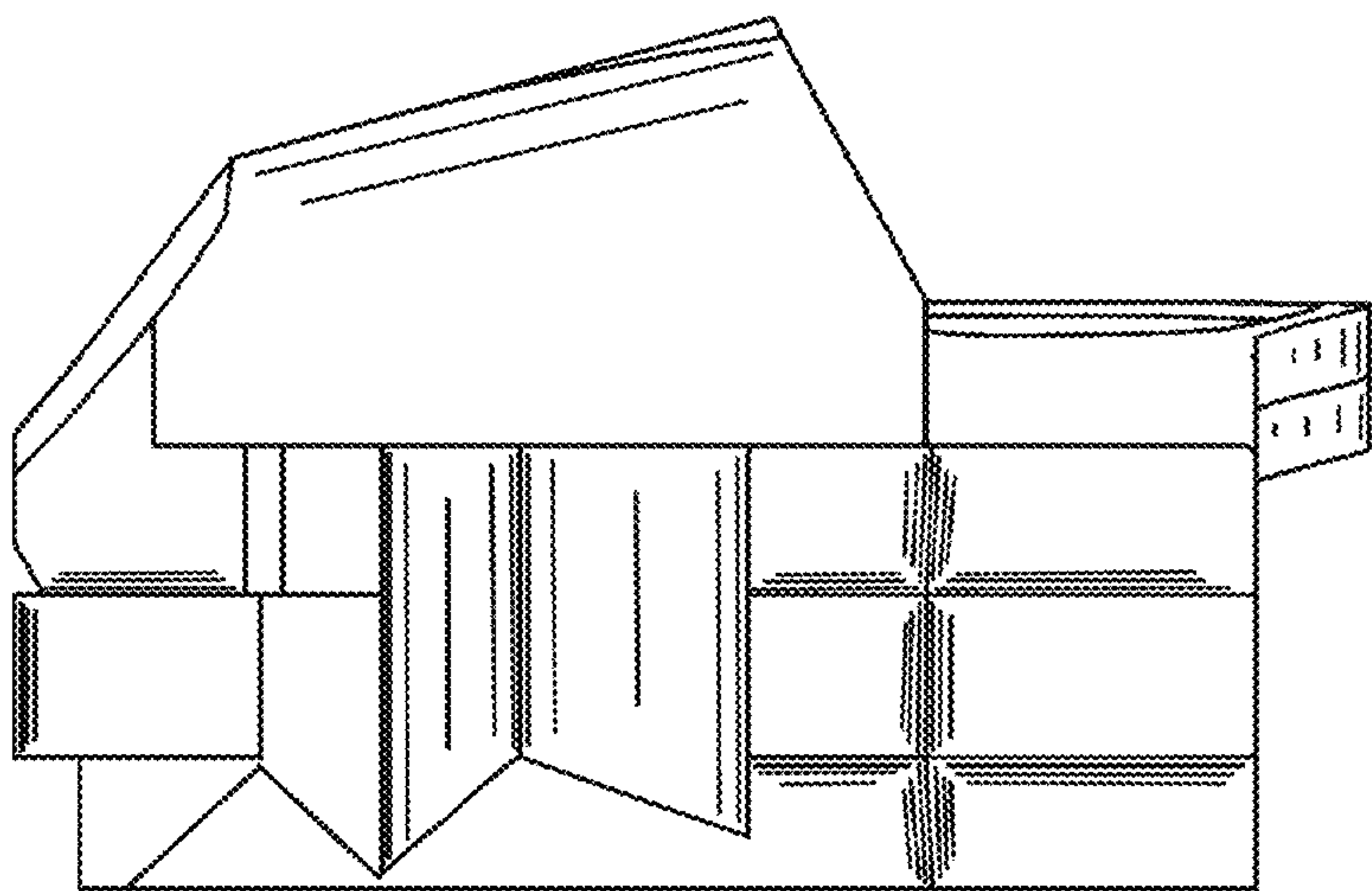

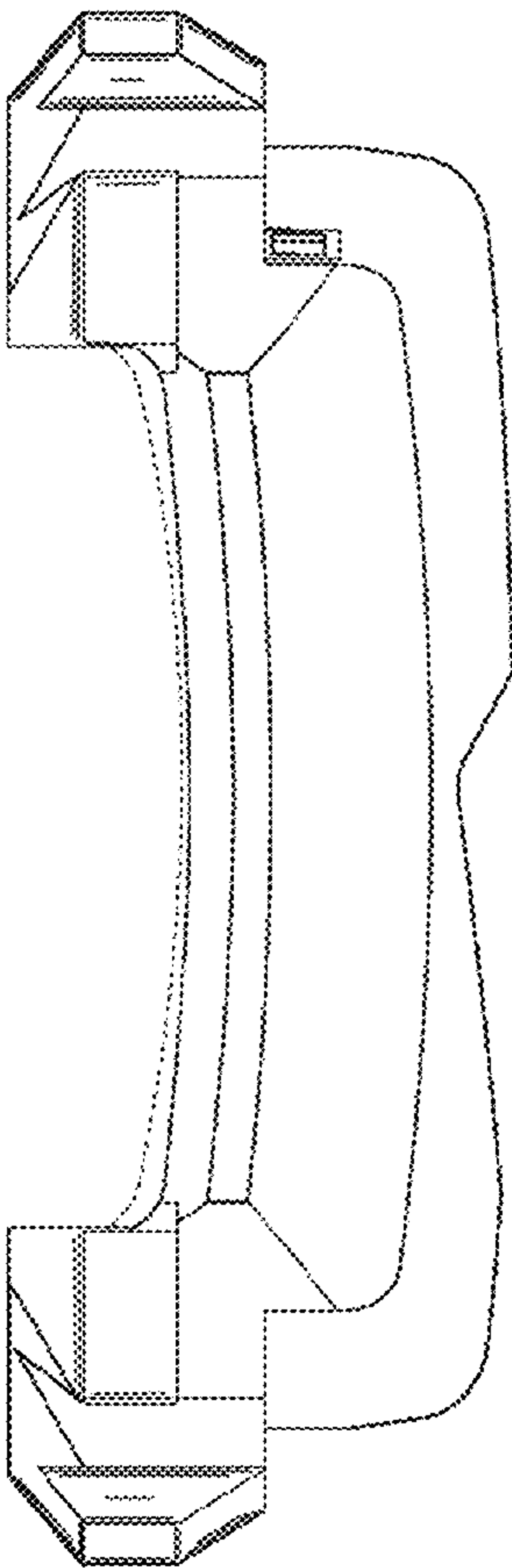

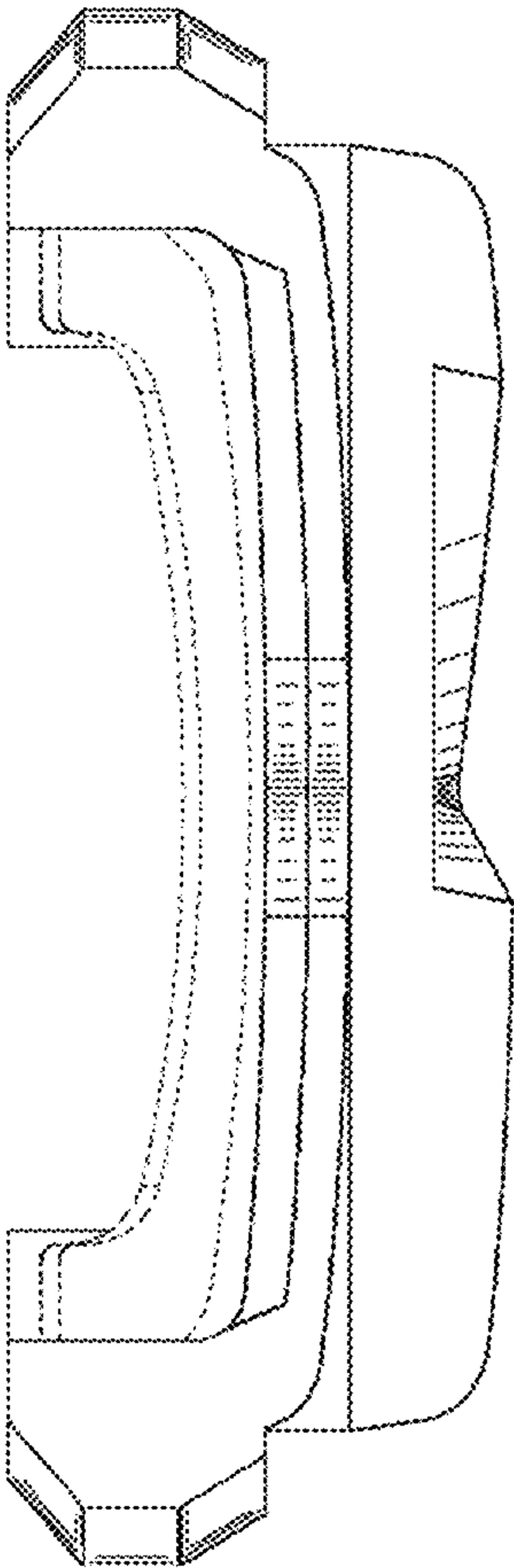

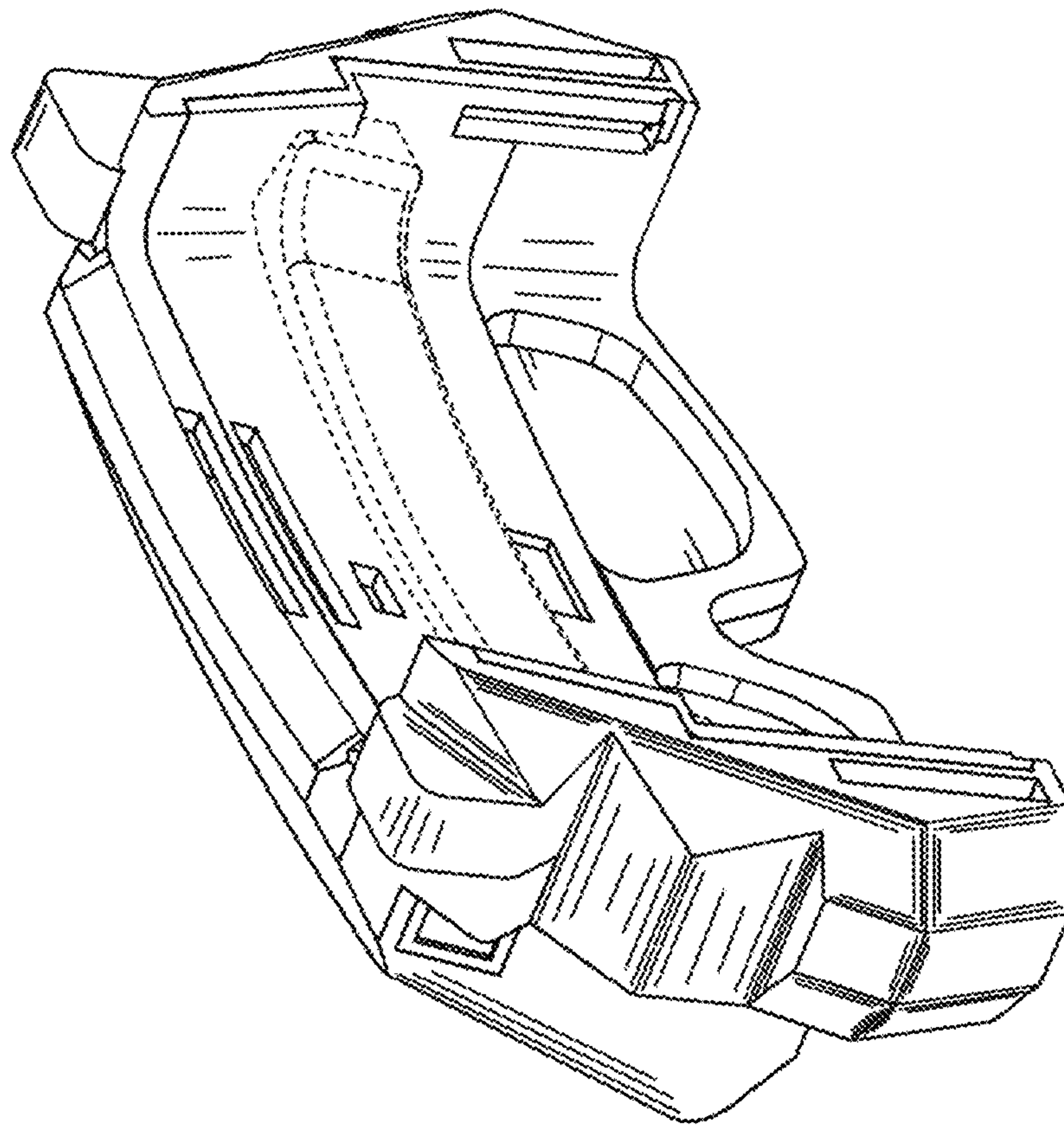
